FIG. 12 is a left side view of FIG. 9;

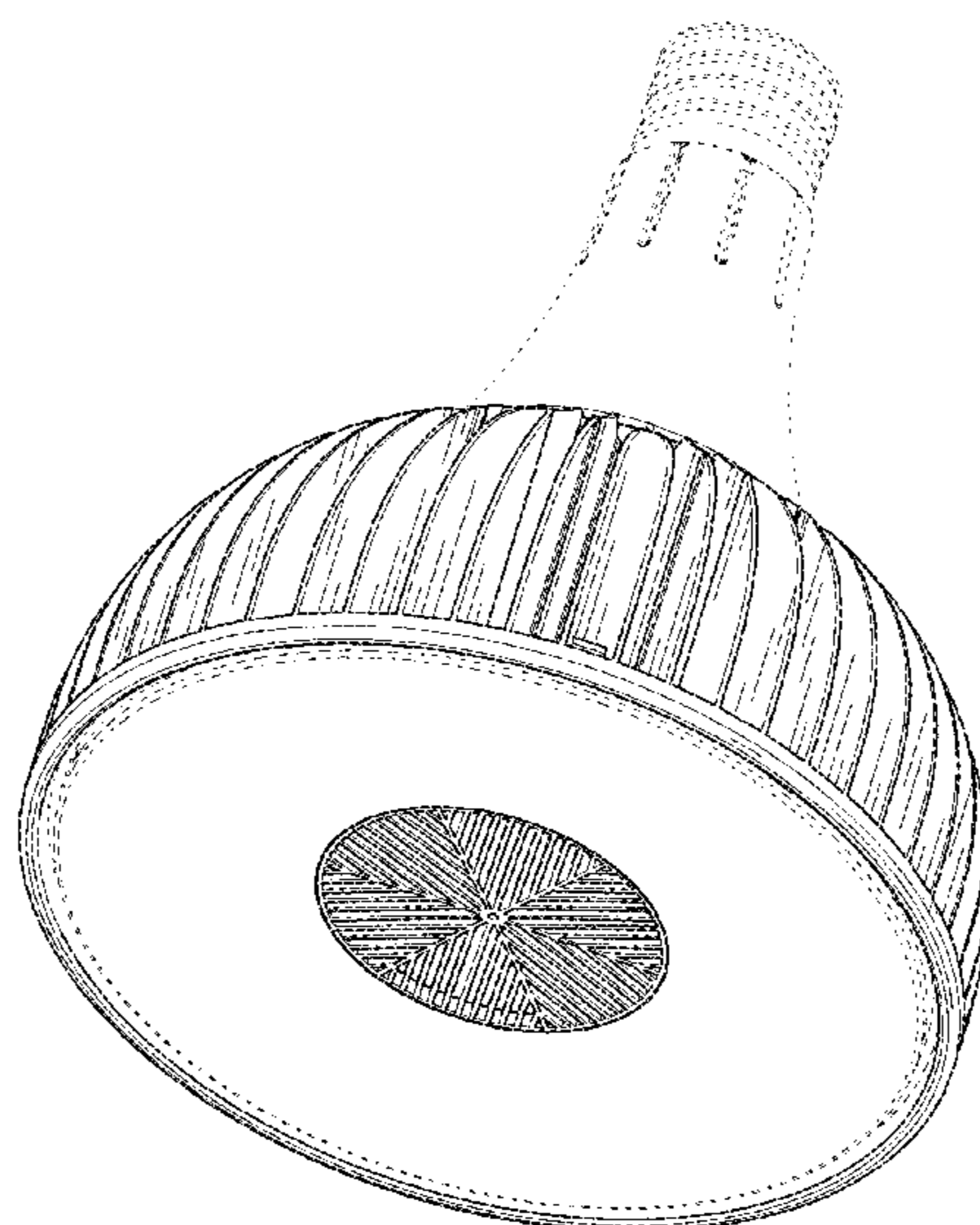
FIG. 13 is a right side view of FIG. 9;

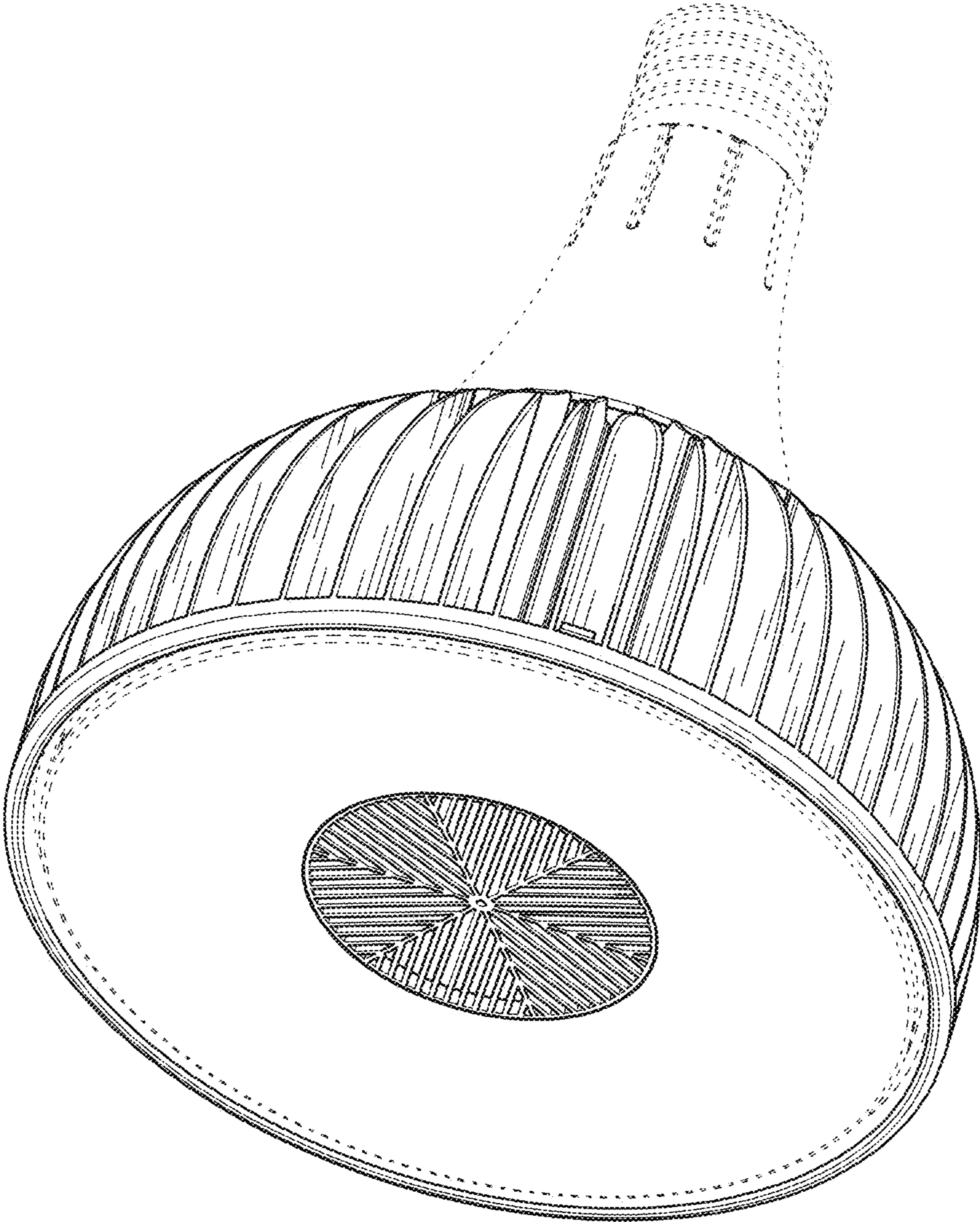

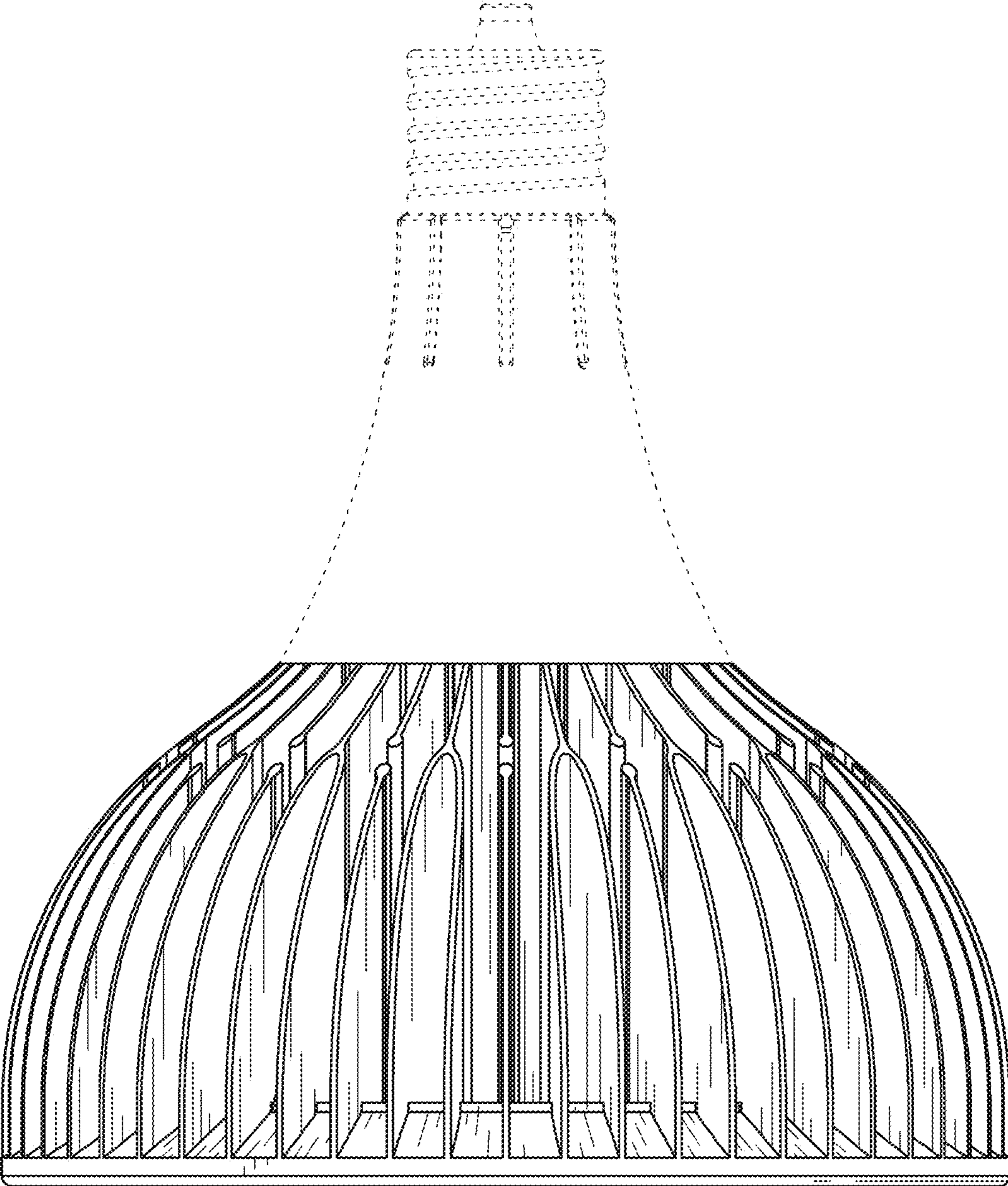

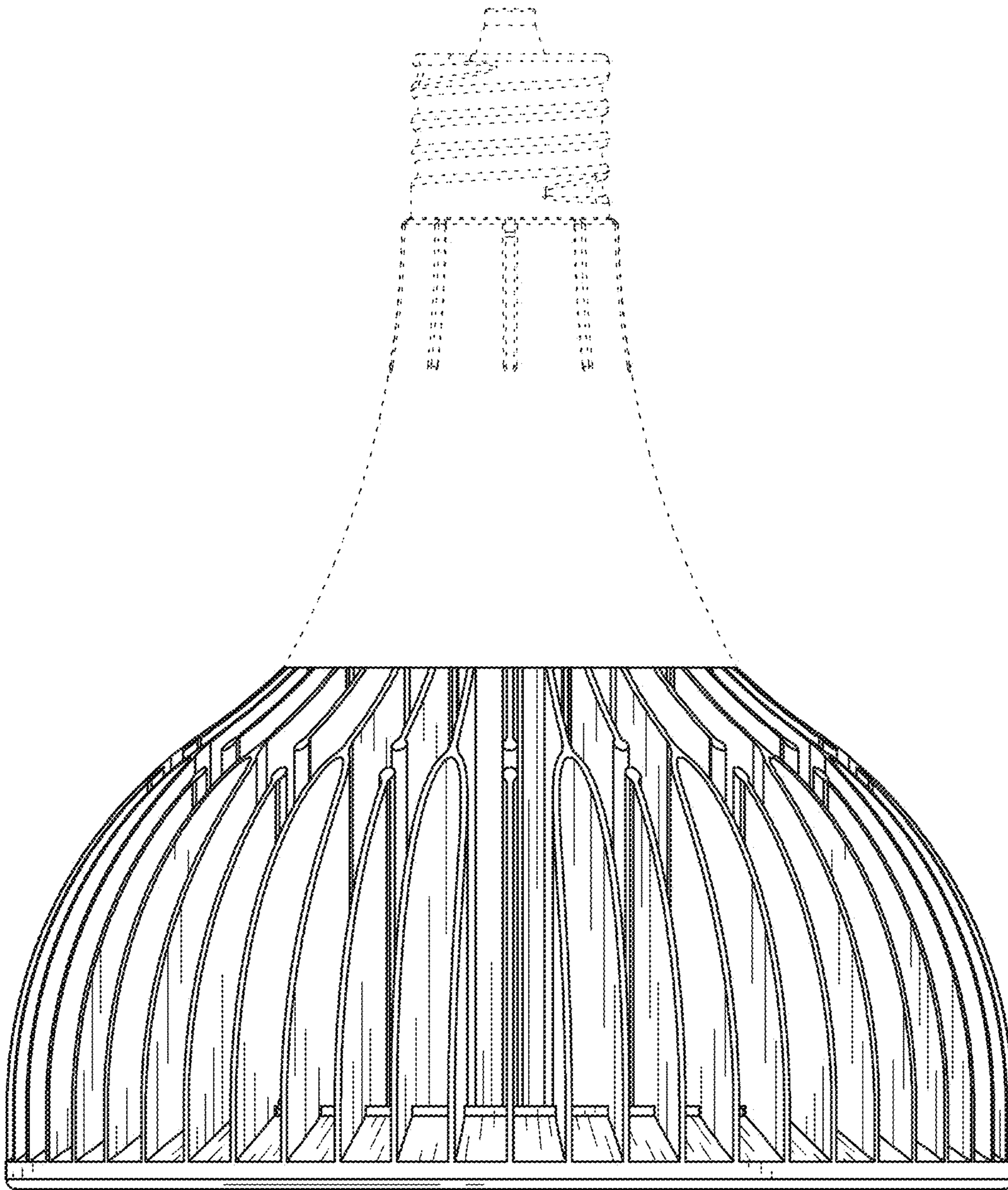

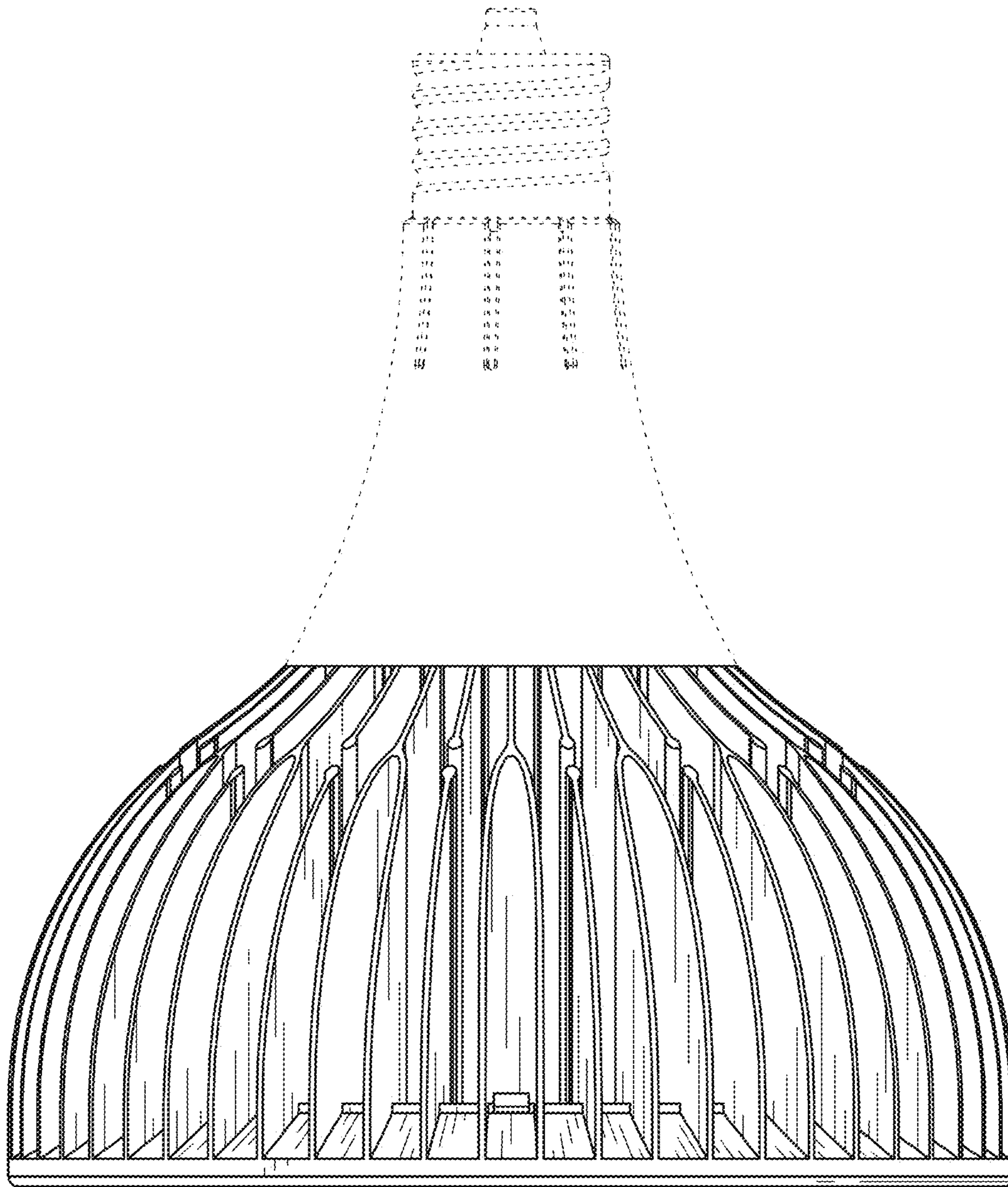

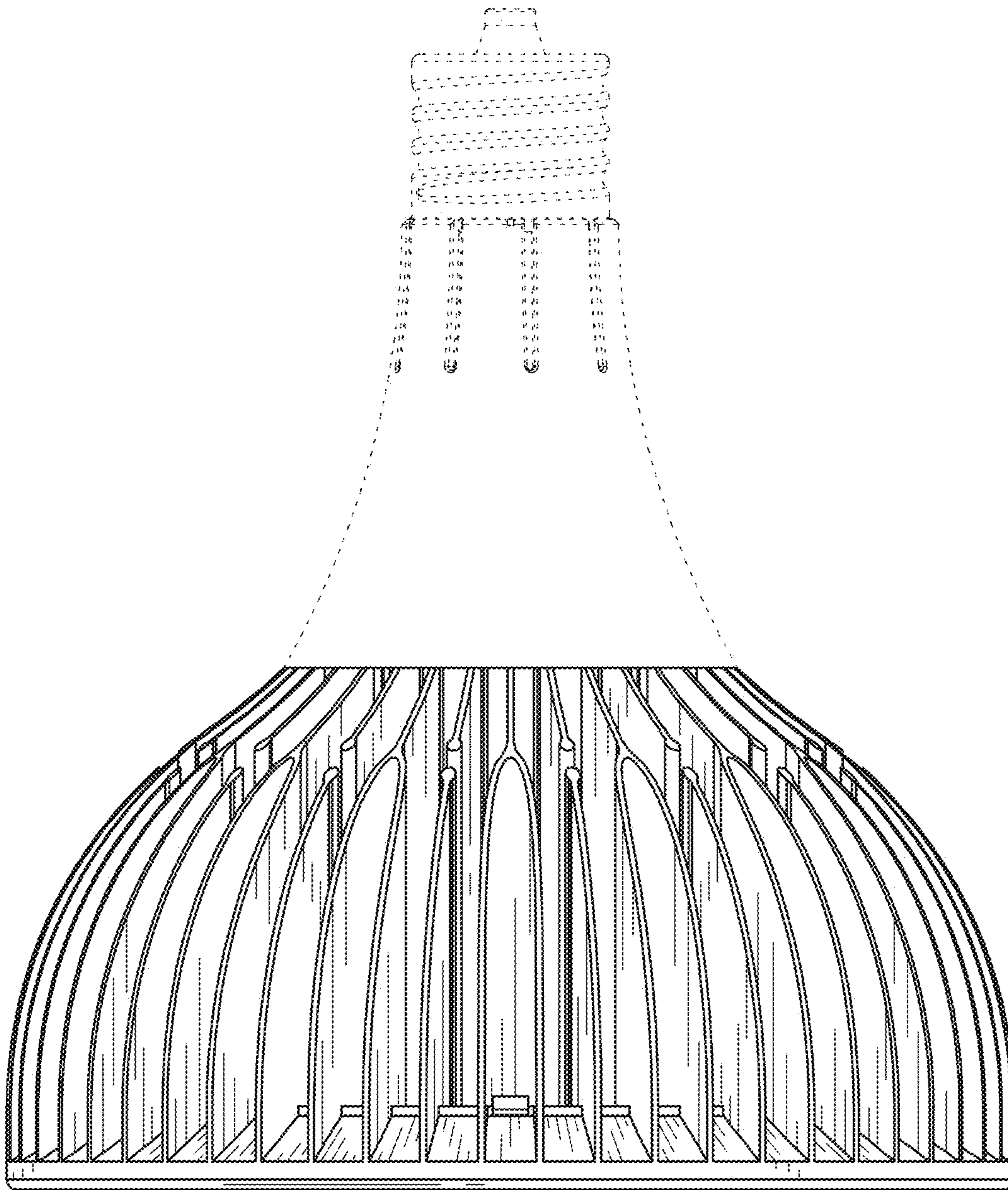

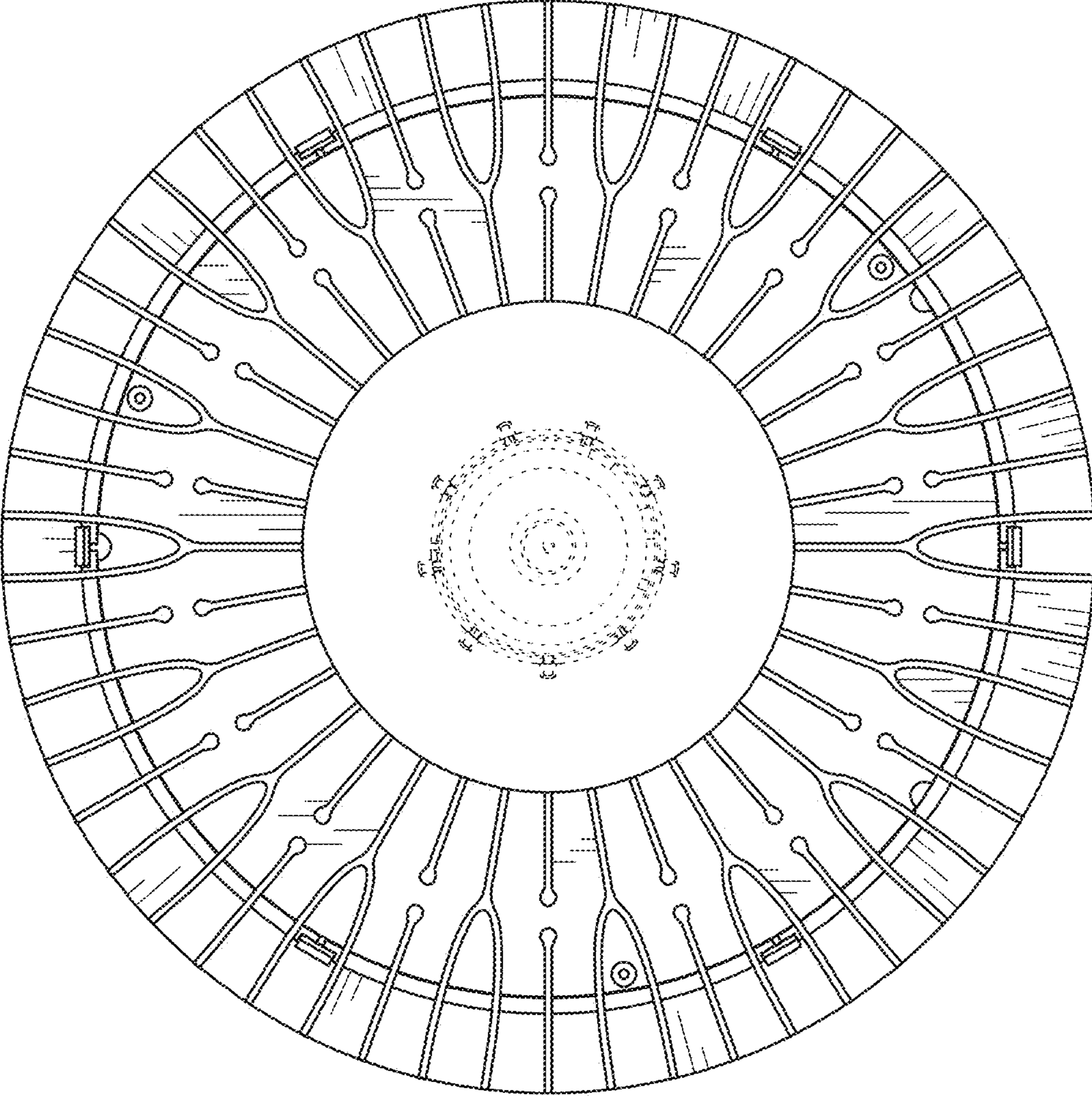

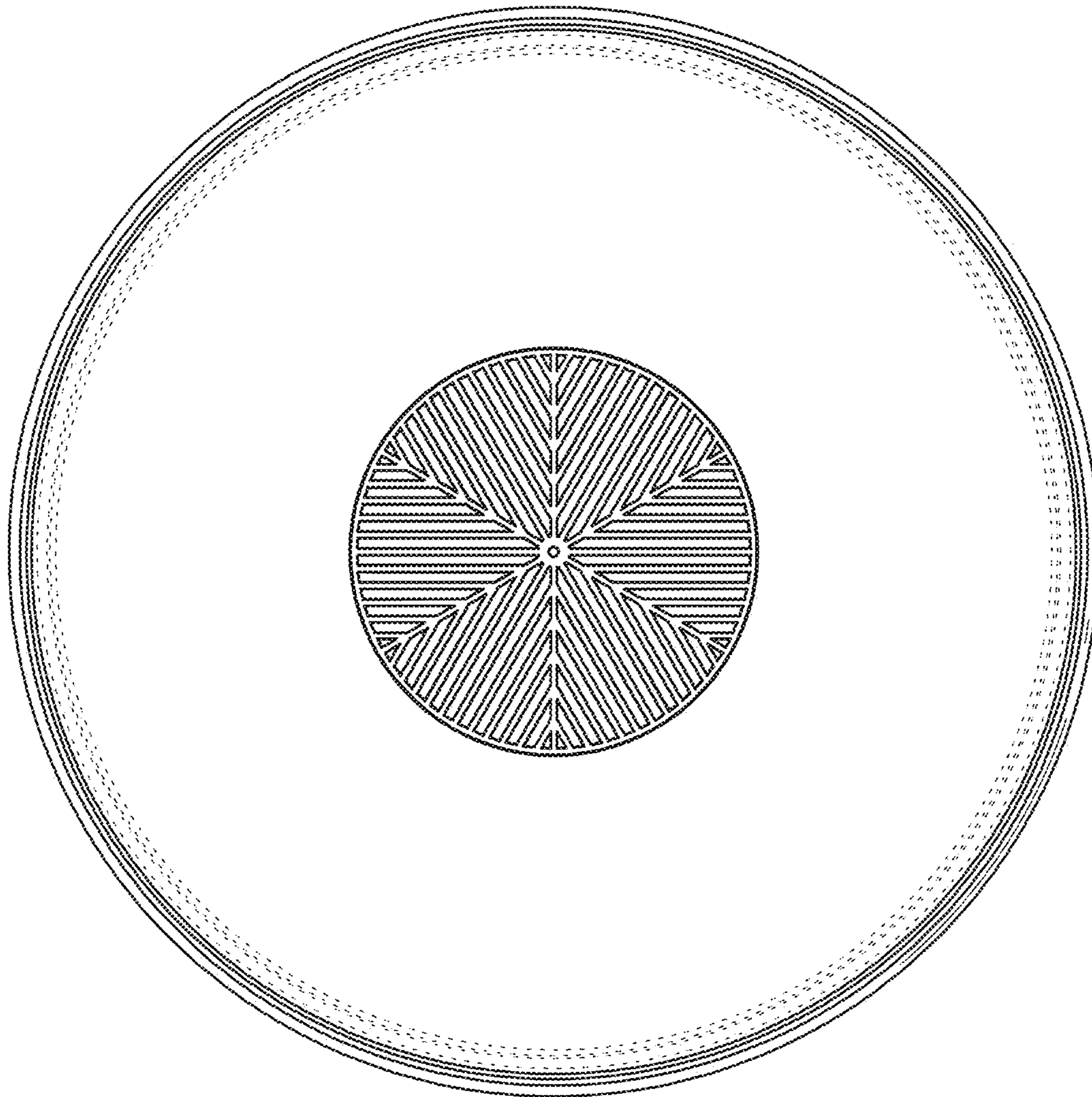

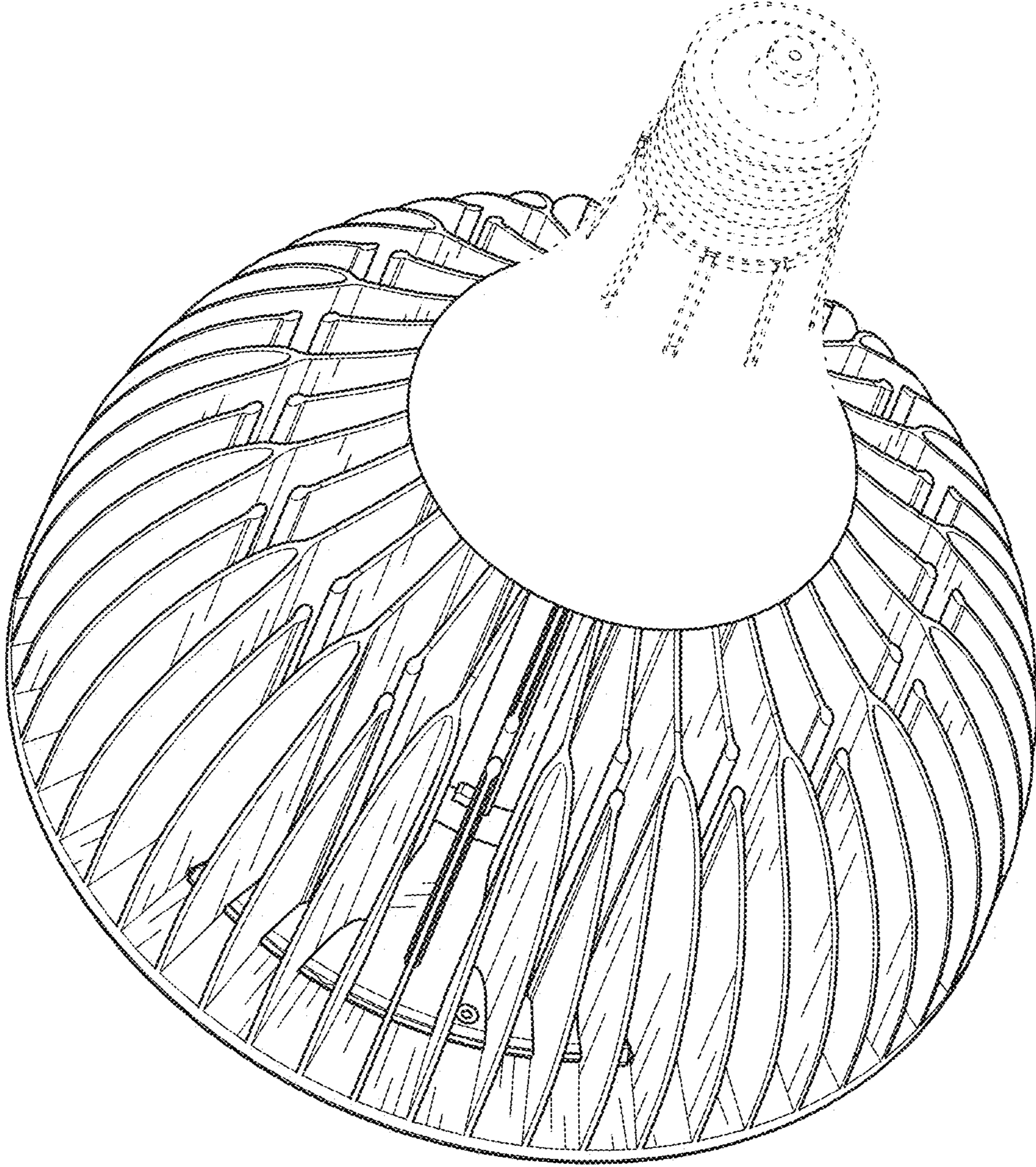

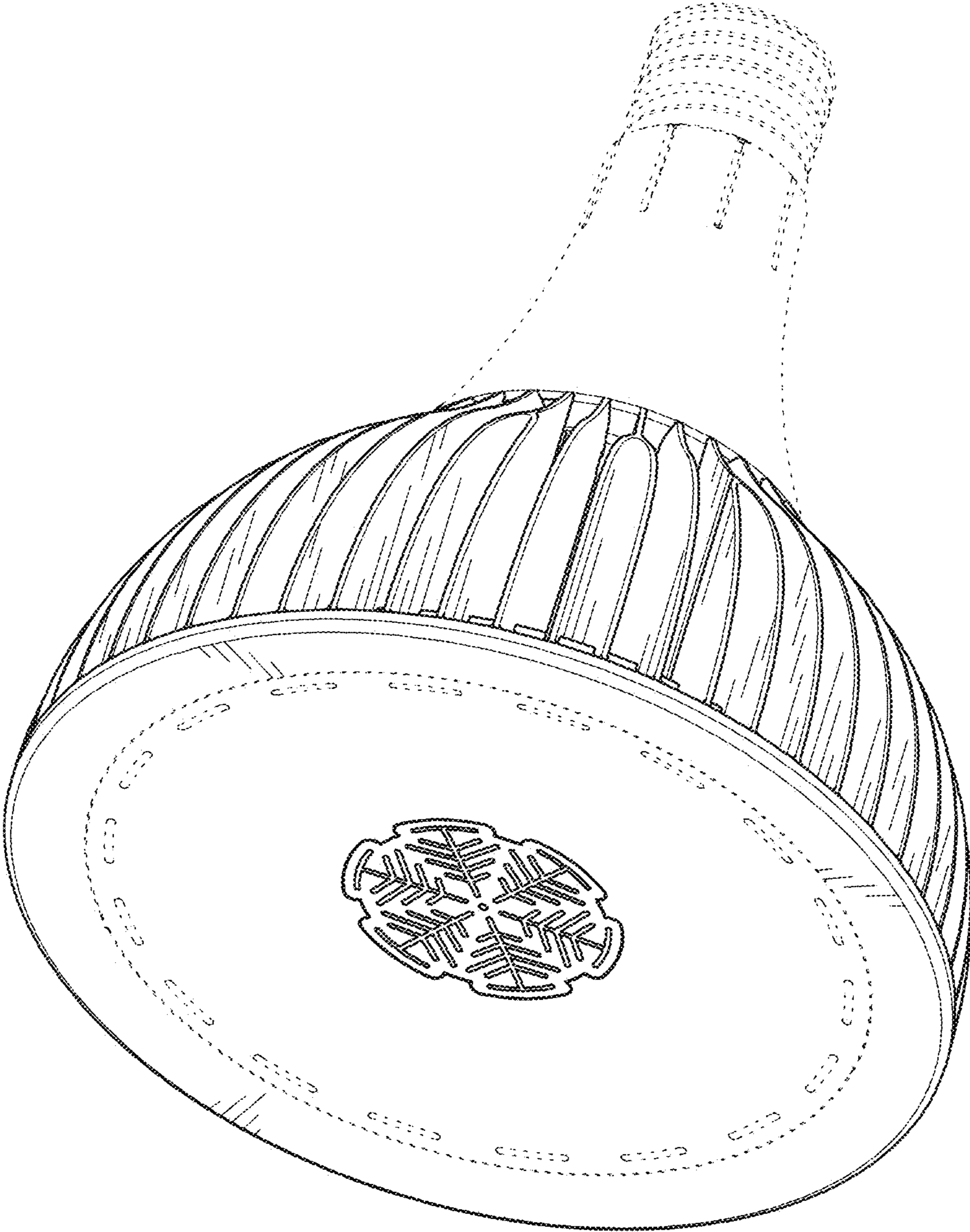

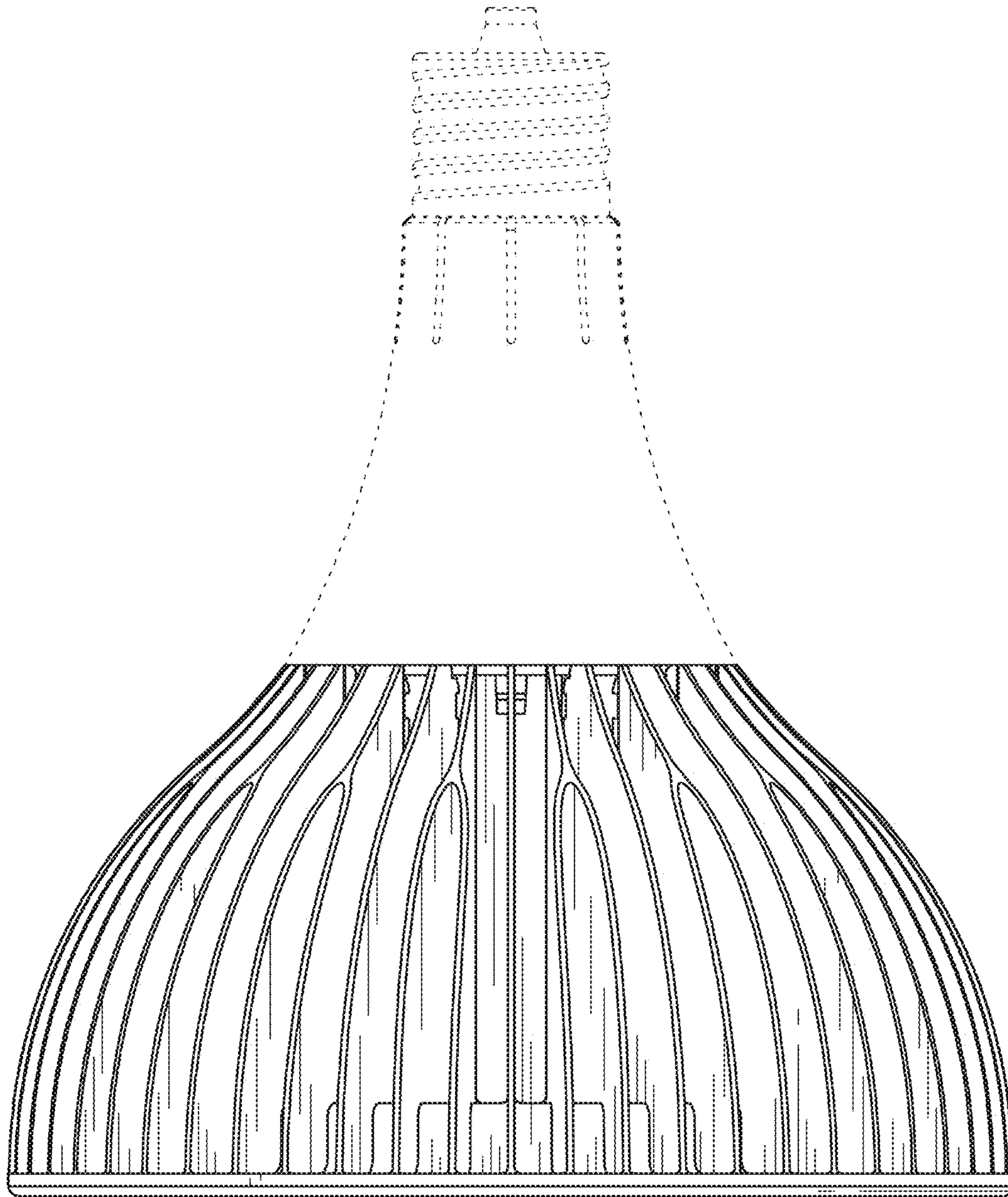

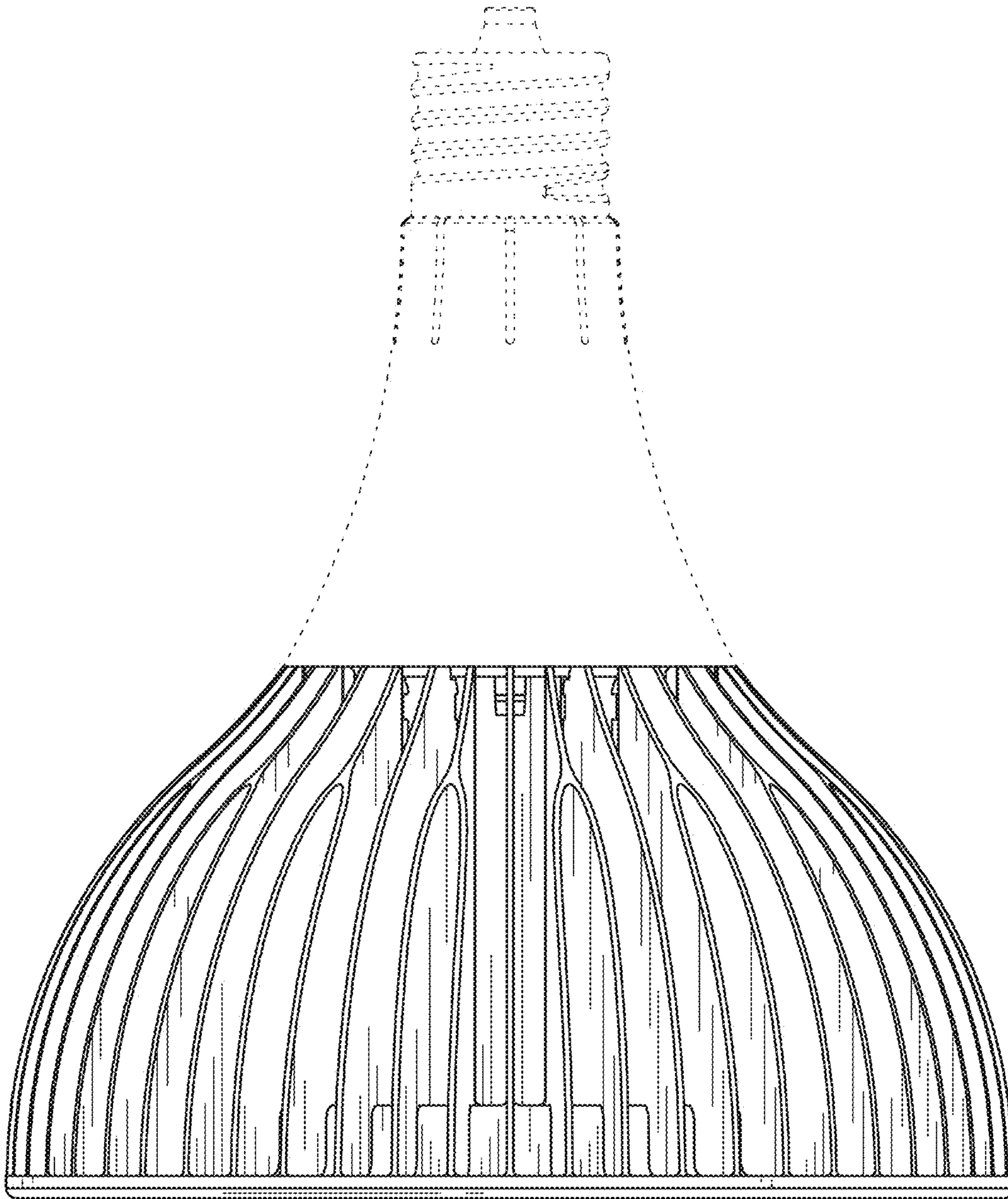

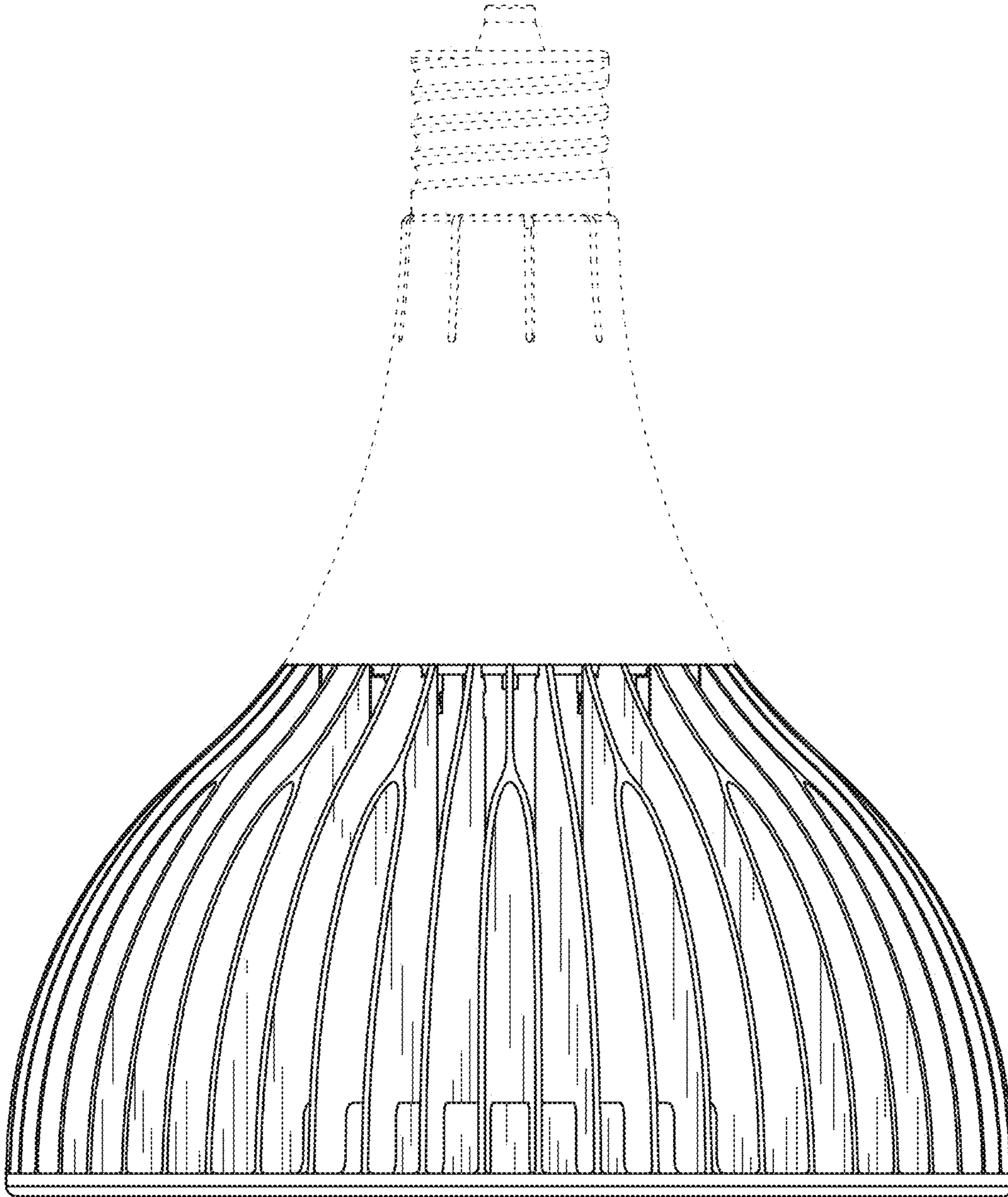

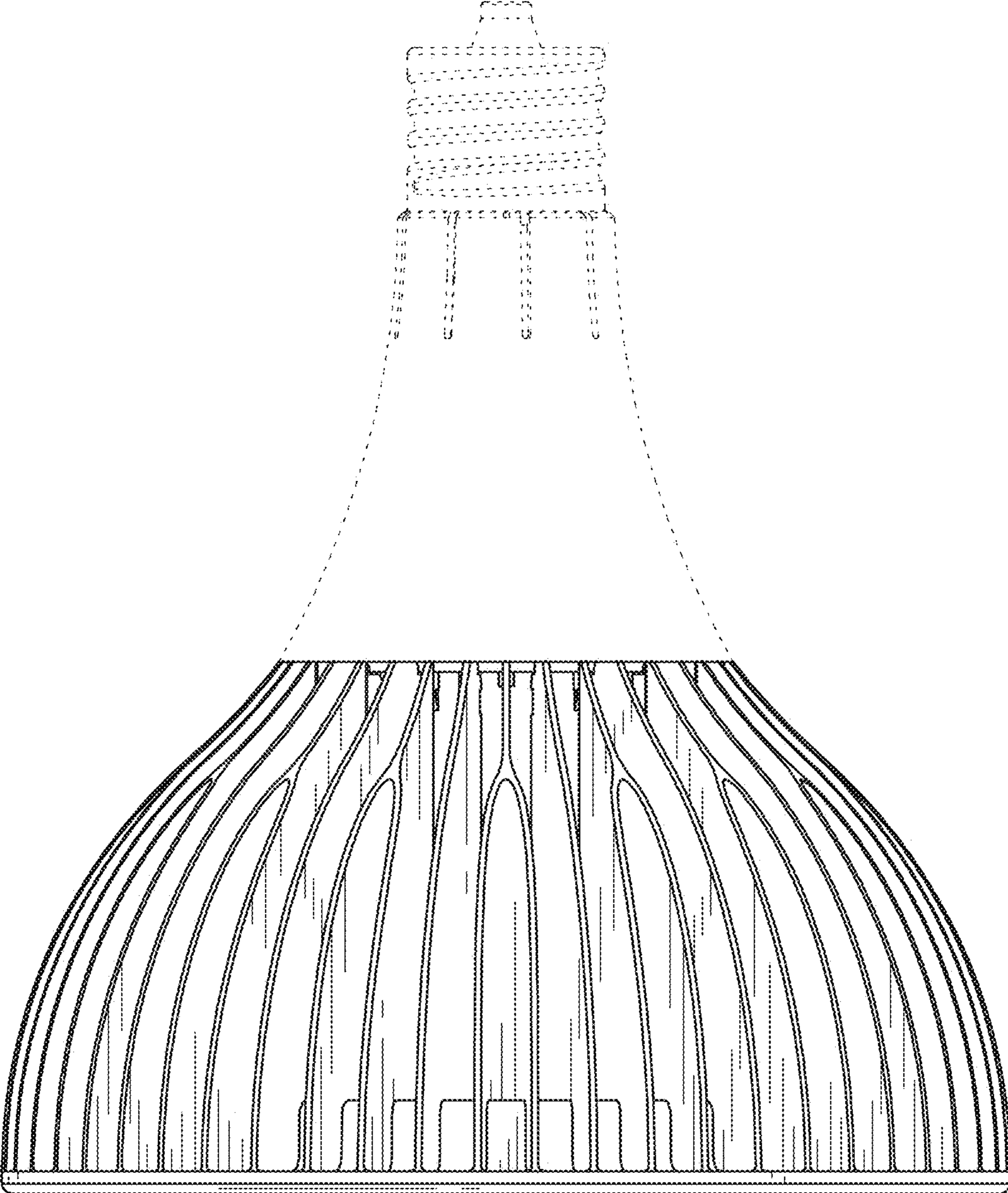

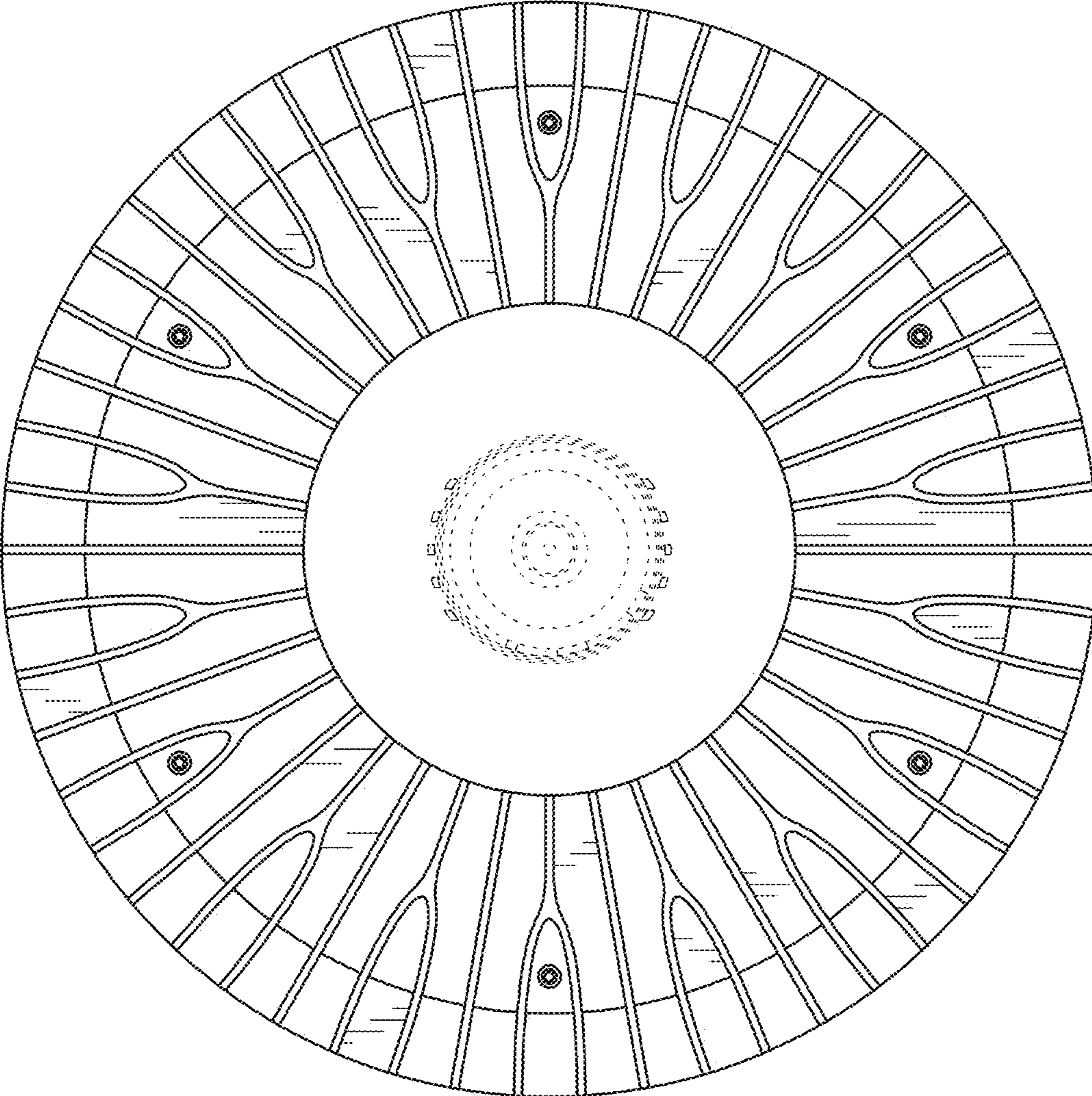

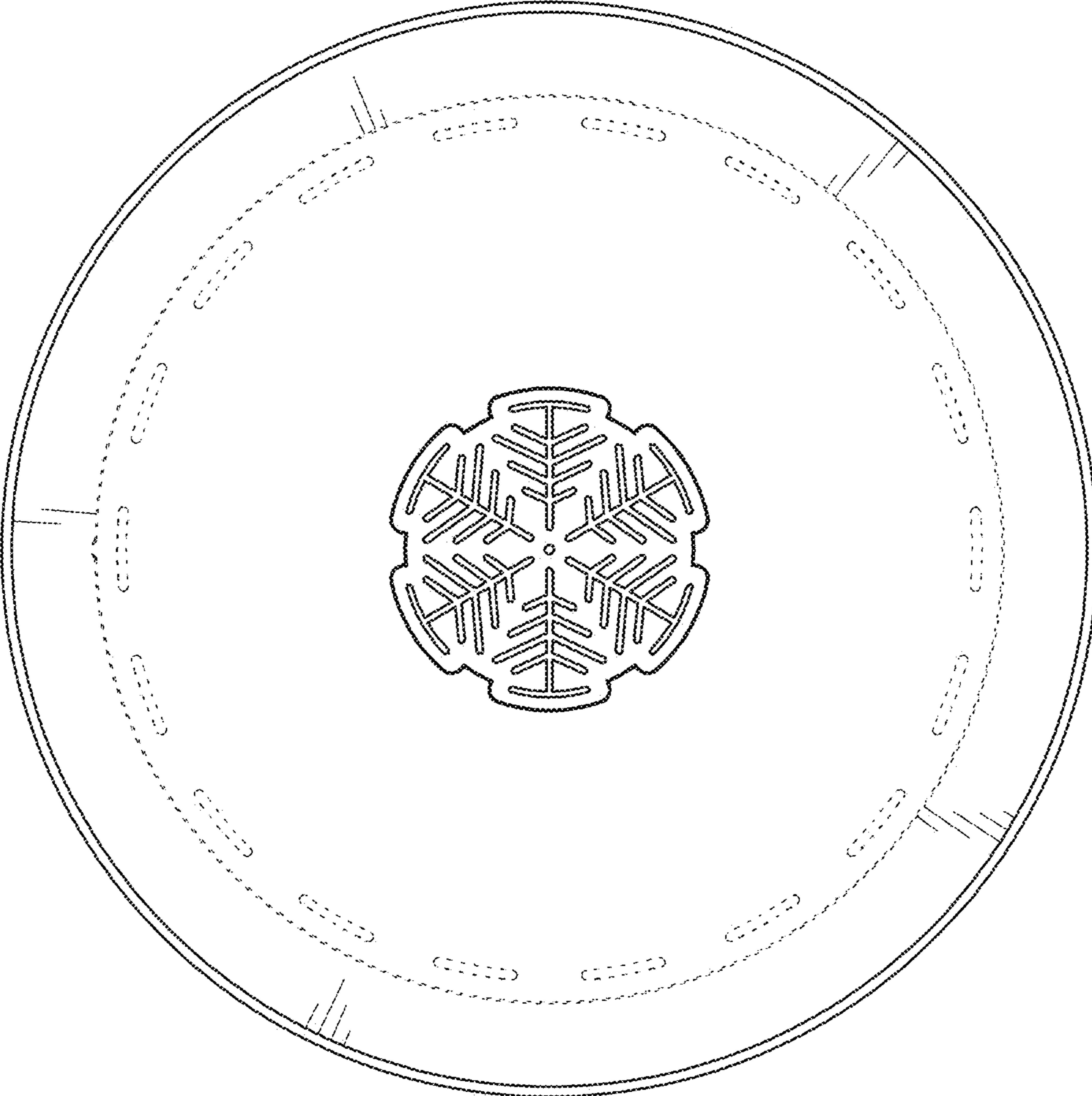
