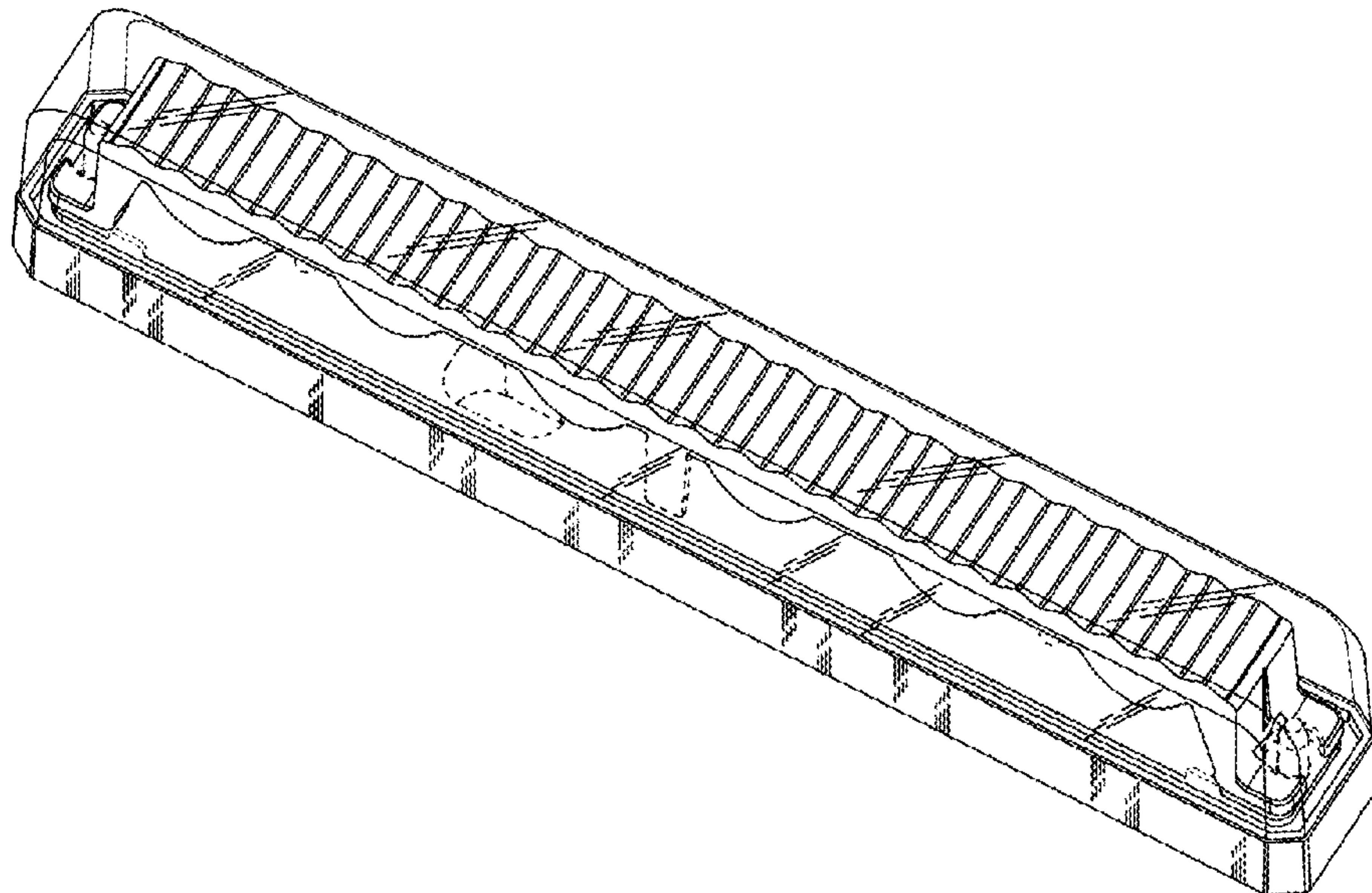
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a lighthouse for vehicle showing our new design;

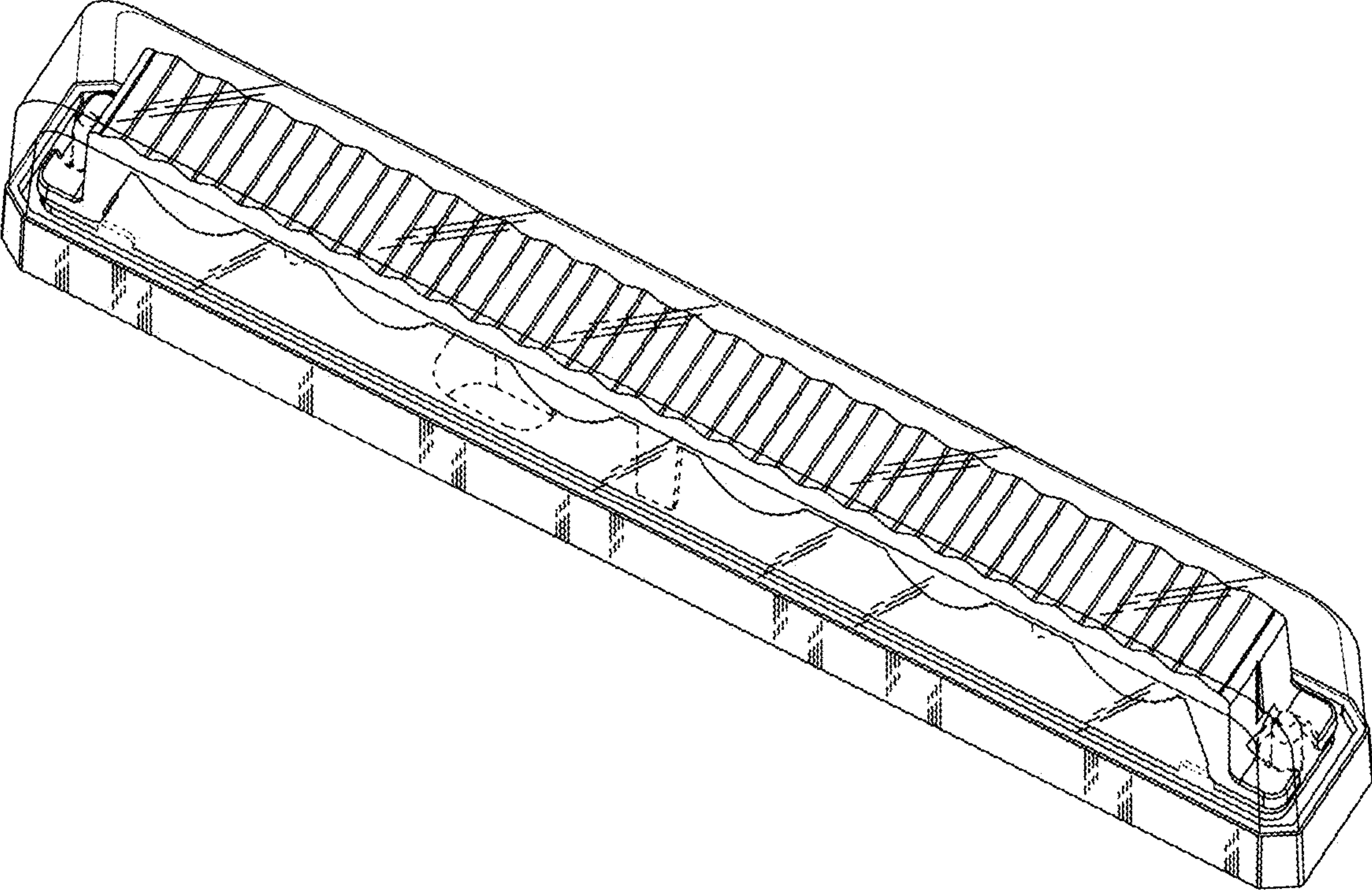

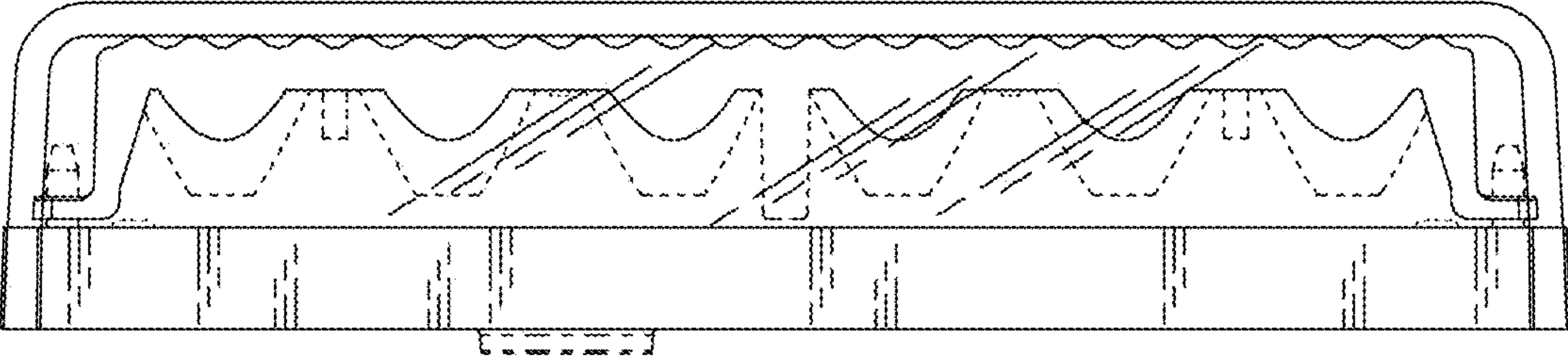

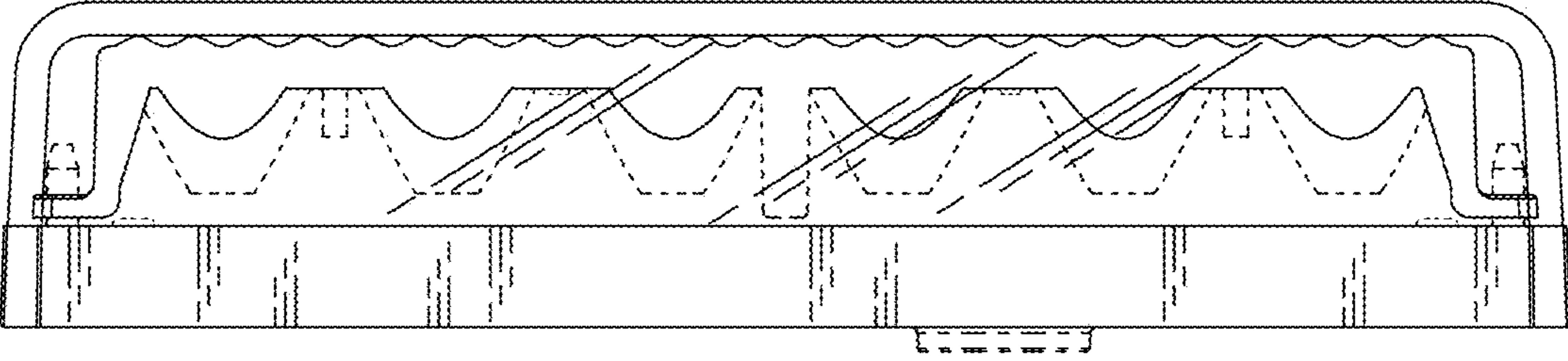

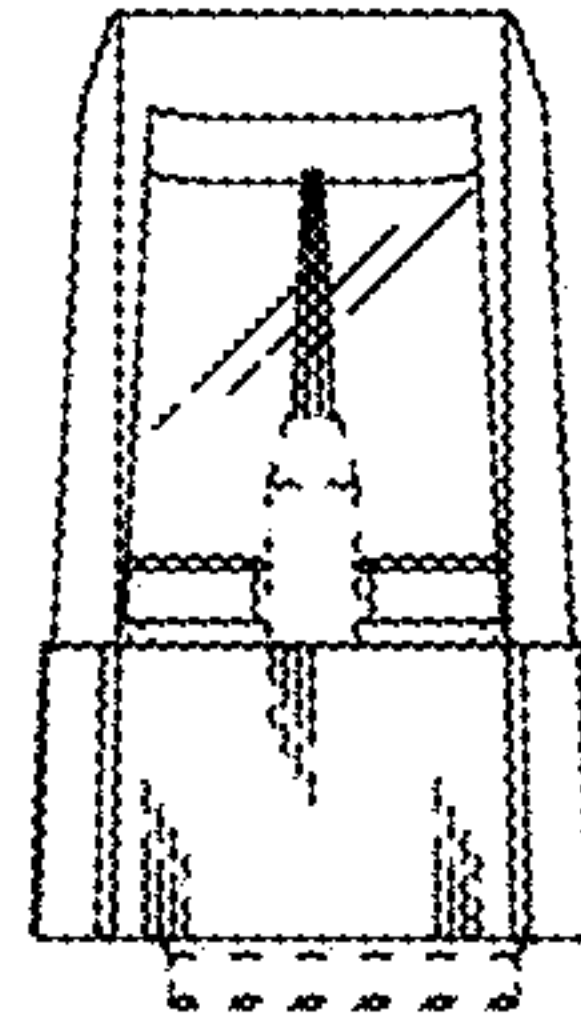

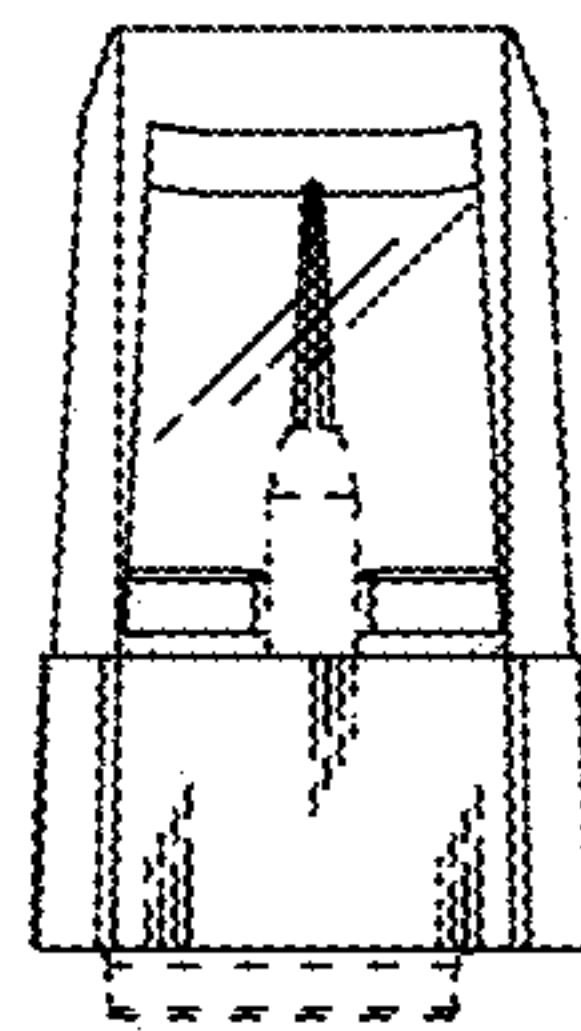

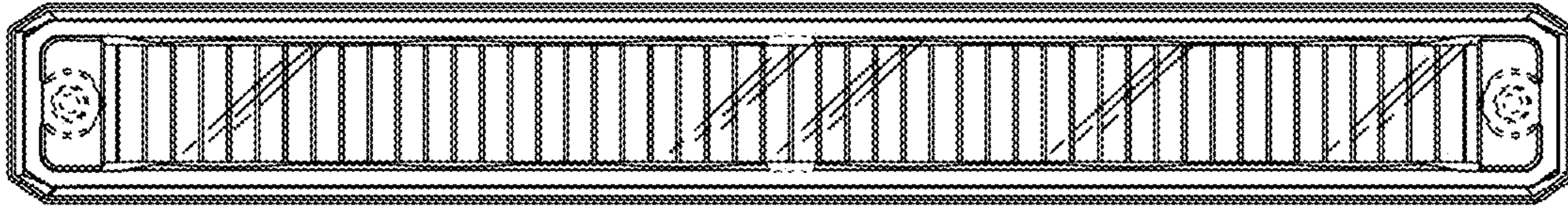

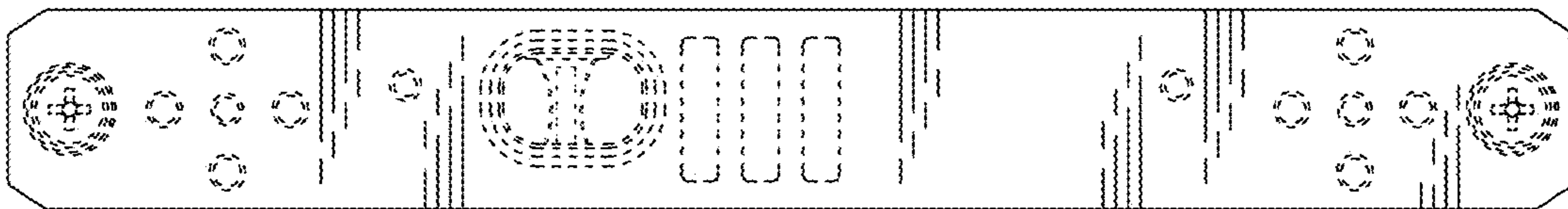
