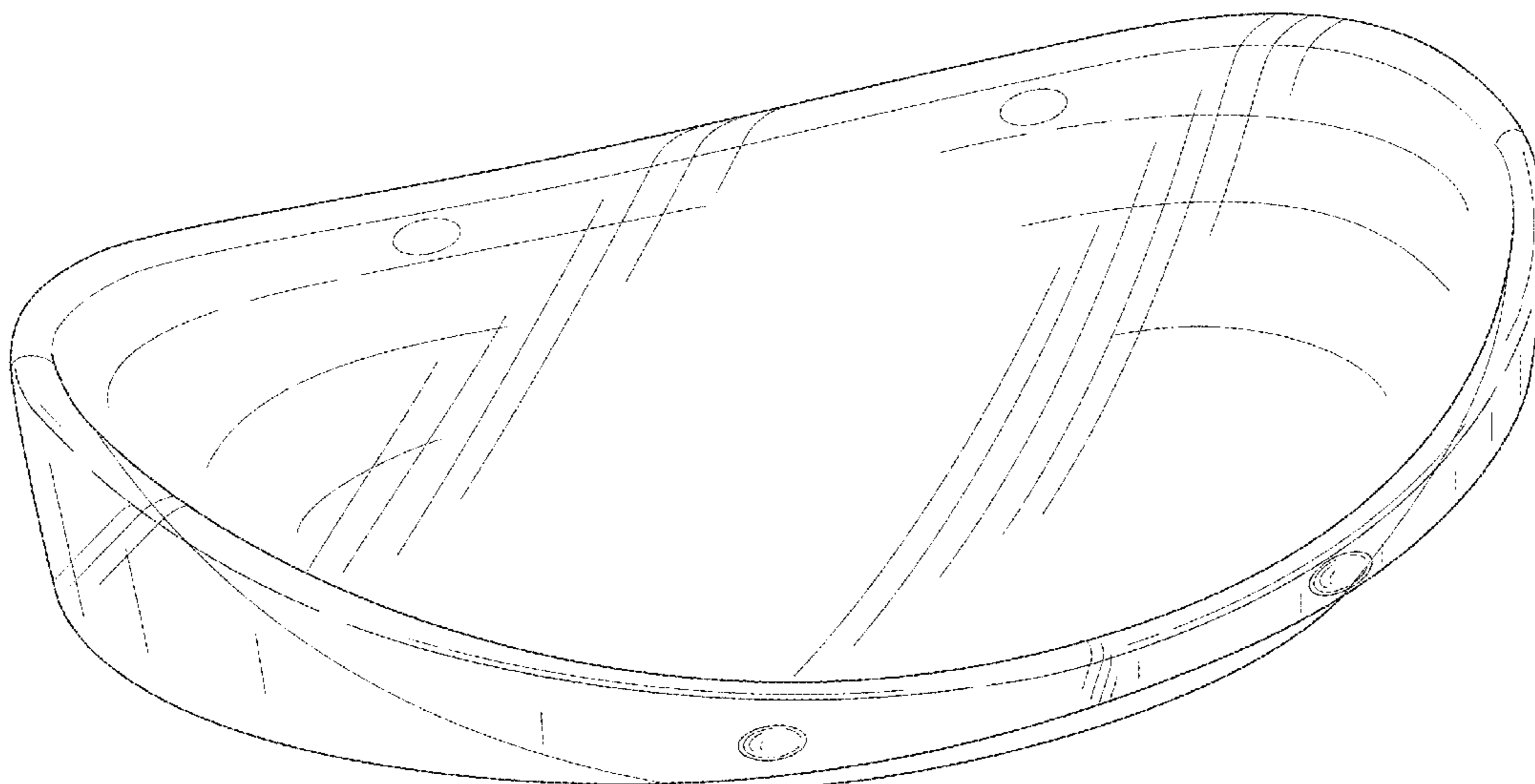
(57) **CLAIM**

The ornamental design for a light cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light cover showing a new design;
 FIG. 2 is a top plane view thereof;
 FIG. 3 is bottom plane view thereof;
 FIG. 4 is a left side elevation view thereof;
 FIG. 5 is a right side elevation view thereof;
 FIG. 6 is a front elevation view thereof;
 FIG. 7 is a rear elevation view thereof;
 FIG. 8 is another perspective view of the light cover of FIG. 1 shown as installed on an example light fixture for environmental purposes;
 FIG. 9 is a perspective view of the light cover showing an alternate embodiment;
 FIG. 10 is a top plane view thereof;
 FIG. 11 is bottom plane view thereof;
 FIG. 12 is a left side elevation view thereof;
 FIG. 13 is a right side elevation view thereof;
 FIG. 14 is a front elevation view thereof;
 FIG. 15 is a rear elevation view thereof; and,

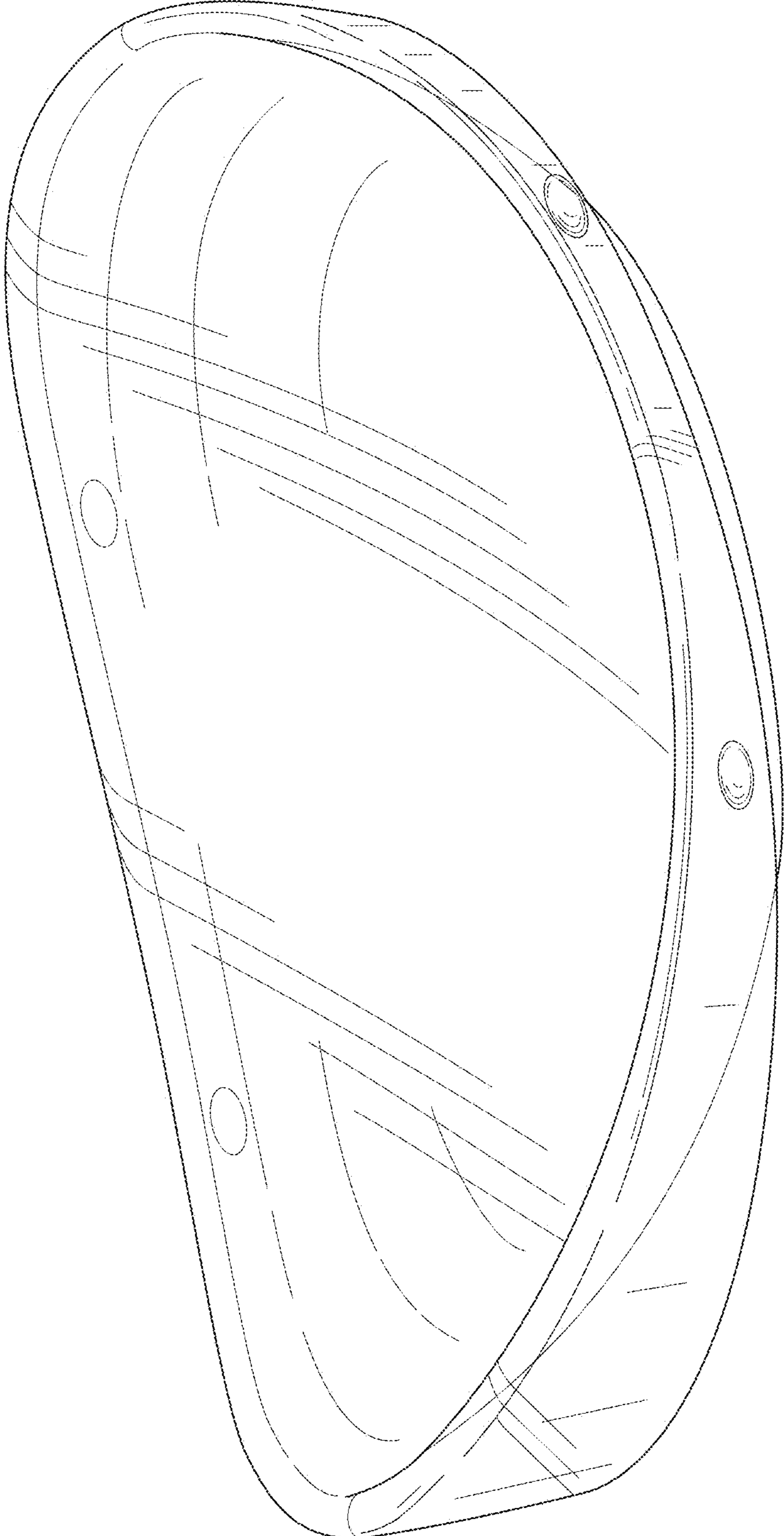

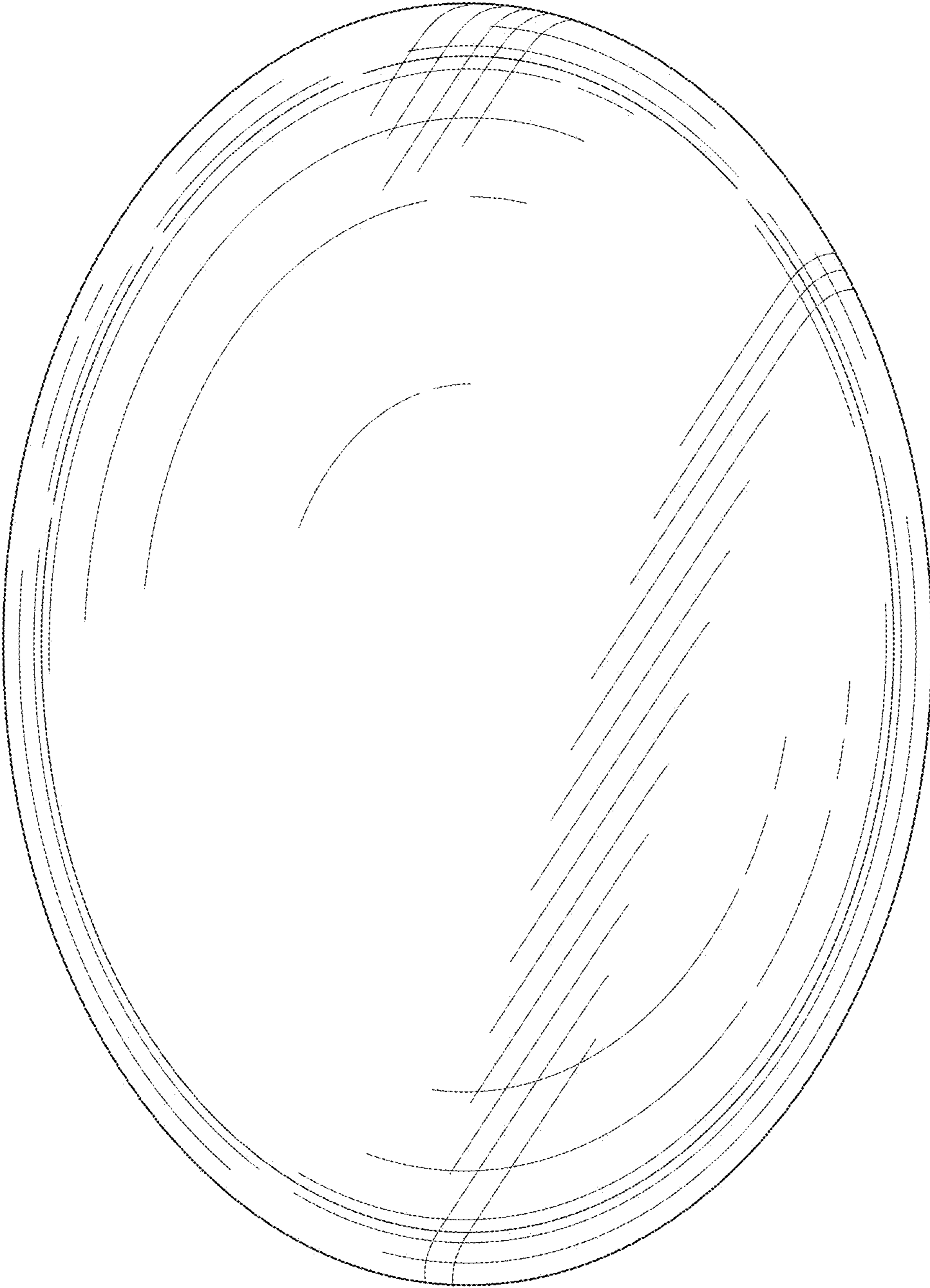

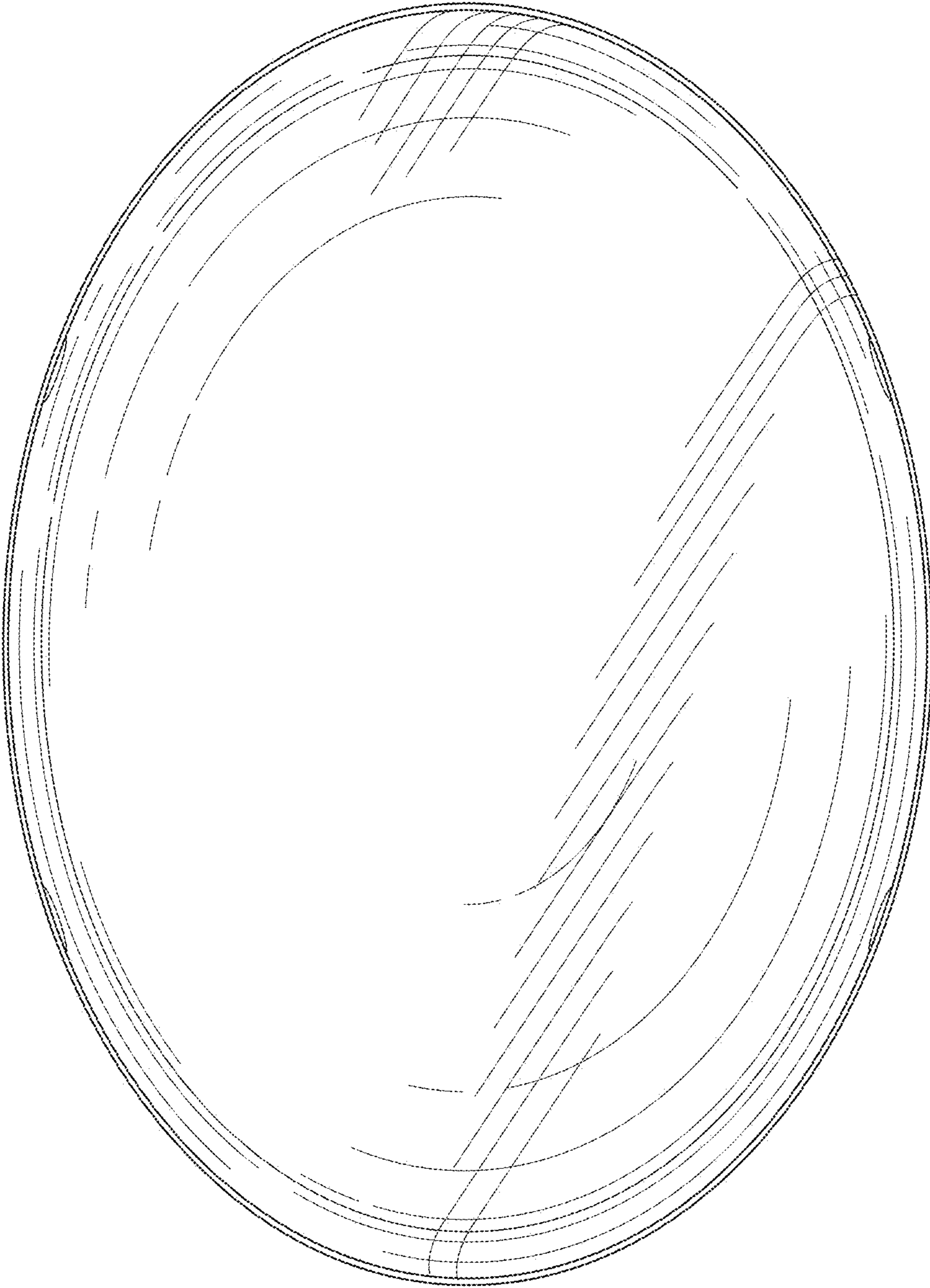

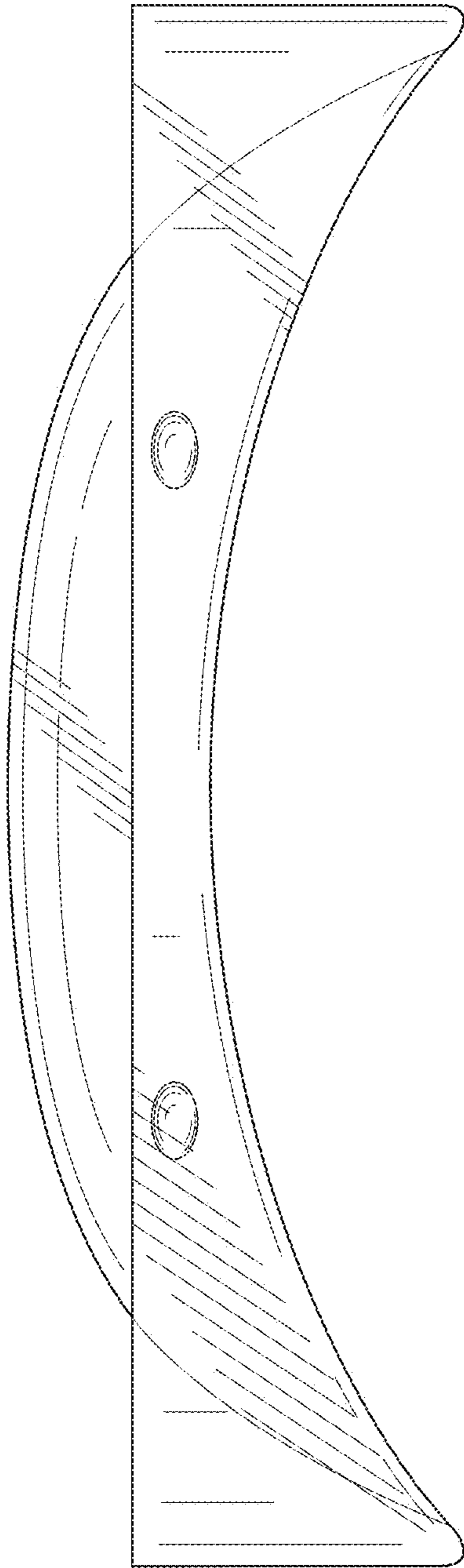

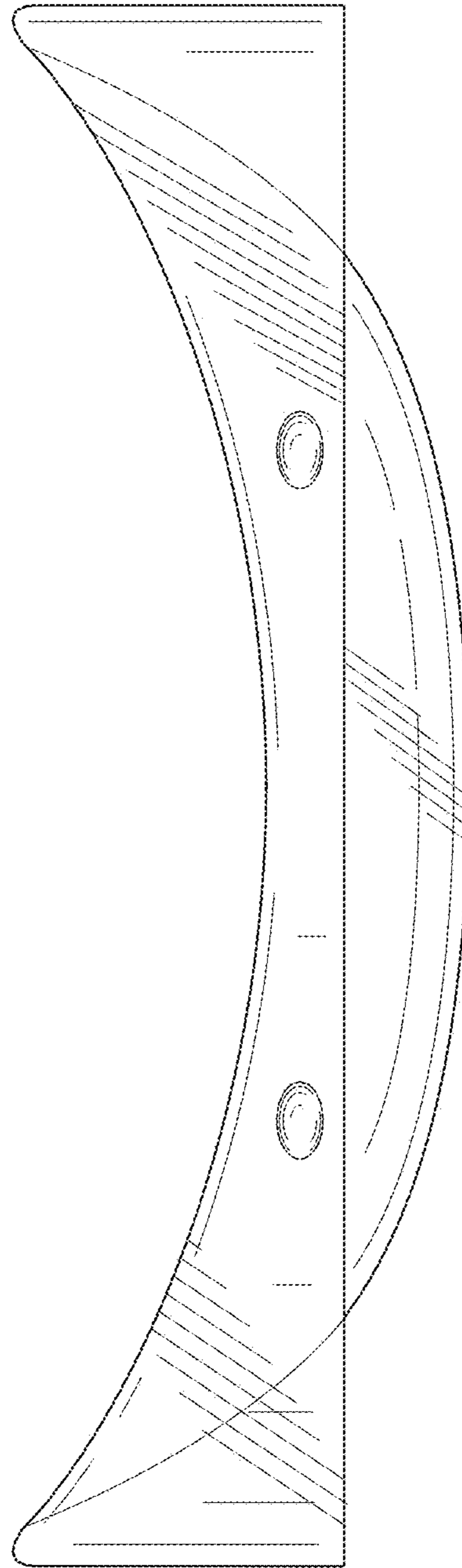

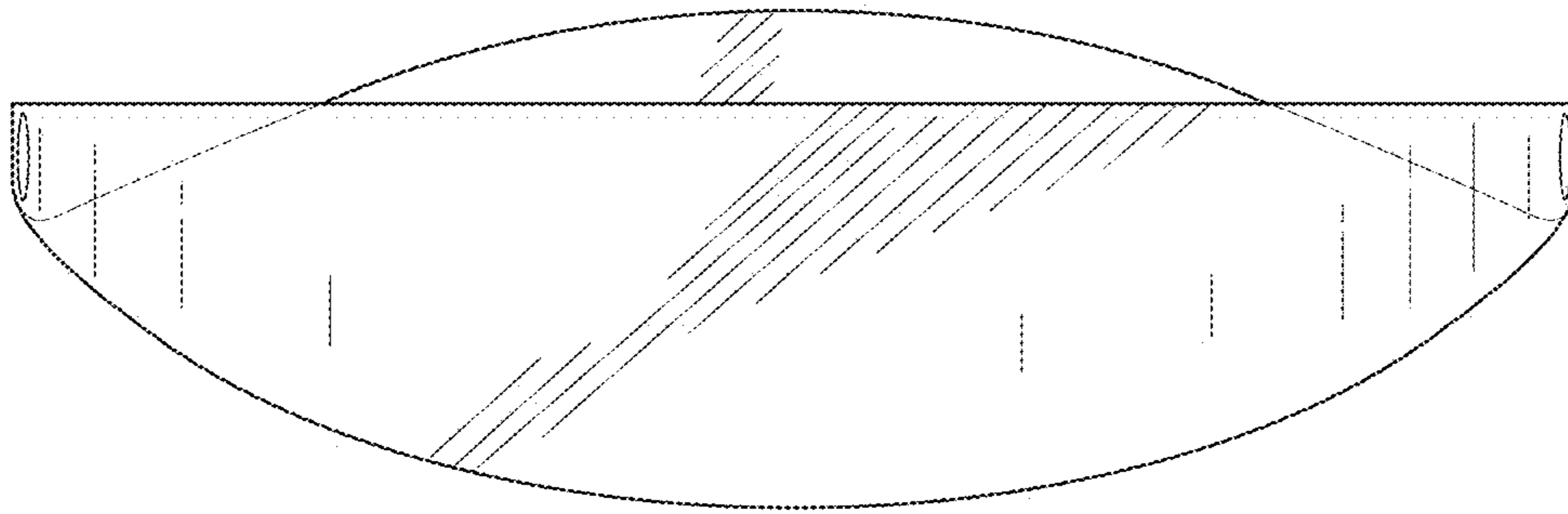

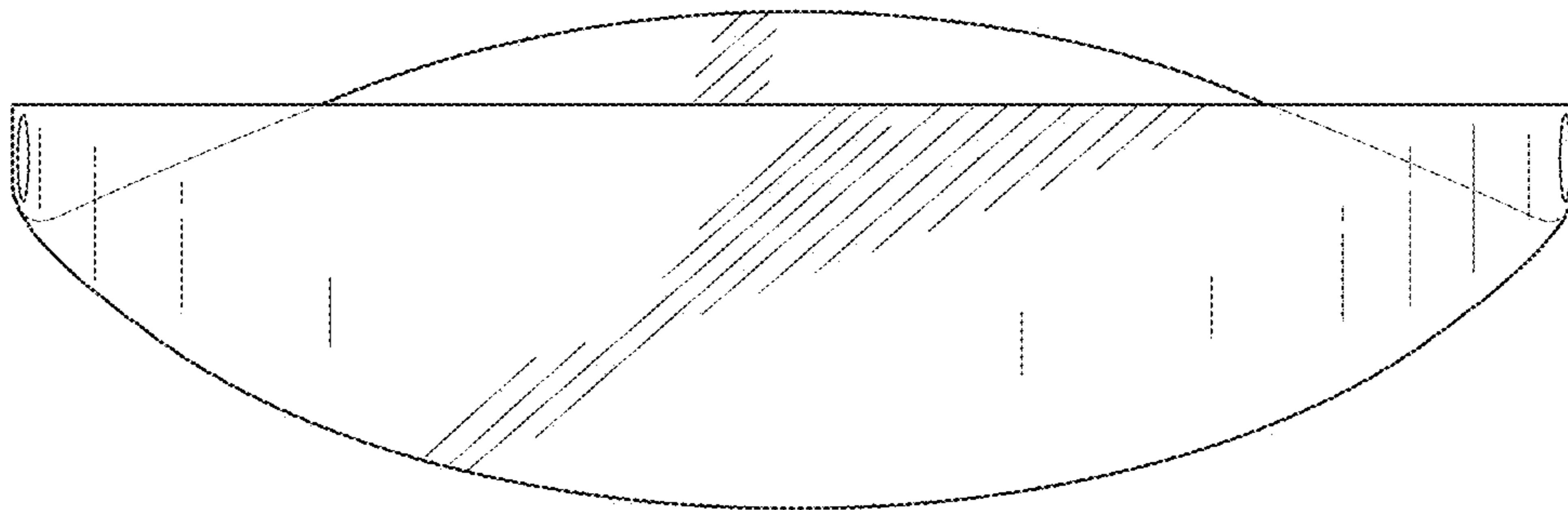

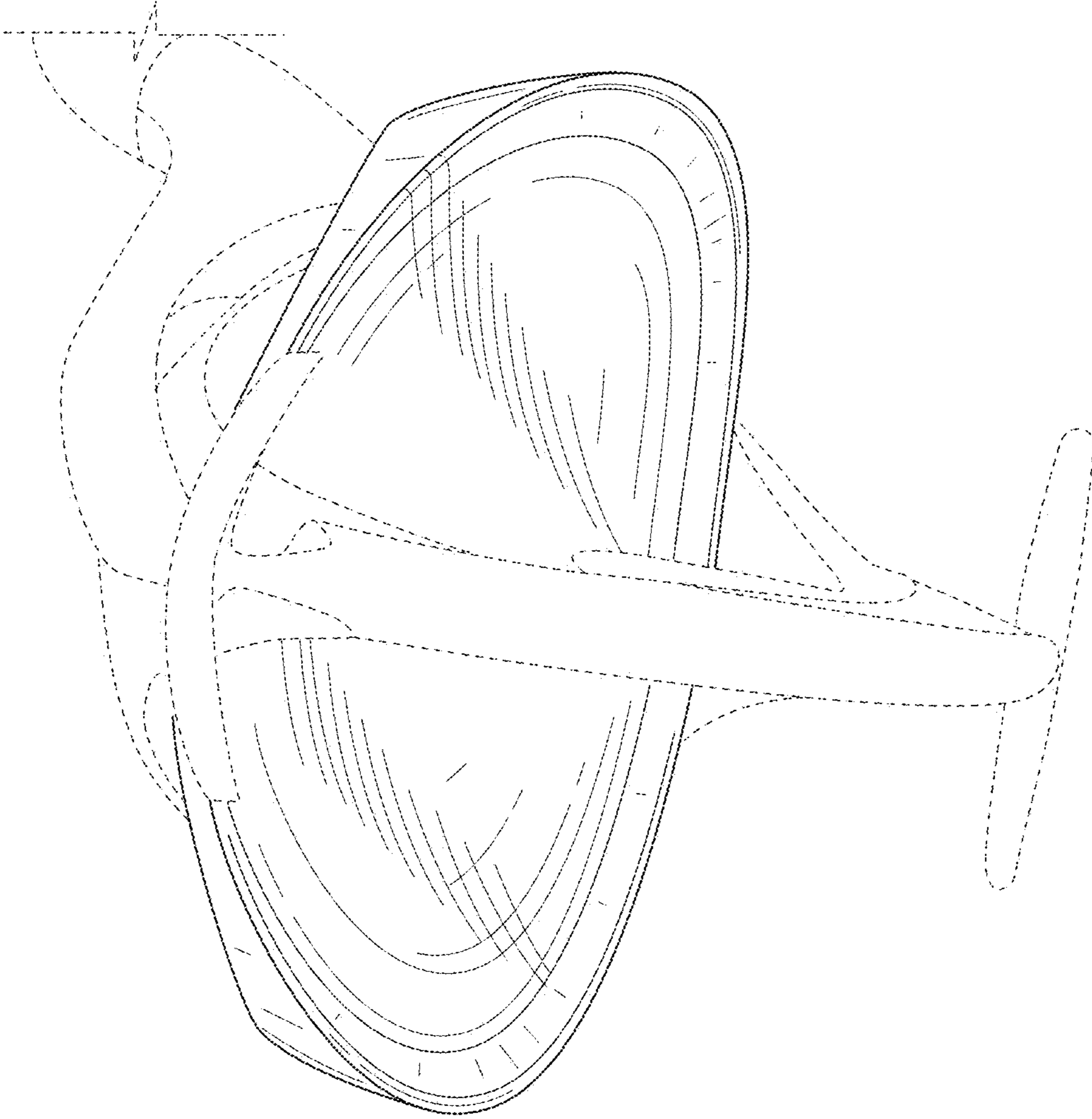

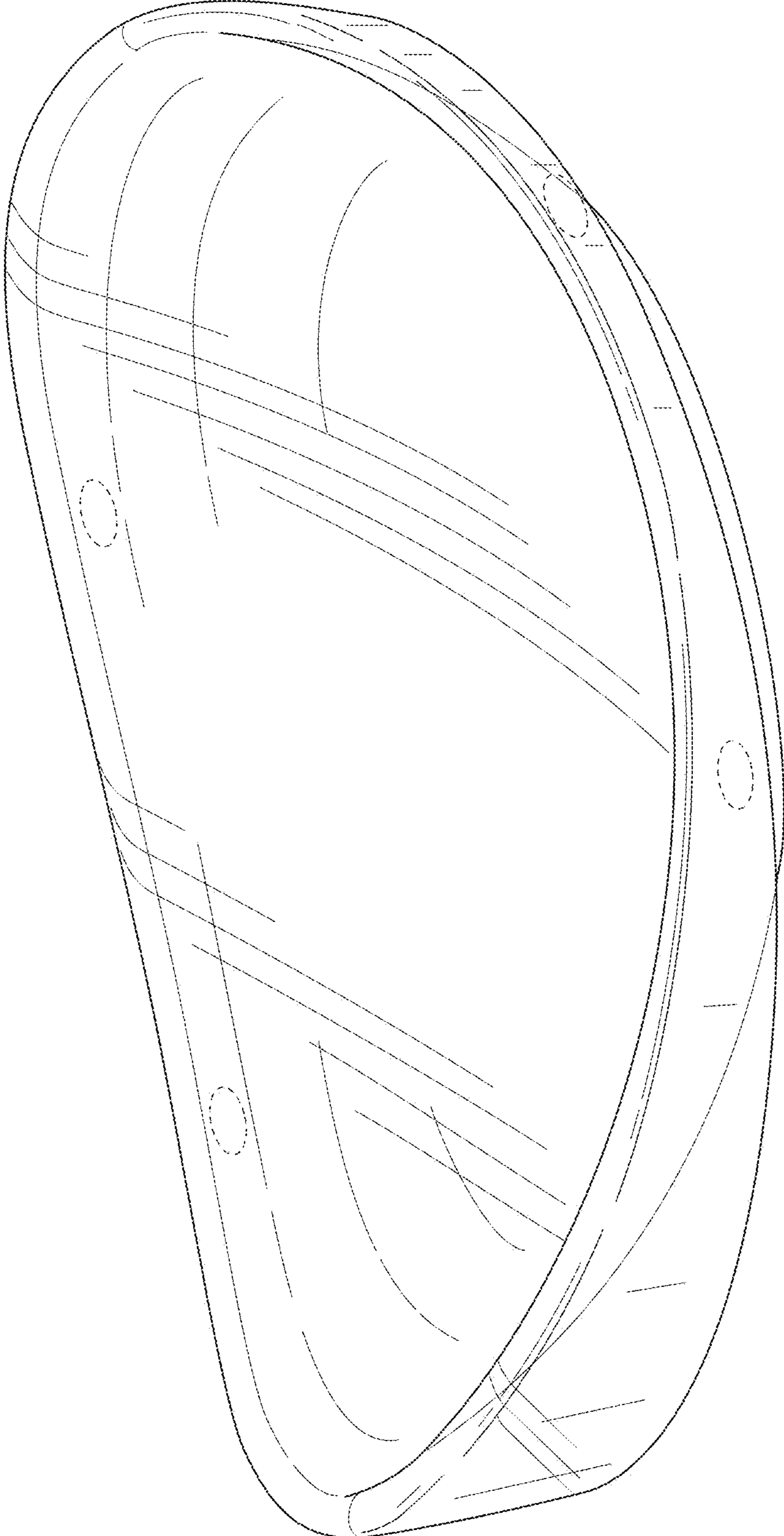

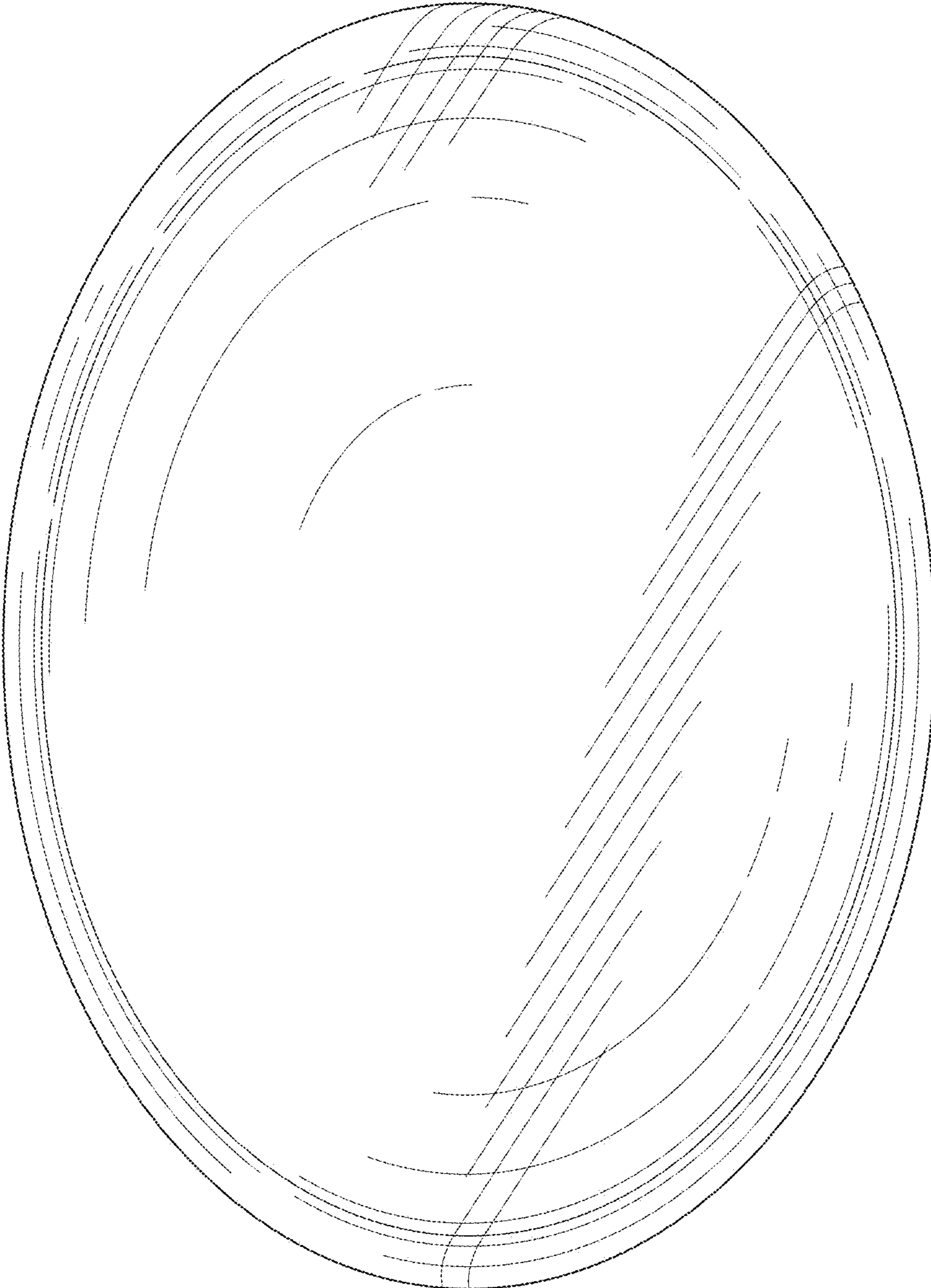

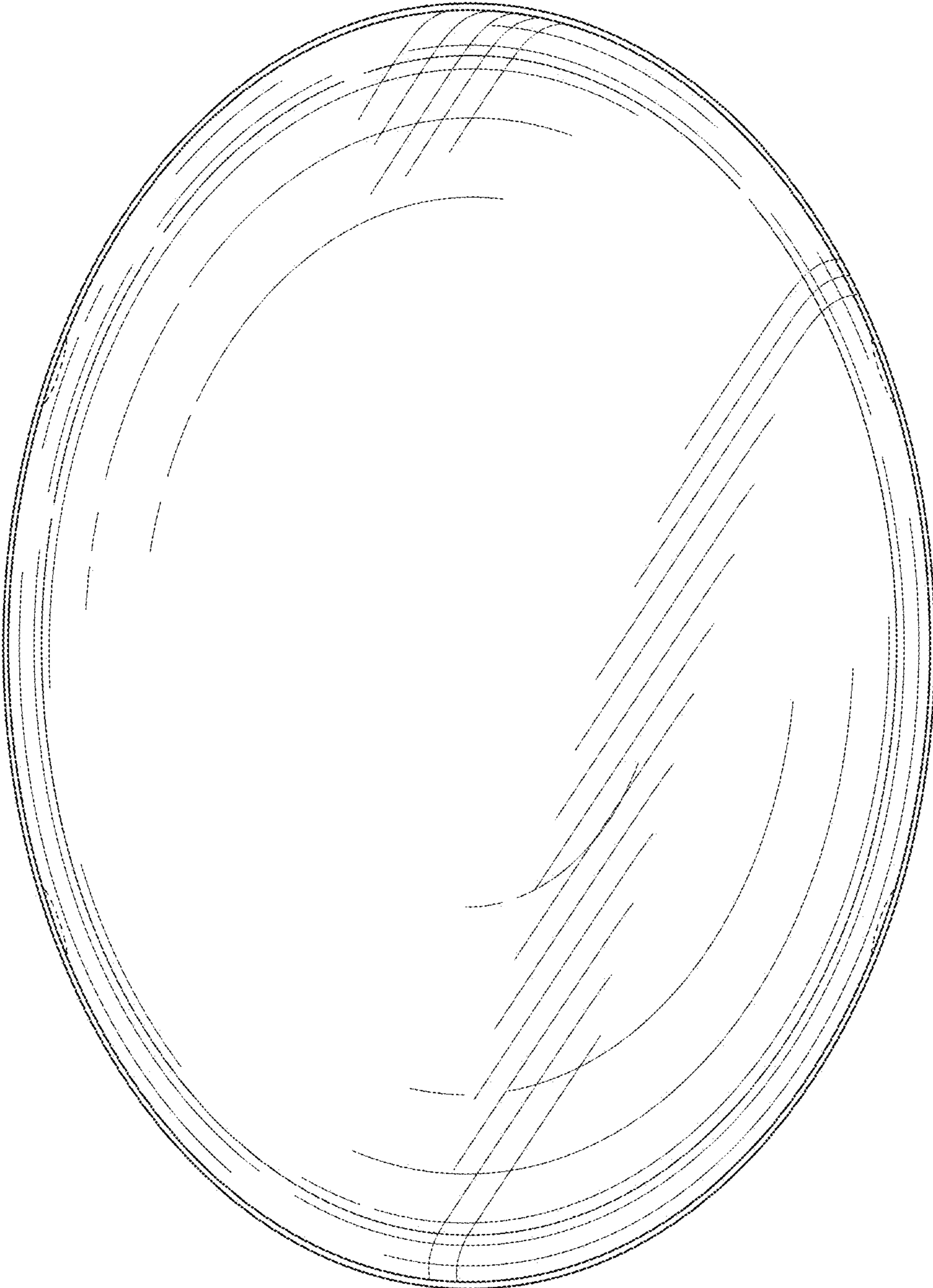

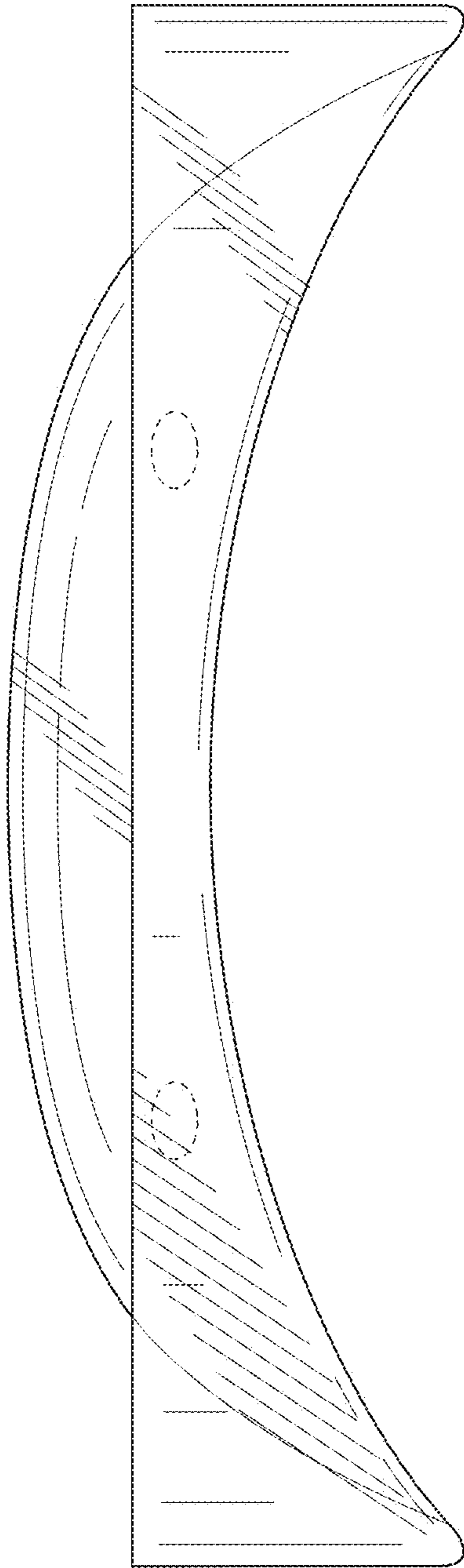

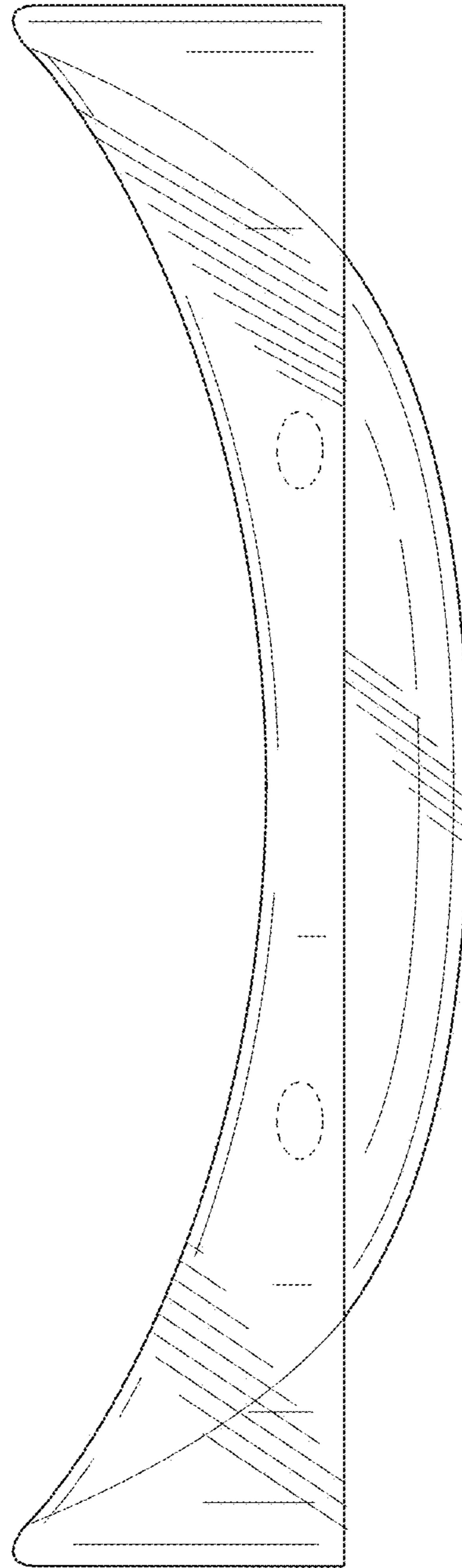

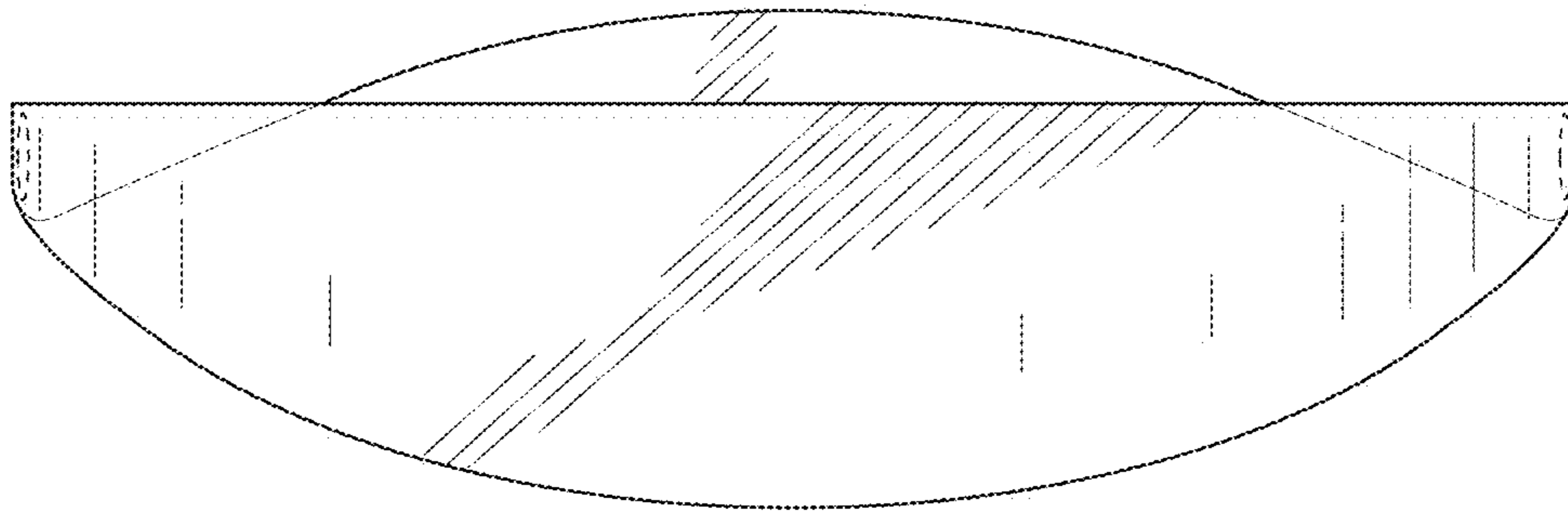

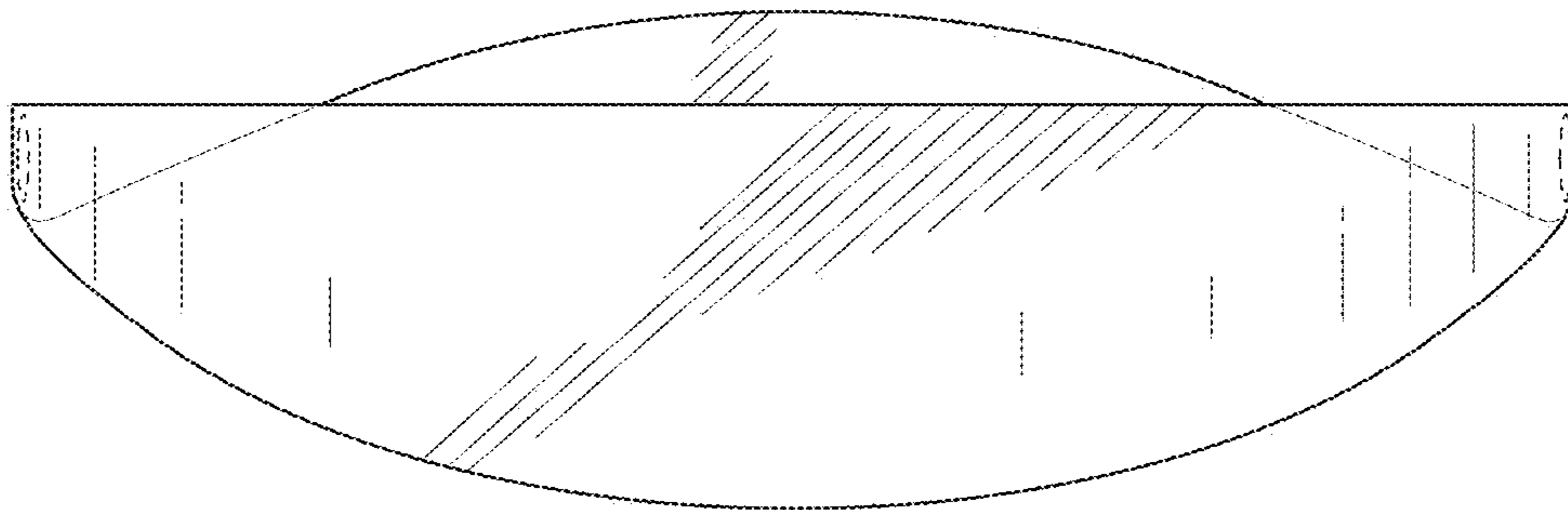

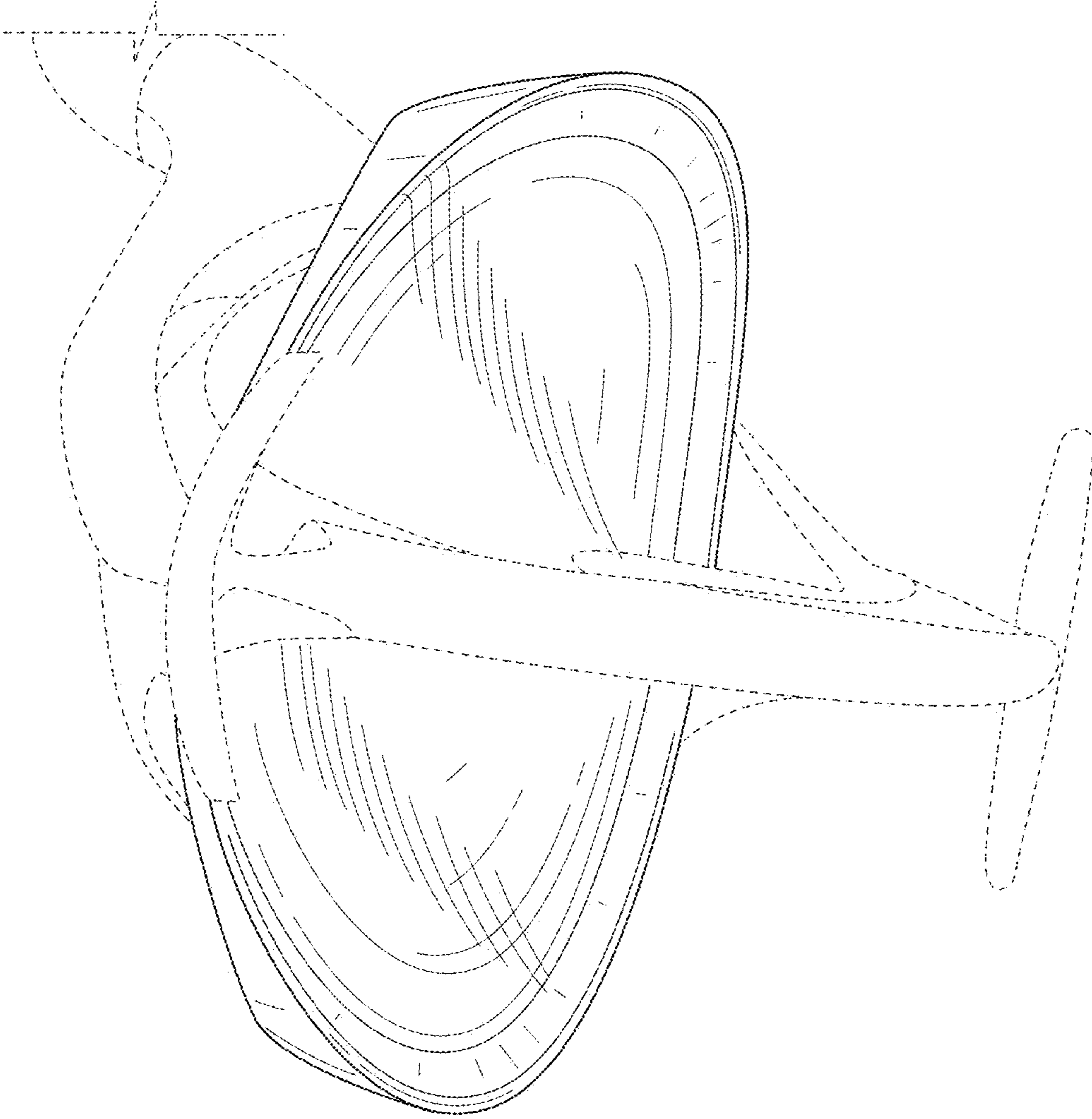
