**DESCRIPTION**

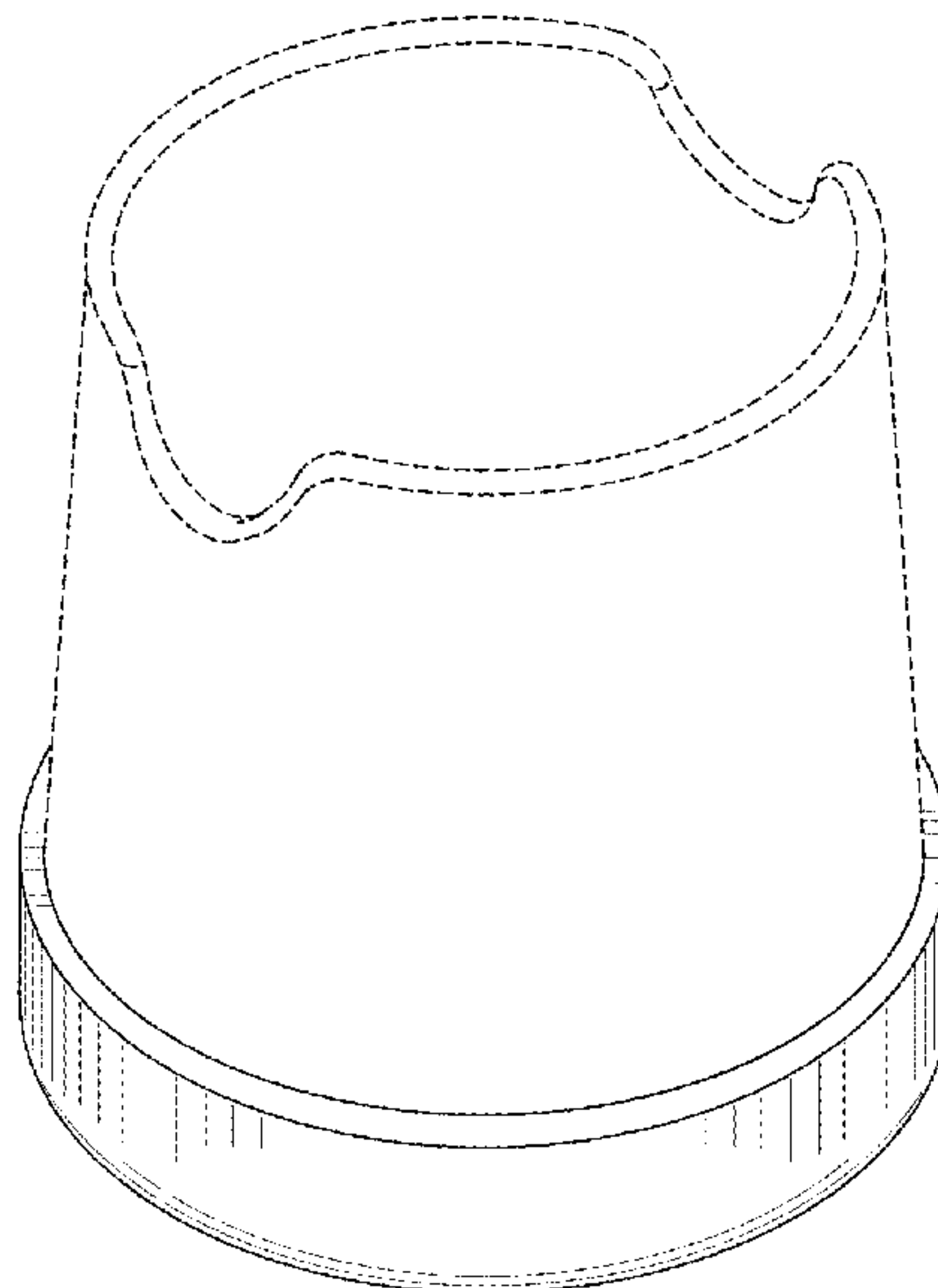
FIG. 1 depicts a front perspective view of an ashtray showing my new design showing a glass in broken lines that forms no part of the claimed design;

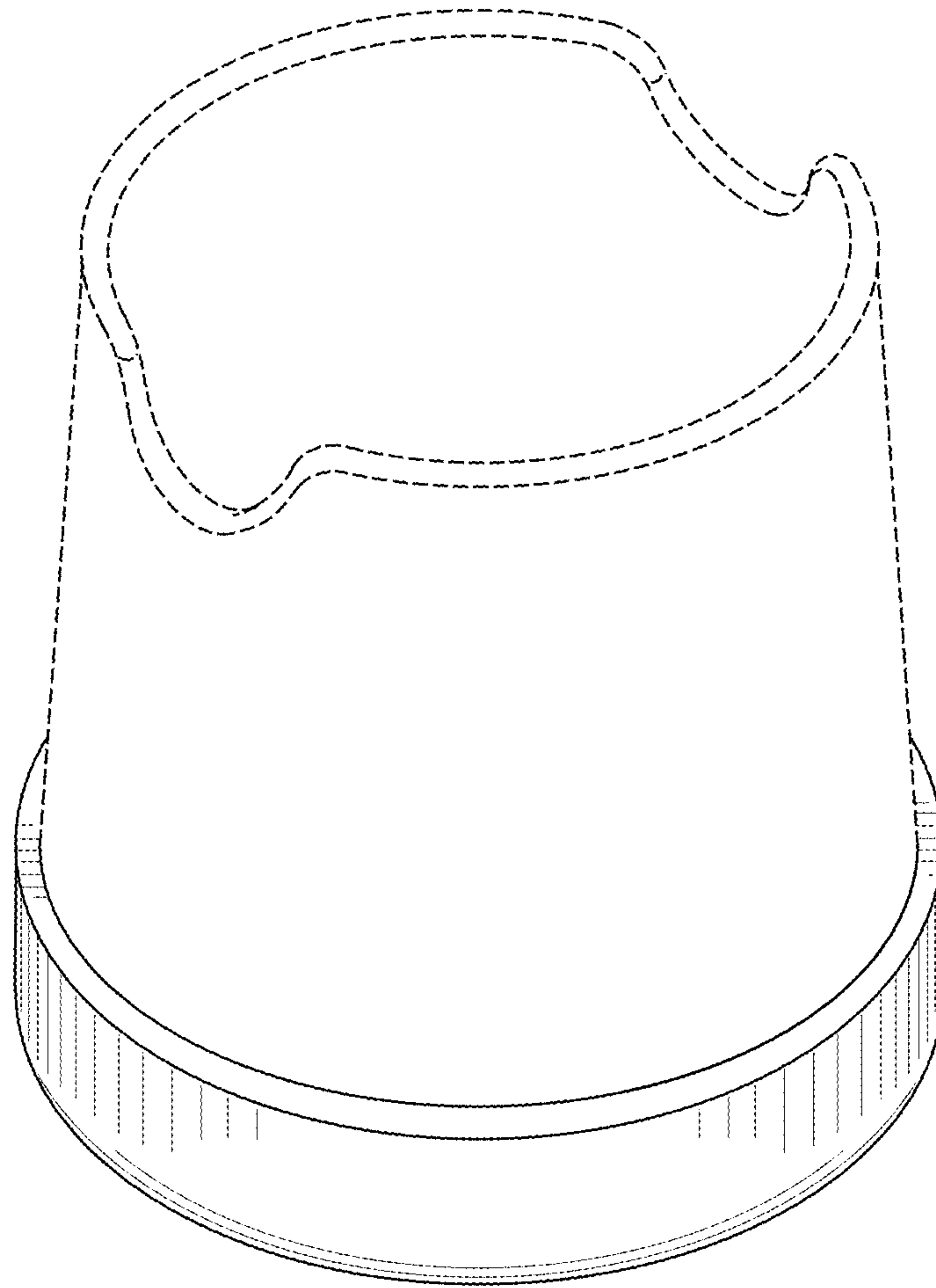

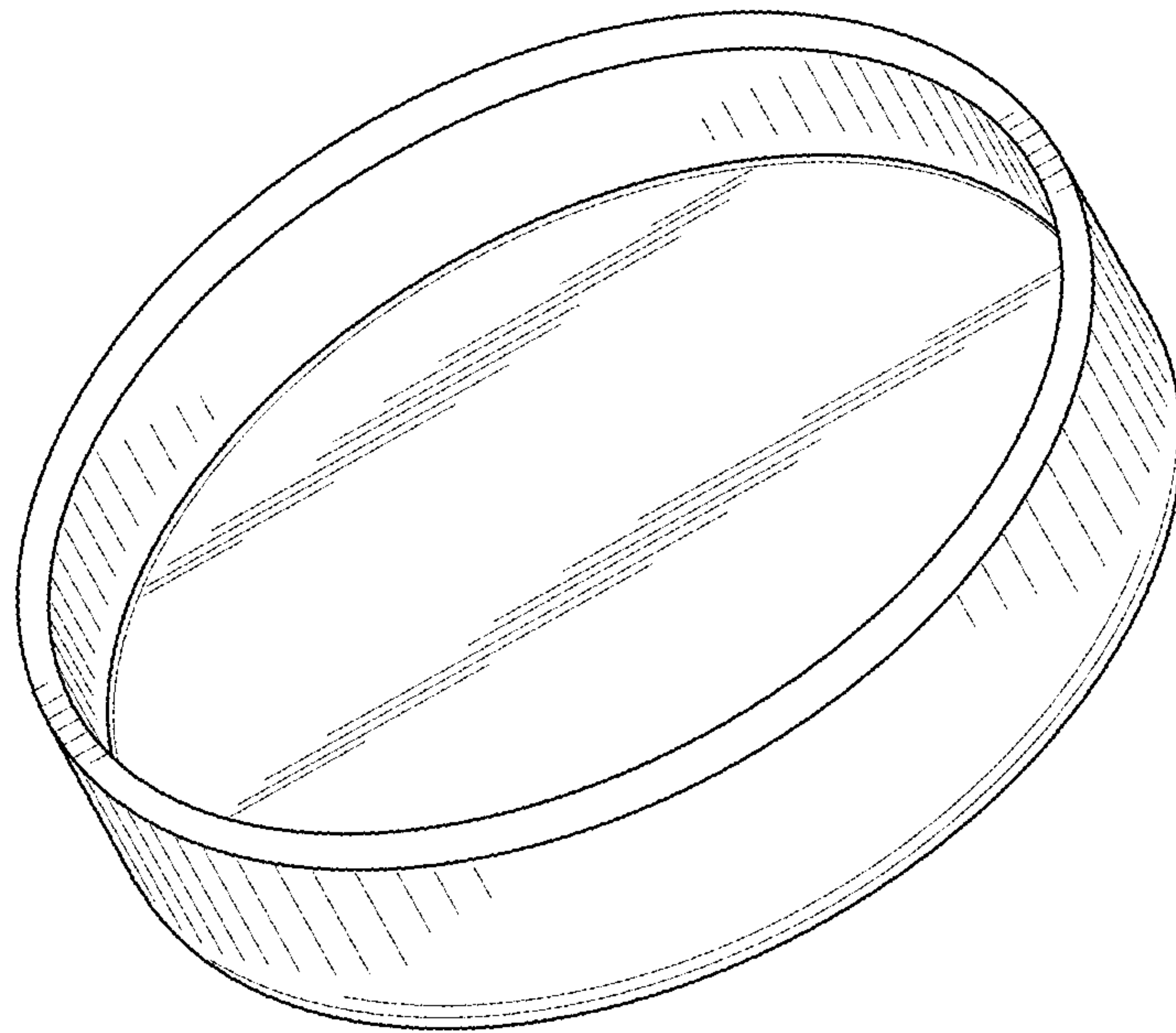

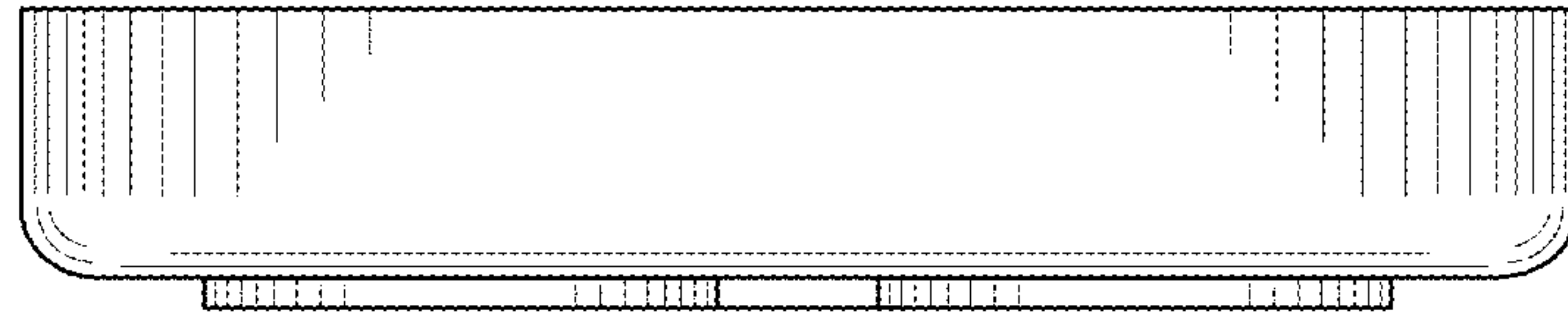

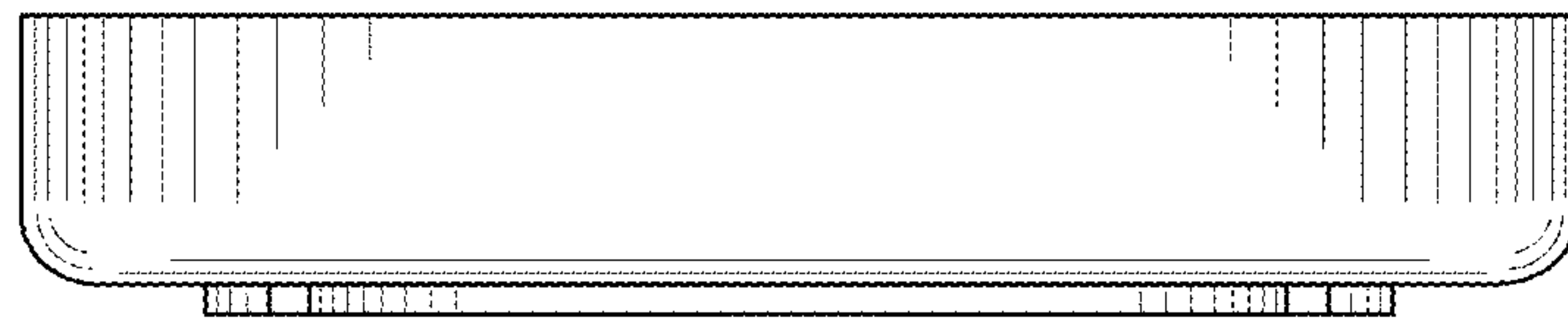

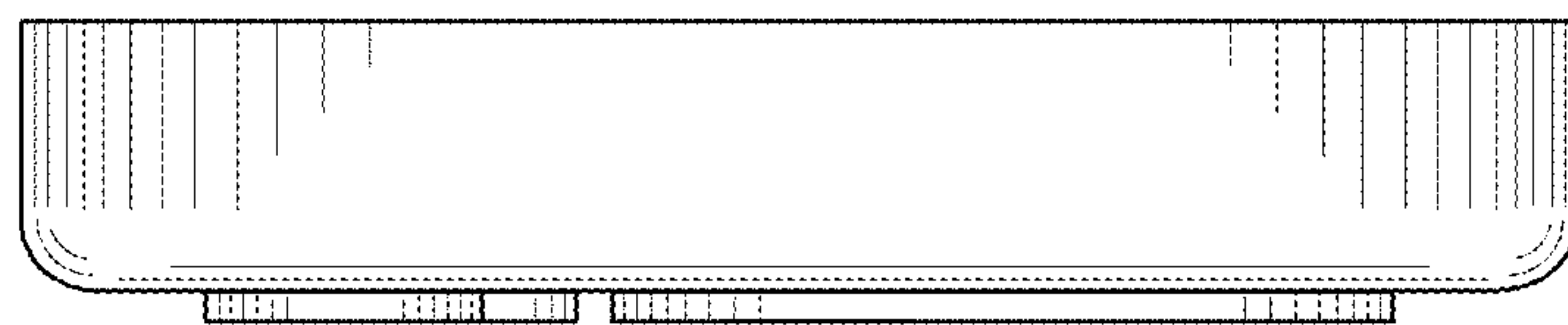

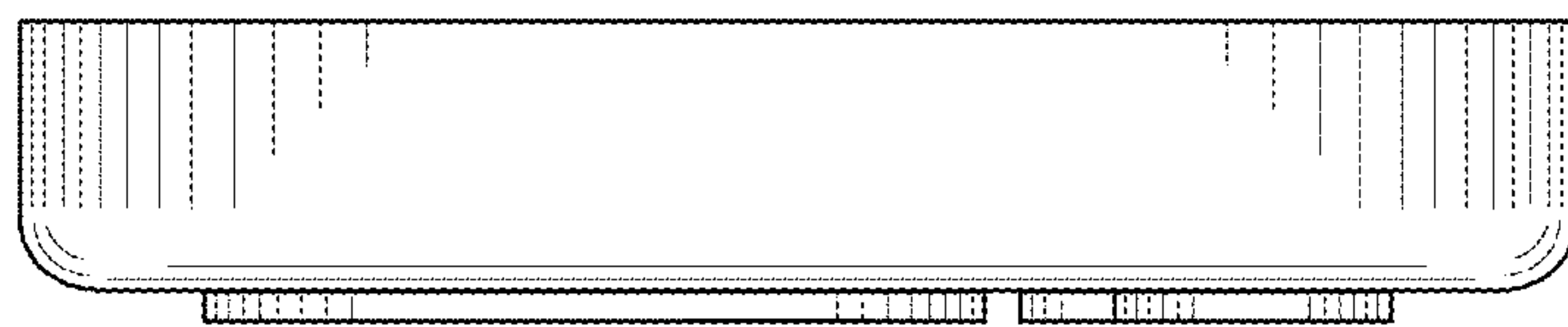

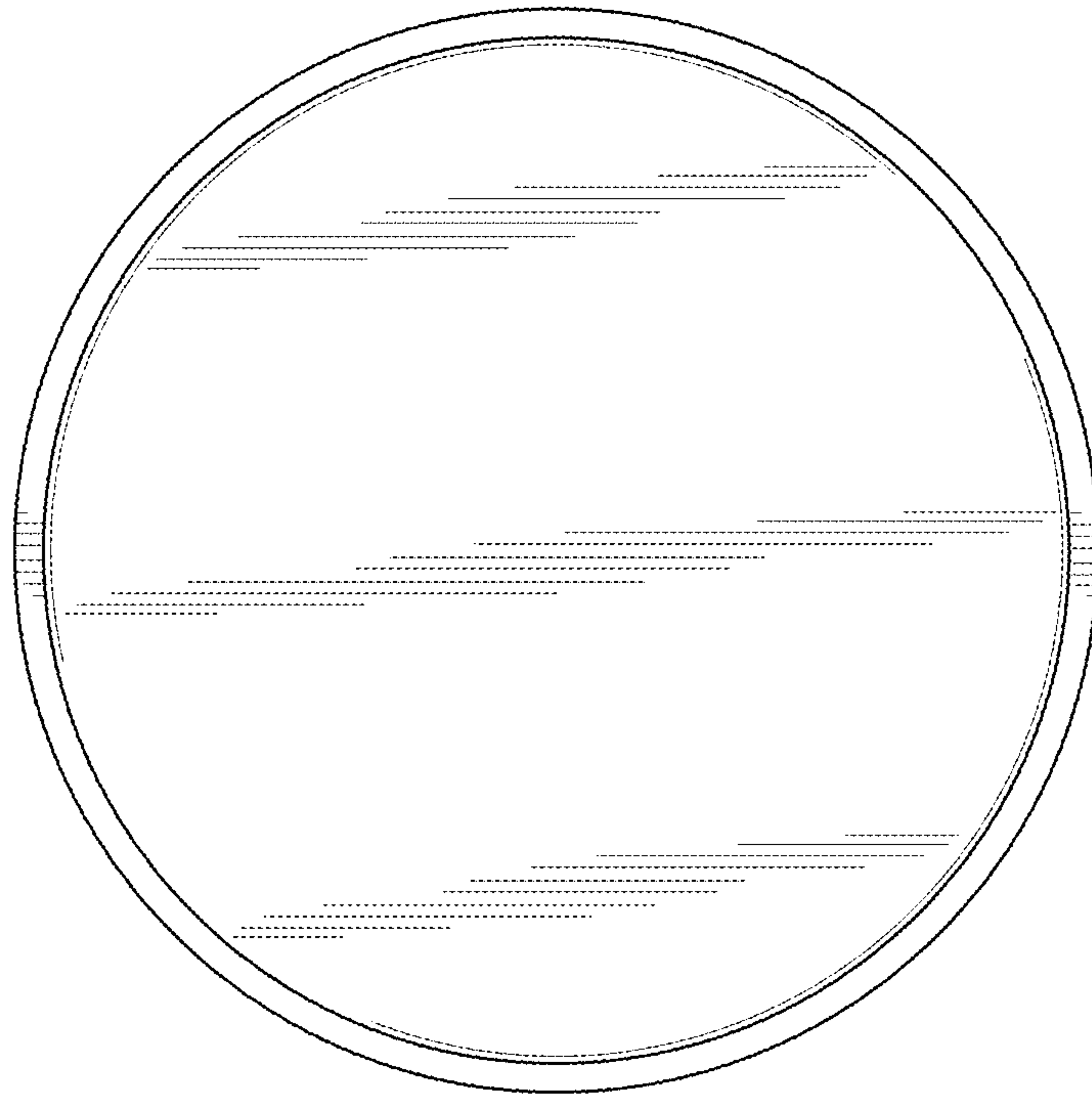

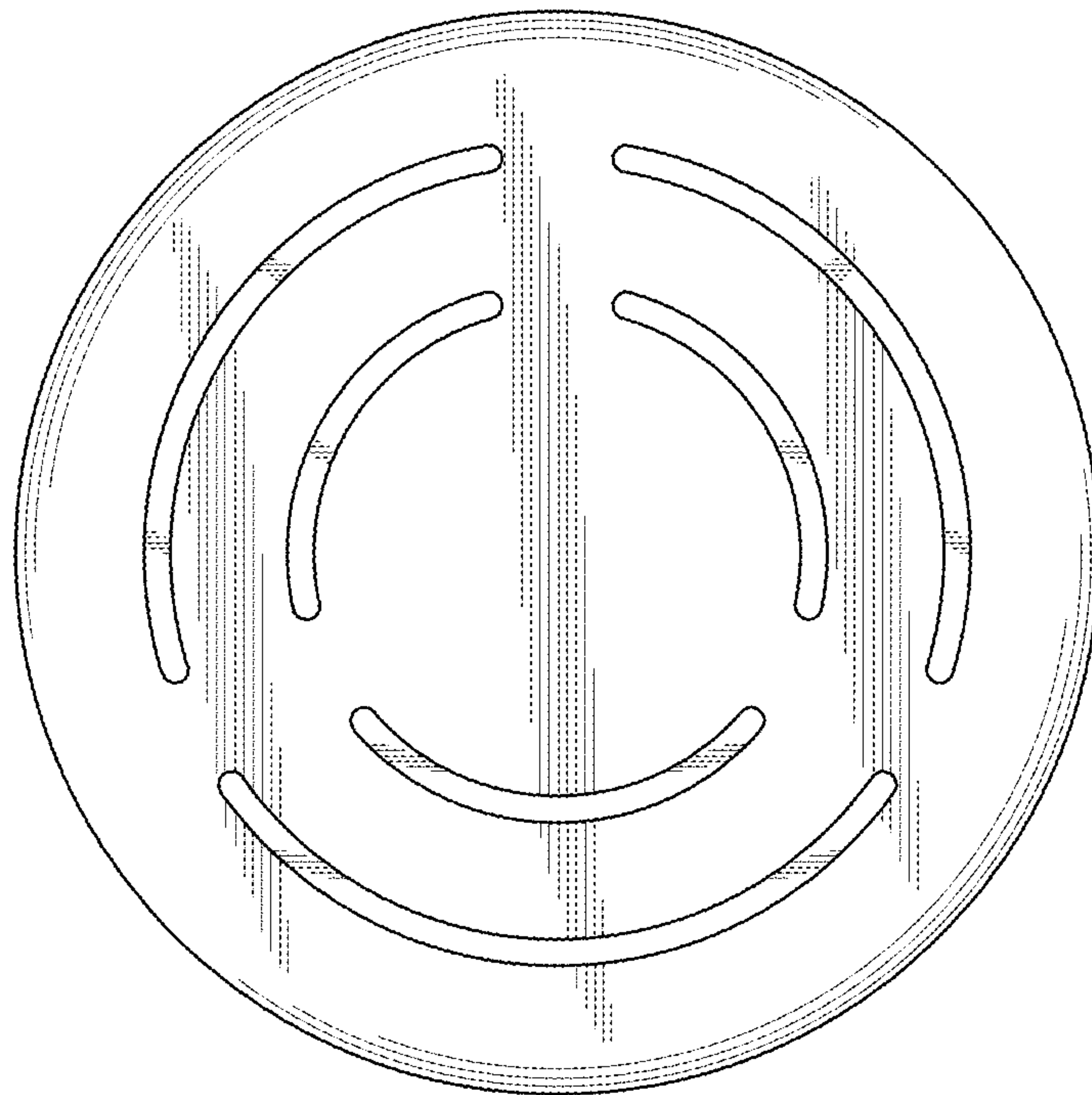
