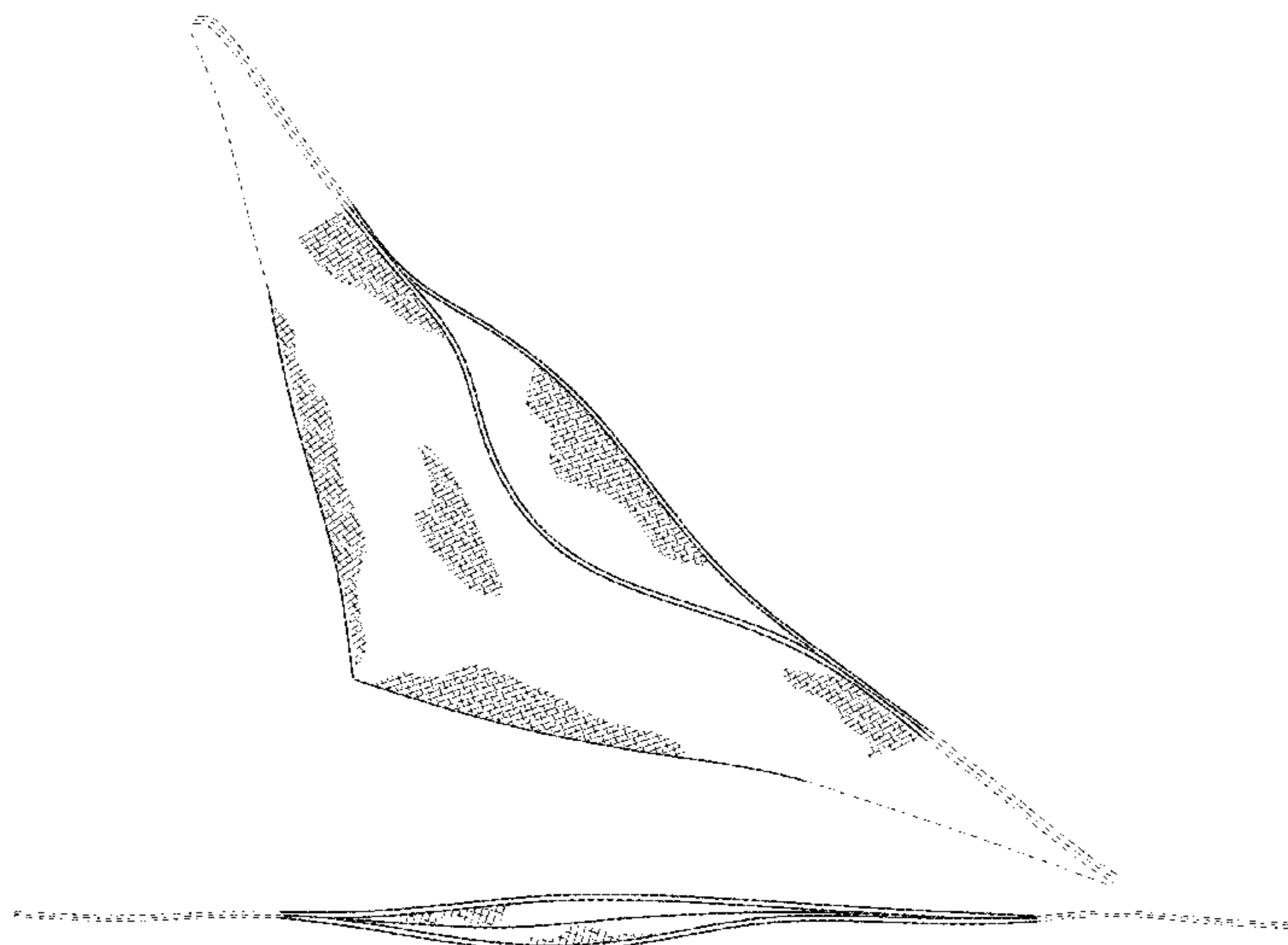
CLAIM

I claim the ornamental design for a pet bandana, substan-
tially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet bandana showing the
new design, shown in a state of use;
FIG. 2 is a perspective view of the pet bandana shown in a
knotted configuration;
FIG. 3 is a front perspective view of the pet bandana shown
in an unknotted configuration;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a left view thereof;
FIG. 7 is a right view thereof;
FIG. 8 is a top view thereof; and,
FIG. 9 is a bottom view thereof.
The broken lines showing a dog in FIG. 1 depicts environ-
mental subject matter and forms no part of the claimed
design. The remaining broken lines shown in the drawings
depict portions of the pet bandana that form no part of the
claimed design.

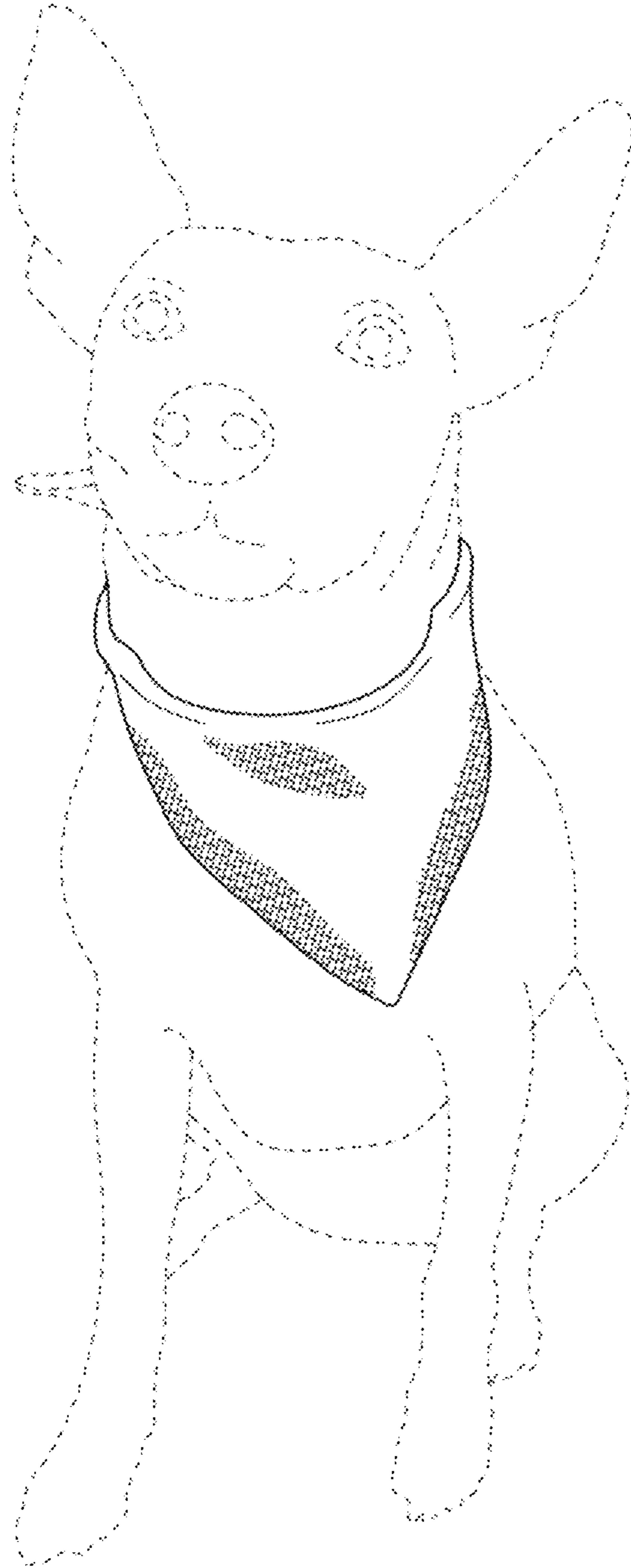

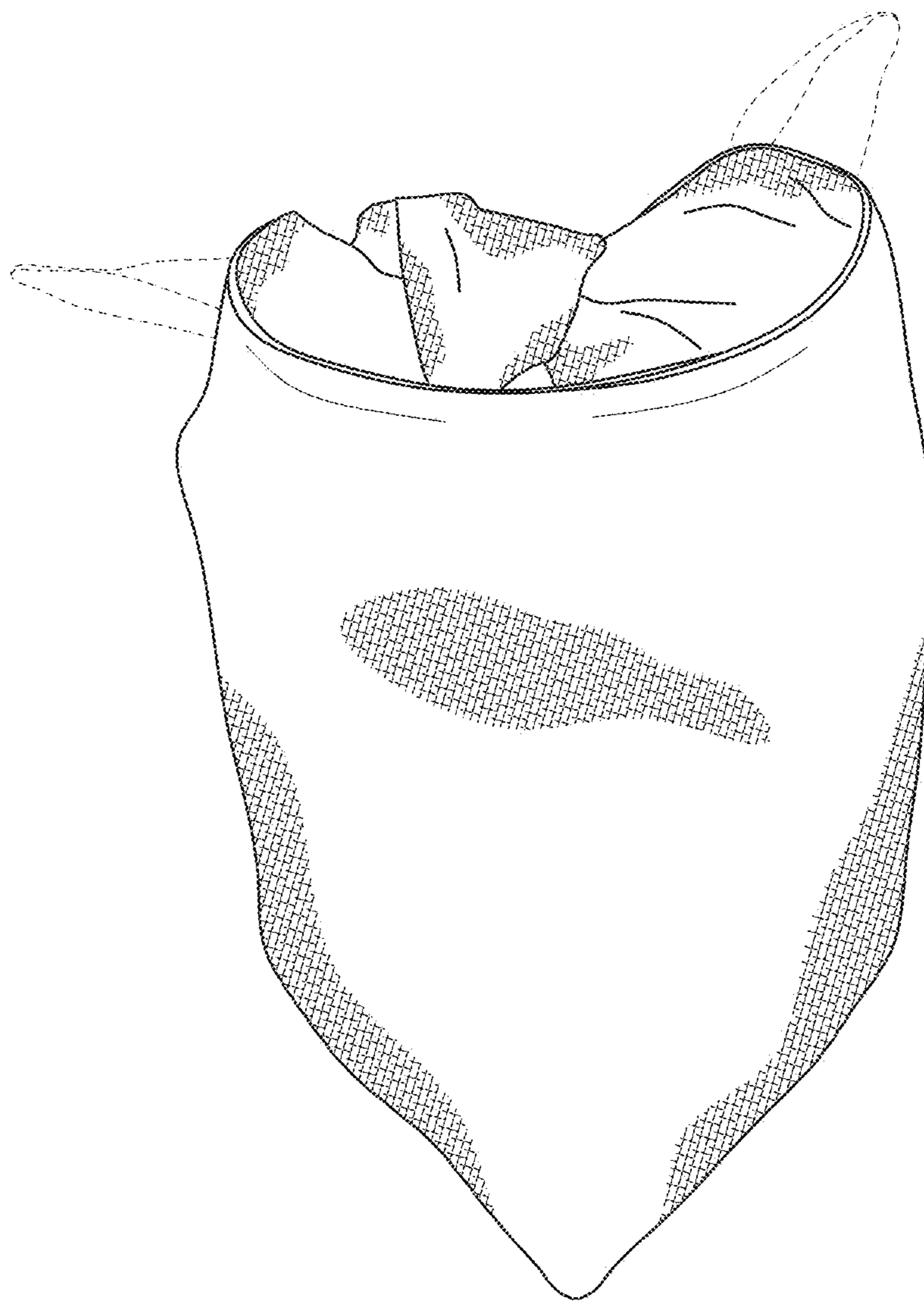

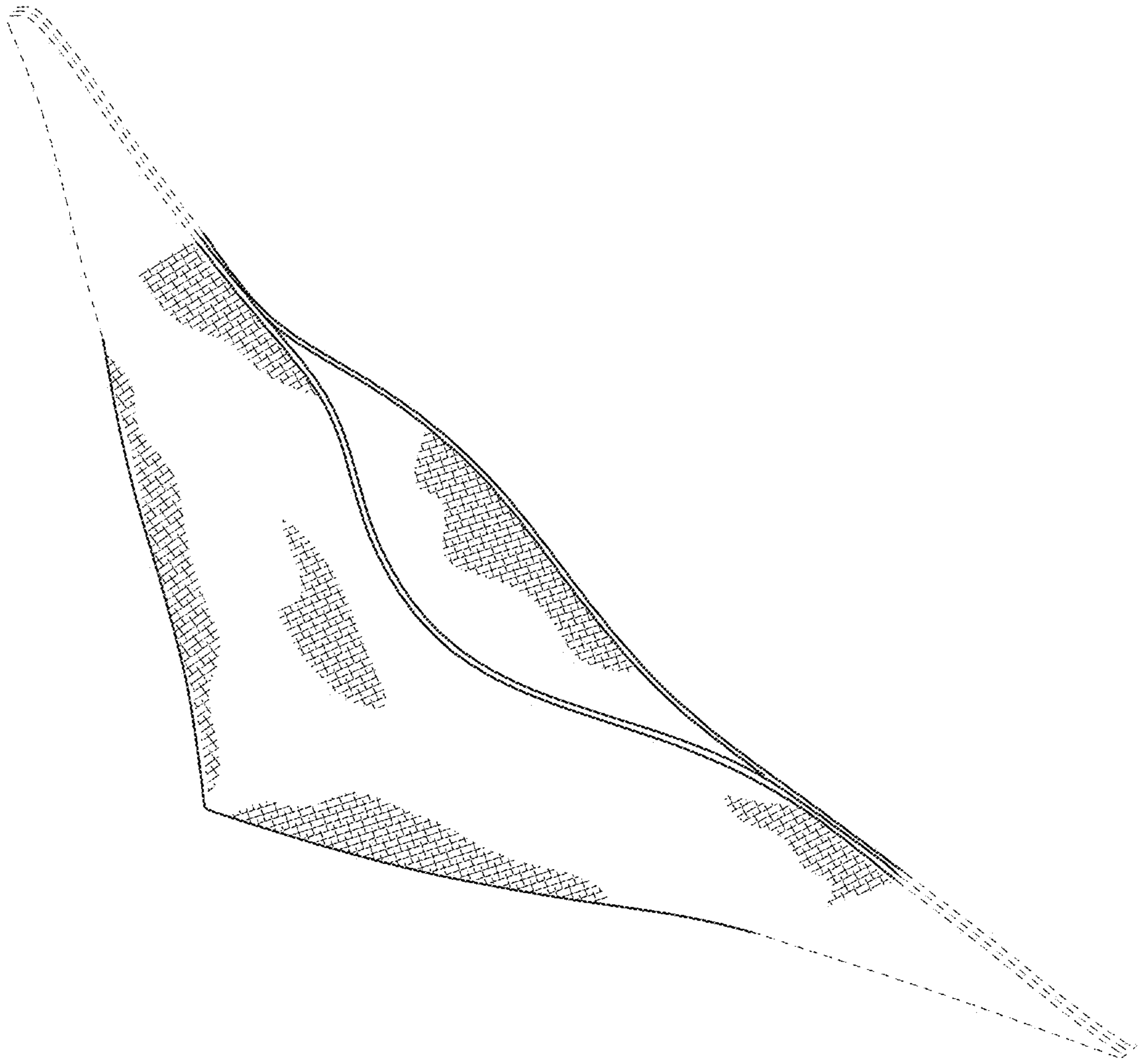

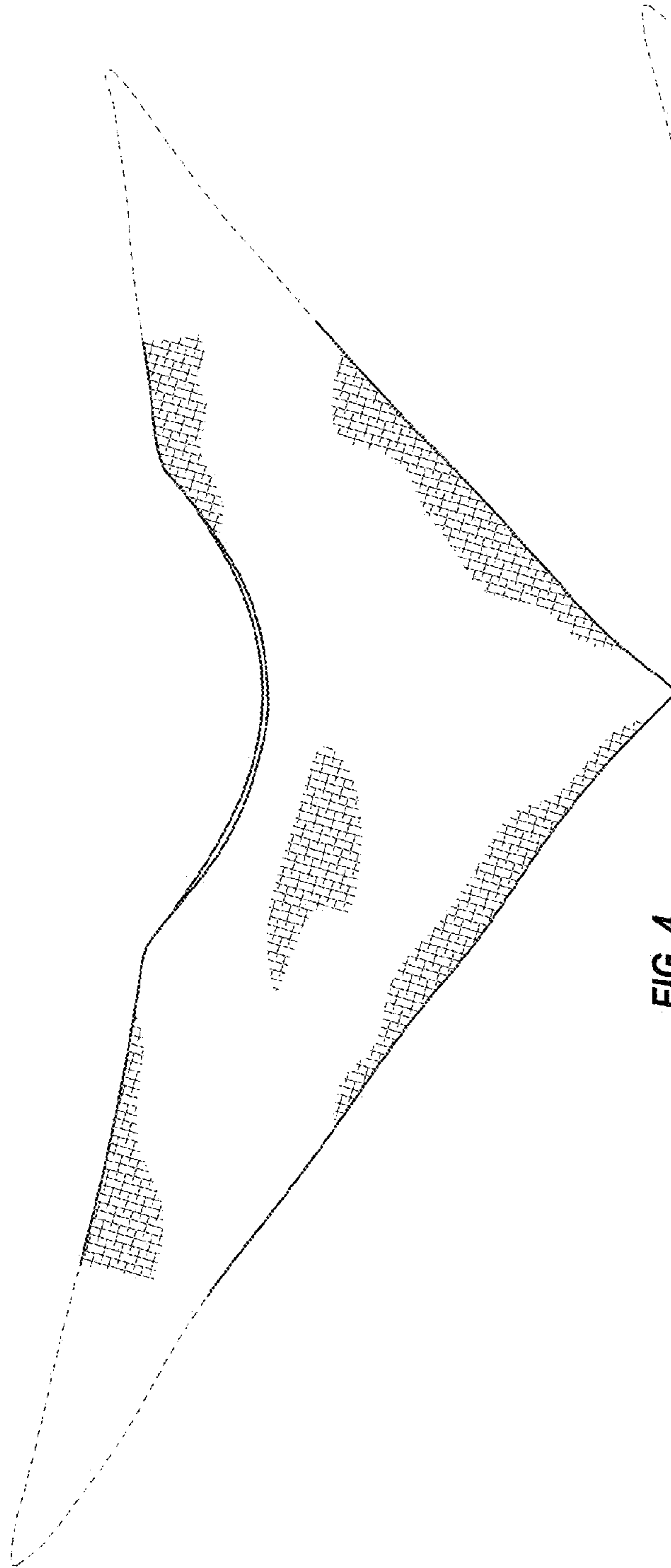

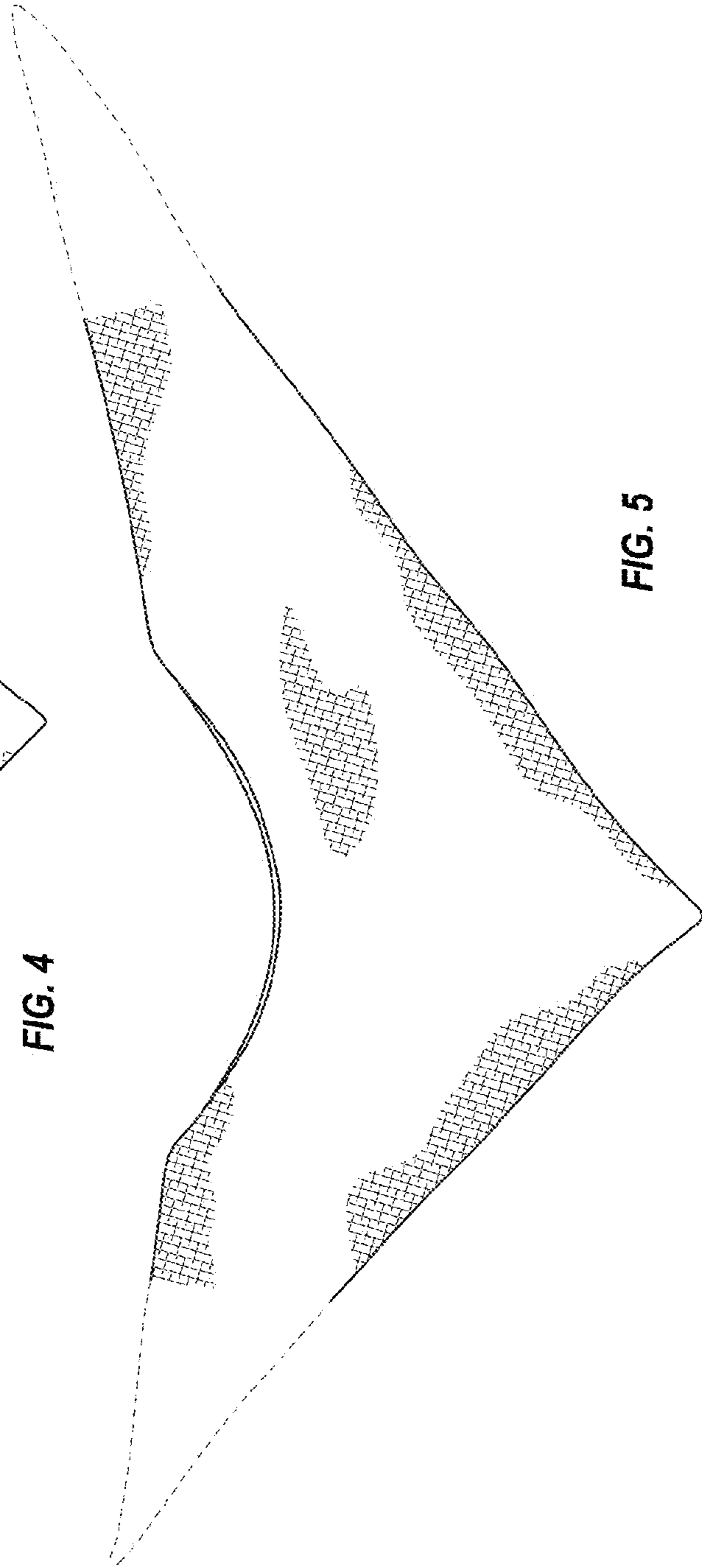

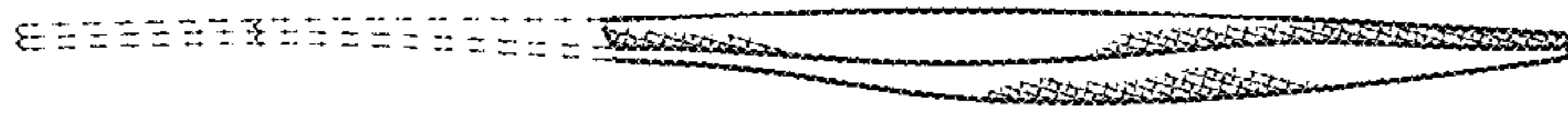

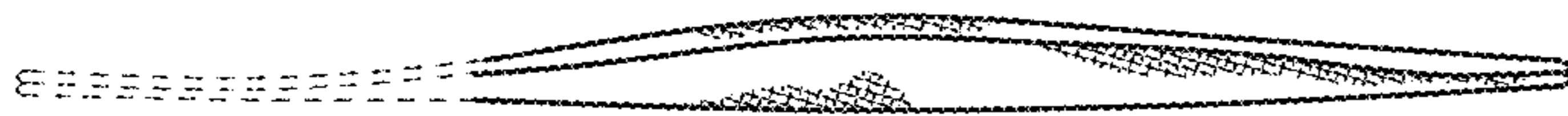

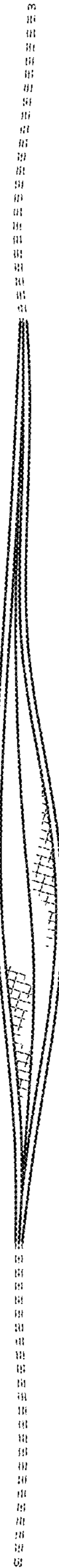

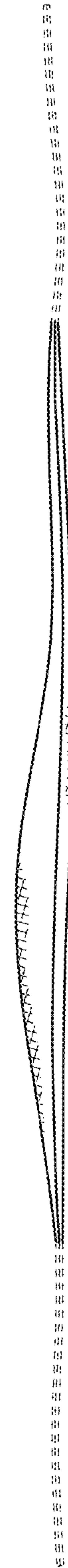
