DESCRIPTION

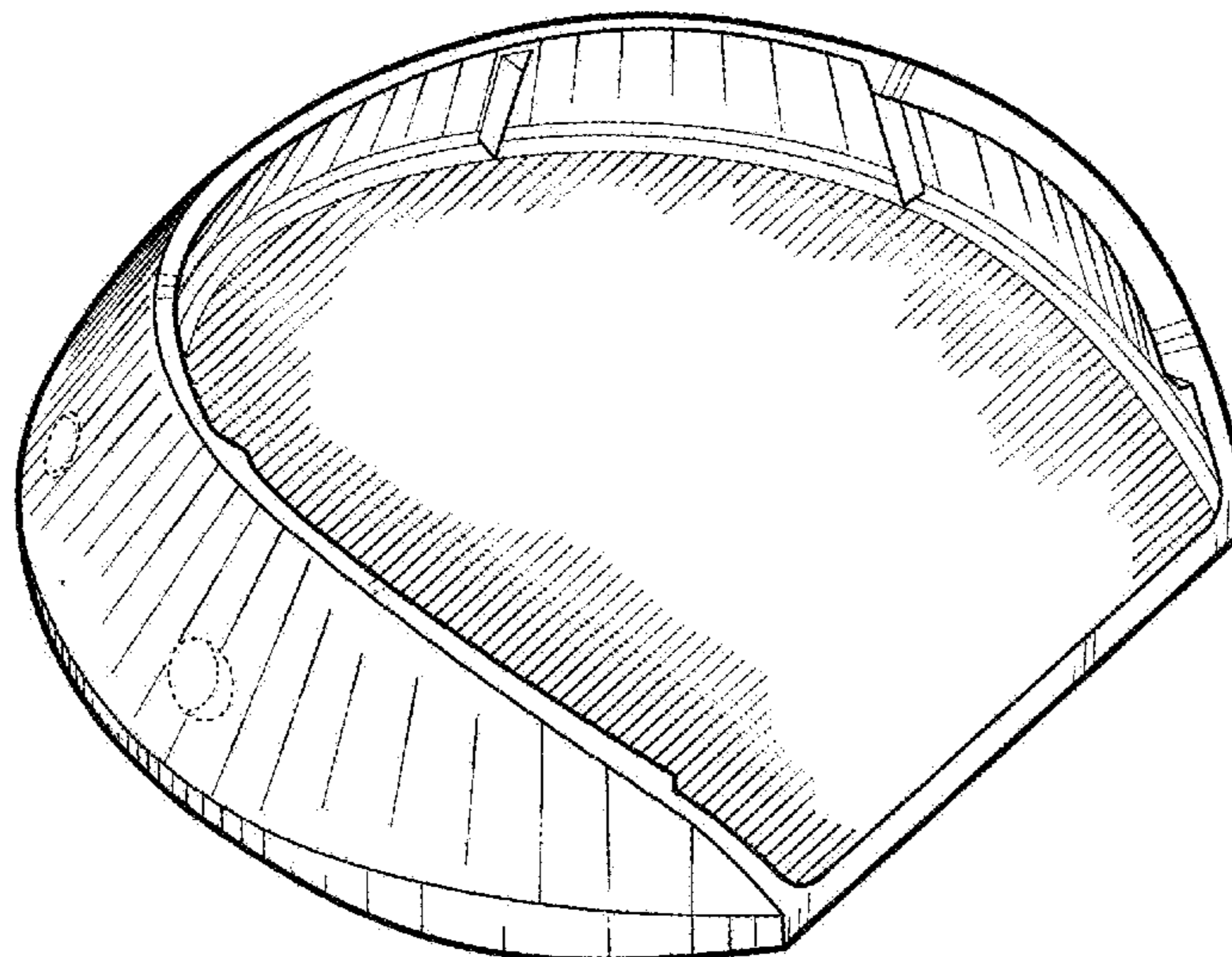
FIG. 1 is a top, rear perspective view of a horseshoe, showing my new design;

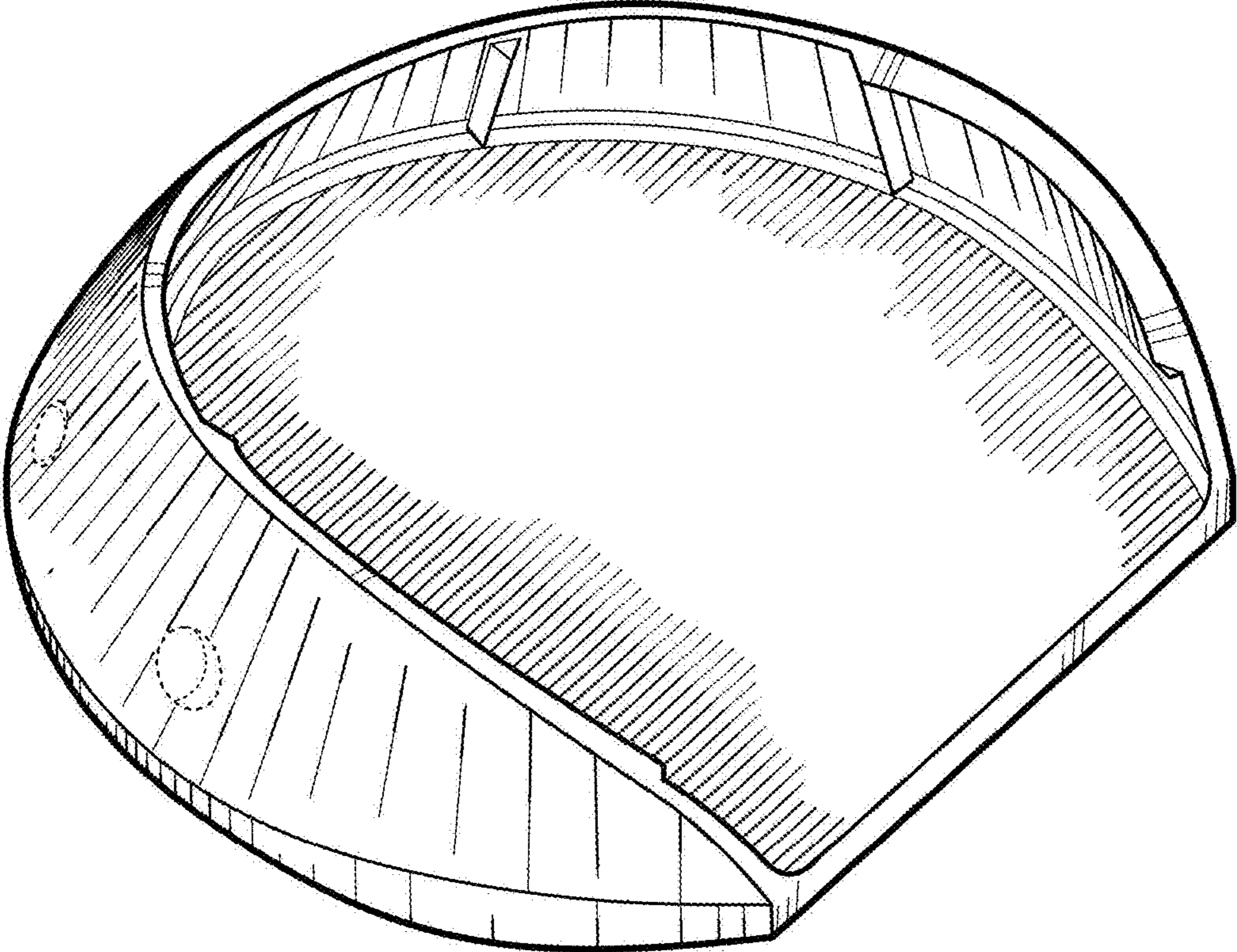

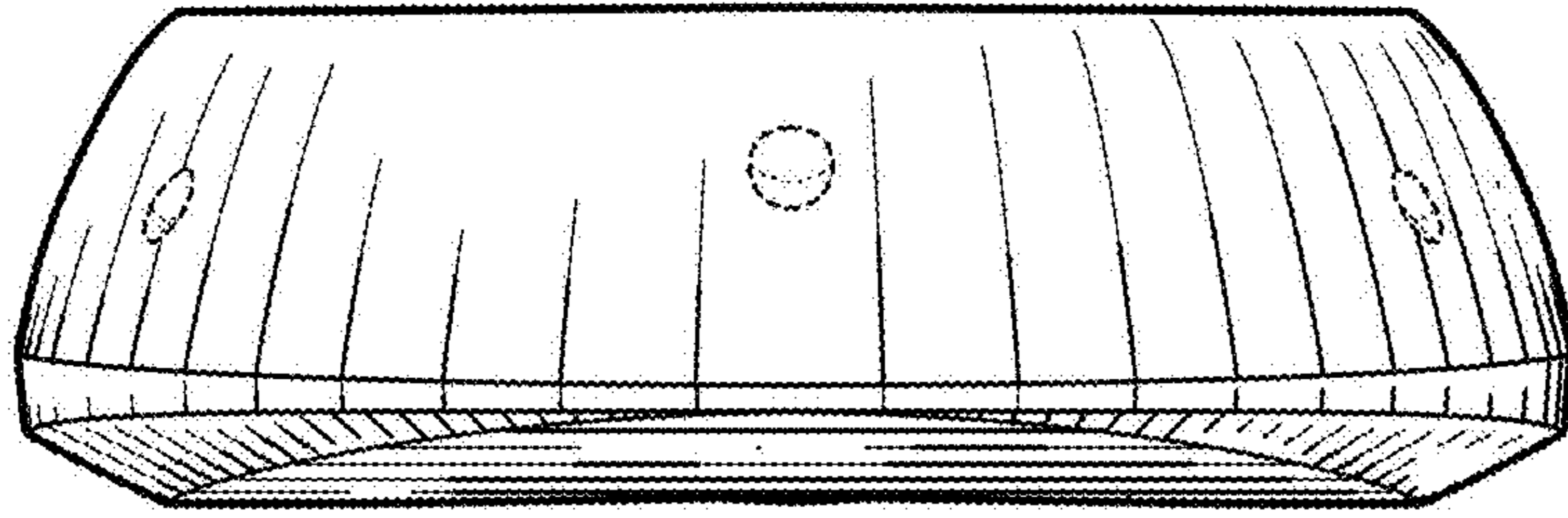

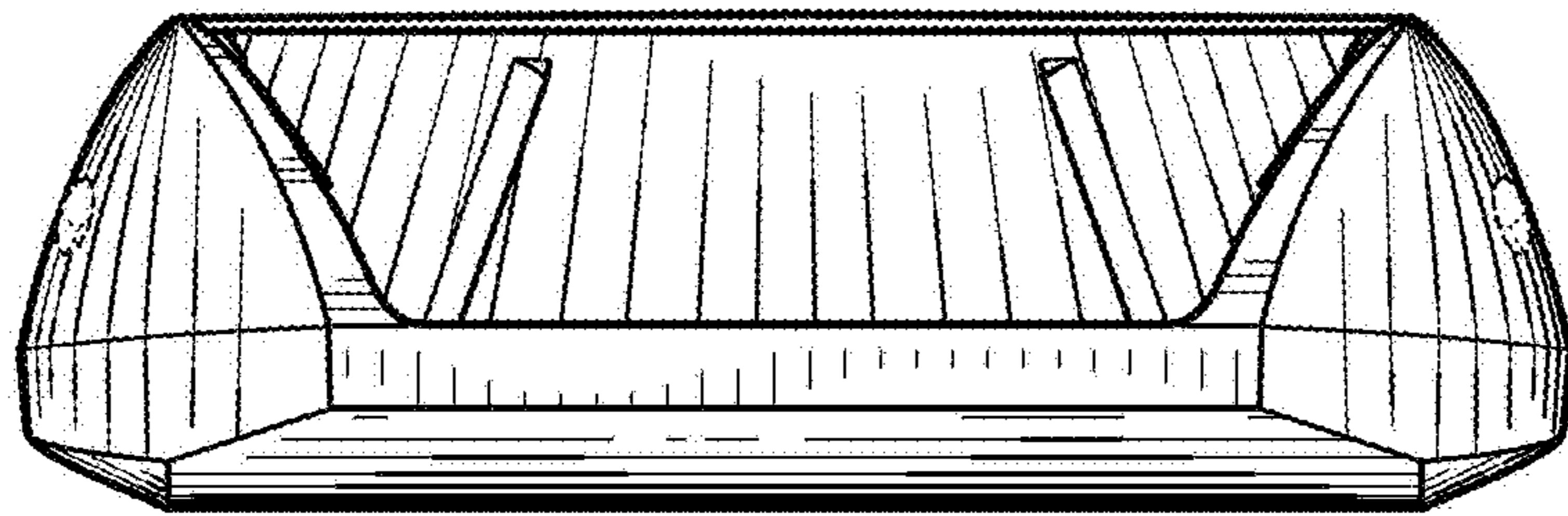

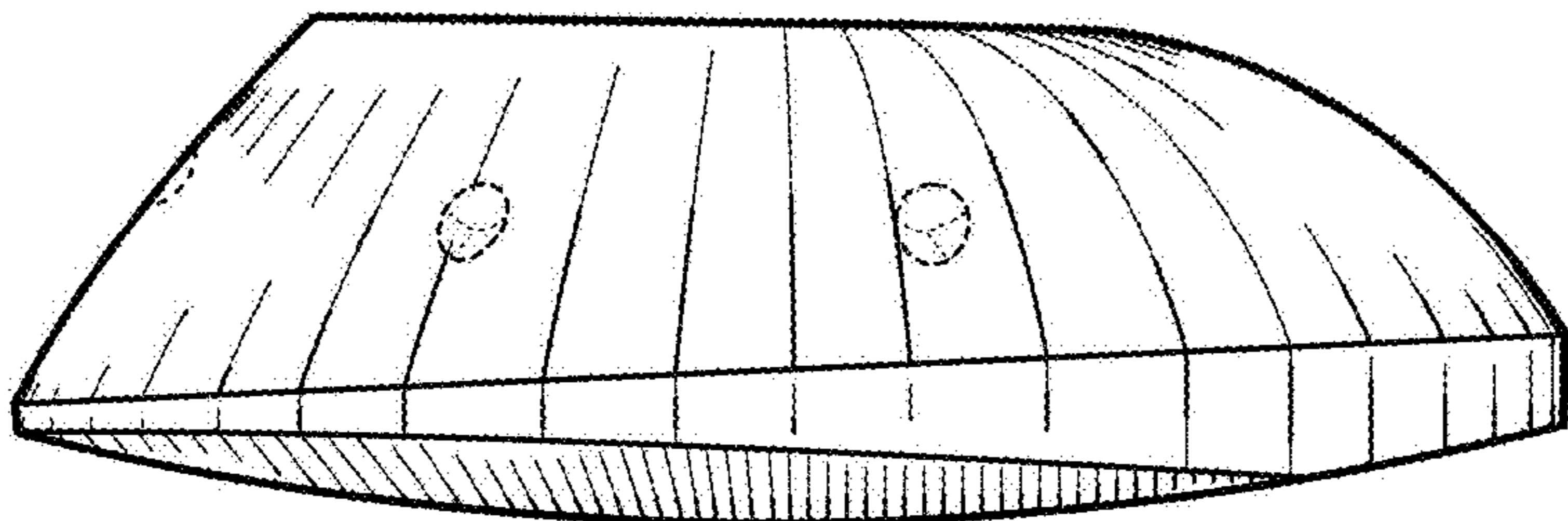

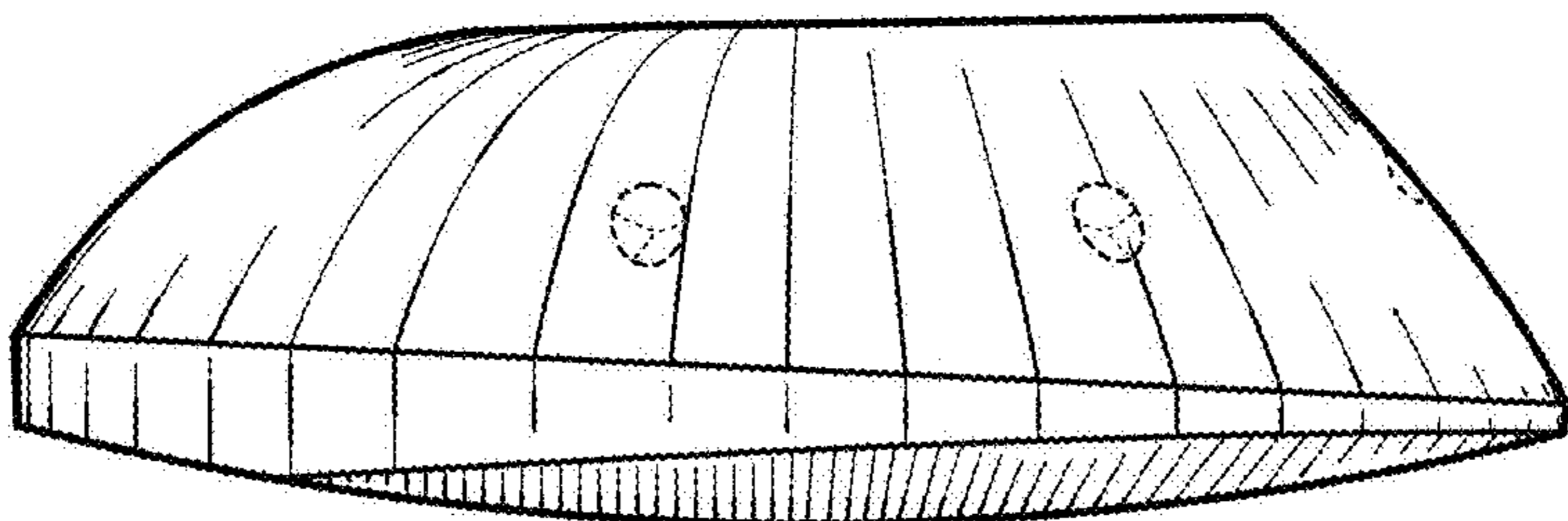

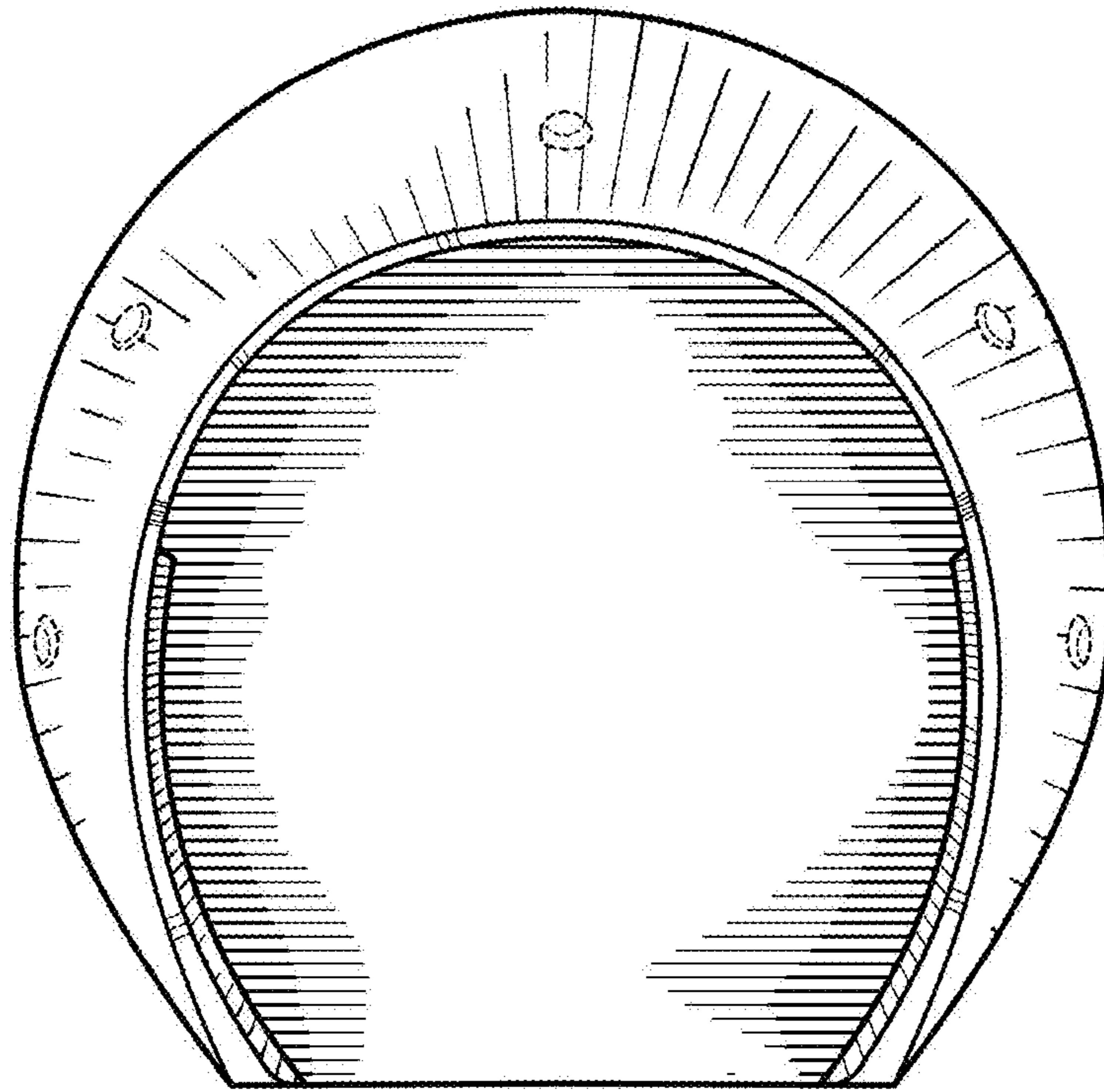

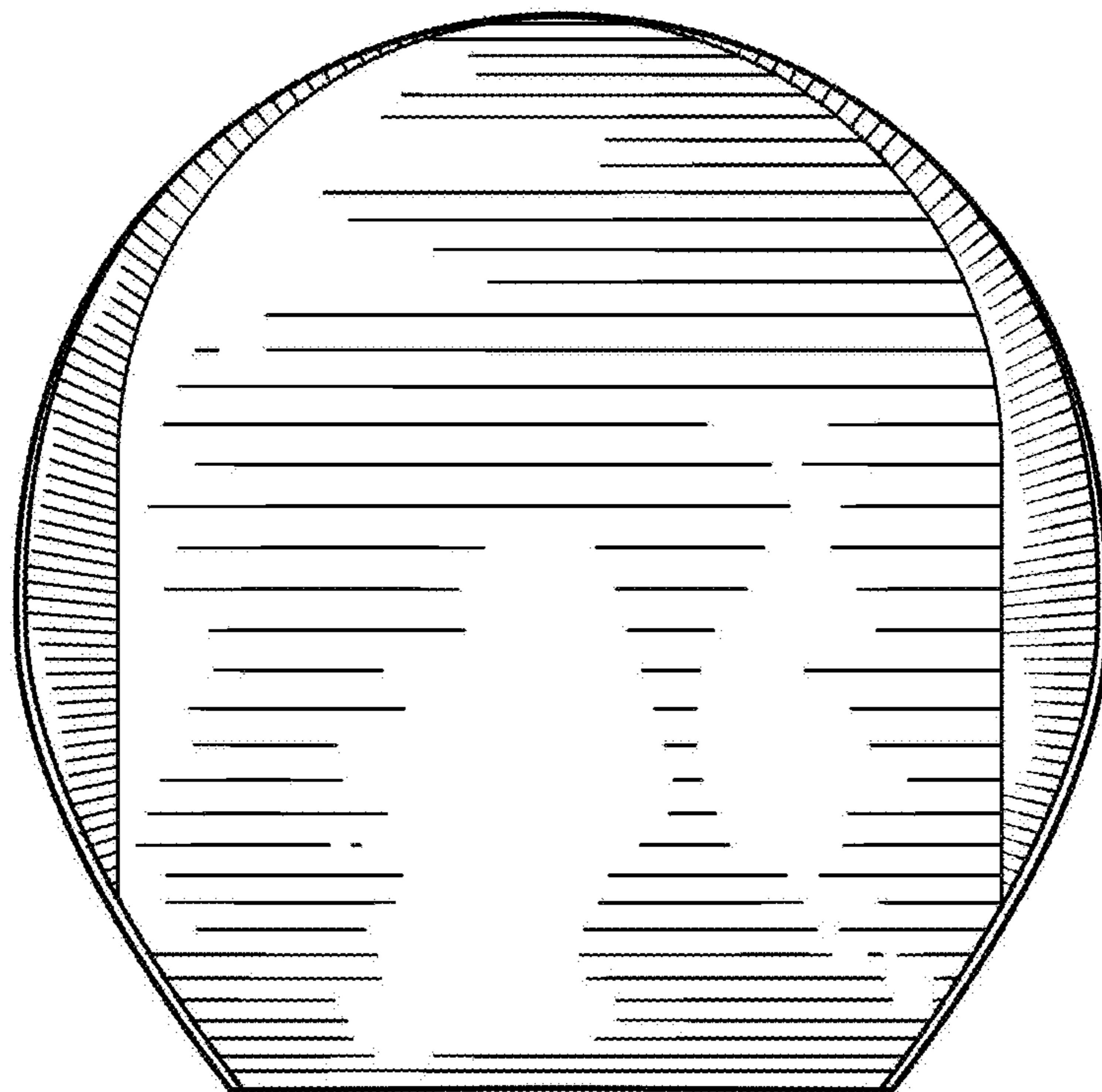
