The ornamental design for a mailbox post, as shown and described.

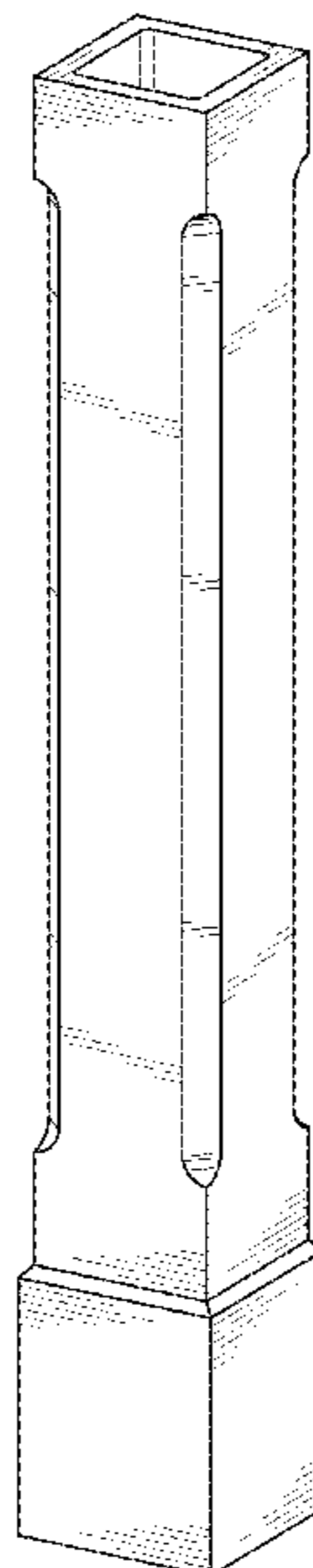
DESCRIPTION

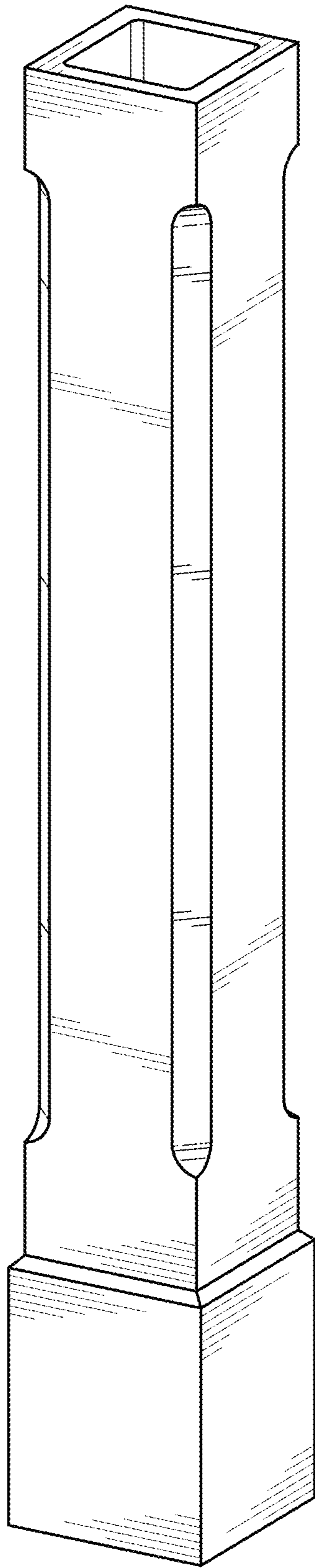

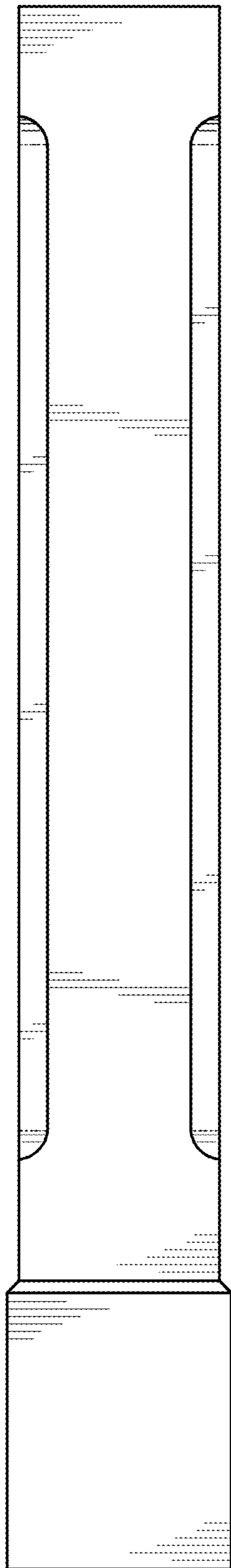

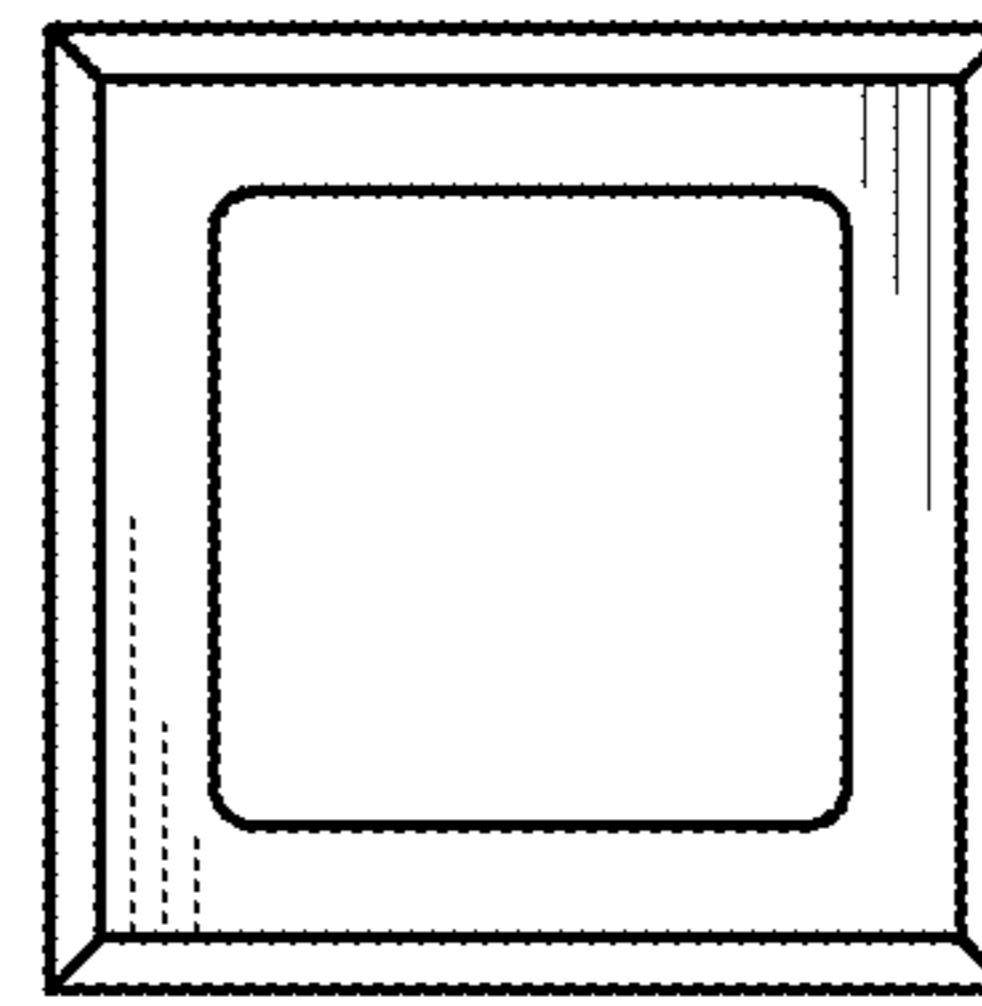

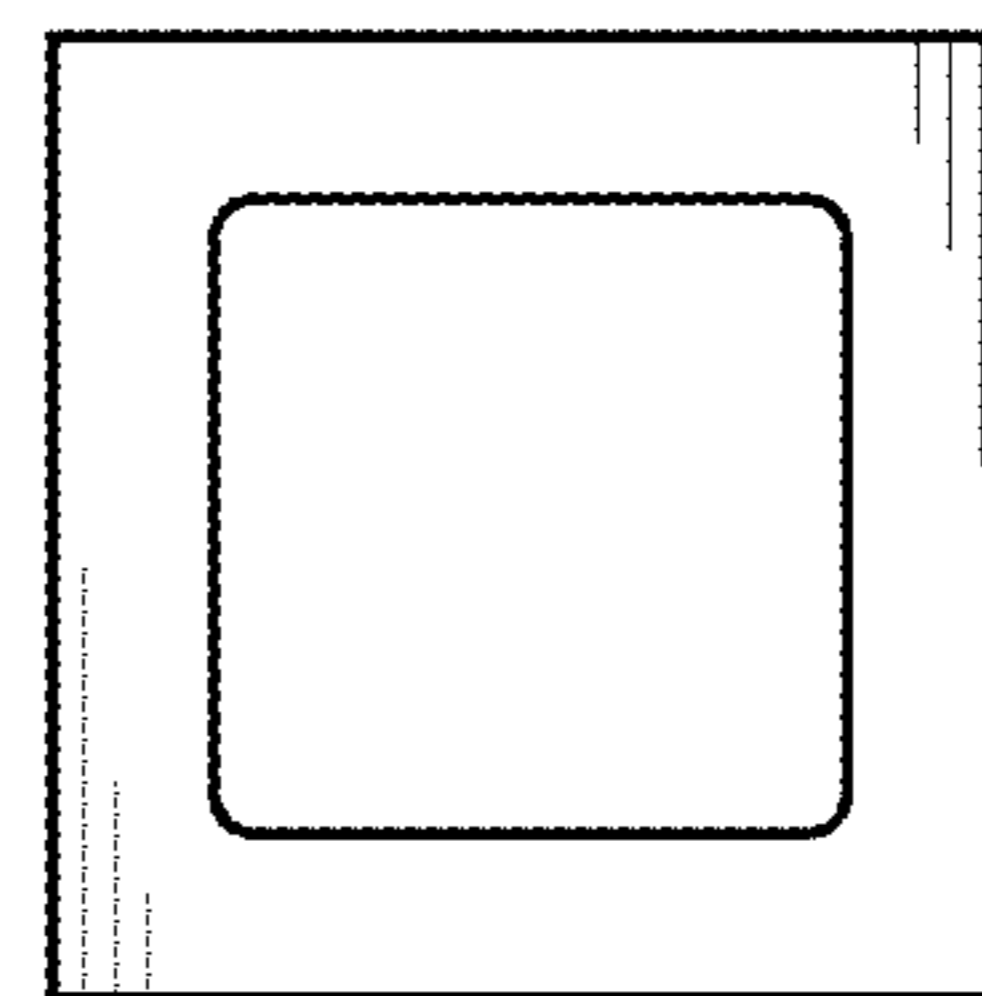
