DESCRIPTION

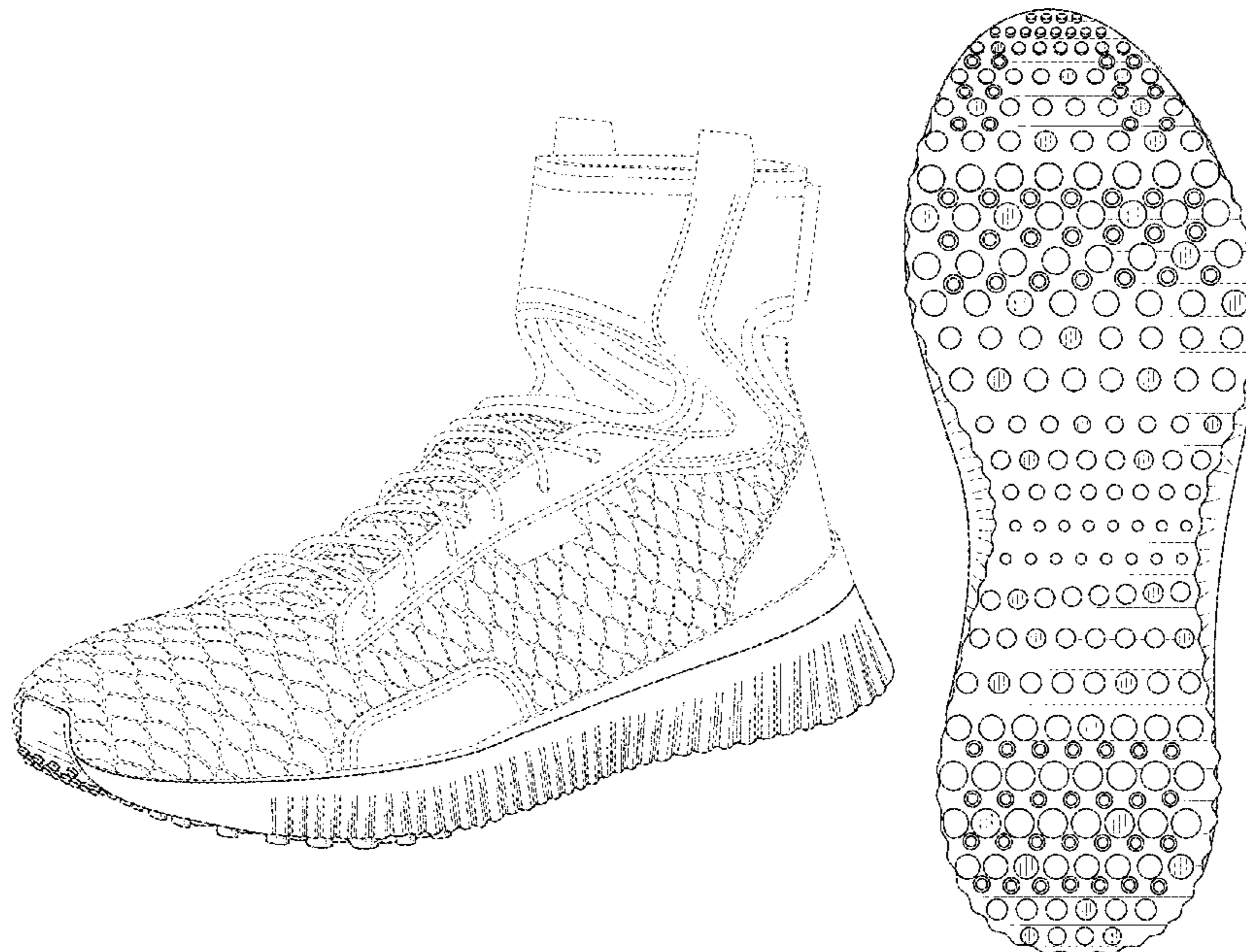
FIG. 1 is a top left front perspective view of the shoe showing my new design;

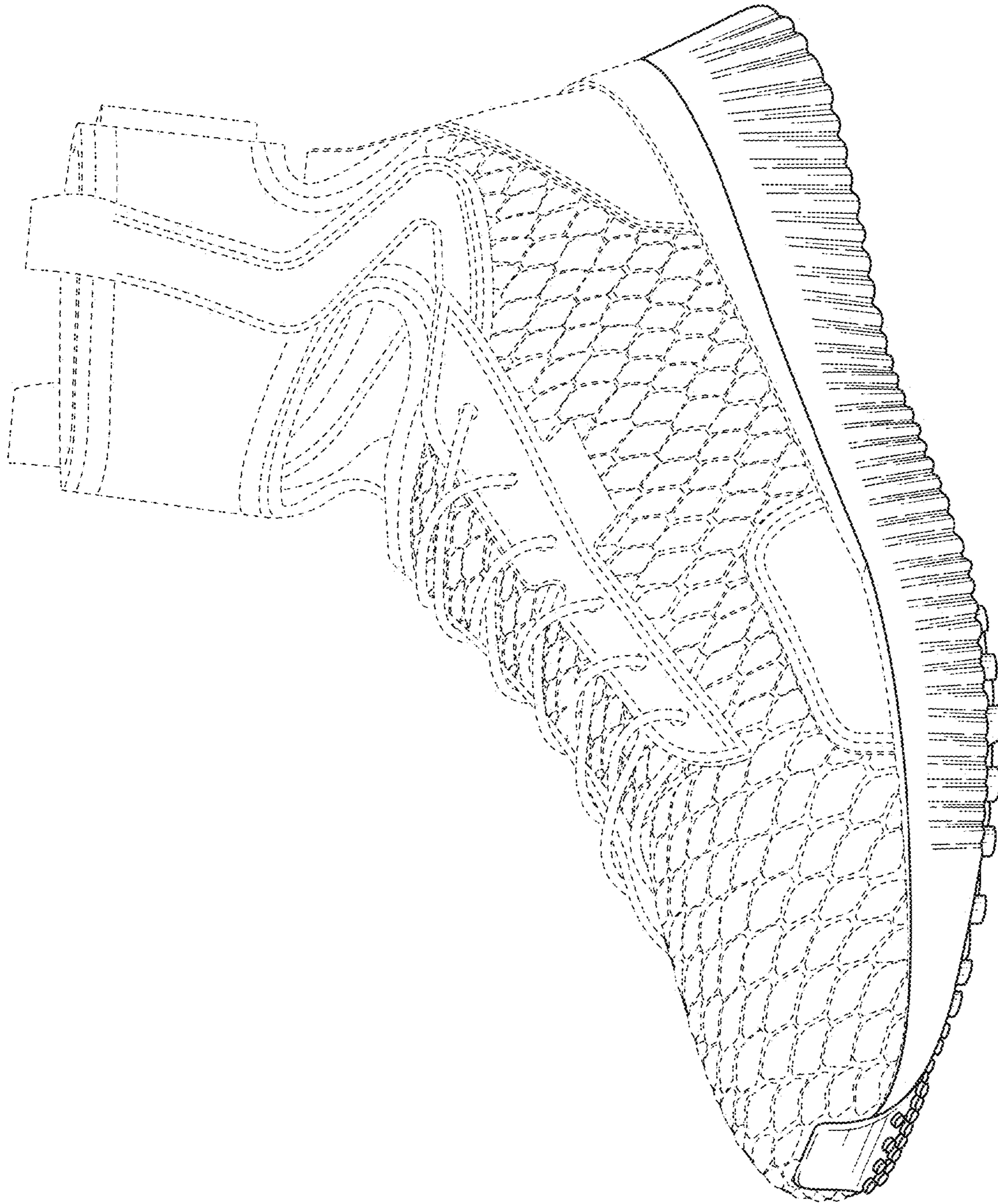

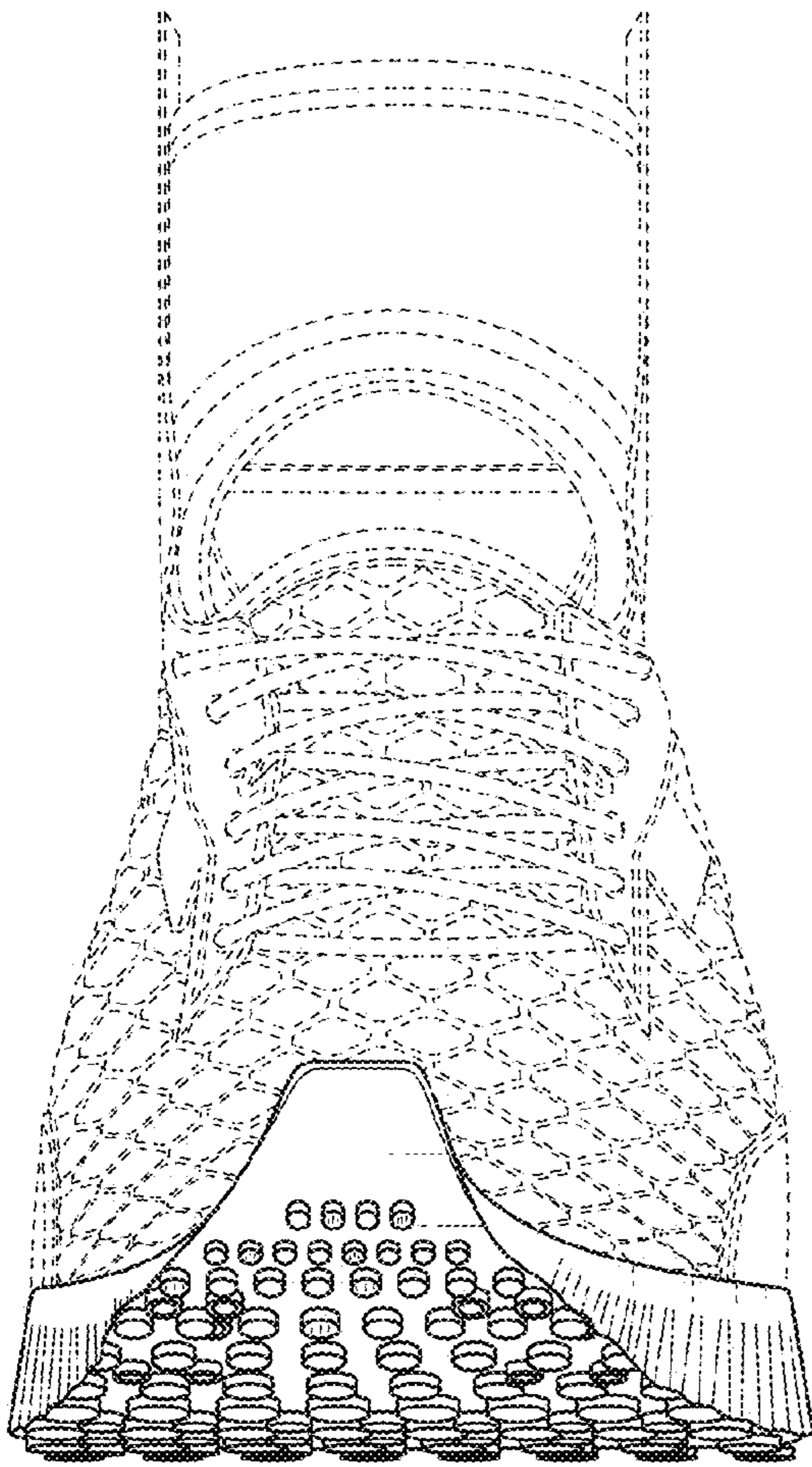

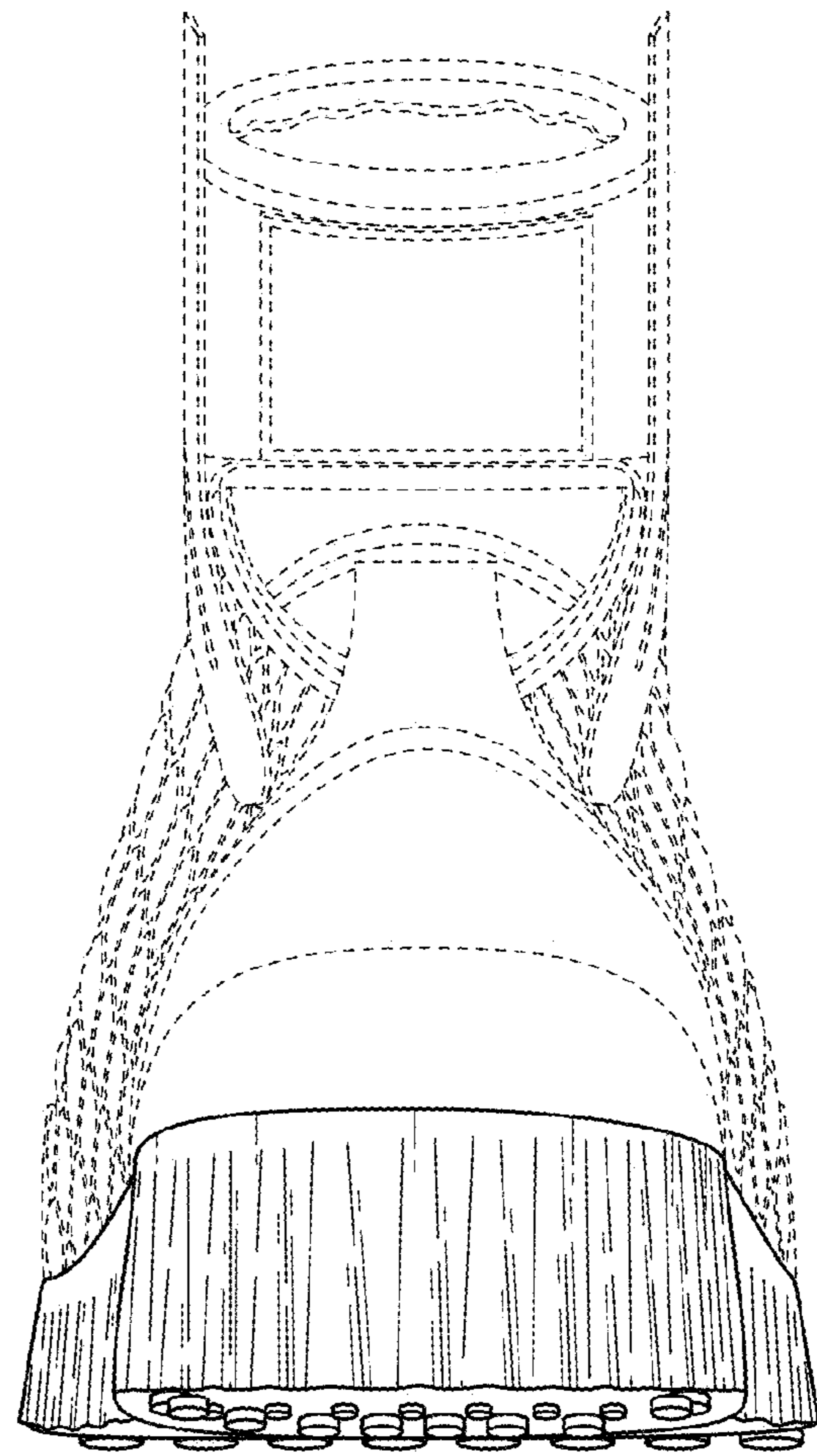

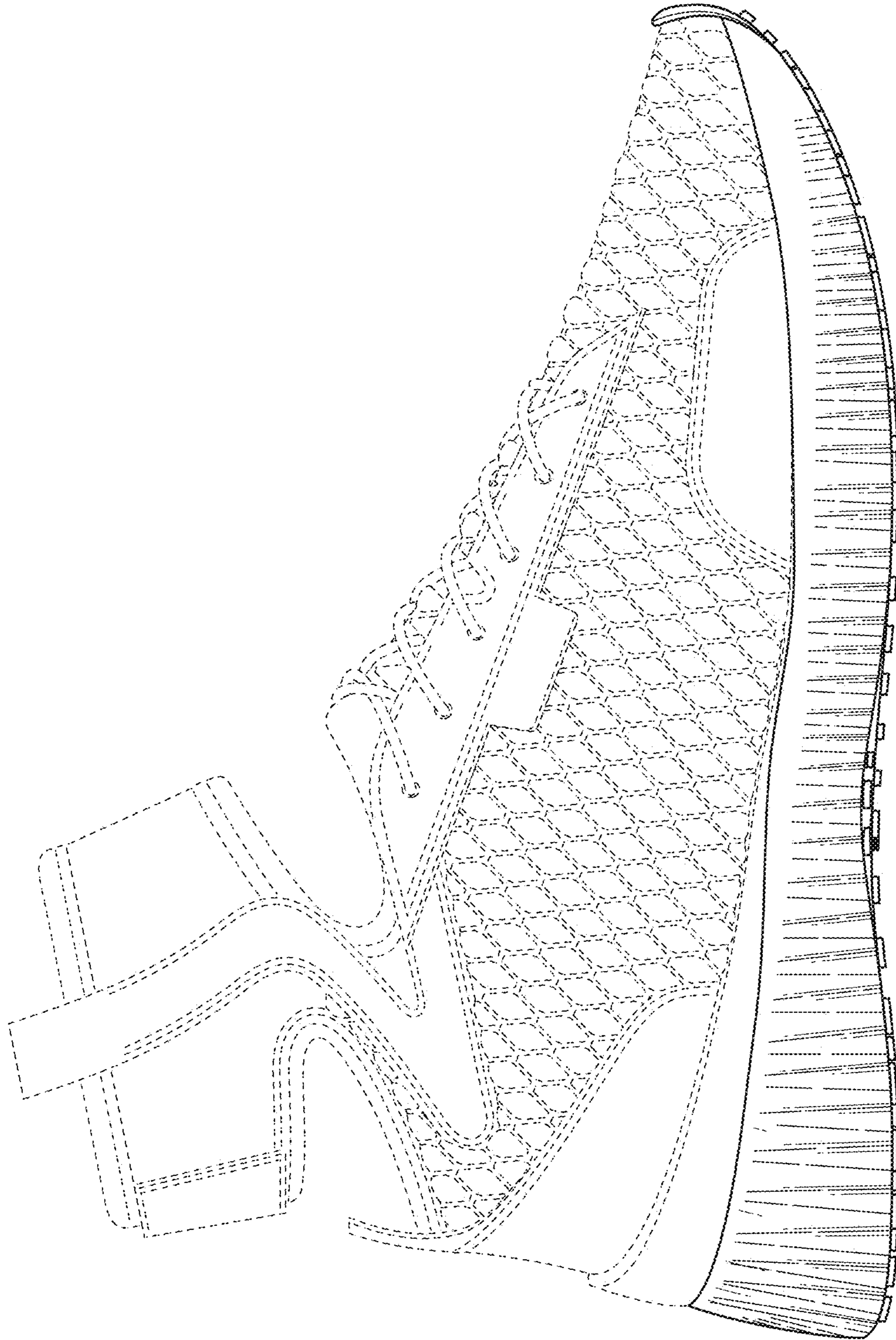

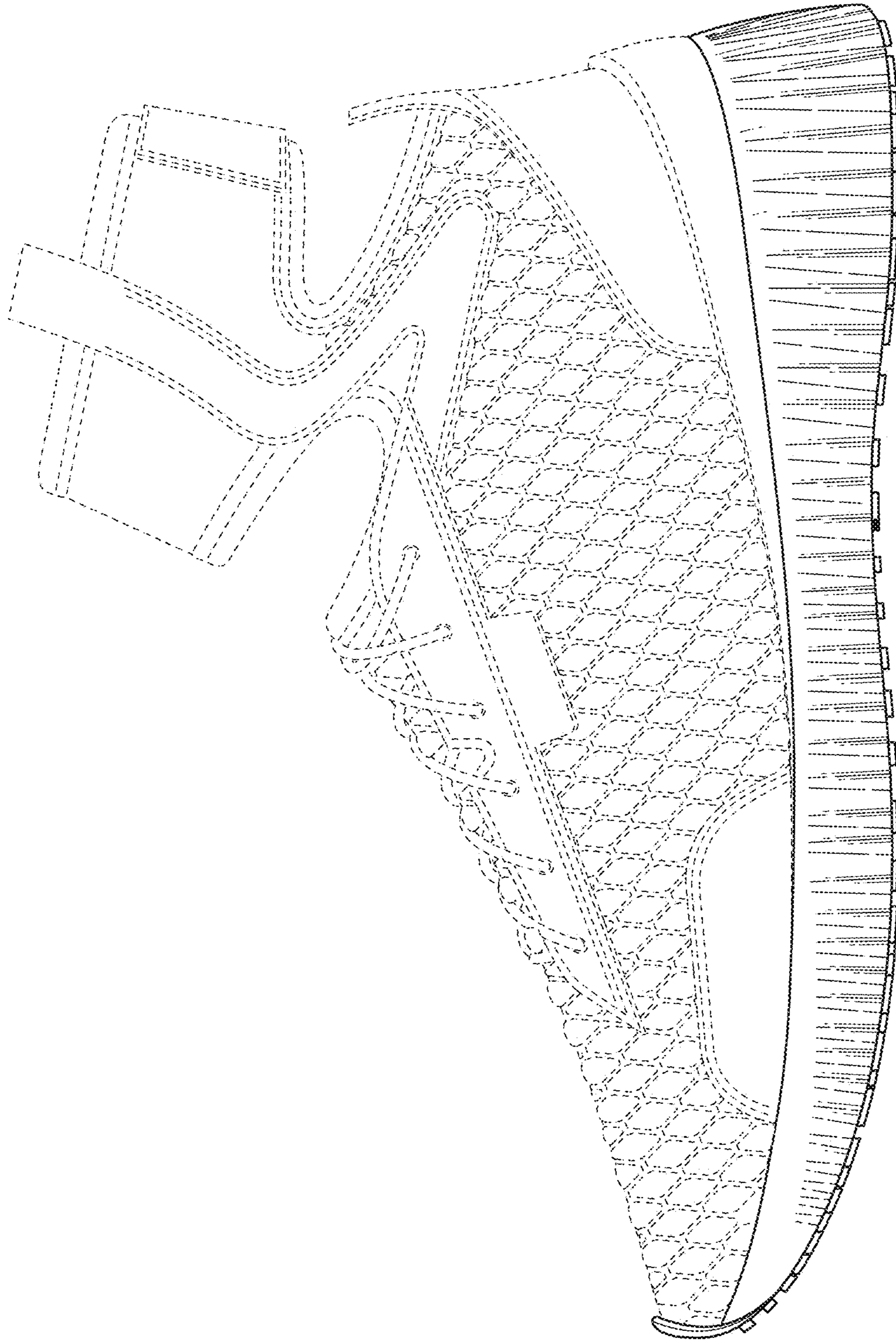

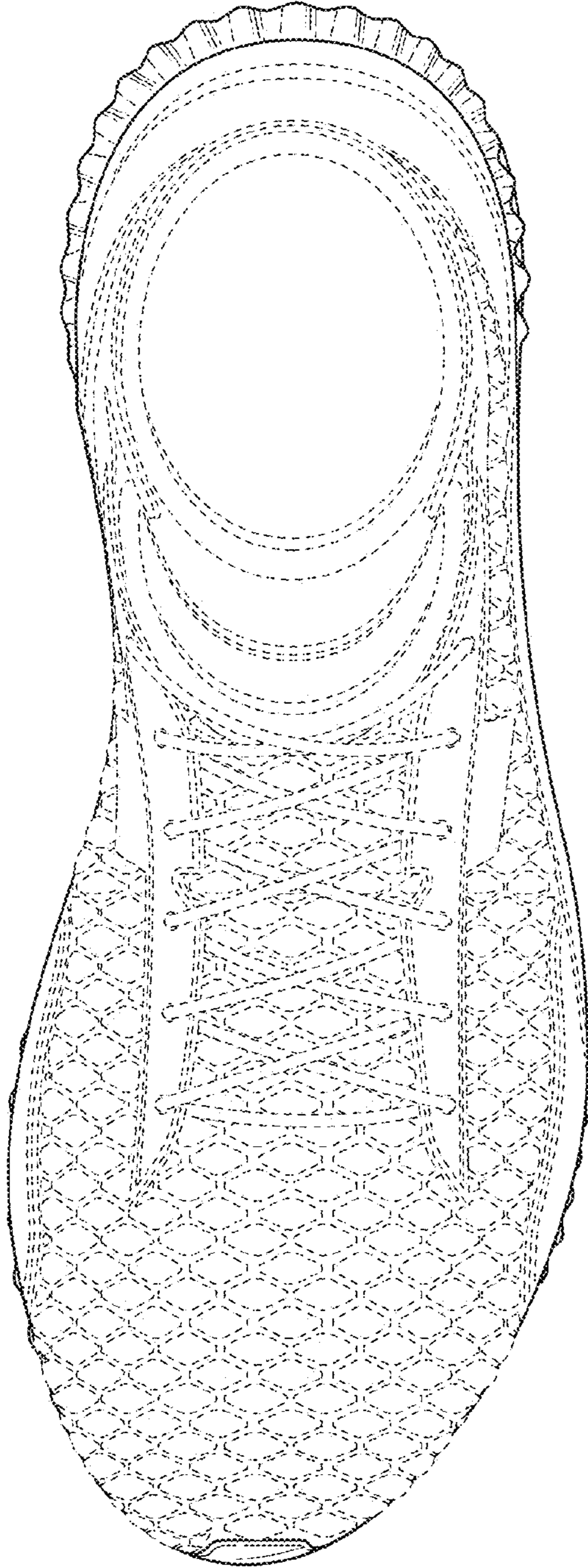

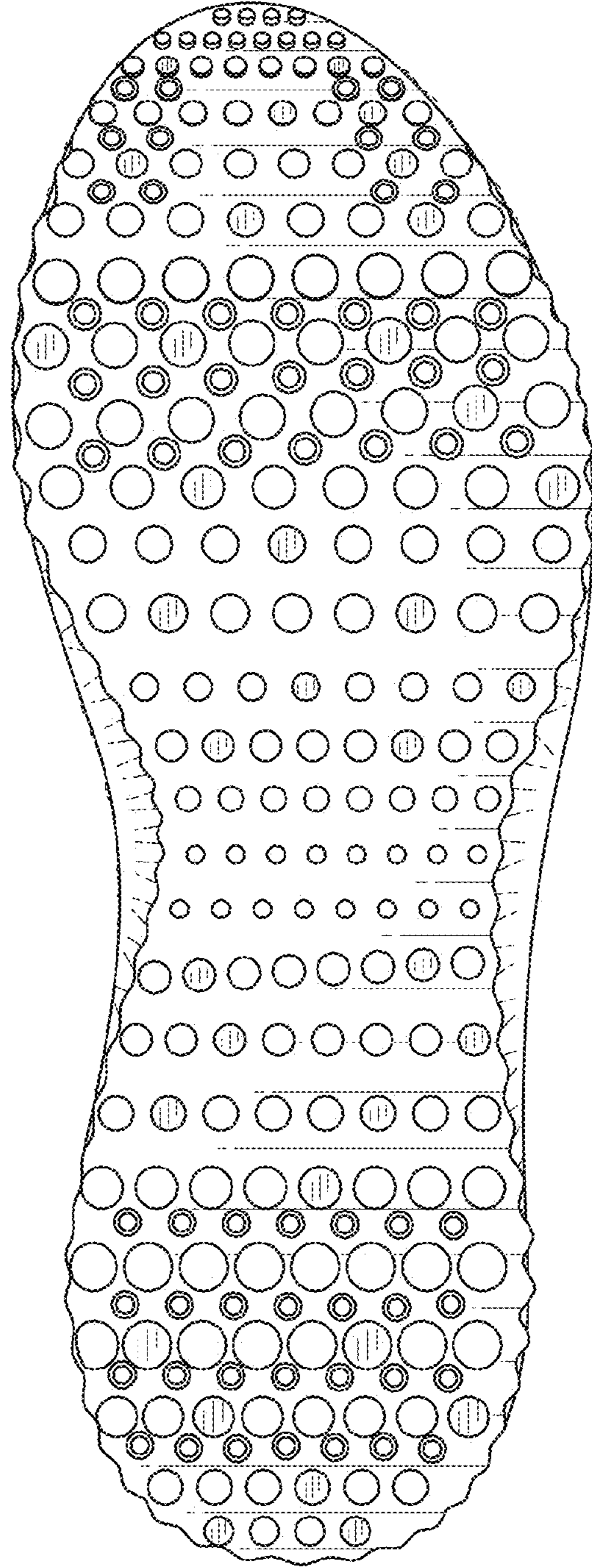
