DESCRIPTION

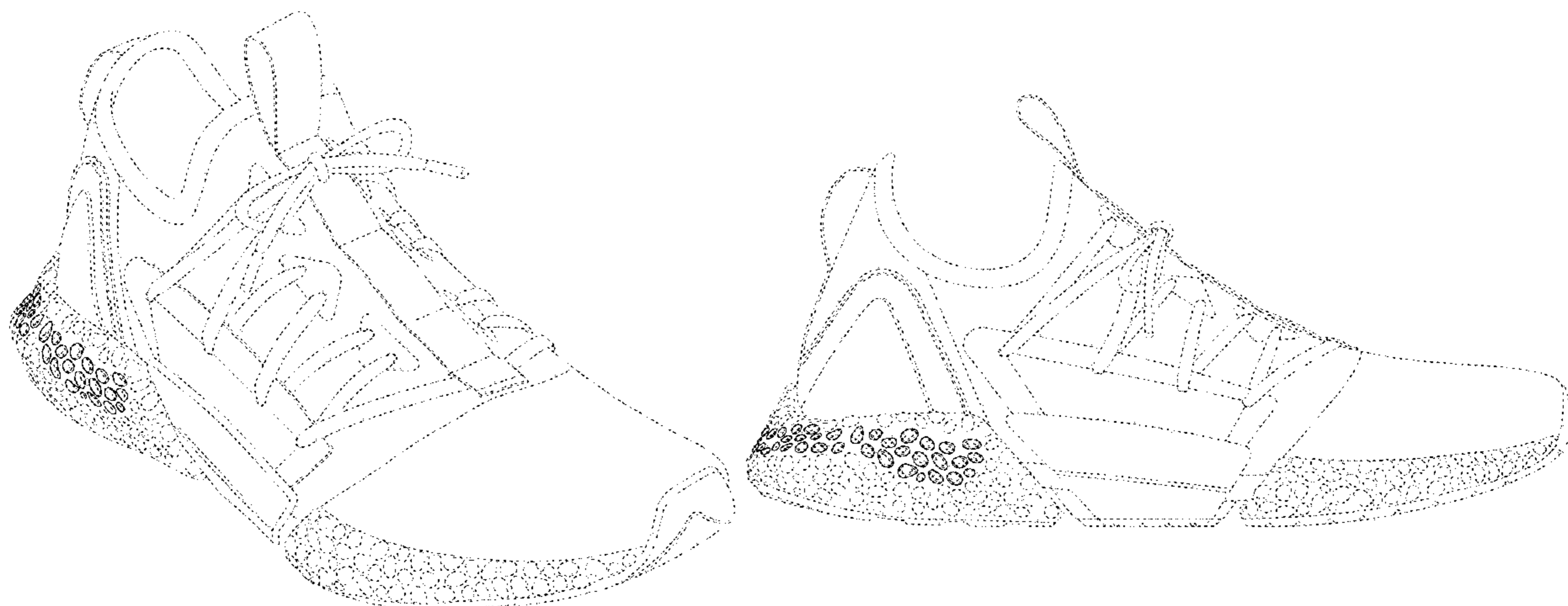
FIG. 1 is a top, front, and right perspective view of a shoe showing our new design;

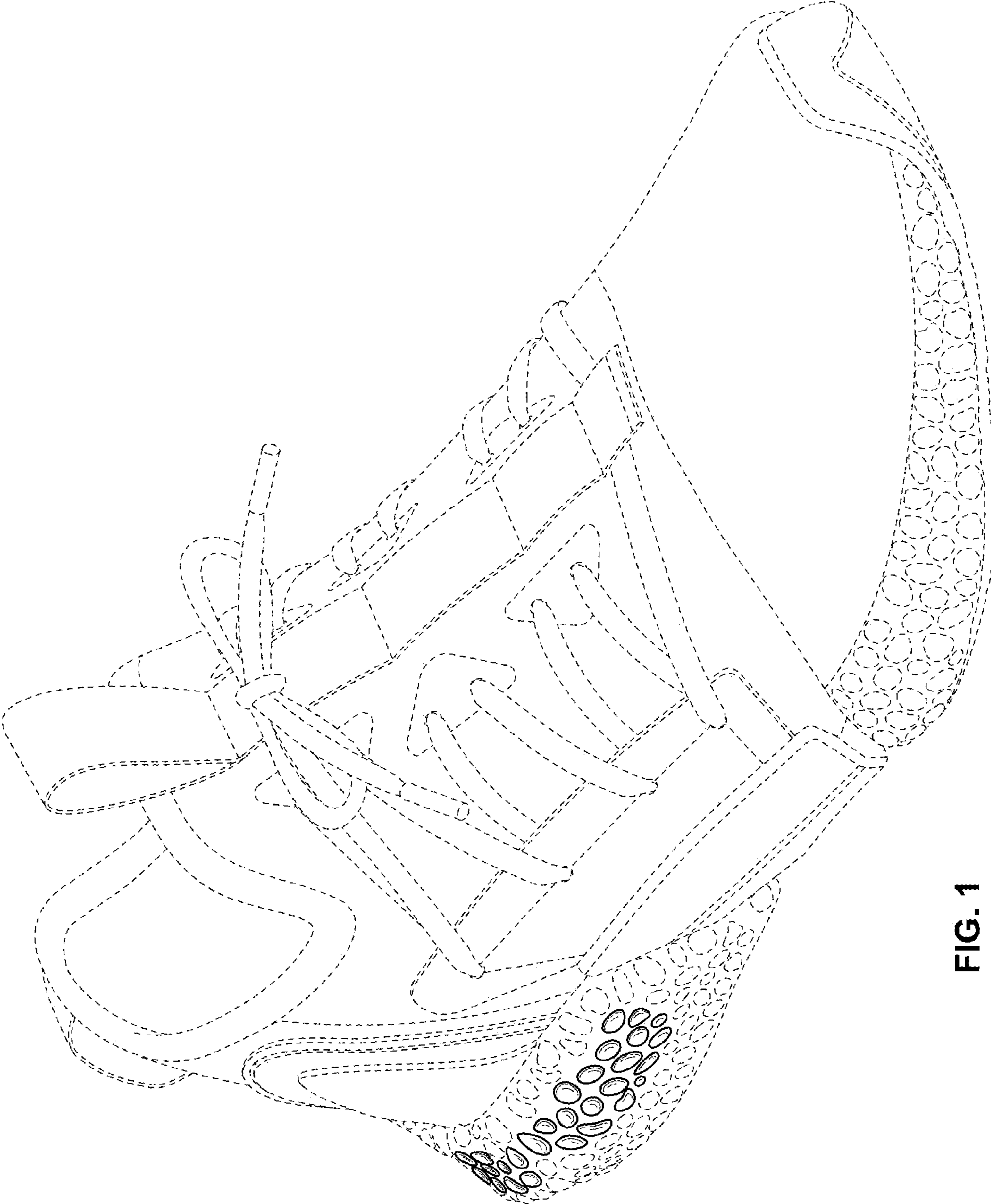

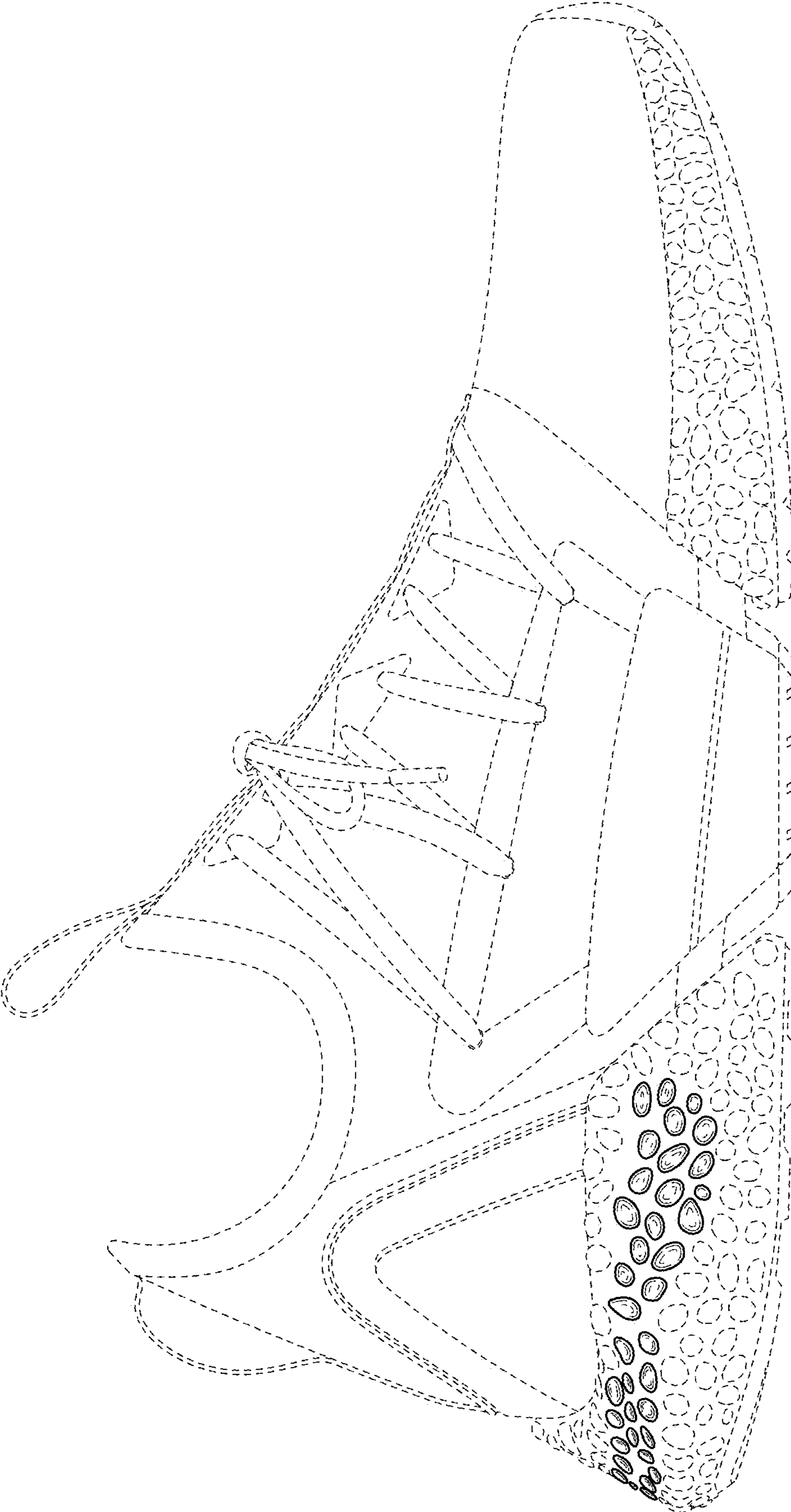

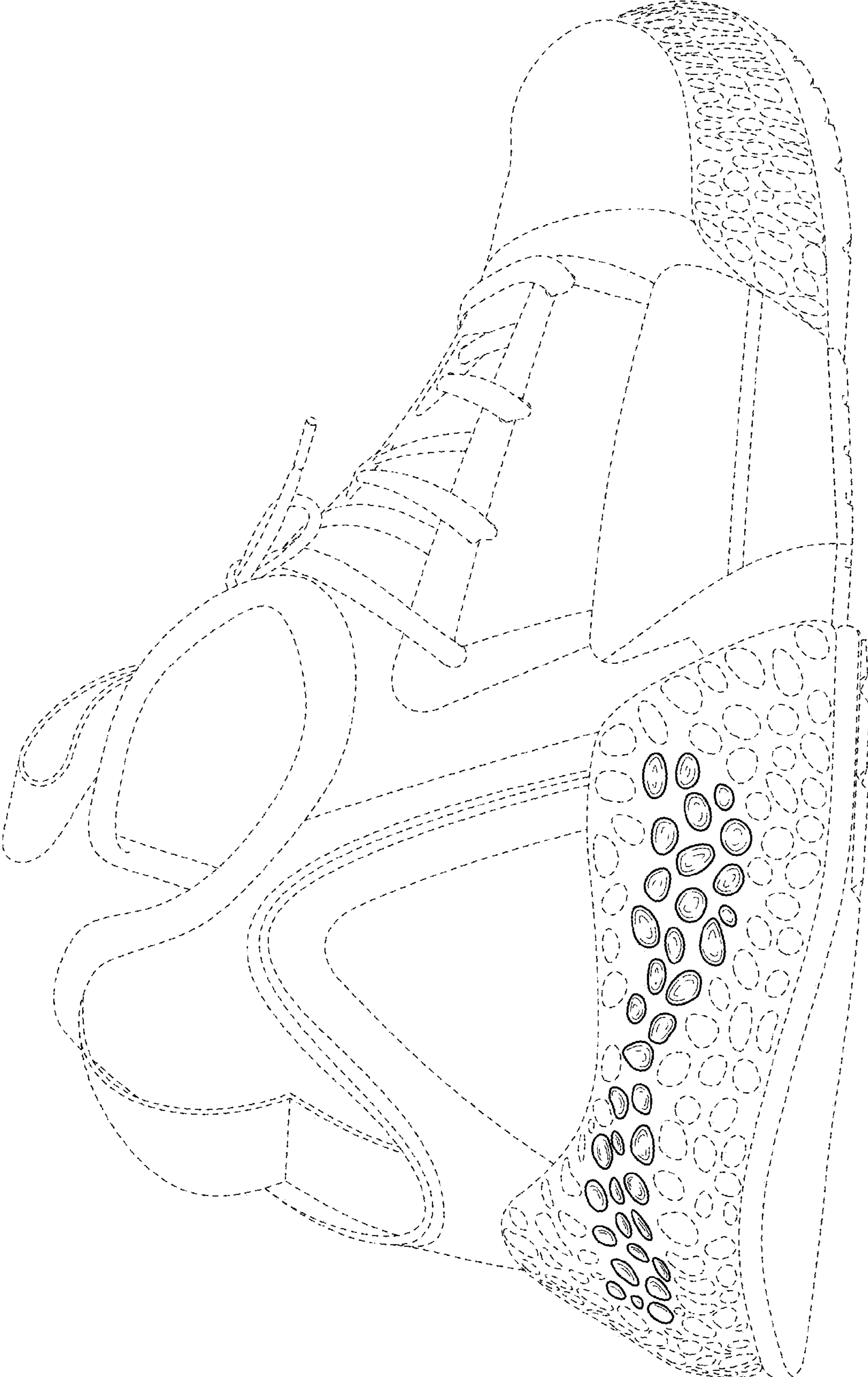
