(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear bottom perspective view of a shoe showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is an opposite side rear bottom perspective view thereof;

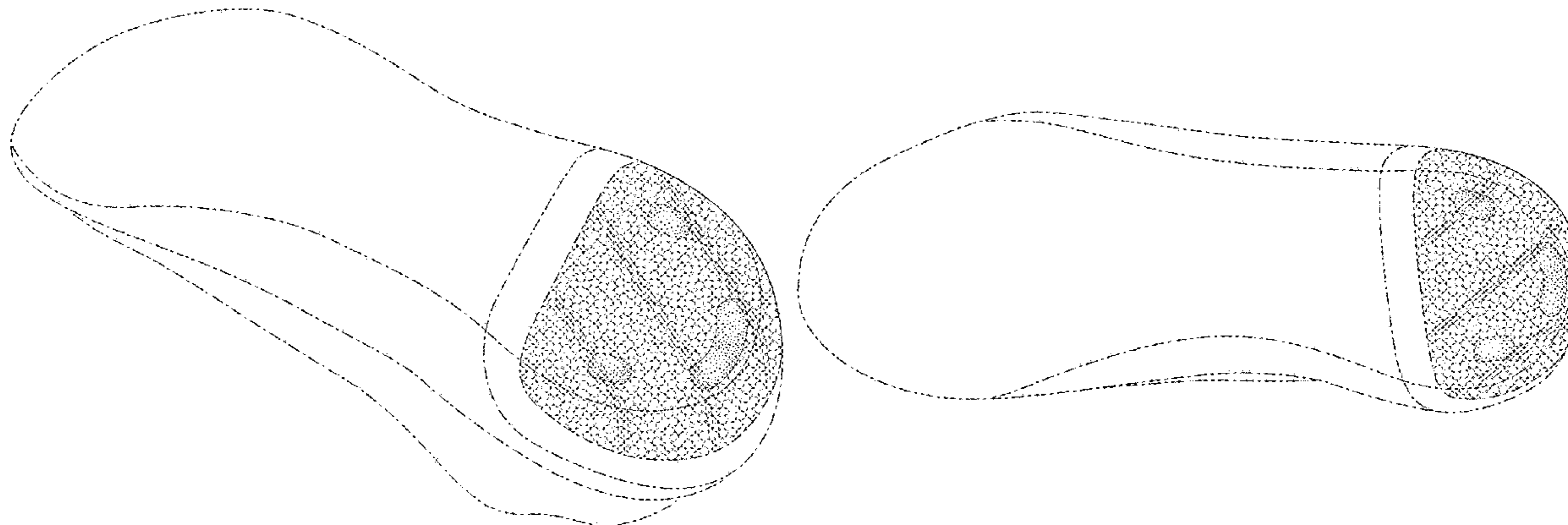
FIG. 4 is a rear view thereof;

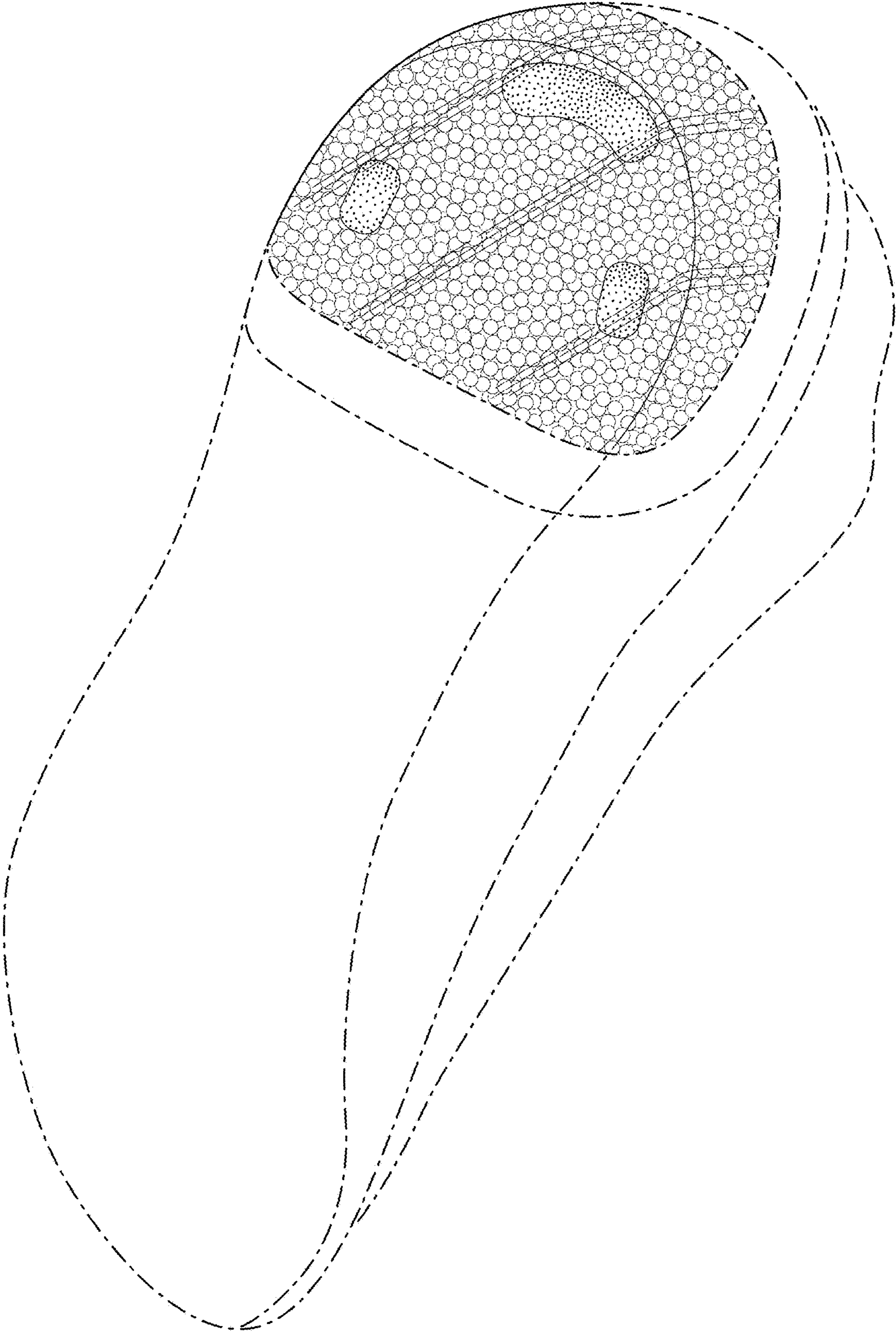

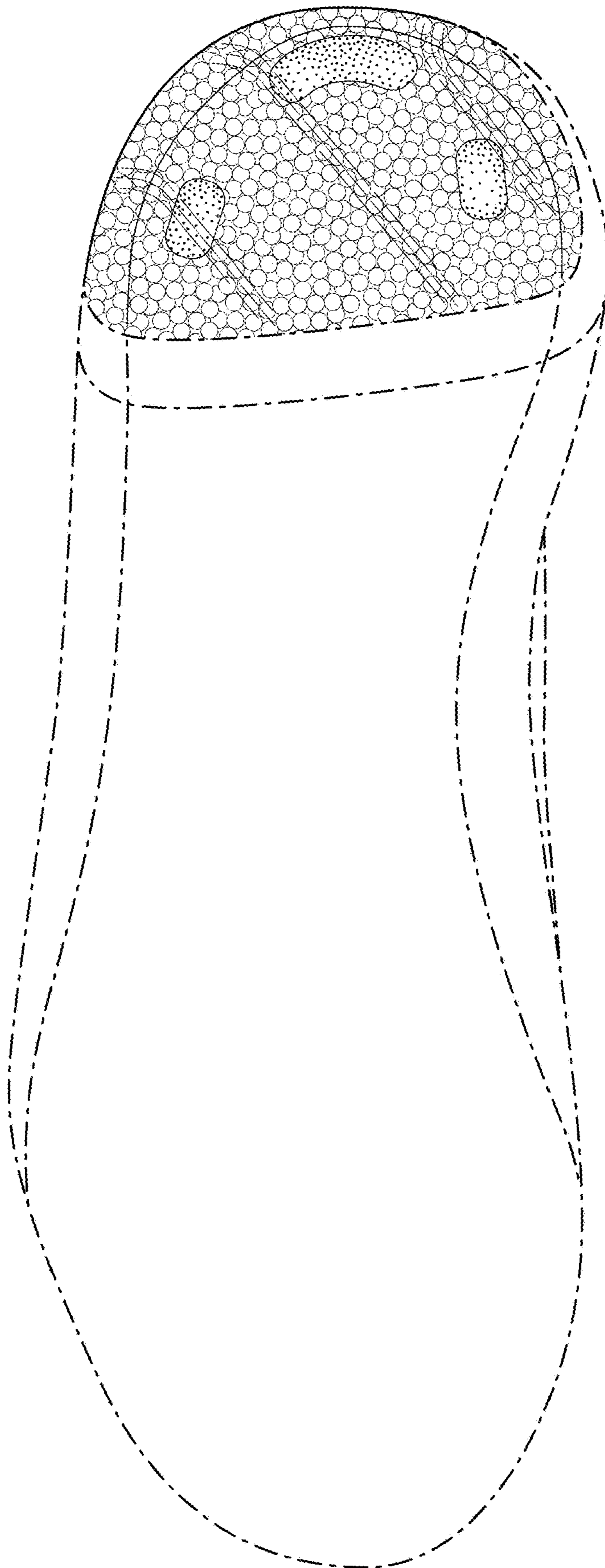

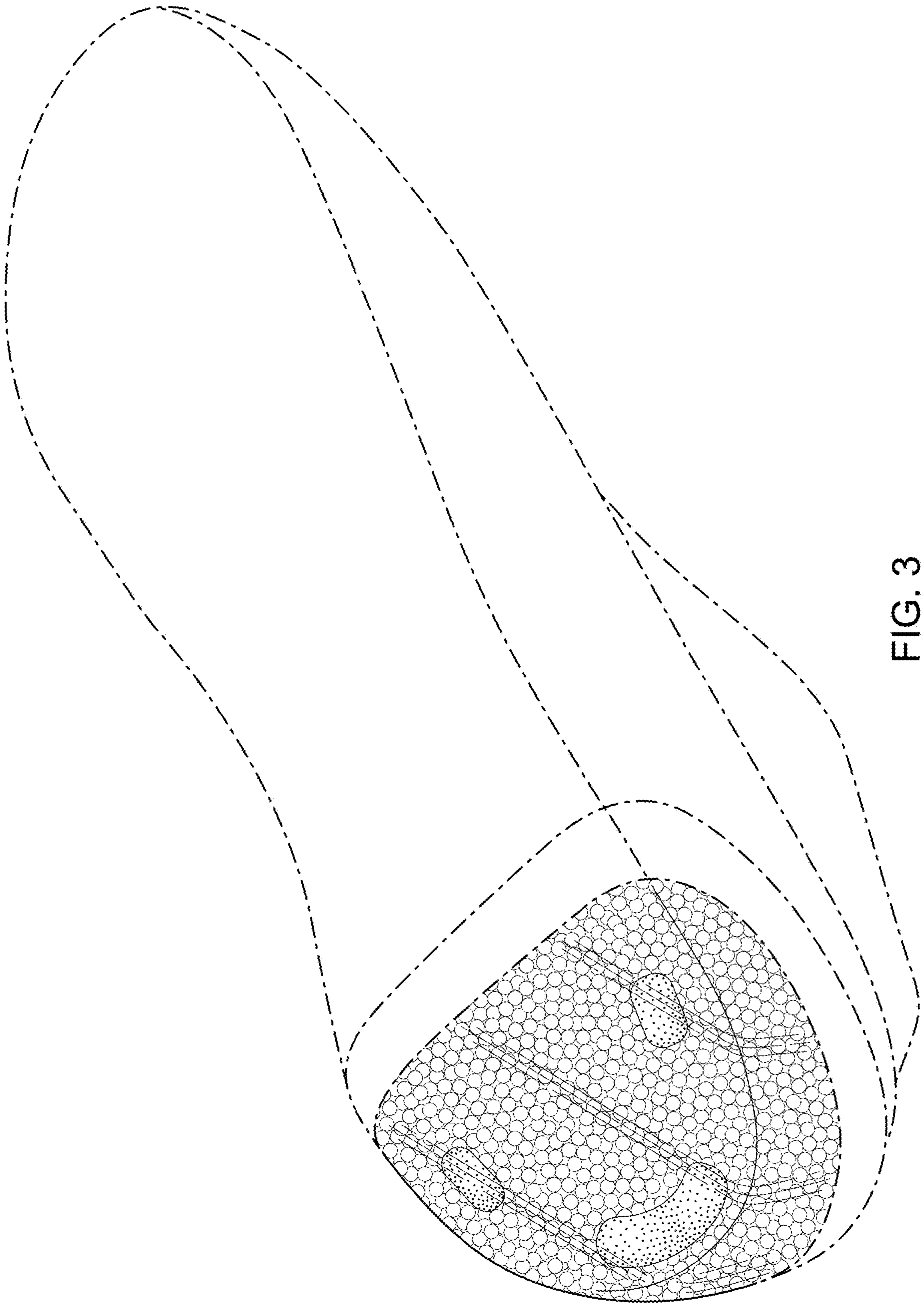

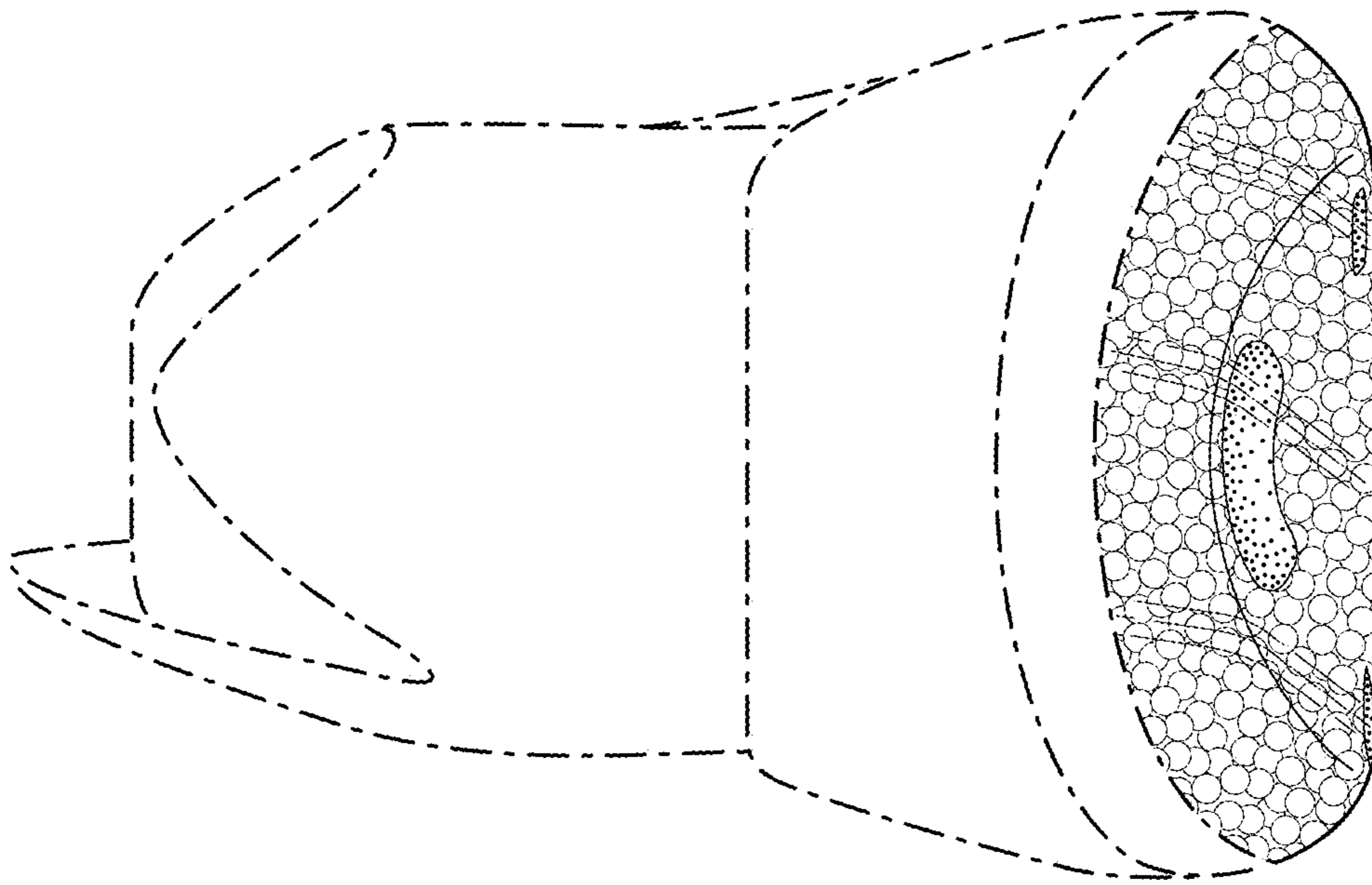

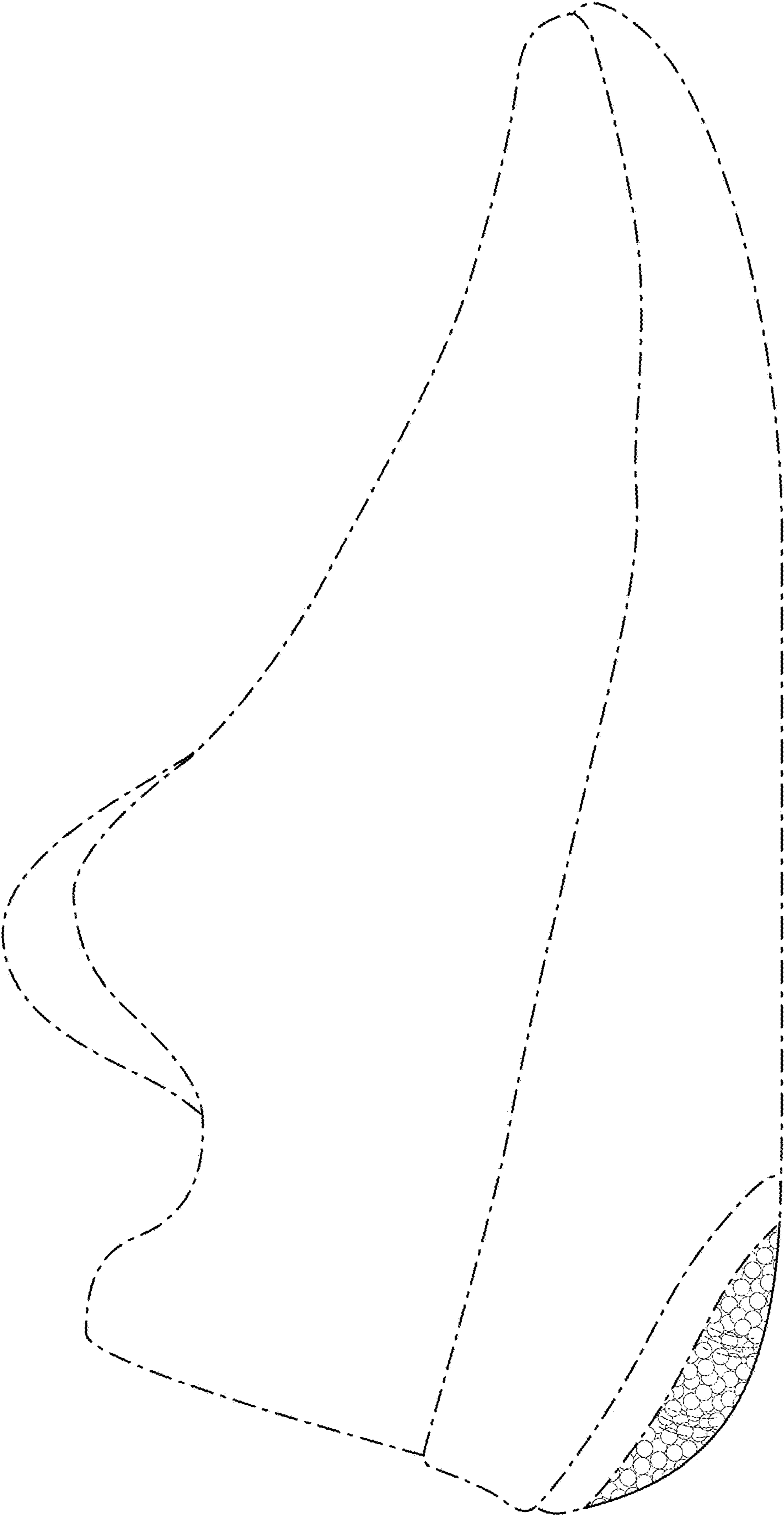
