(57) **CLAIM**

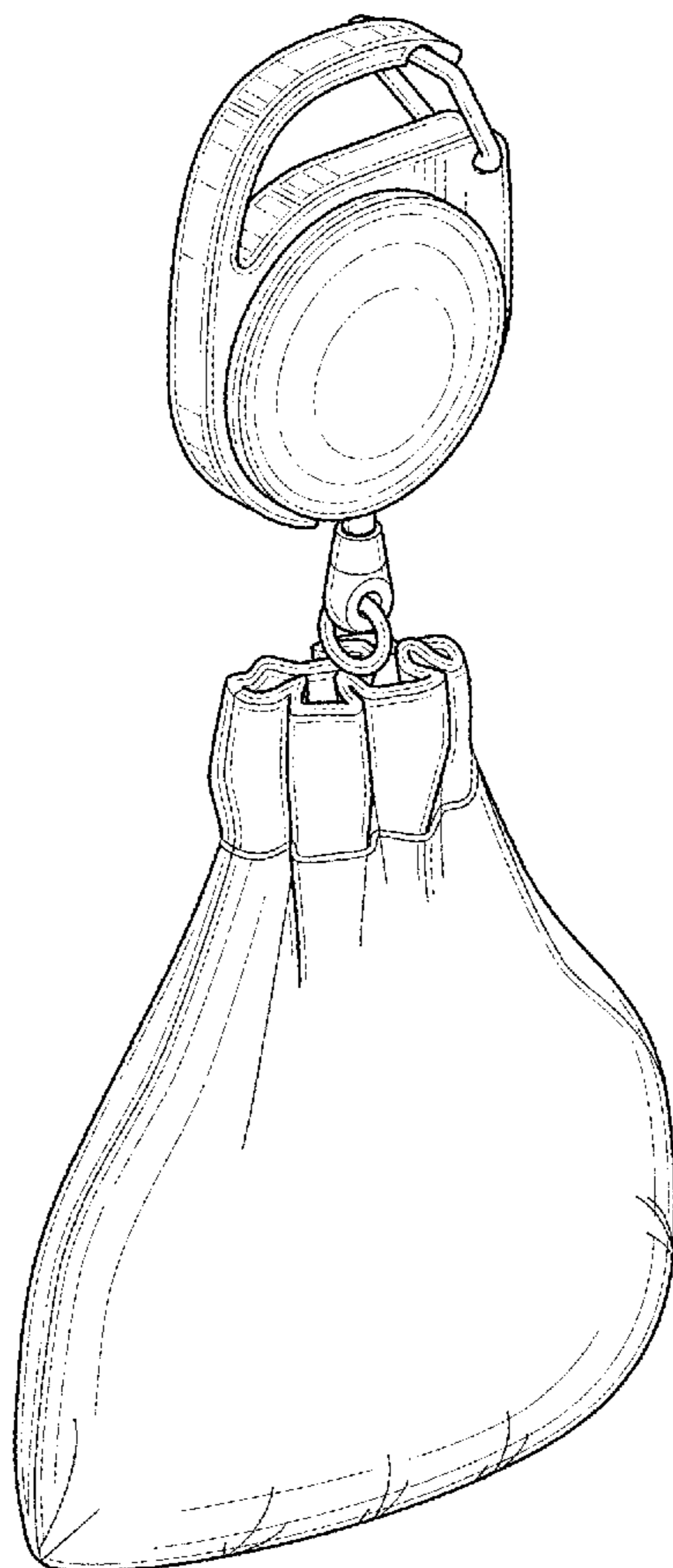
The ornamental design for a resin bag with retractable clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the resin bag with retractable clip showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is a perspective view thereof in use.

The resin bag with retractable clip is shown with a symbolic break in the retractable cord. The appearance of any portion of the article between the break lines forms no part of the claimed design.

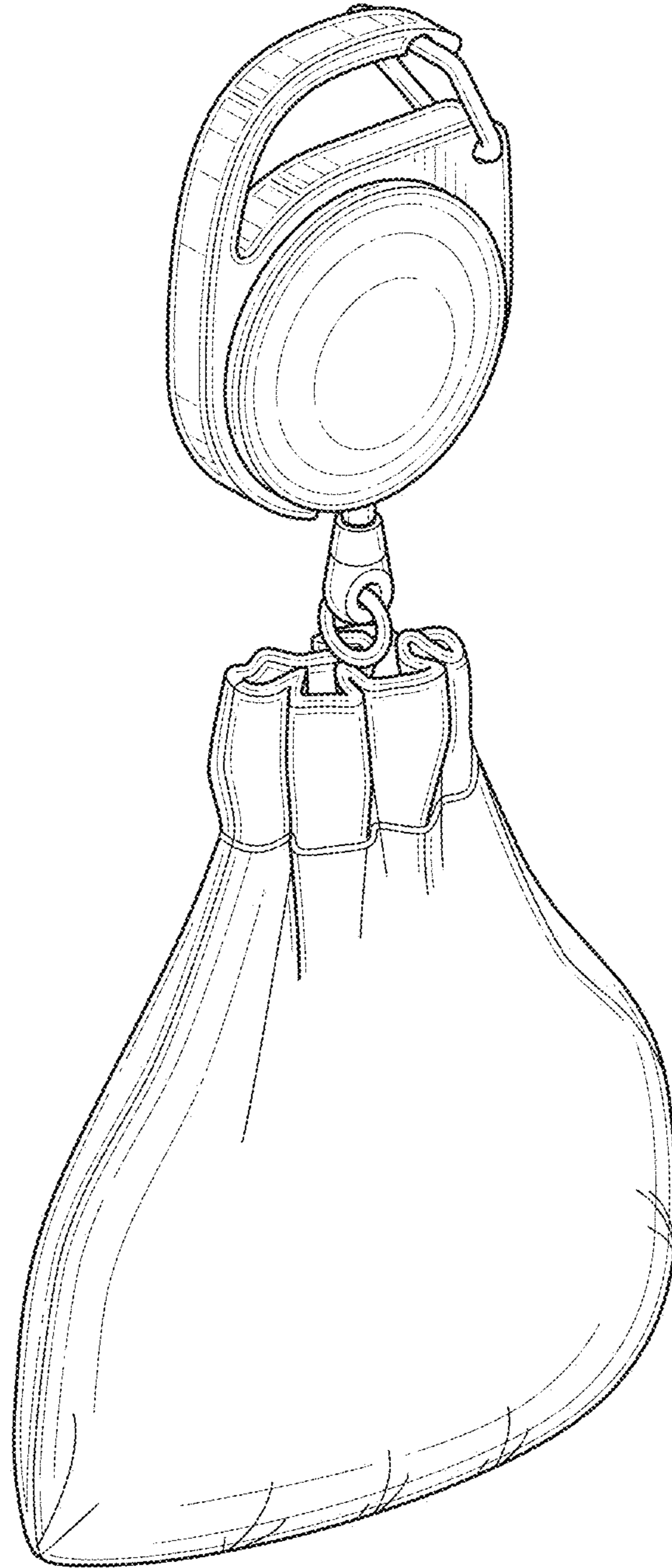

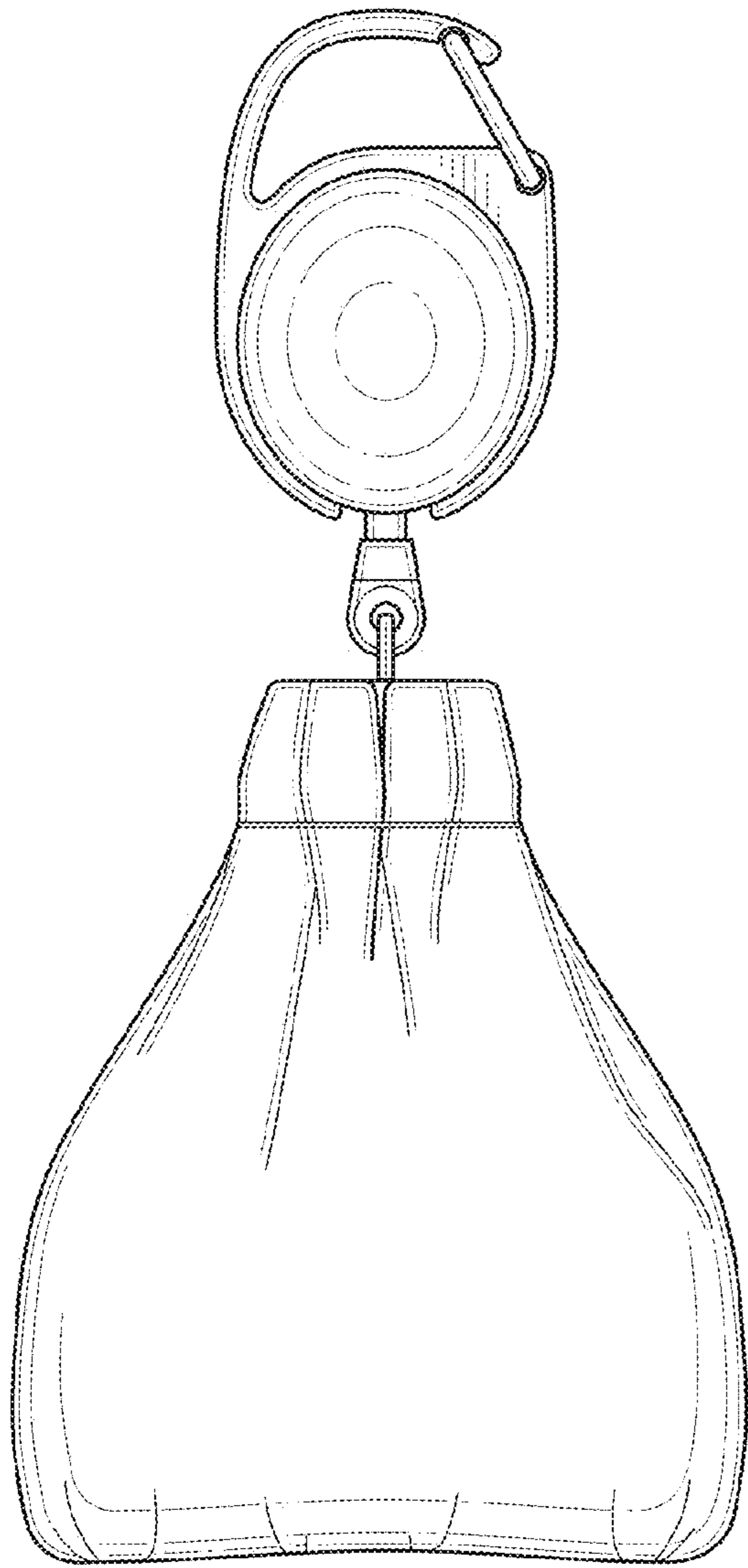

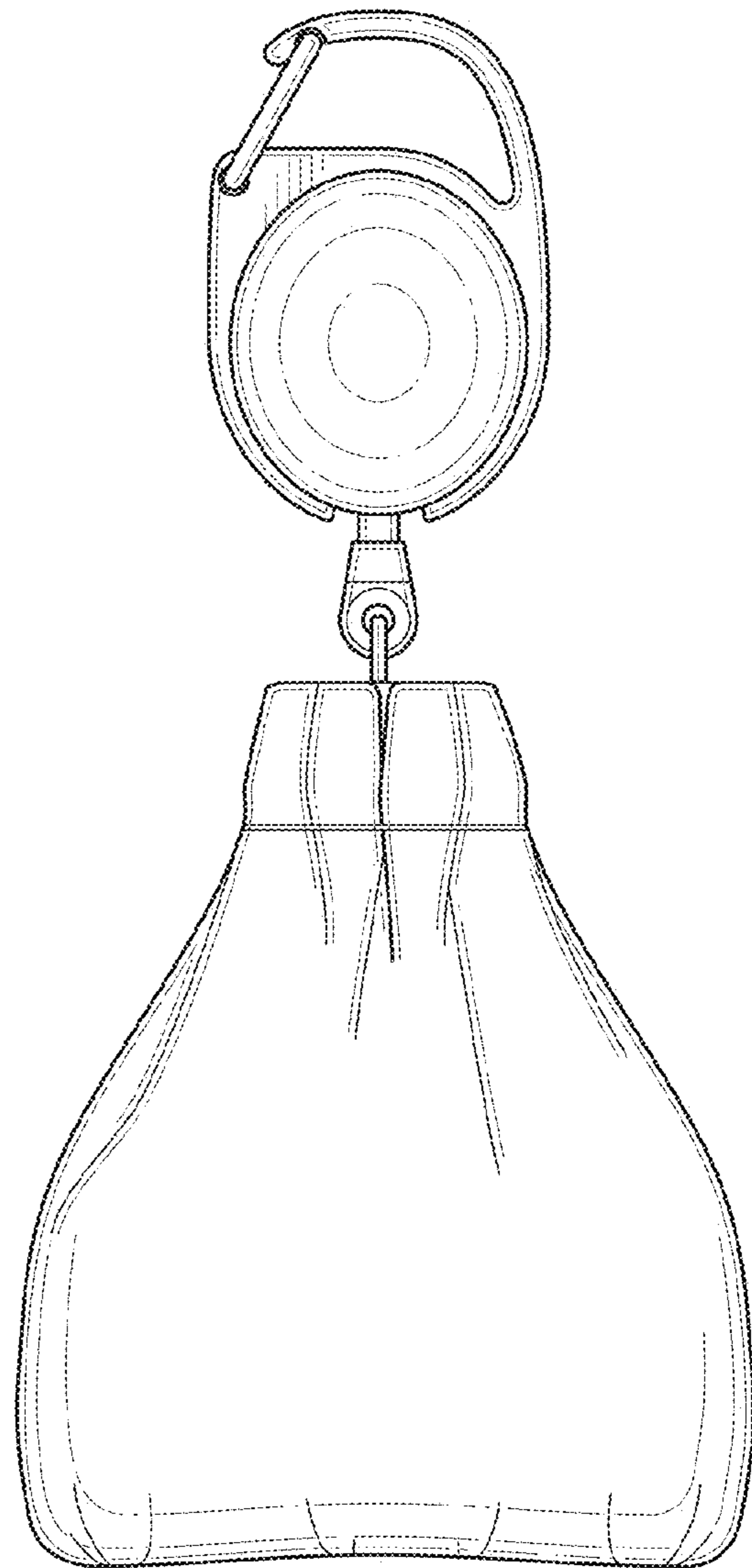

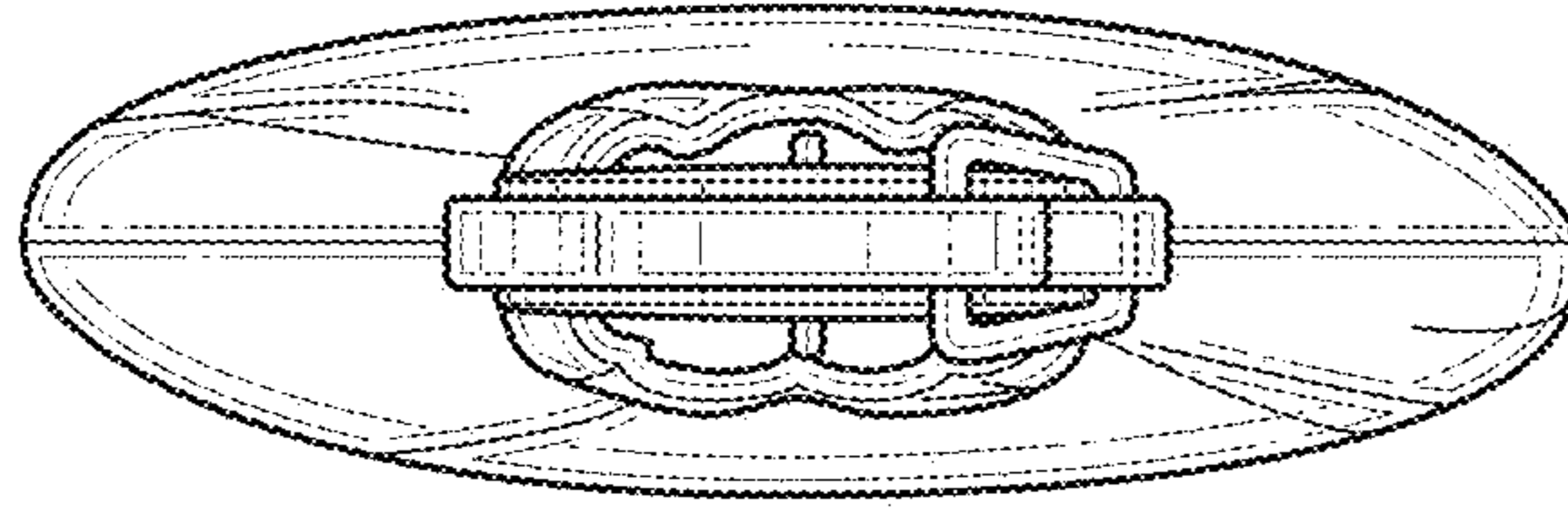

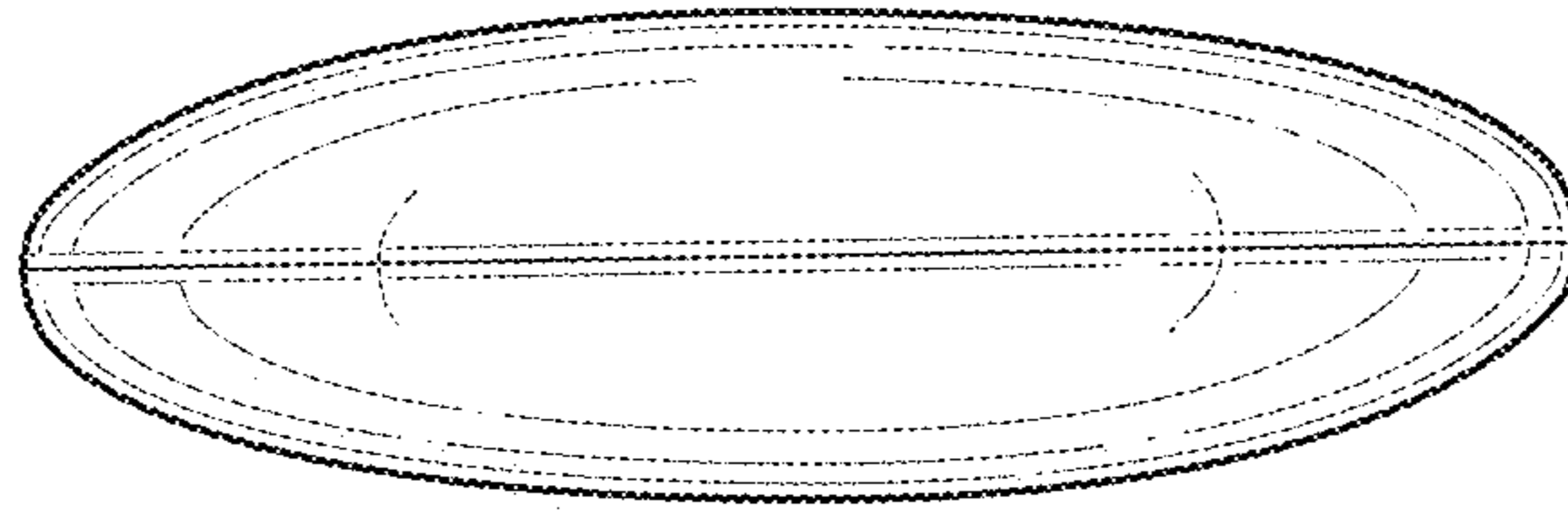

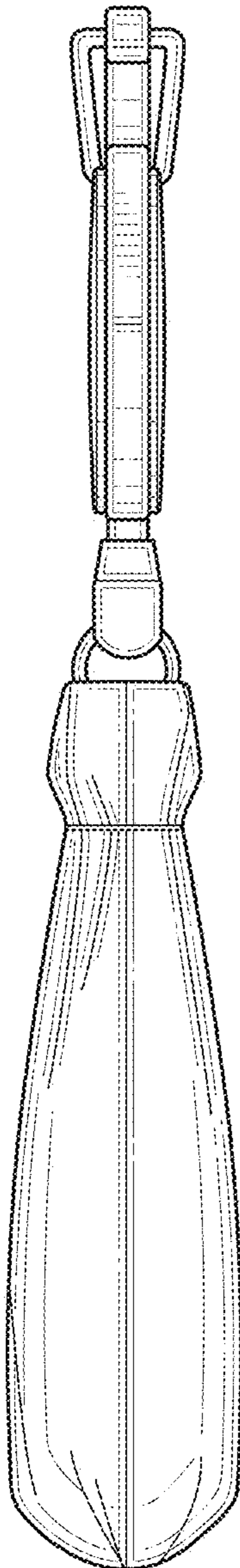

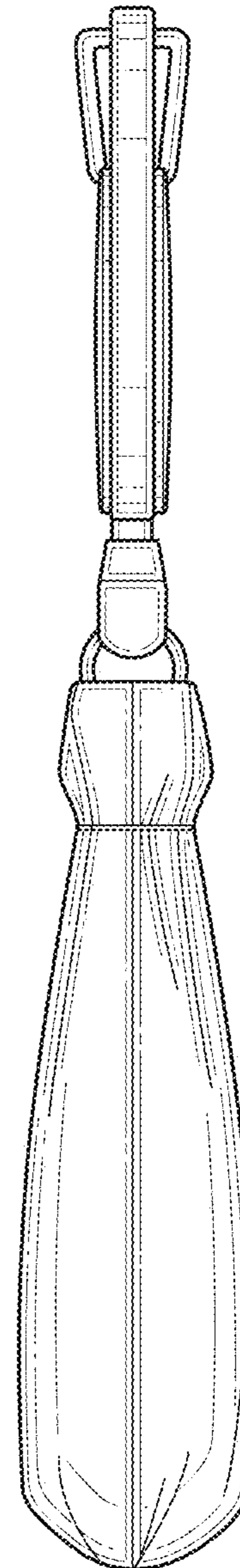

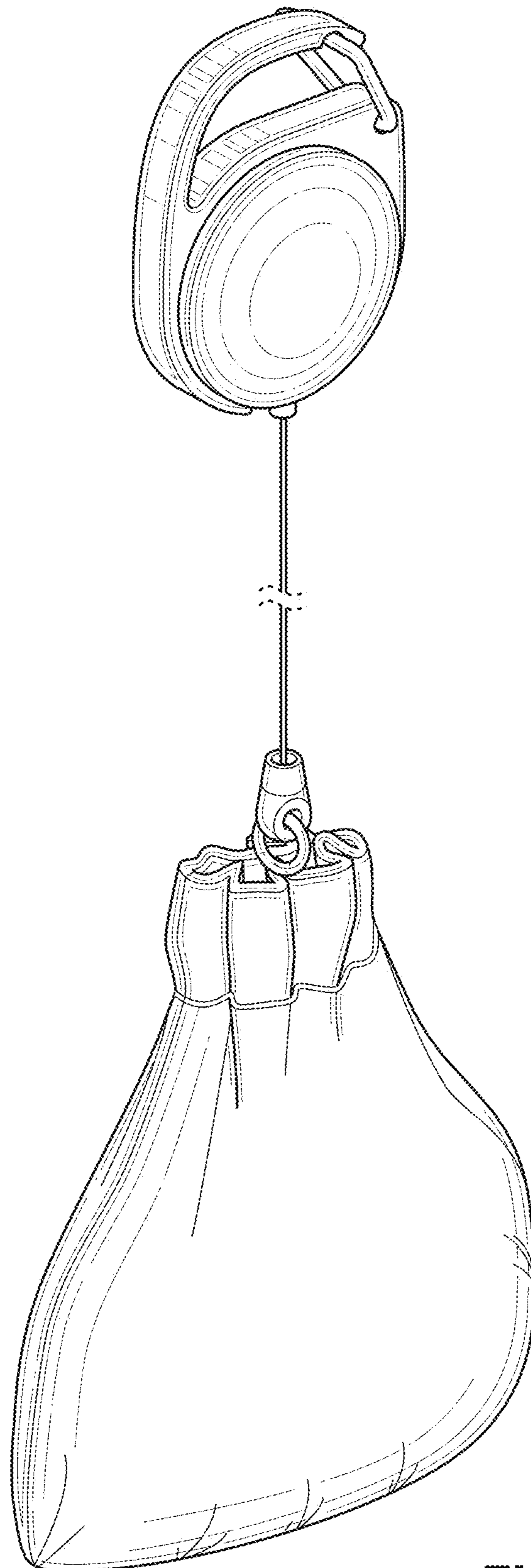
