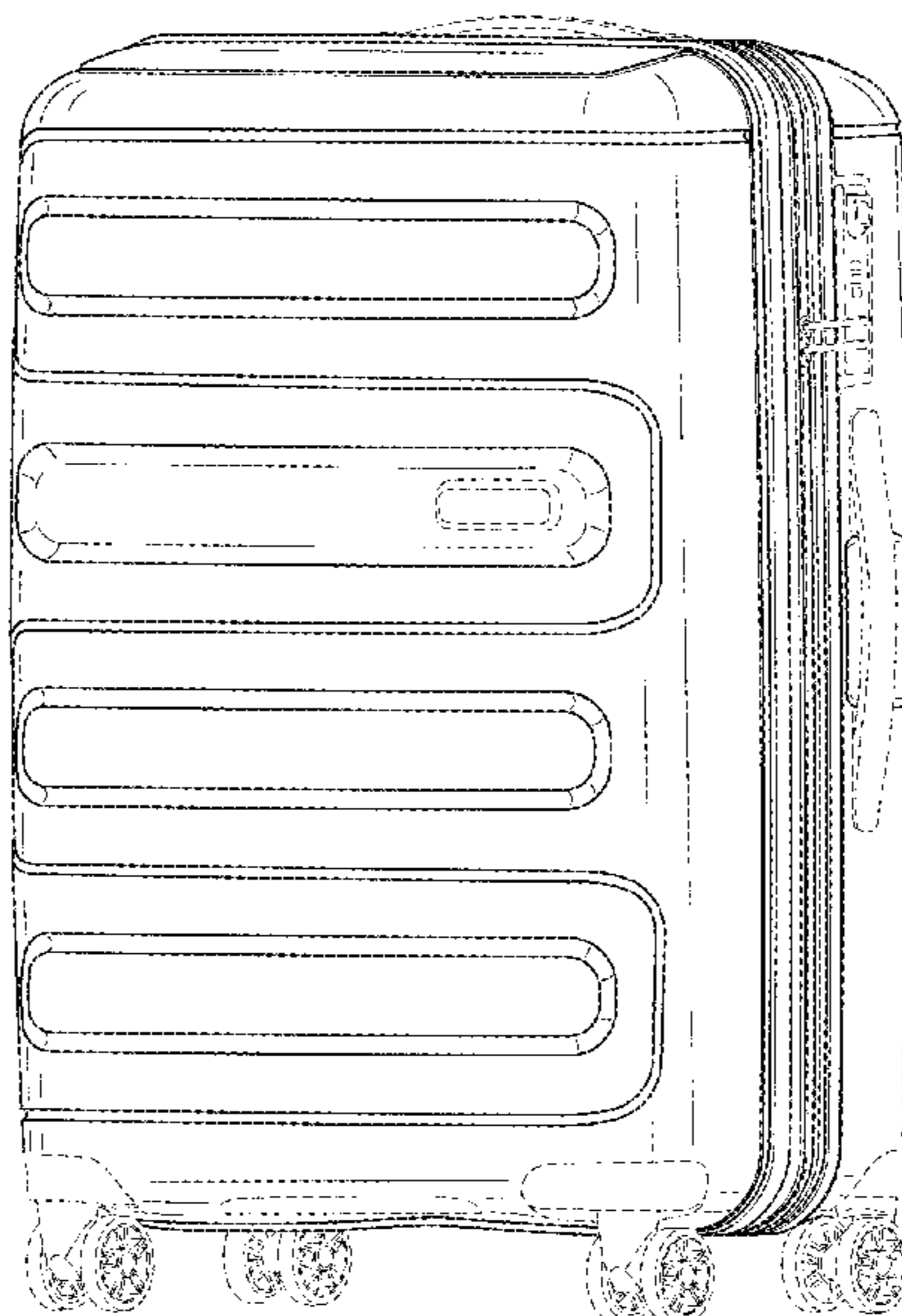
FIG. 1 shows a front perspective view of a piece of luggage;

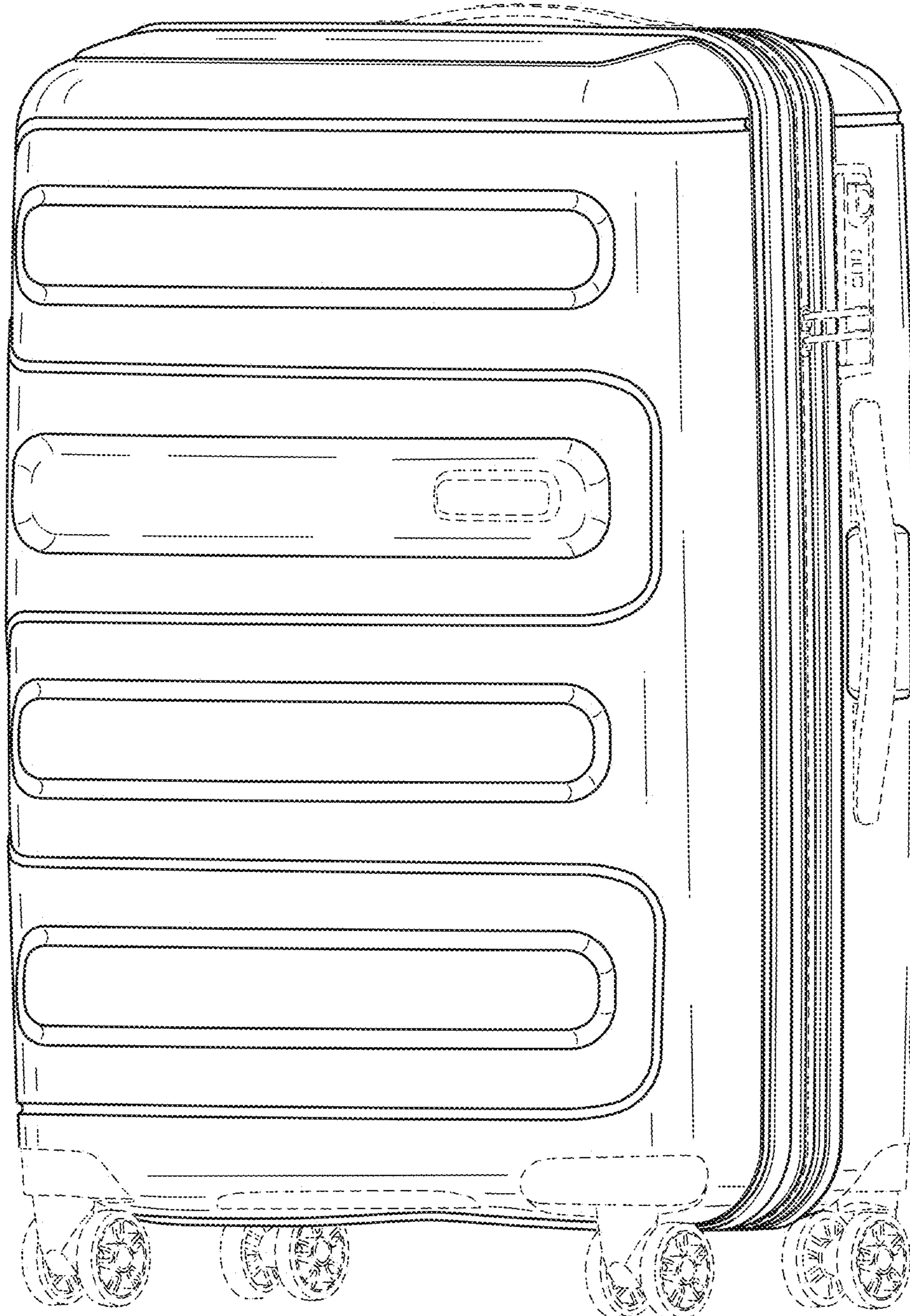

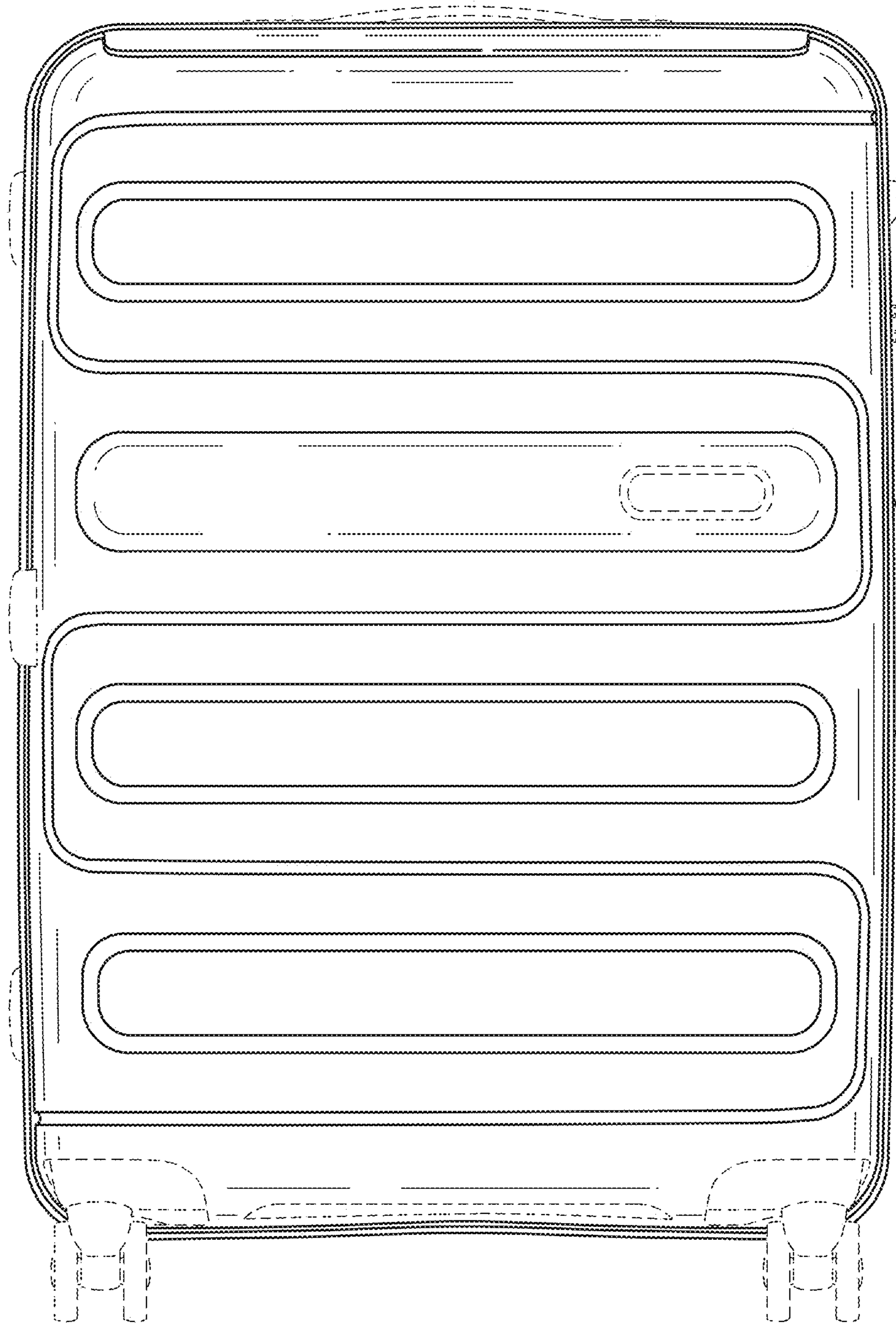

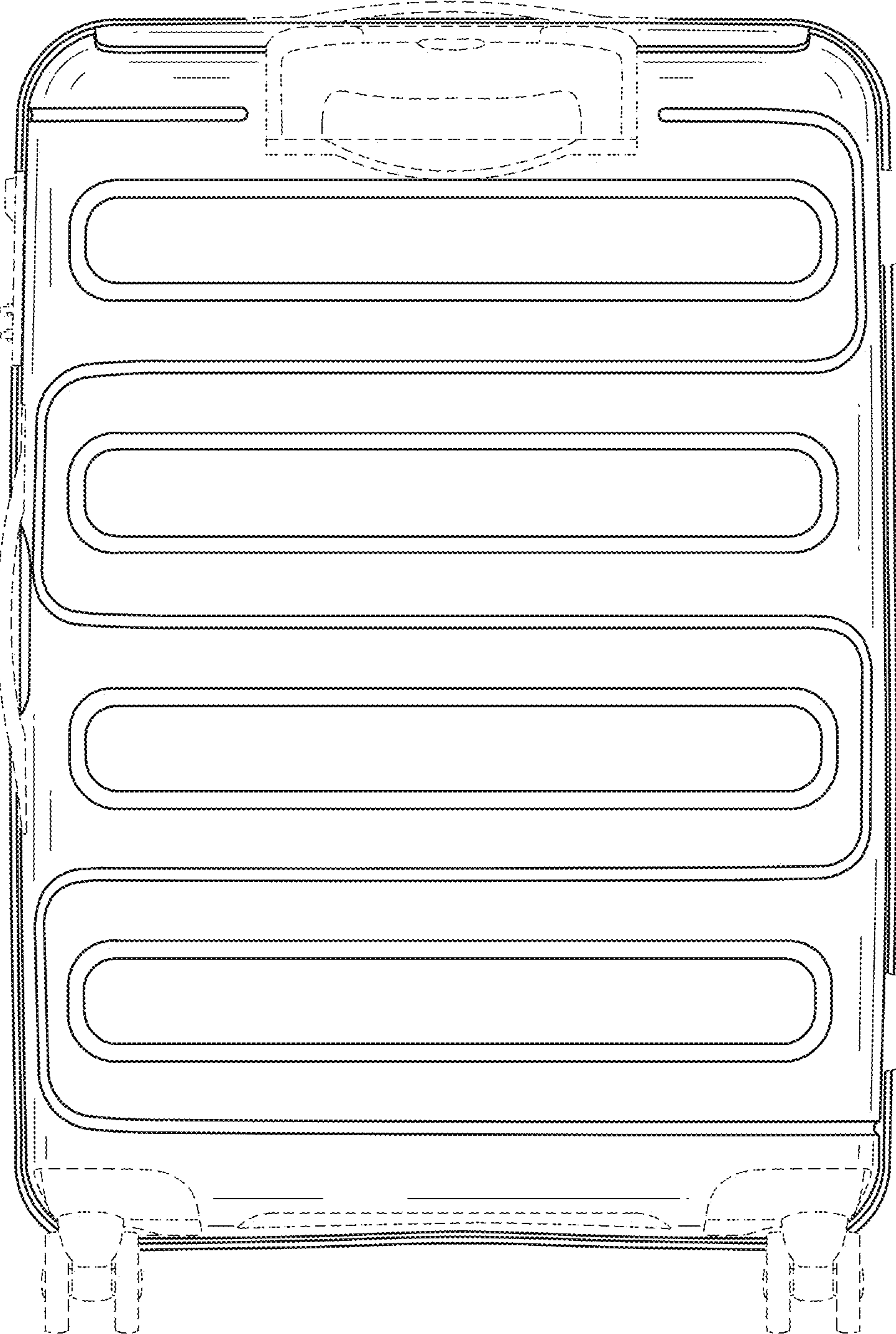

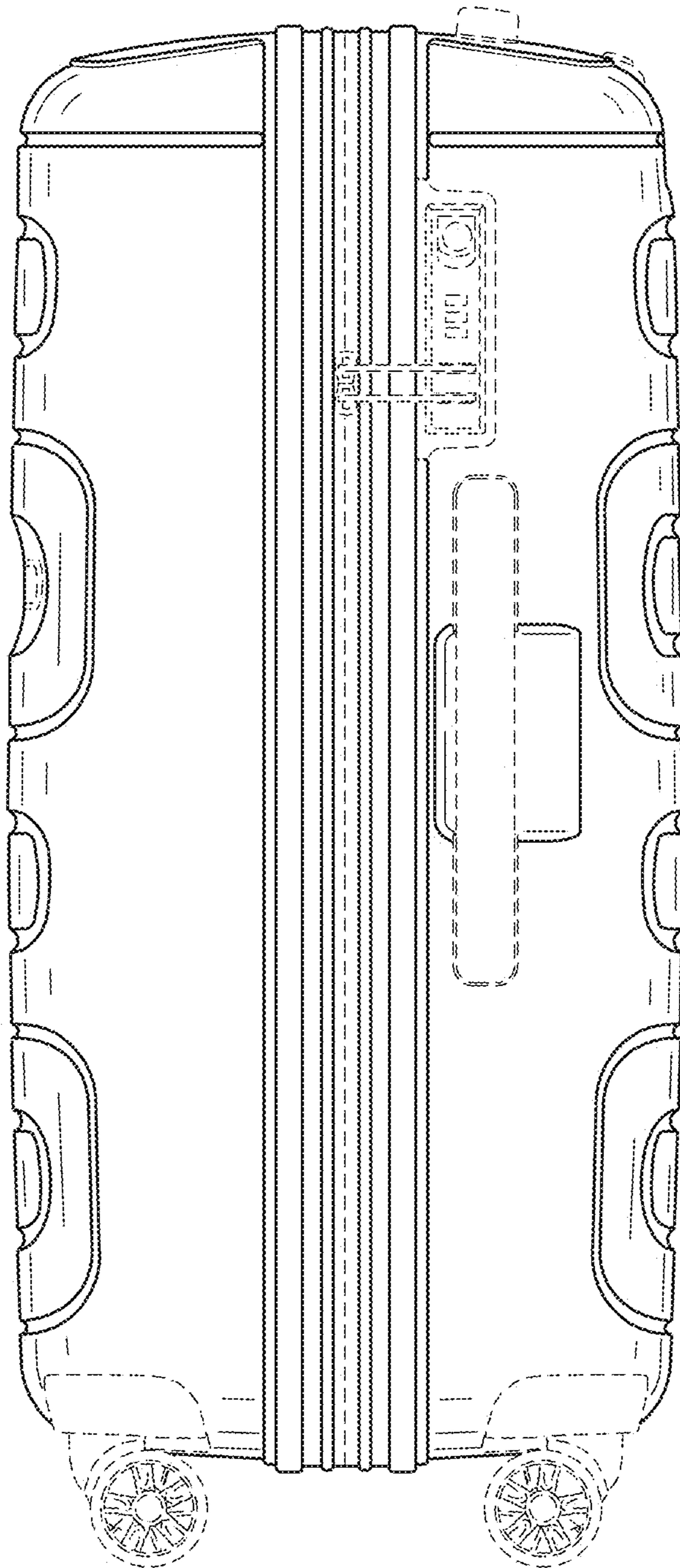

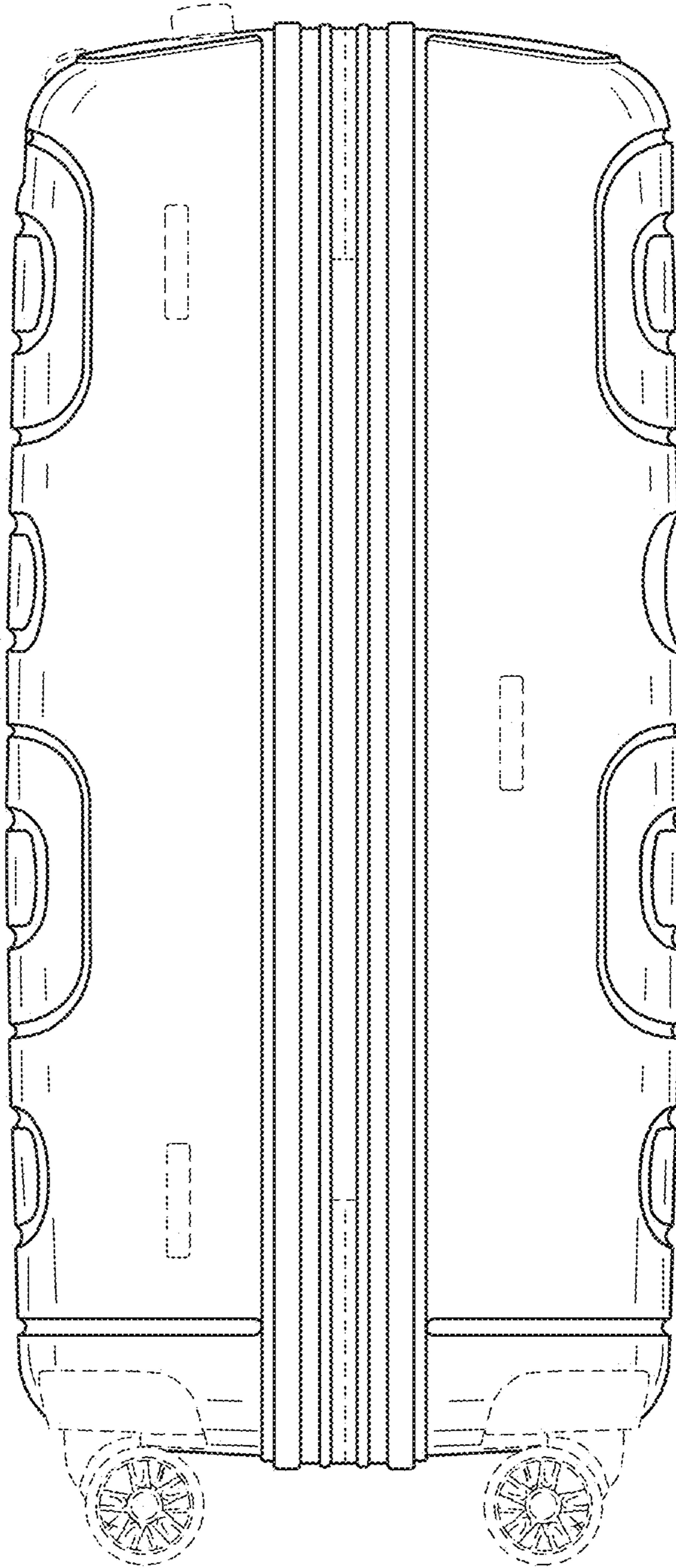

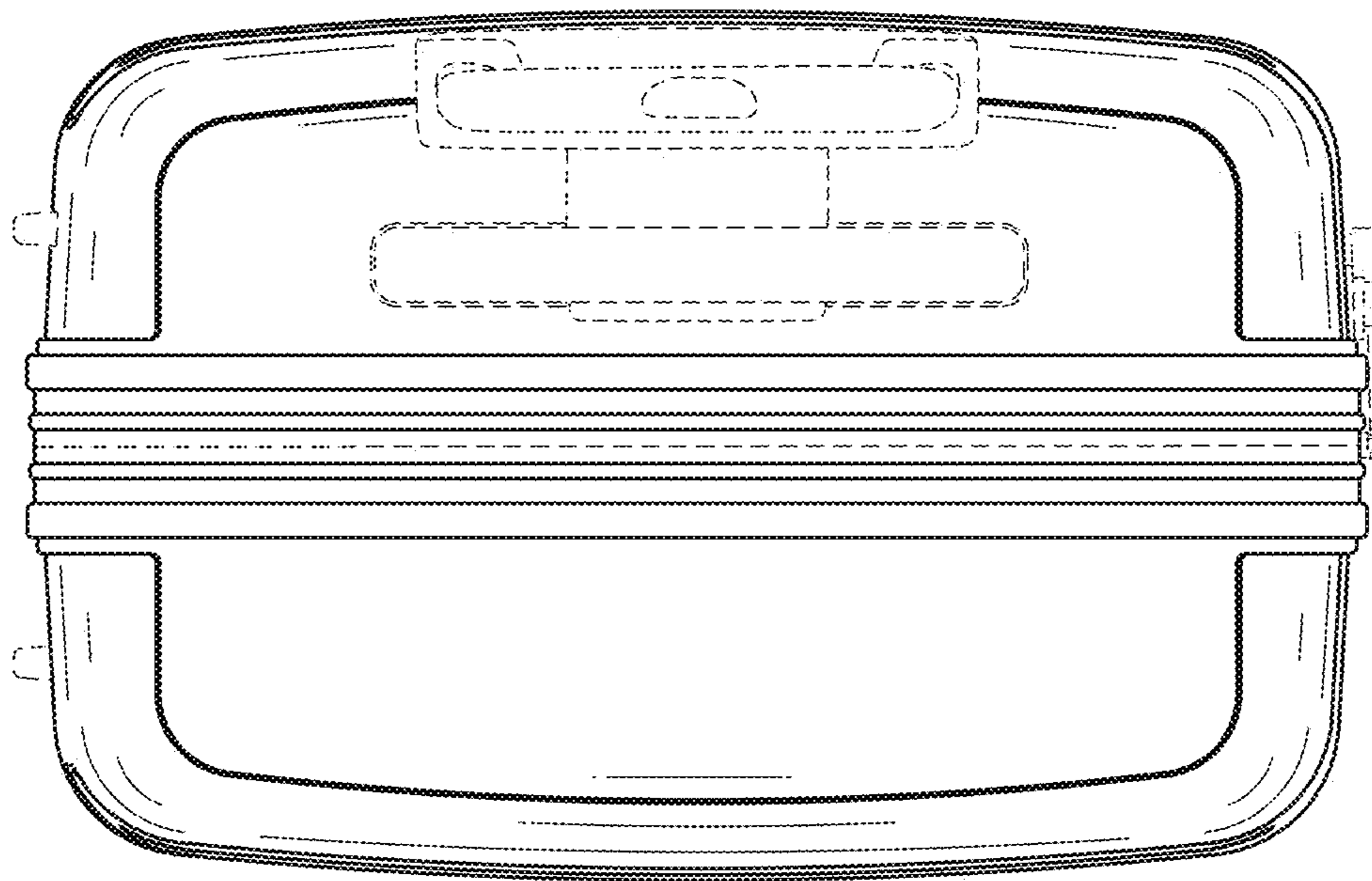

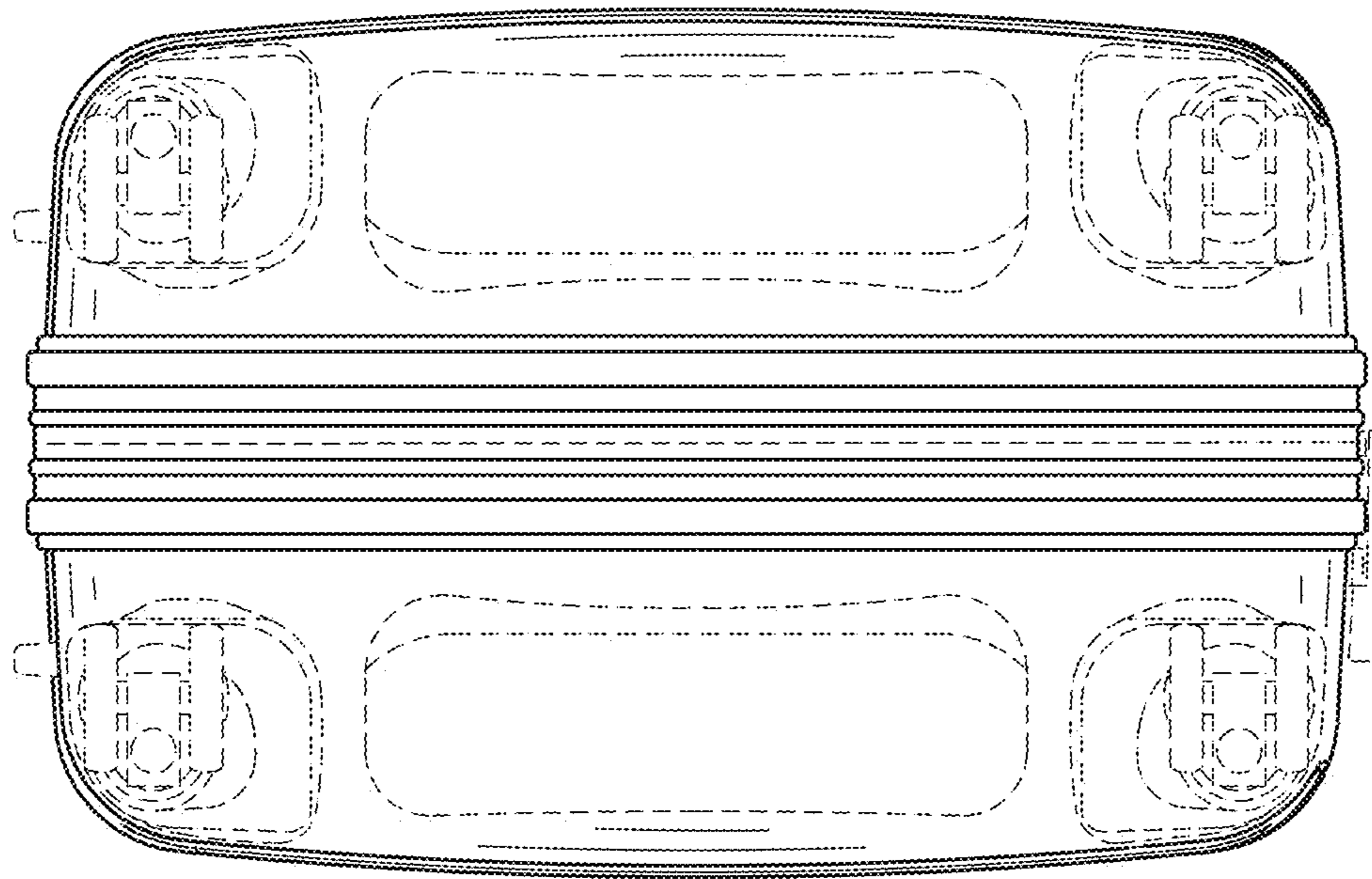
