(57) **CLAIM**

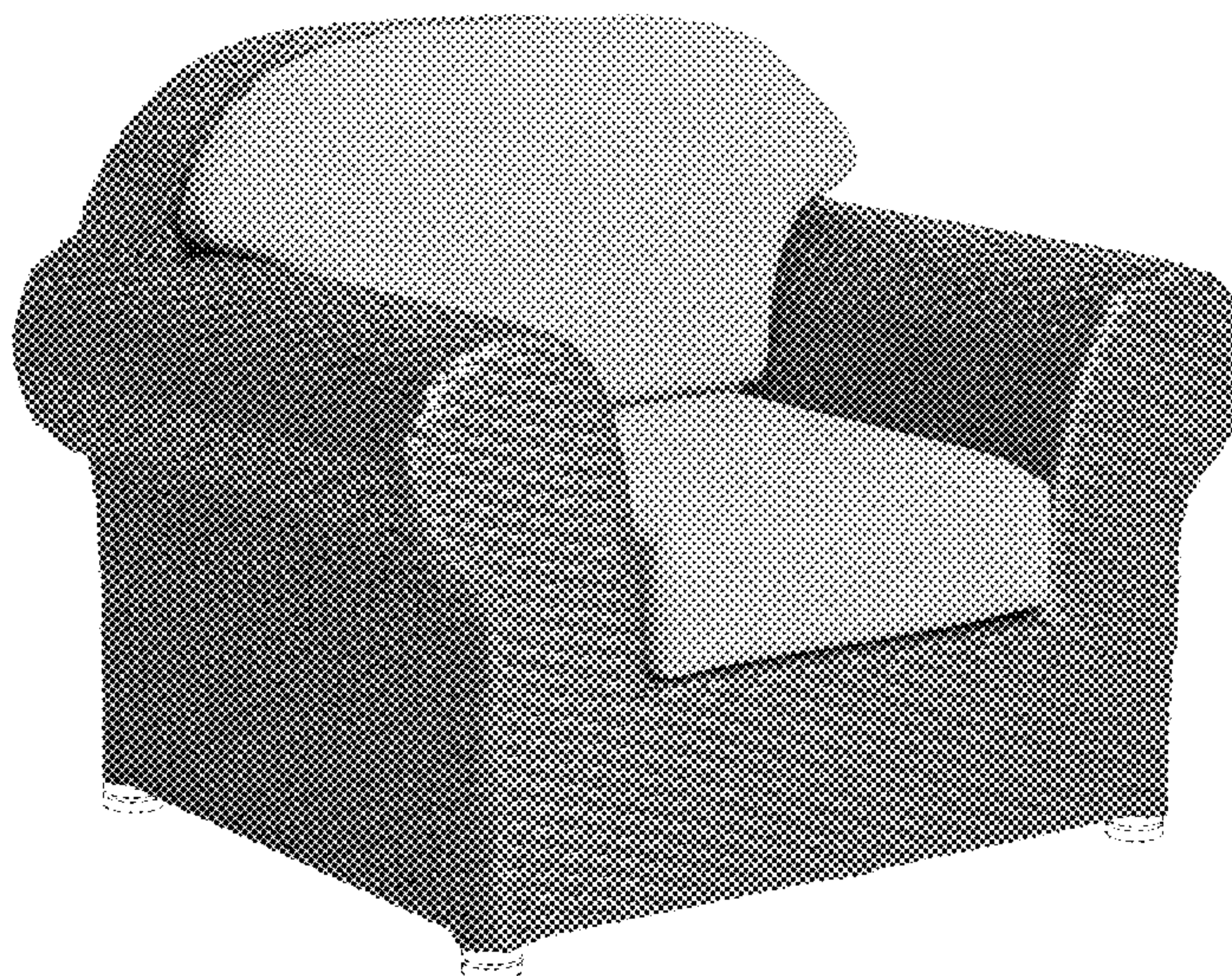
The ornamental design for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of a chair showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a left side elevation view thereof; and,  
FIG. 6 is a top plan view thereof.

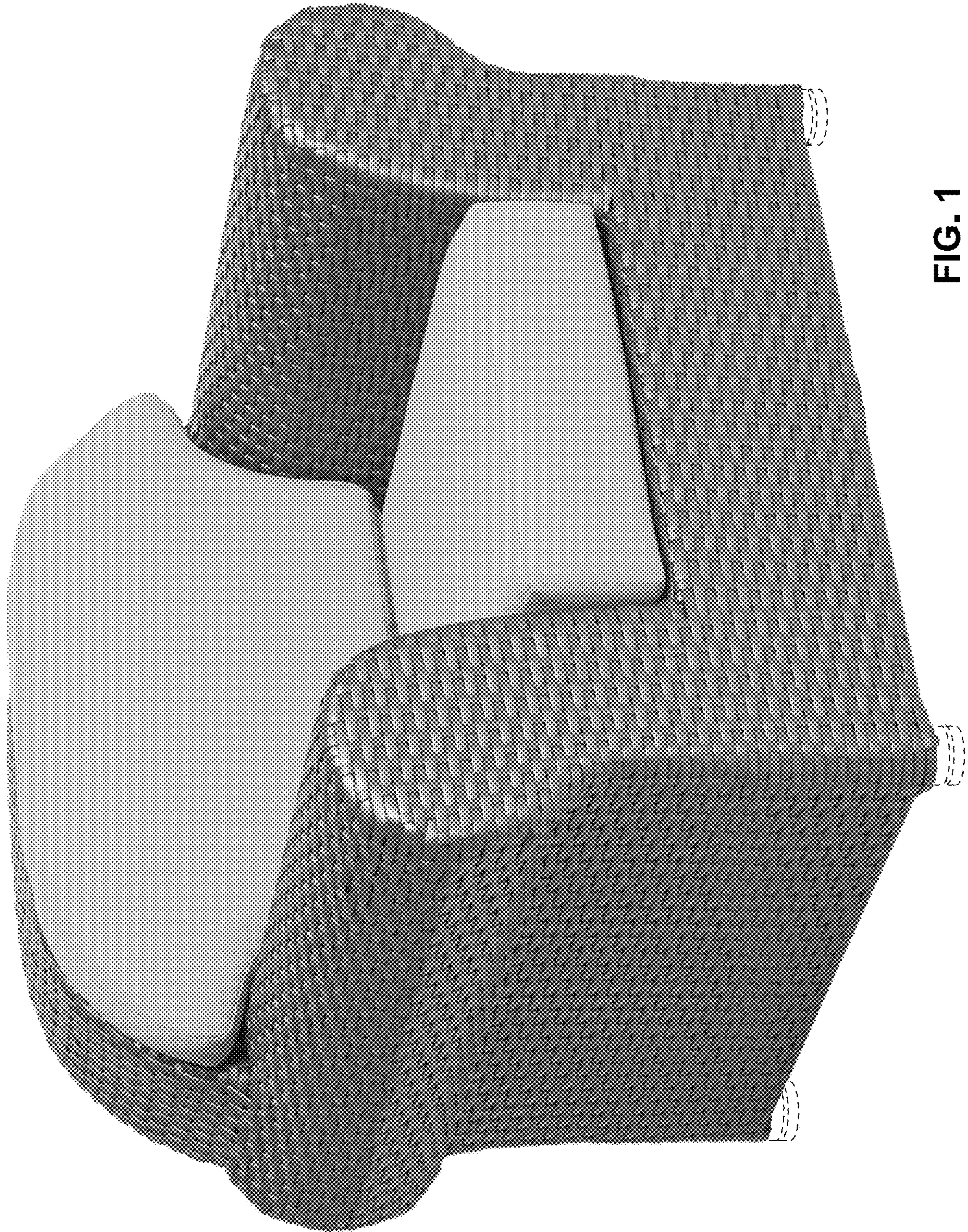

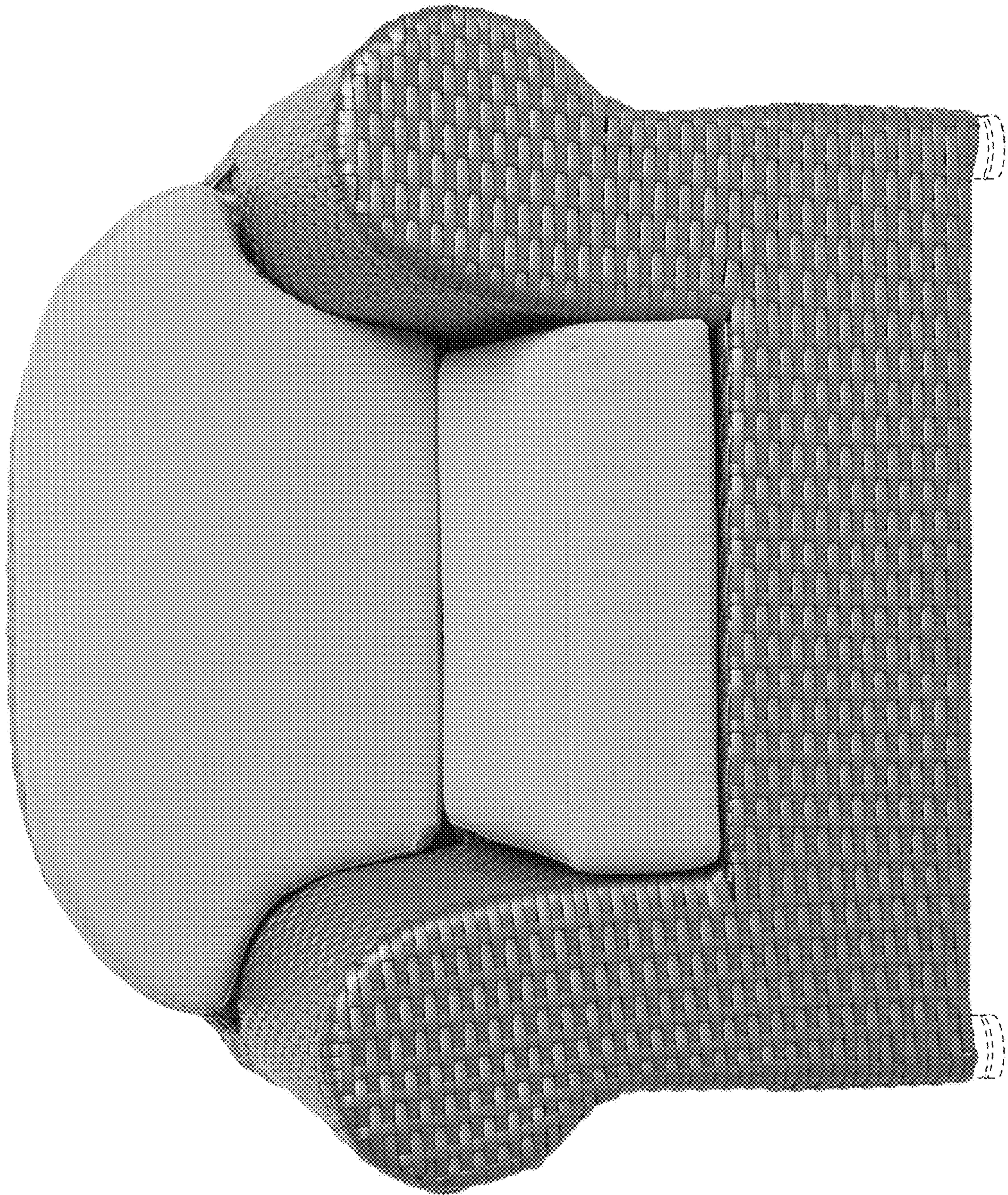

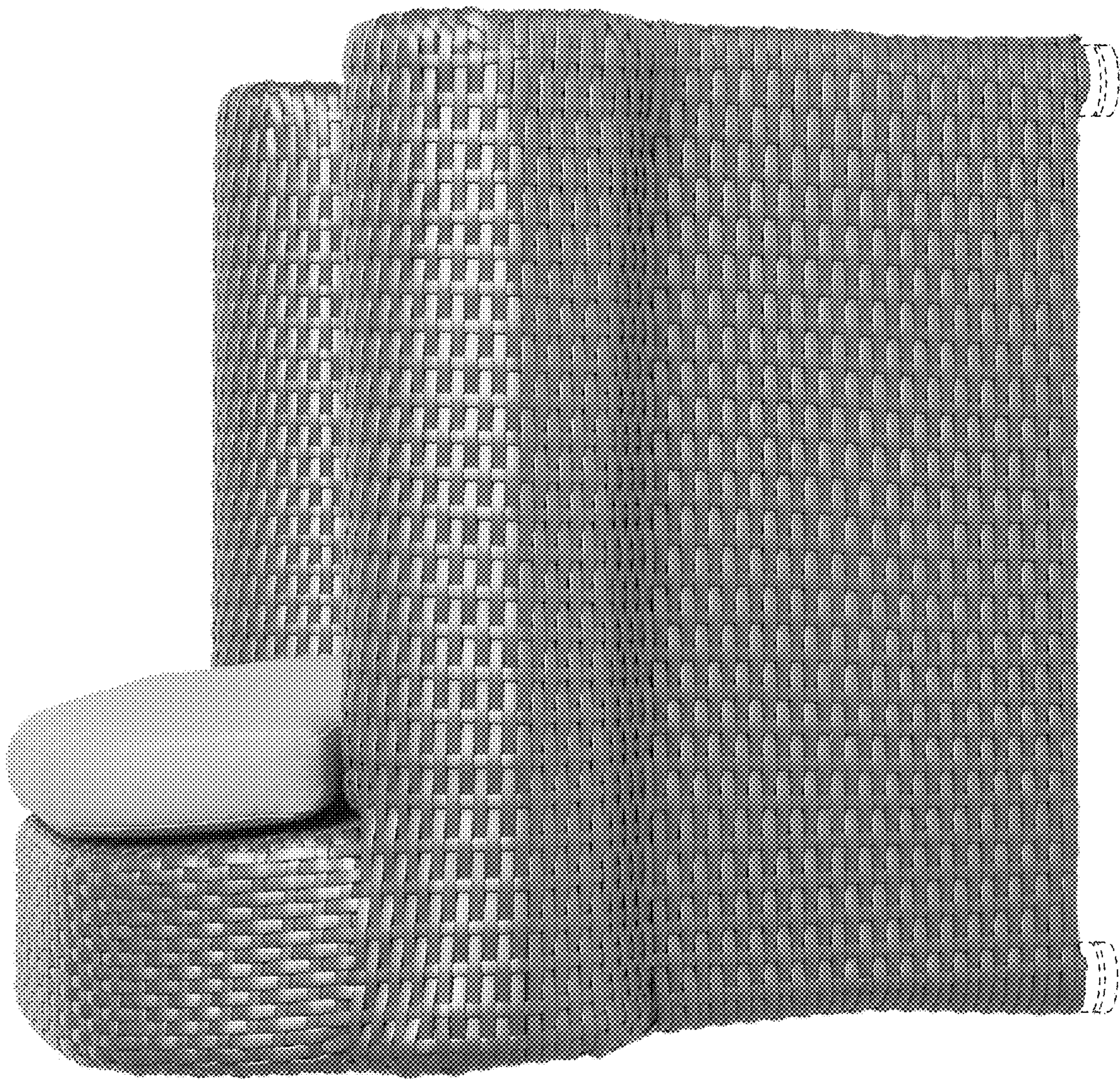
