The broken lines in the drawings illustrate portions of the motorcycle and/or replica thereof that form no part of the claimed design.

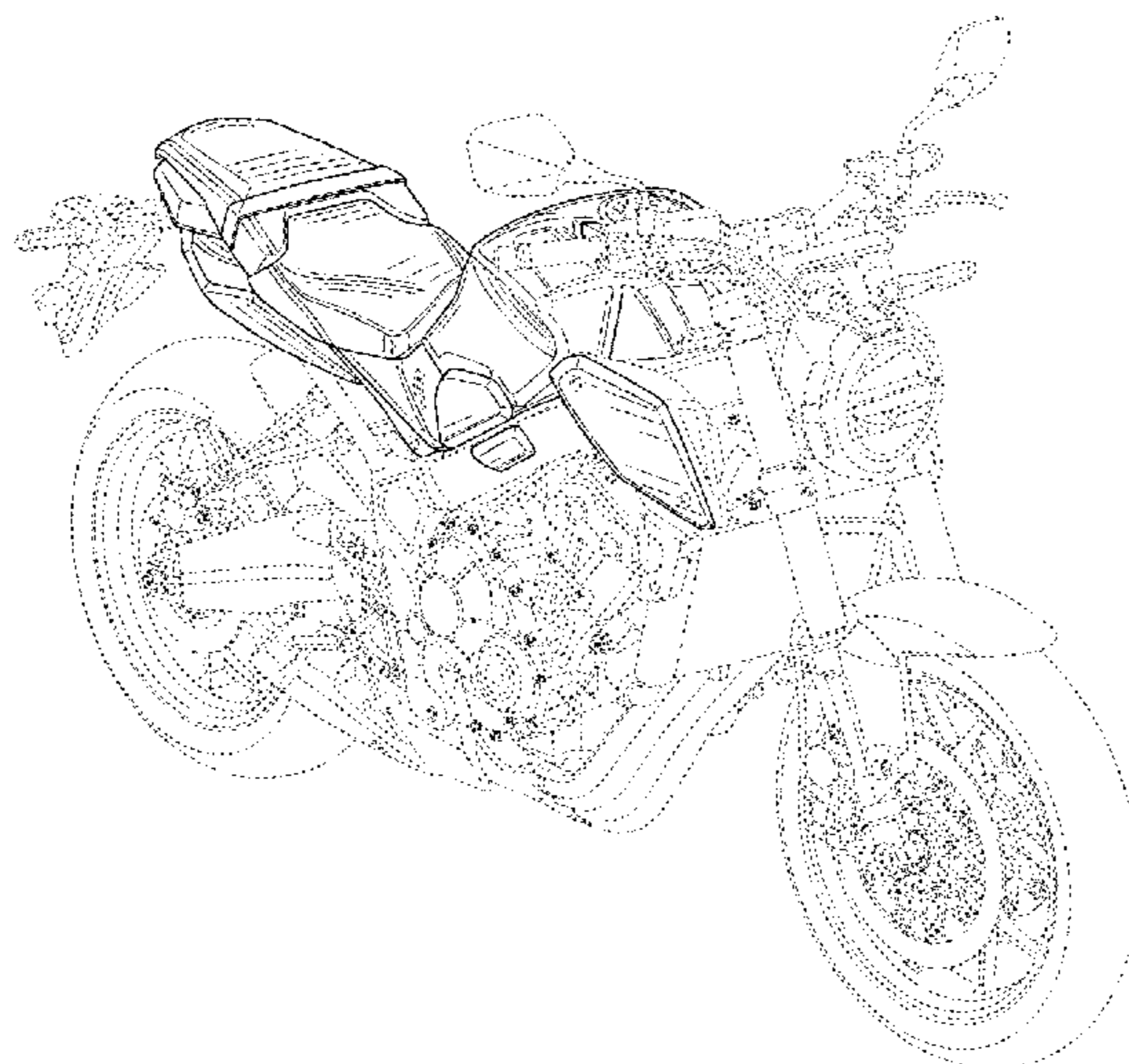

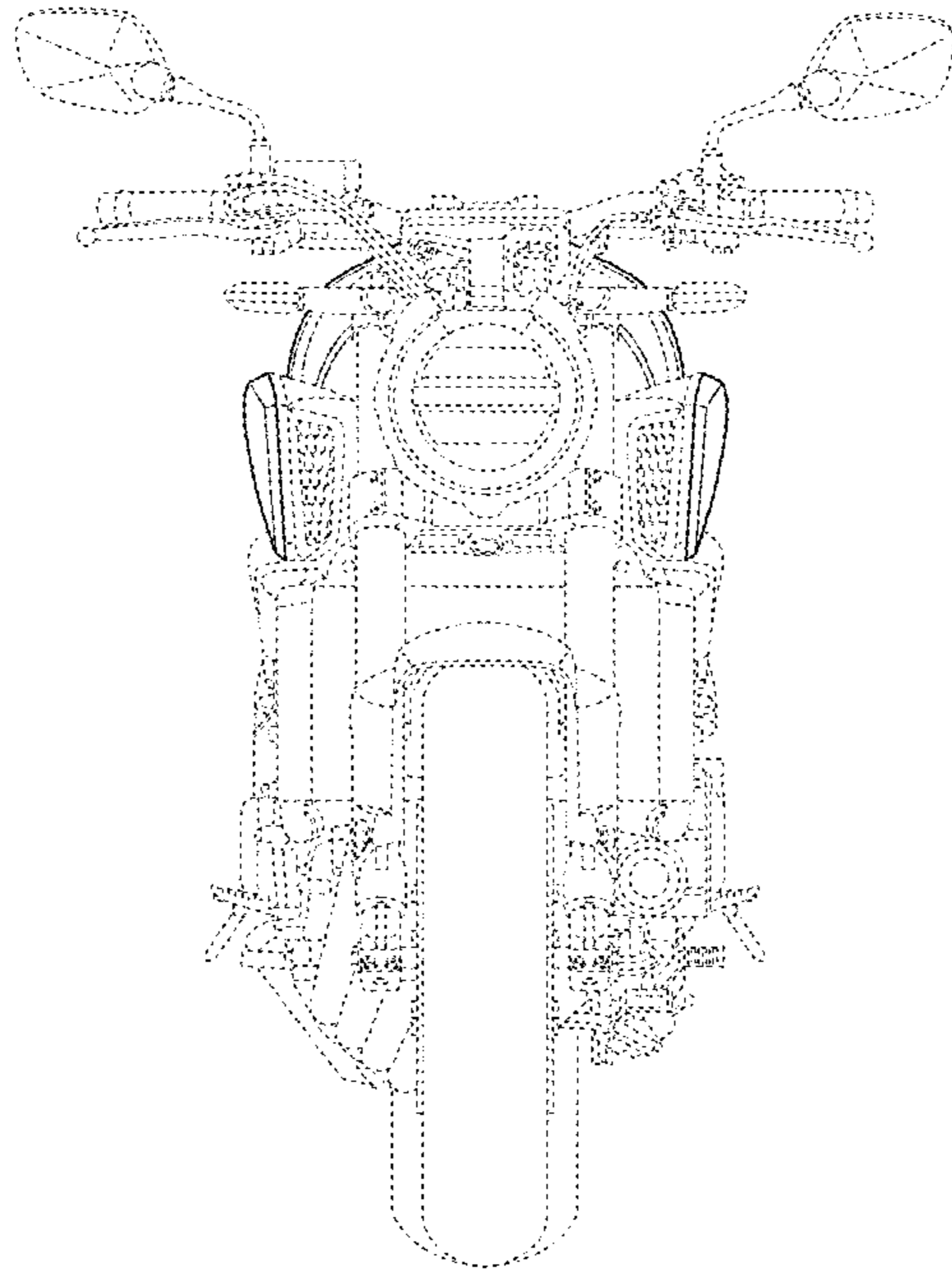

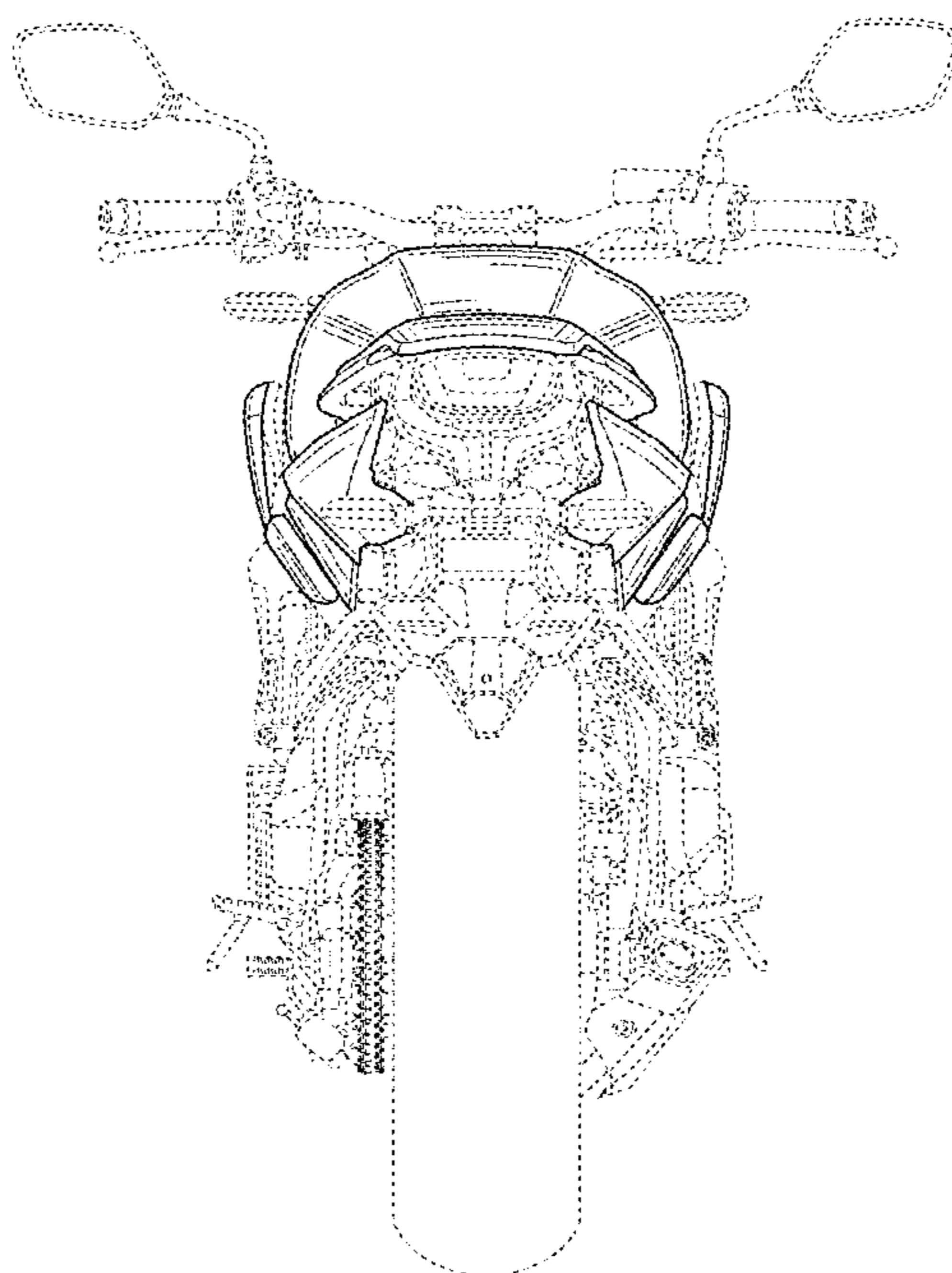

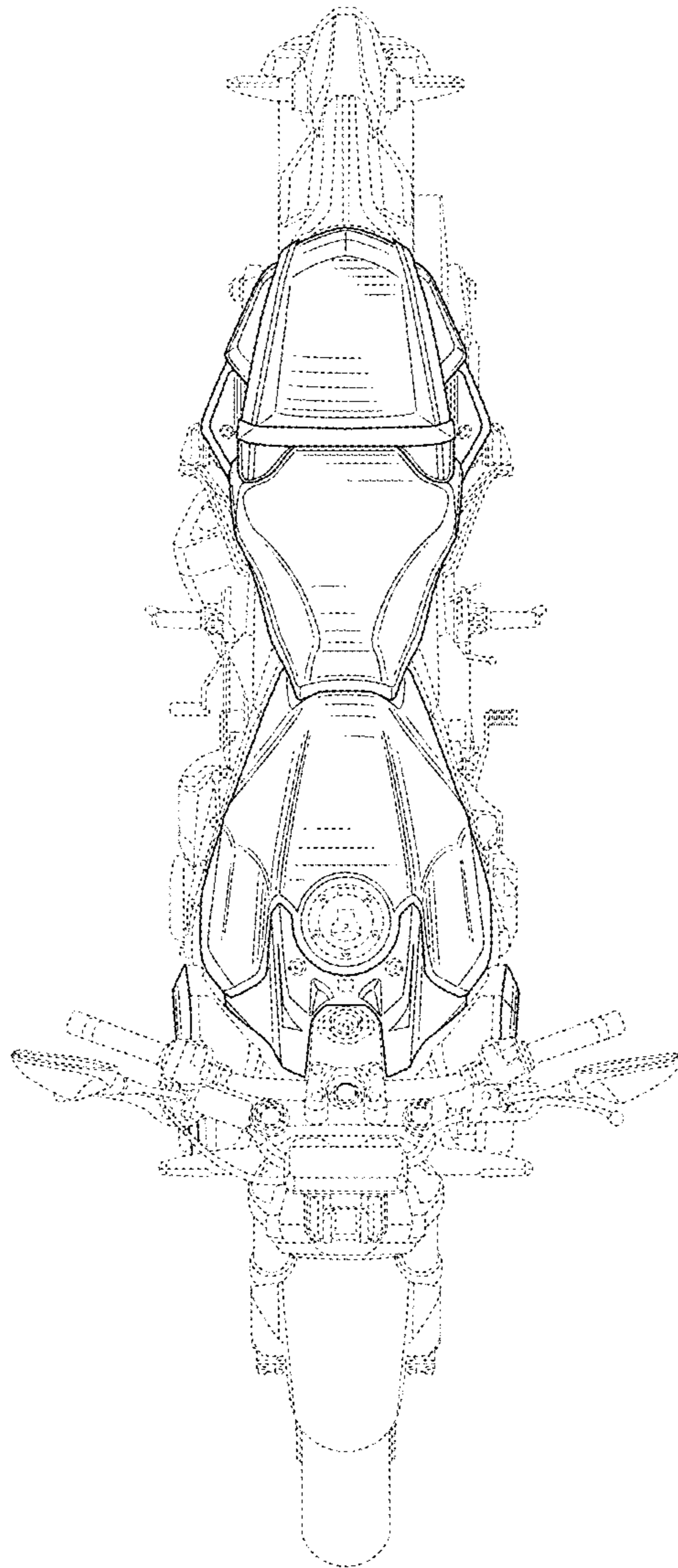

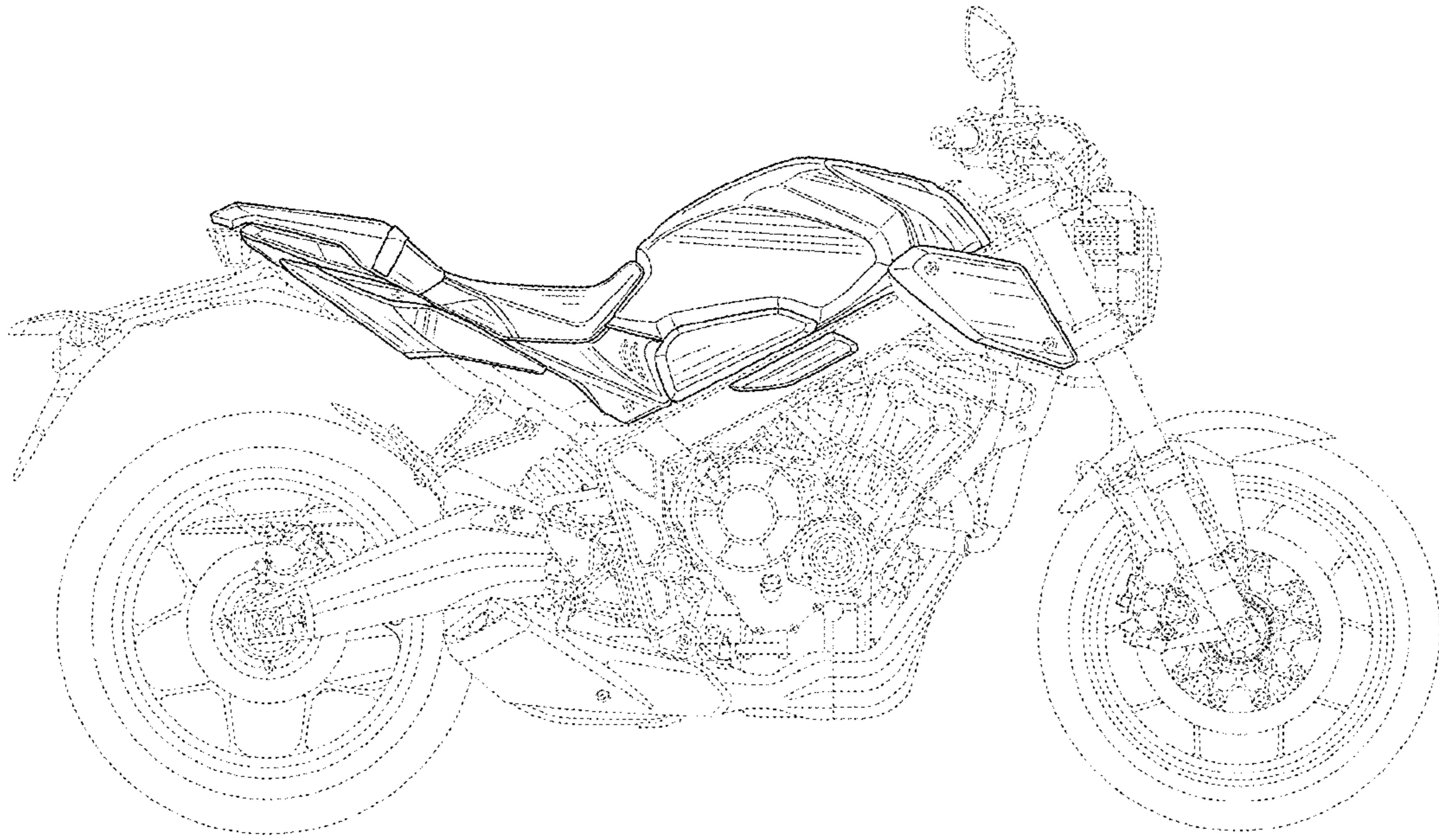

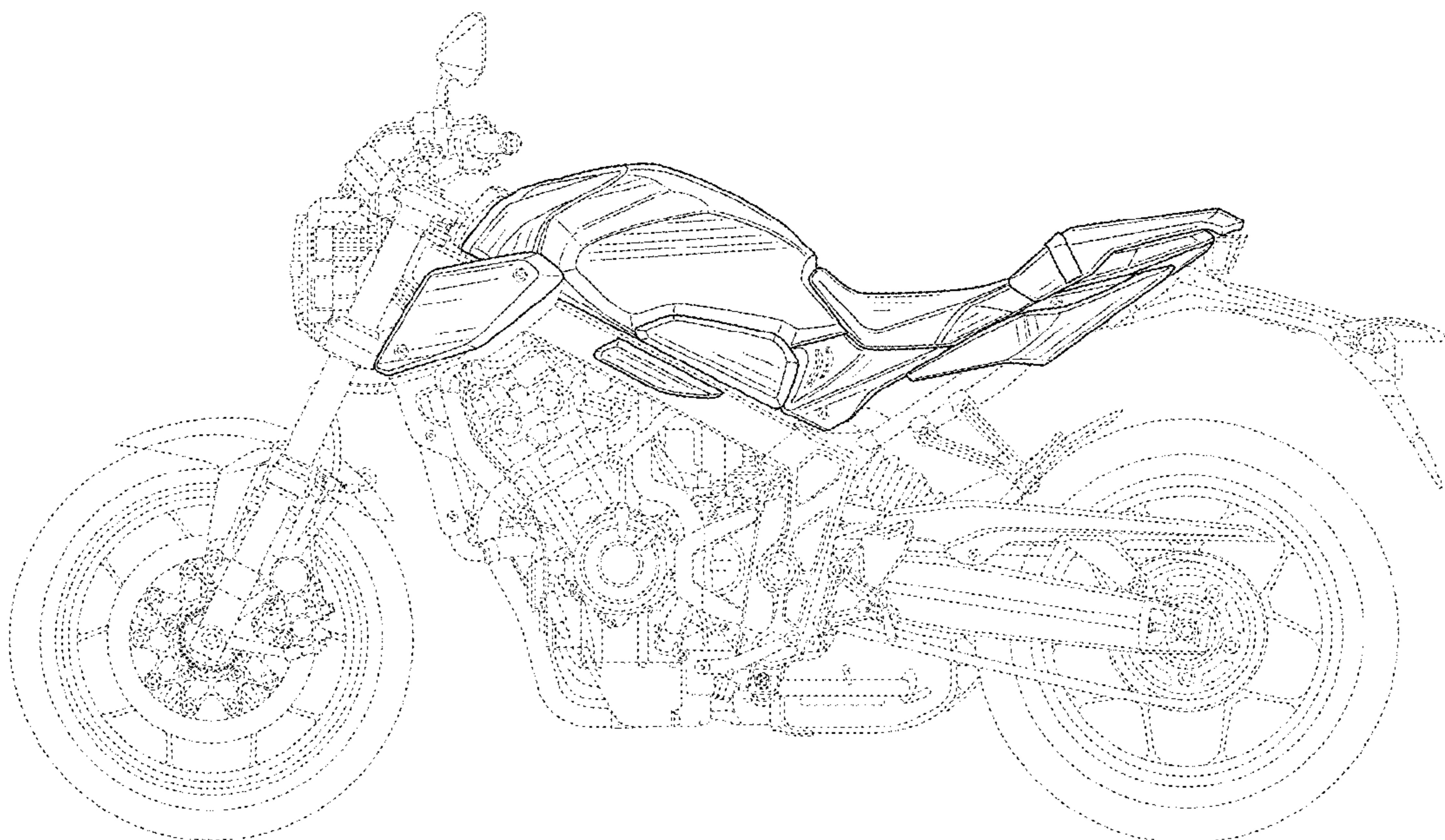

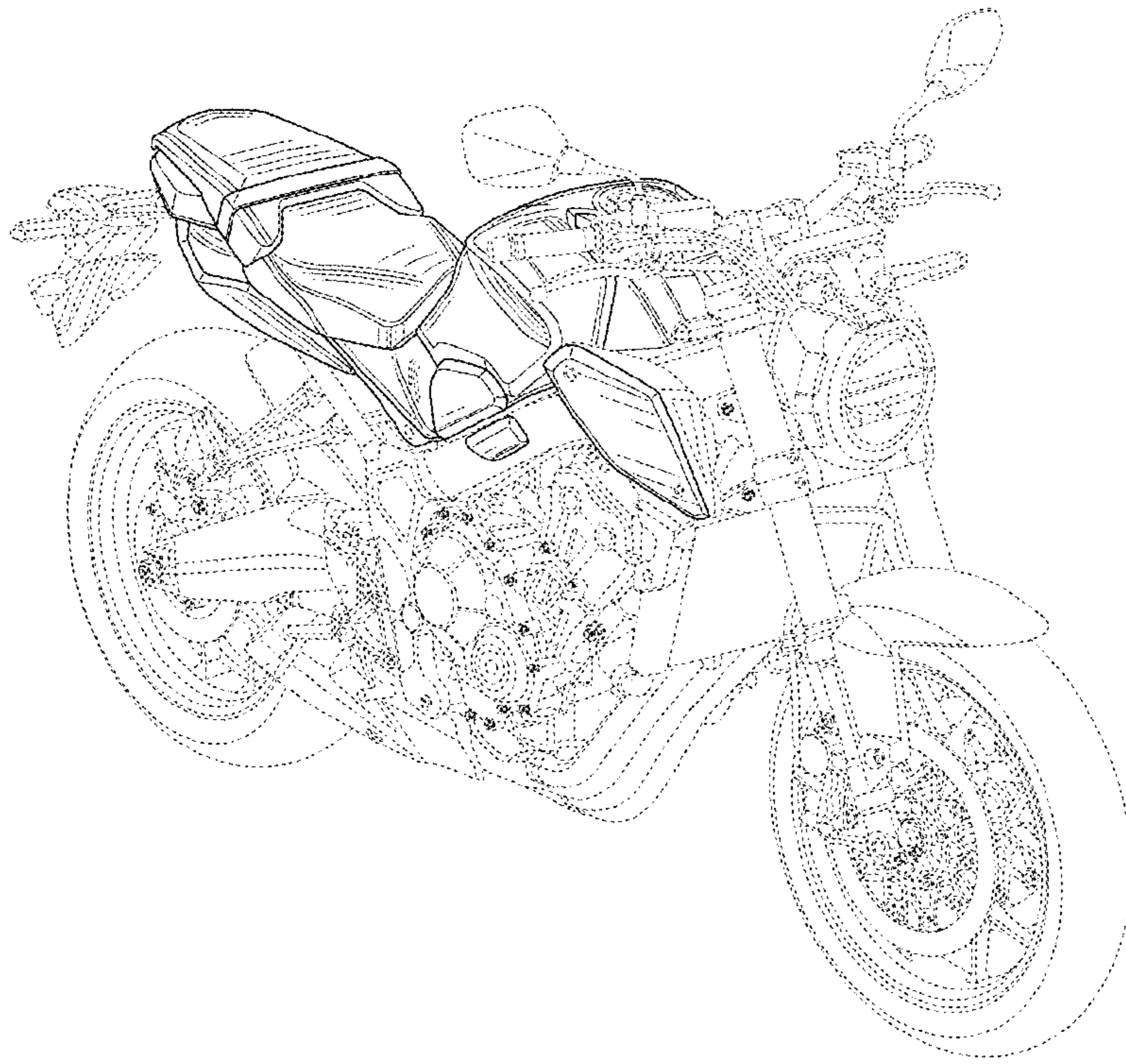

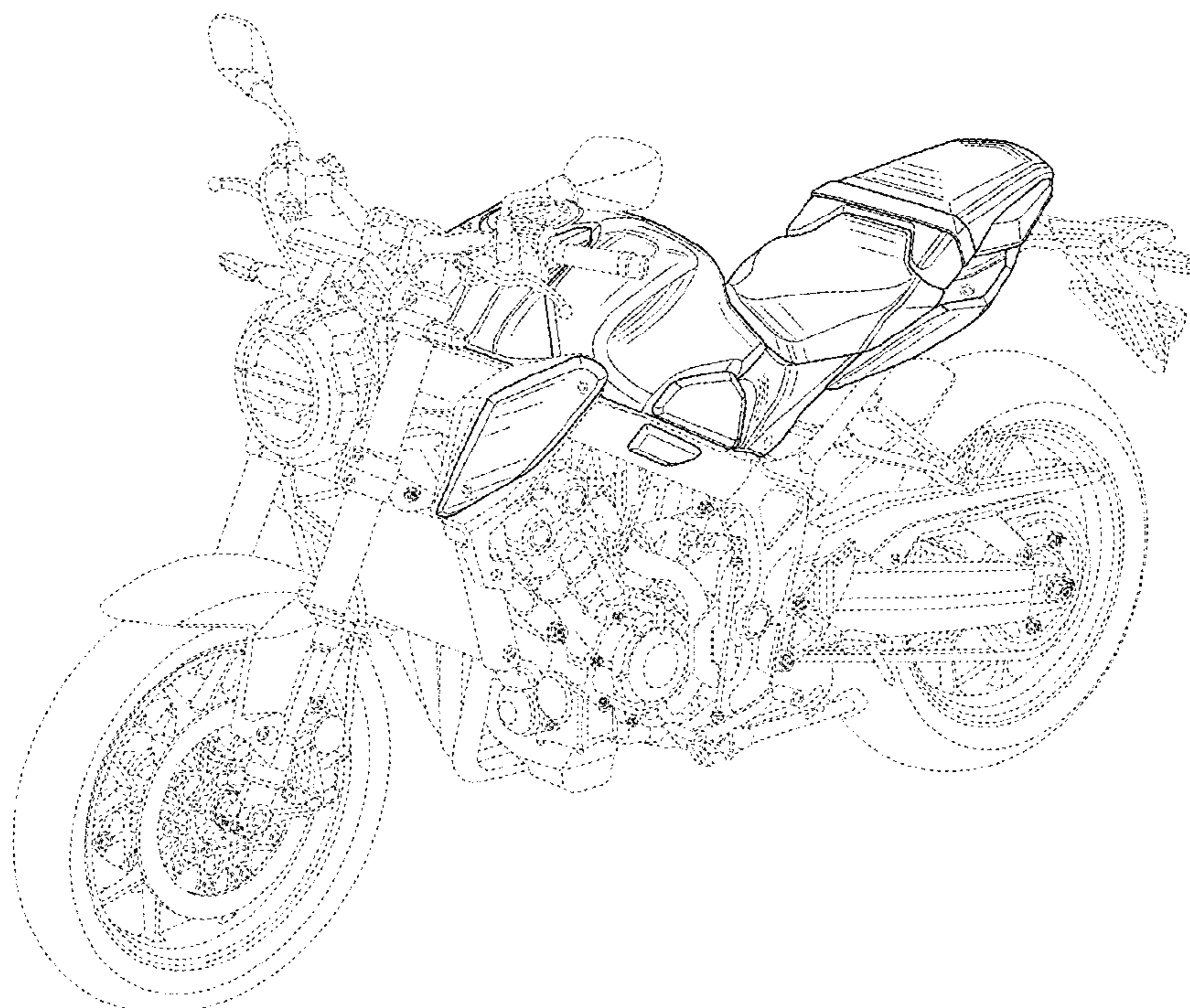

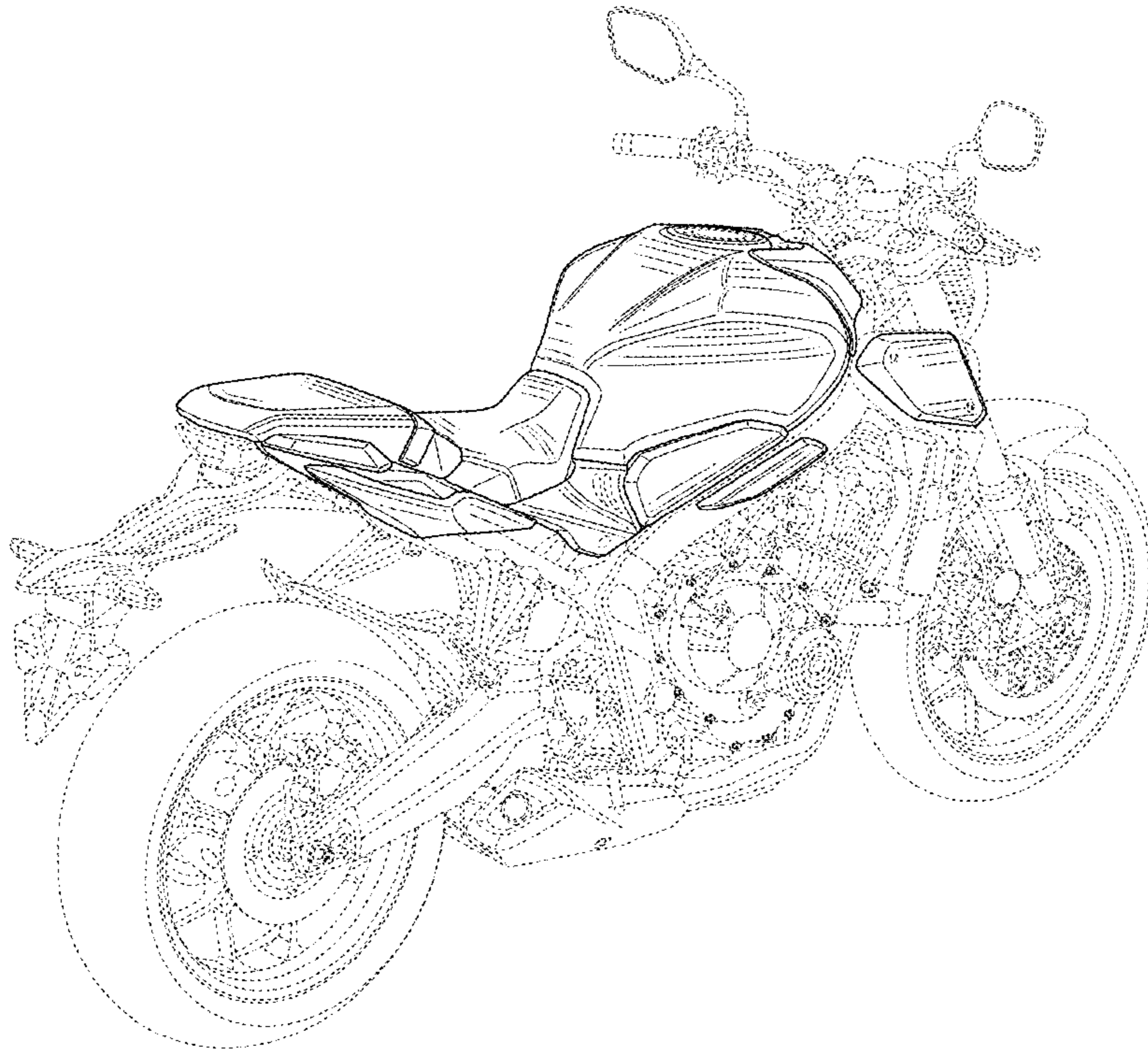
