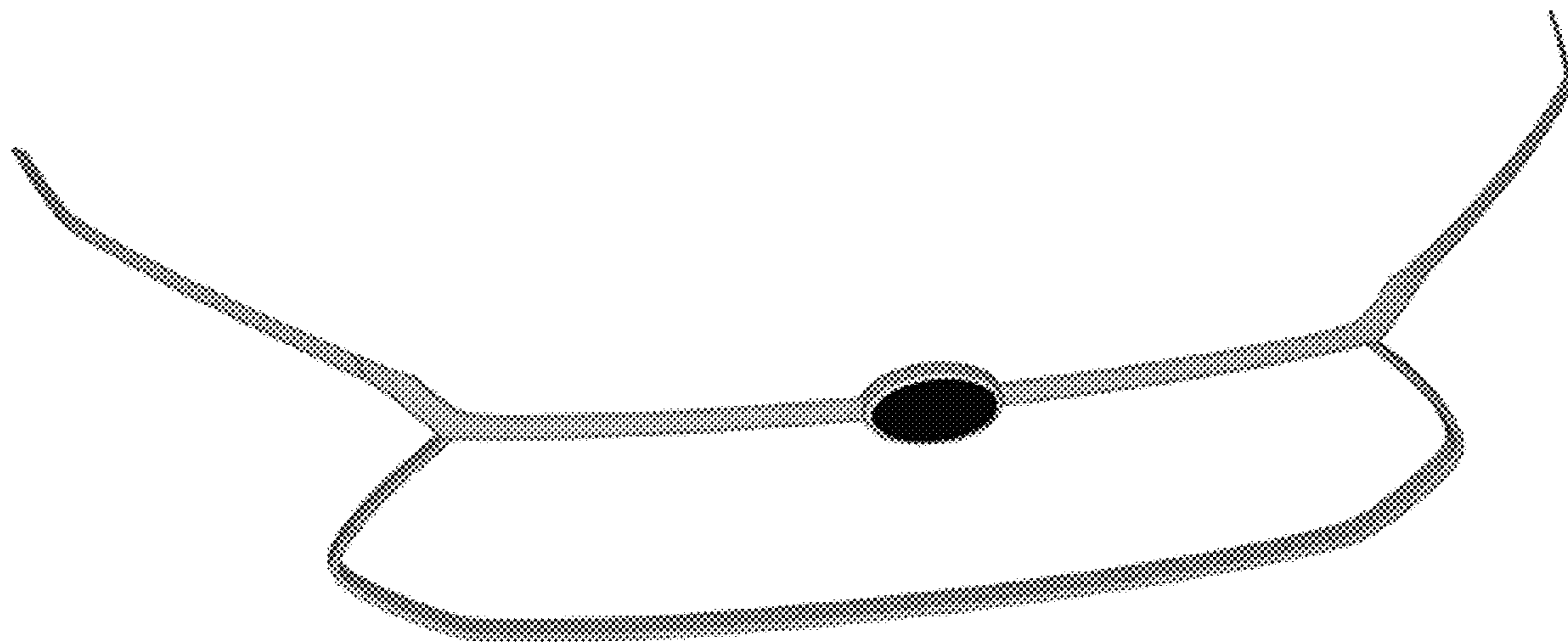
(57) **CLAIM**

We claim the ornamental design for a grille for an automo-
bile, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a grille for an automo-
bile of the present design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top/front/left perspective view thereof; and,
FIG. 8 is a top/front/right perspective view thereof.
The rendered drawings include surface shading that repre-
sents contour and not surface ornamentation.

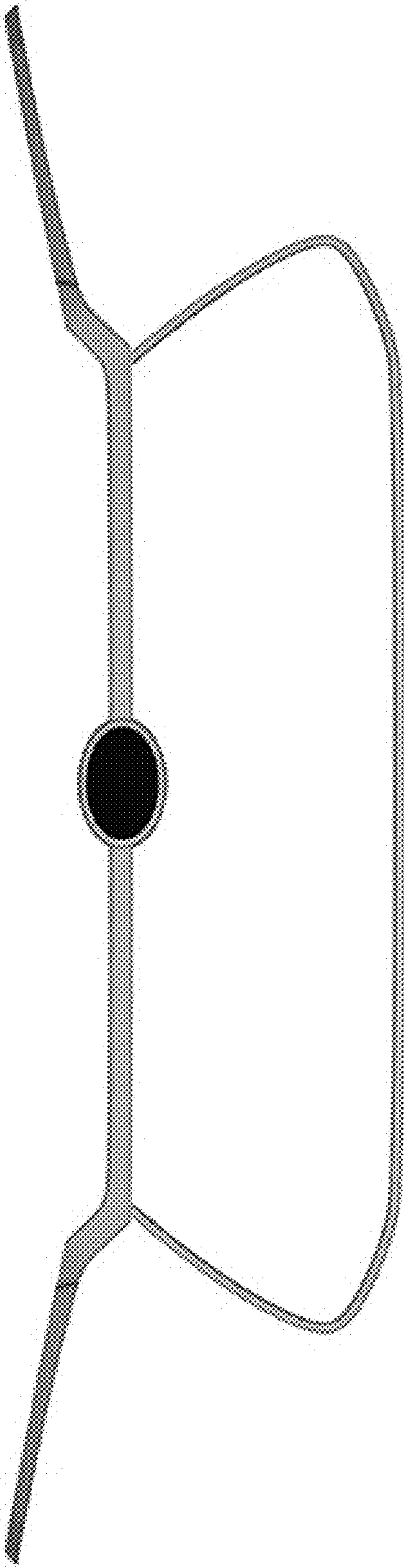

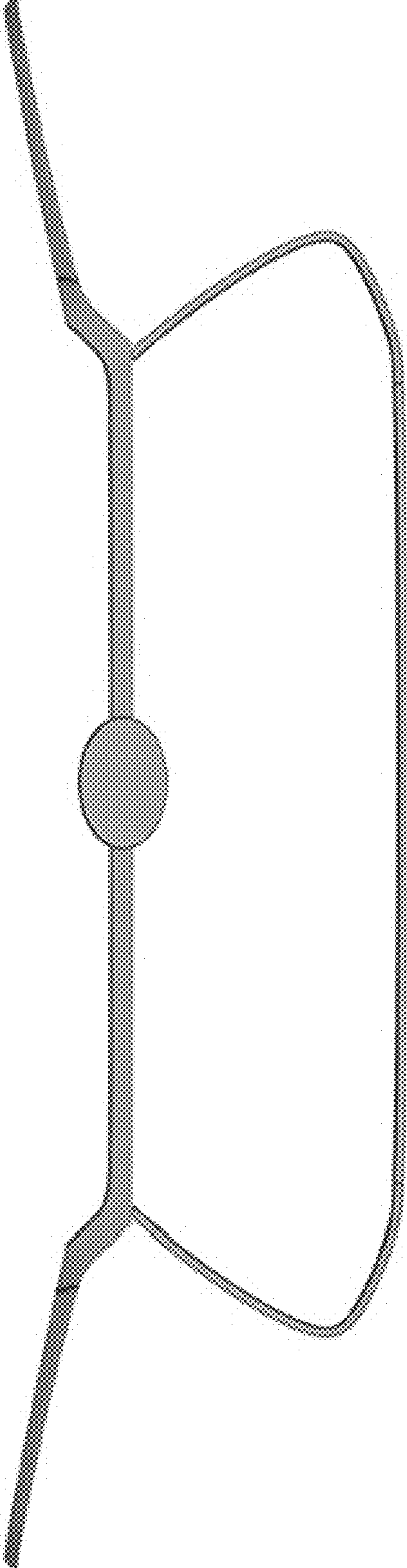

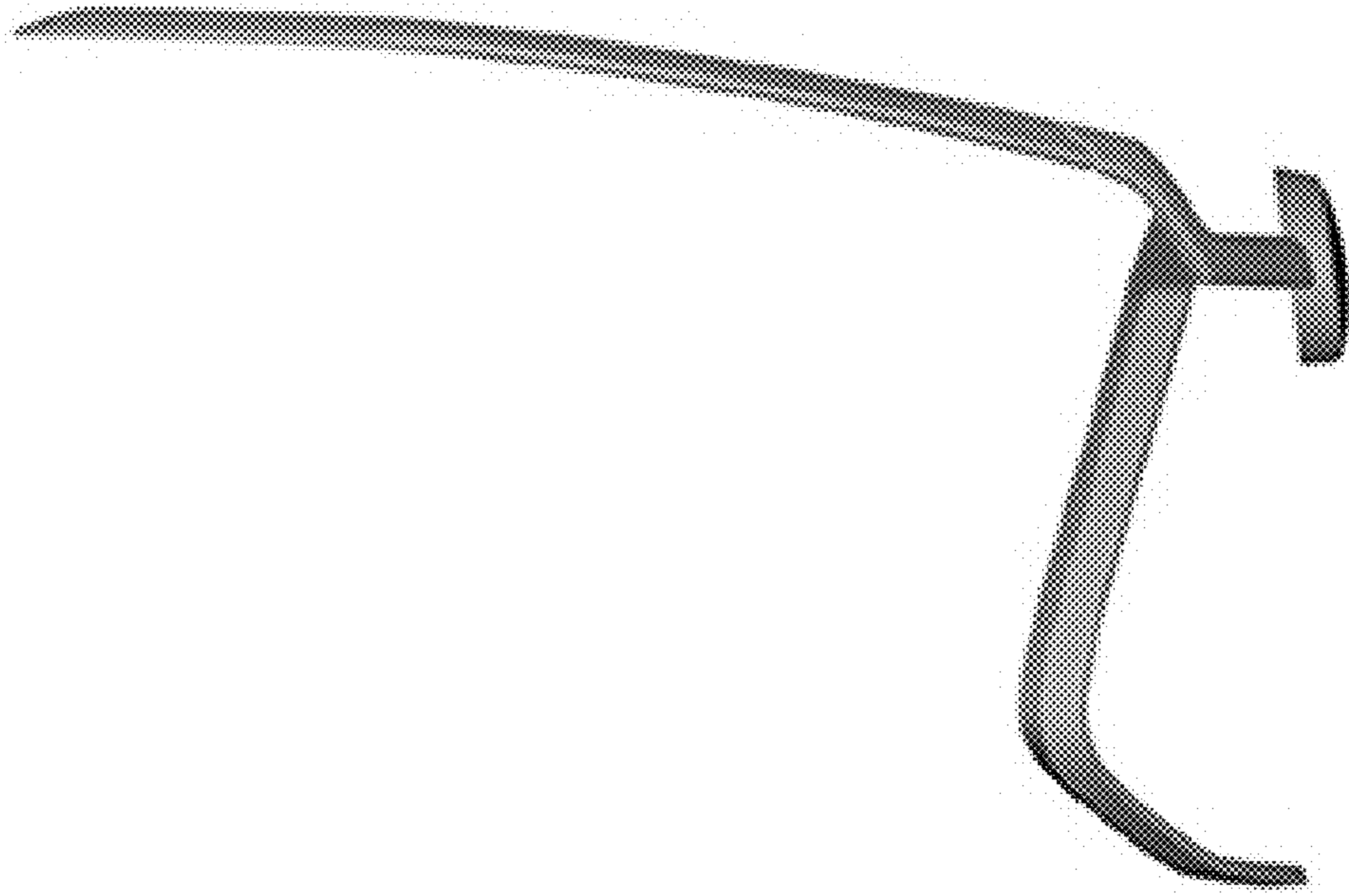

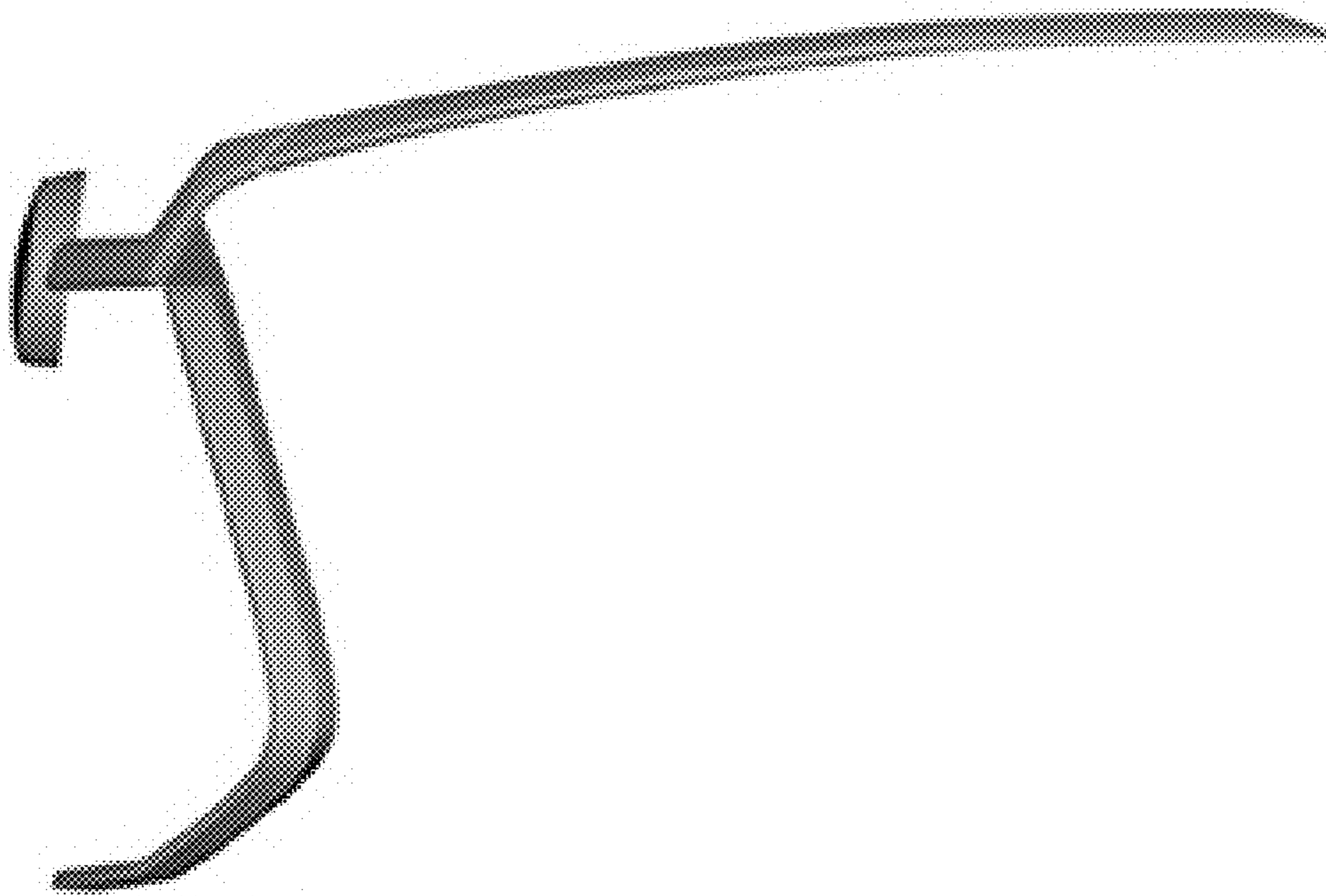

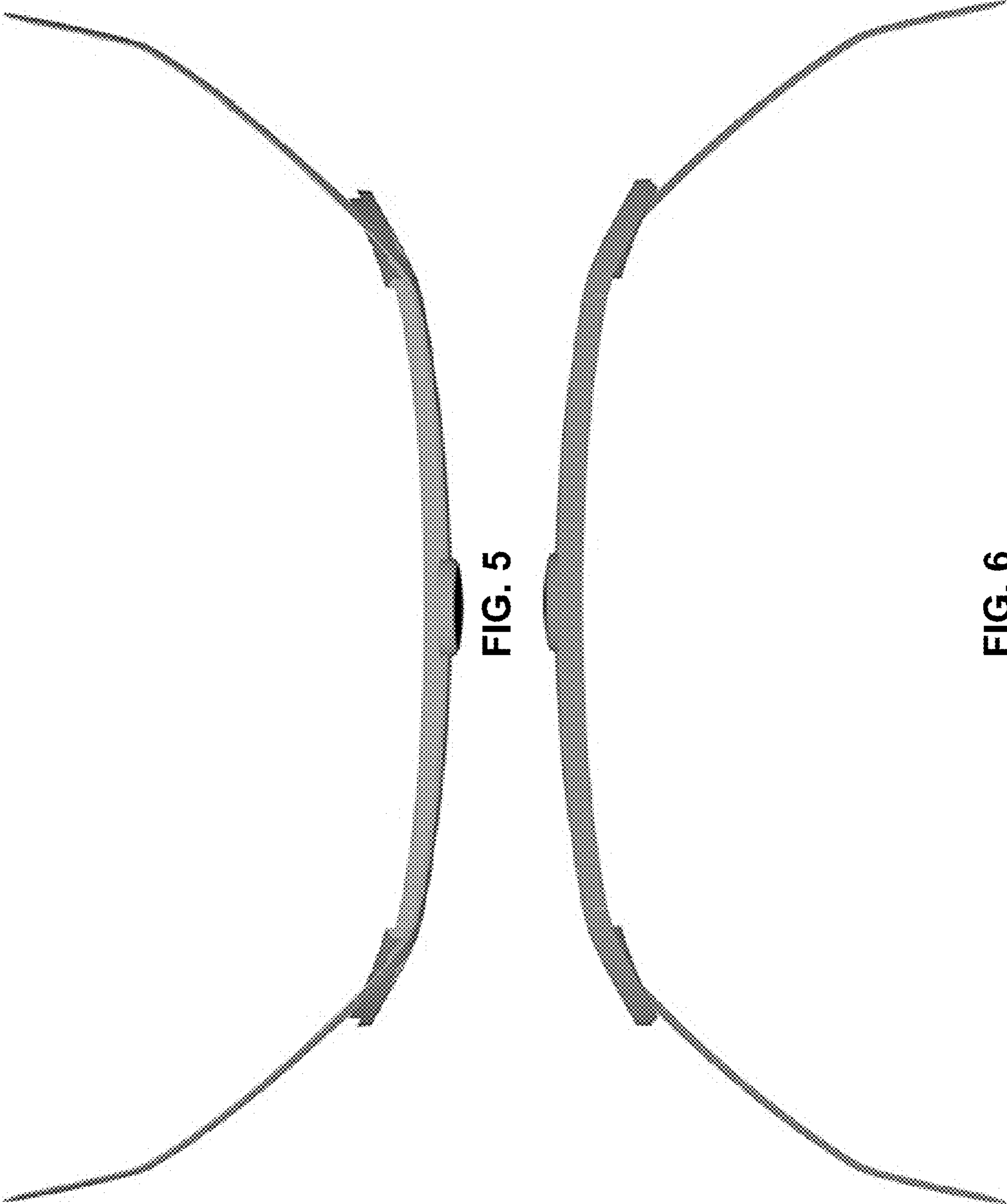
