The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automobile tire showing our design;

FIG. 2 is a front view thereof;

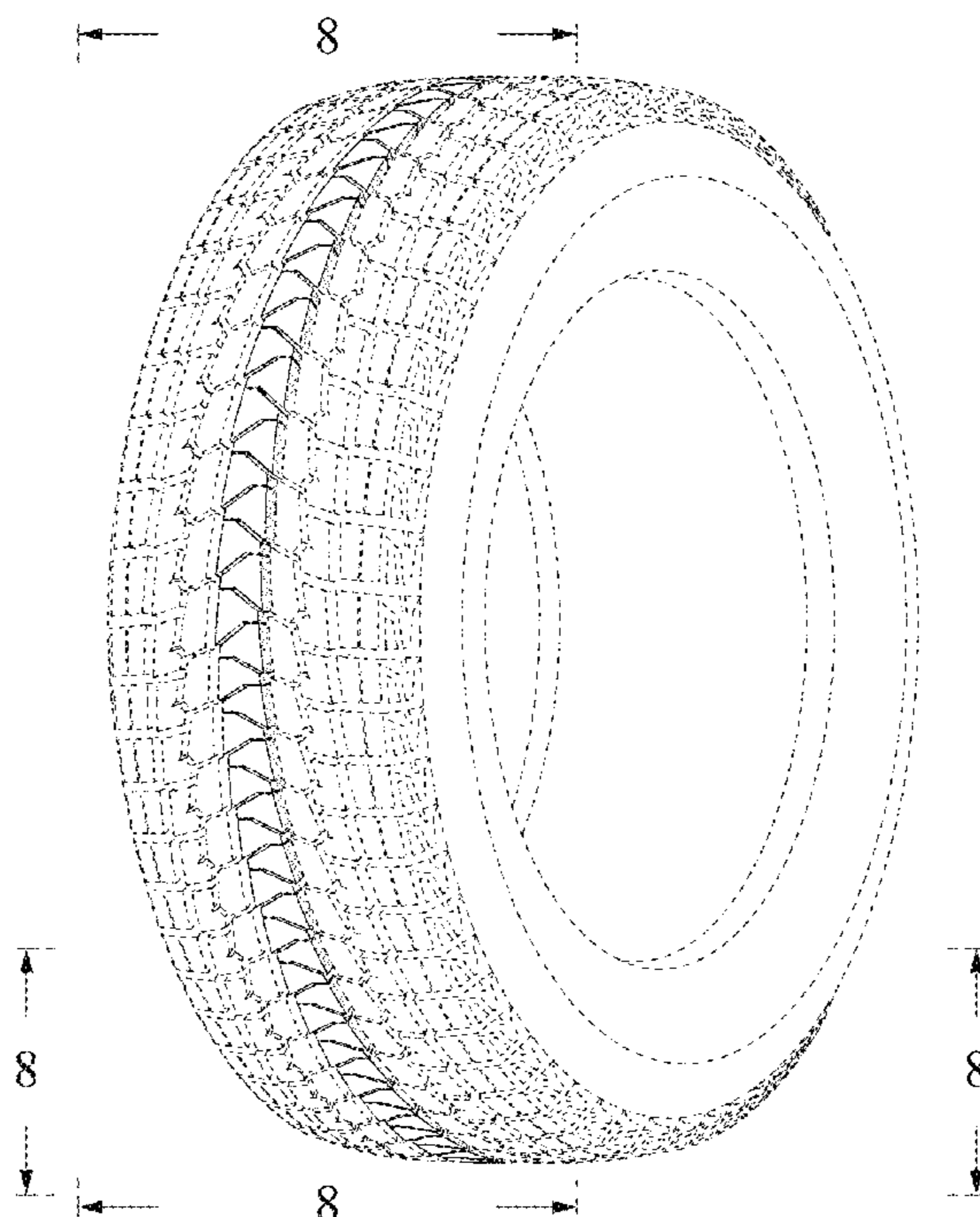

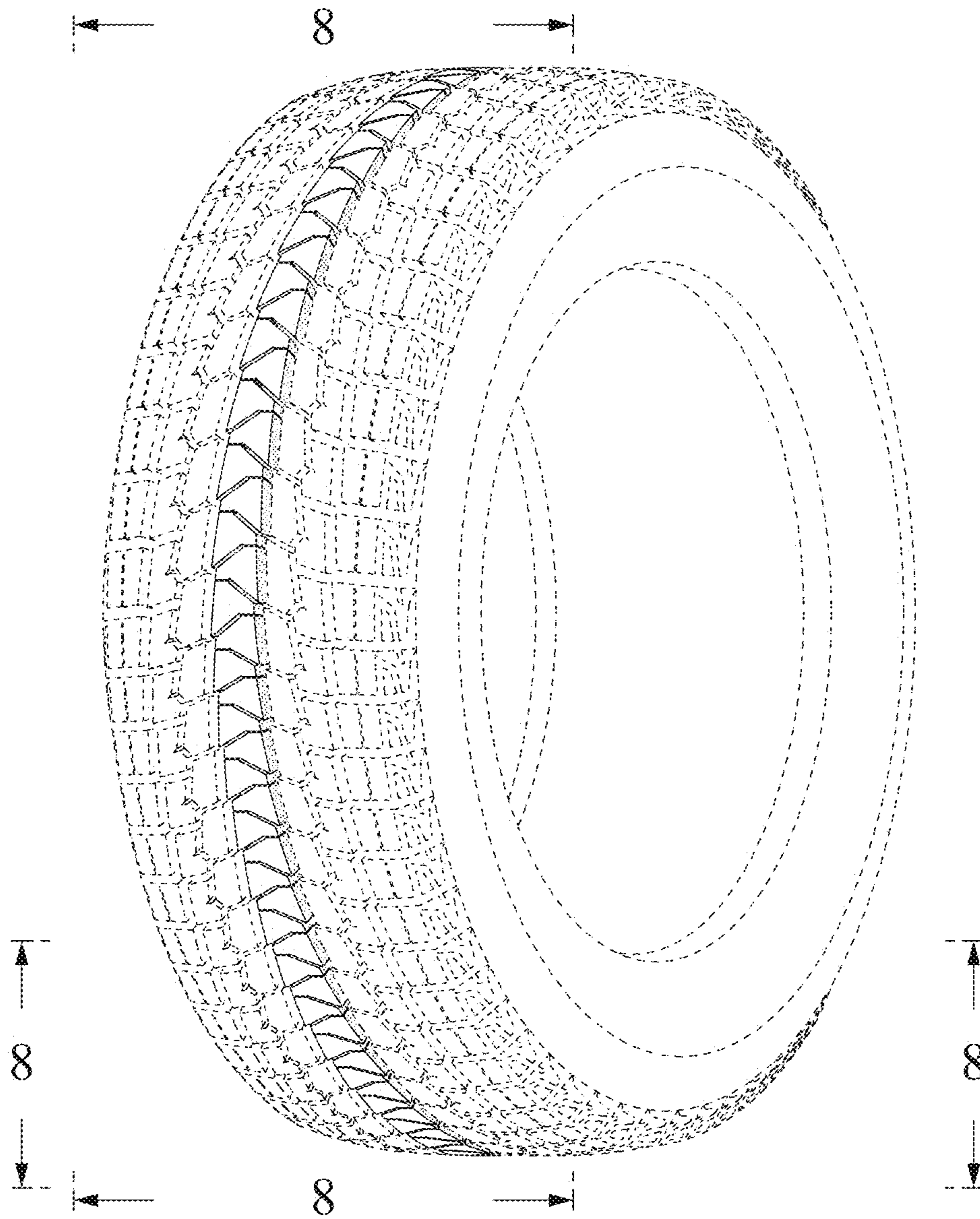

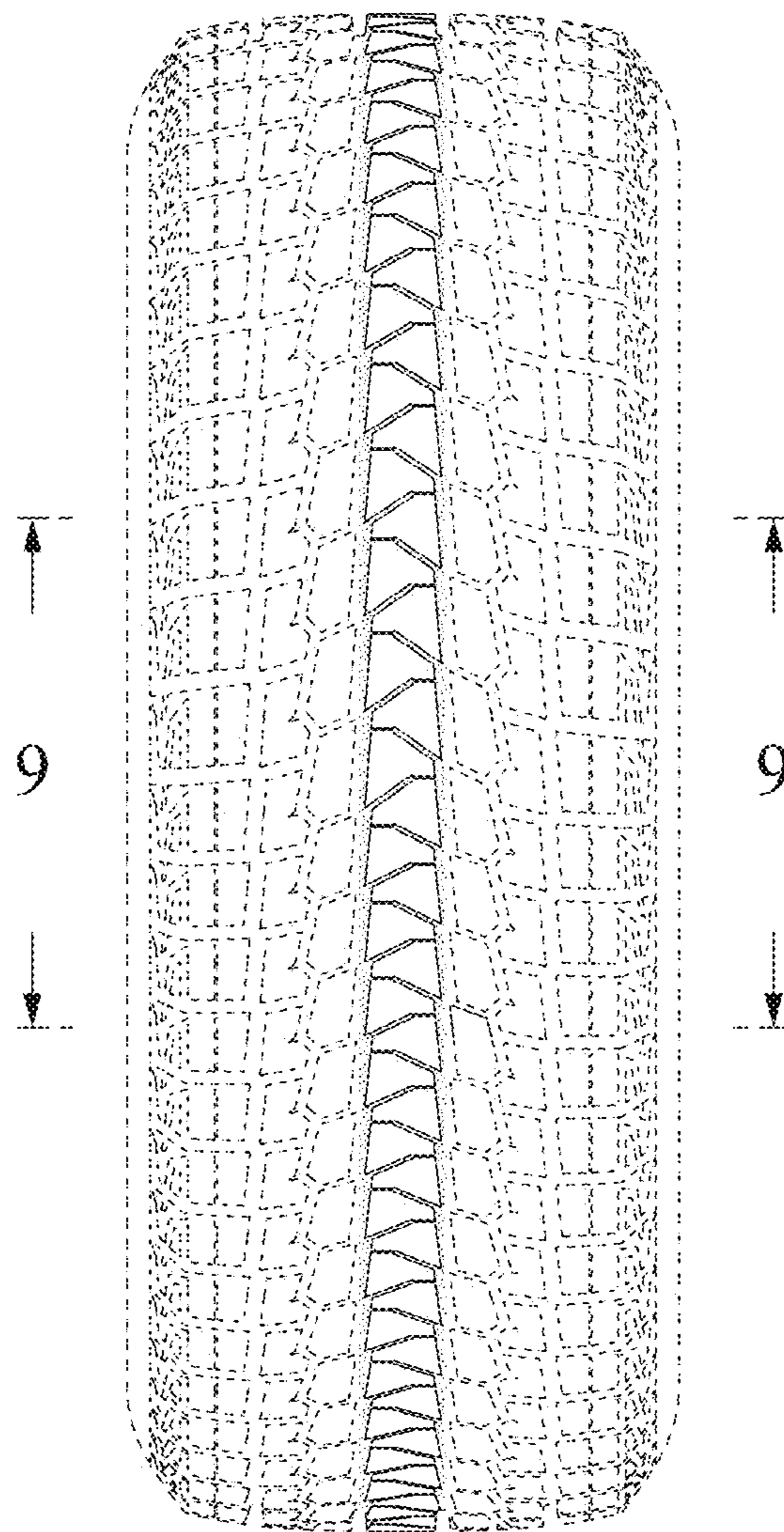

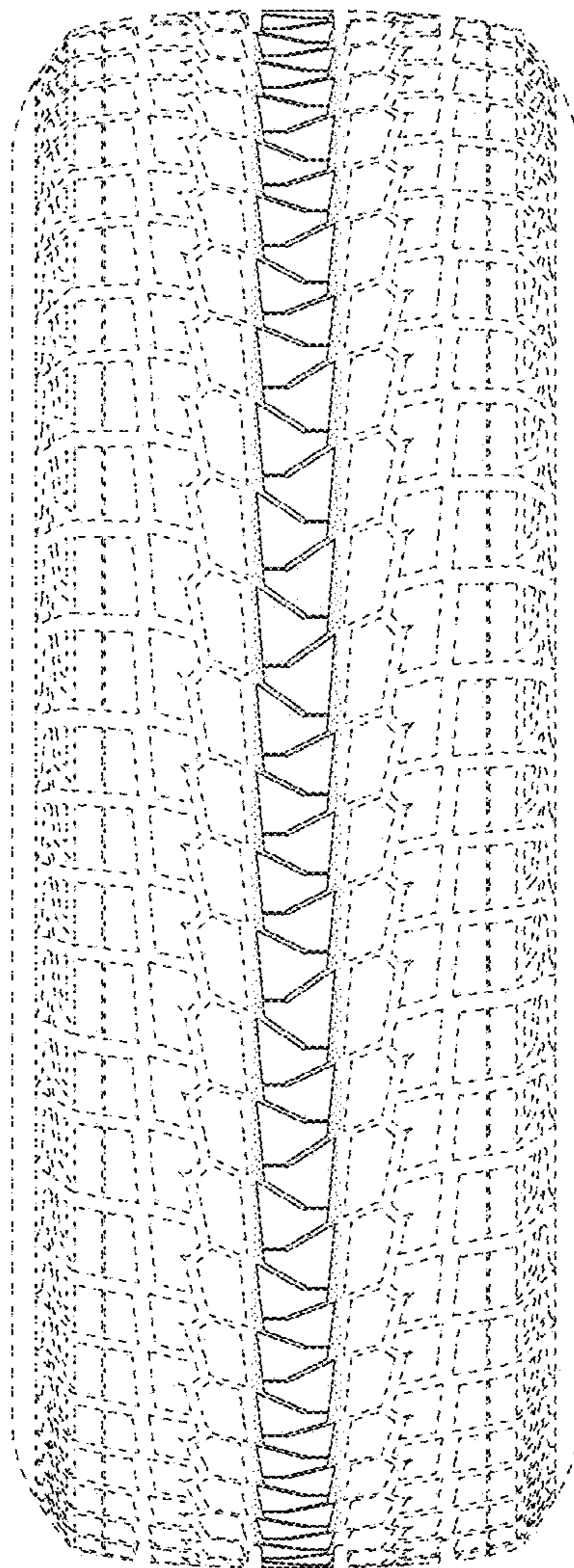

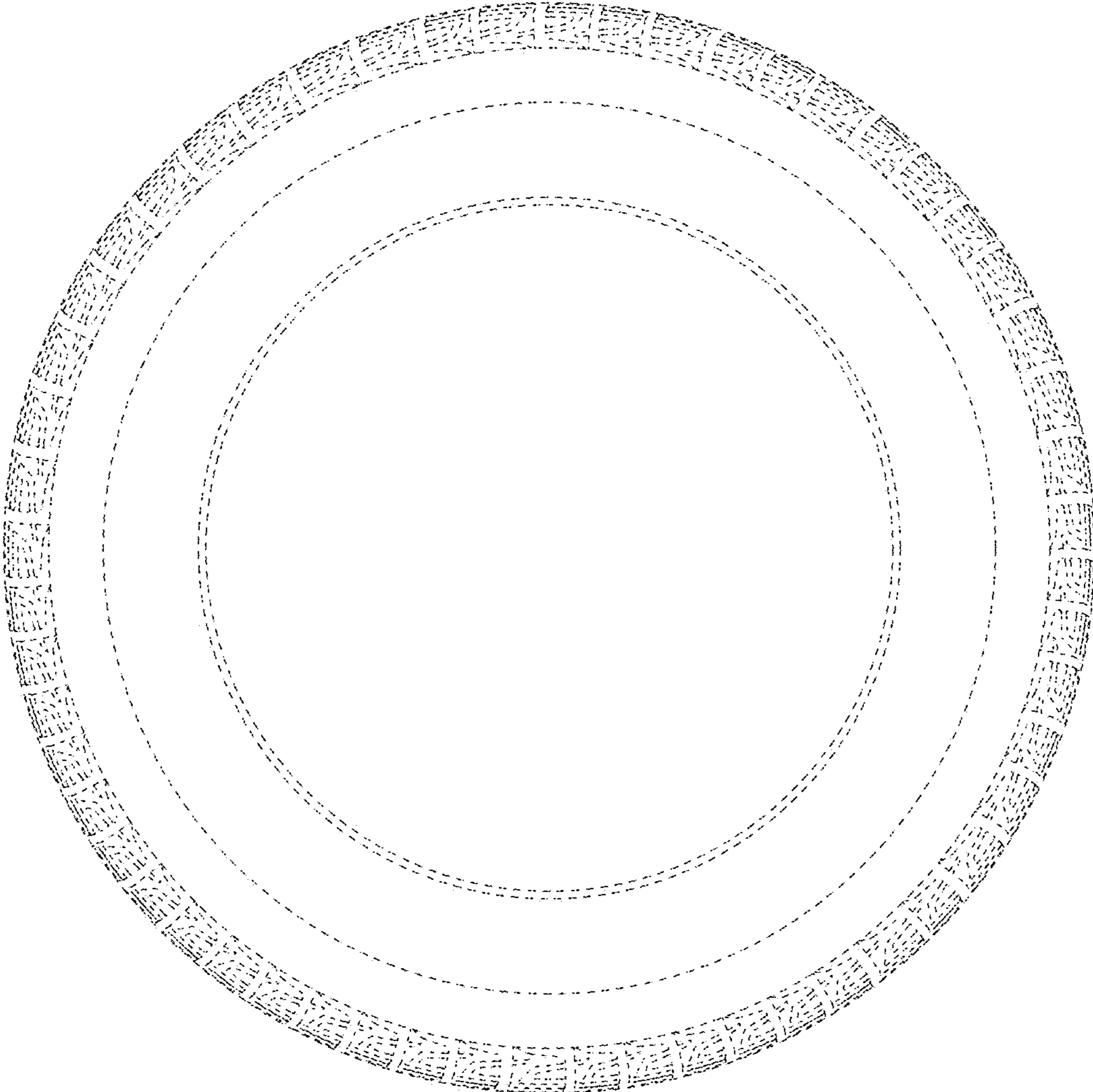

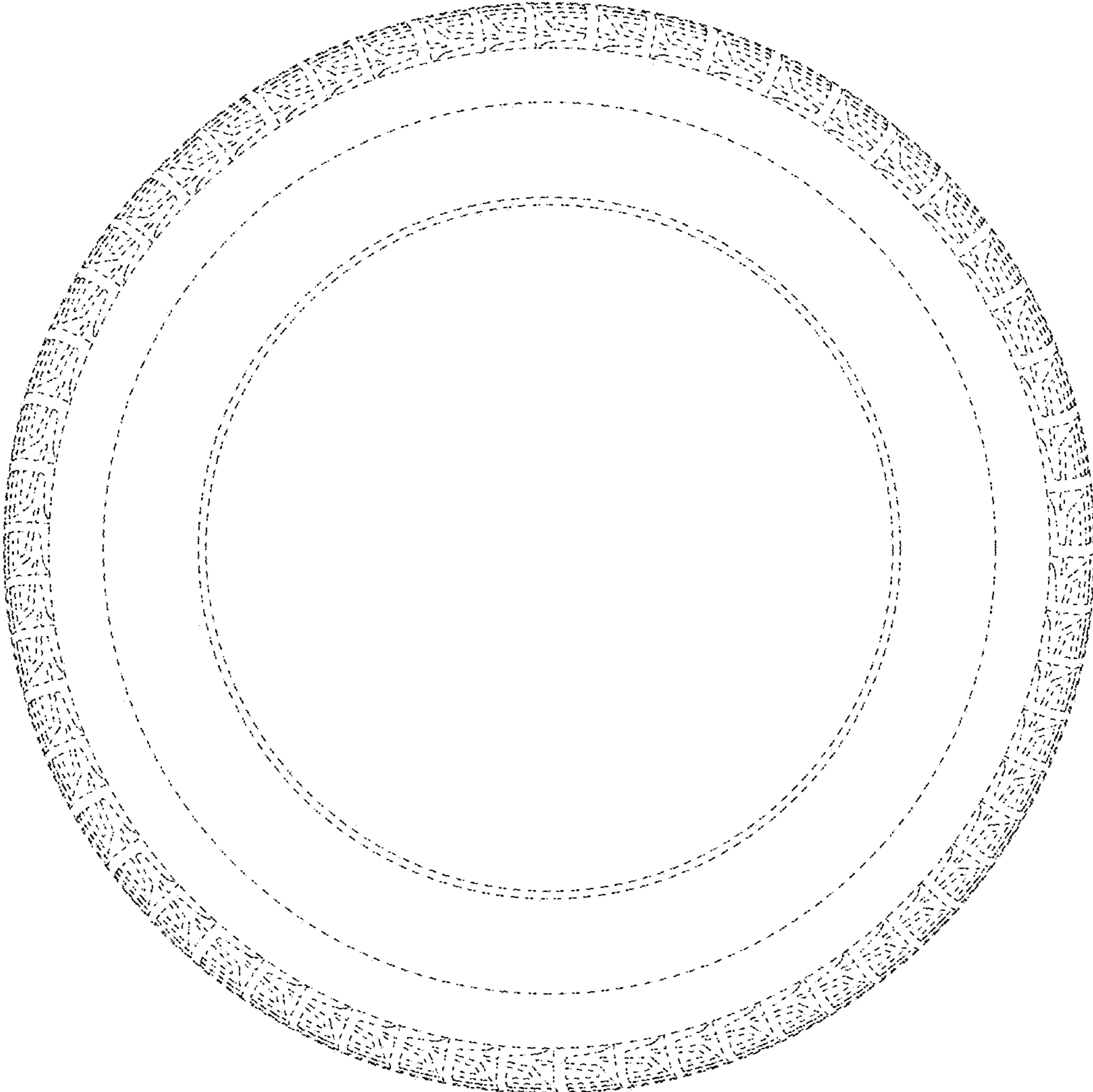

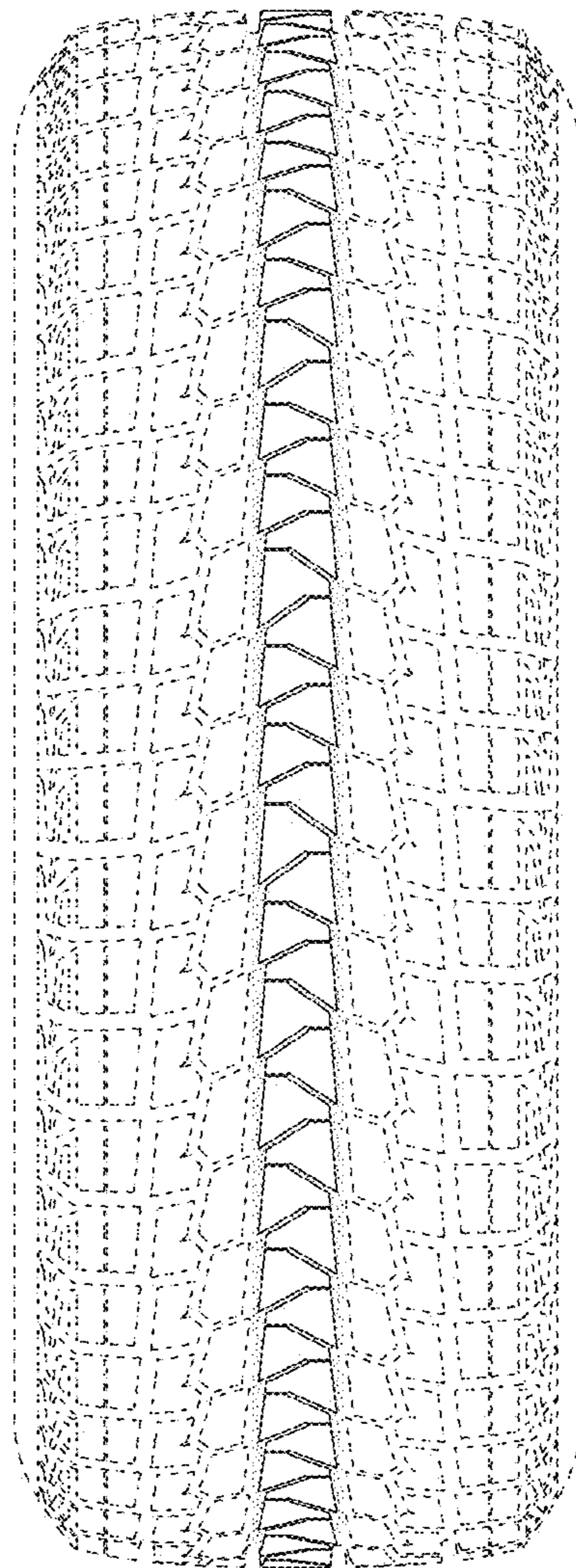

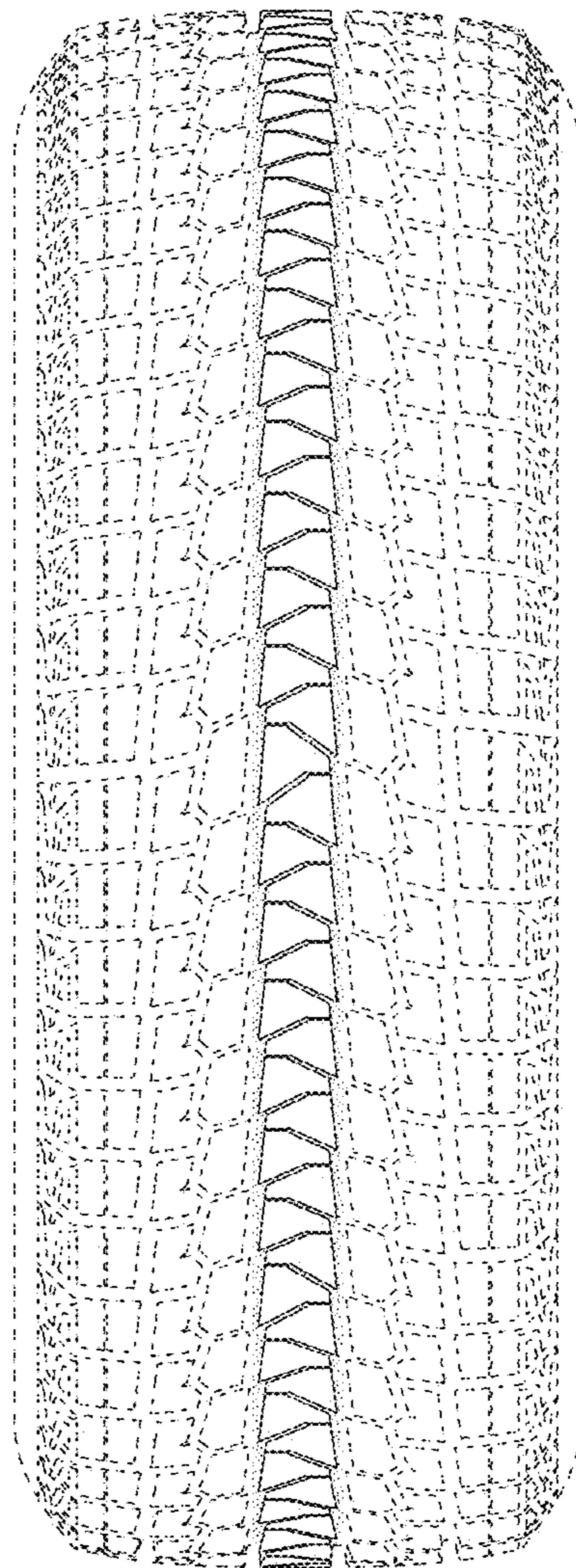

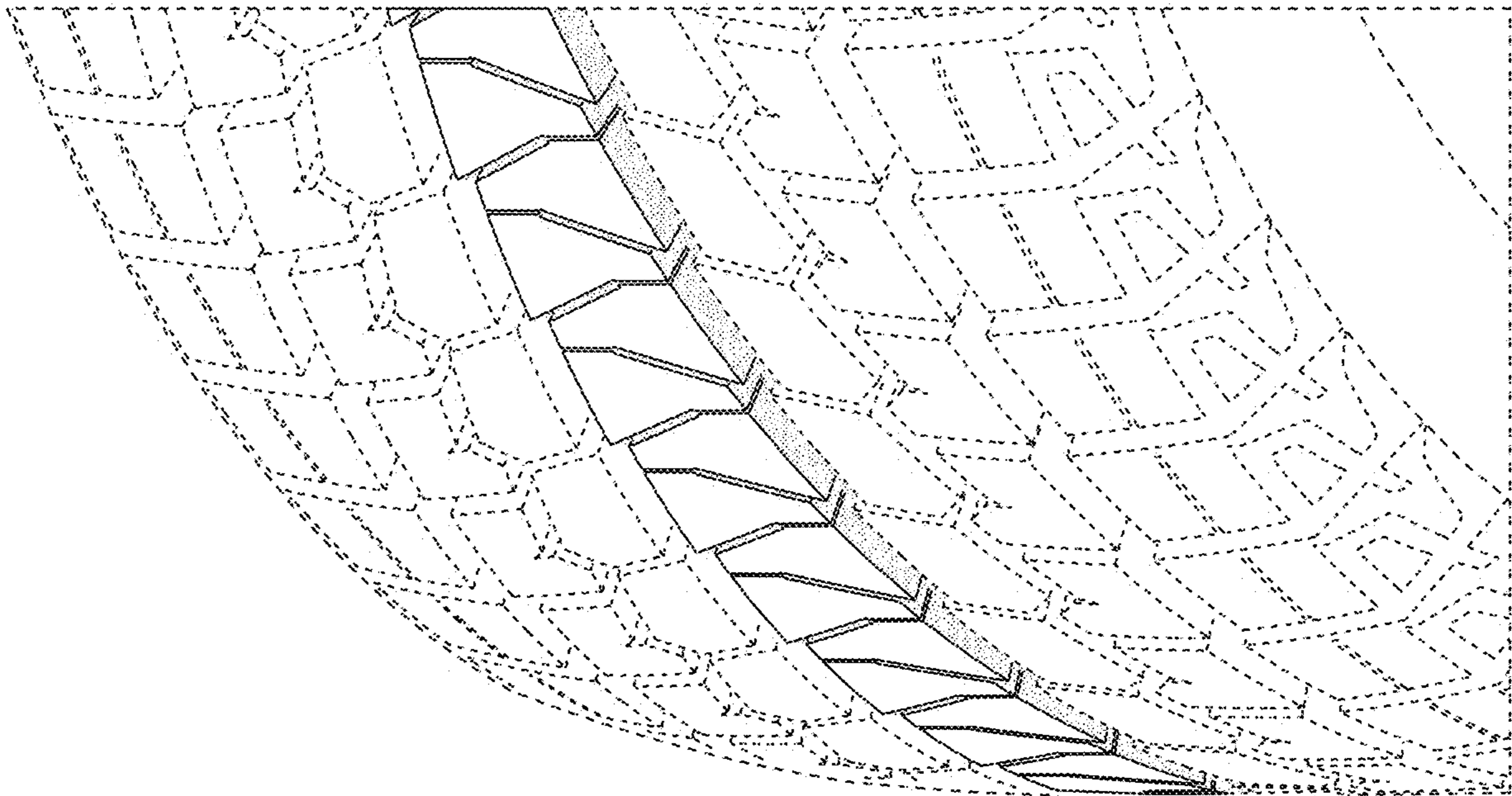

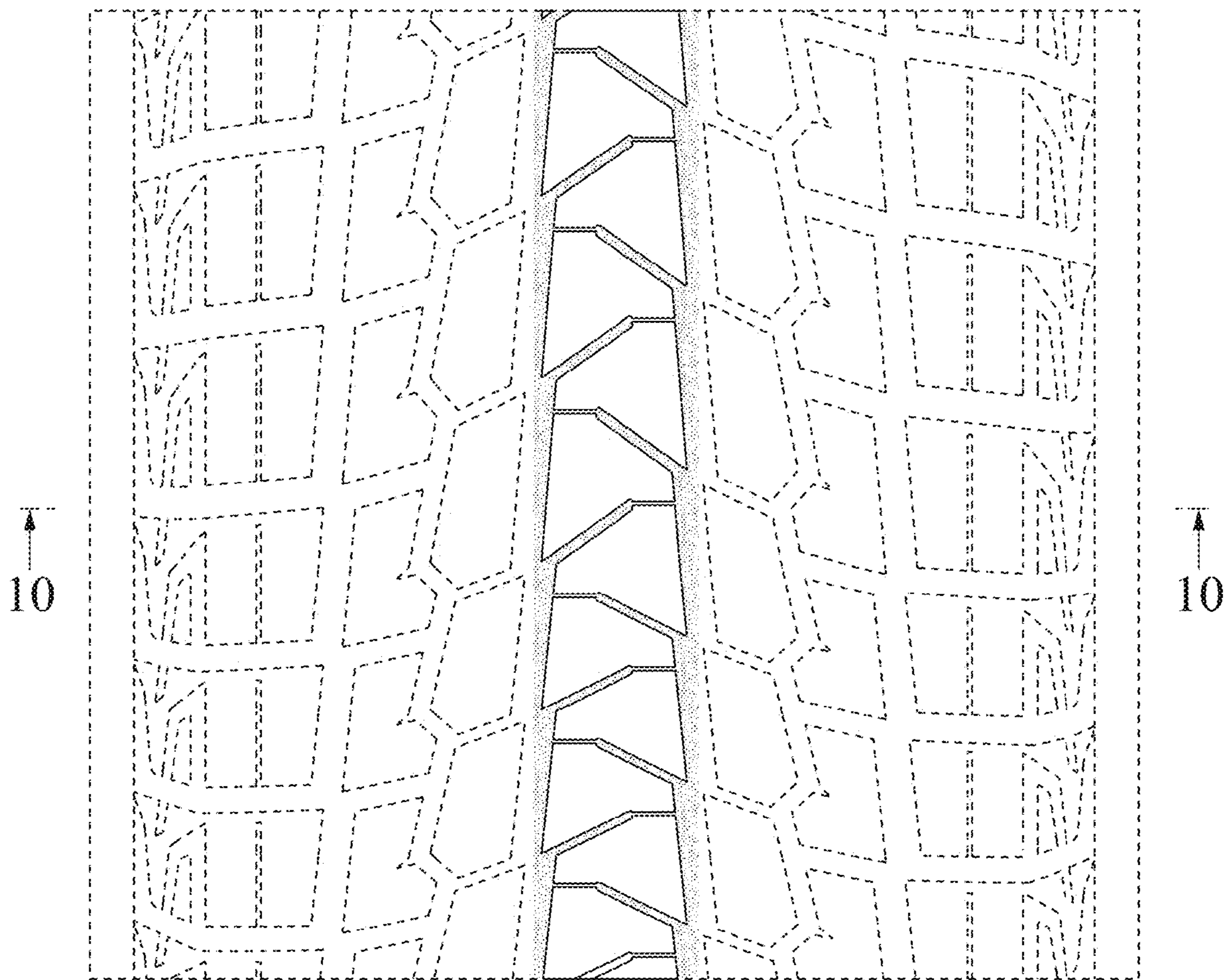
