(57) **CLAIM**

The ornamental design for a “tread portion of a vehicle tire”, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tread portion of a vehicle tire showing our design;
FIG. 2 is a front view thereof;
FIG. 3 is a side view thereof, wherein the opposite side view is the same; and,

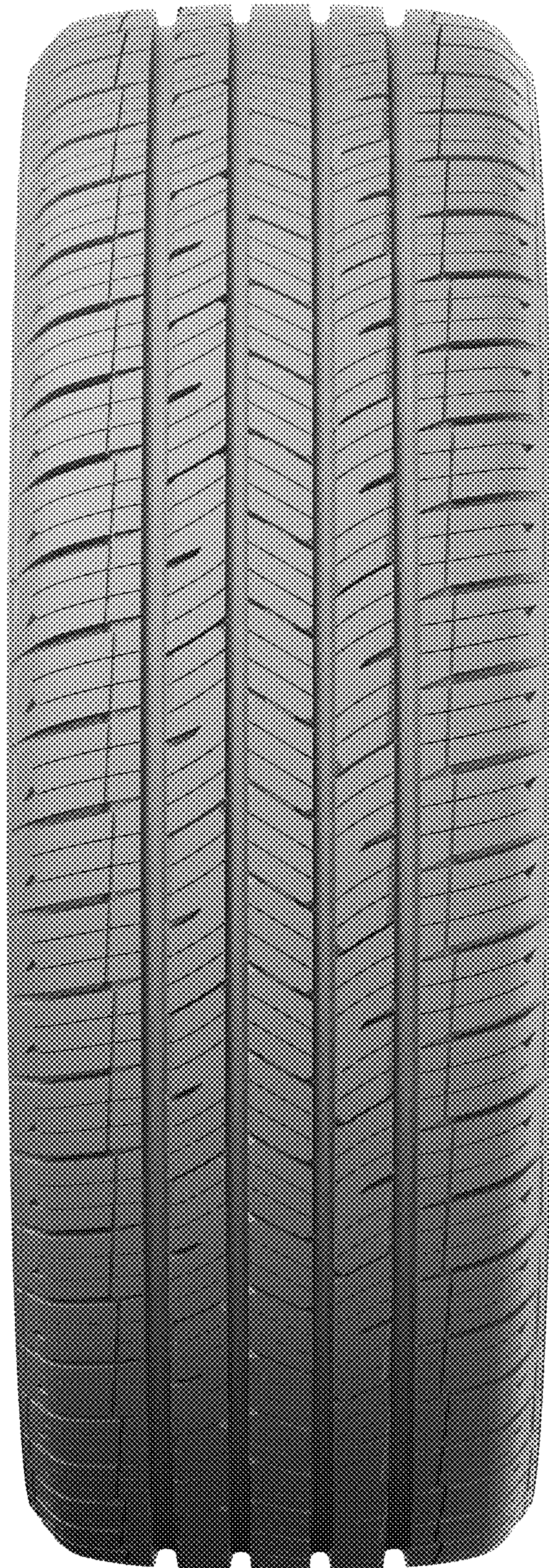
