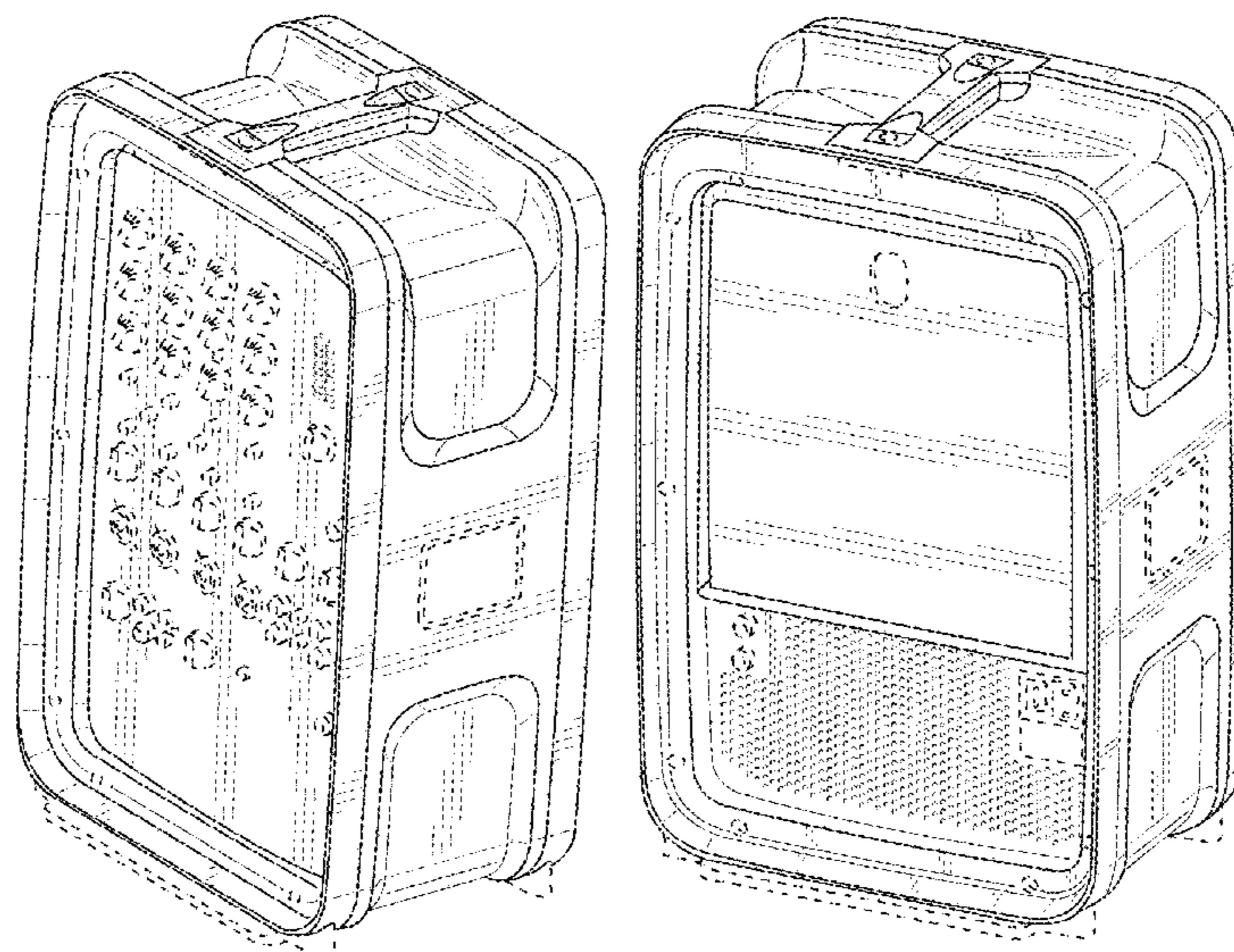
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an audio component showing our new design;
FIG. 2 is an opposite perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a side elevational view thereof, the opposite side elevational view being a mirror image thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

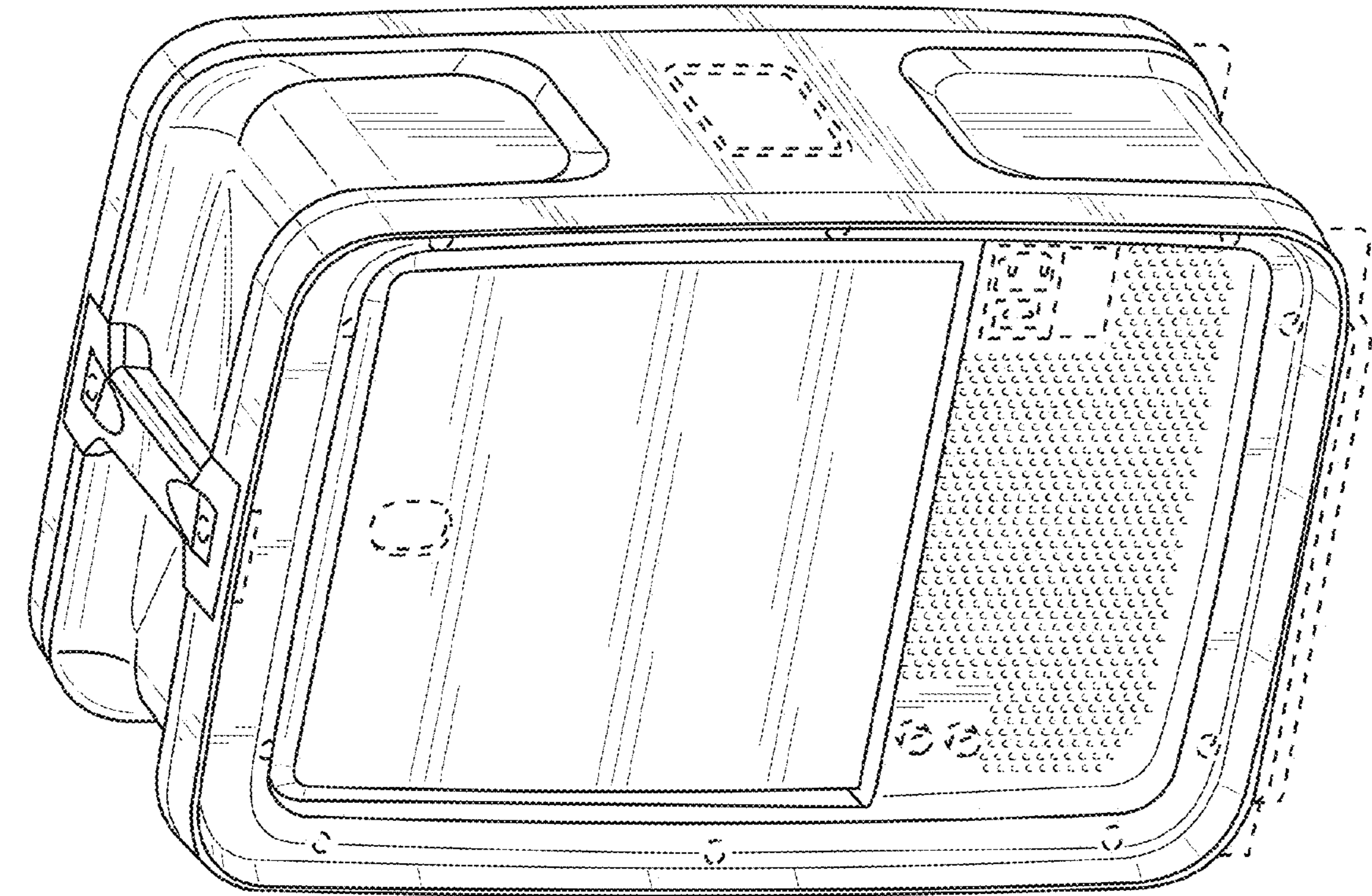

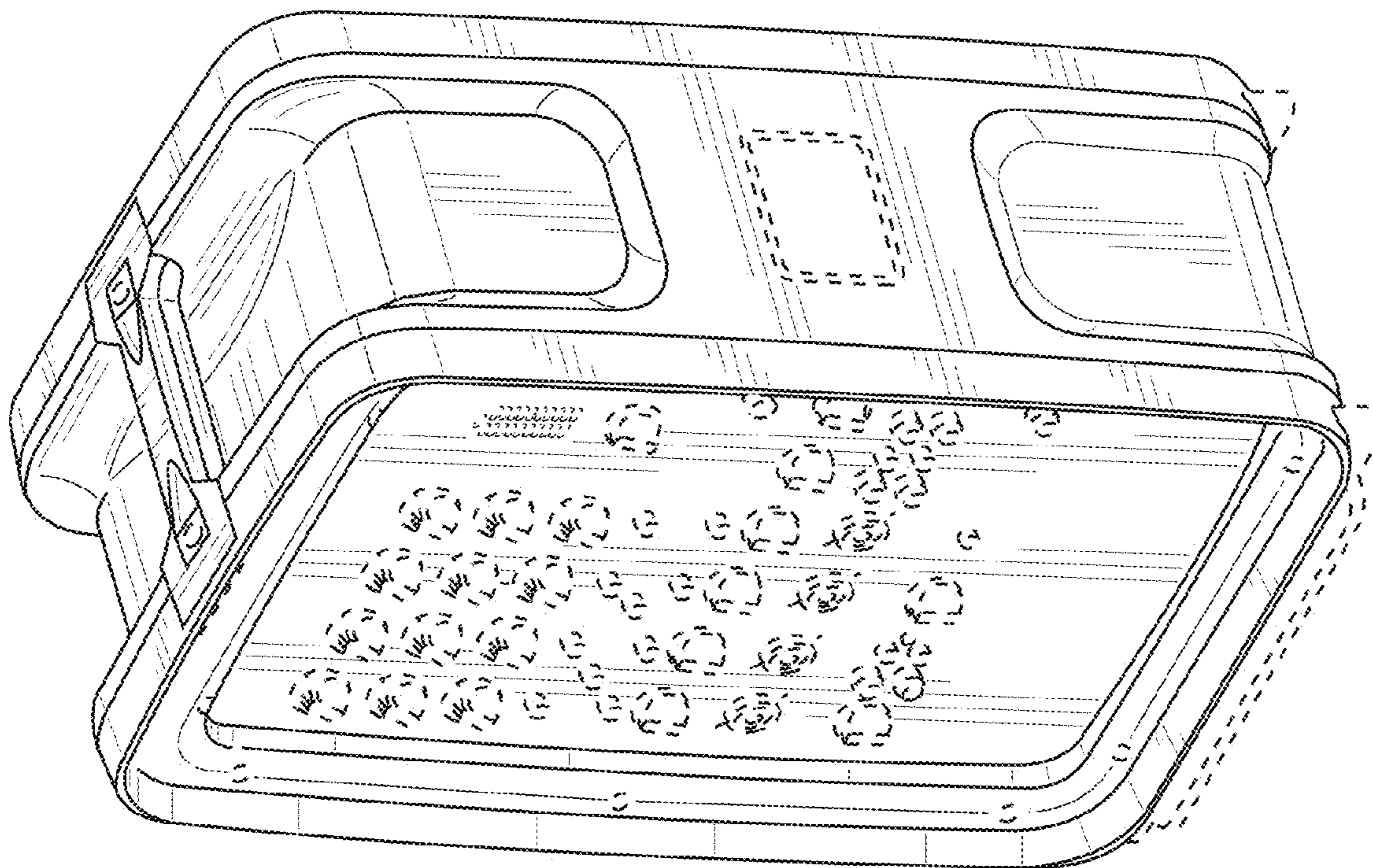

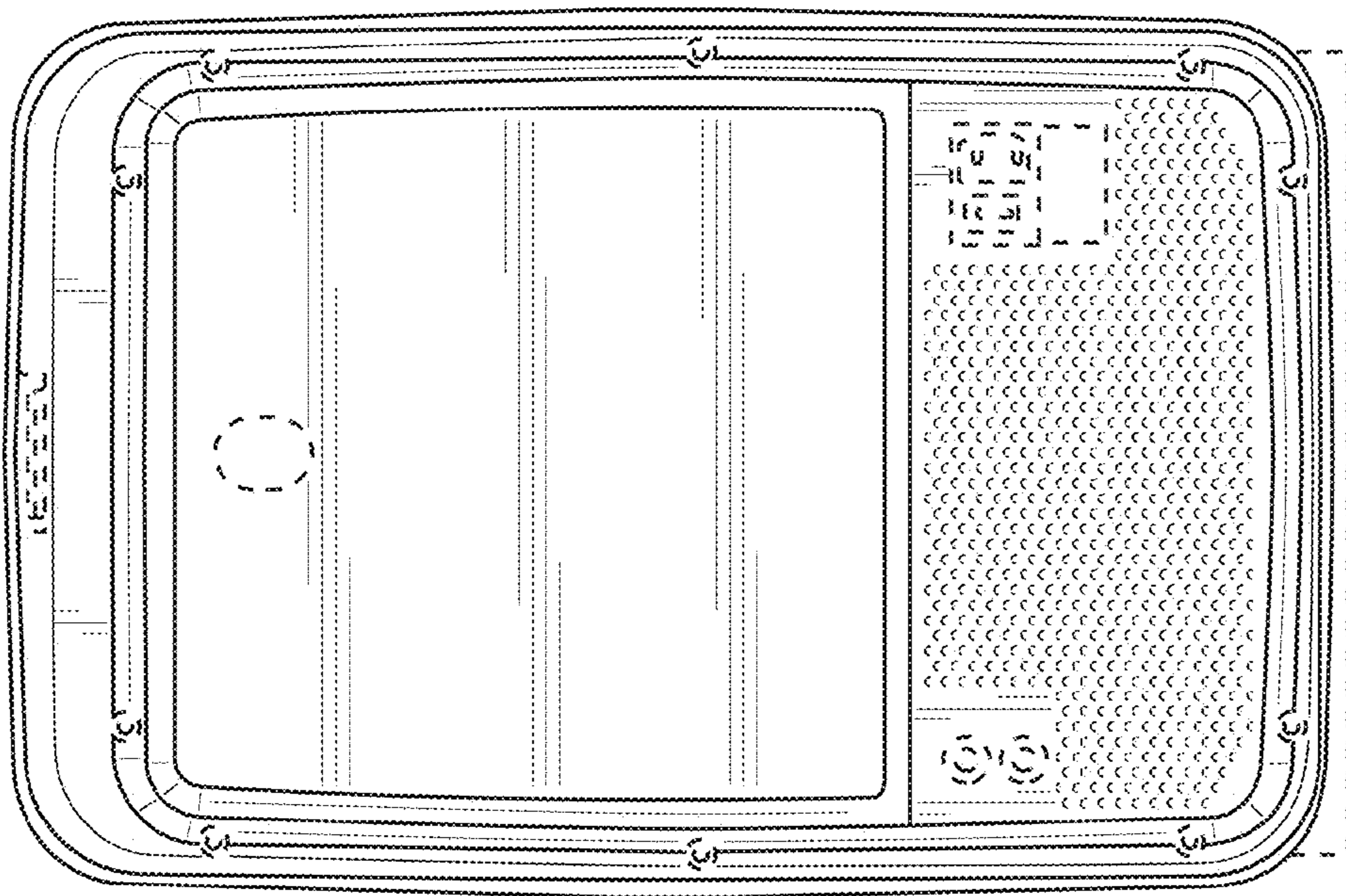

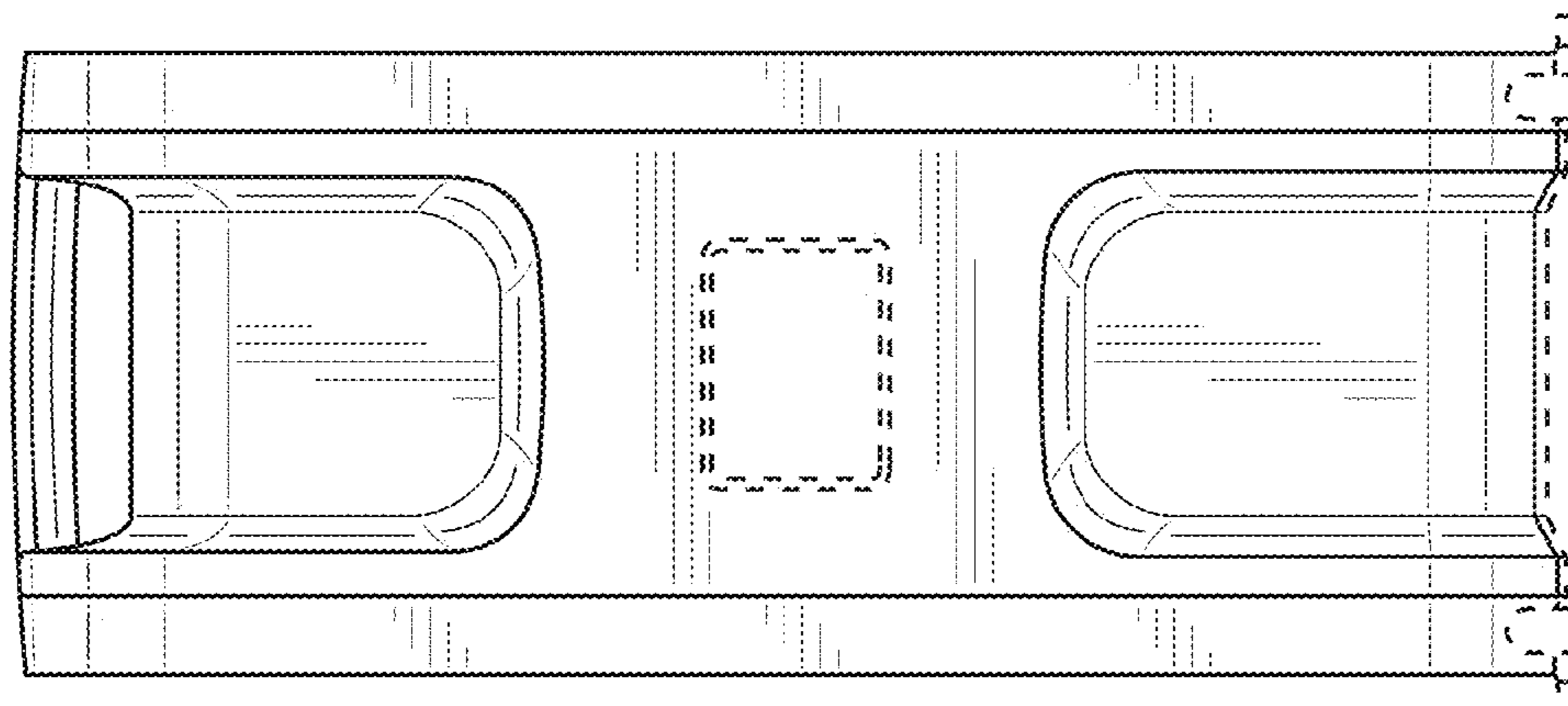

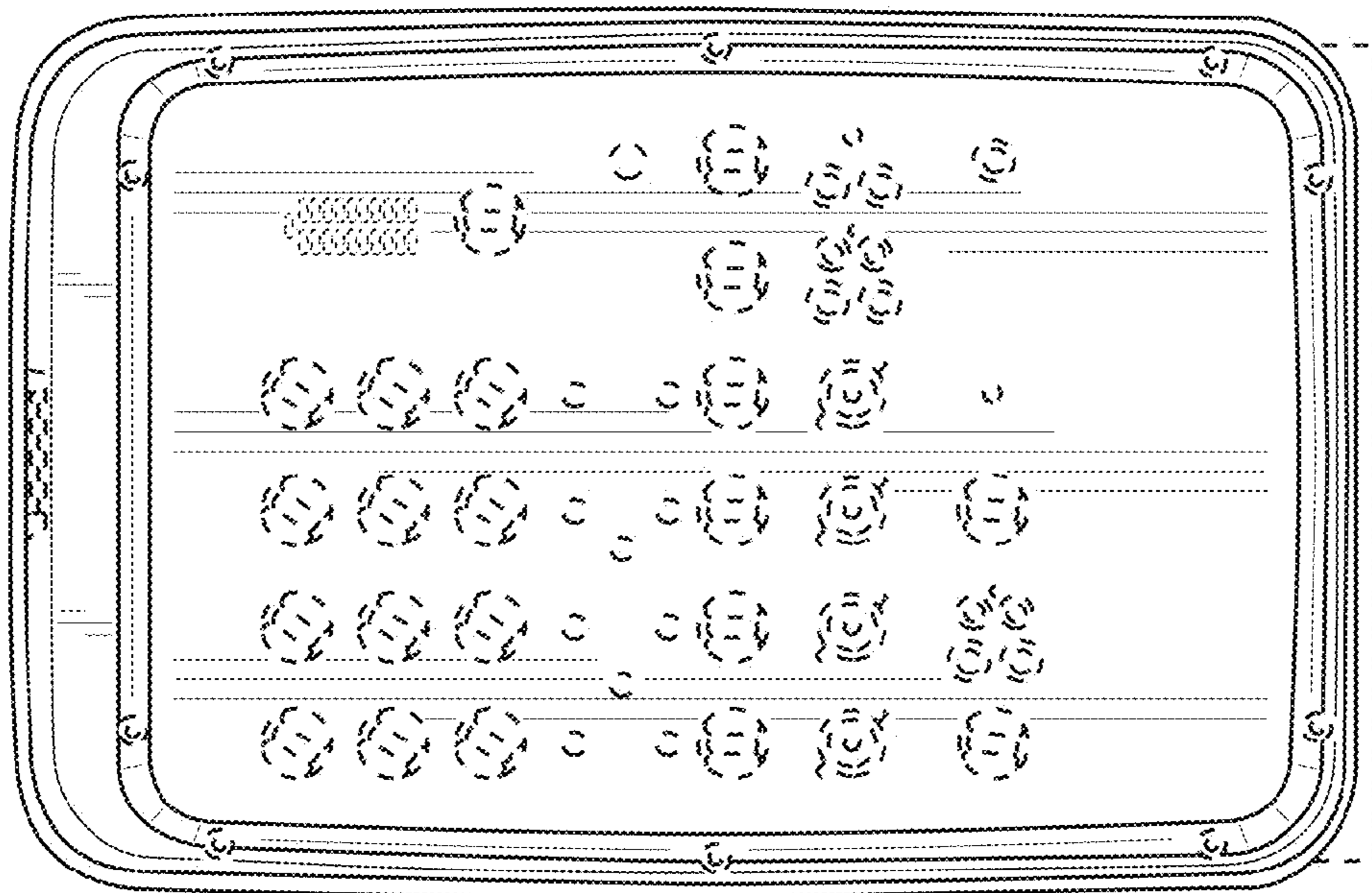

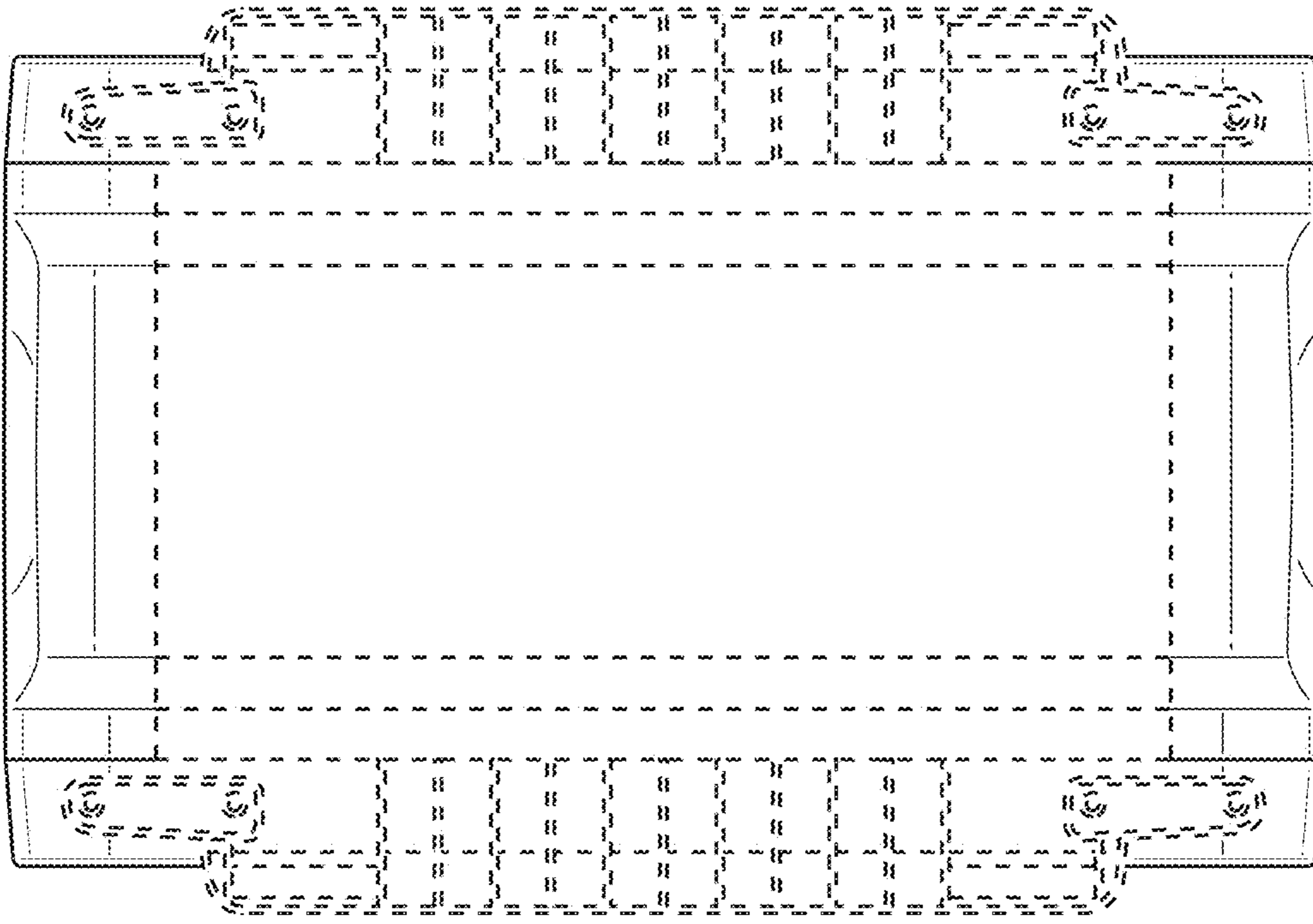

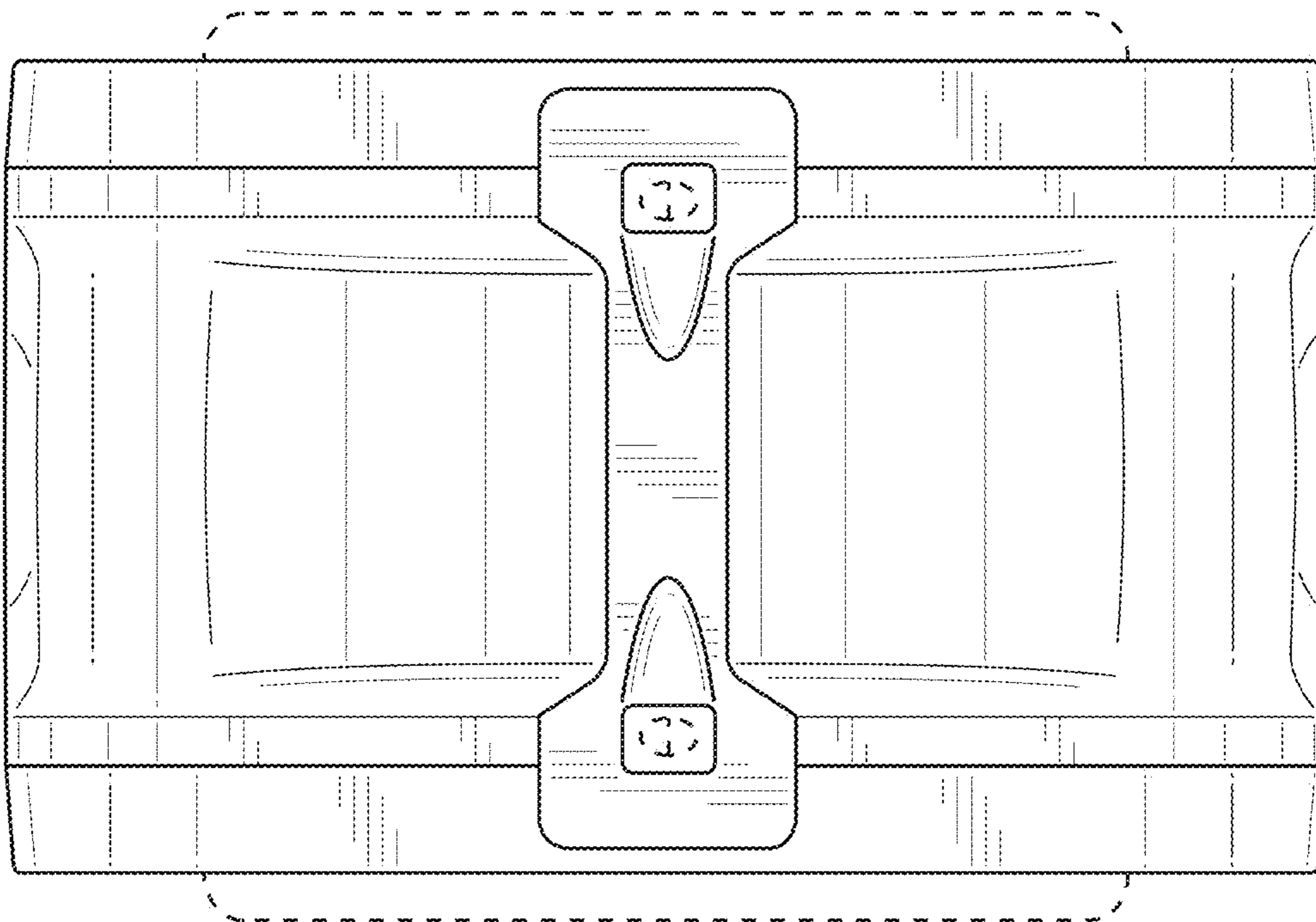
