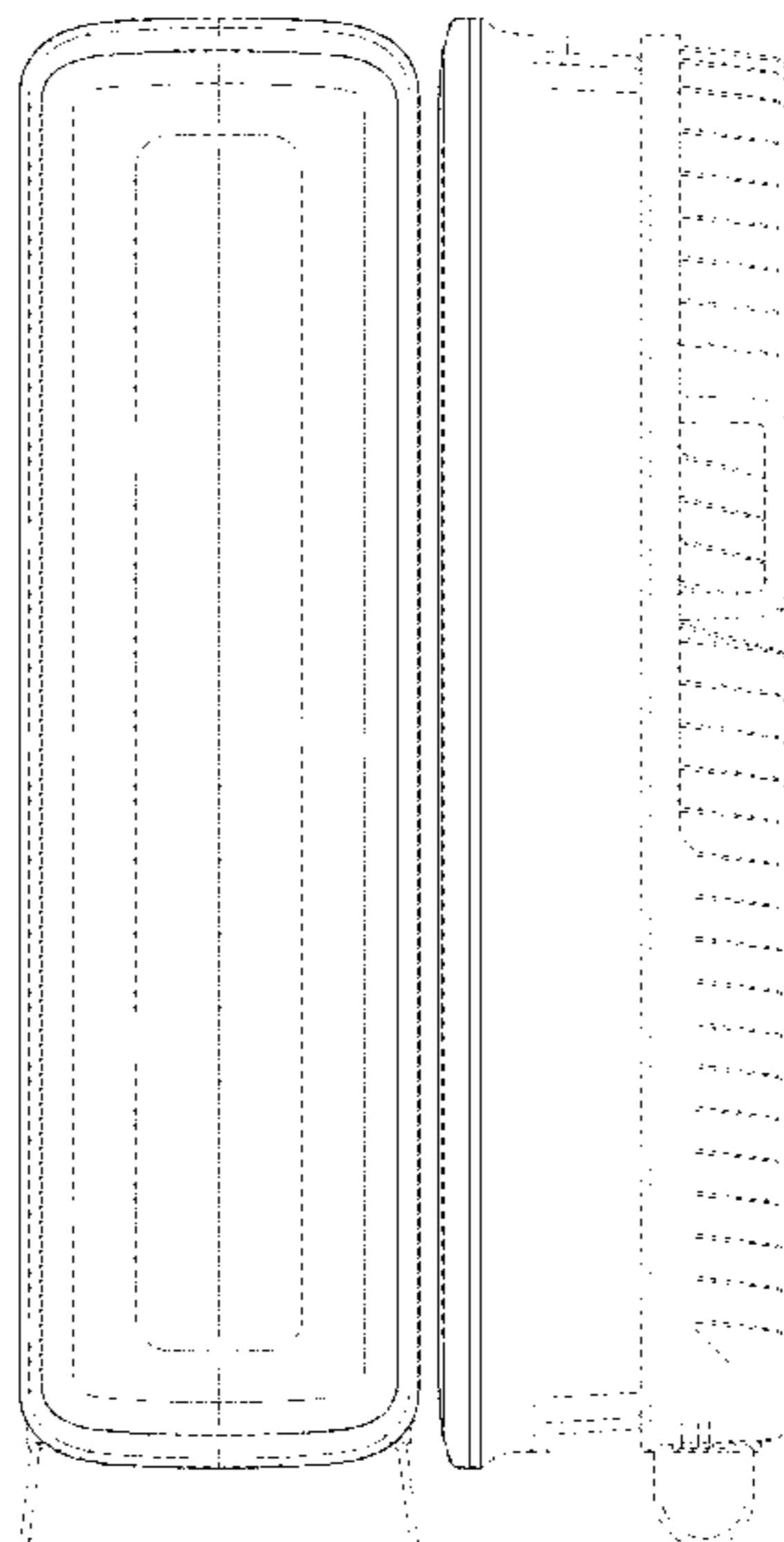

The ornamental design for a transceiver for wireless communications, as shown and described.

**DESCRIPTION**  
FIG. 1 is a front perspective view of a transceiver for wireless communications showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.  
The dashed broken lines in the drawings illustrate portions of the transceiver for wireless communications that form no part of the claimed design.

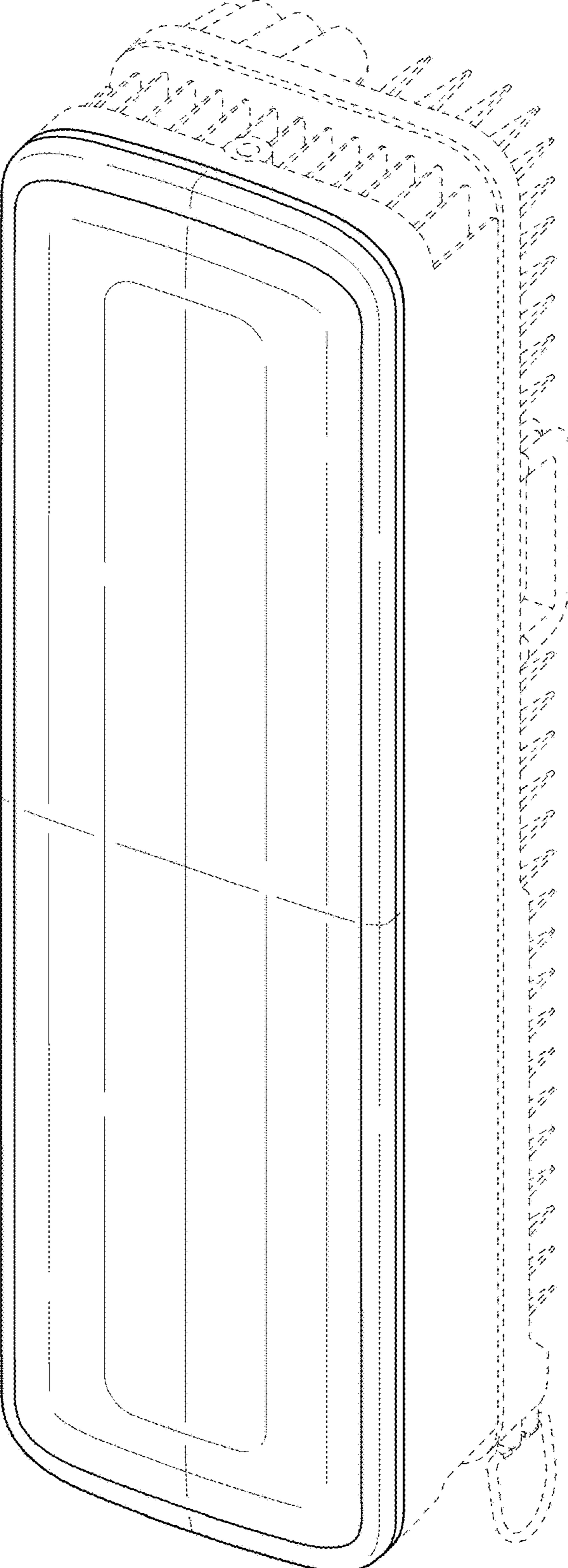

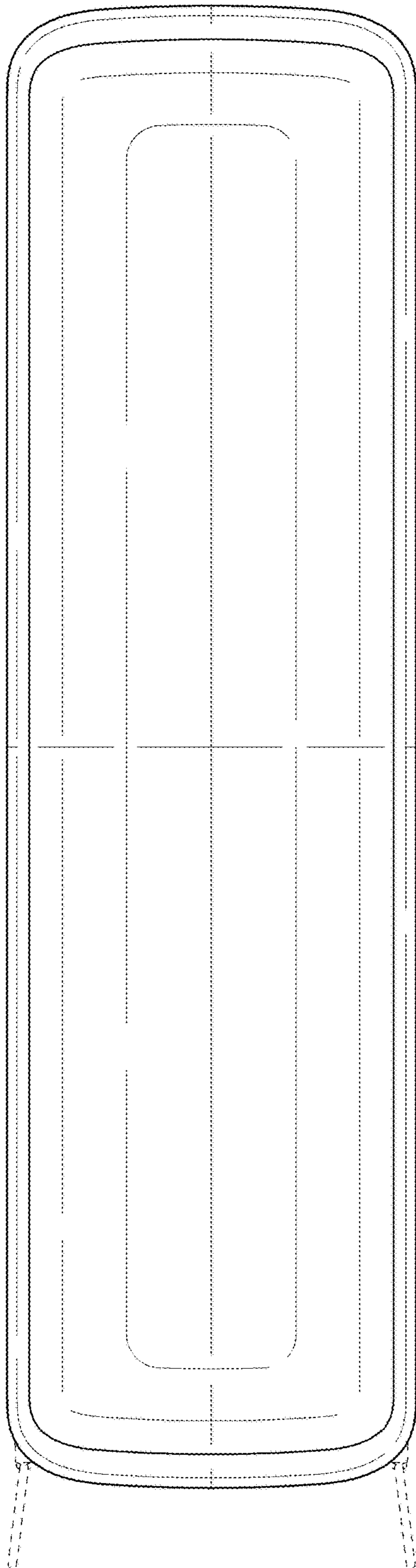

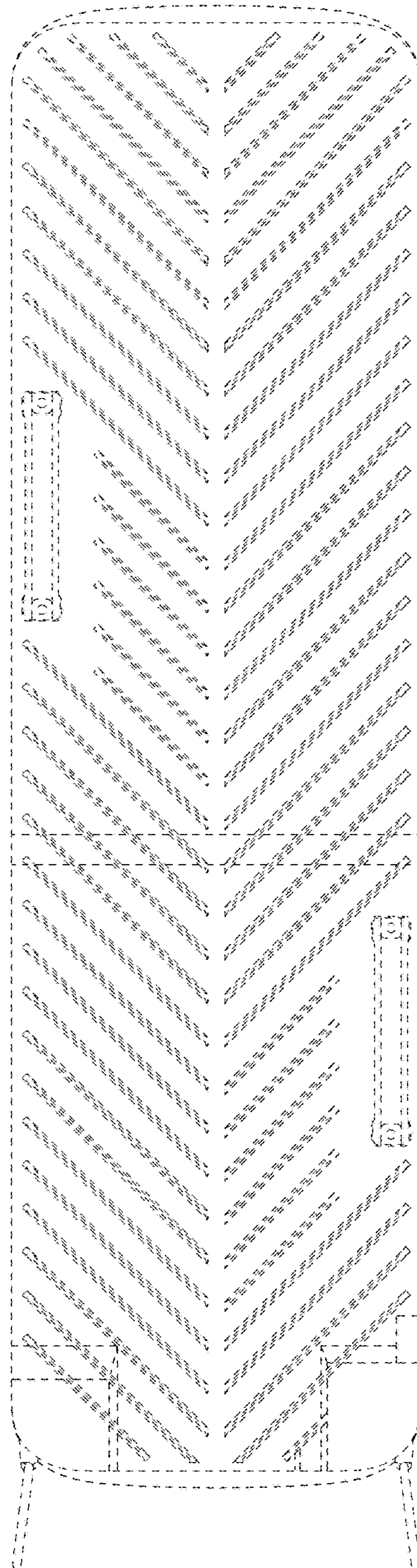

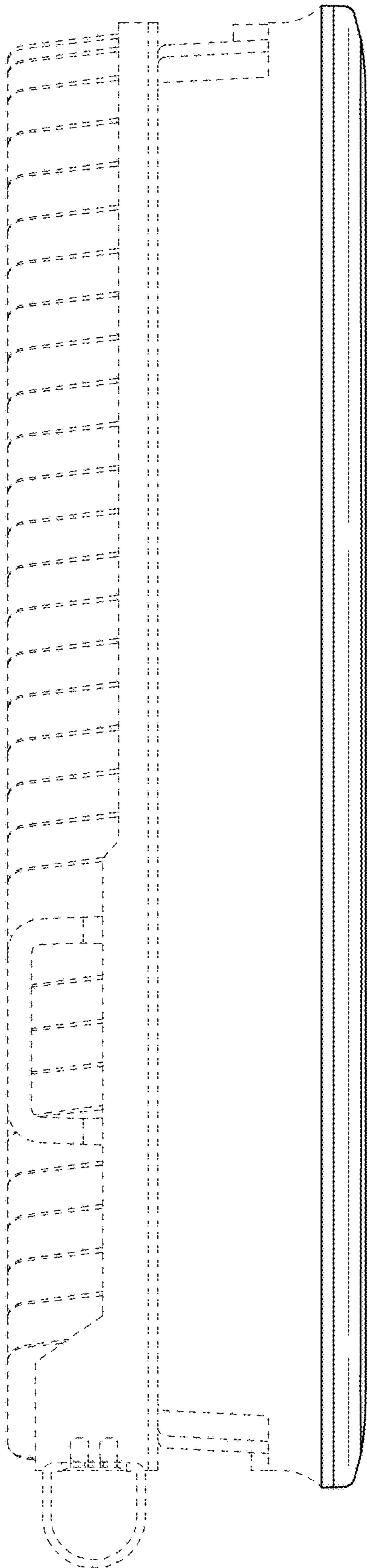

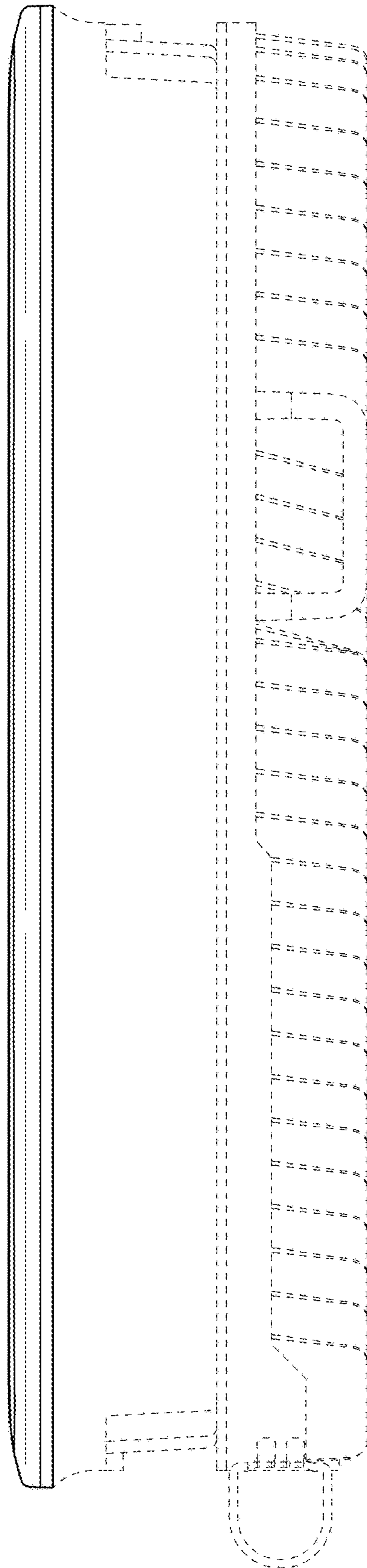

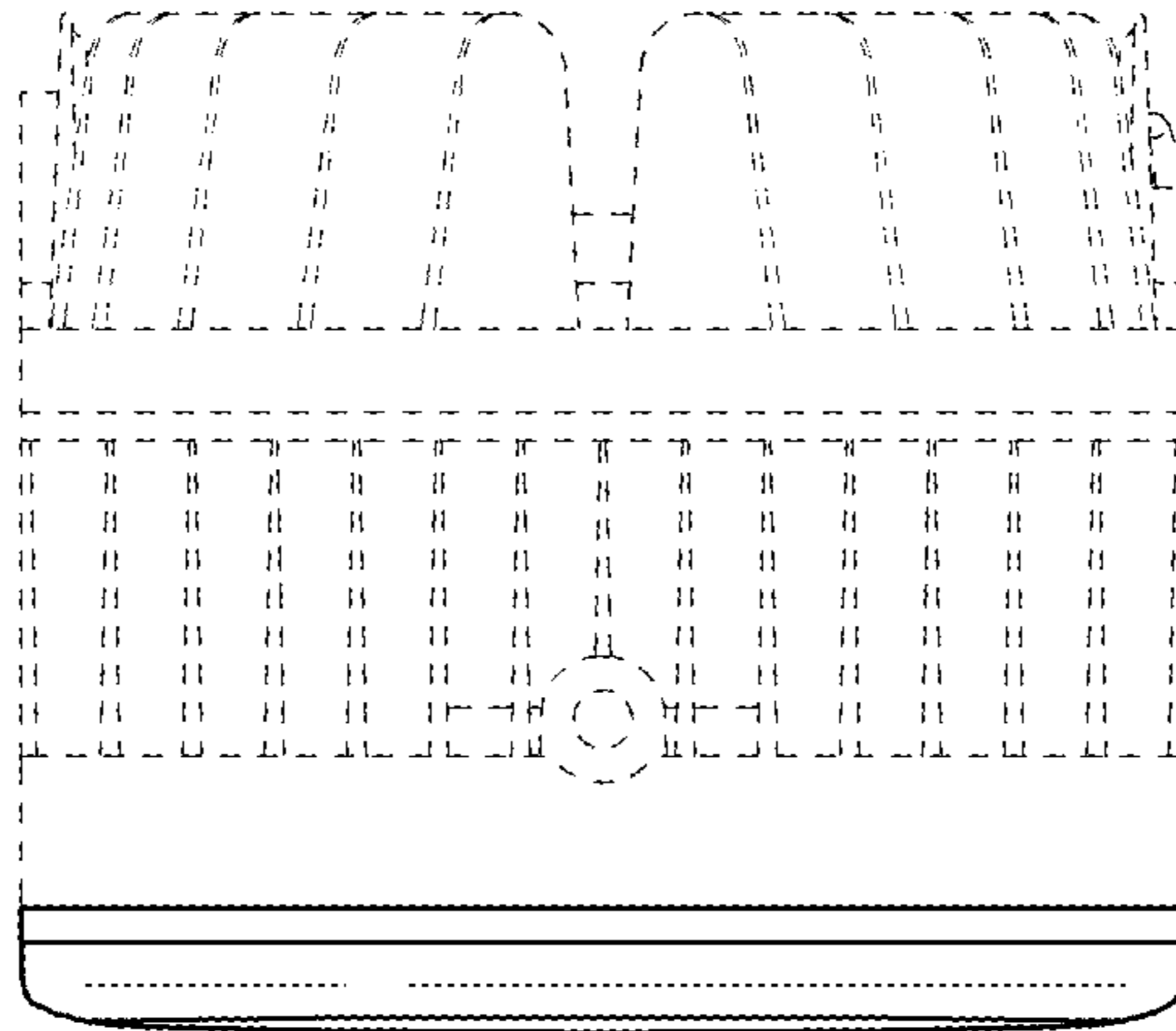
