(57) **CLAIM**

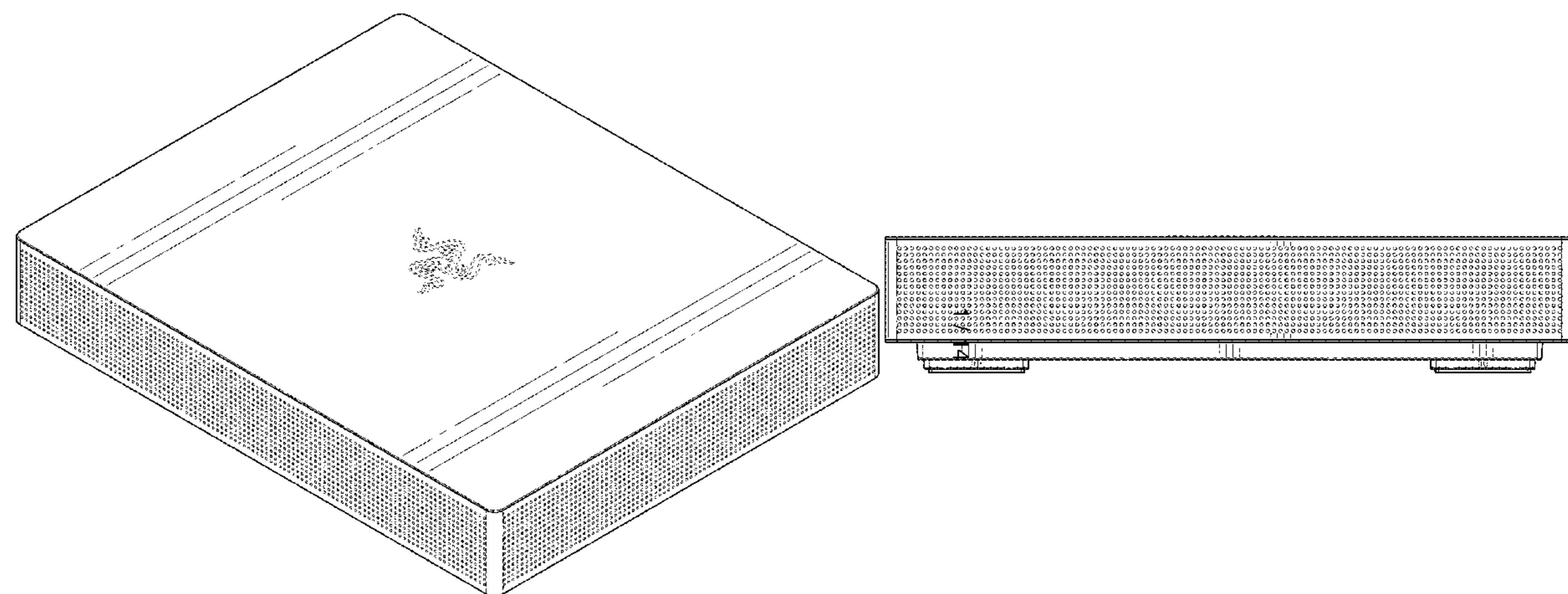
I claim the ornamental design for a router, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a router, showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof; and
 FIG. 7 is a bottom plan elevational view thereof.
 FIG. 8 is a perspective view of a second embodiment of the router;
 FIG. 9 is a front elevational view thereof;
 FIG. 10 is a rear elevational view thereof;

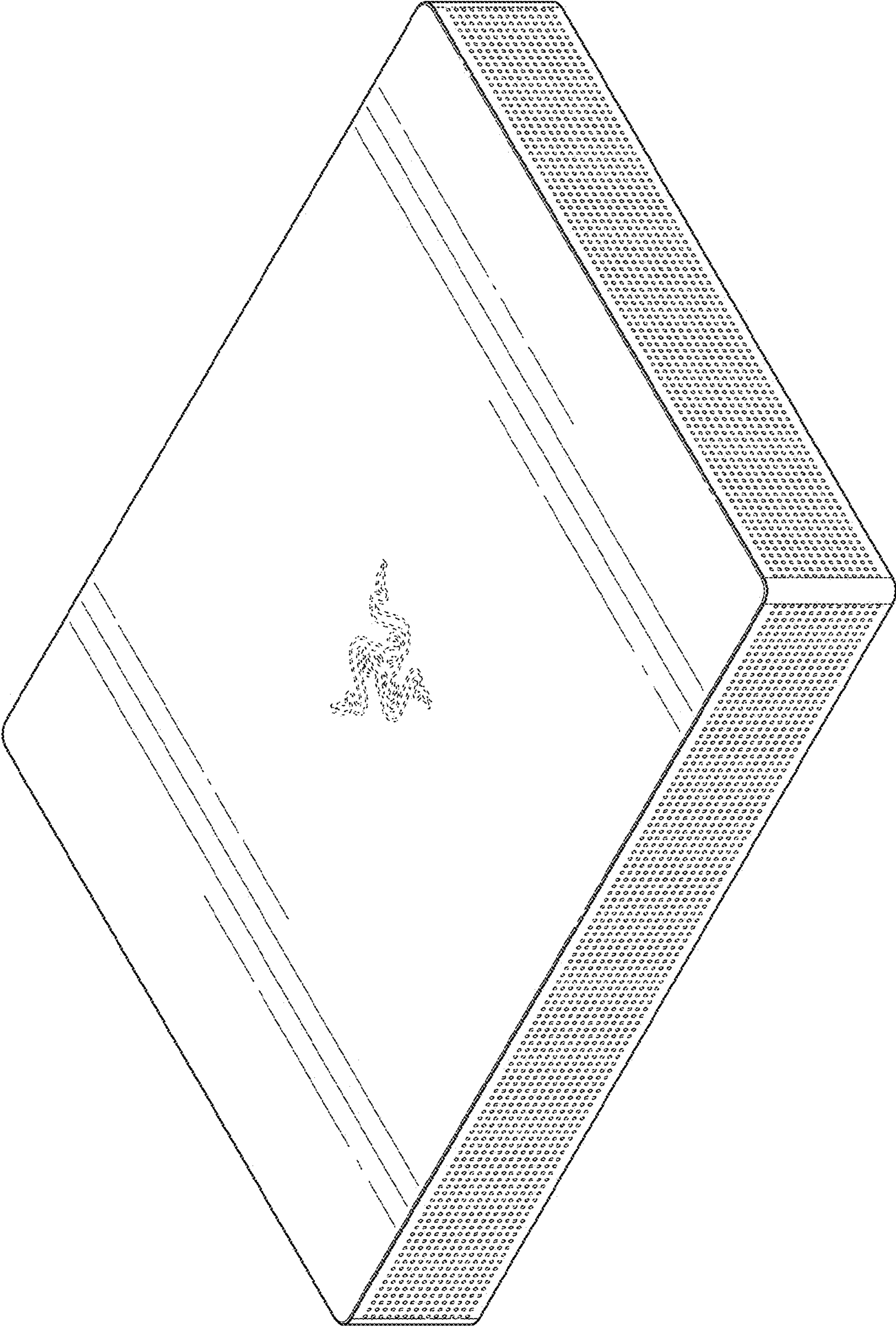

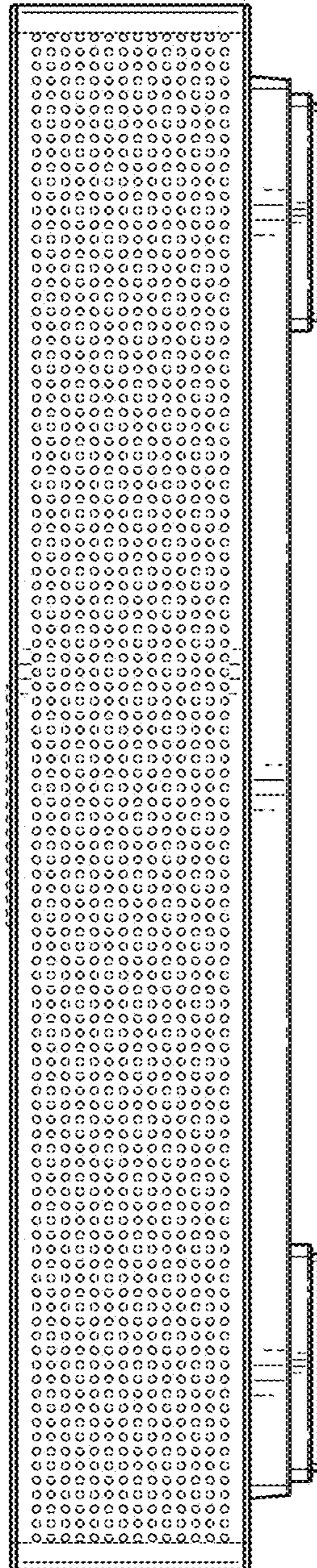

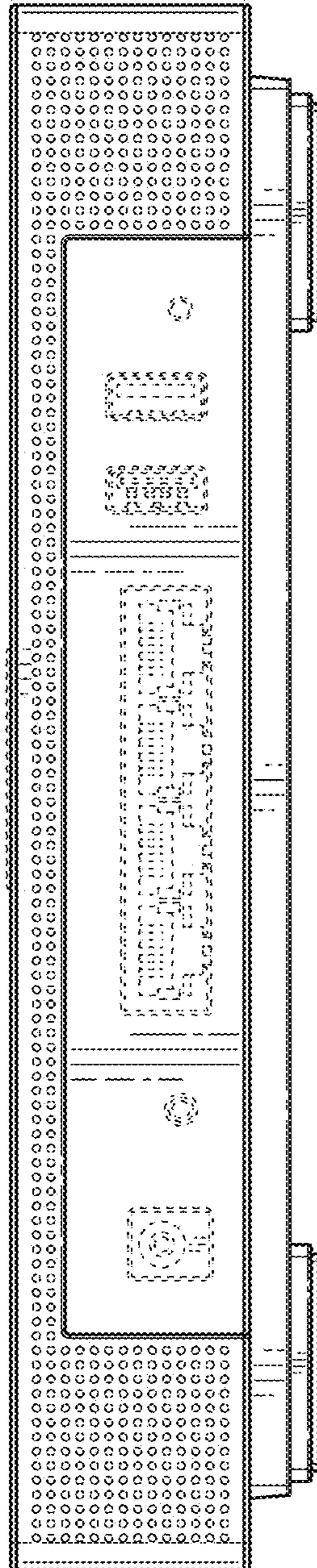

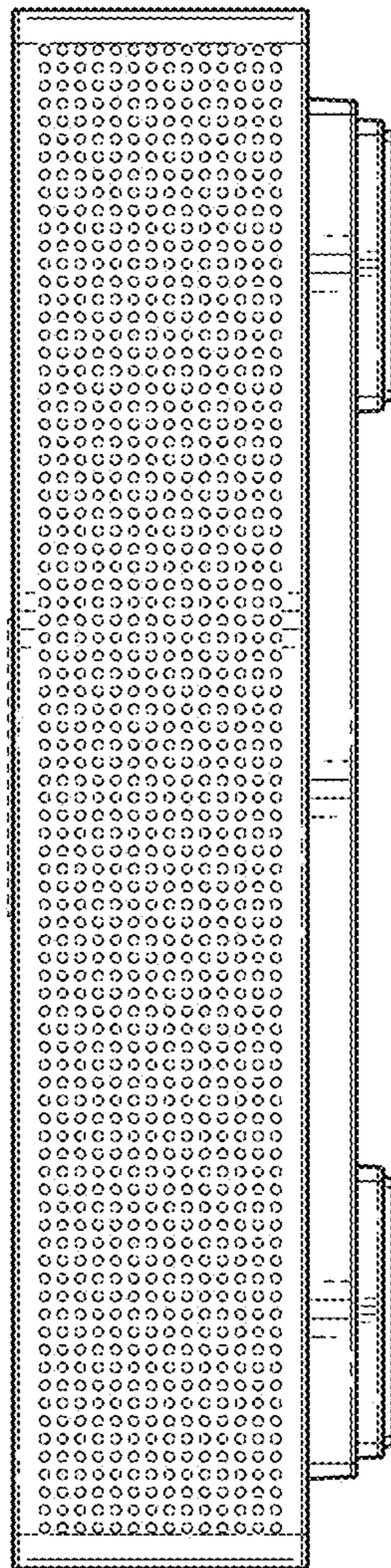

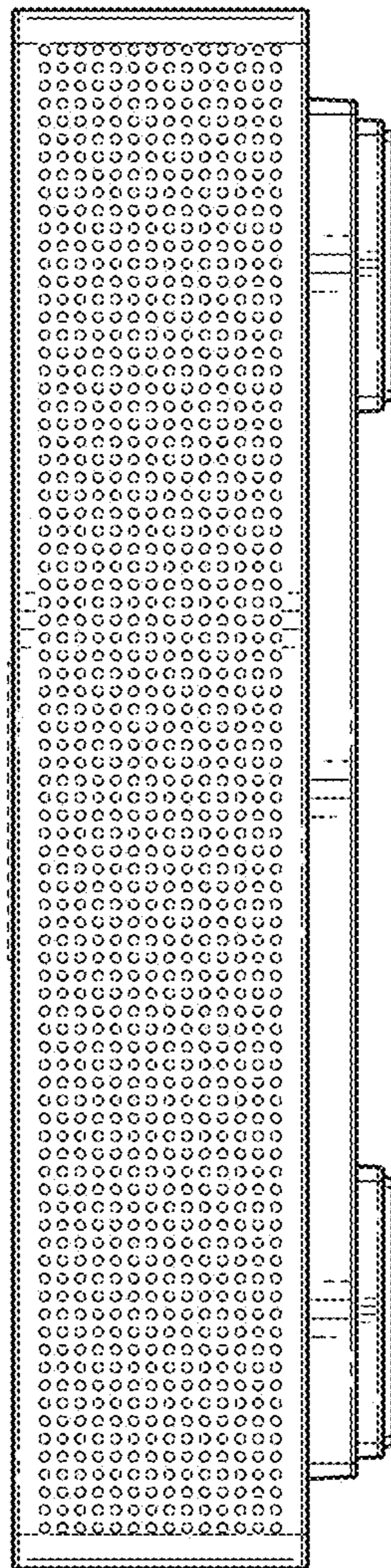

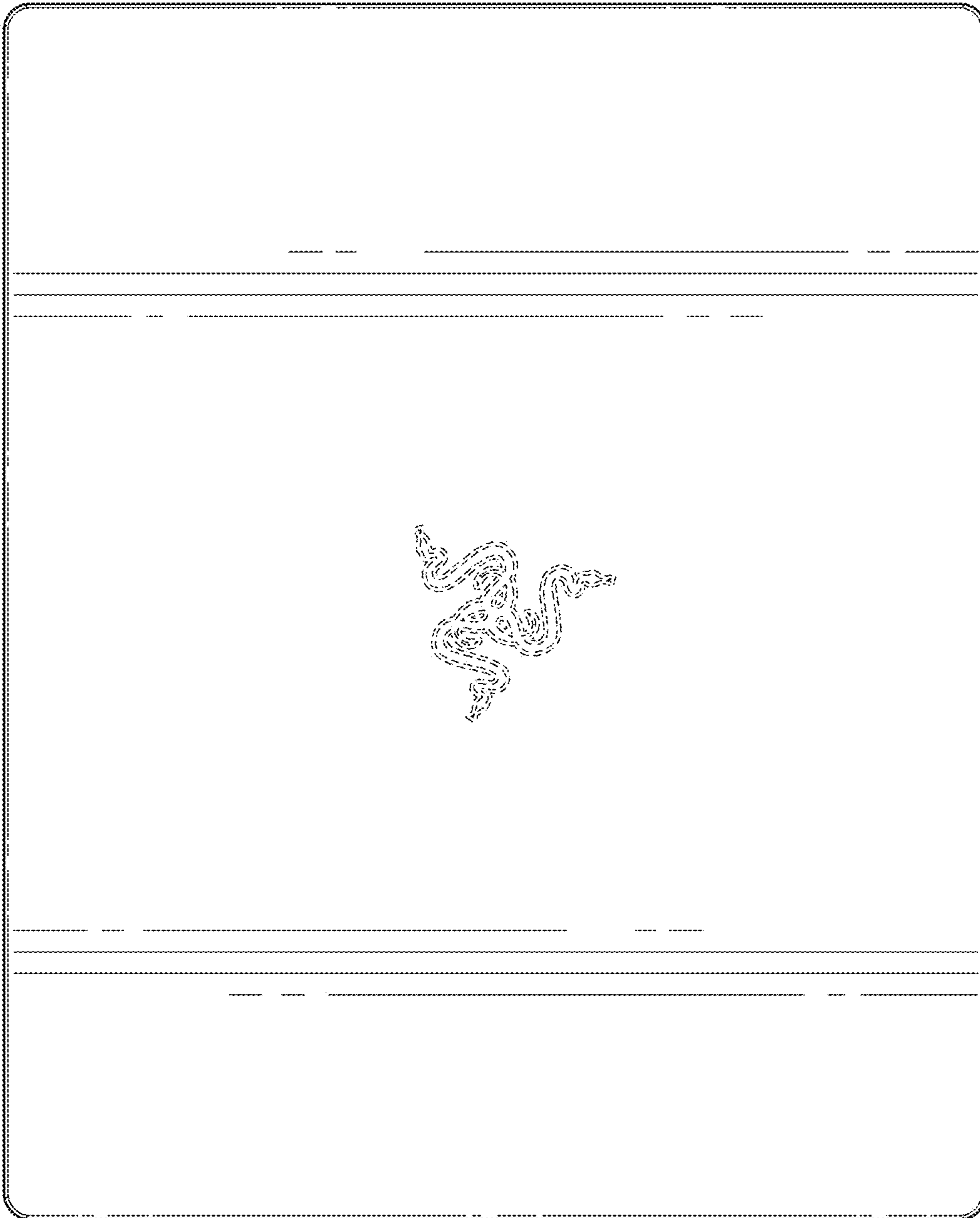

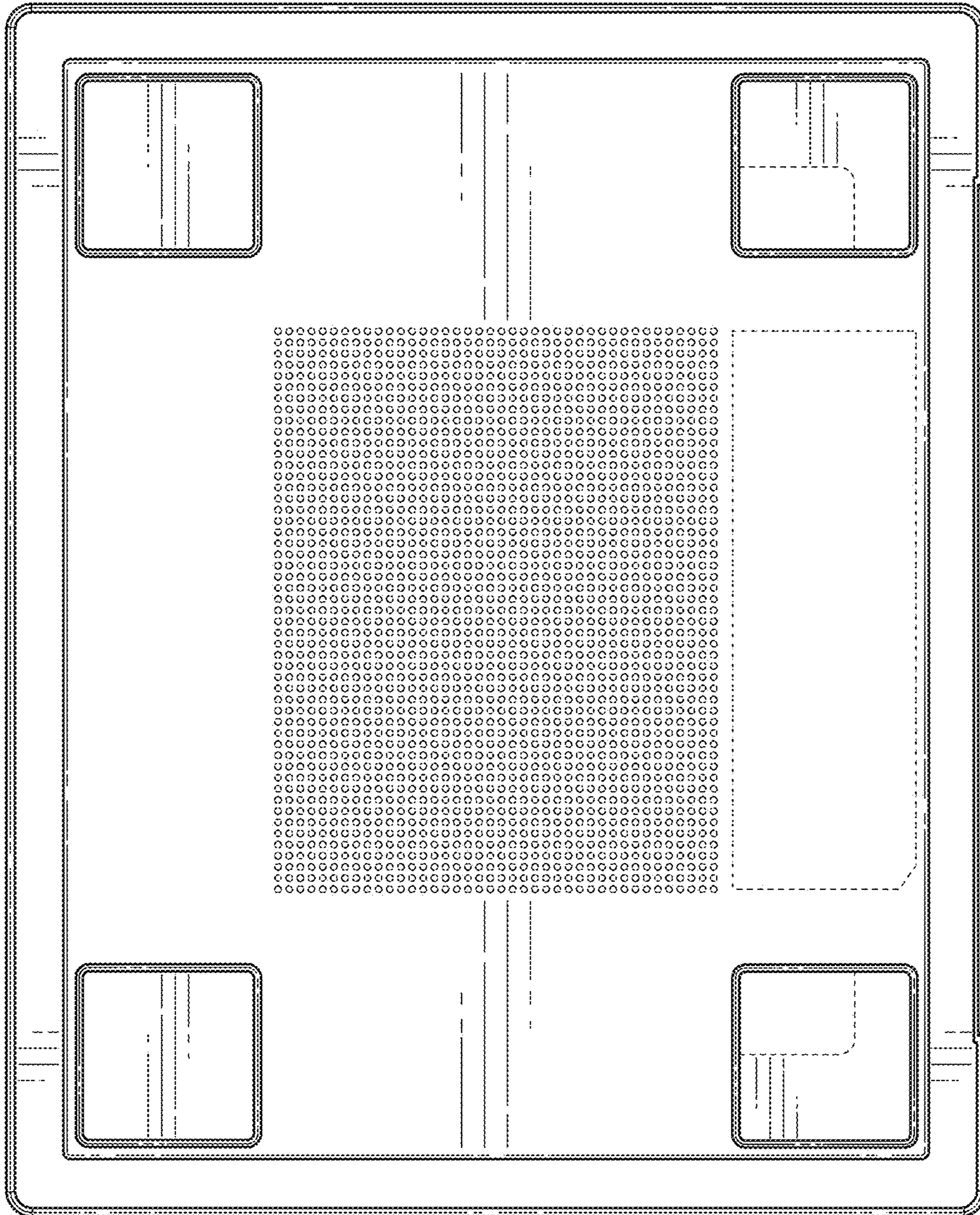

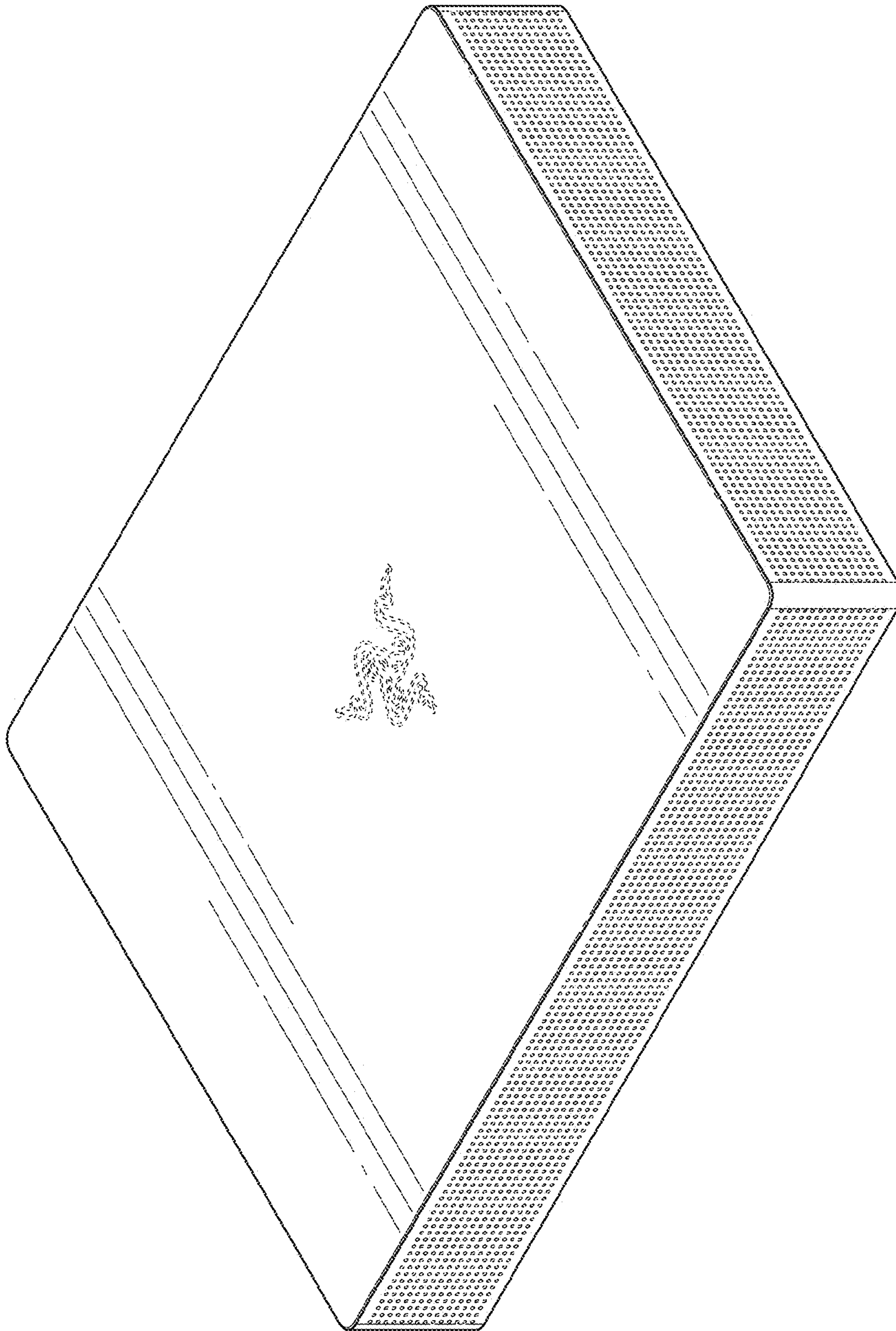

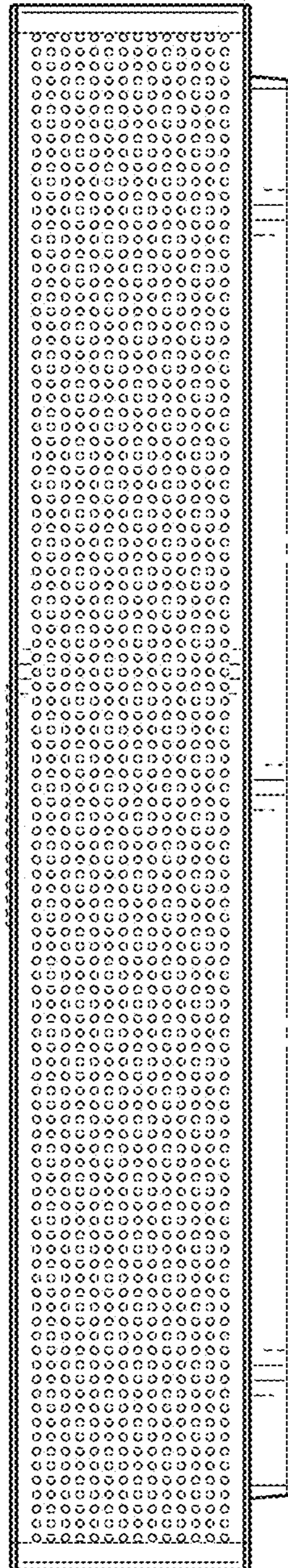

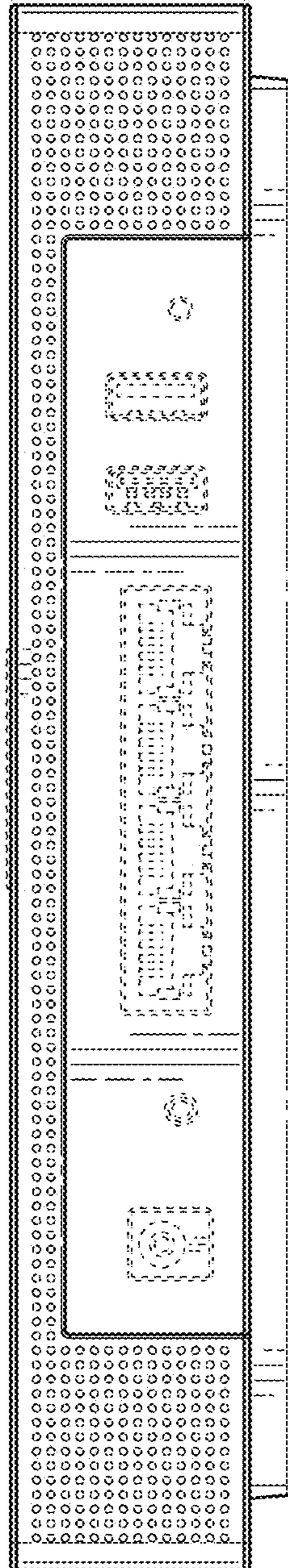

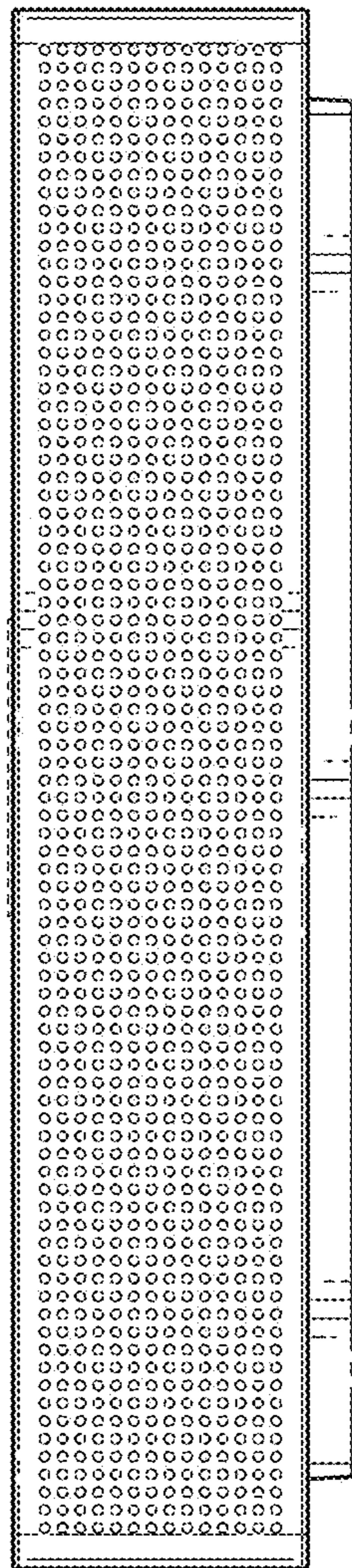

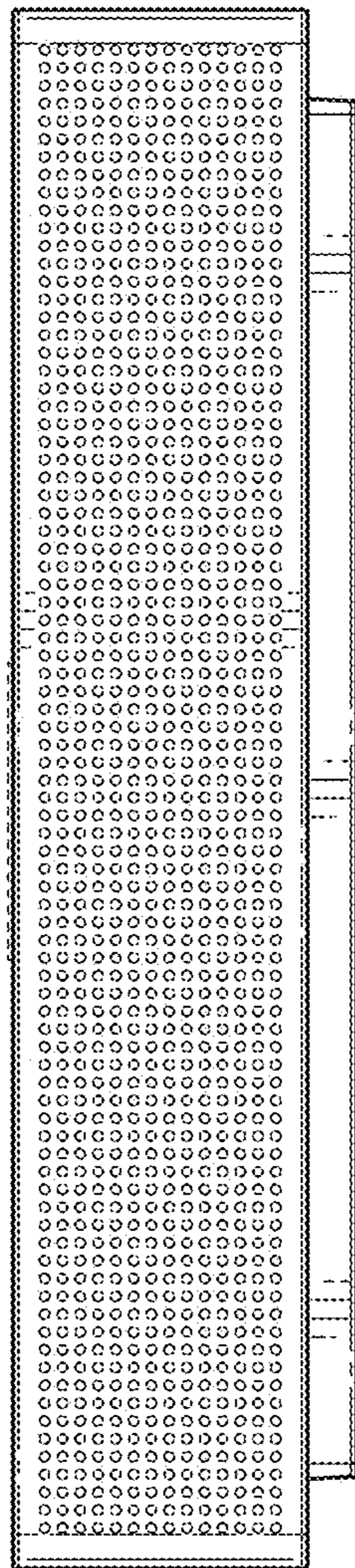

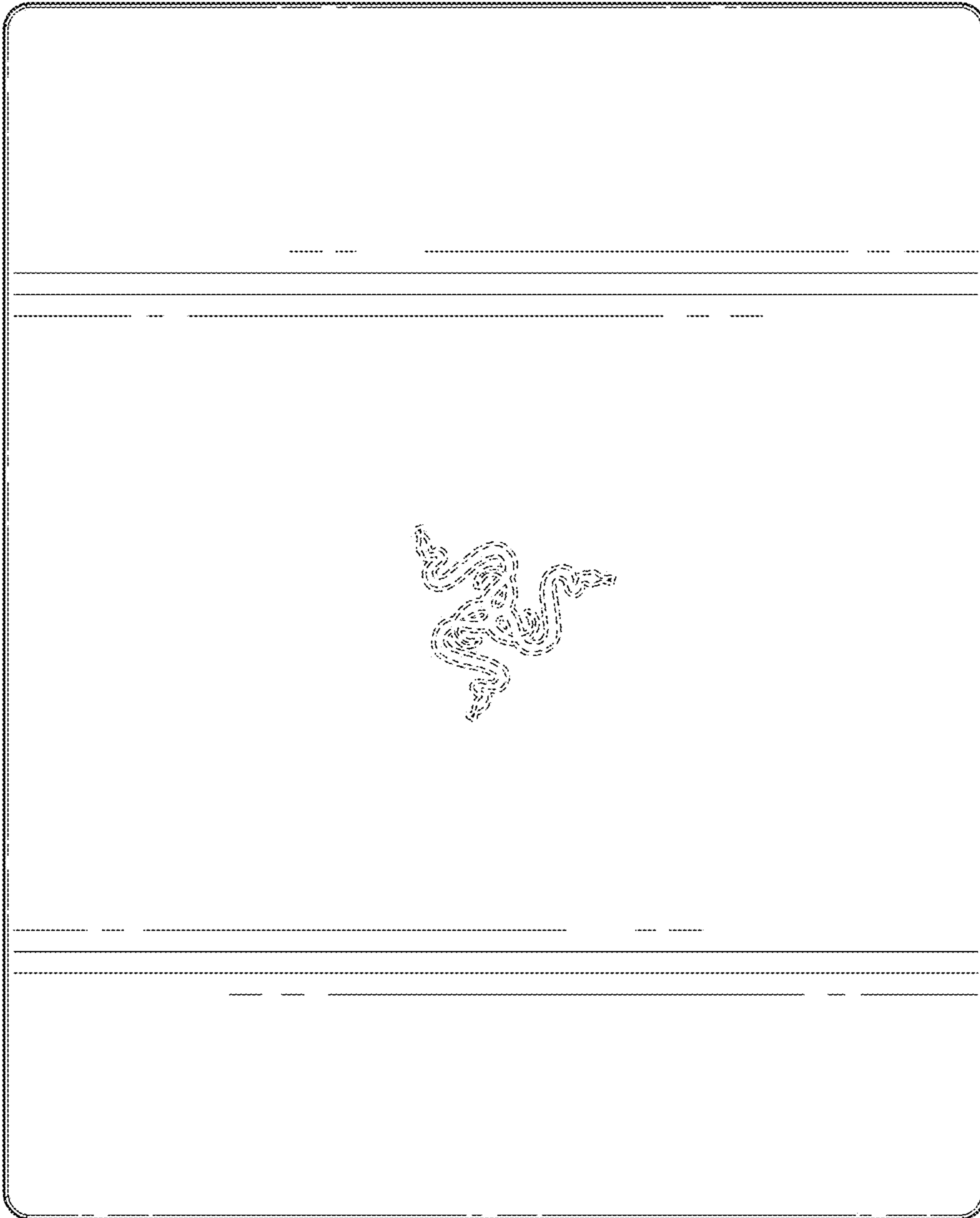

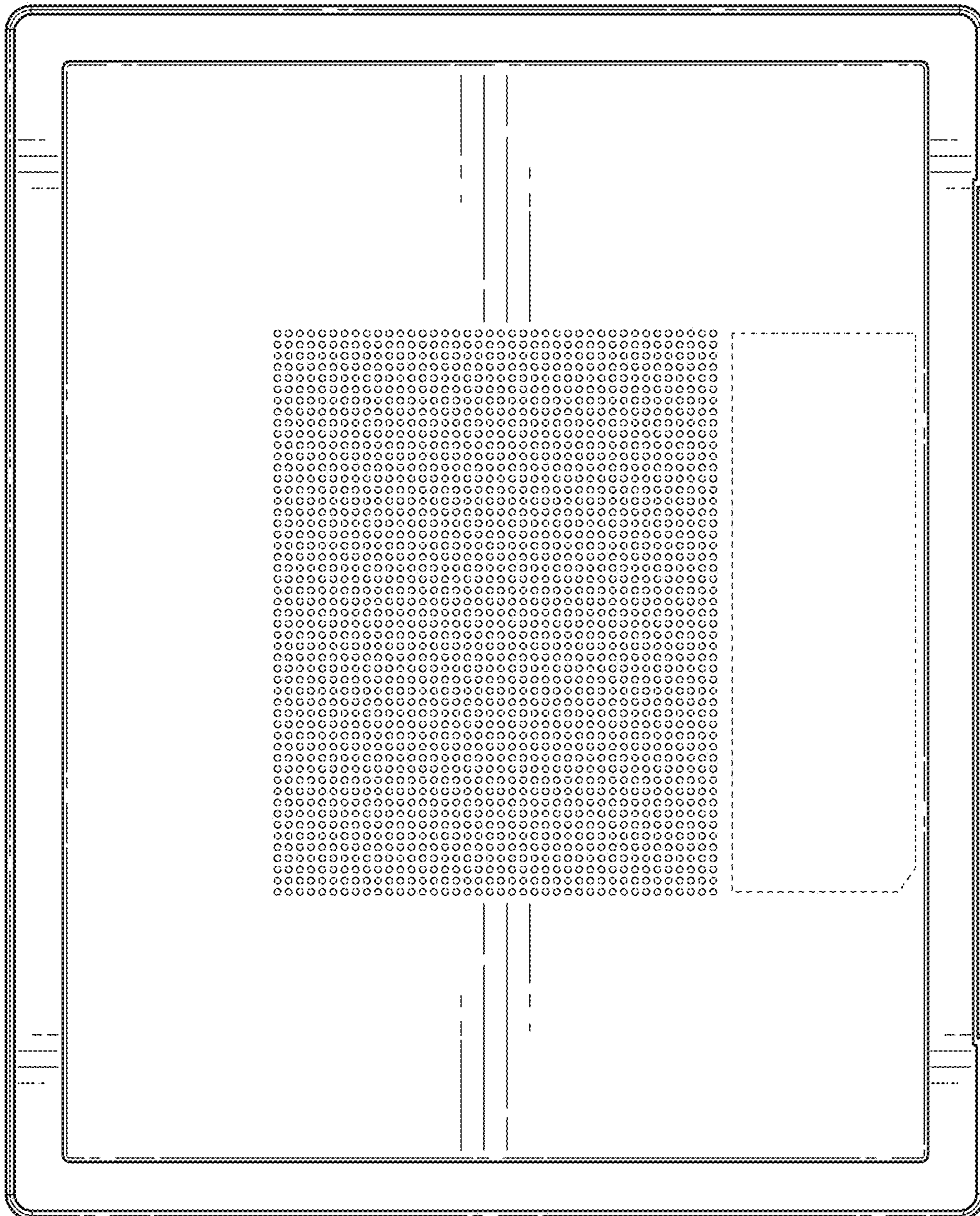
