(57) **CLAIM**

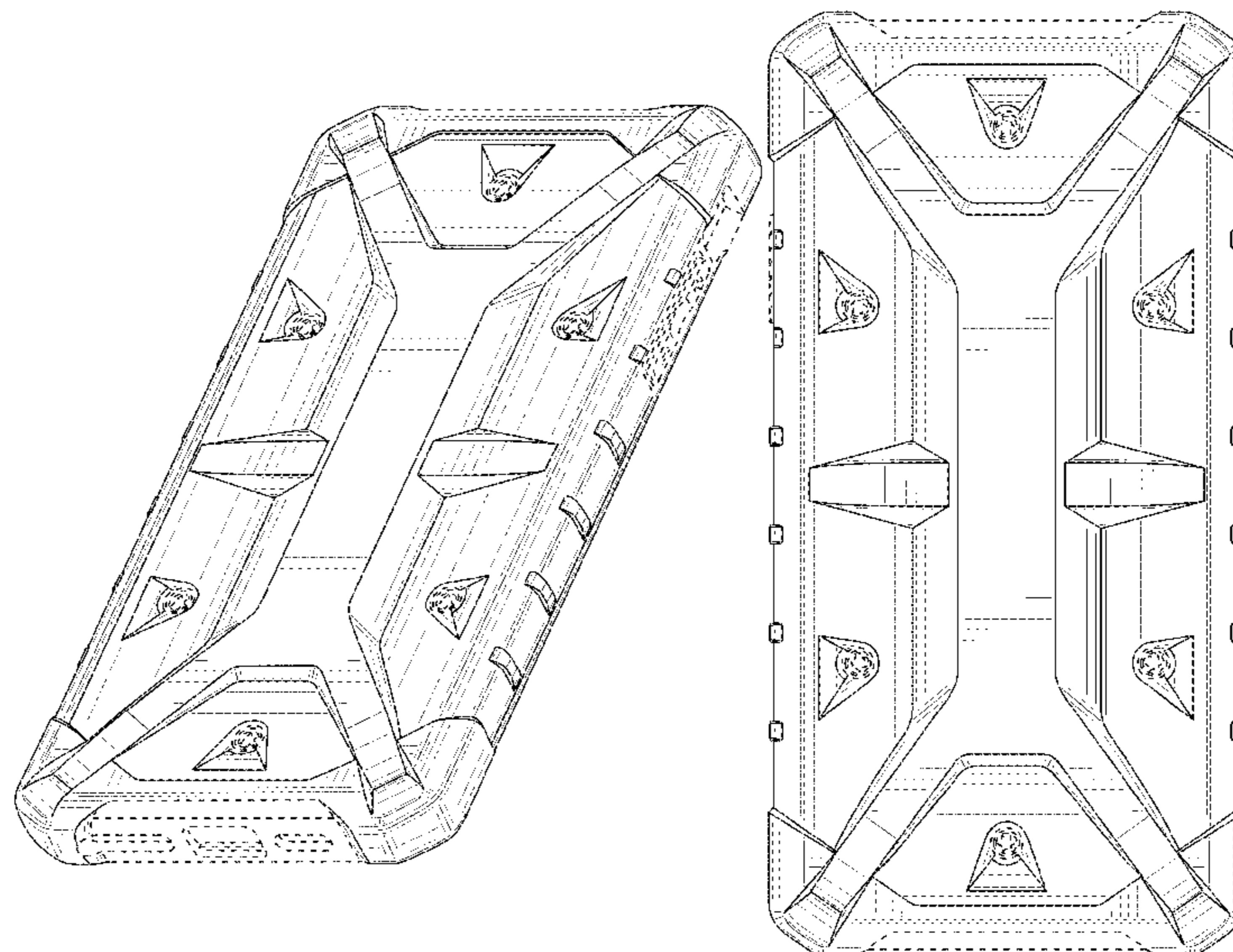
We claim the ornamental design for a case for a mobile device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the case for a mobile device;  
 FIG. 2 is another front perspective view of the case for a mobile device shown in FIG. 1;  
 FIG. 3 is a rear perspective view of the case for a mobile device shown in FIG. 1;  
 FIG. 4 is a front plan view of the case for a mobile device shown in FIG. 1;  
 FIG. 5 is rear plan view of the case for a mobile device shown in FIG. 1;  
 FIG. 6 is a right plan view of the case for a mobile device shown in FIG. 1;  
 FIG. 7 is a left plan view of the case for a mobile device shown in FIG. 1;  
 FIG. 8 is a top plan view of the case for a mobile device shown in FIG. 1; and,  
 FIG. 9 is a bottom plan view of the case for a mobile device shown in FIG. 1.

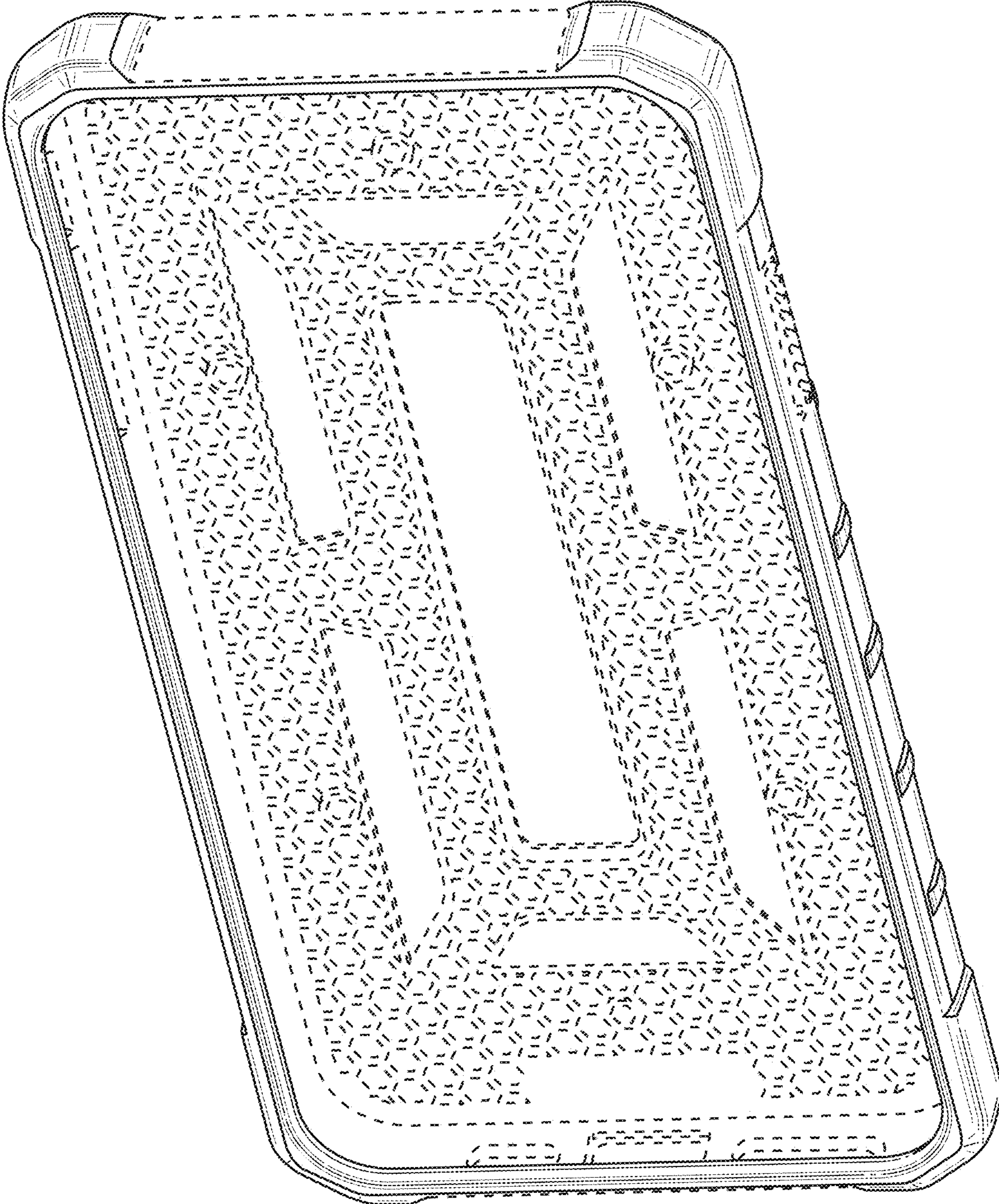

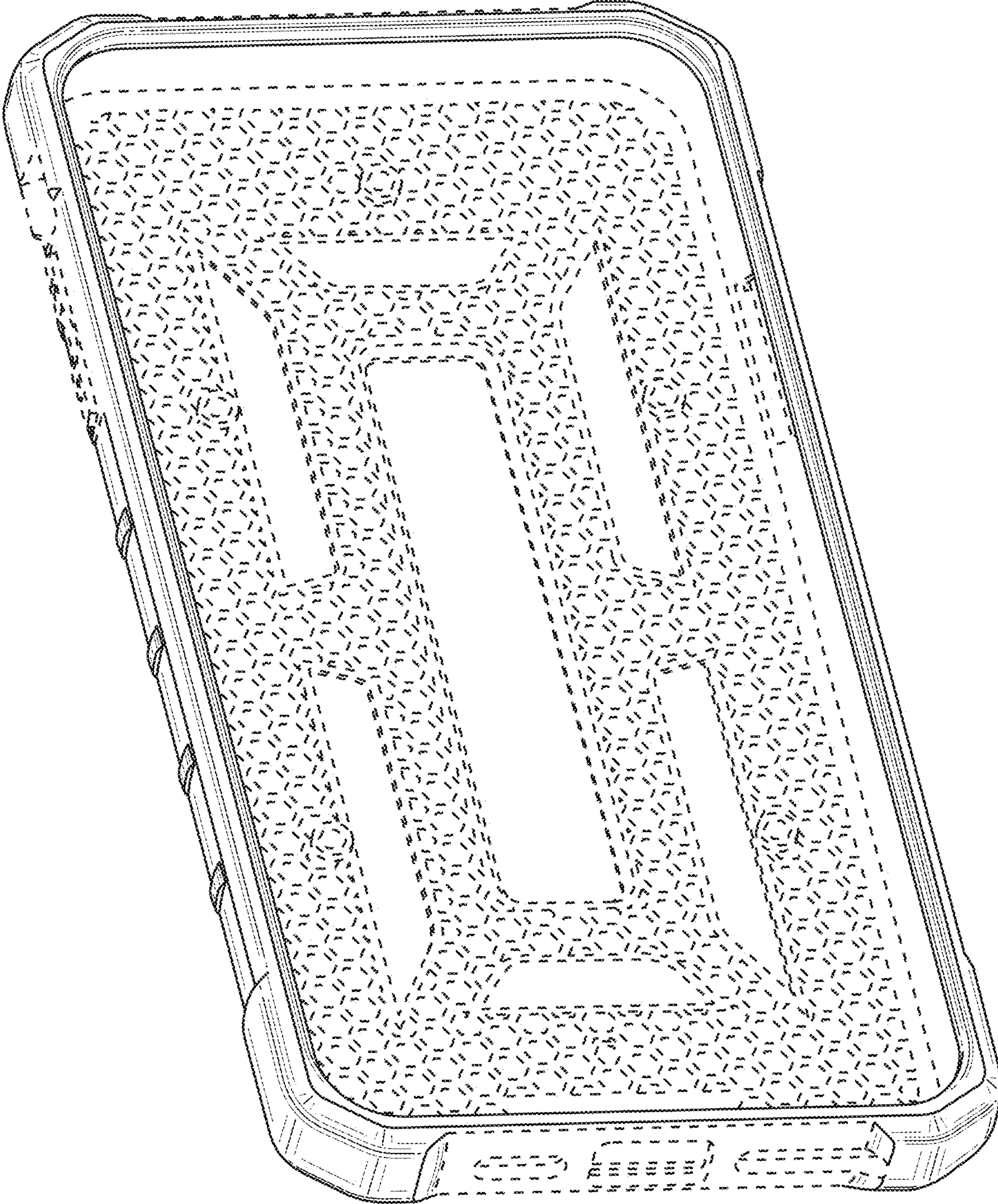

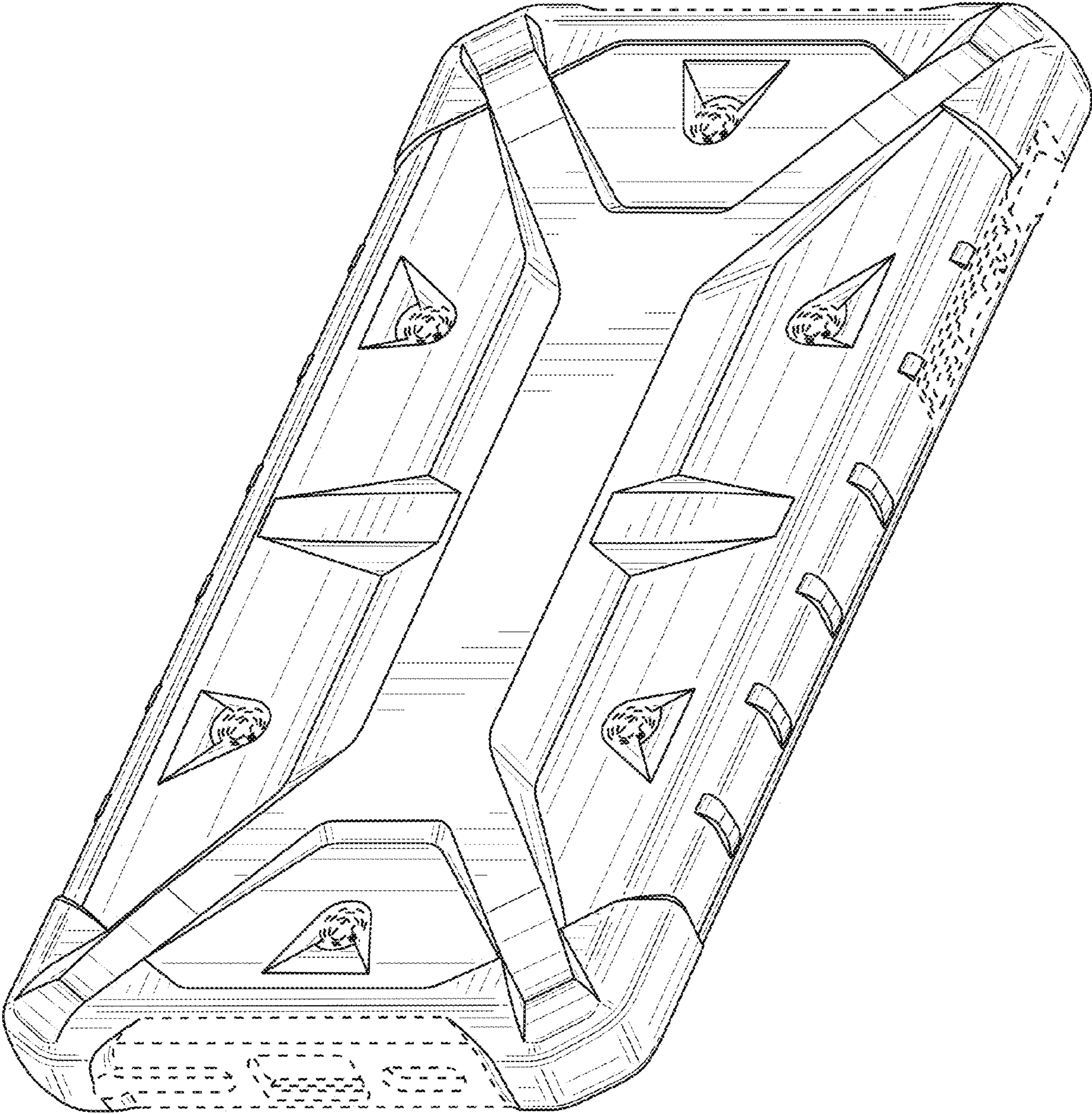

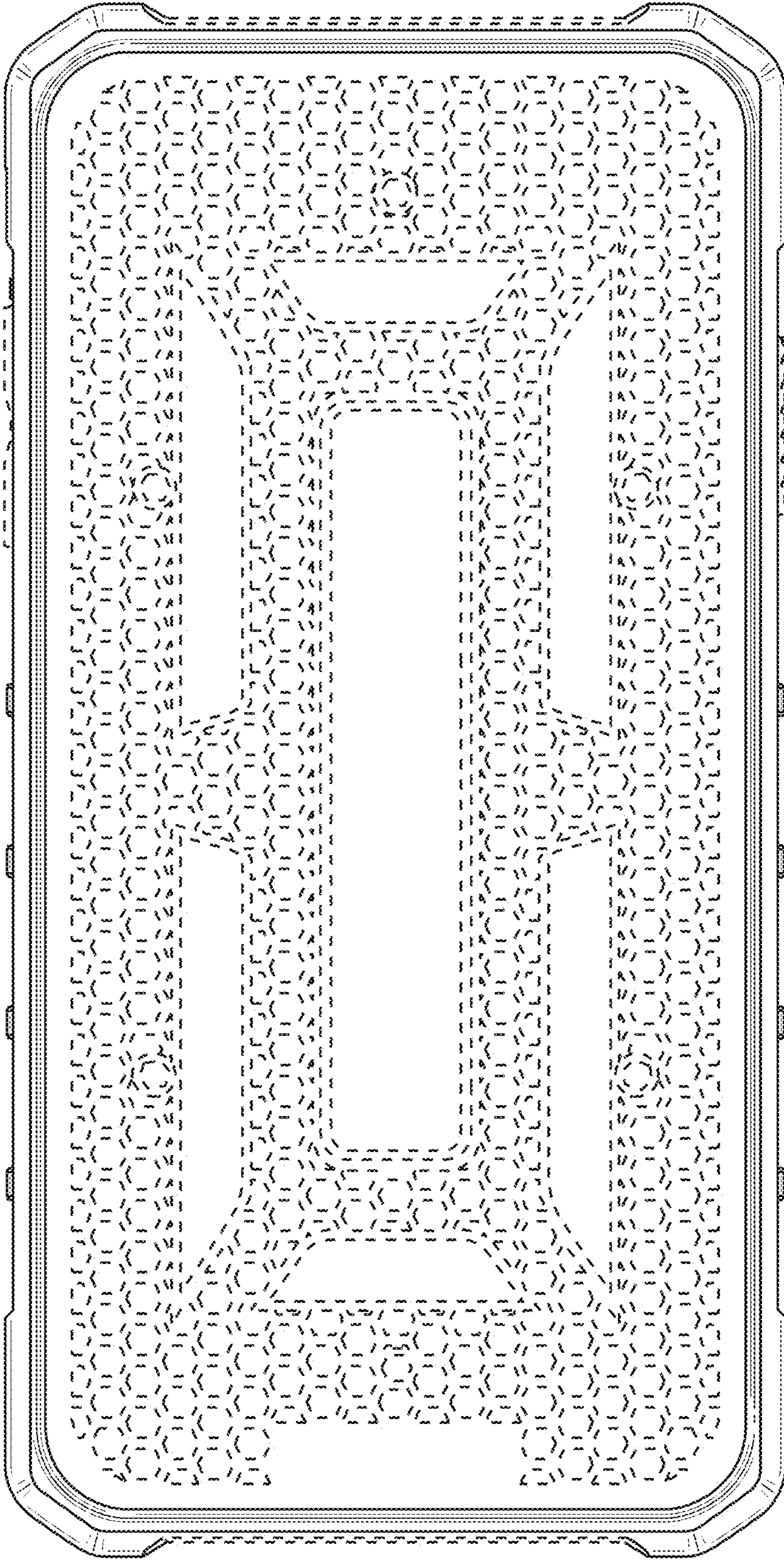

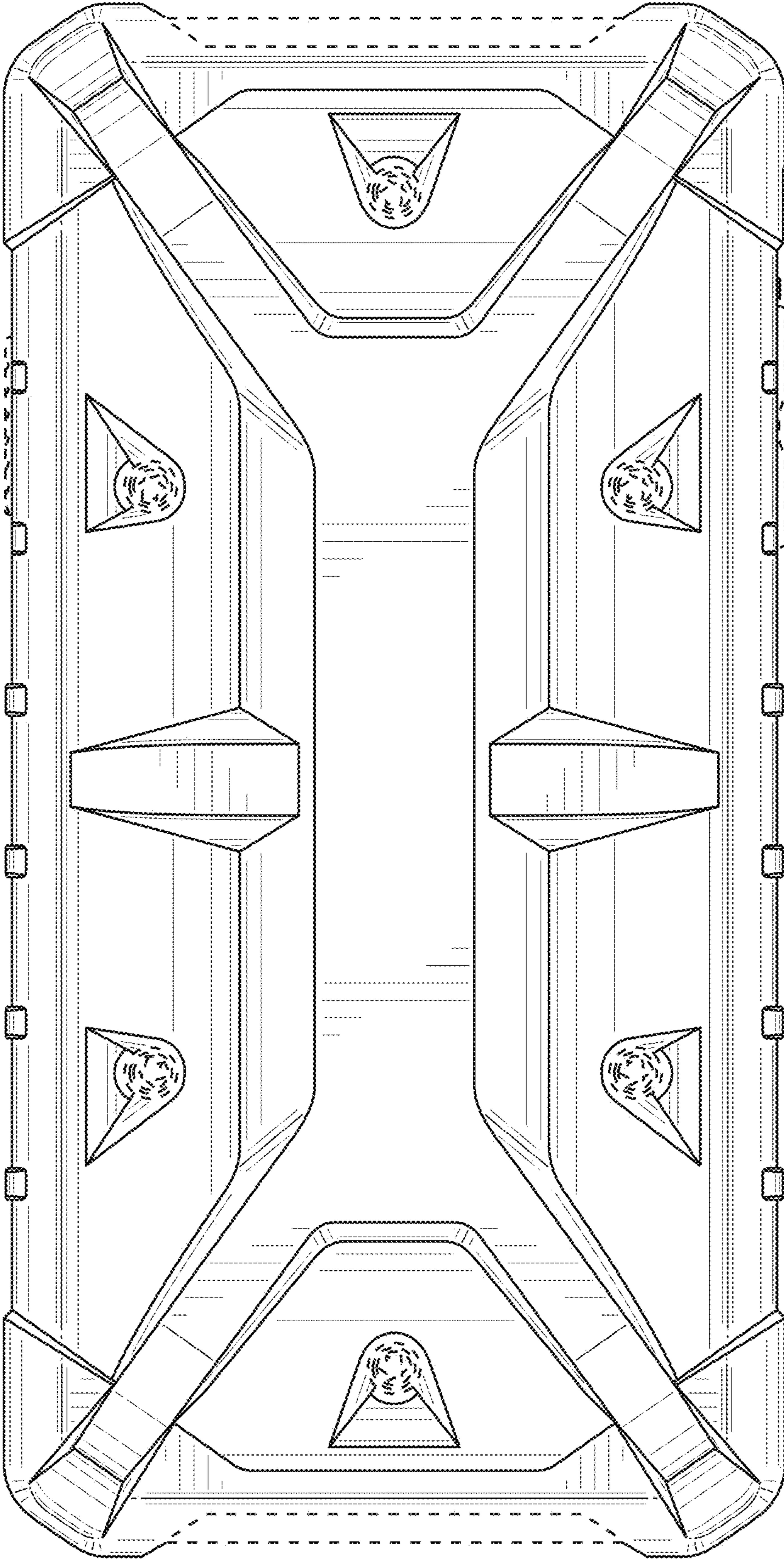

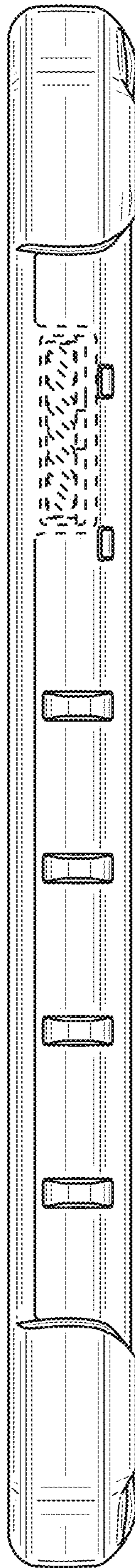

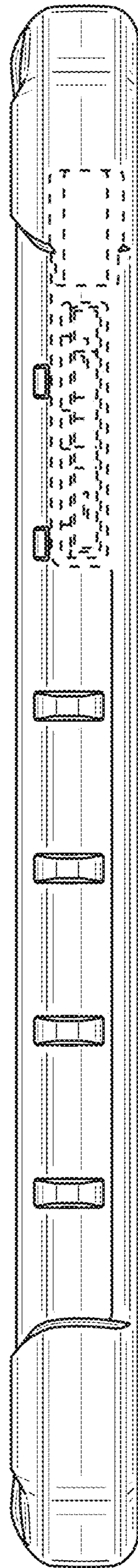

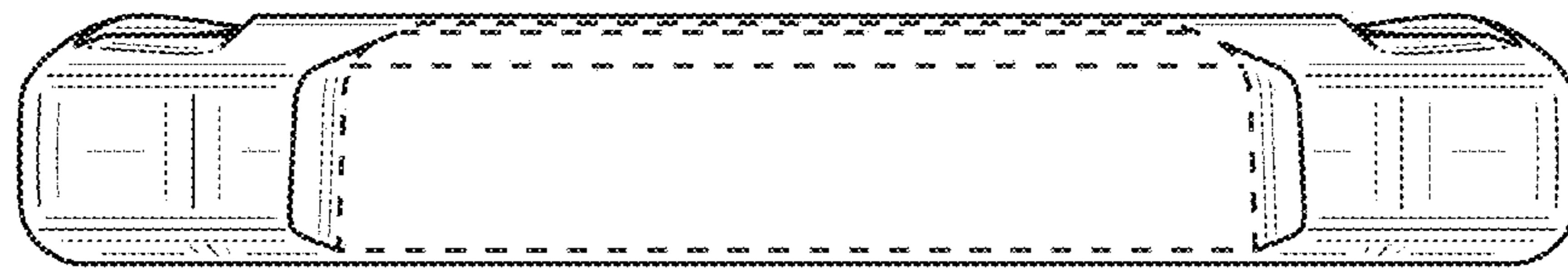

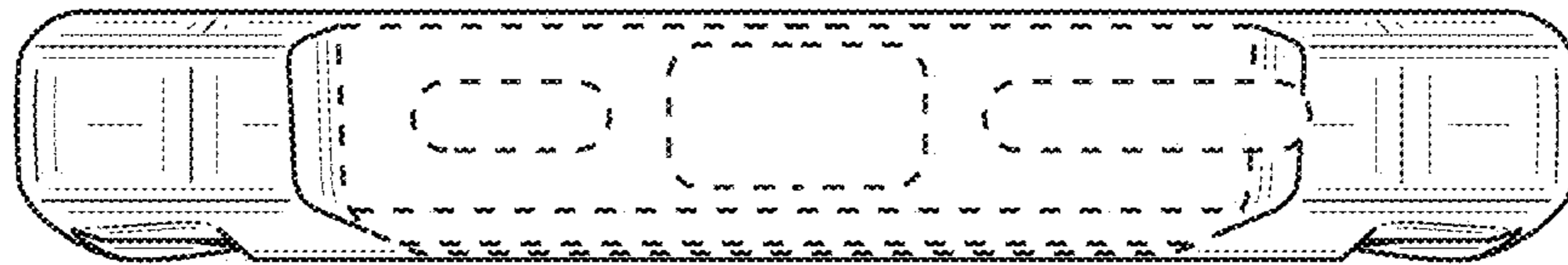
