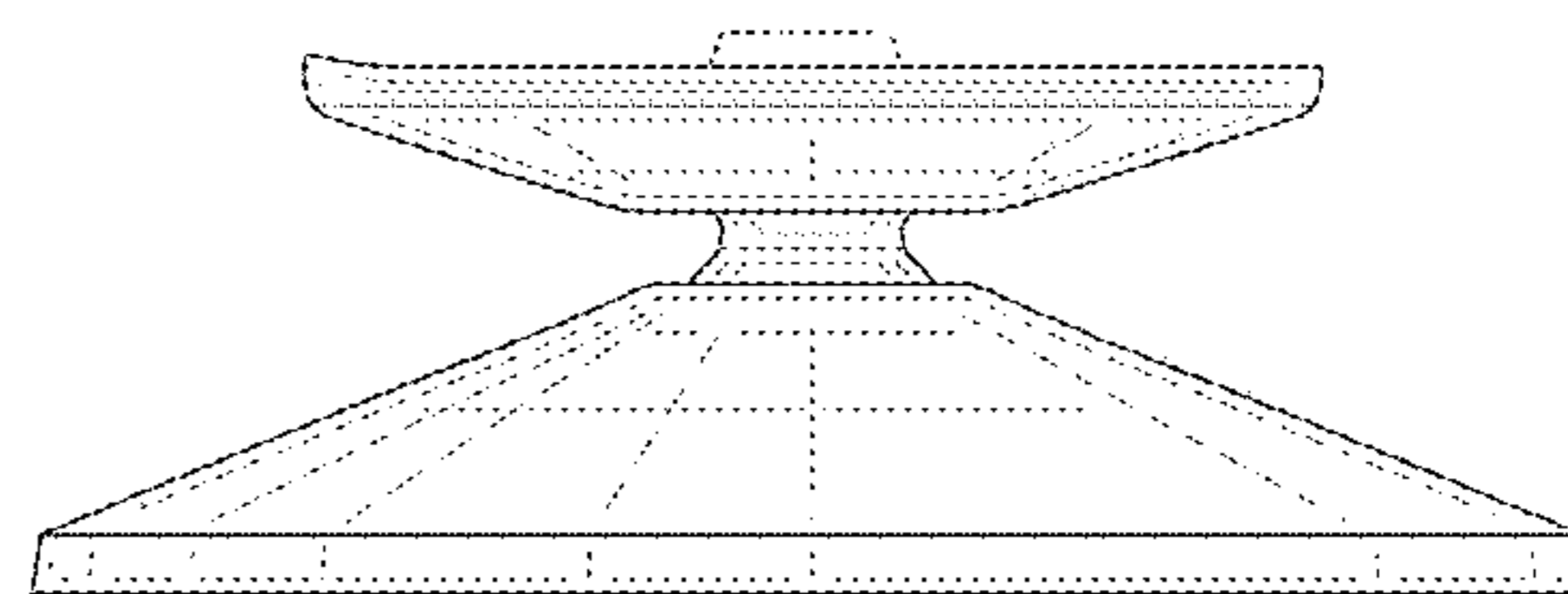
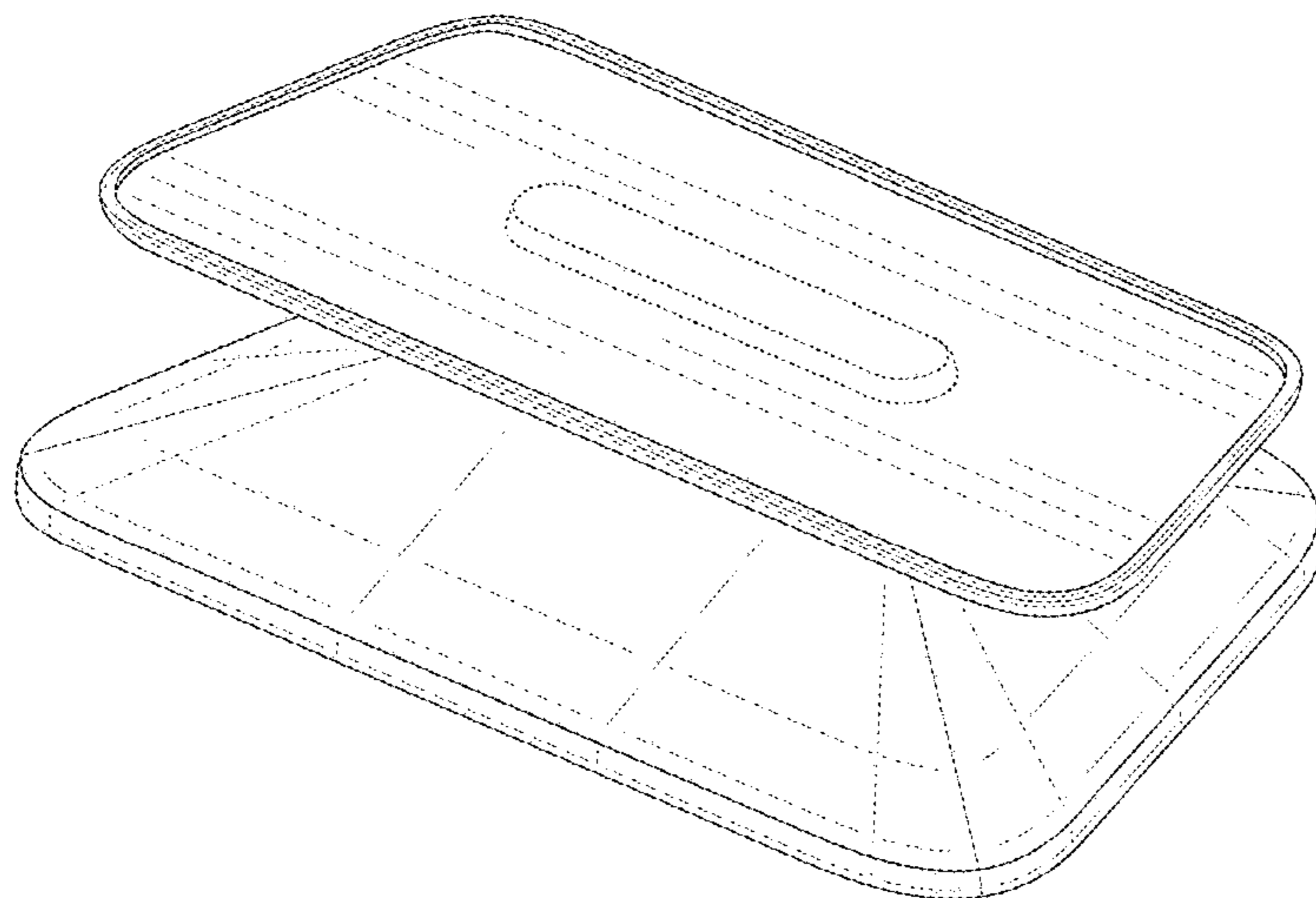
The ornamental design for a stand for a device, as shown and described.

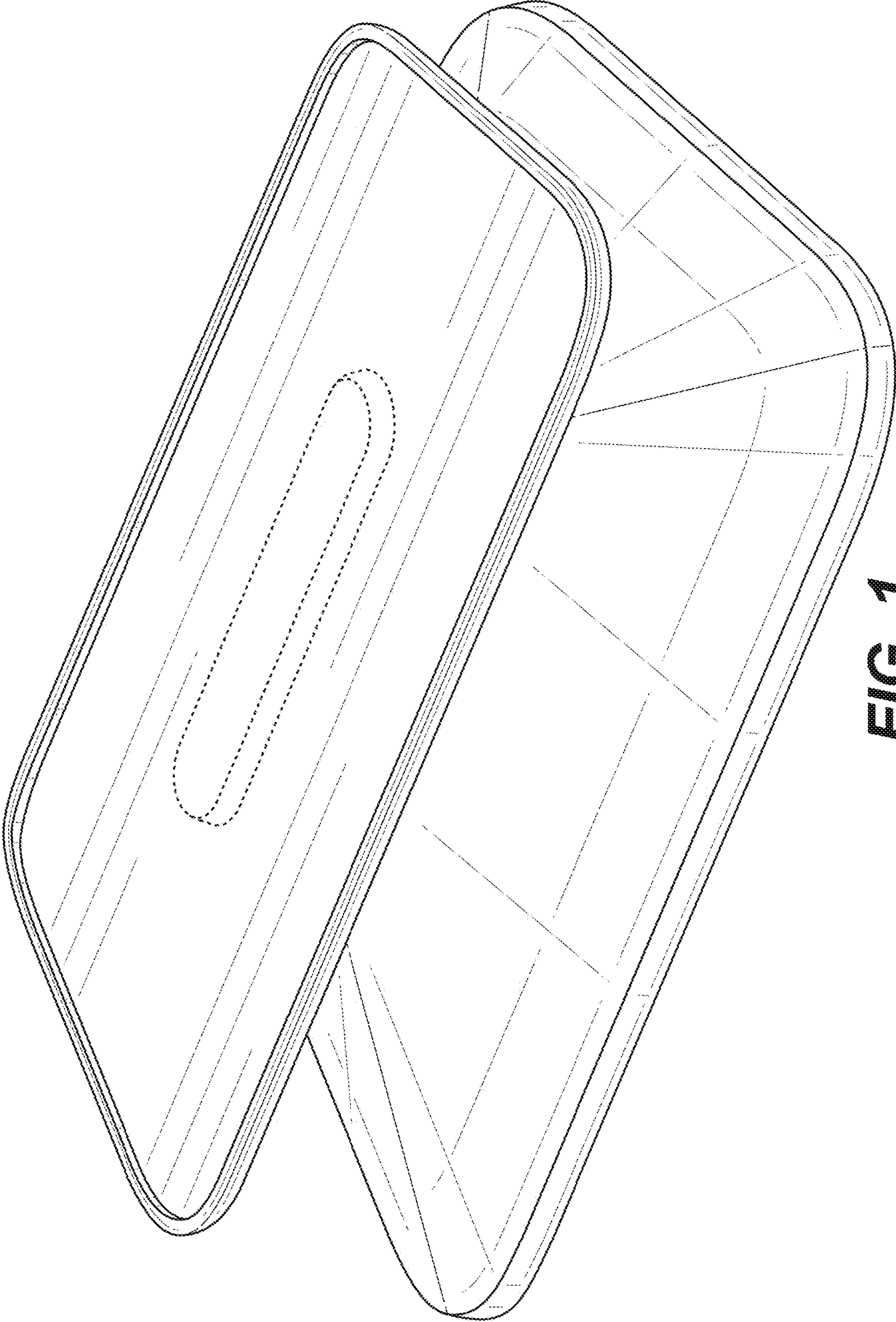

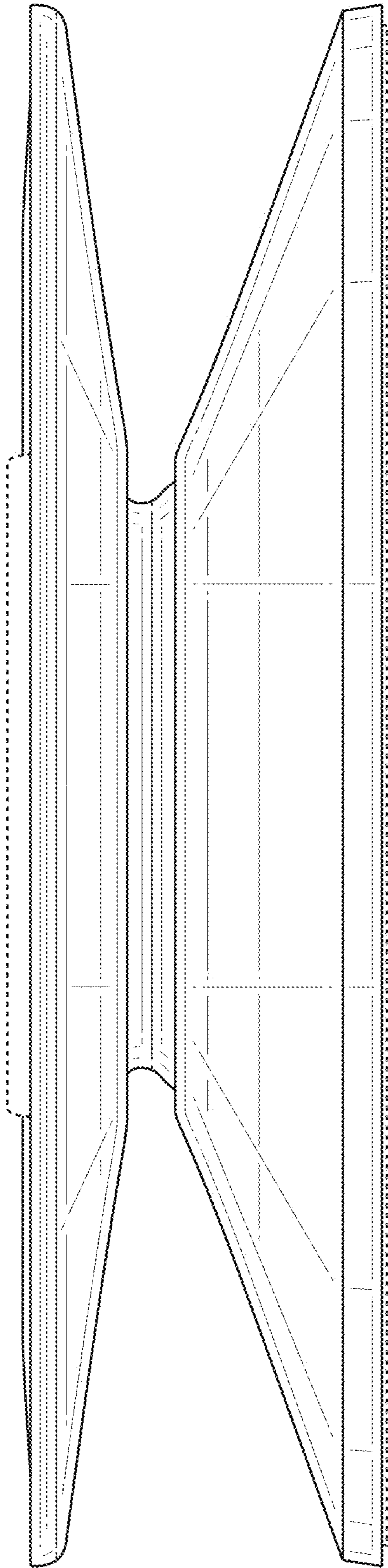

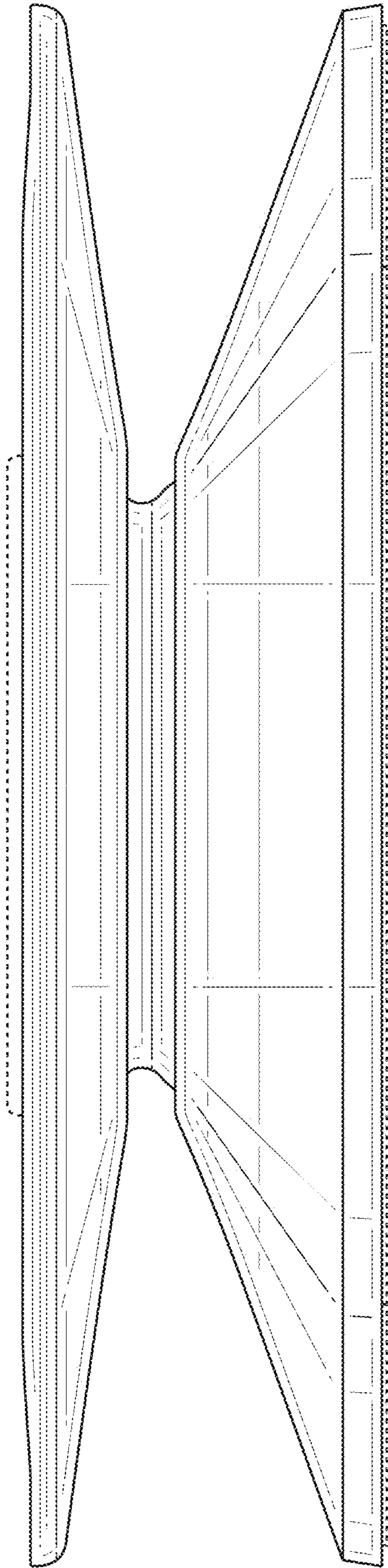

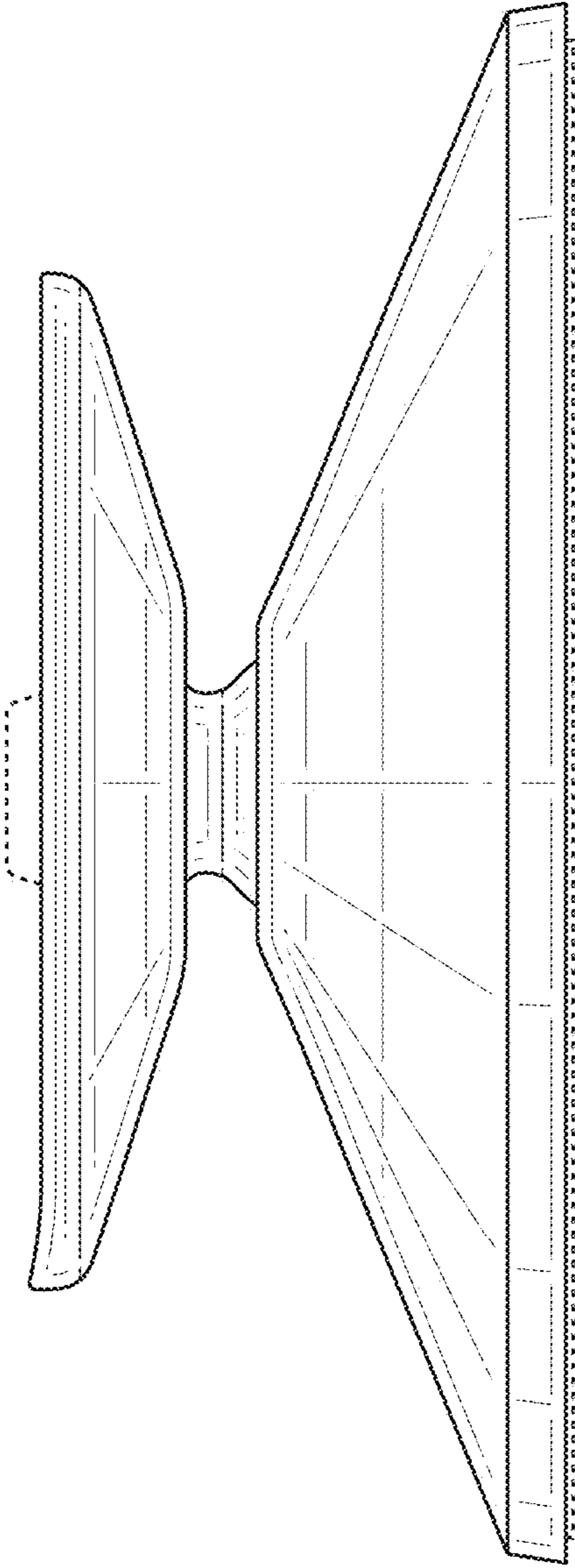

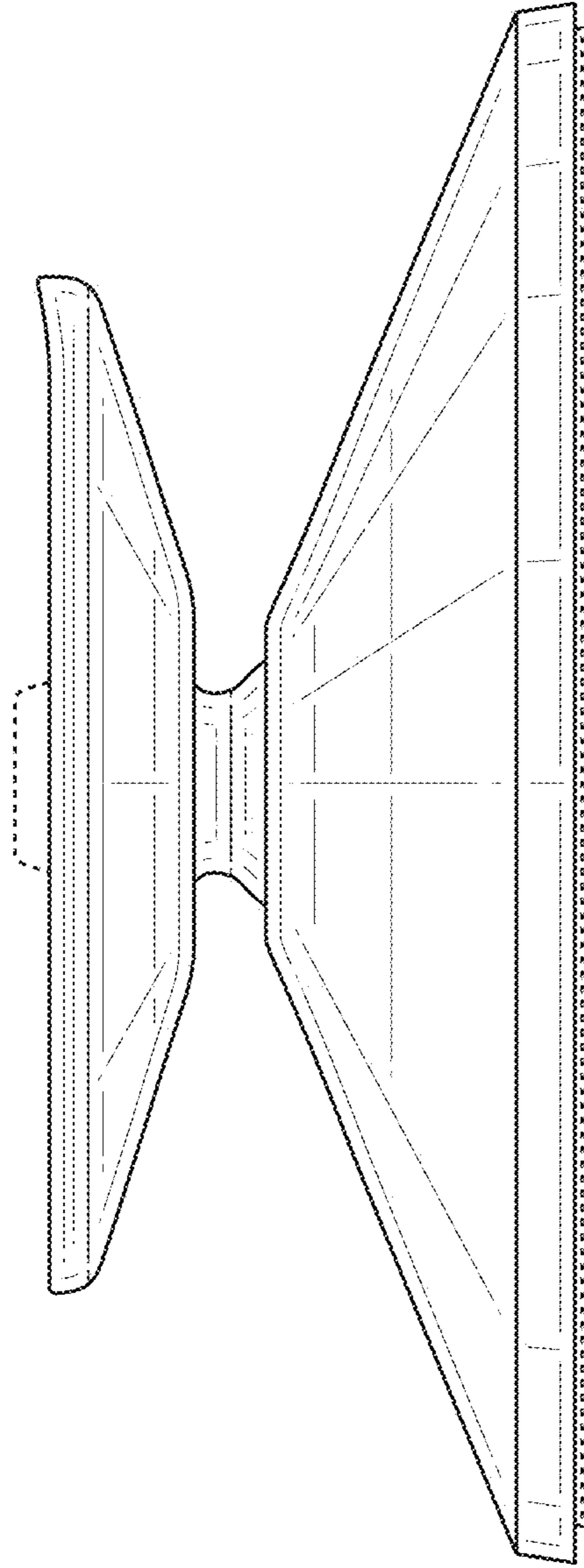

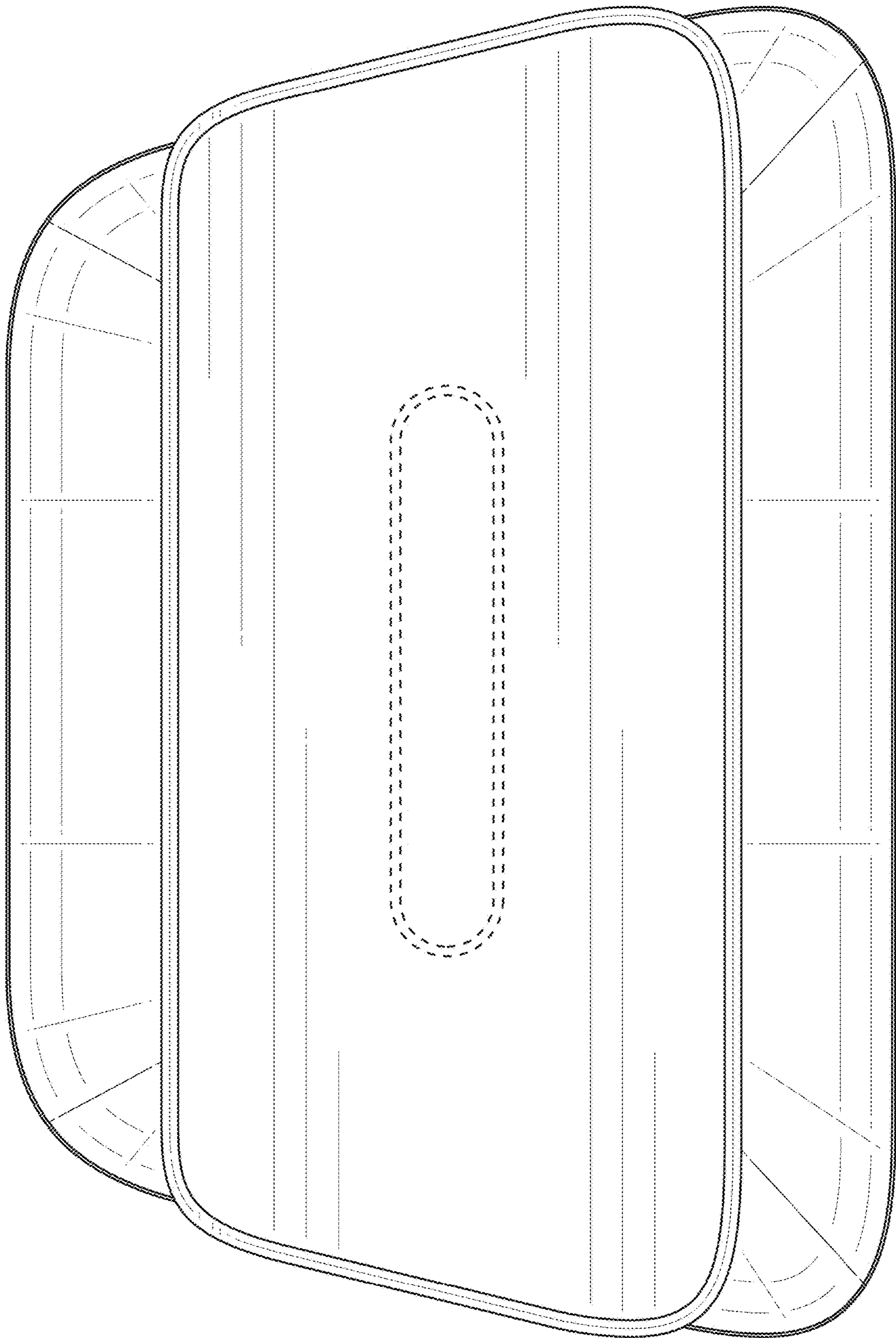

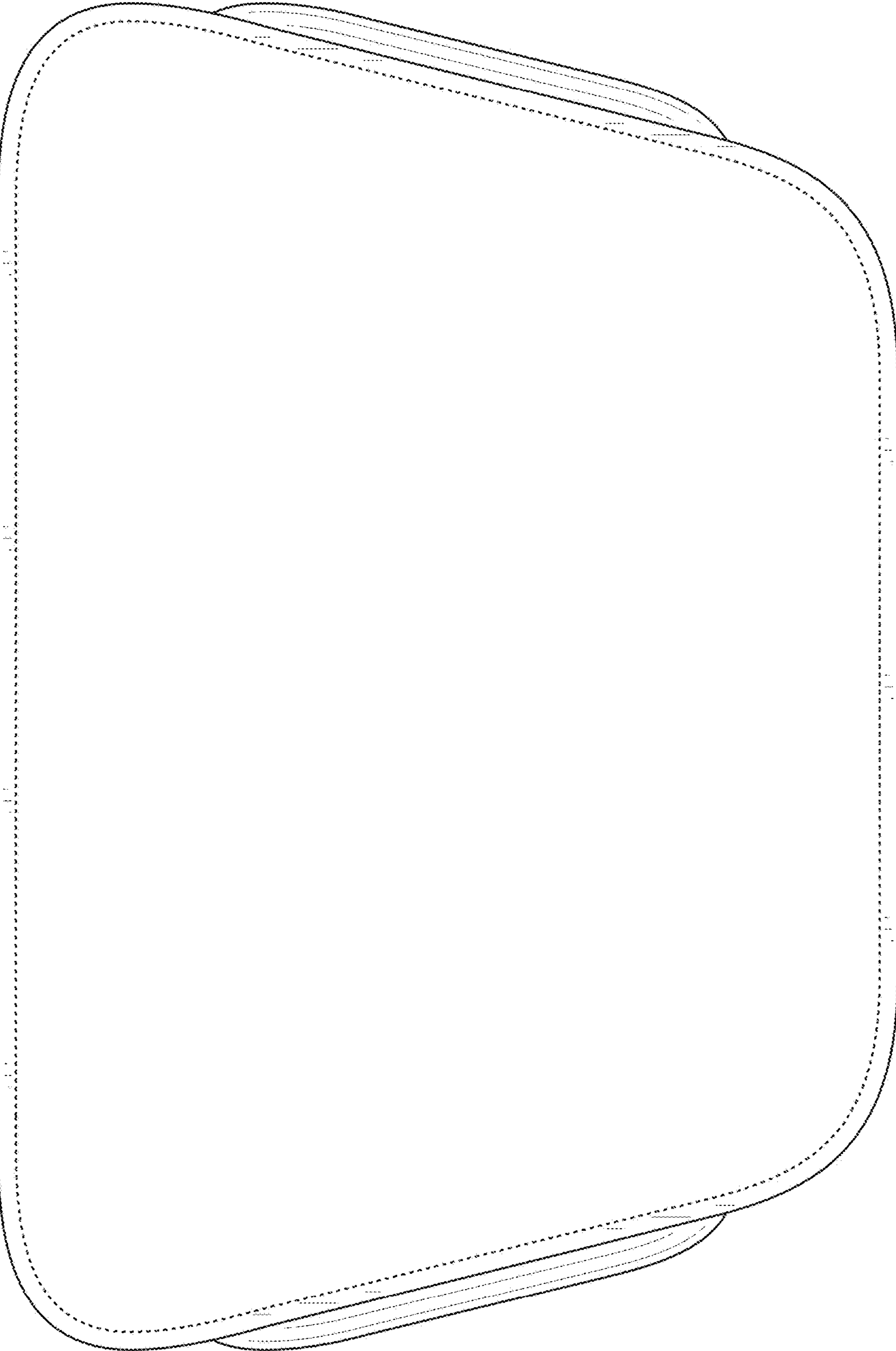
