The ornamental design for combined display device and screen with an animated graphical user interface, as shown and described.

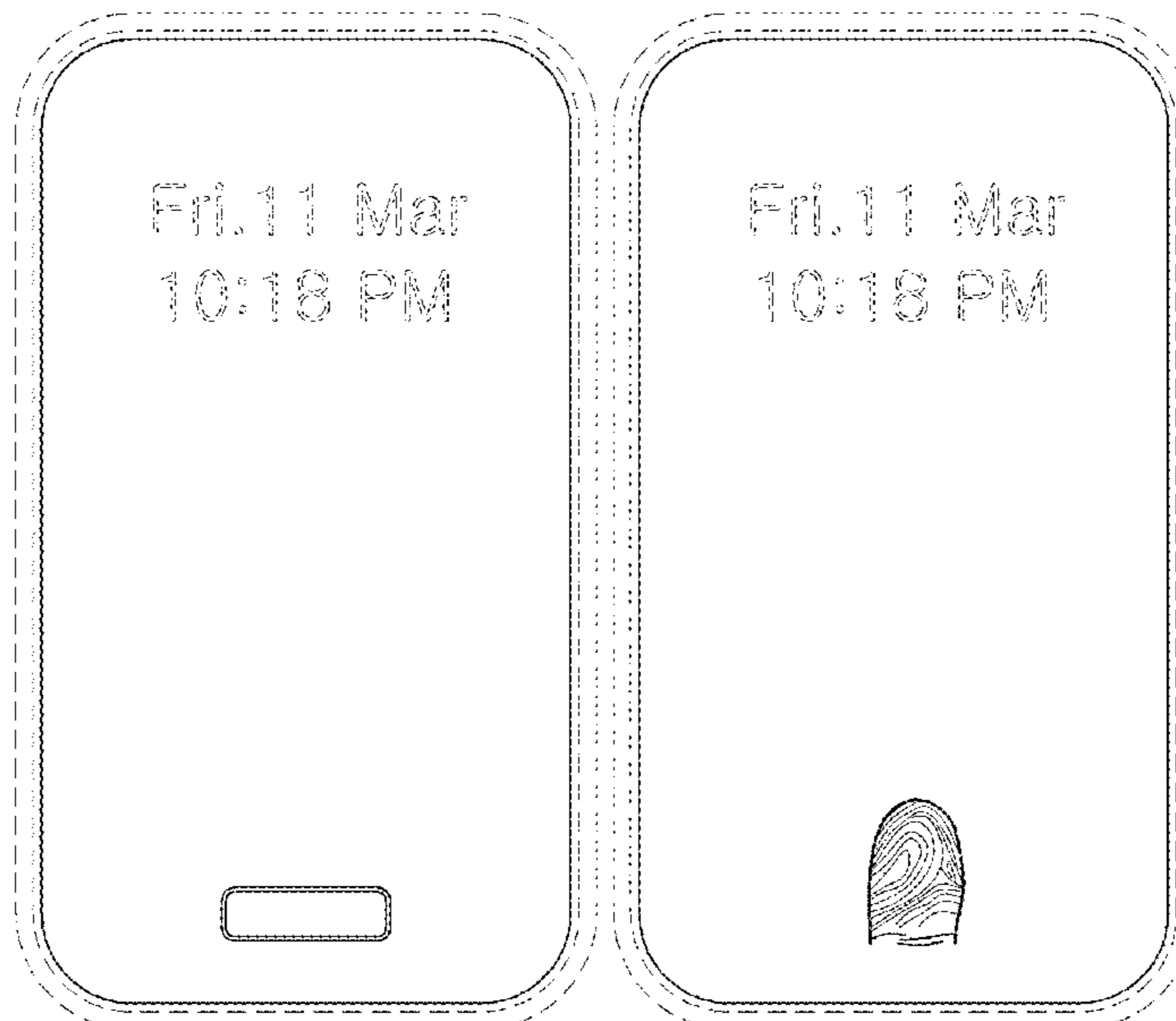
**DESCRIPTION**

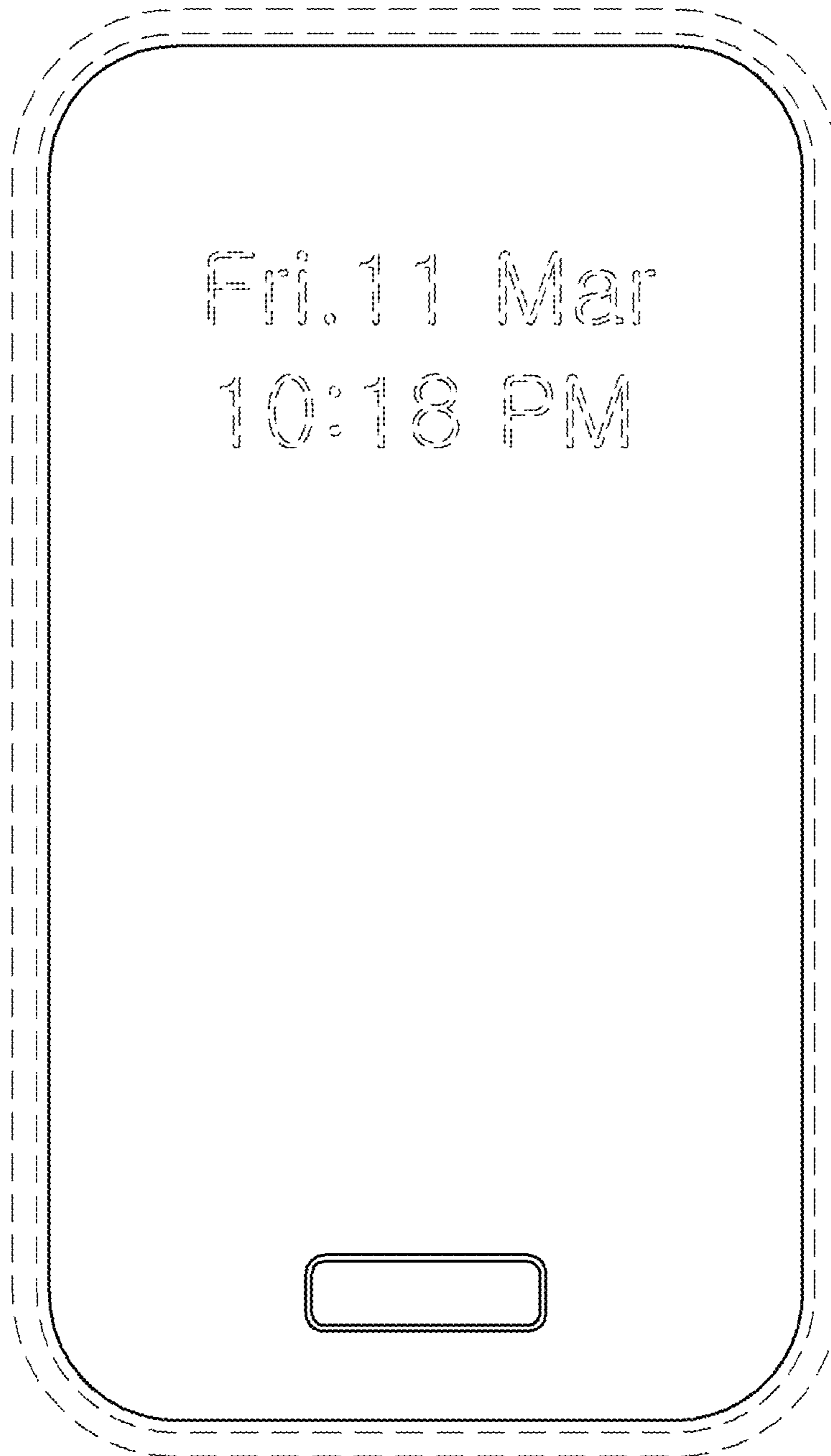
