The ornamental design for a refrigerator, as shown and described.

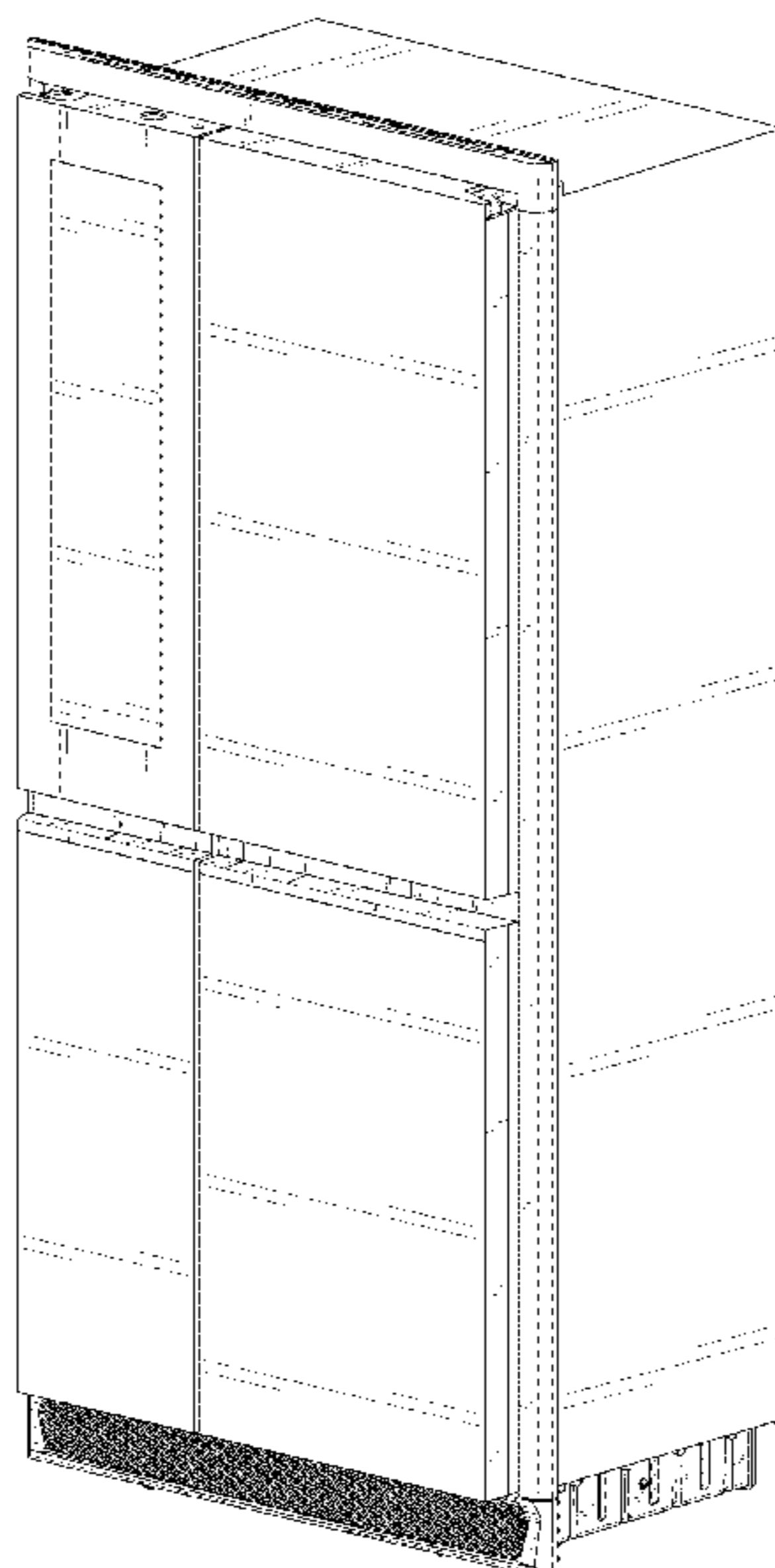
DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a refrigerator illustrating my new design; FIG. 2 is a front view of the first embodiment of FIG. 1; FIG. 3 is a rear view of the first embodiment of FIG. 1; FIG. 4 is a left side view of the first embodiment of FIG. 1; FIG. 5 is a right side view of the first embodiment of FIG. 1; FIG. 6 is a top view of the first embodiment of FIG. 1; and, FIG. 7 is a bottom view of the first embodiment of FIG. 1. A second embodiment of a refrigerator is a mirror image of the first embodiment of FIGS. 1-7.

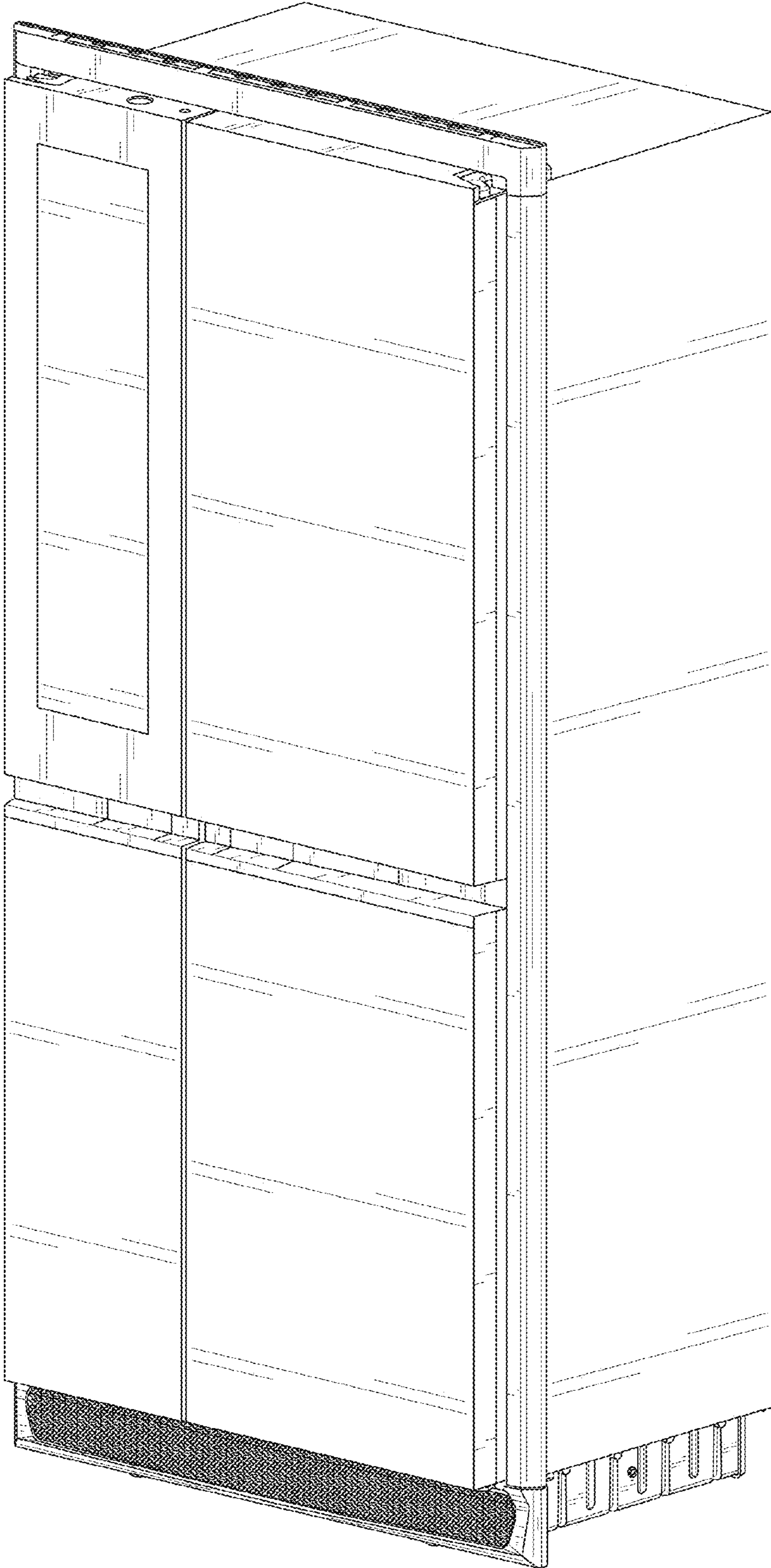

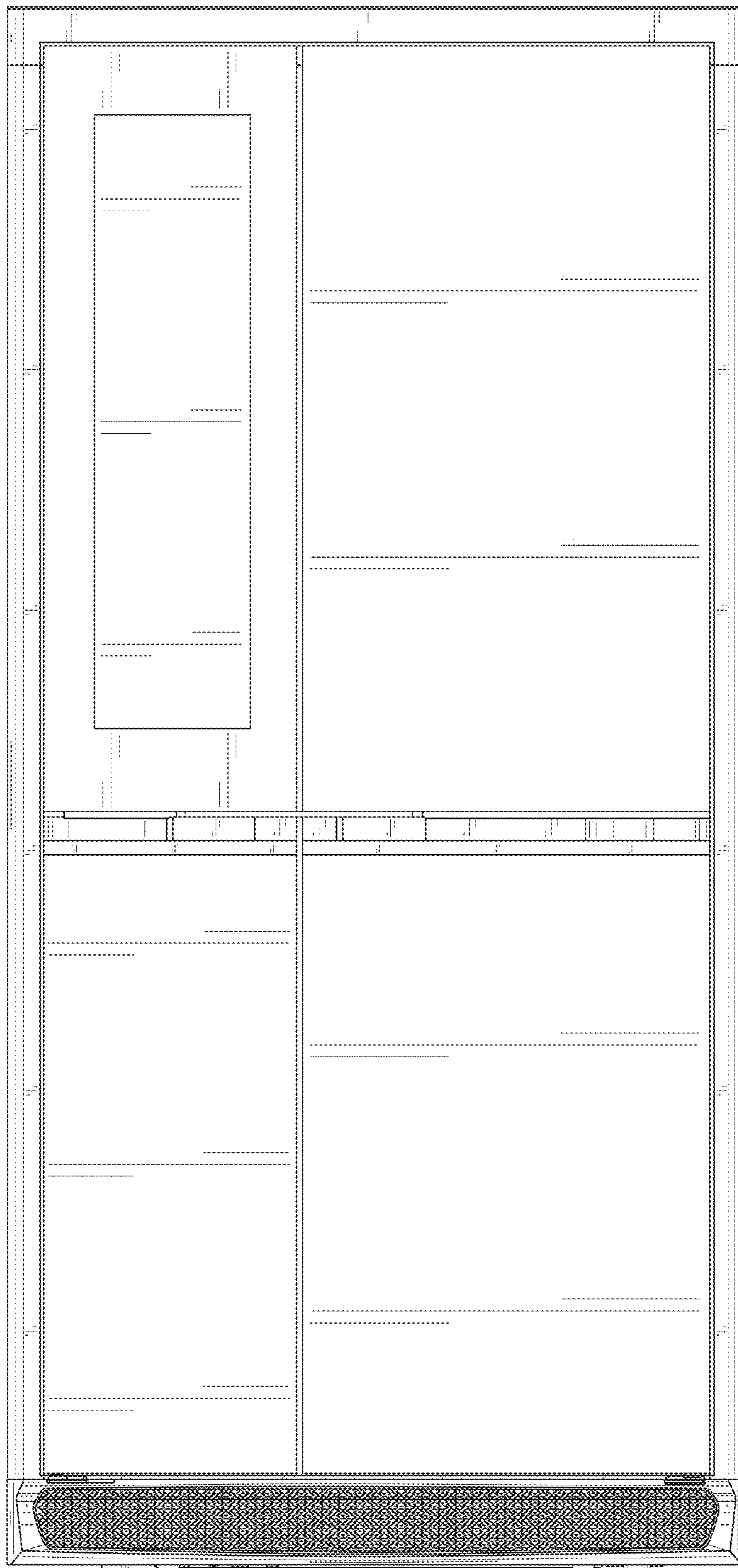

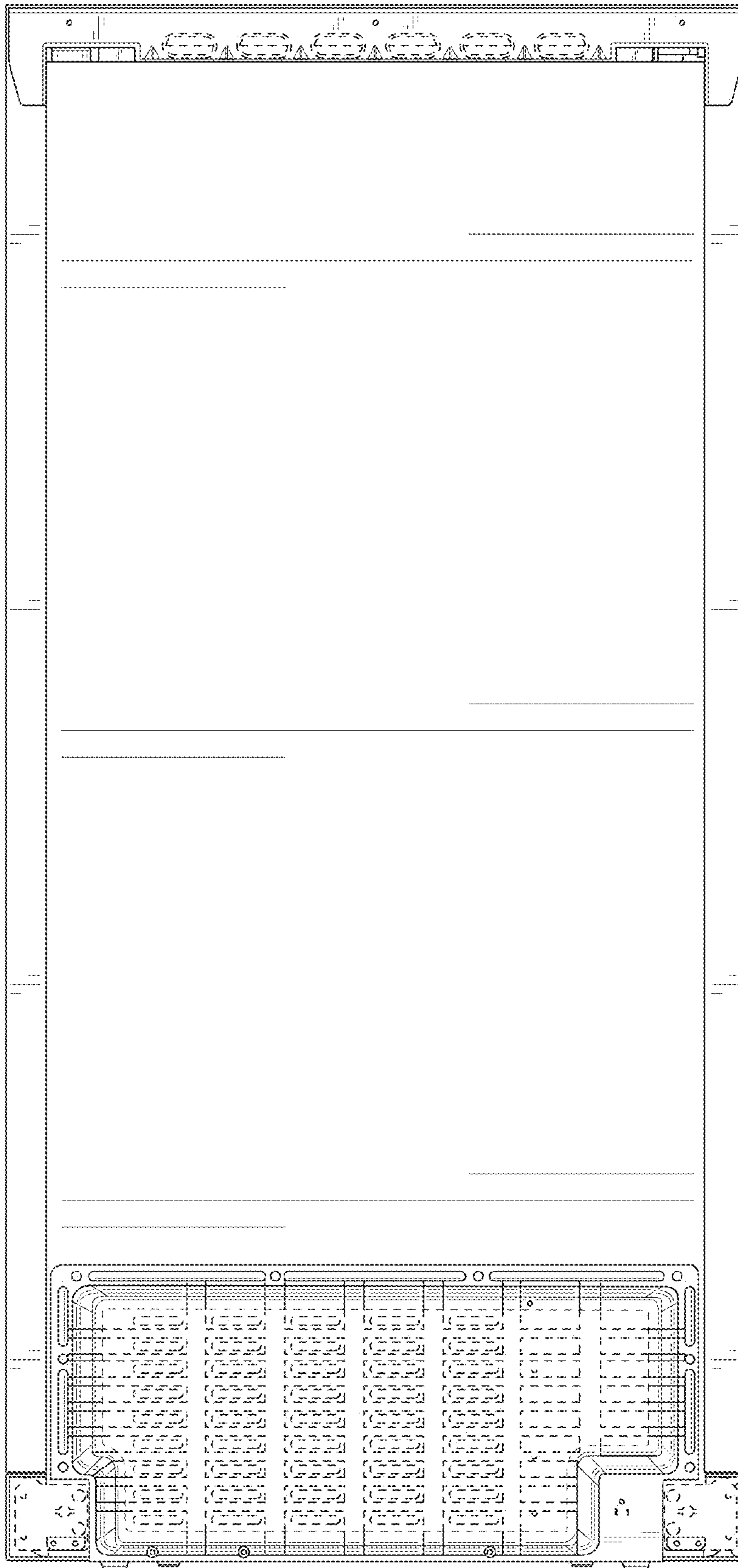

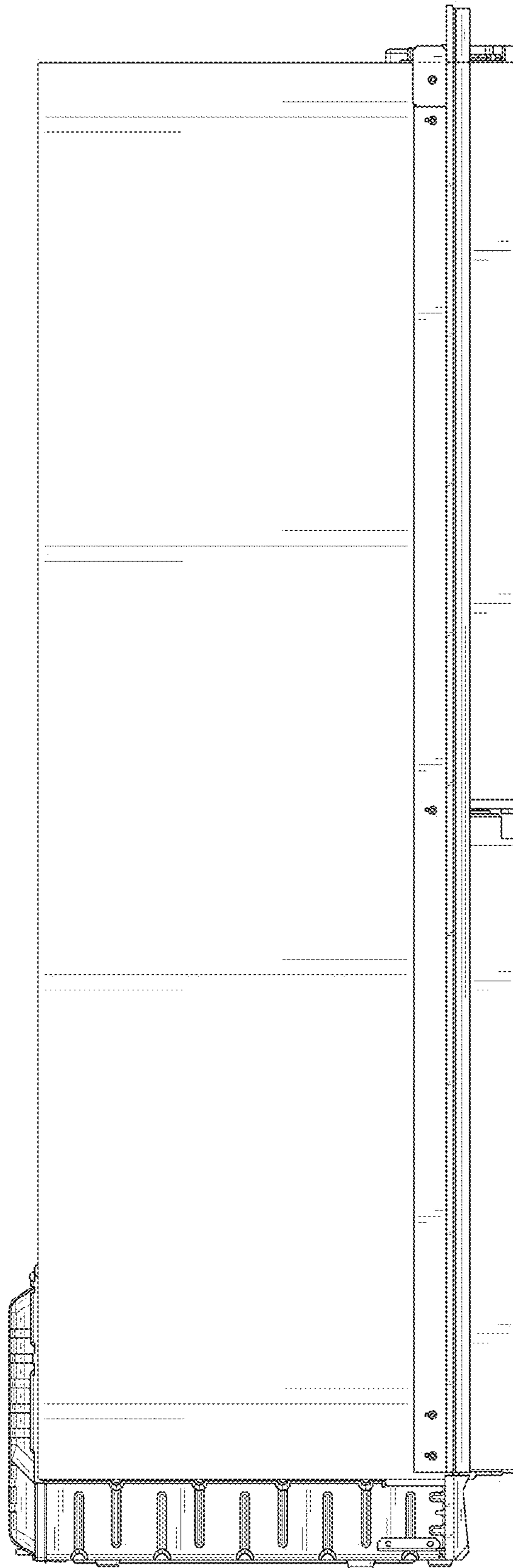

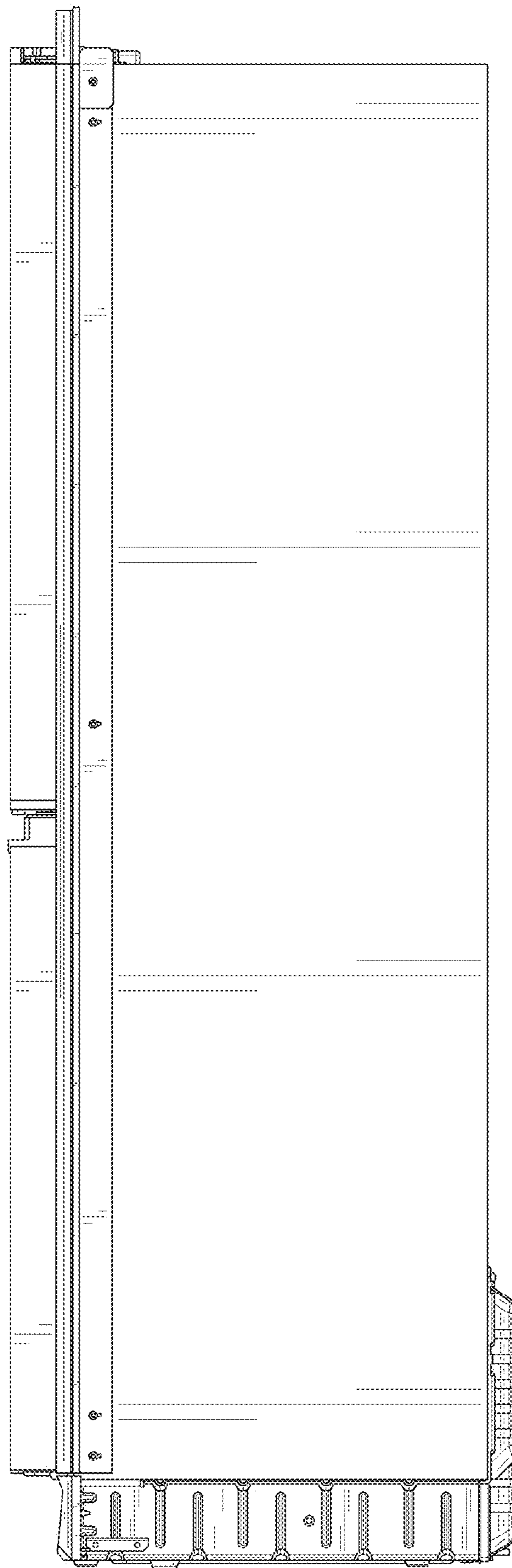

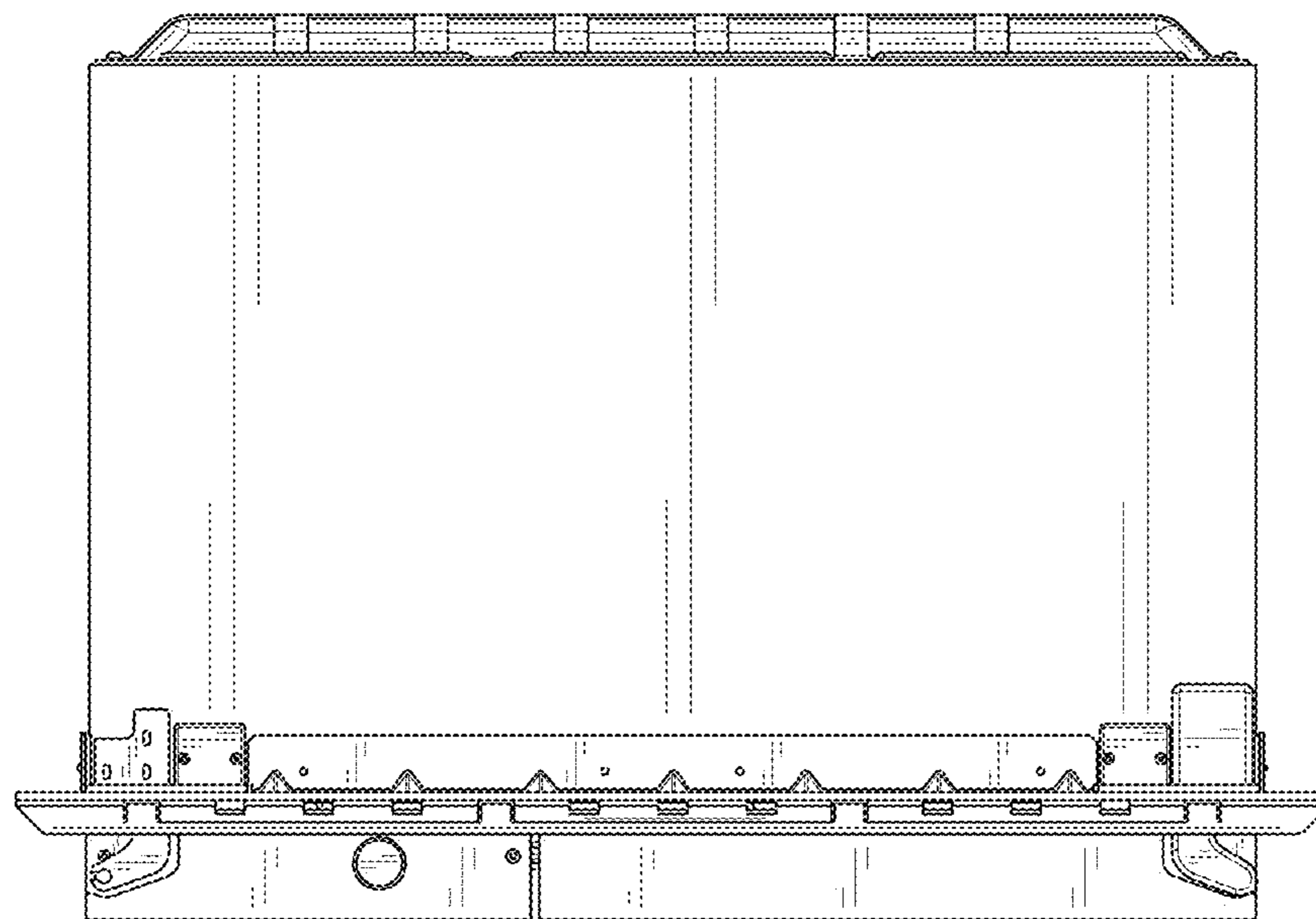

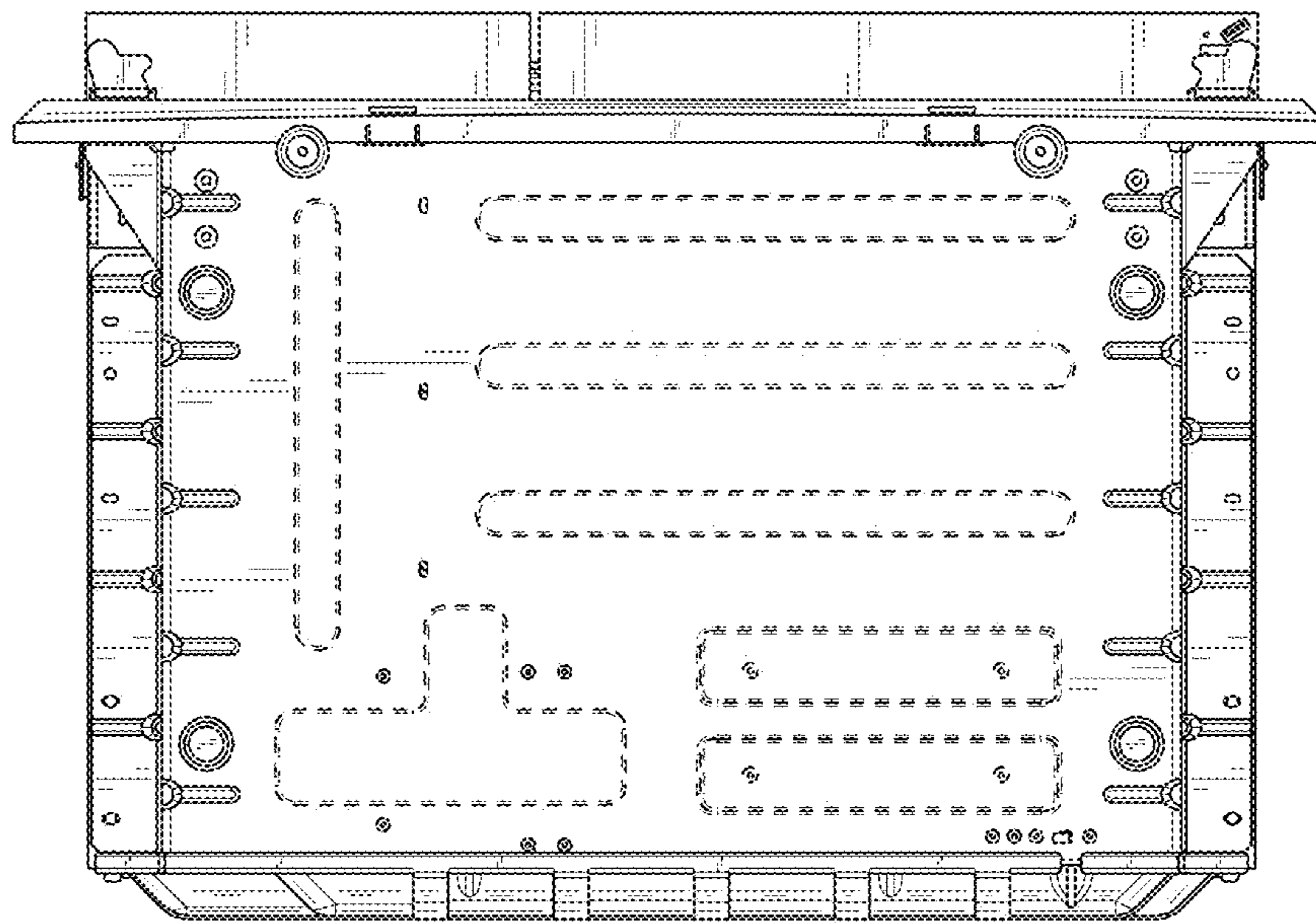
