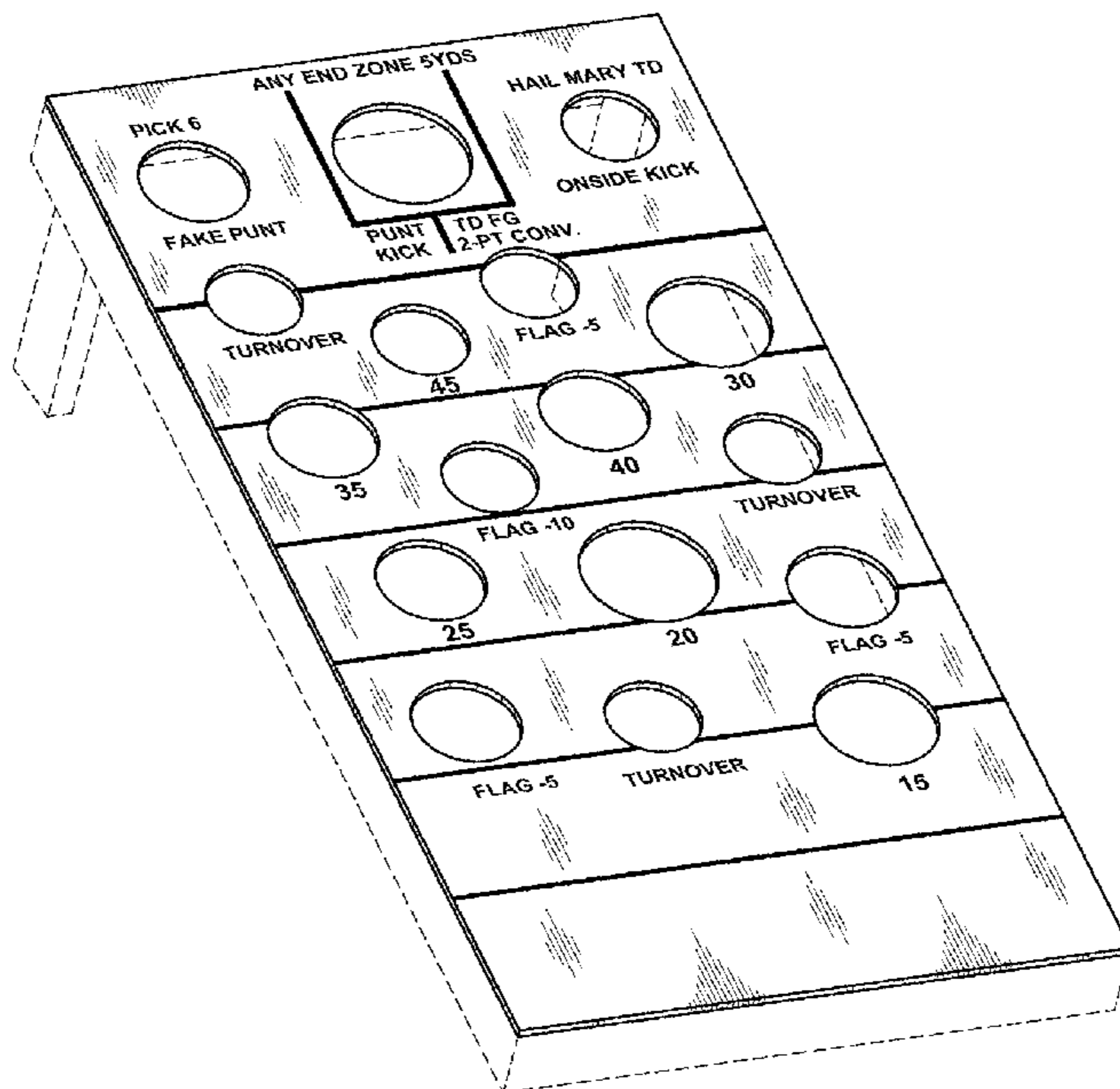
(57) **CLAIM**

The ornamental design for a football-based bean bag tossing game, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a football-based bean bag tossing game showing my new design; FIG. 2 is a bottom plan view of the football-based bean bag tossing game shown in FIG. 1; FIG. 3 is a left-side elevation view of the football-based bean bag tossing game shown in FIG. 1; FIG. 4 is a right-side elevation view of the football-based bean bag tossing game shown in FIG. 1; FIG. 5 is a front elevation view of the football-based bean bag tossing game shown in FIG. 1; FIG. 6 is a rear elevation view of the football-based bean bag tossing game shown in FIG. 1; and, FIG. 7 is a top perspective view of the football-based bean bag tossing game shown in FIG. 1. The dashed lines in the drawings depict environmental structure and forms no part of the claimed design.

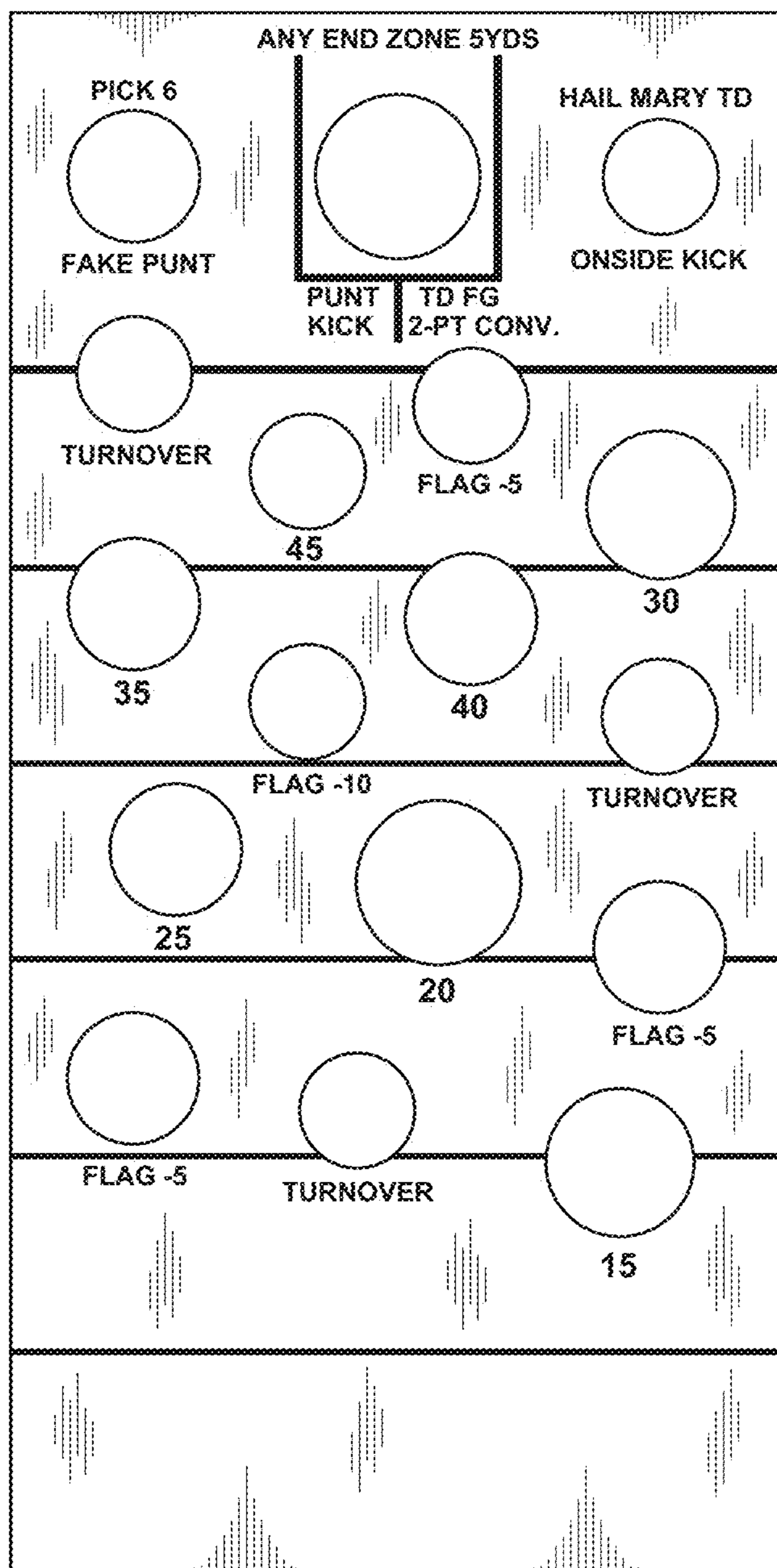

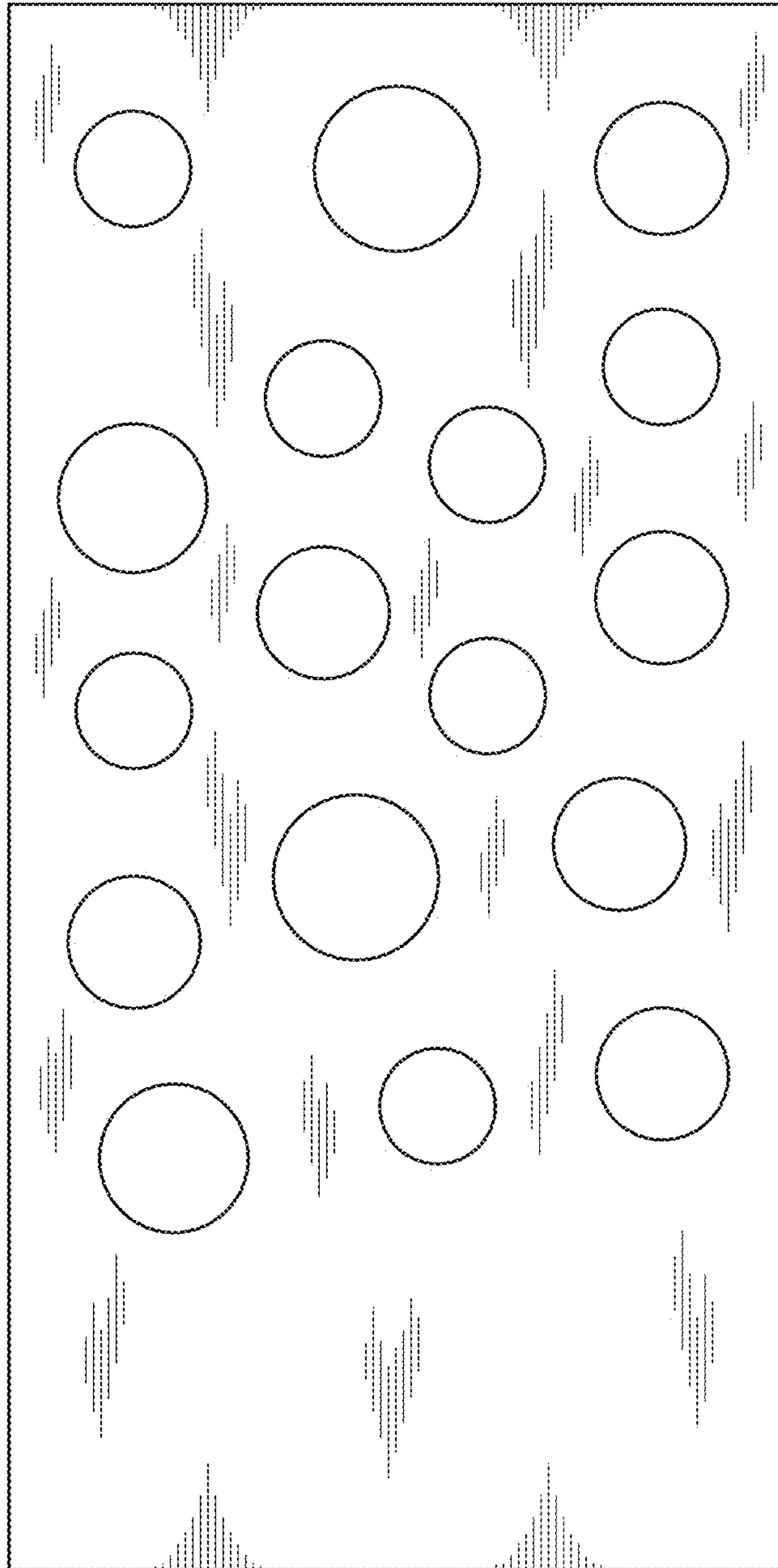

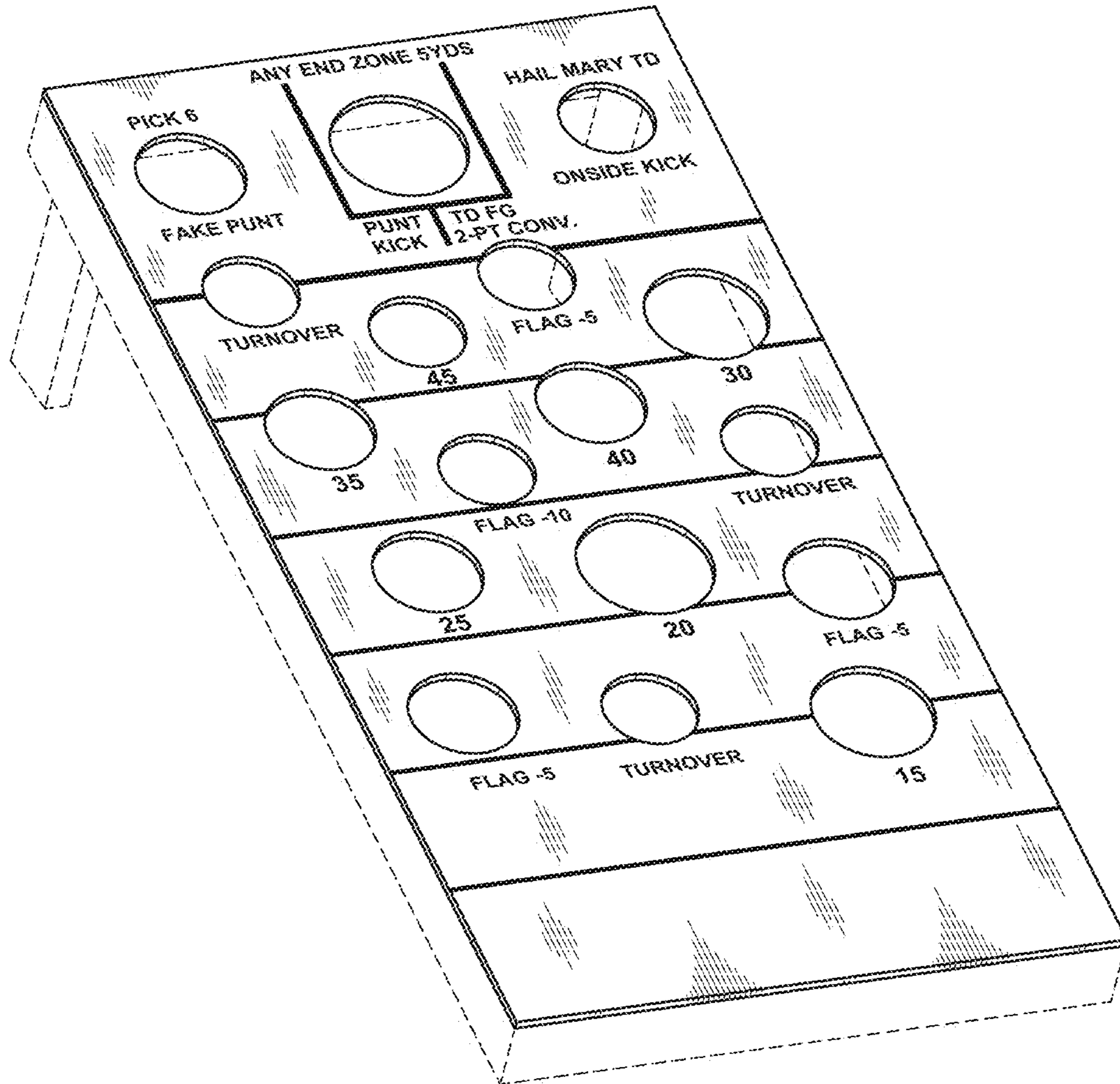
