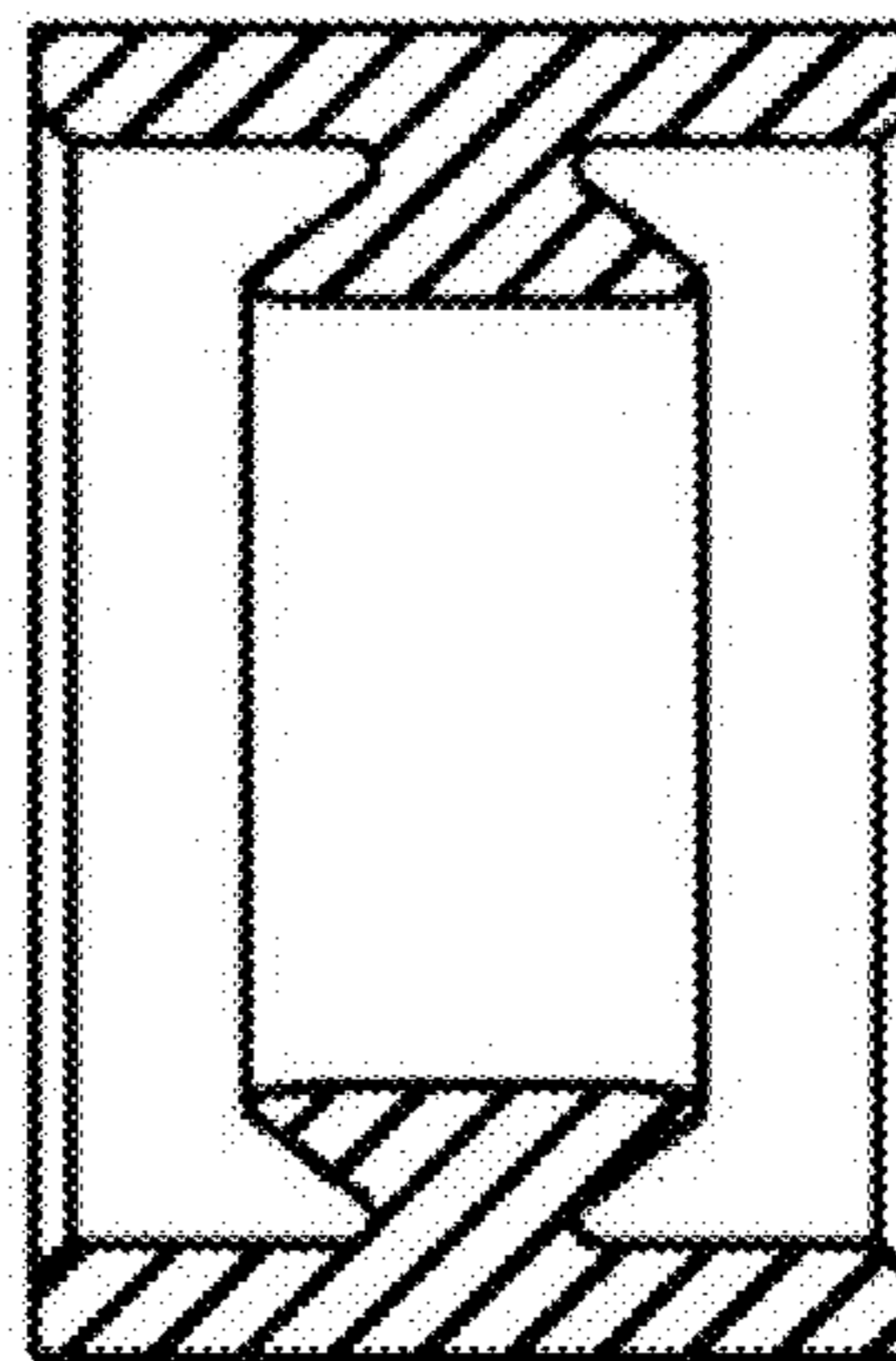
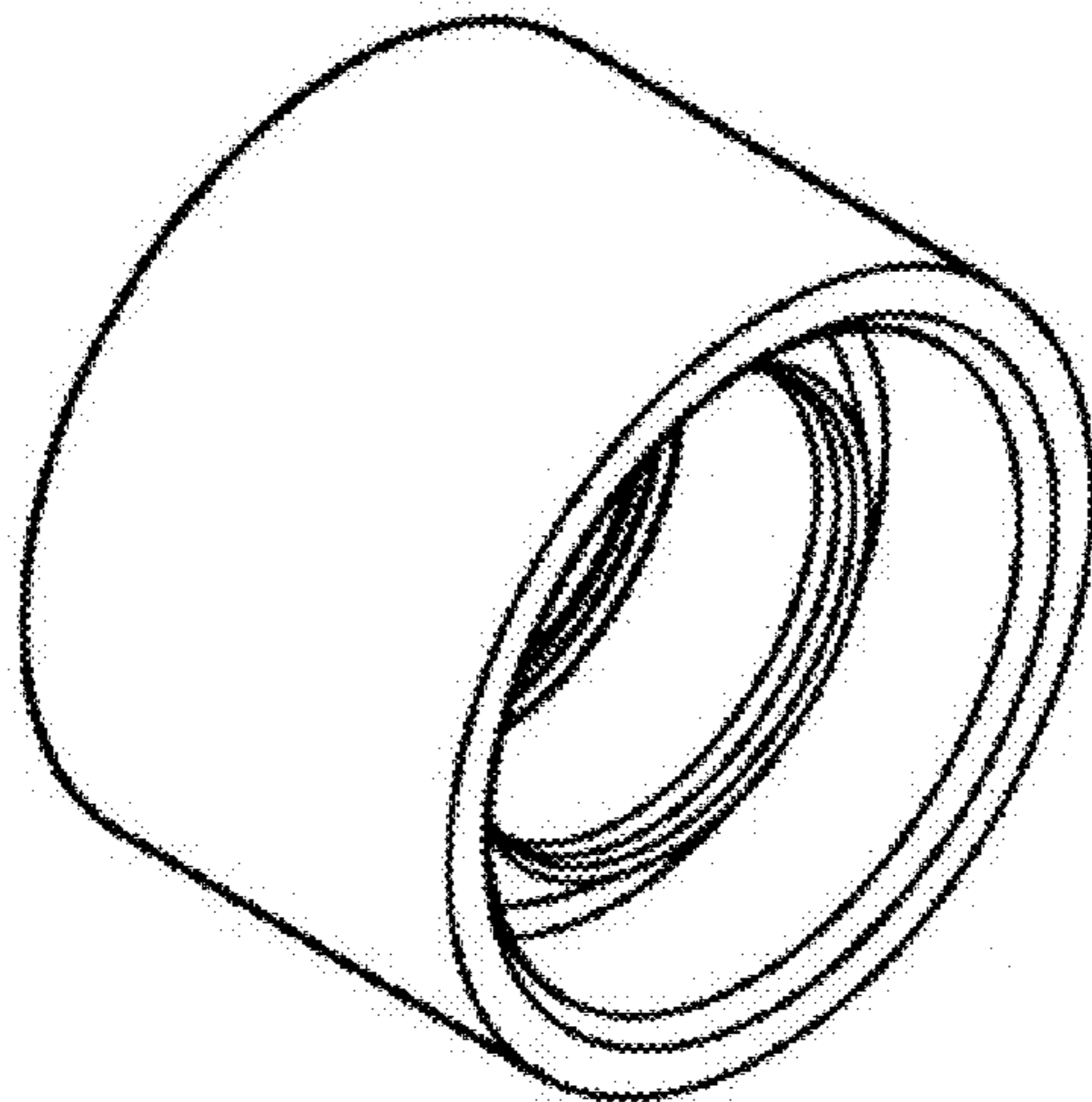
The ornamental design for a fluid gasket, as shown and described.

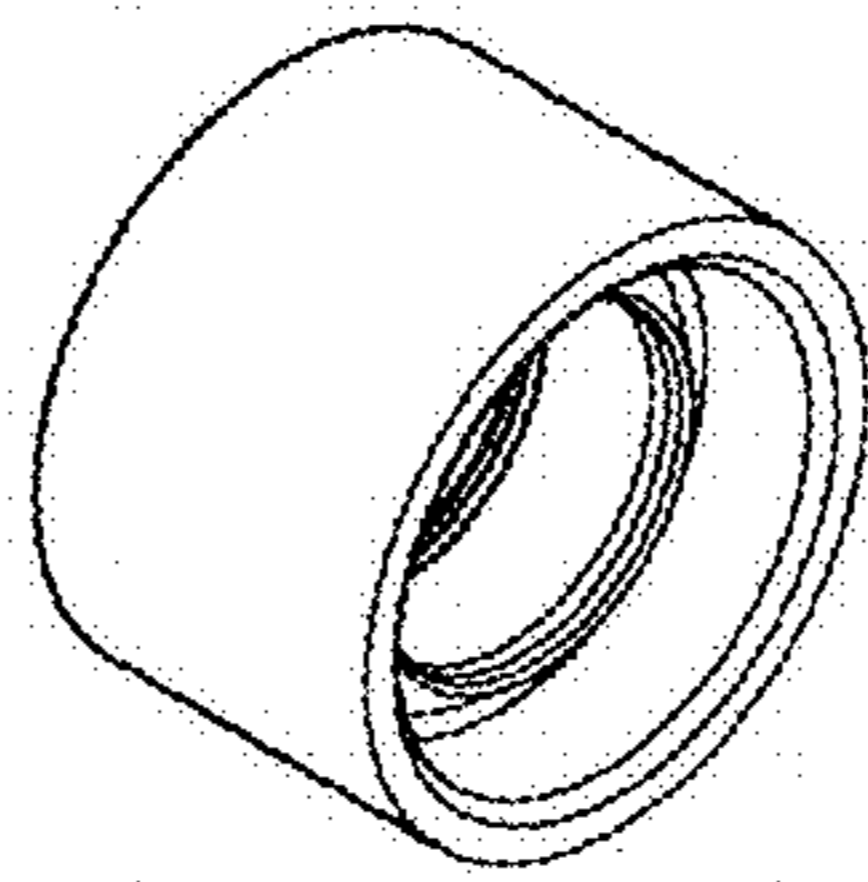
- 1. Fluid gasket

Rear view is omitted because it is identical with the front view; bottom view is omitted because it is identical with the top view; right side view is omitted because it is identical with the left side view.

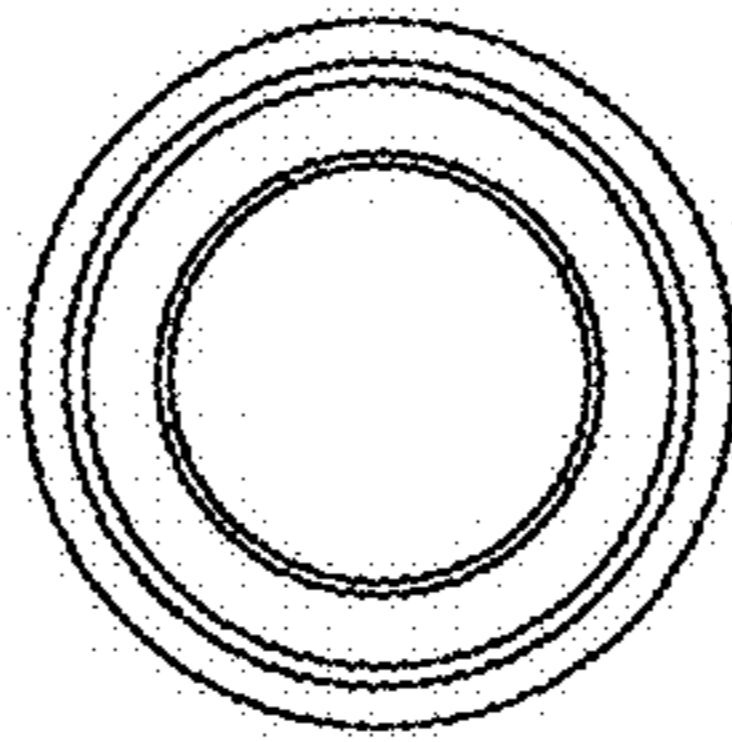

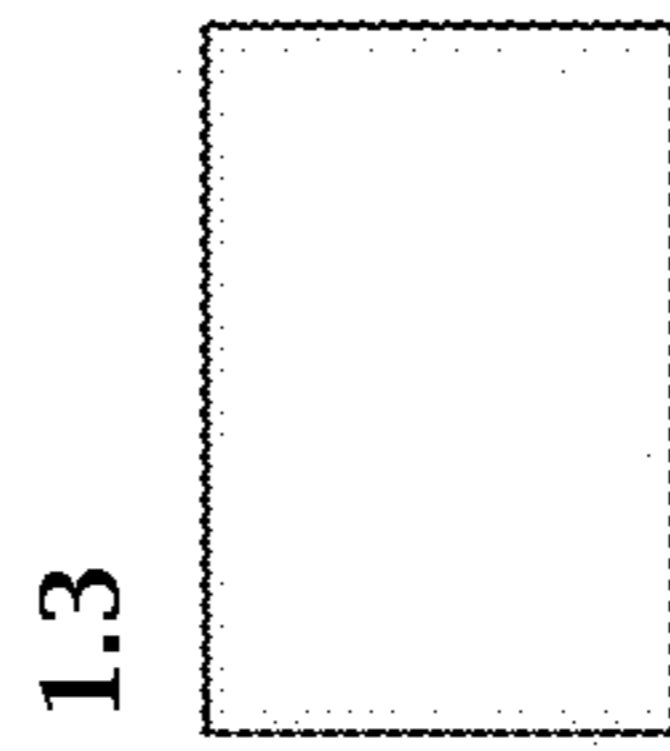

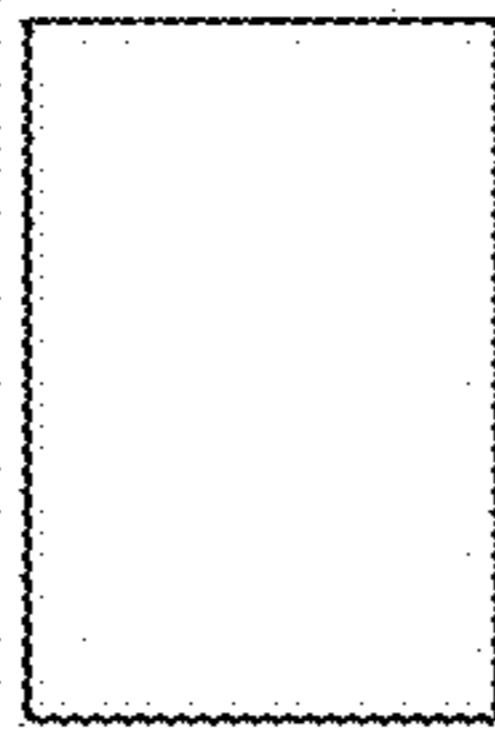
