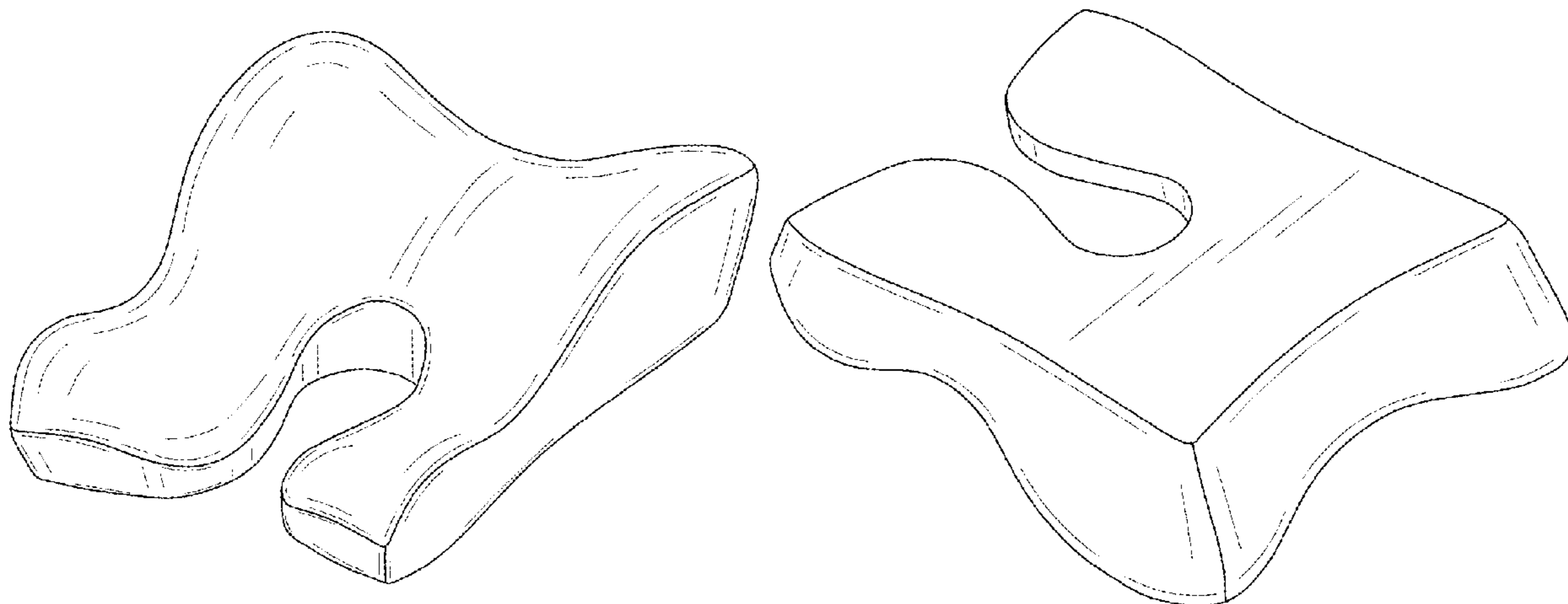

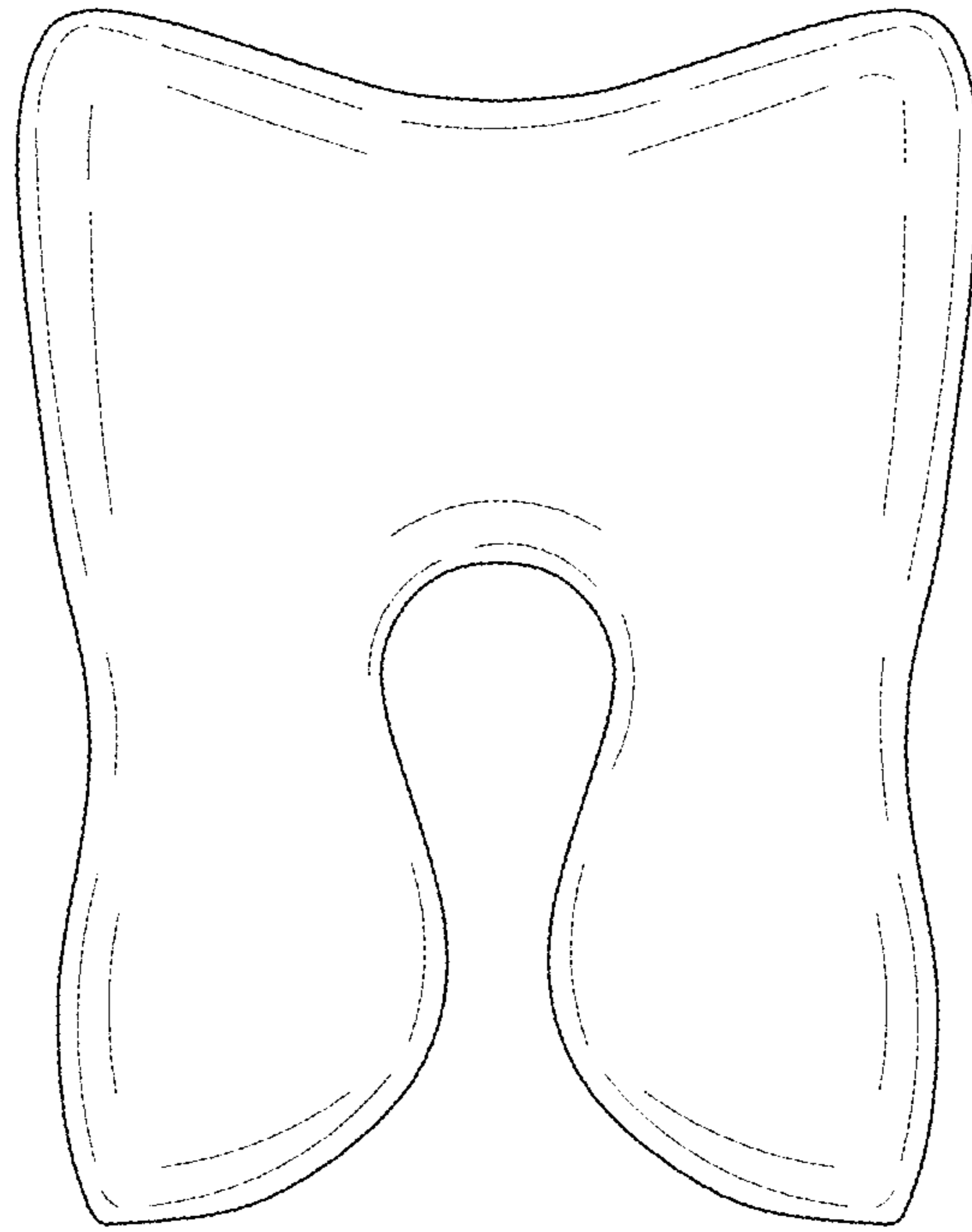
The ornamental design for a waist cushion, as shown and described.

**DESCRIPTION**

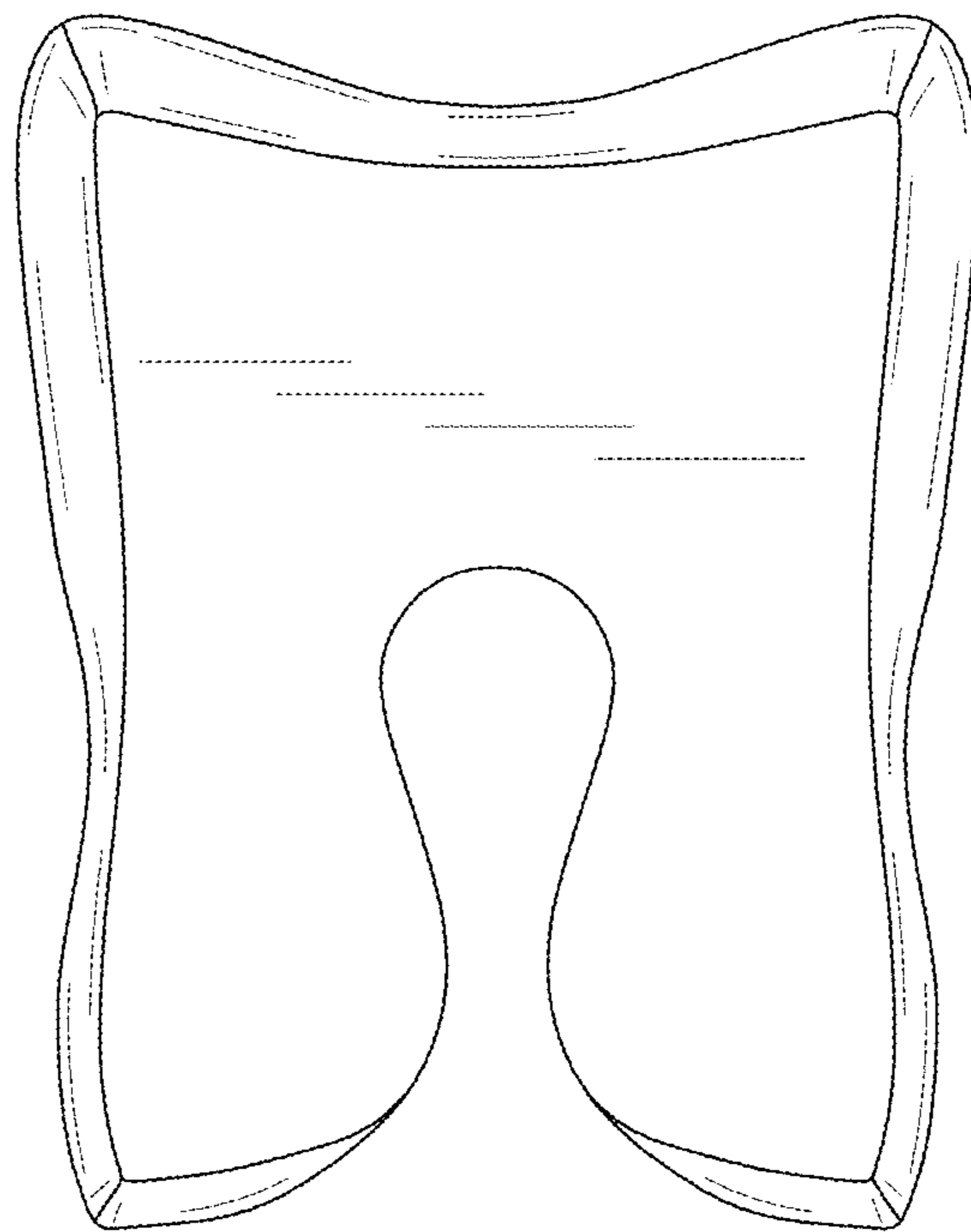
FIG. 1 is a front view of the waist cushion showing my new design;

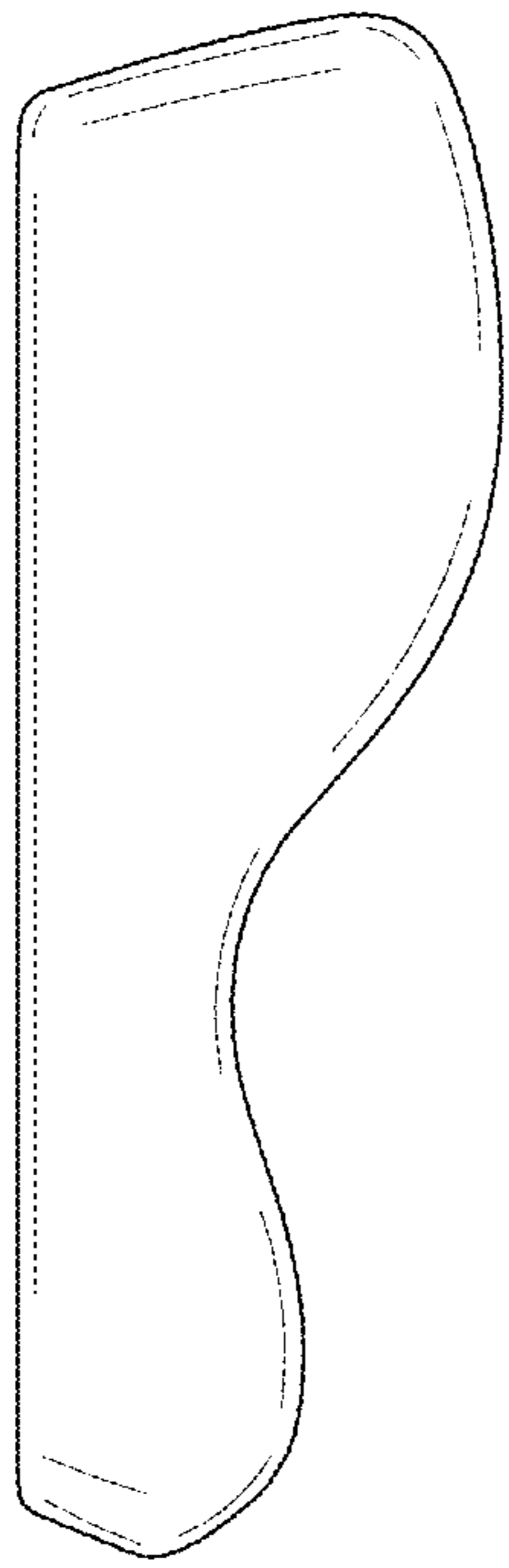




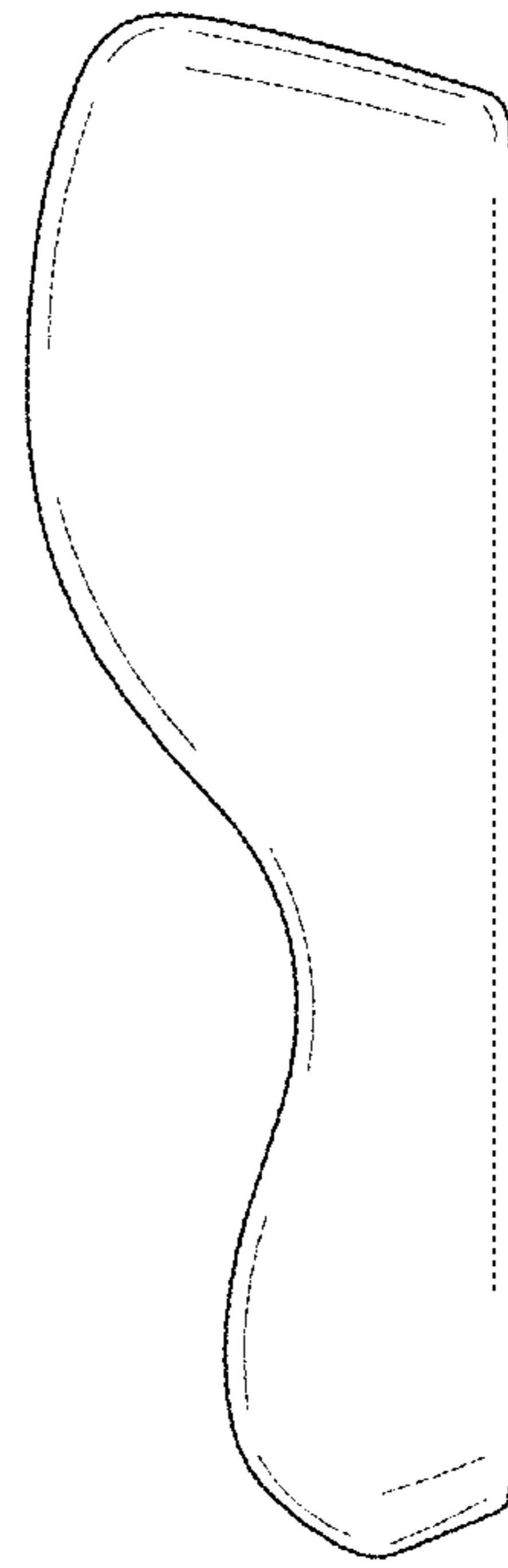

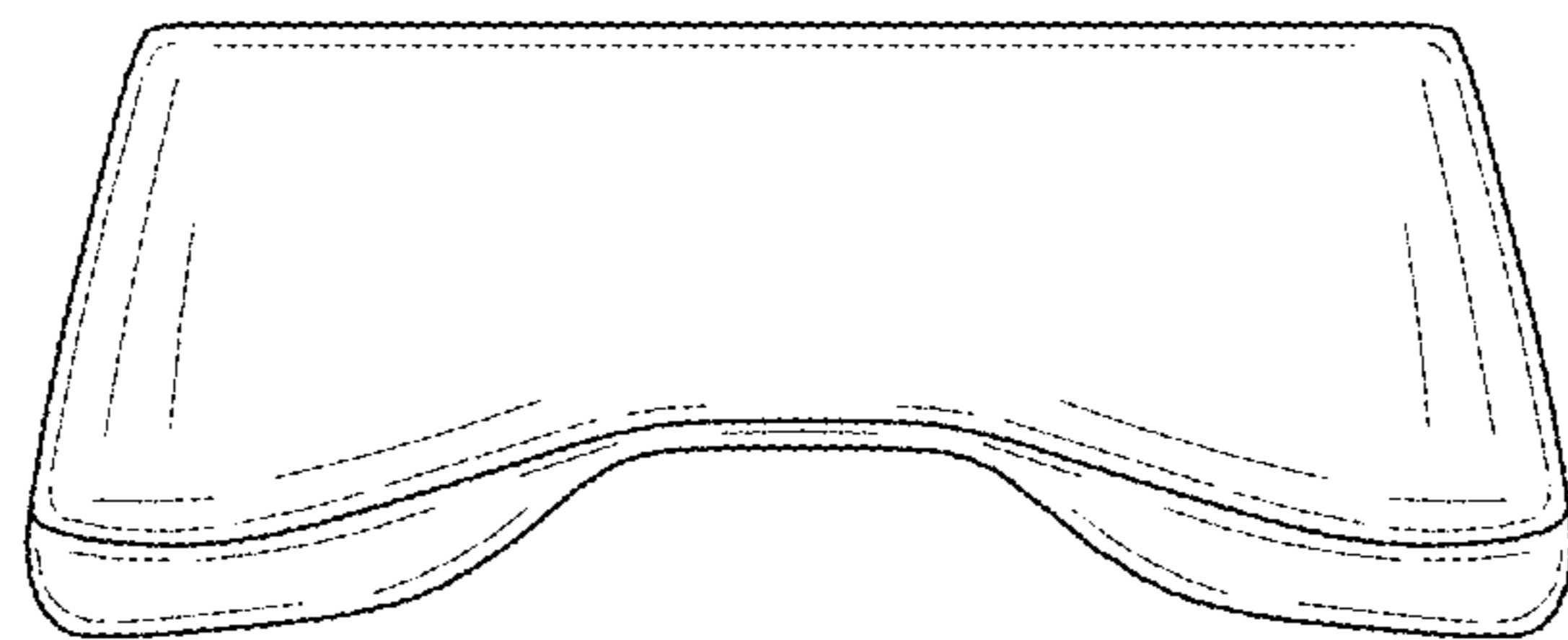

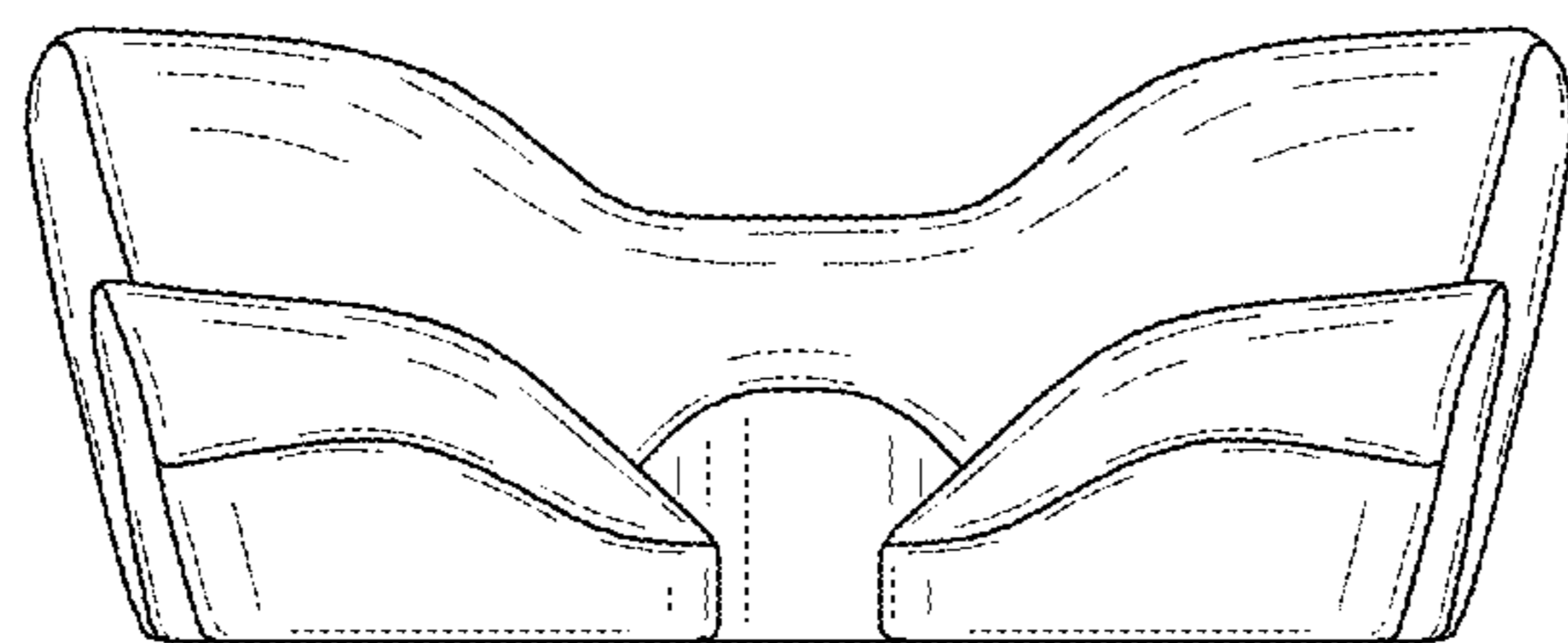

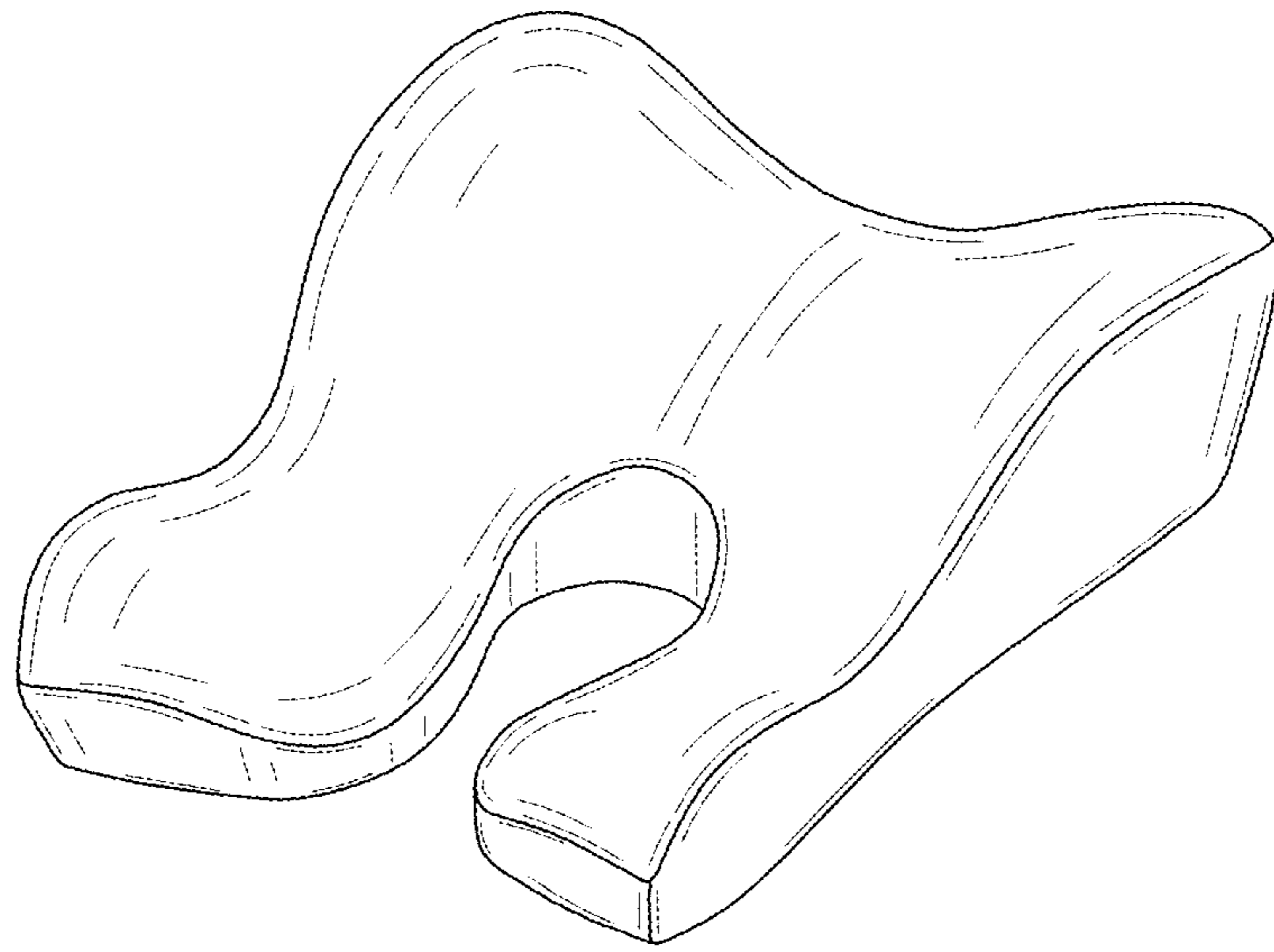

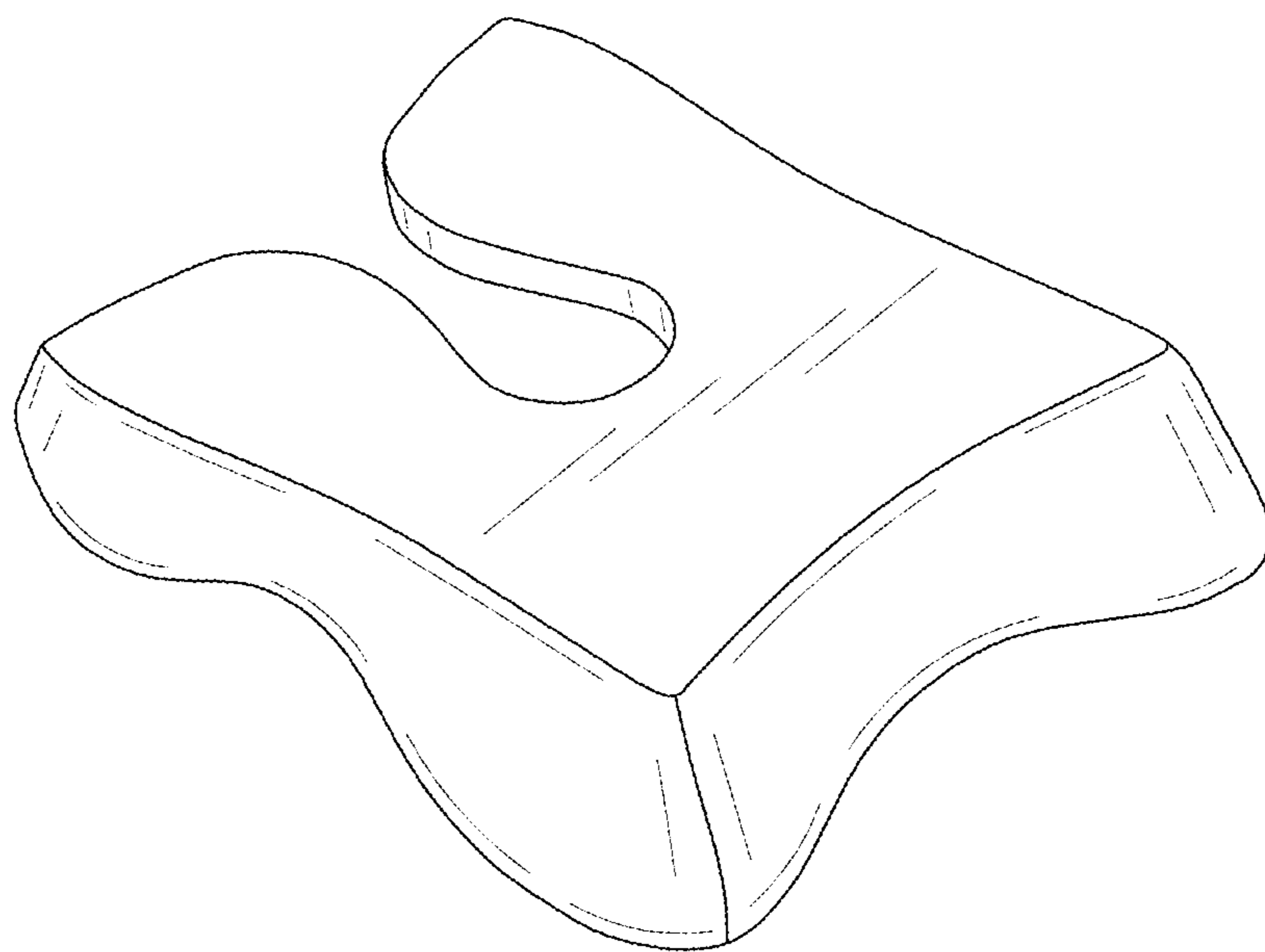
