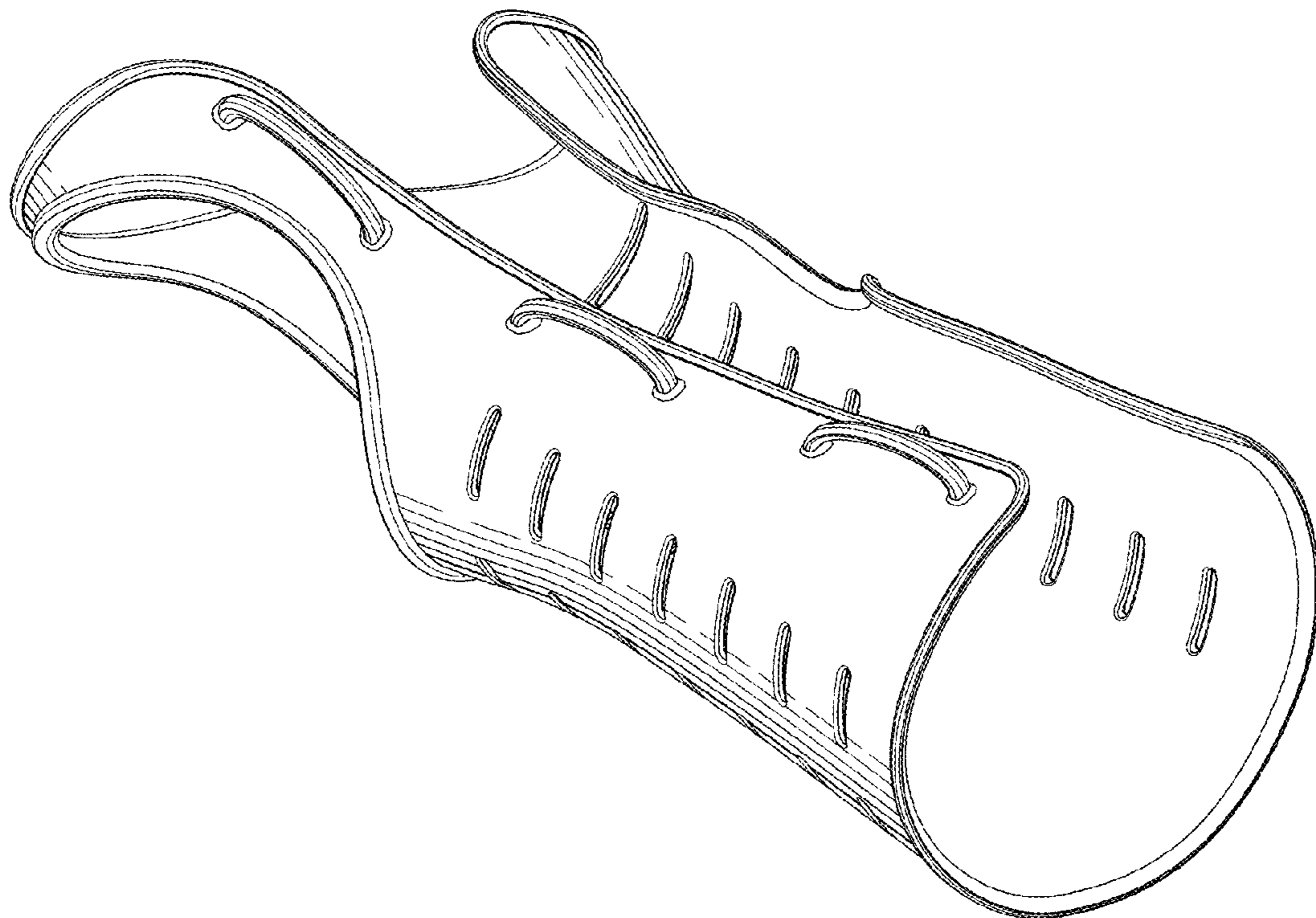
The ornamental design for a wrist splint, as shown and described.

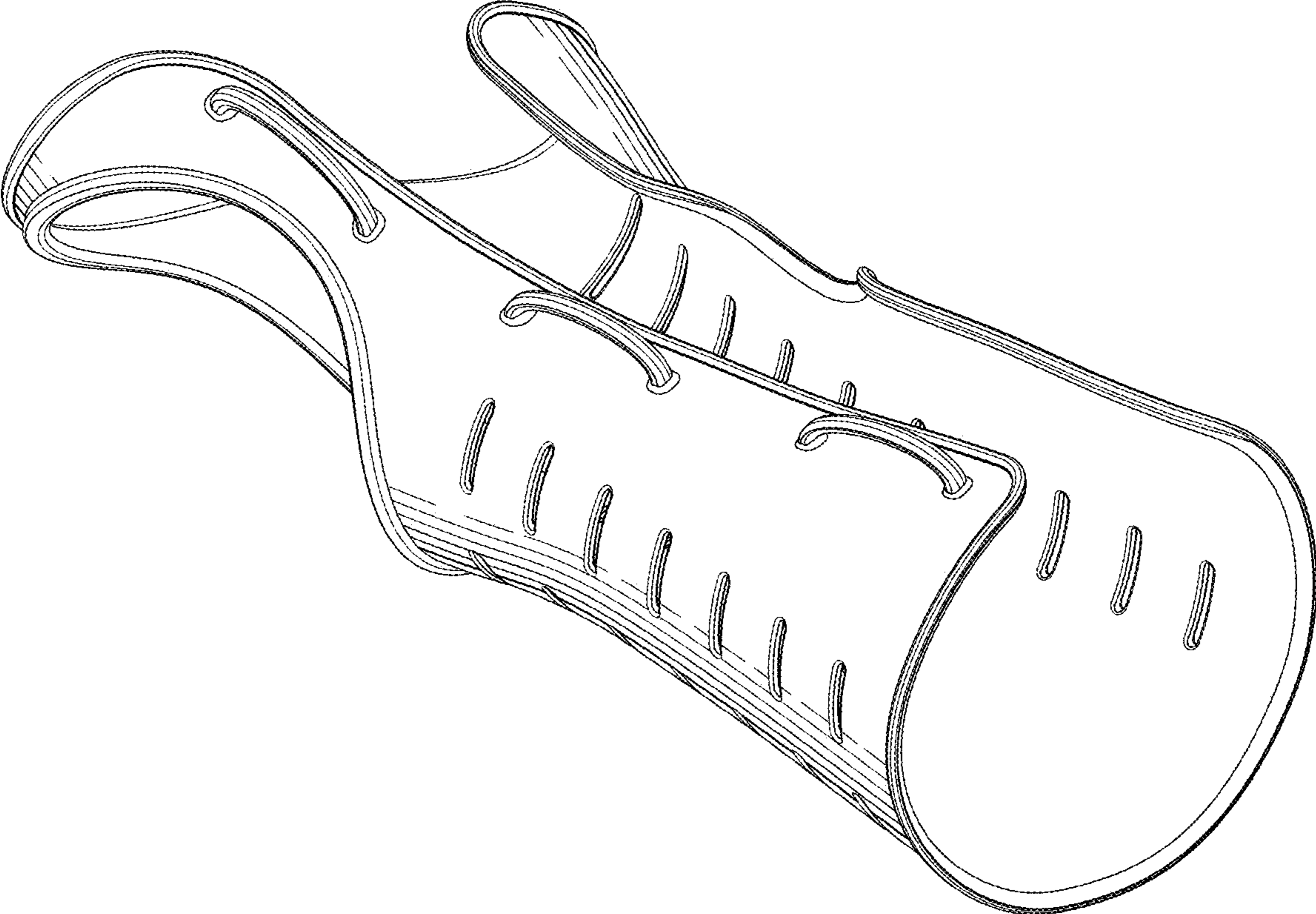

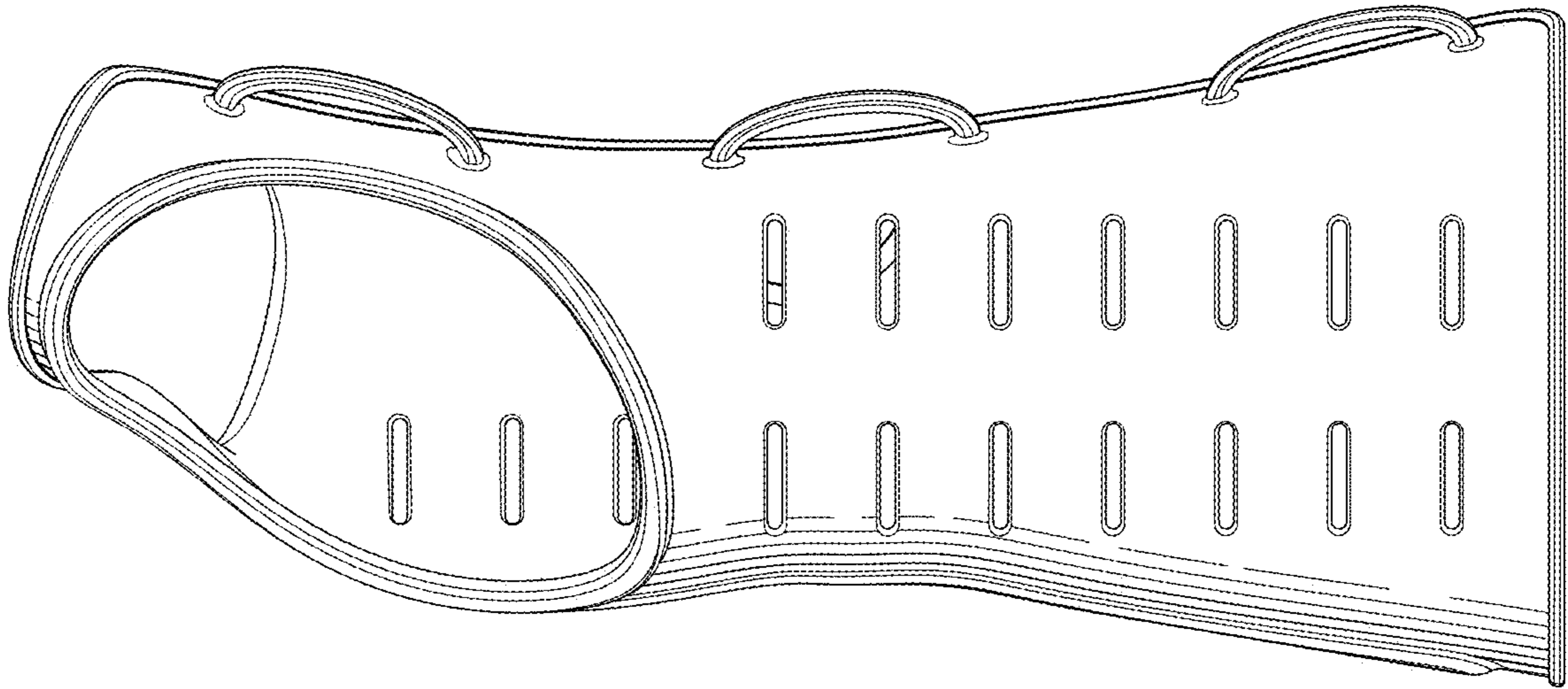

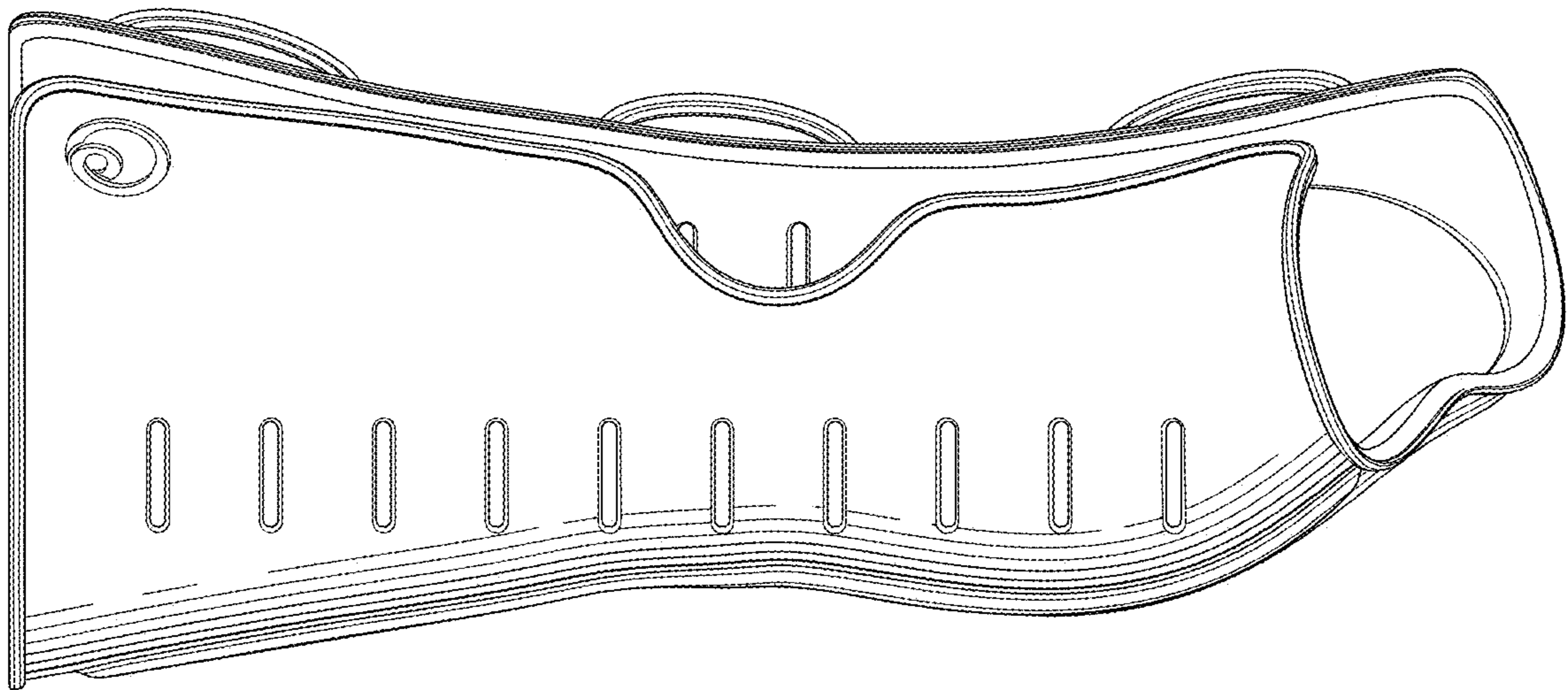

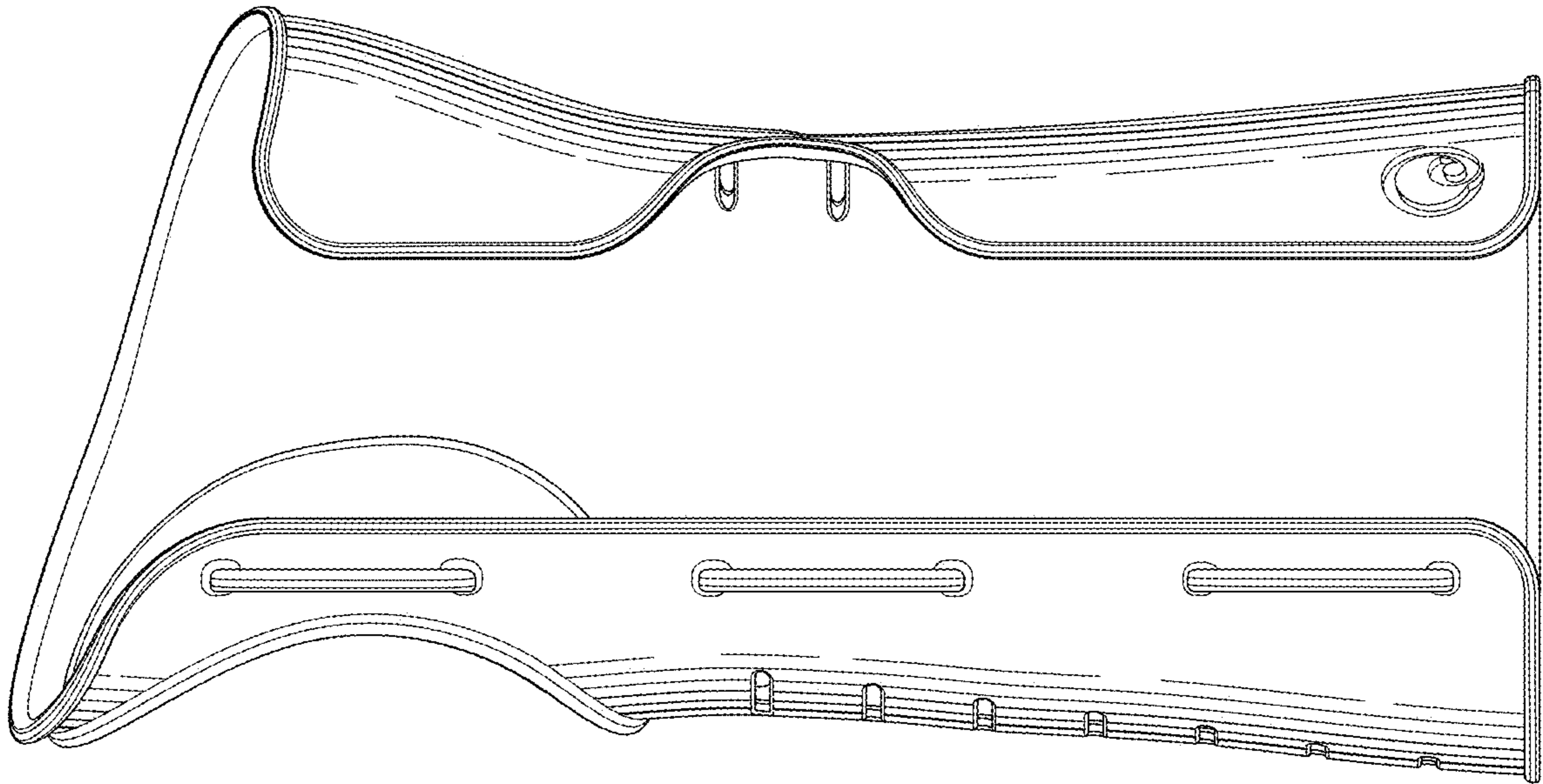

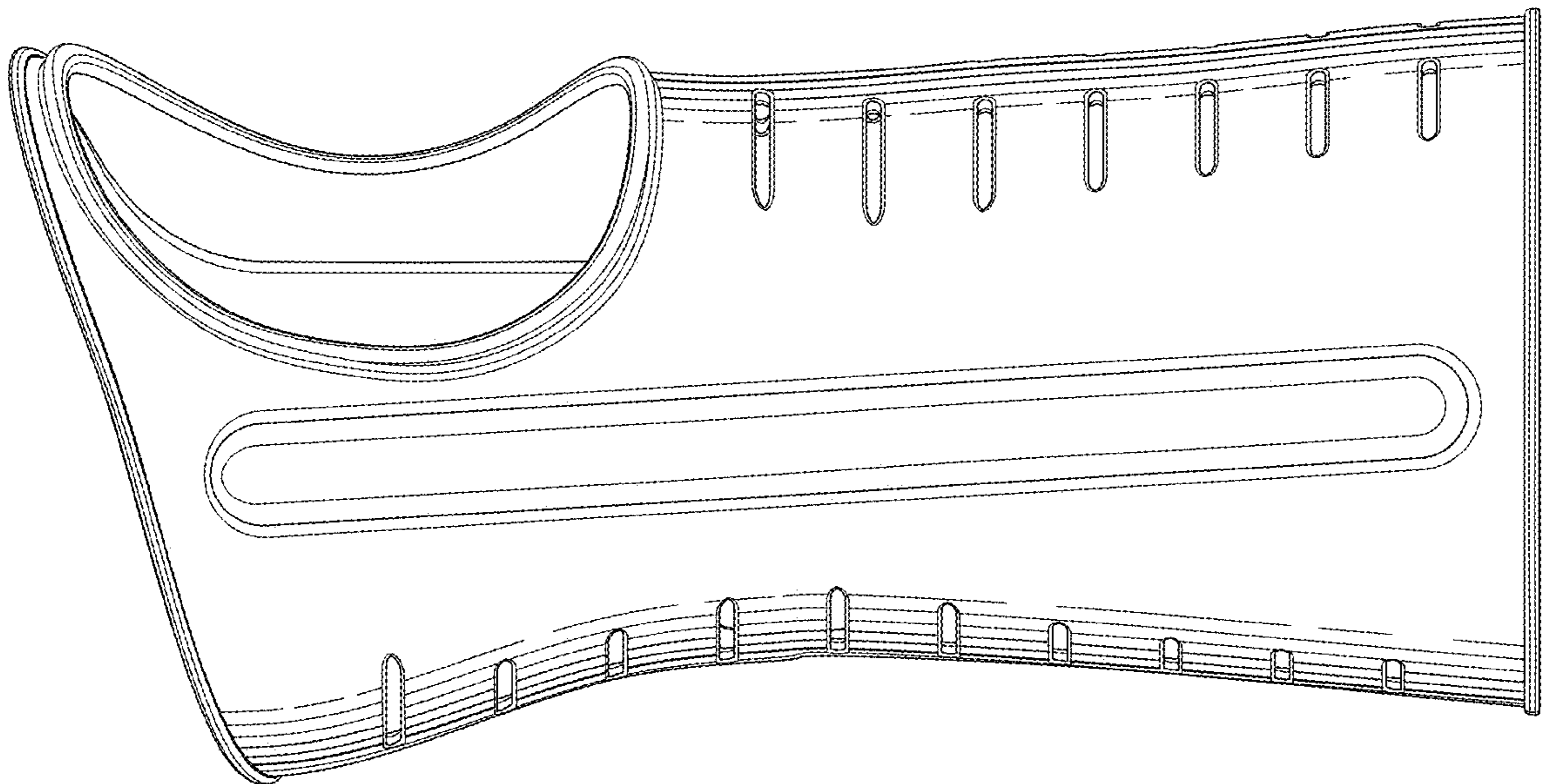

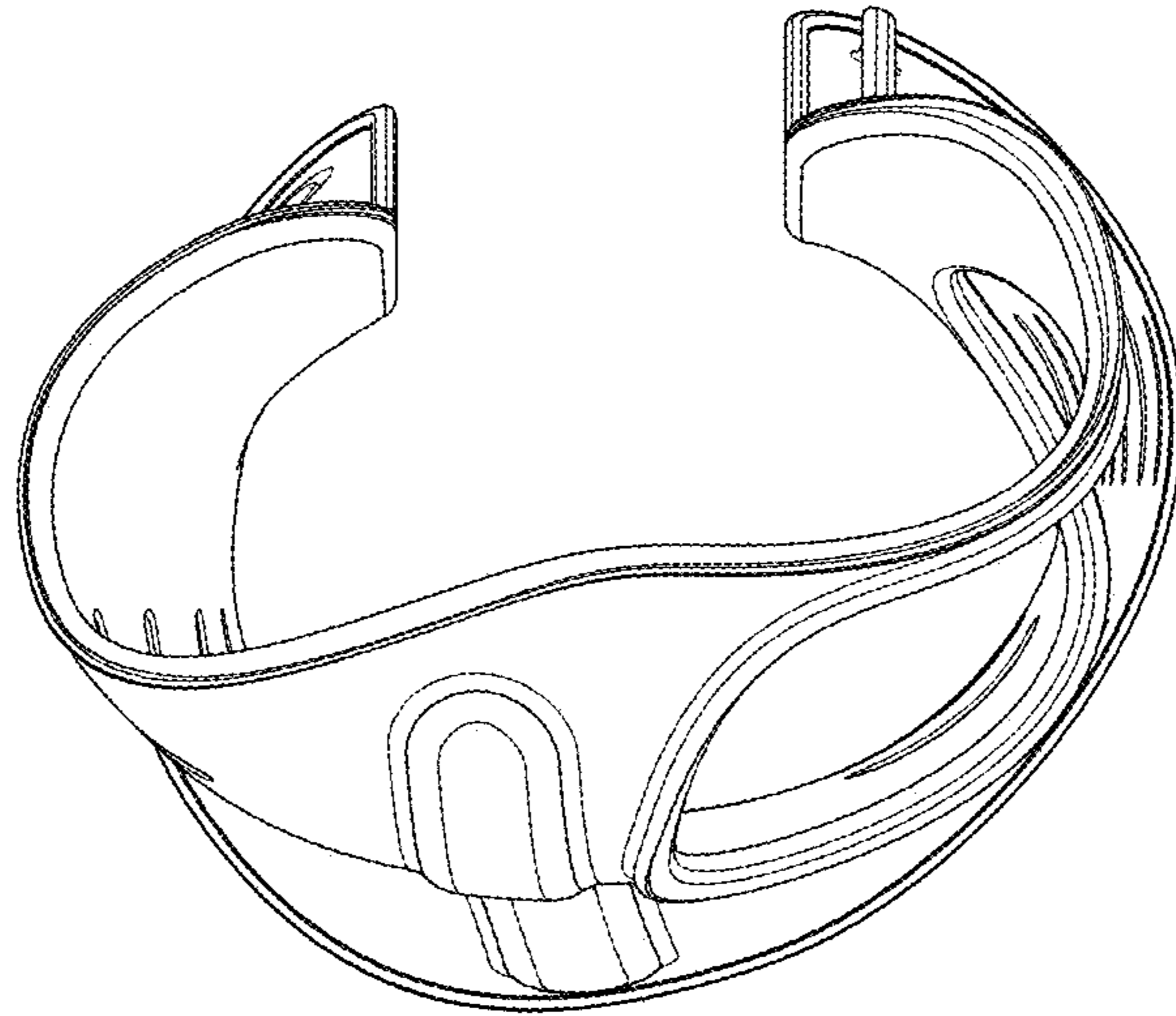

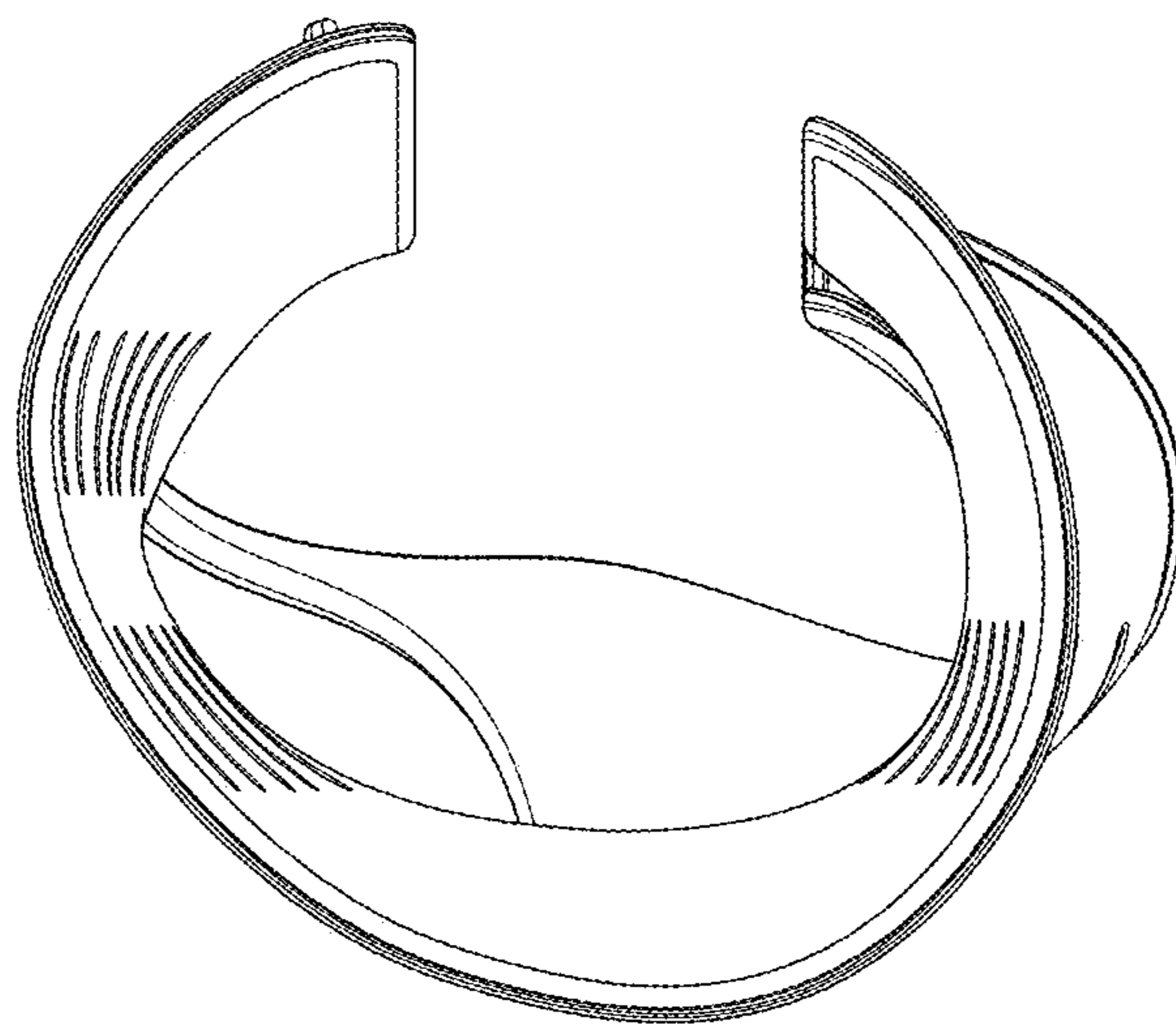
