1.6 : is a perspective view thereof;

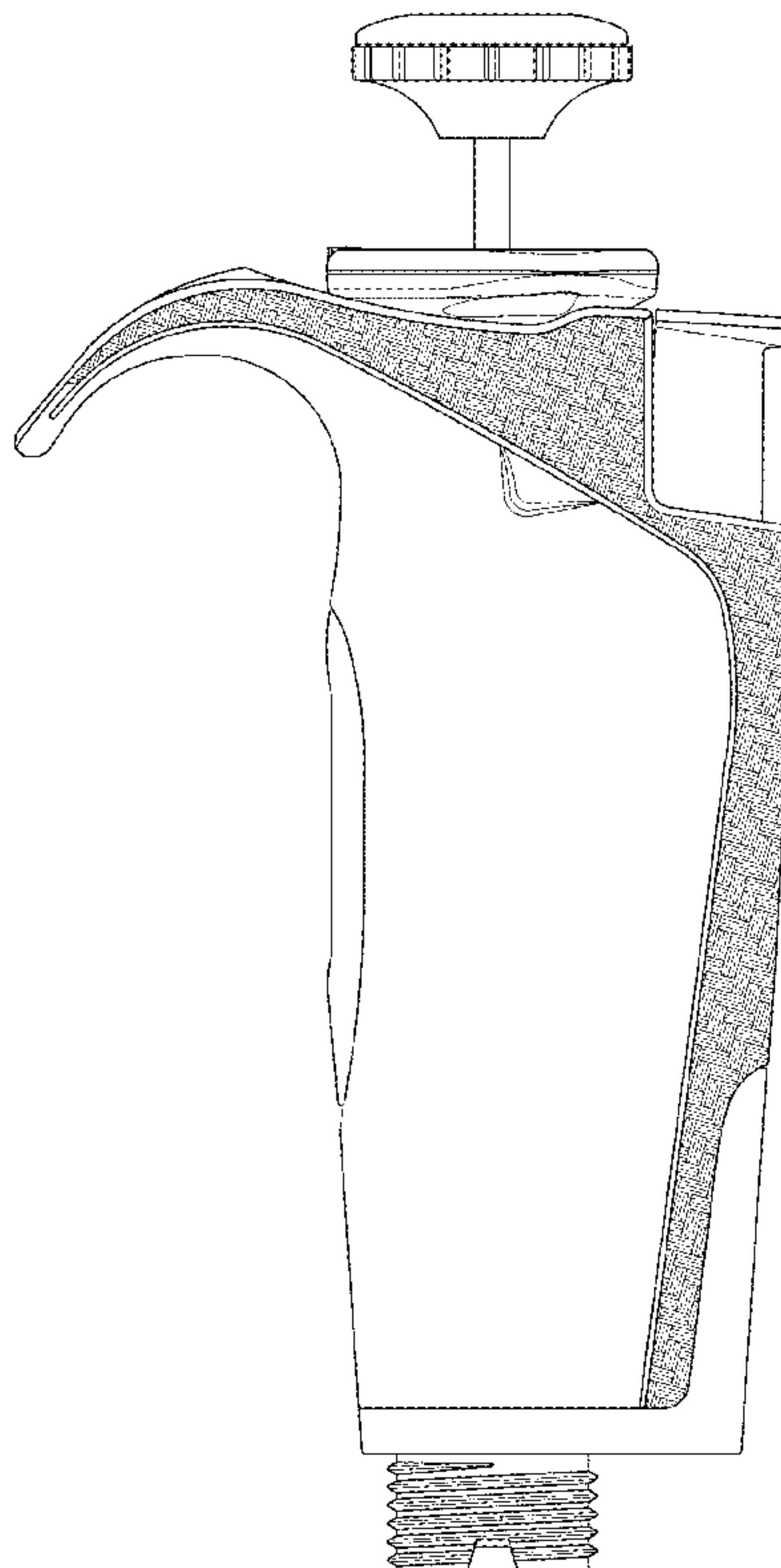
1.7 : is a top view thereof;

1.8 : is a right view thereof; and

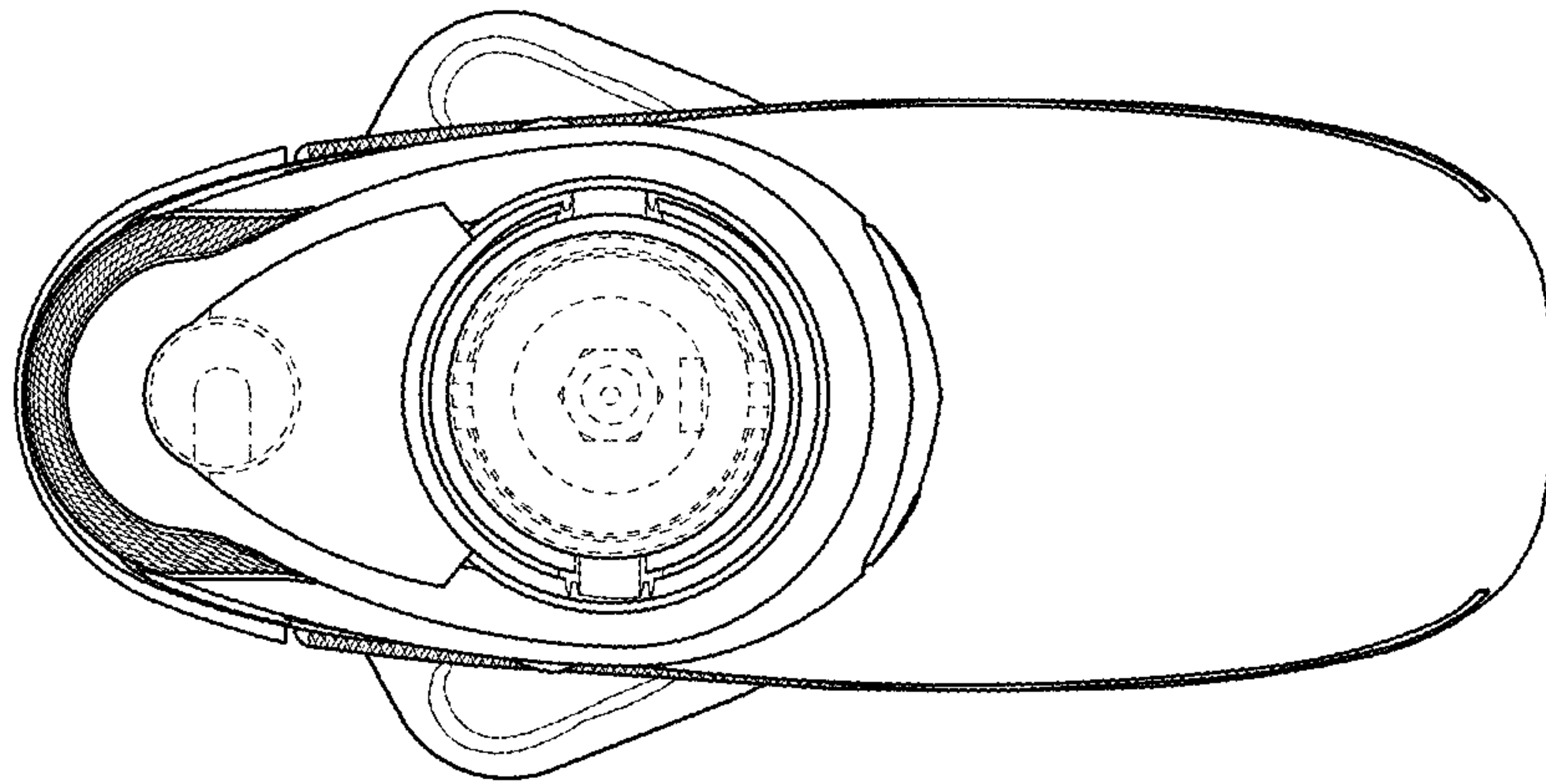
1.9 : is an enlarged view thereof.

The portions of the “pipette” shown in broken lines form no part of the claimed design.

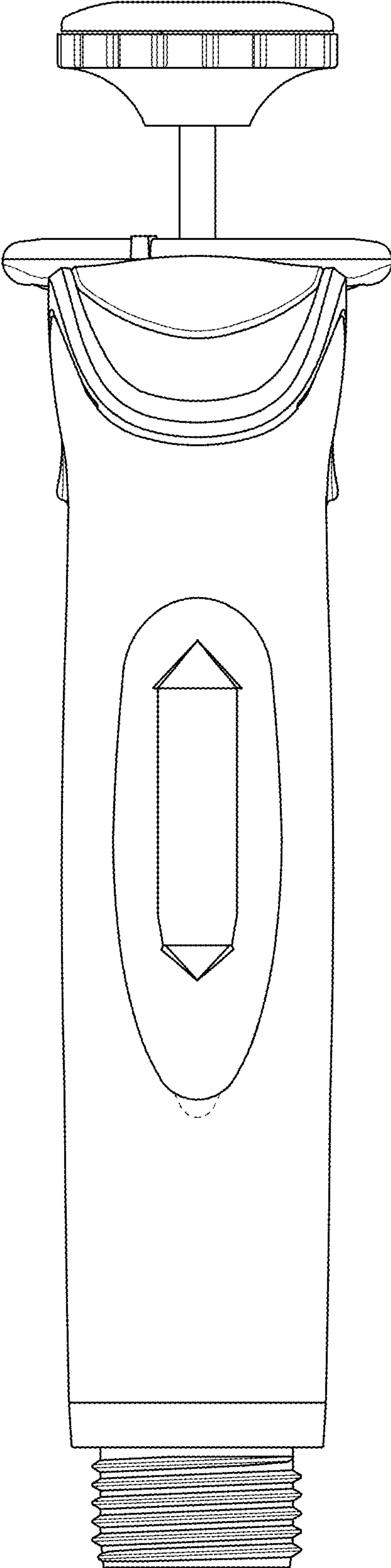

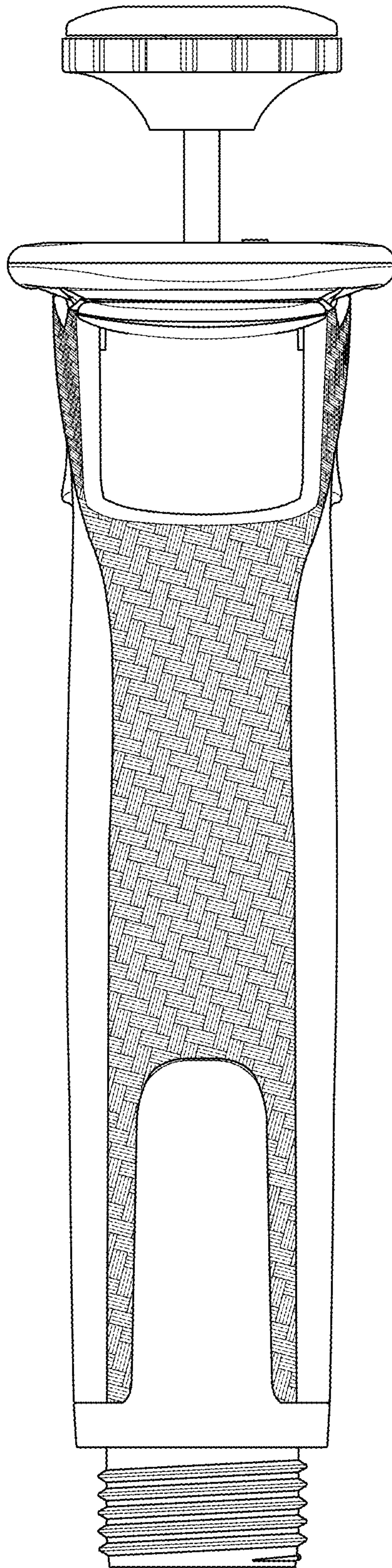

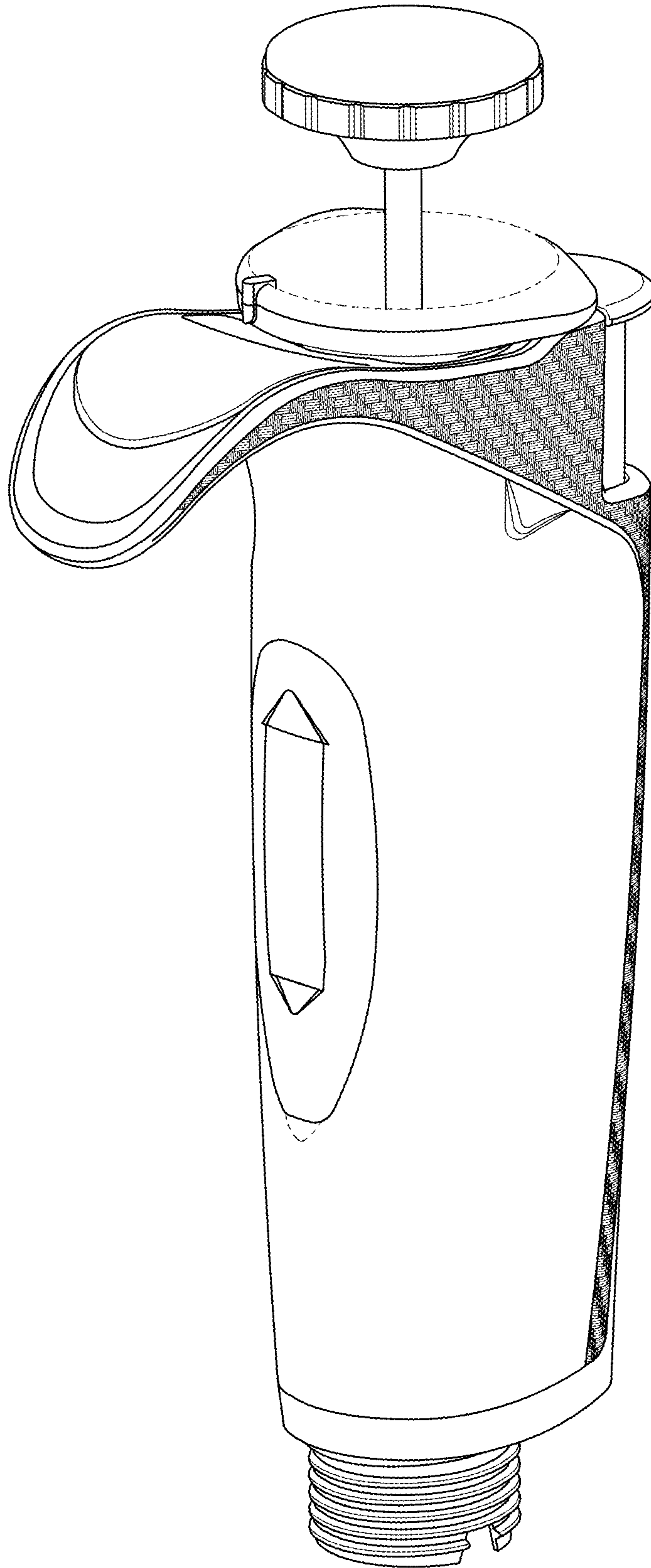

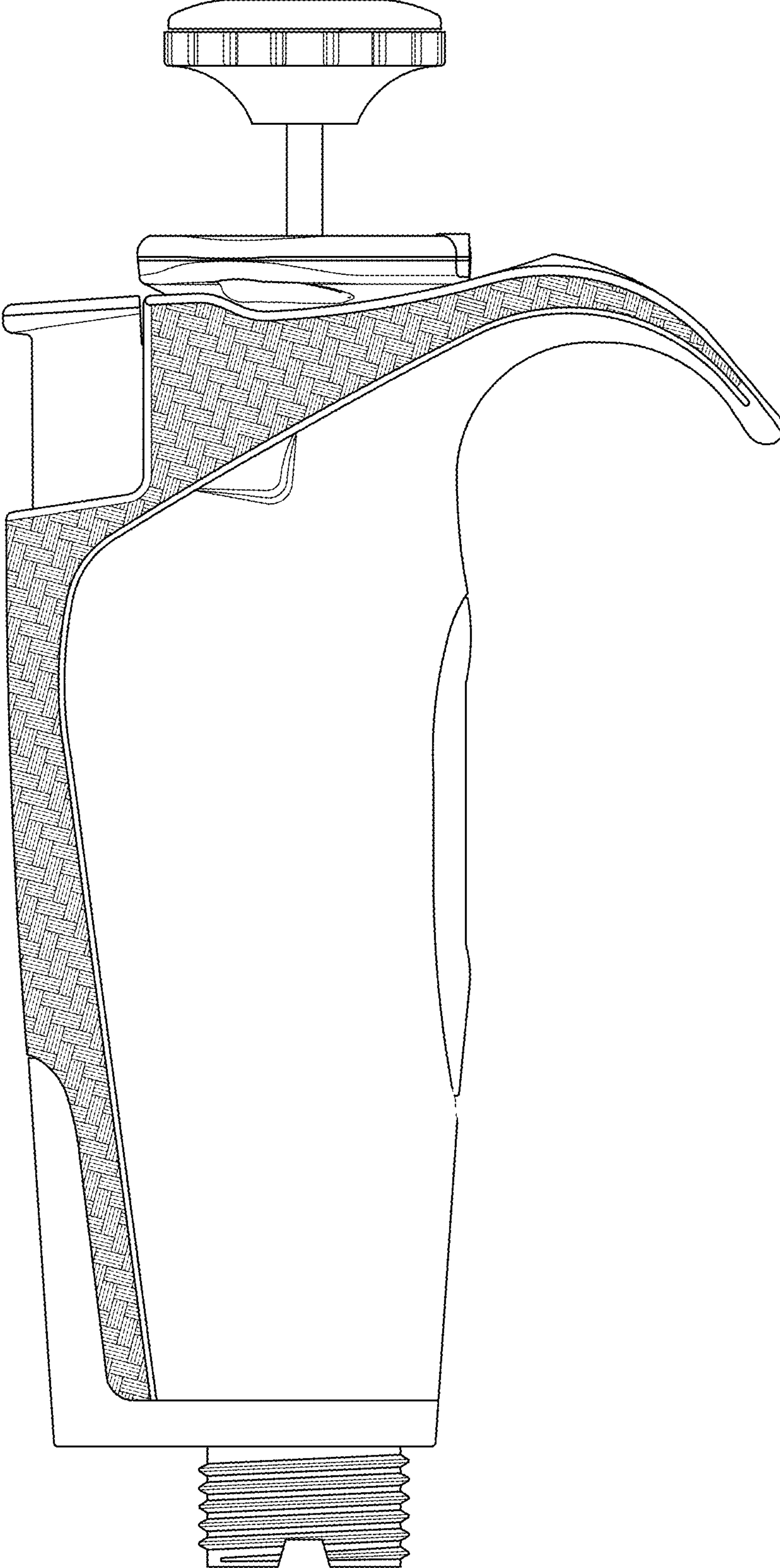

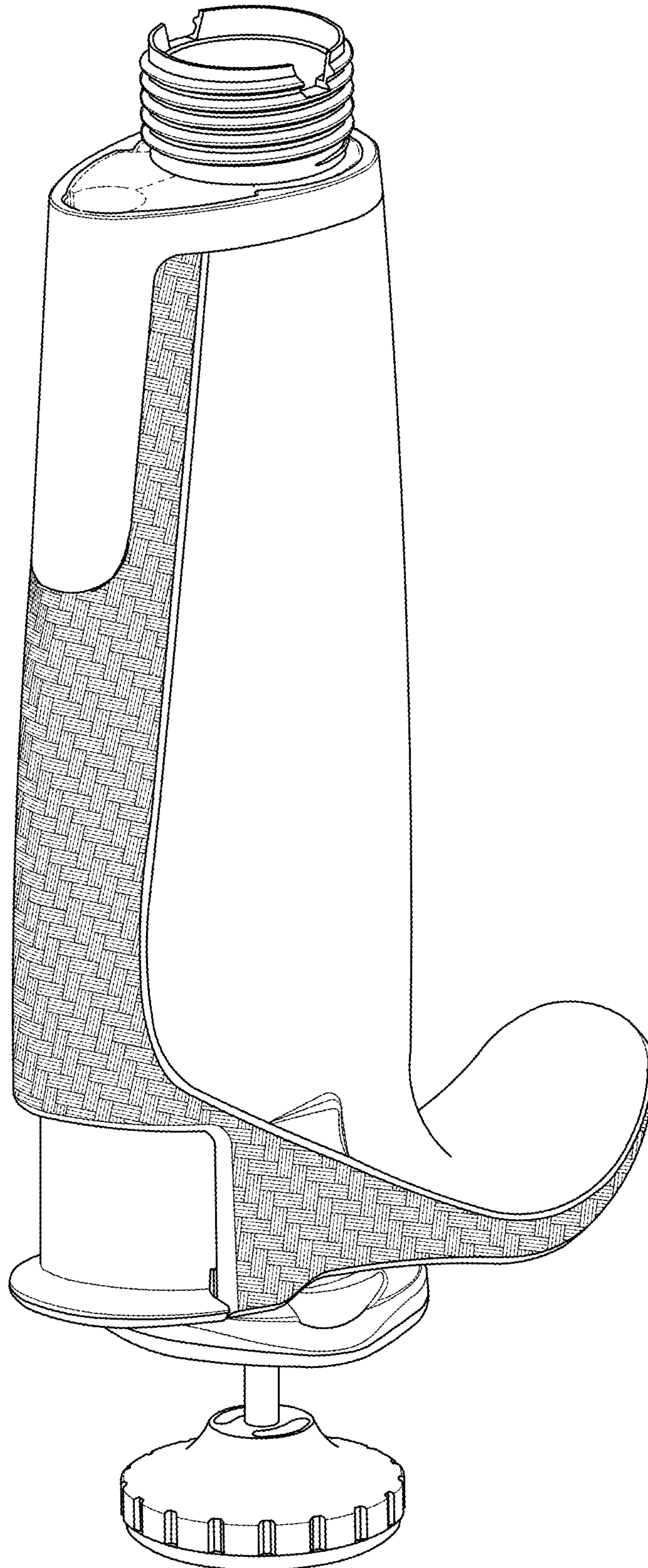

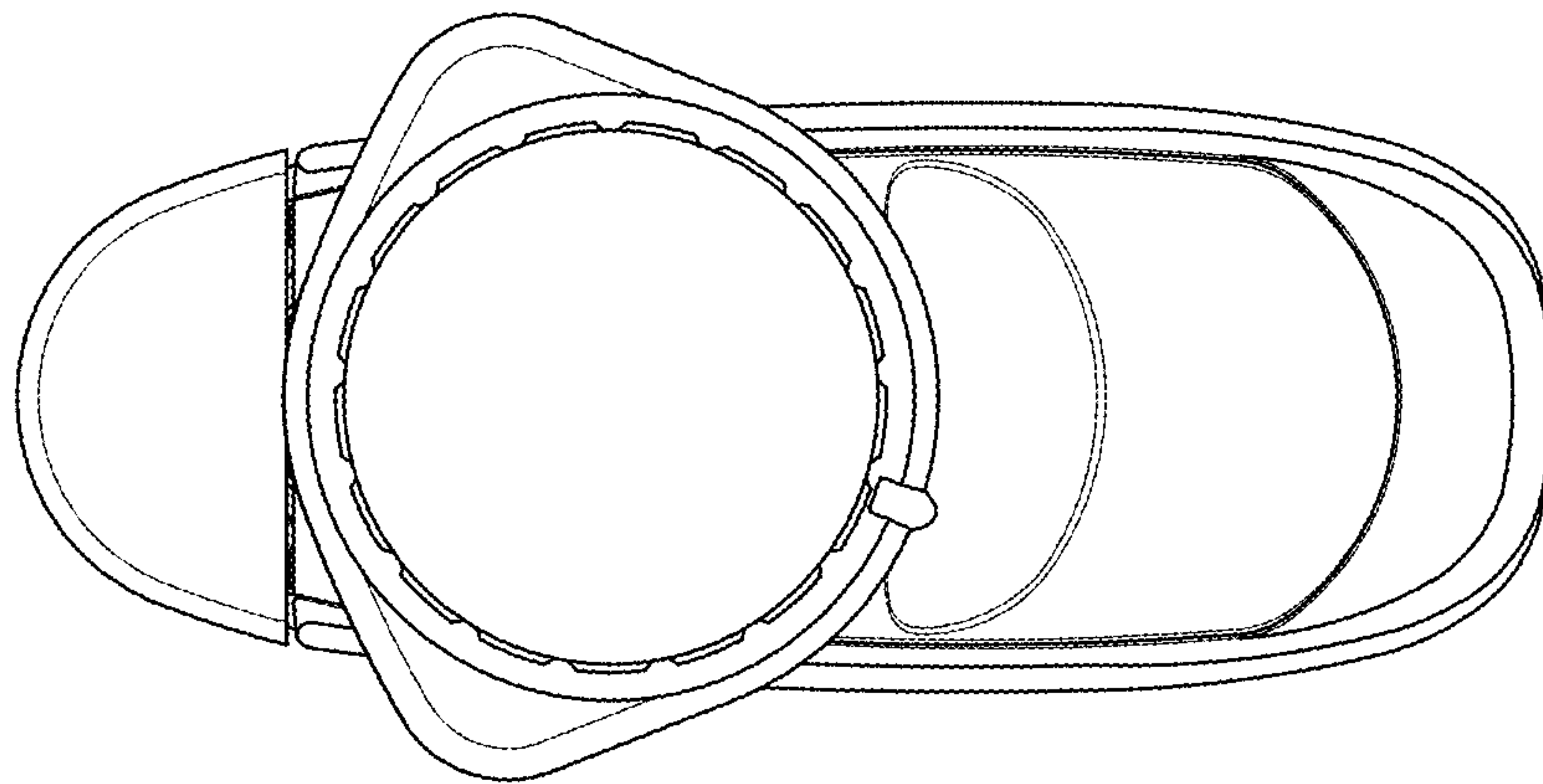

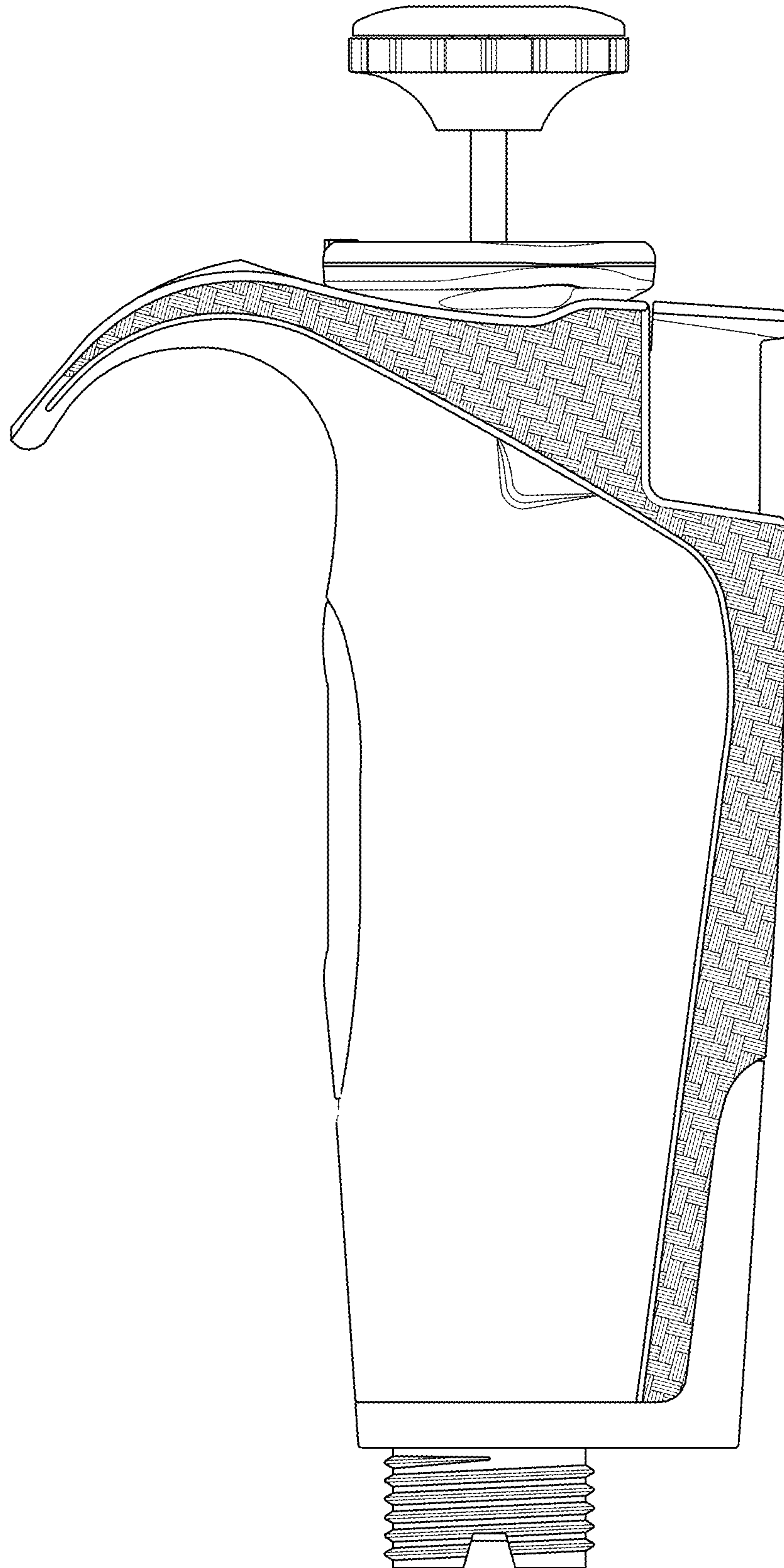
