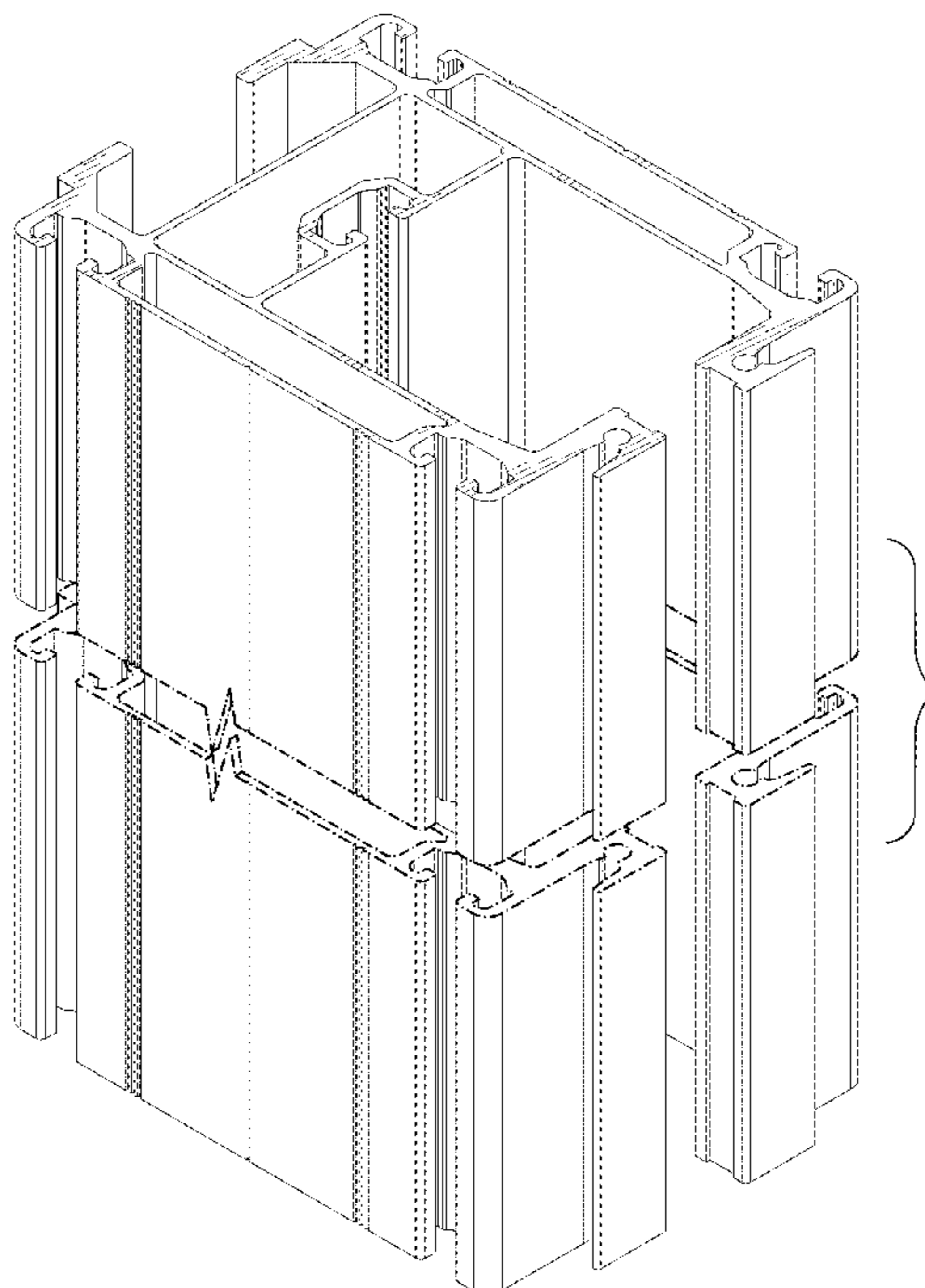
(57) **CLAIM**

The ornamental design for a profile rail, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a profile rail according to a first embodiment;  
FIGS. 2 and 3 are side views thereof;  
FIG. 4 is an end view thereof, the opposite end being a mirror image;  
FIG. 5 is a front view thereof;  
FIG. 6 is a rear view thereof;  
FIG. 7 is a perspective view of a profile rail according to a second embodiment;  
FIG. 8 is an end view thereof, the opposite end being a mirror image;  
FIGS. 9 and 10 are side views thereof;  
FIG. 11 is a front view thereof; and,  
FIG. 12 is a rear view thereof.  
The profile rail is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

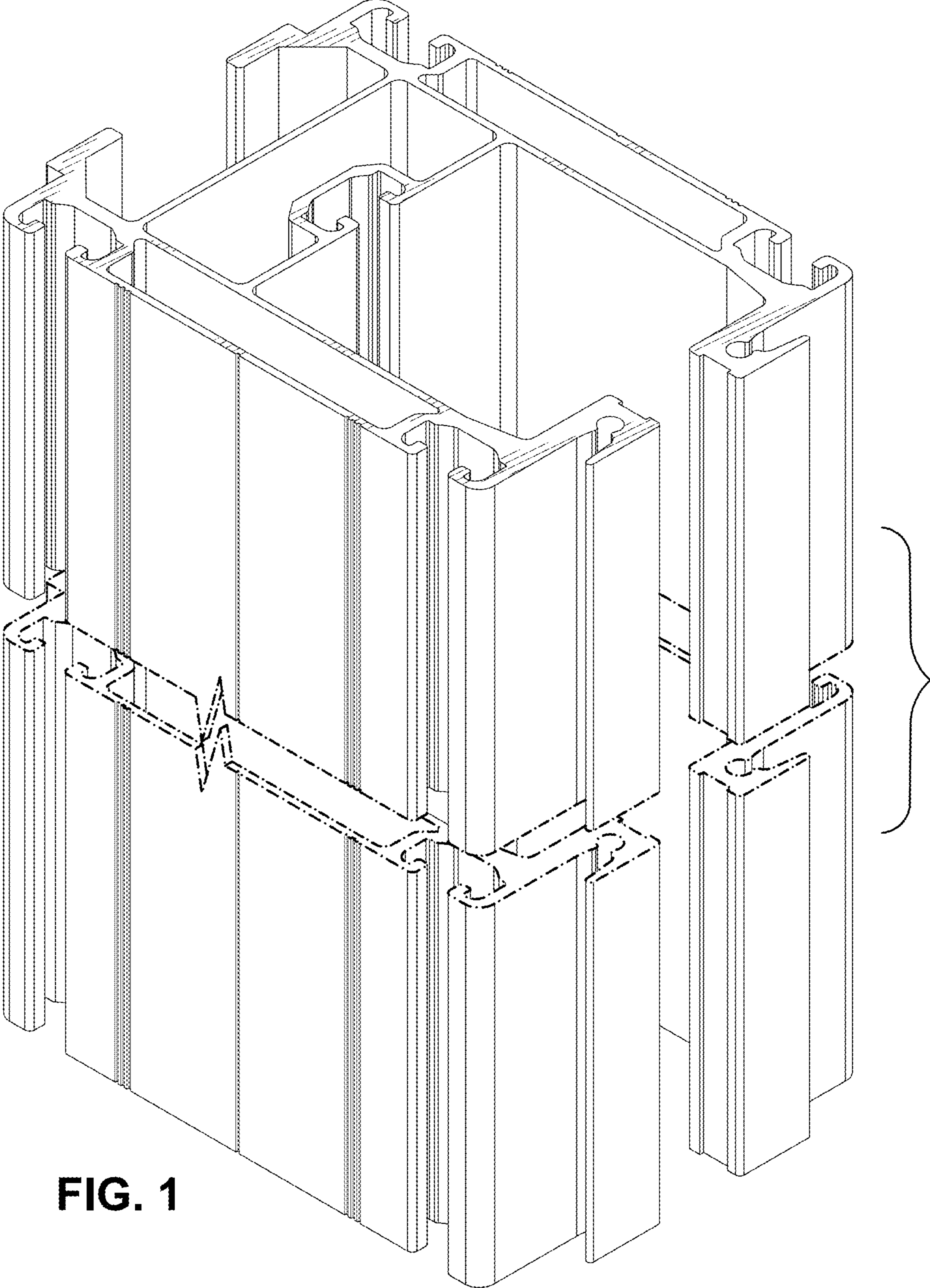

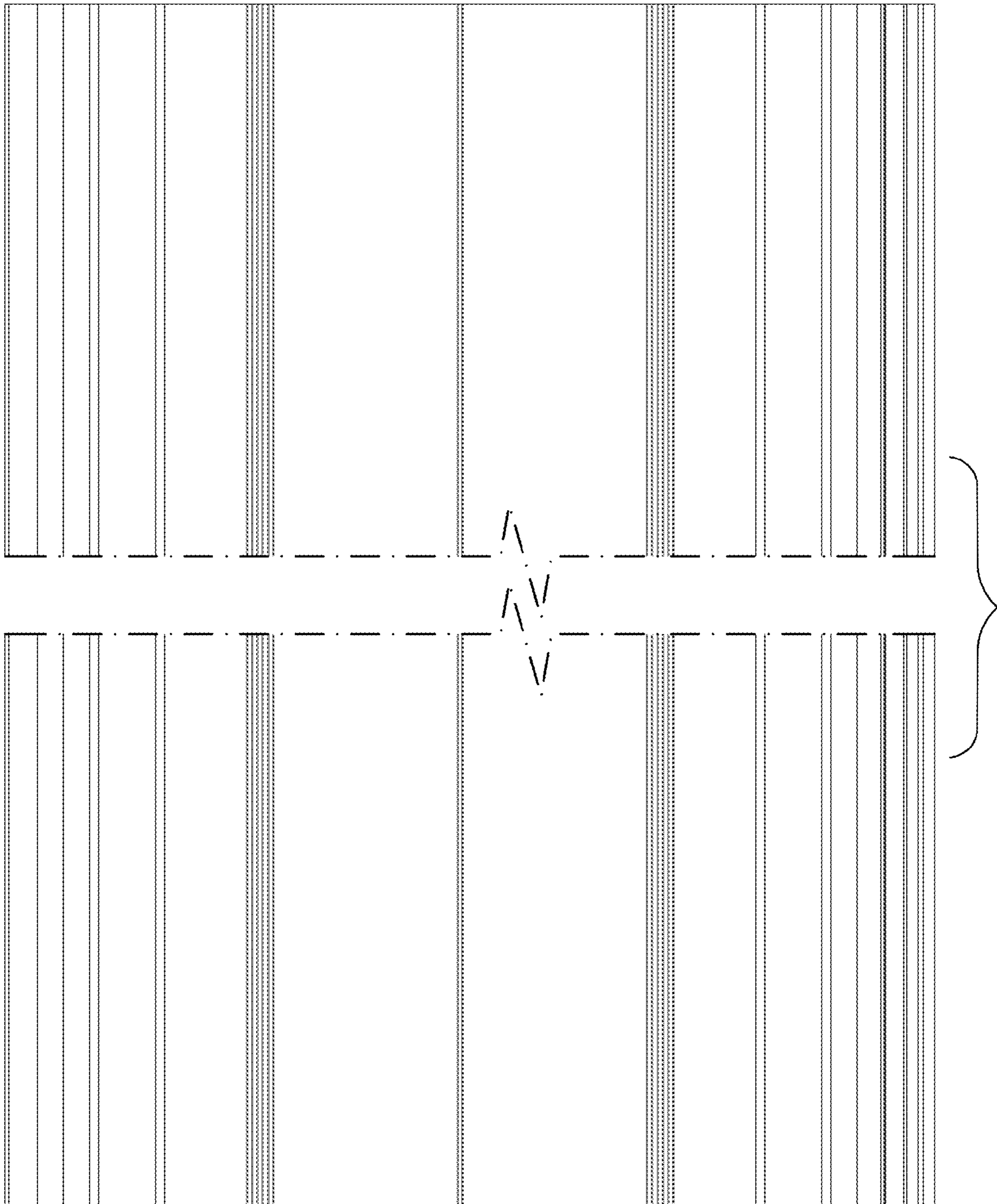

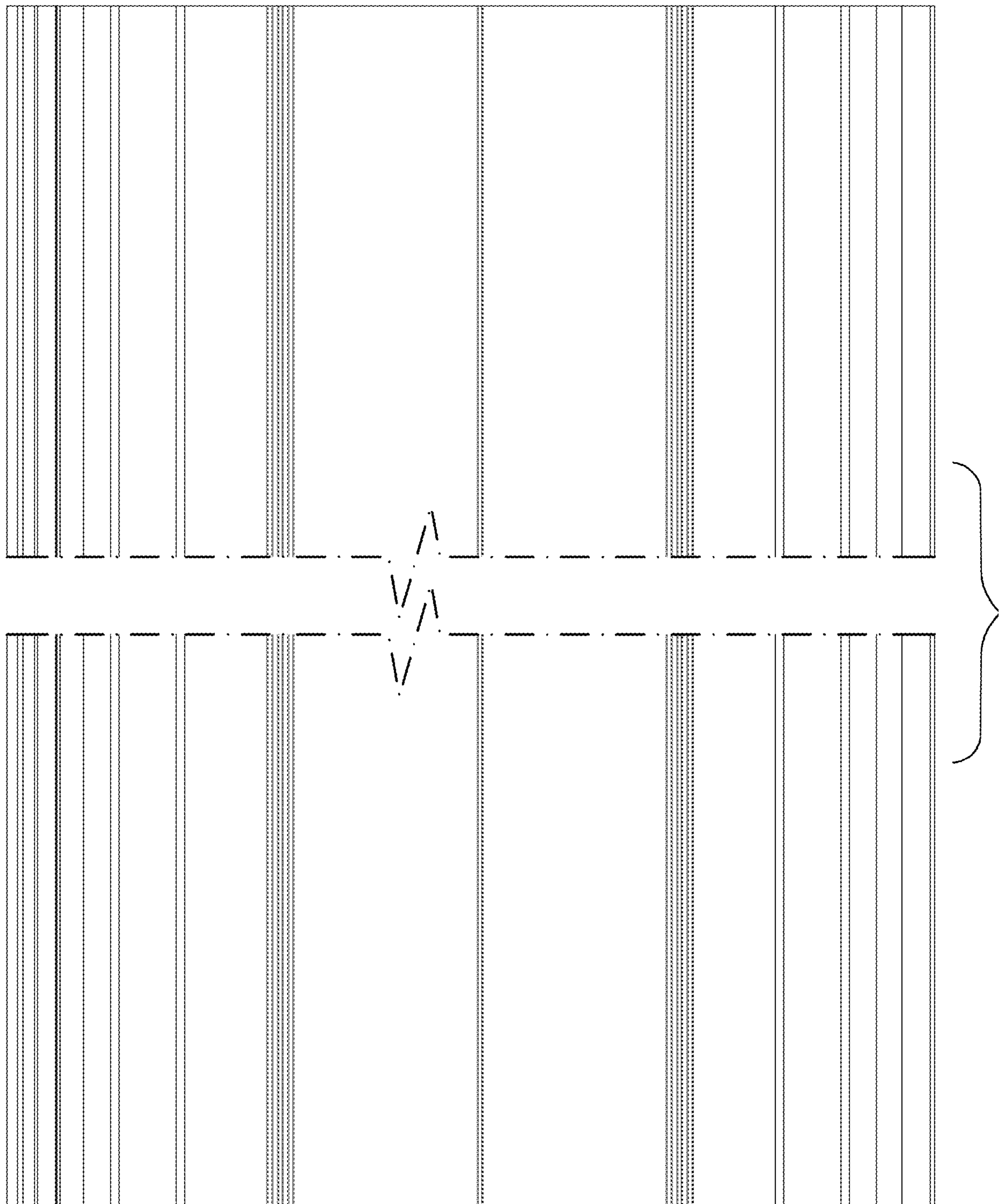

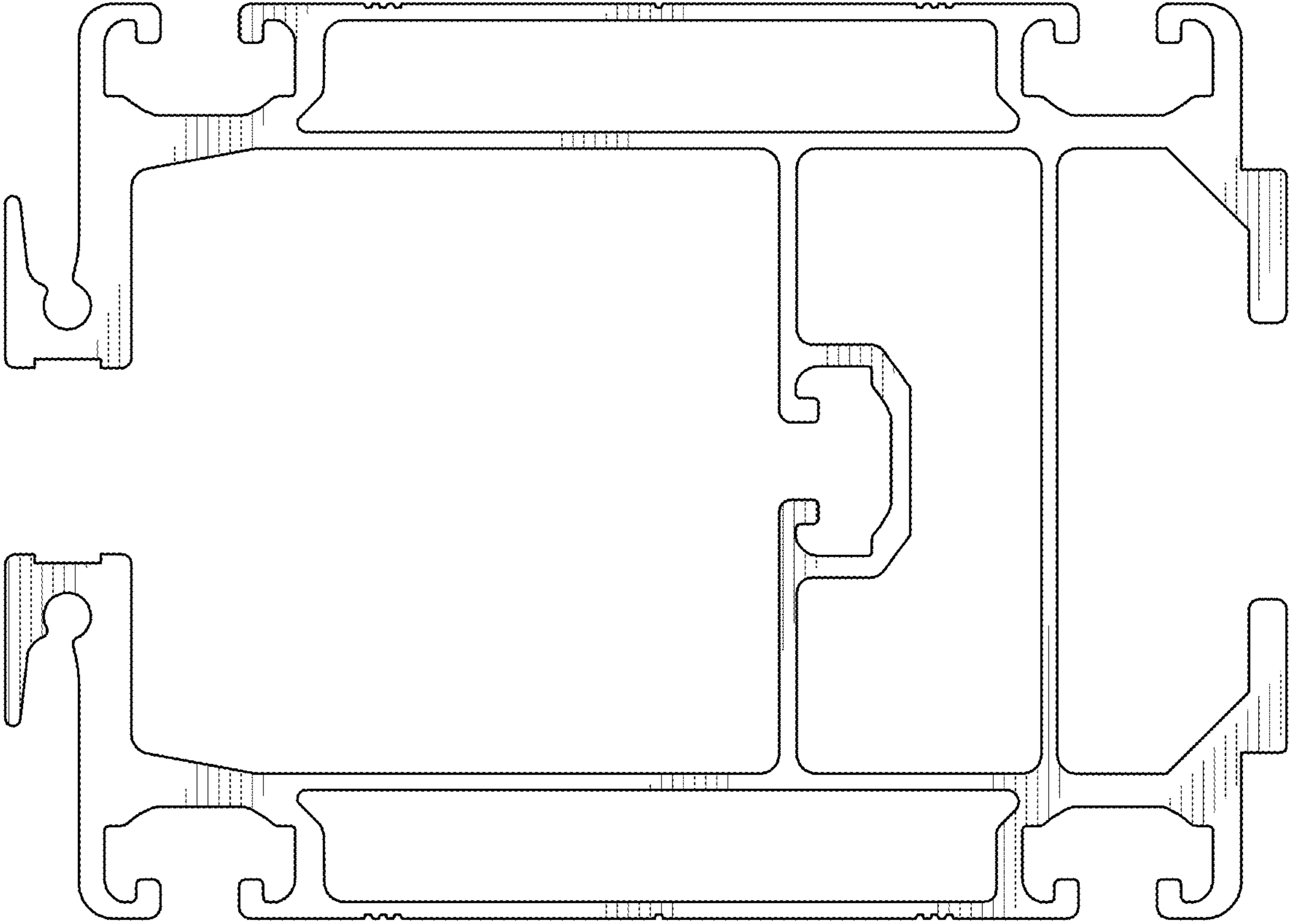

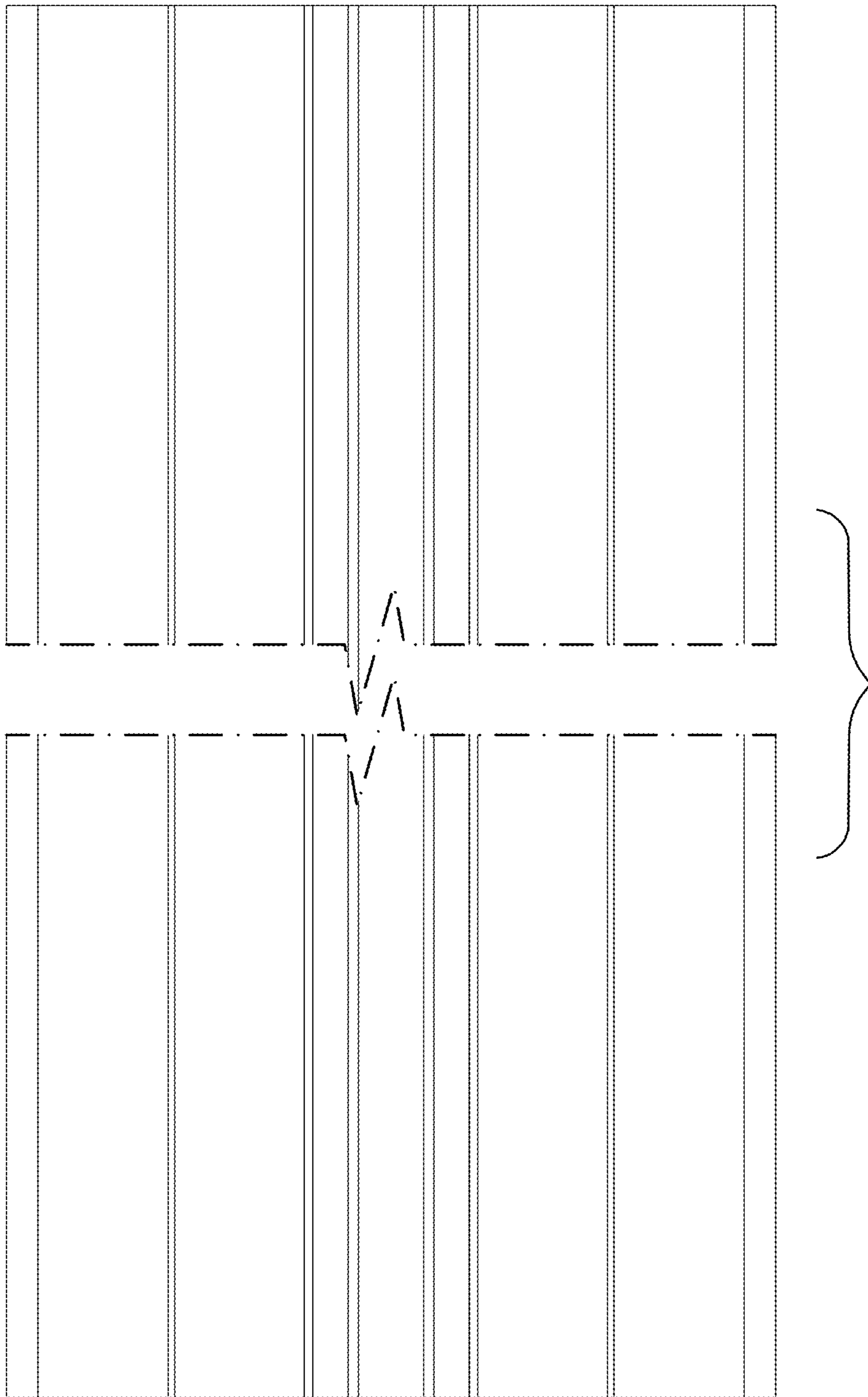

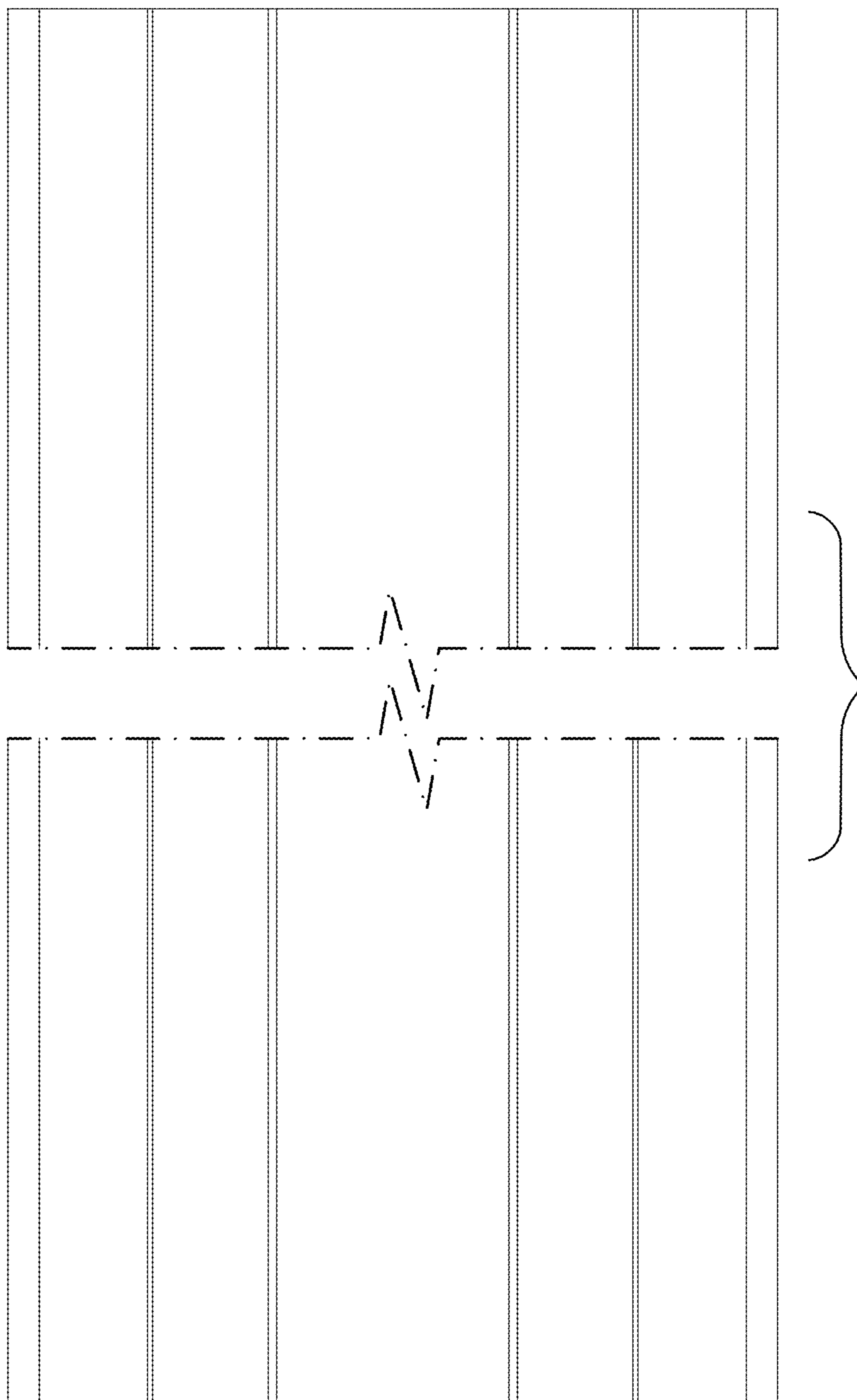
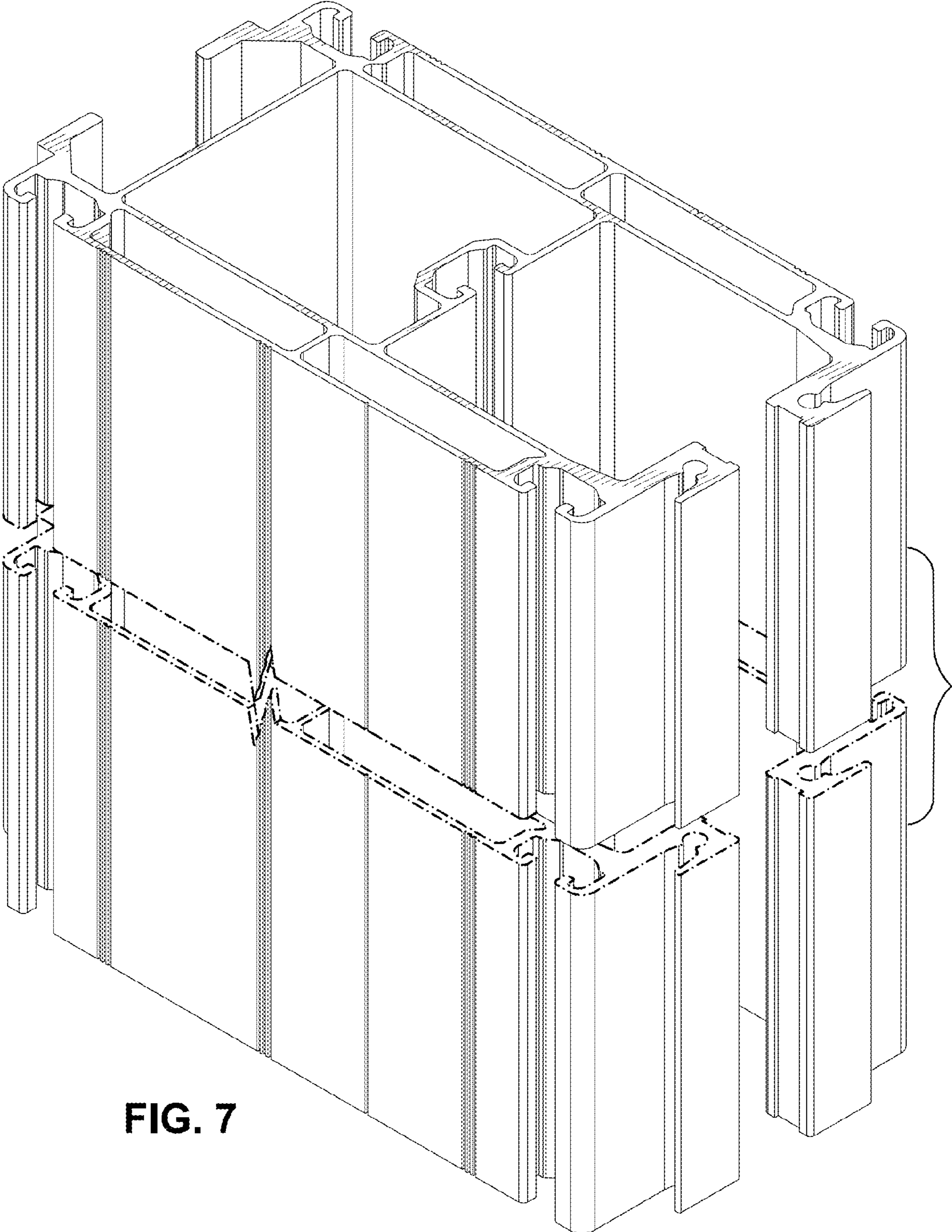

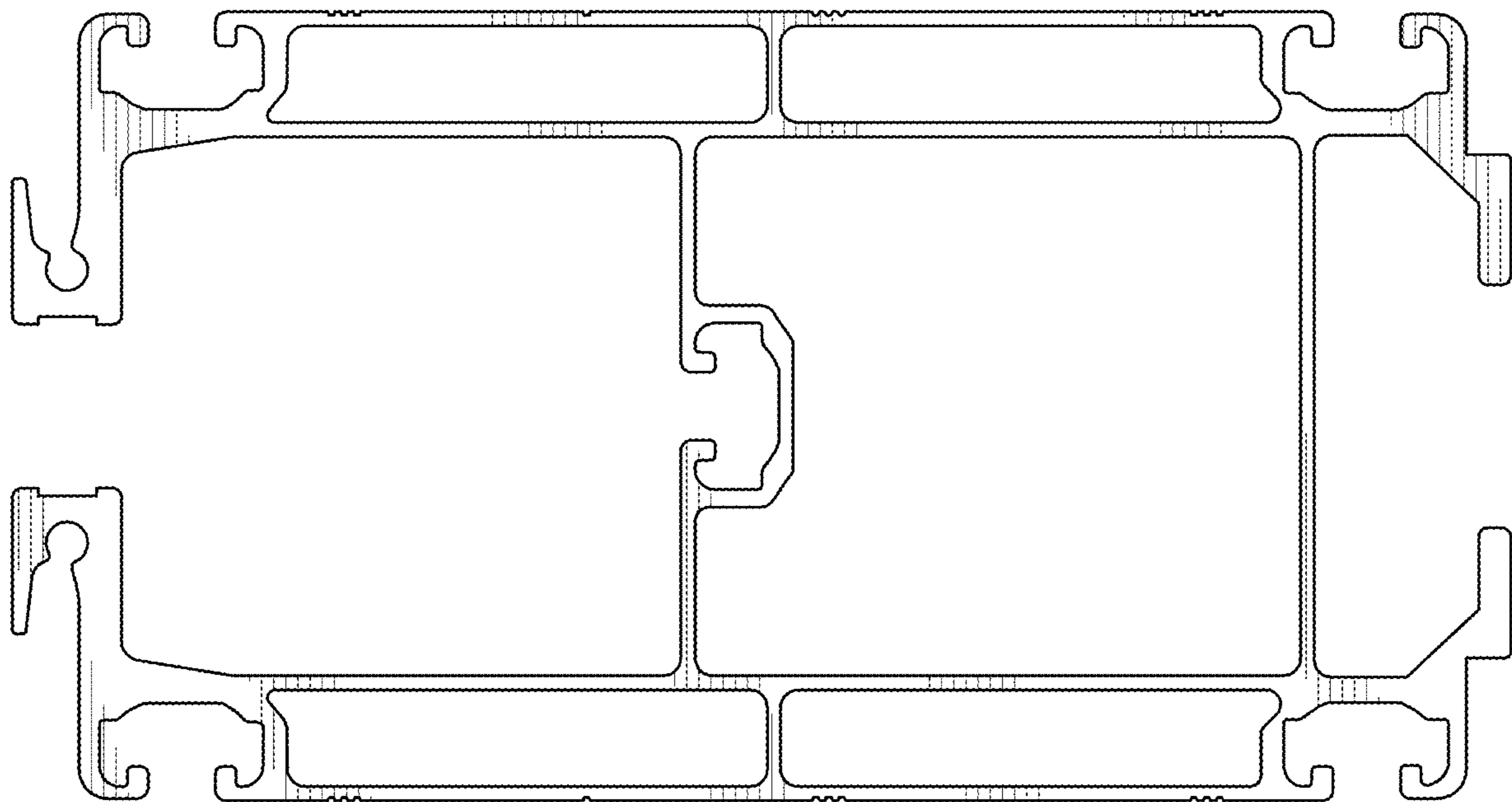

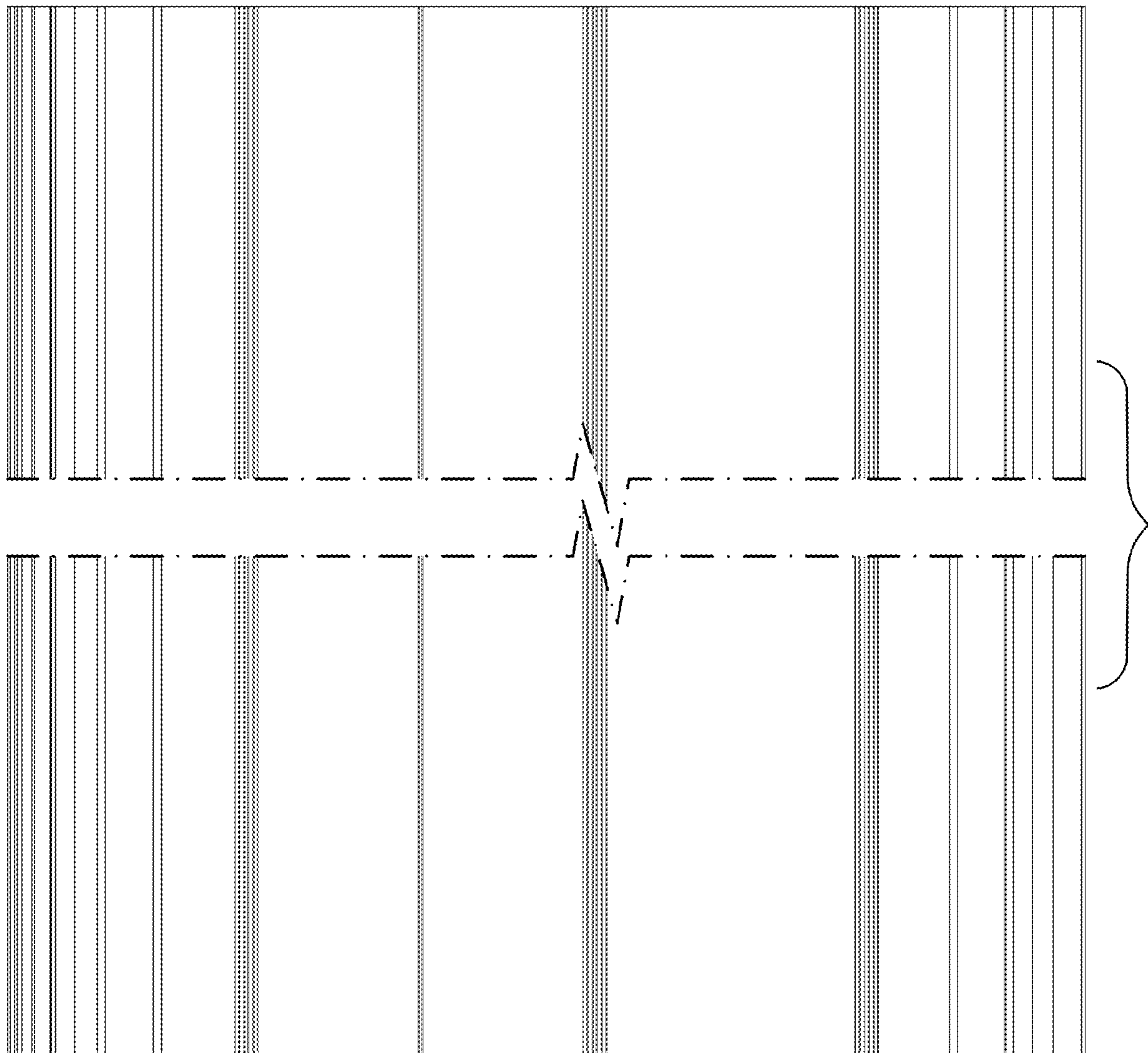

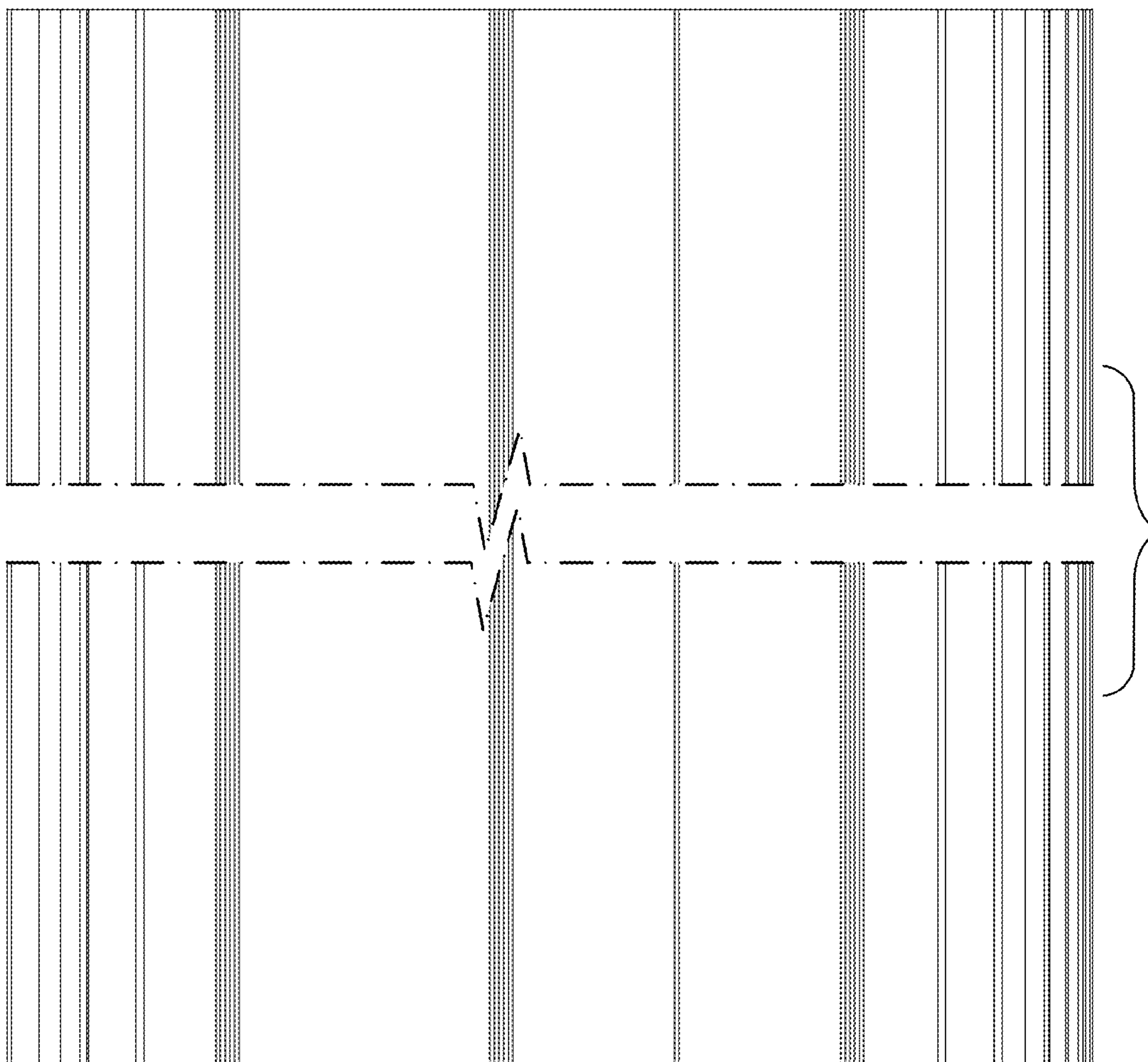
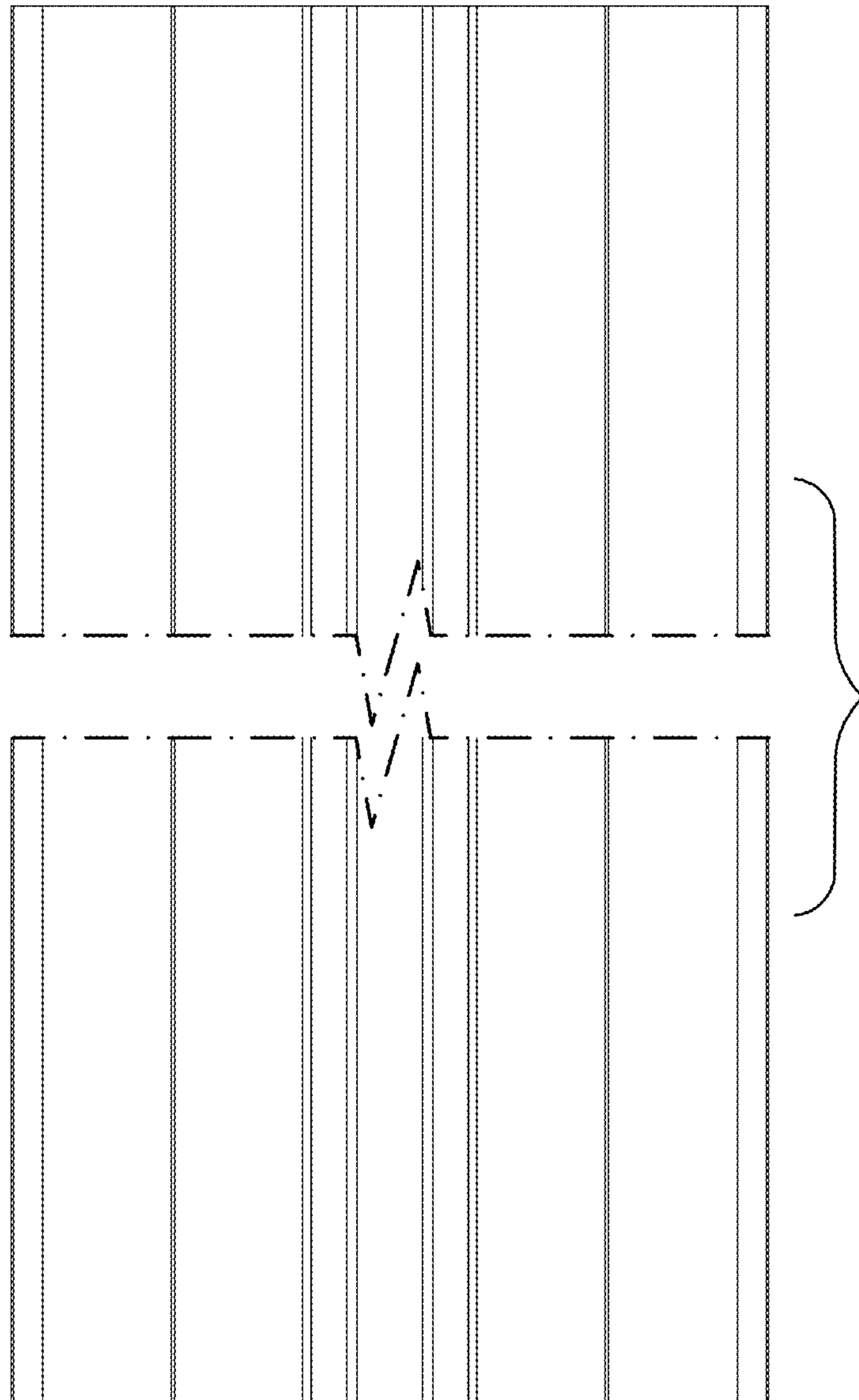
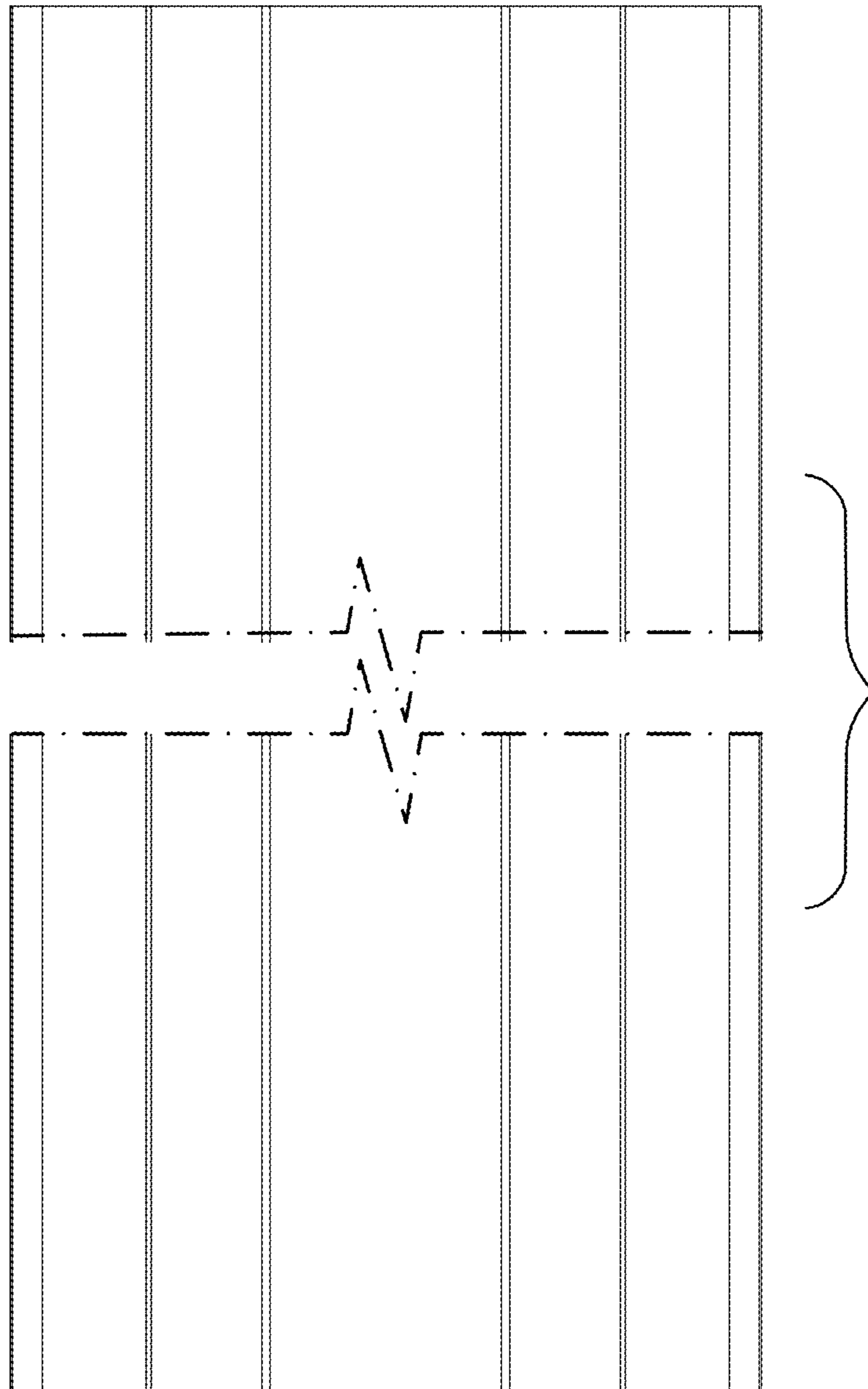
