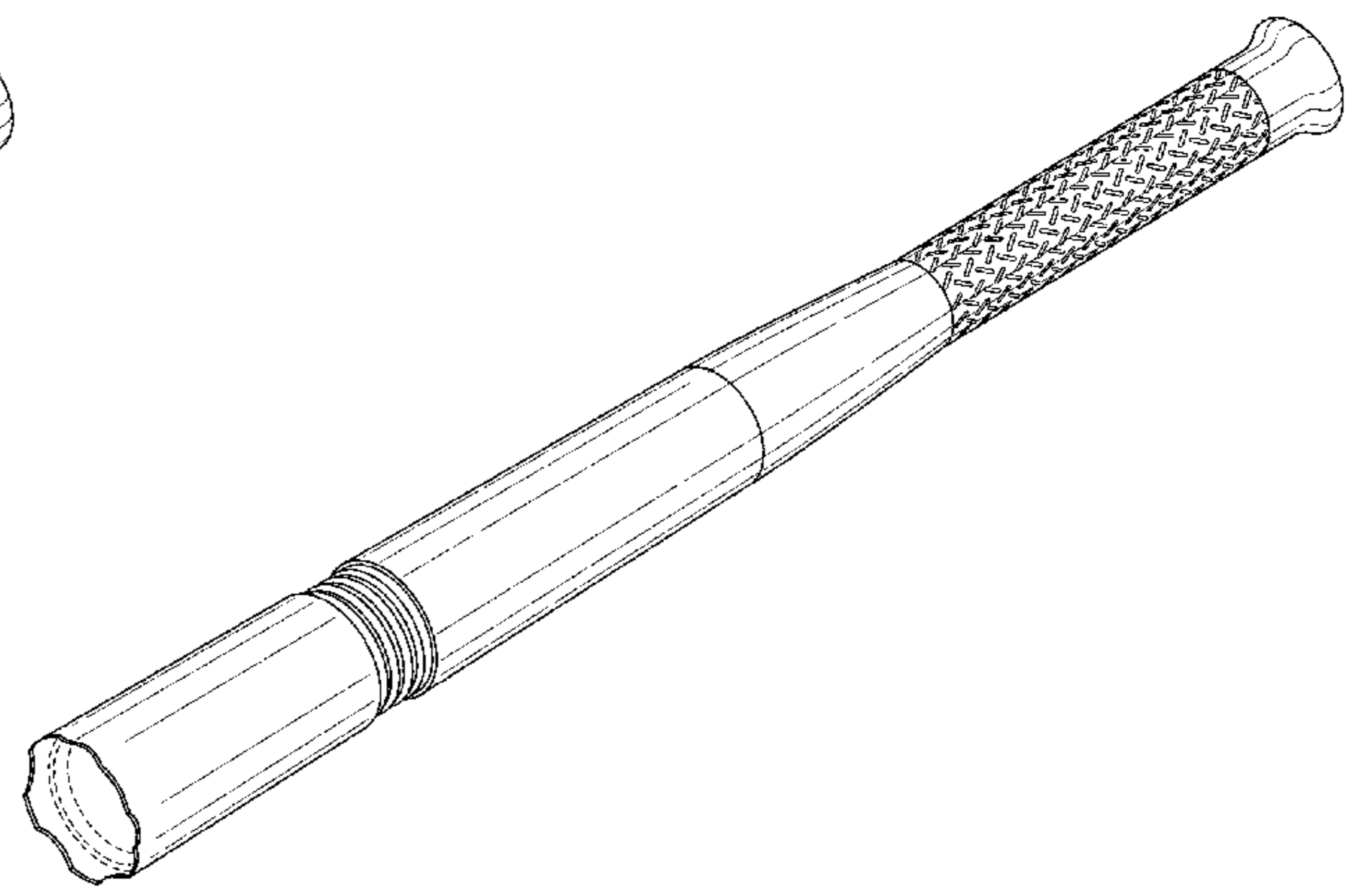
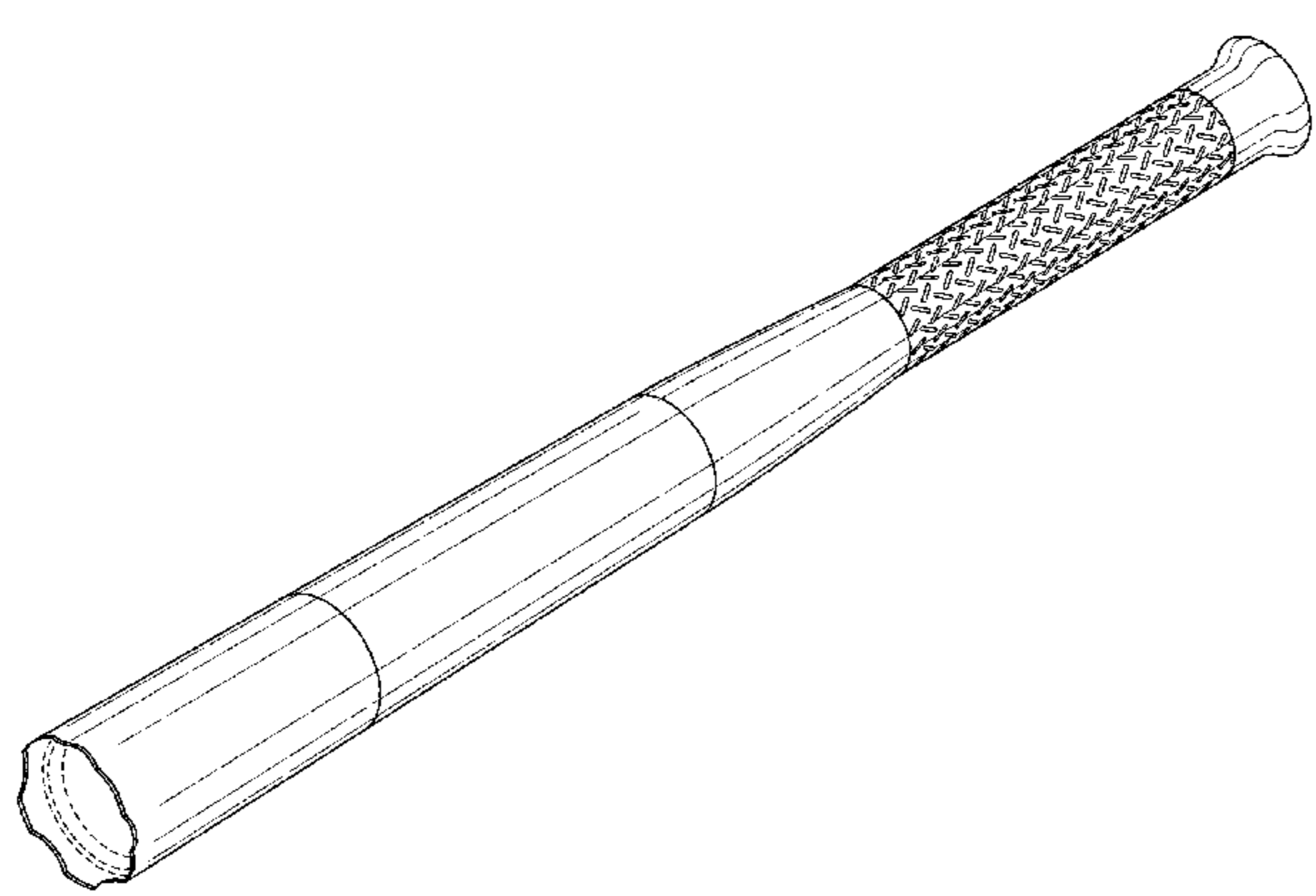

(57) CLAIM

The ornamental design for a flashlight baton with crenulate sliding bezel, as shown and described.

DESCRIPTION

FIG. 1 is a left, top, perspective view of a flashlight baton with crenulate sliding bezel showing my design therefor;

 The broken lines show portion of the article which form no part of the claimed design.

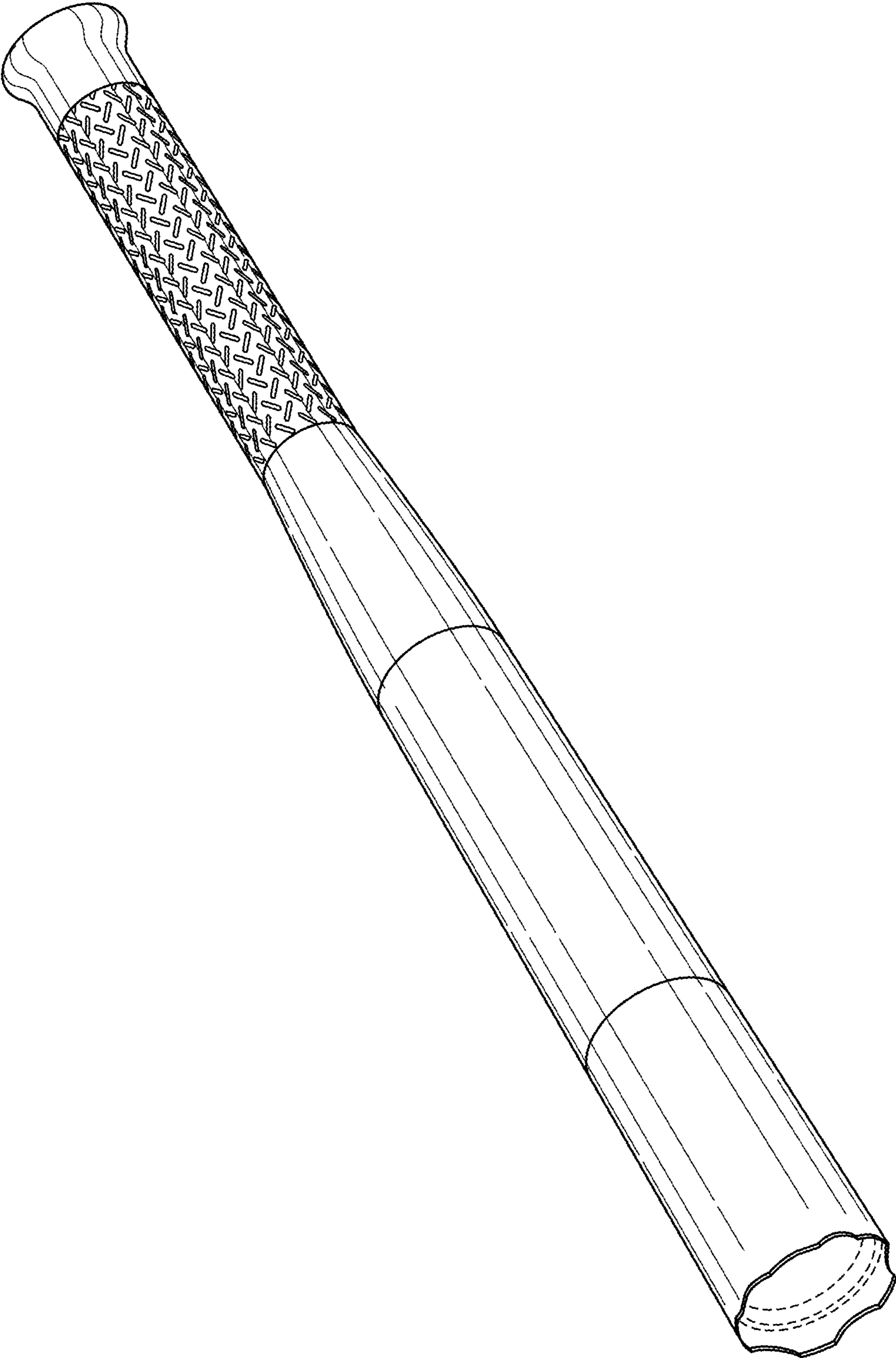

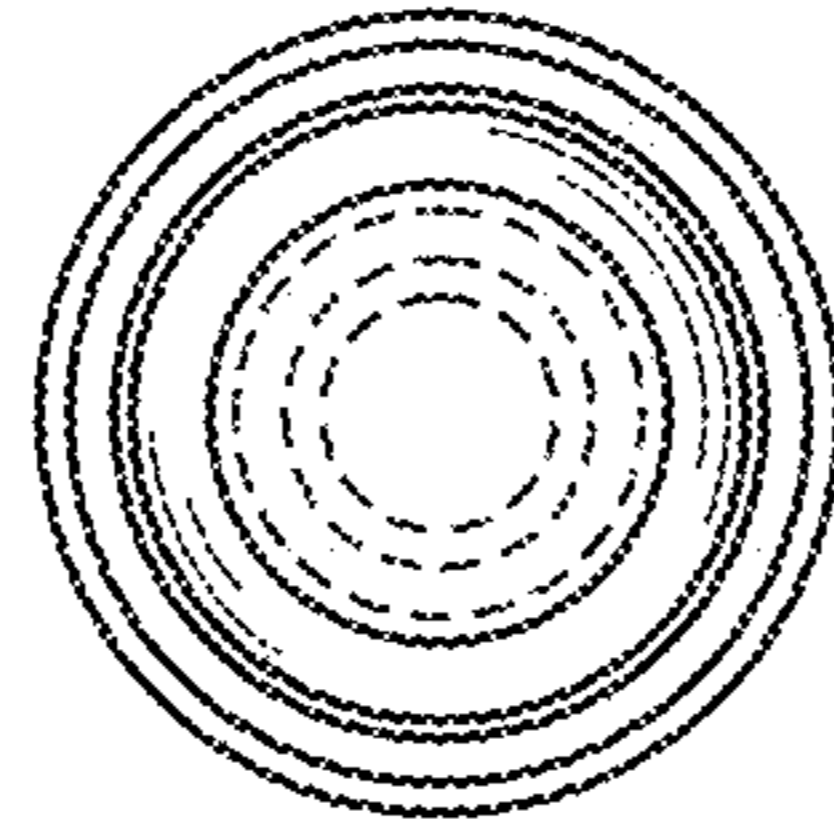

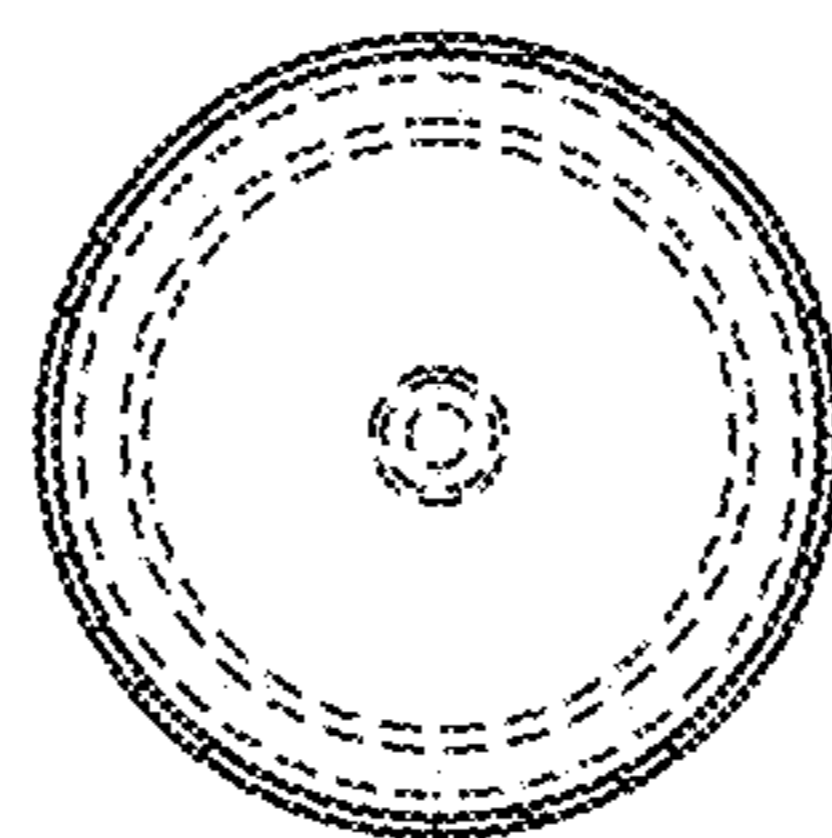

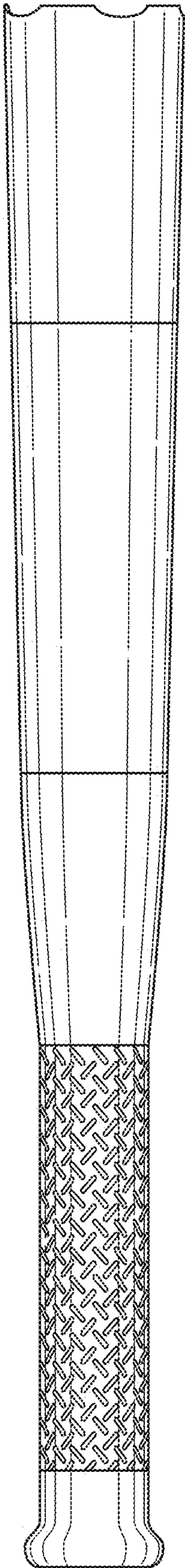

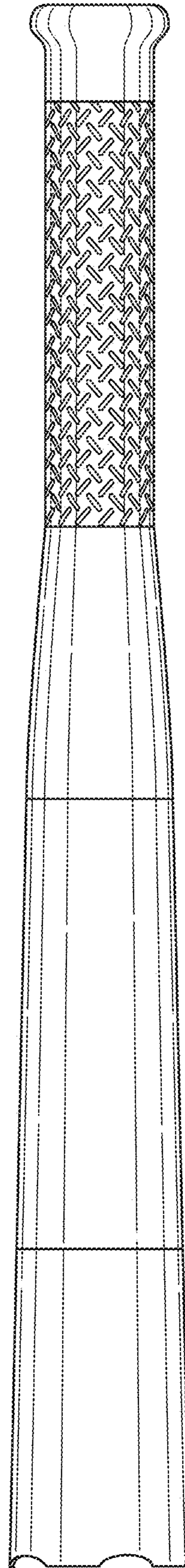

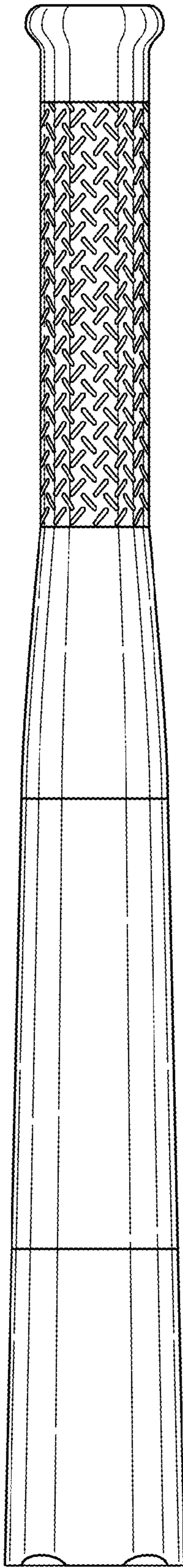

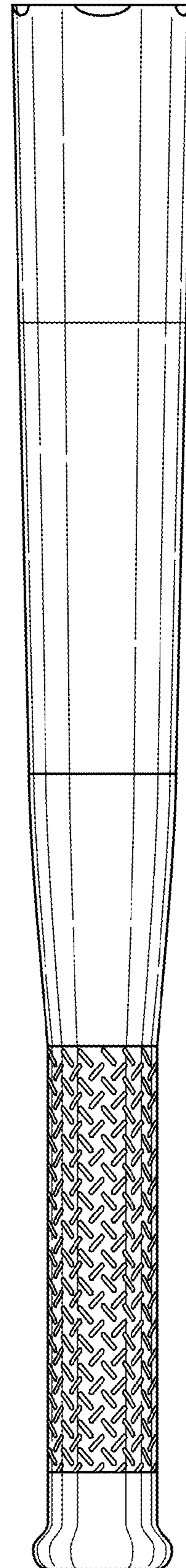

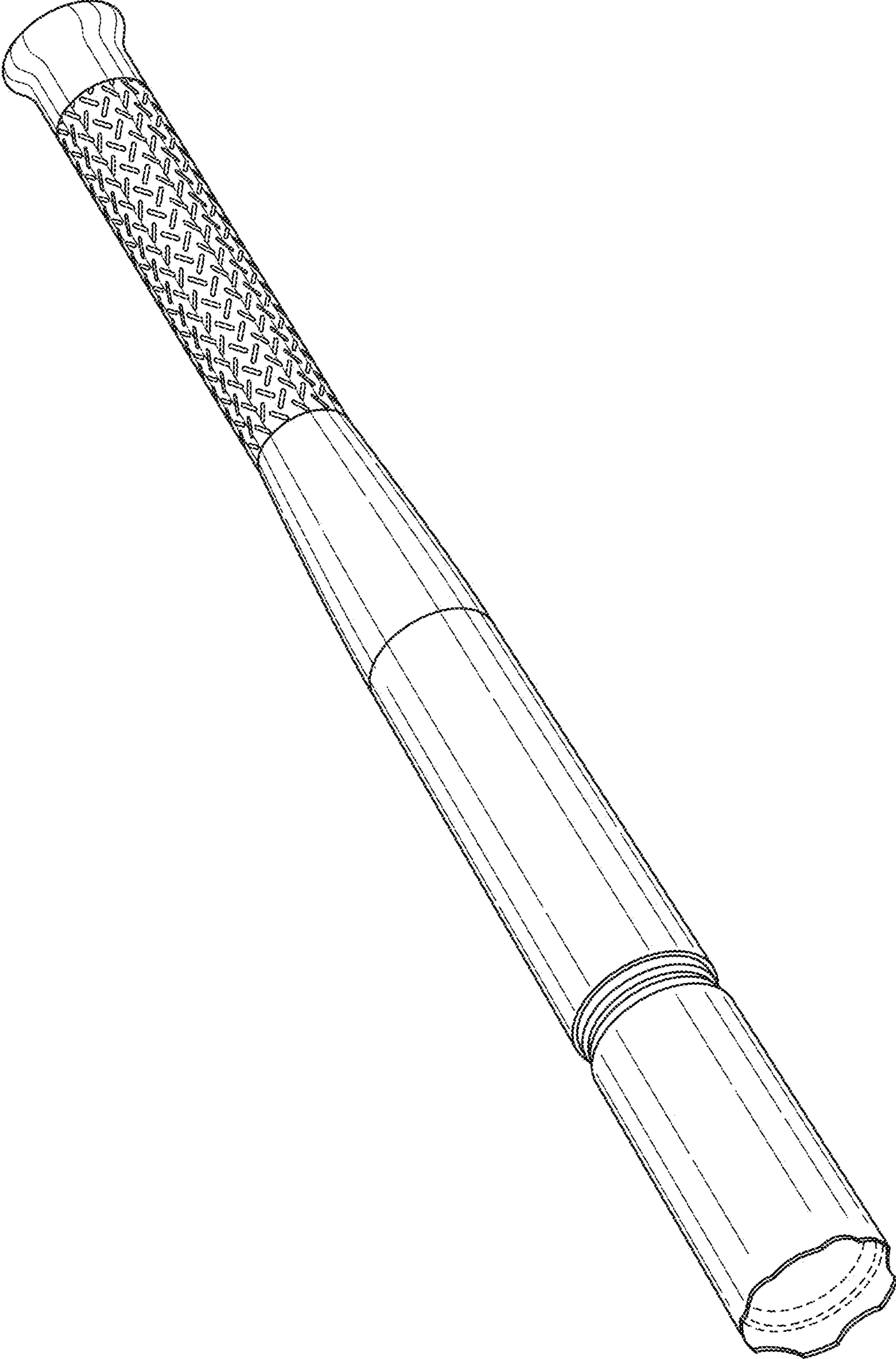

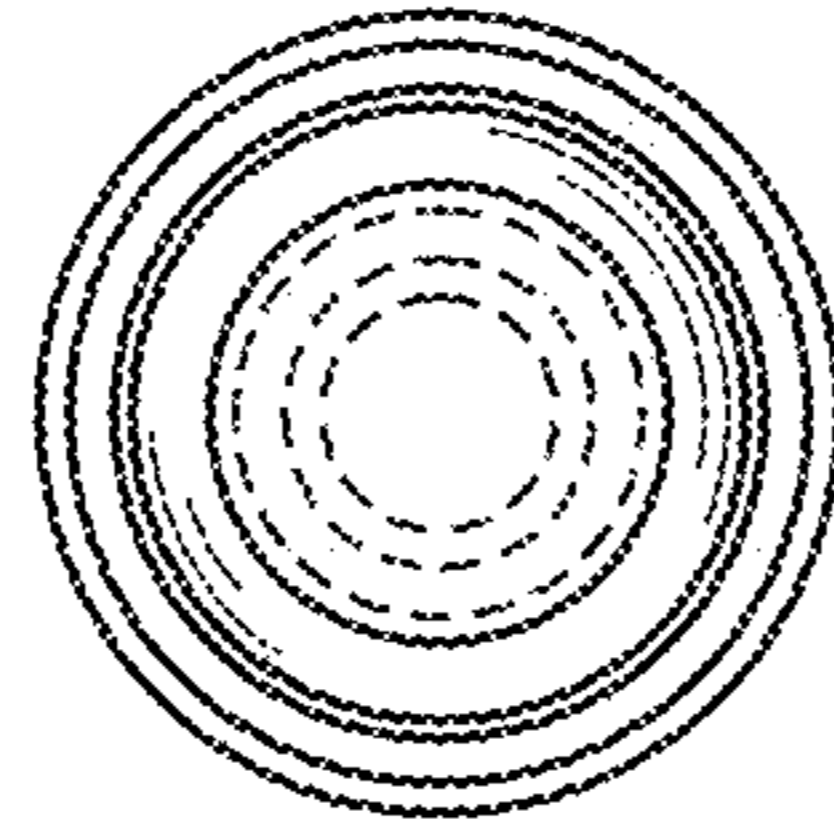

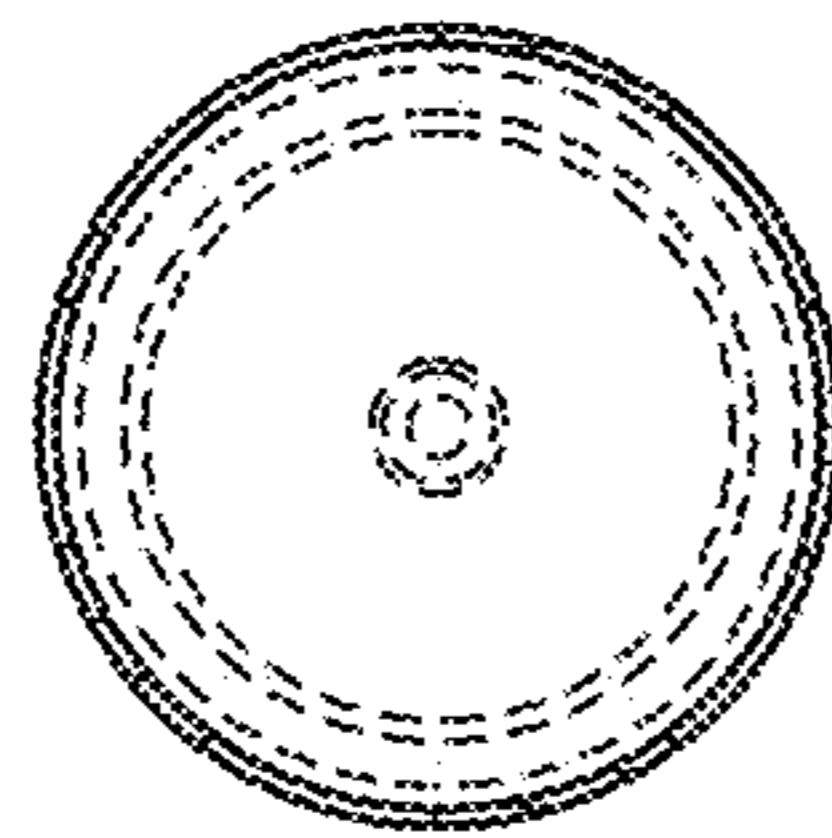

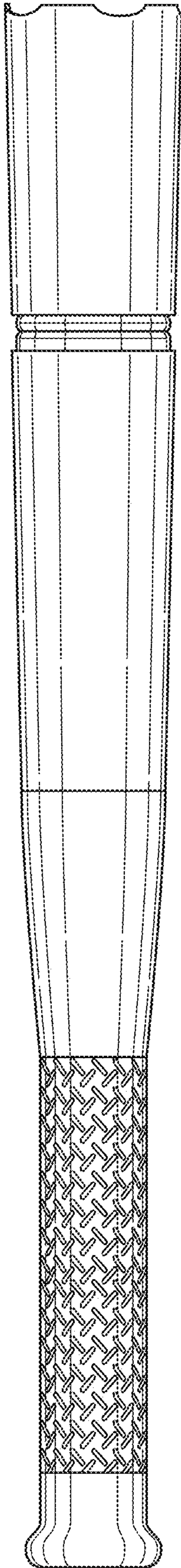

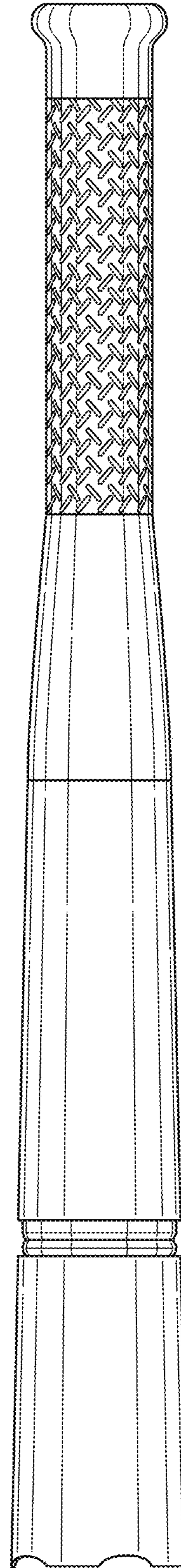

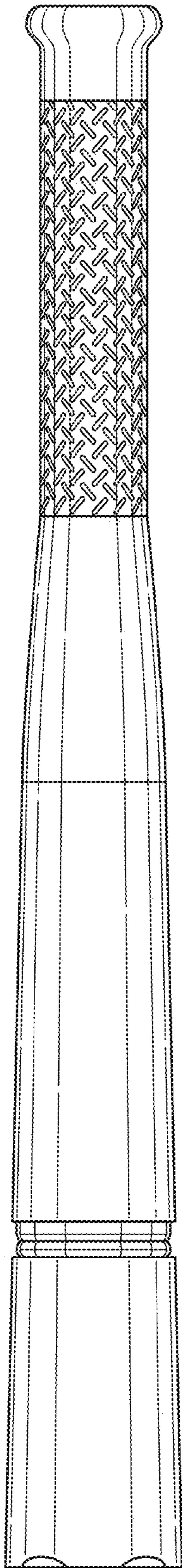

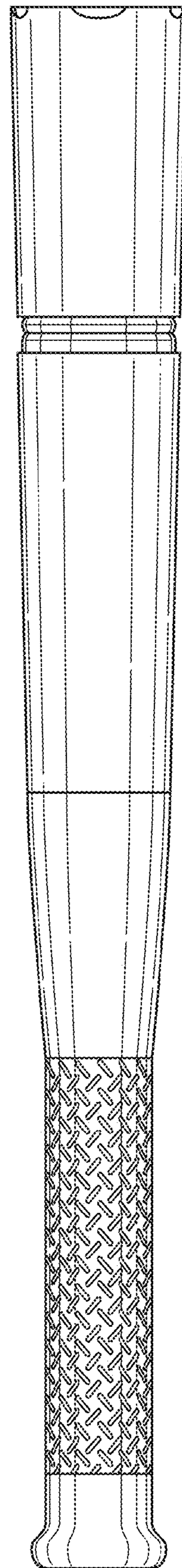

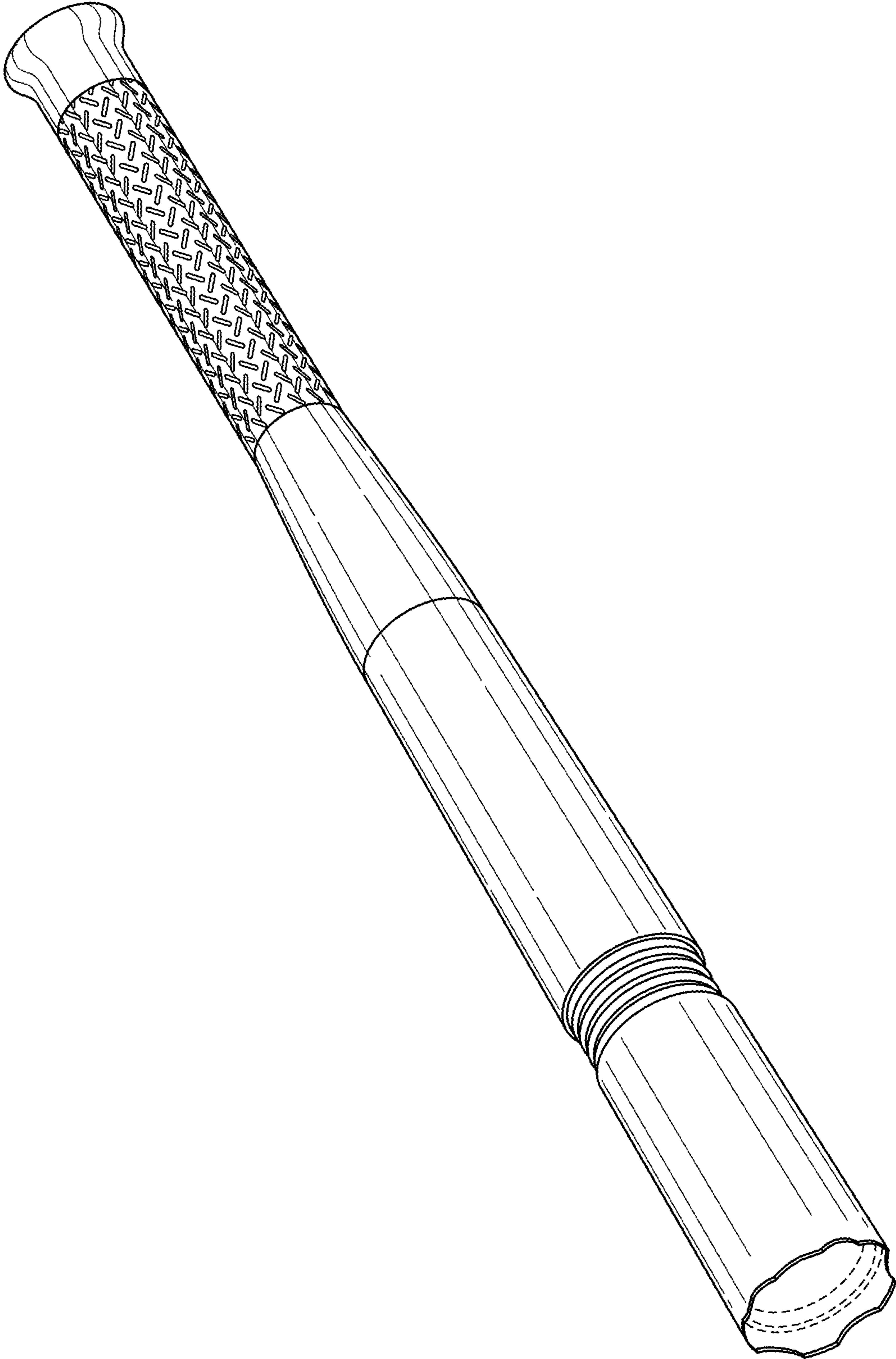

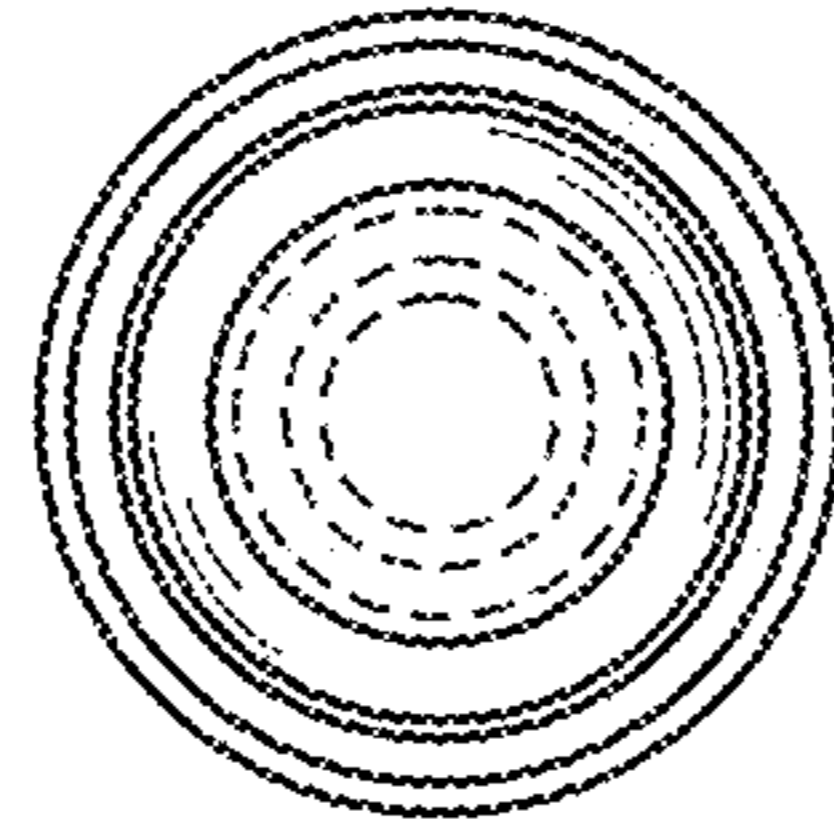

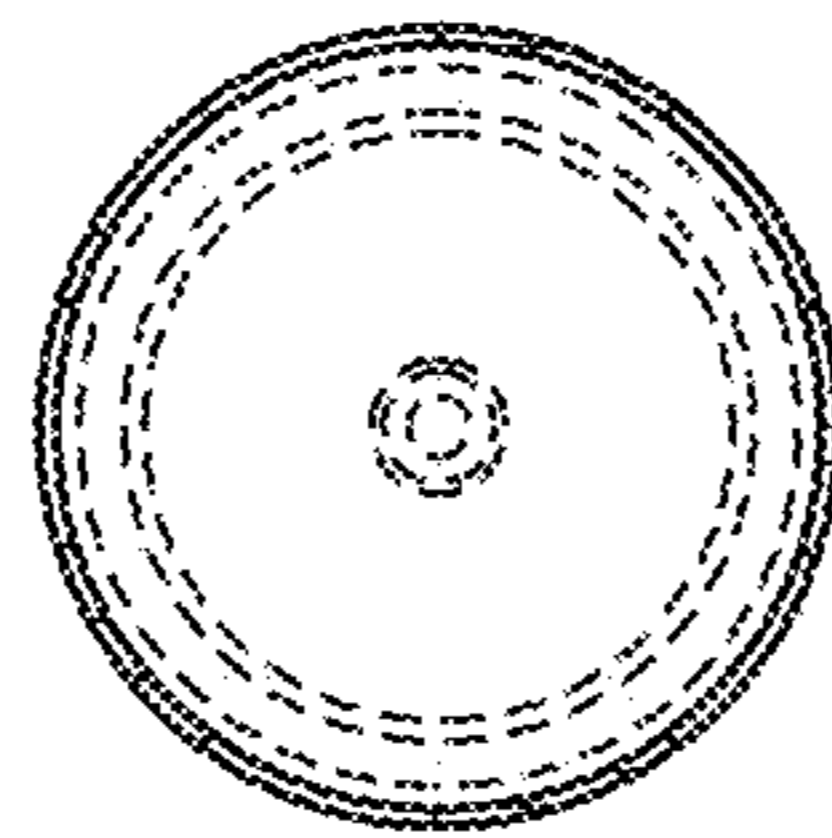

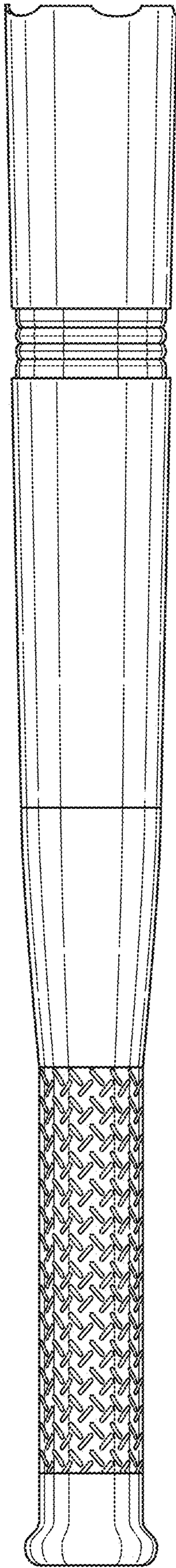

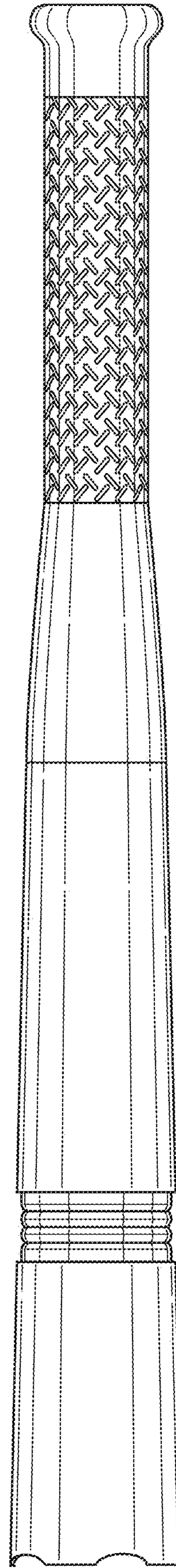

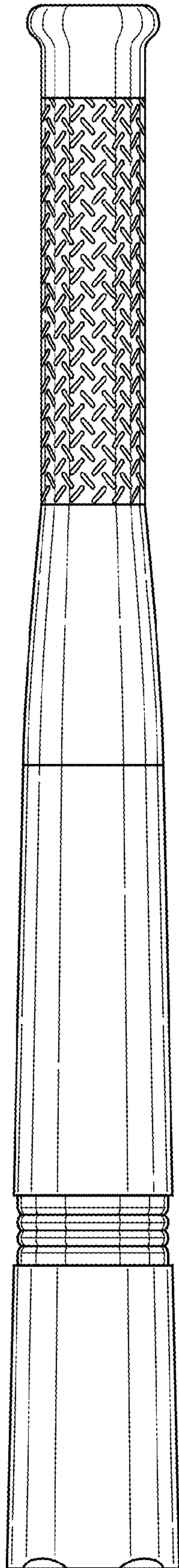

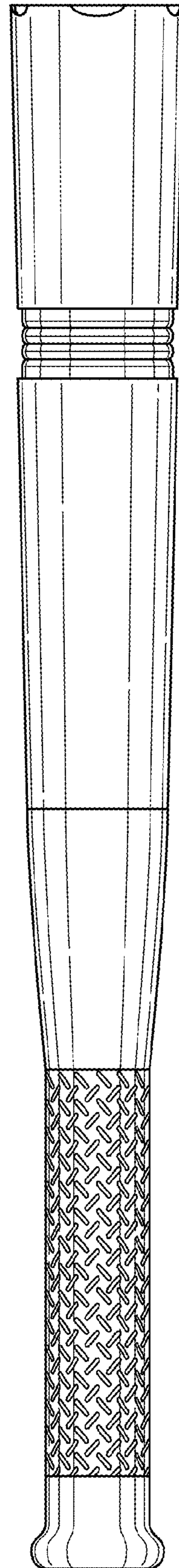
