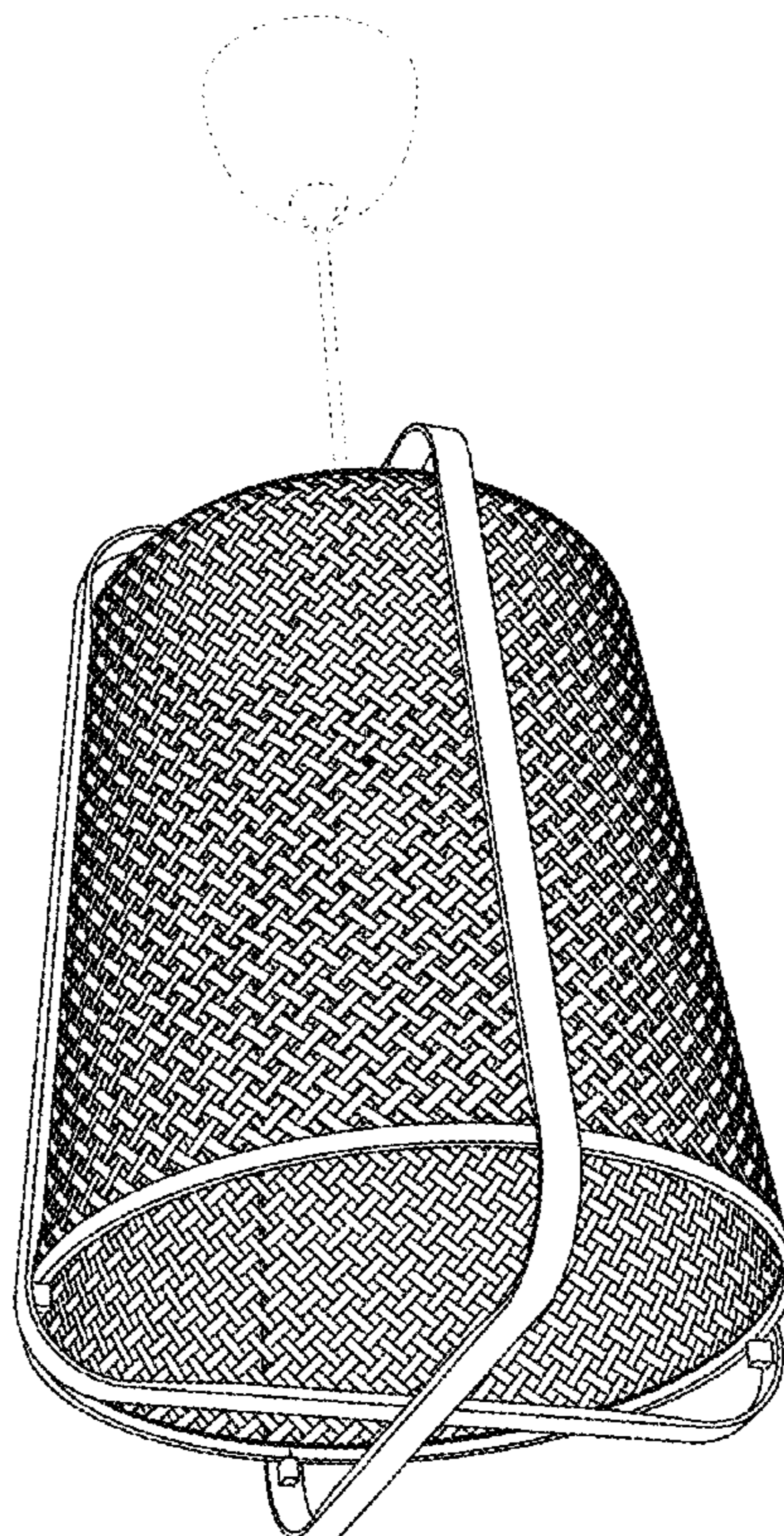
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-right-bottom perspective view of a lamp showing my new design;
 FIG. 2 is a rear-left-top perspective view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a right side view thereof, a left side view being a mirror image of the right side view;
 FIG. 6 is a top view thereof; and,
 FIG. 7 is a bottom view thereof.

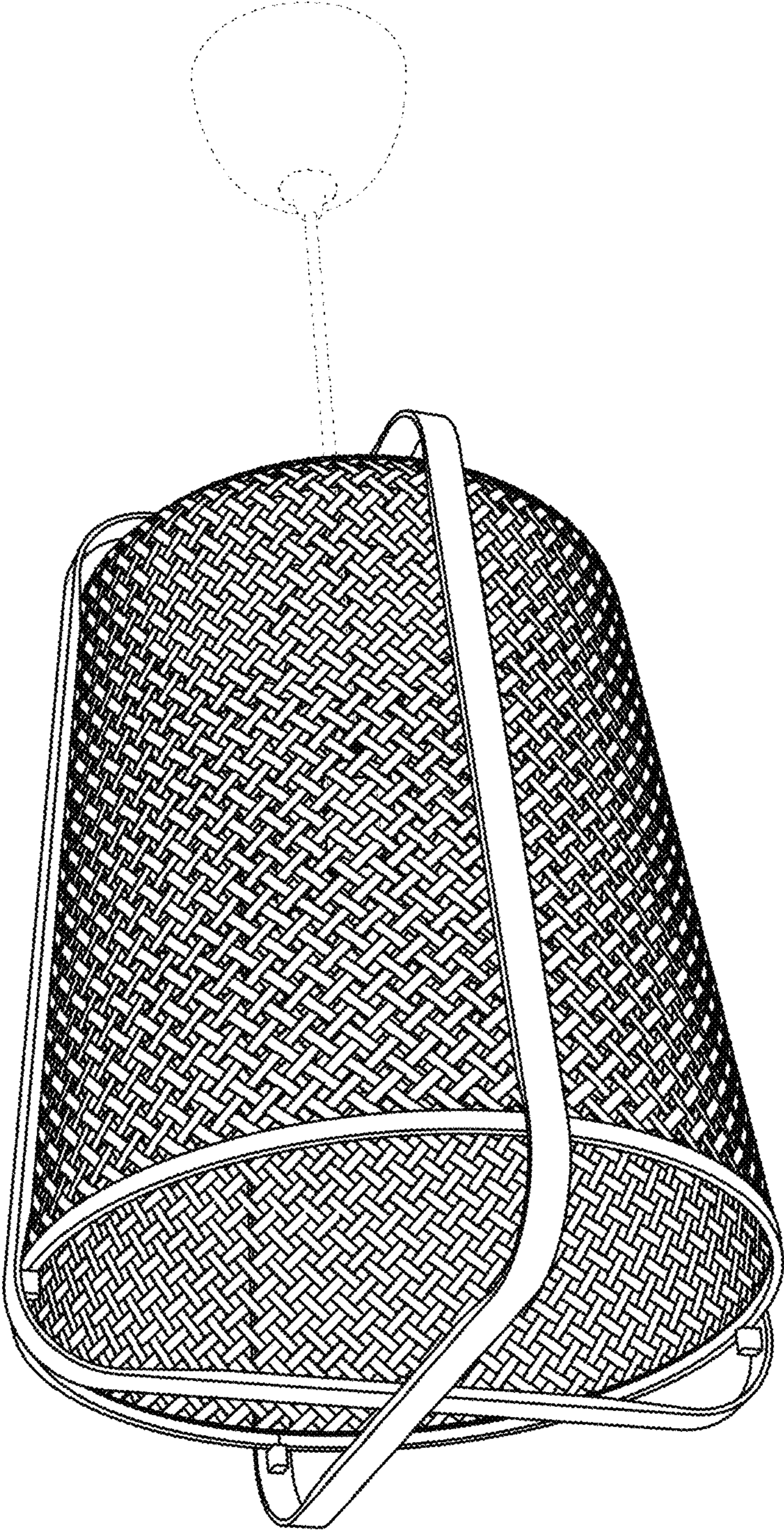

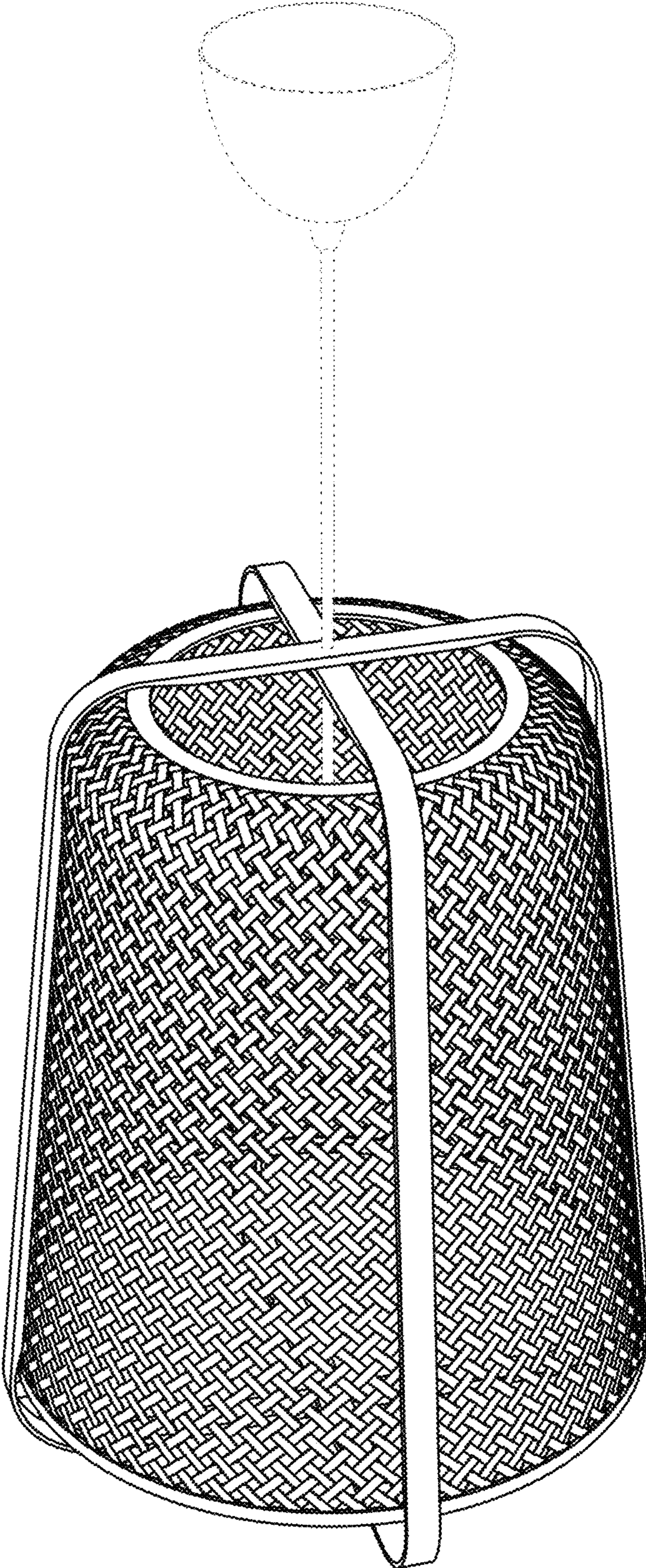

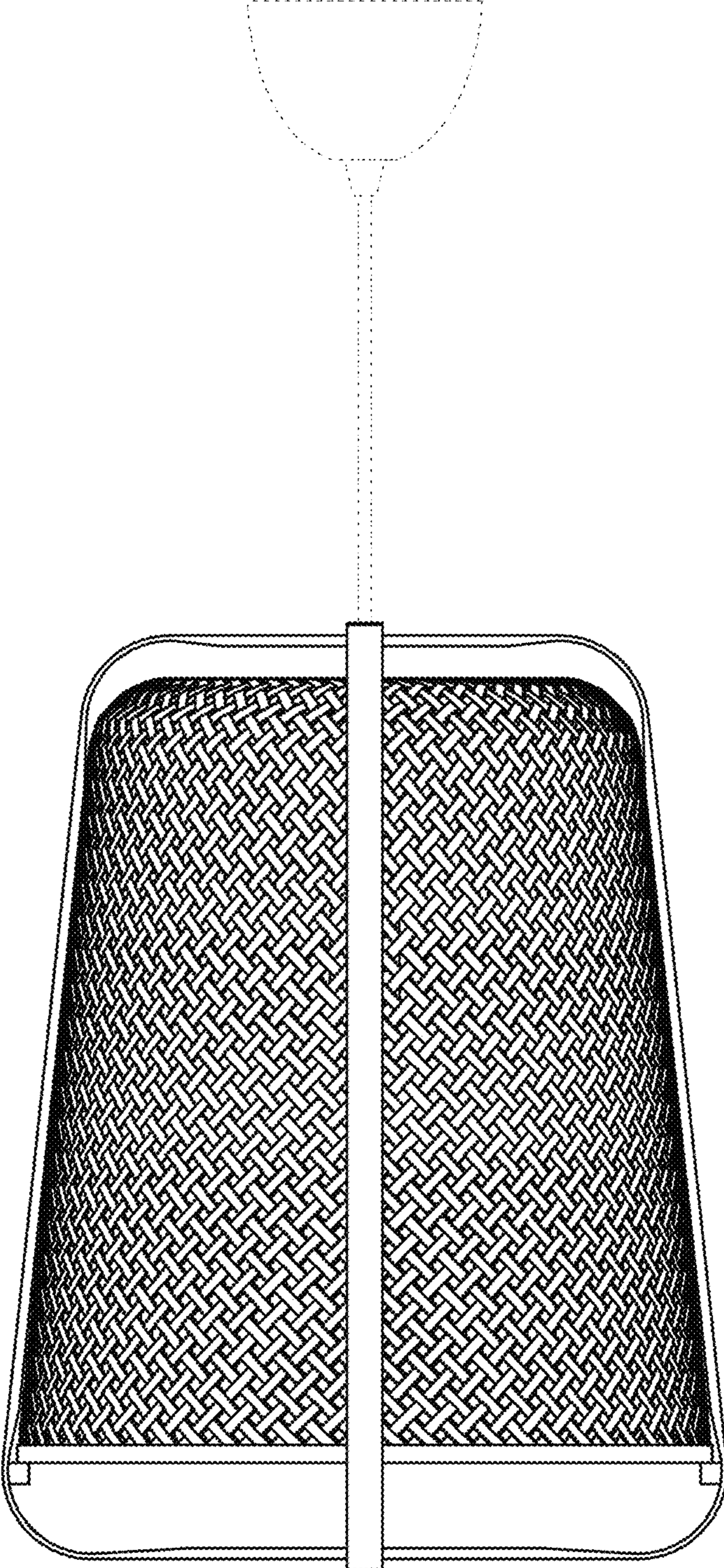

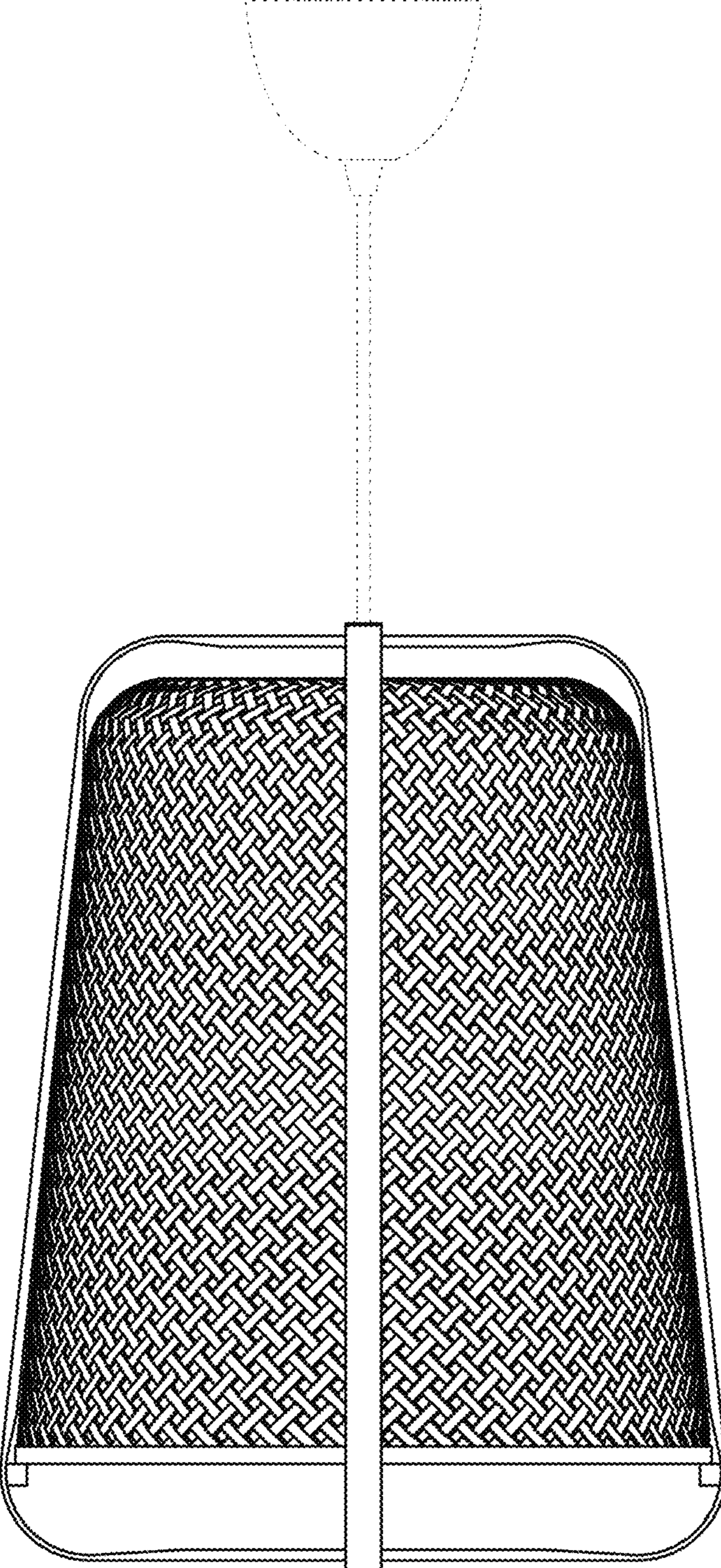

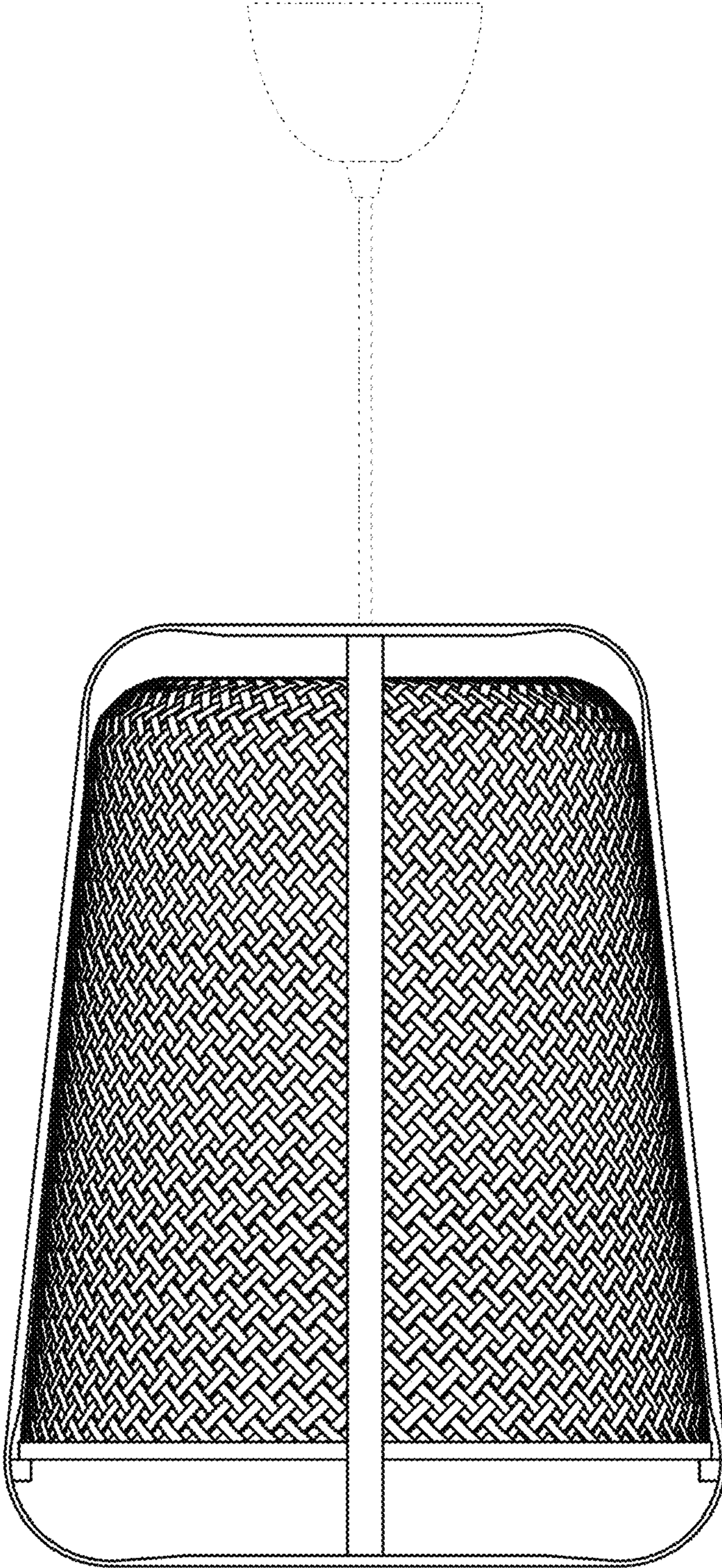

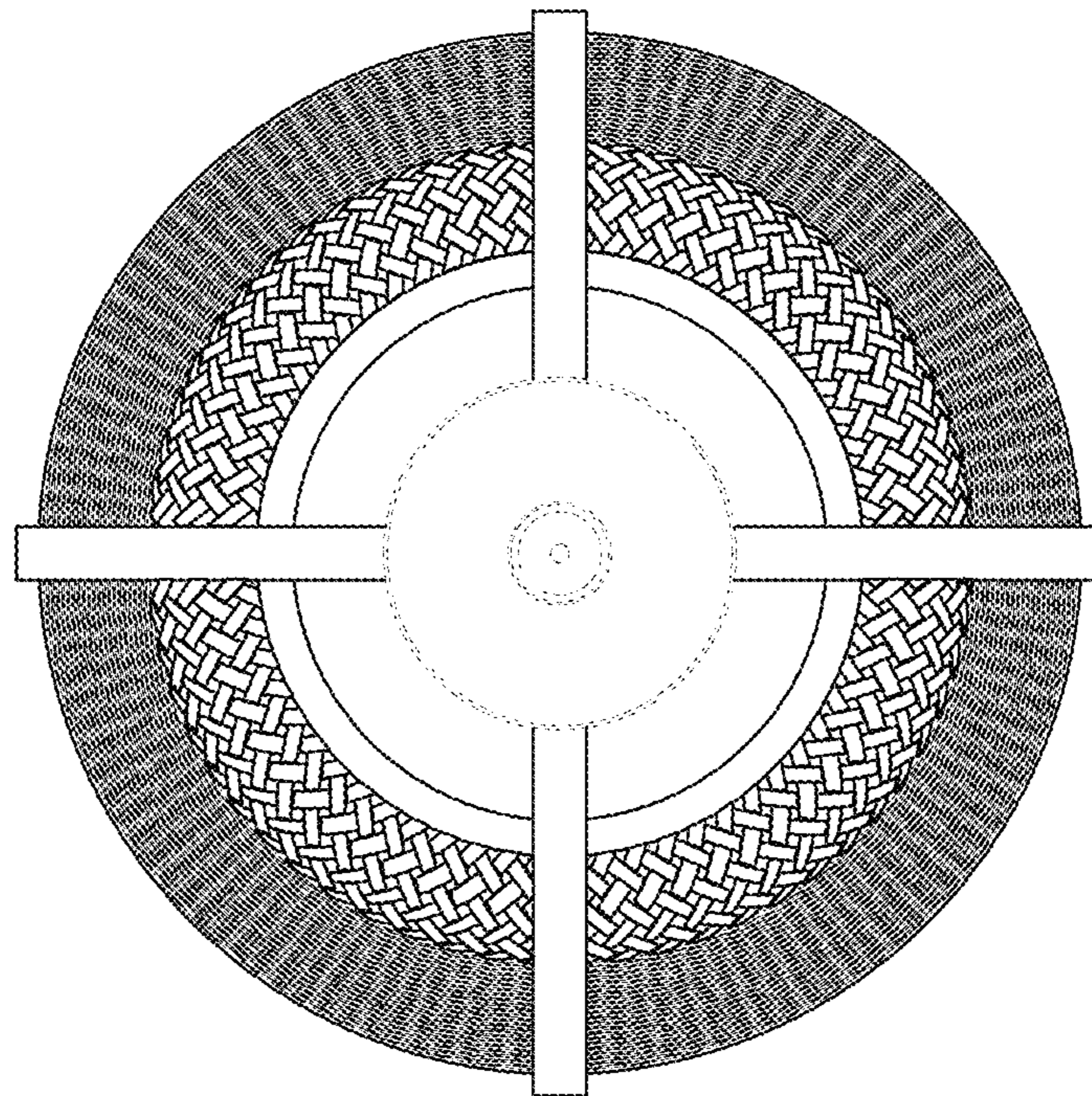

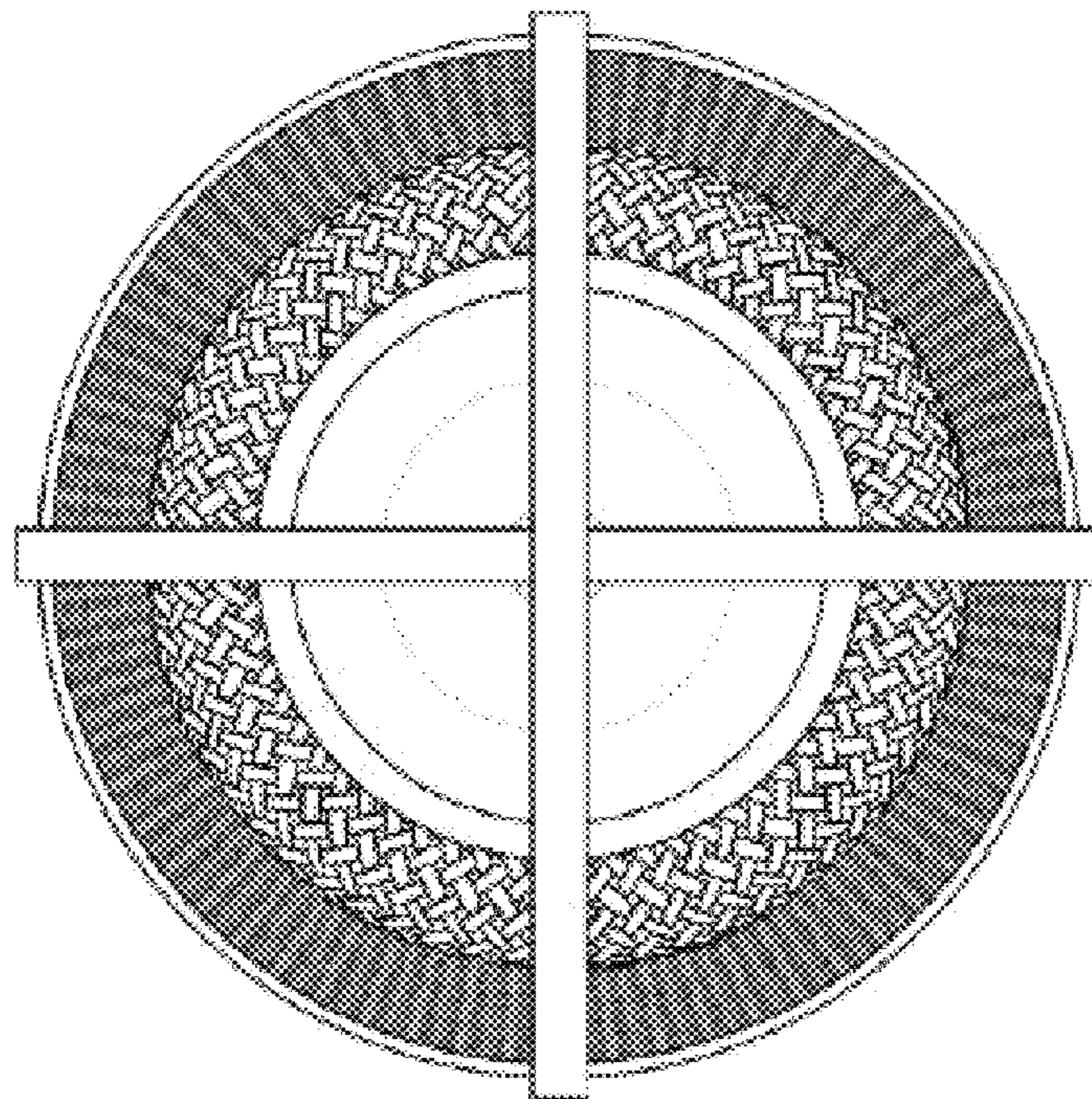
