DESCRIPTION

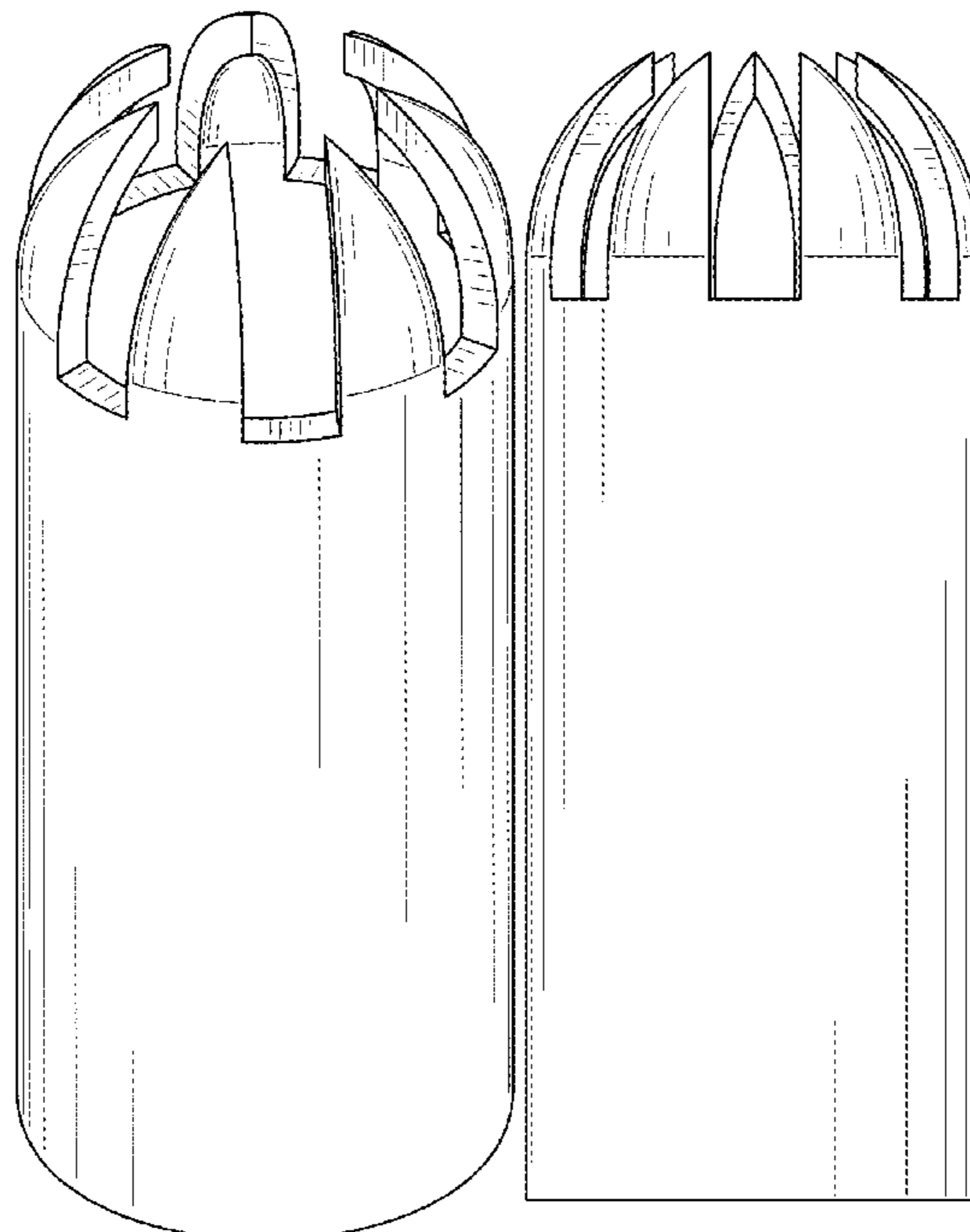
FIG. 1 is a perspective view of a tip for holding an adjustable-angled brush, showing our new design.

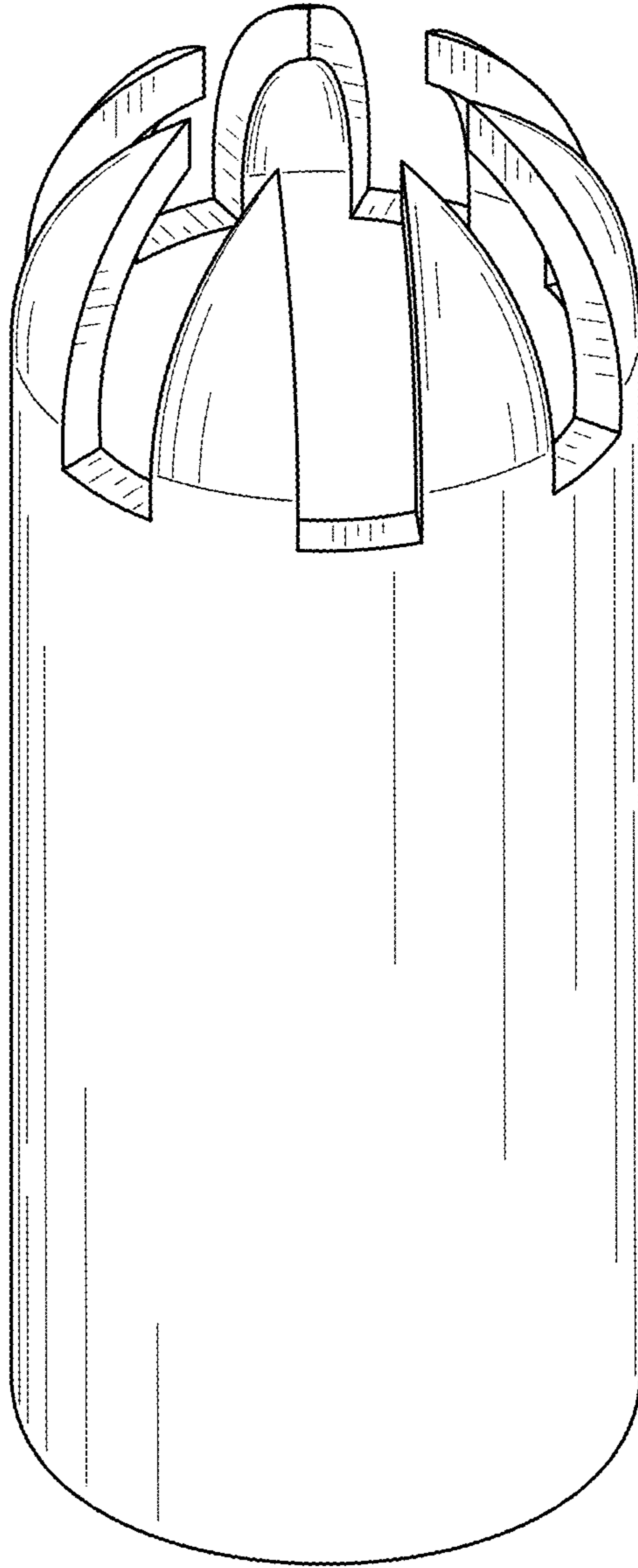

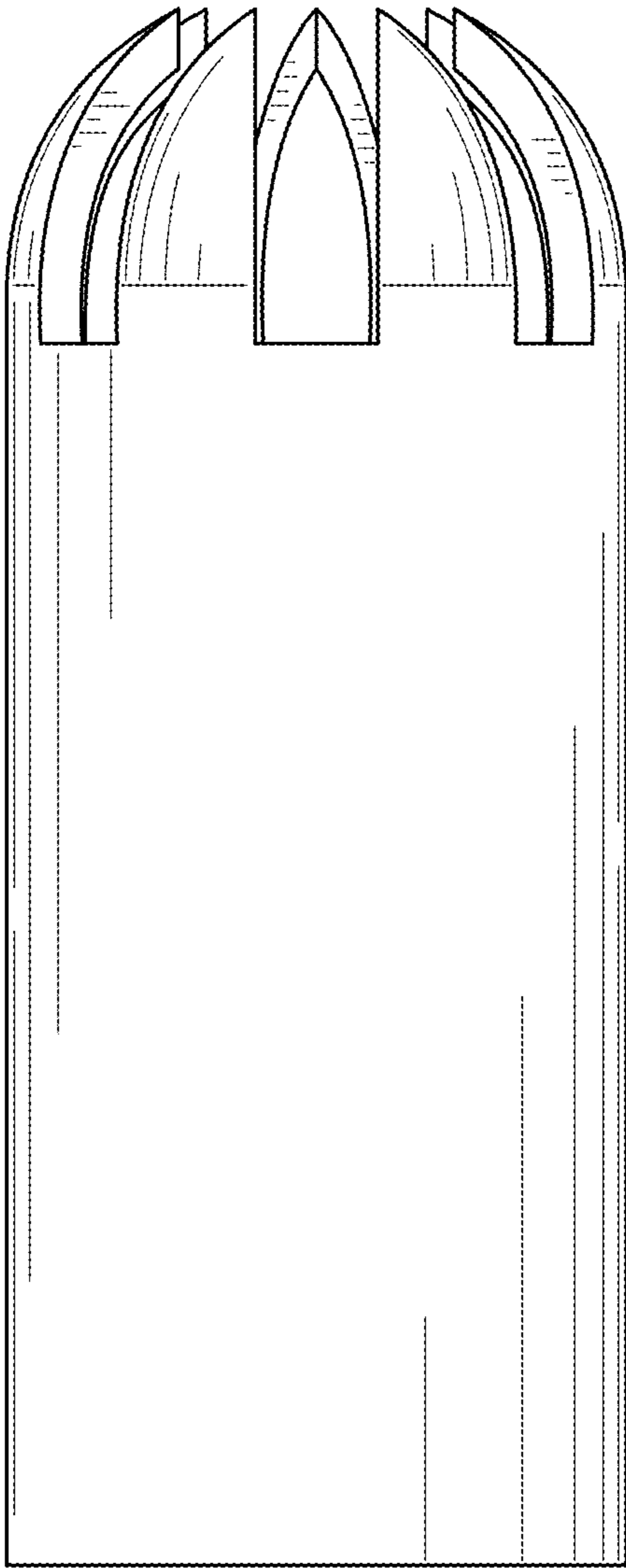

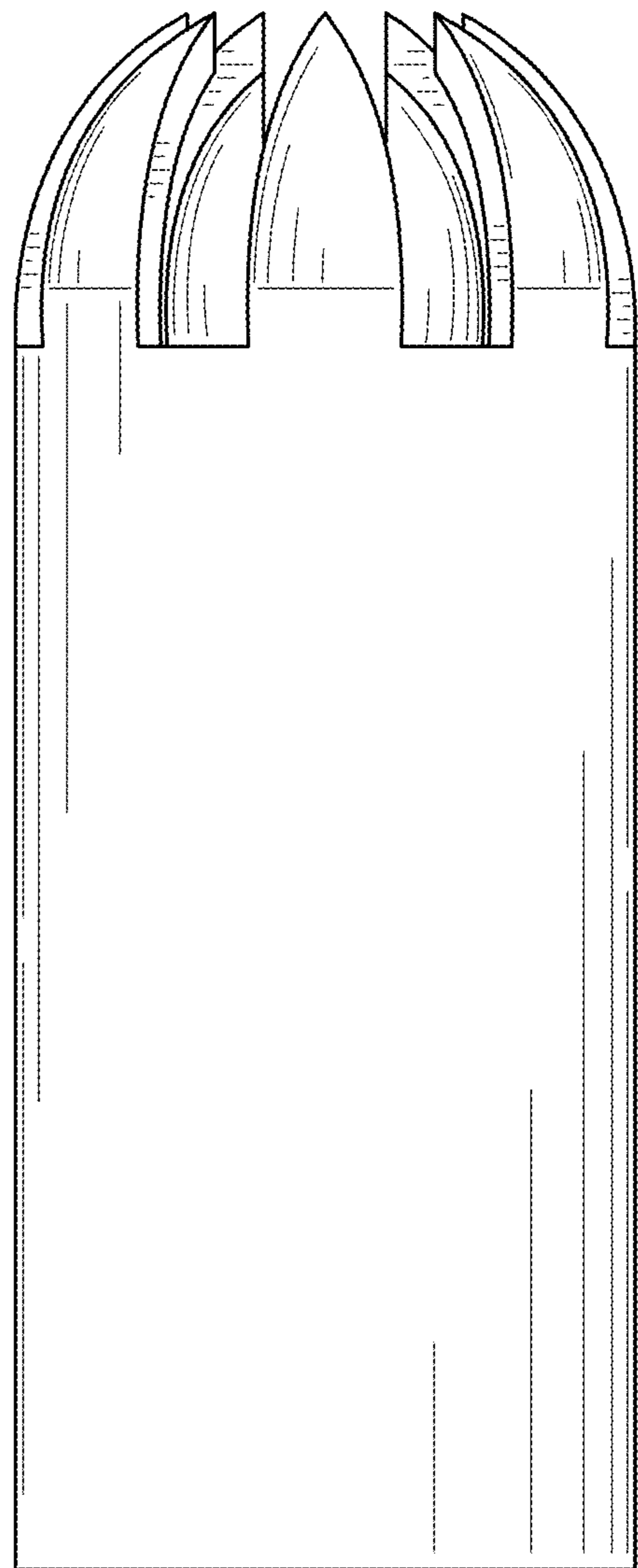

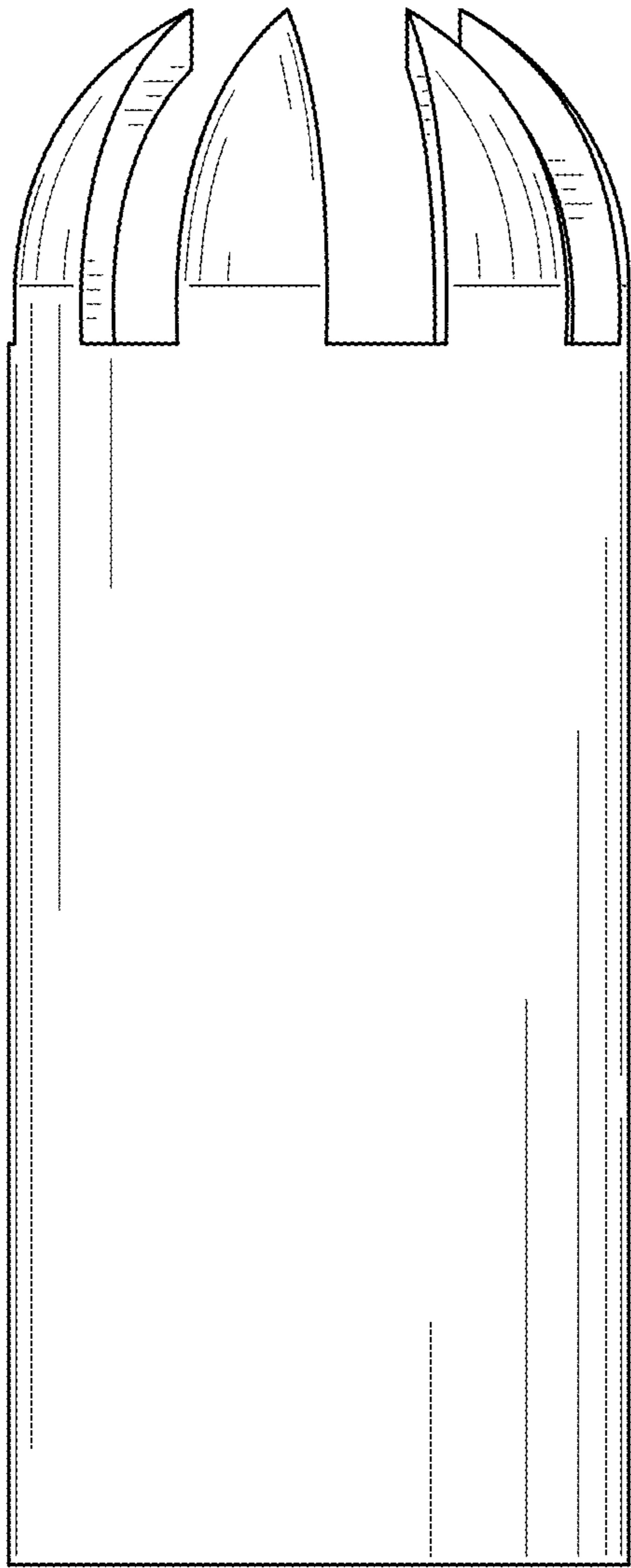

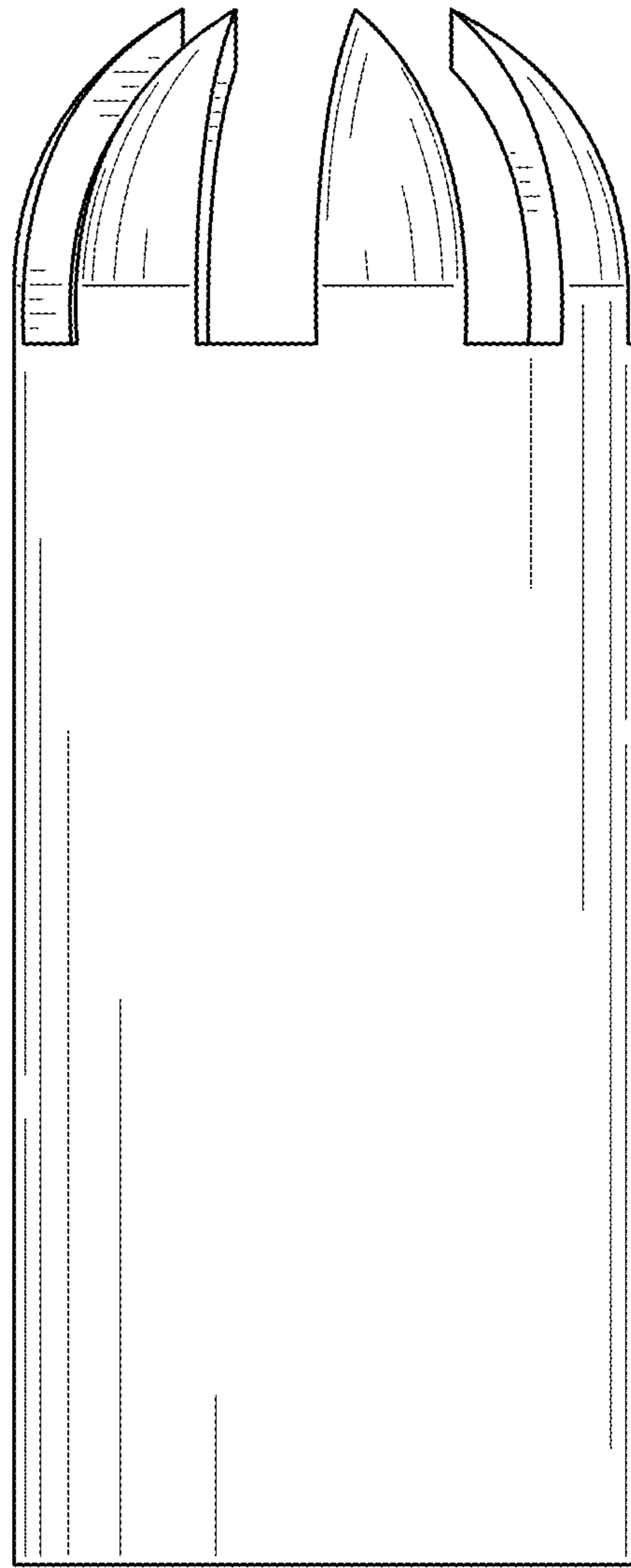

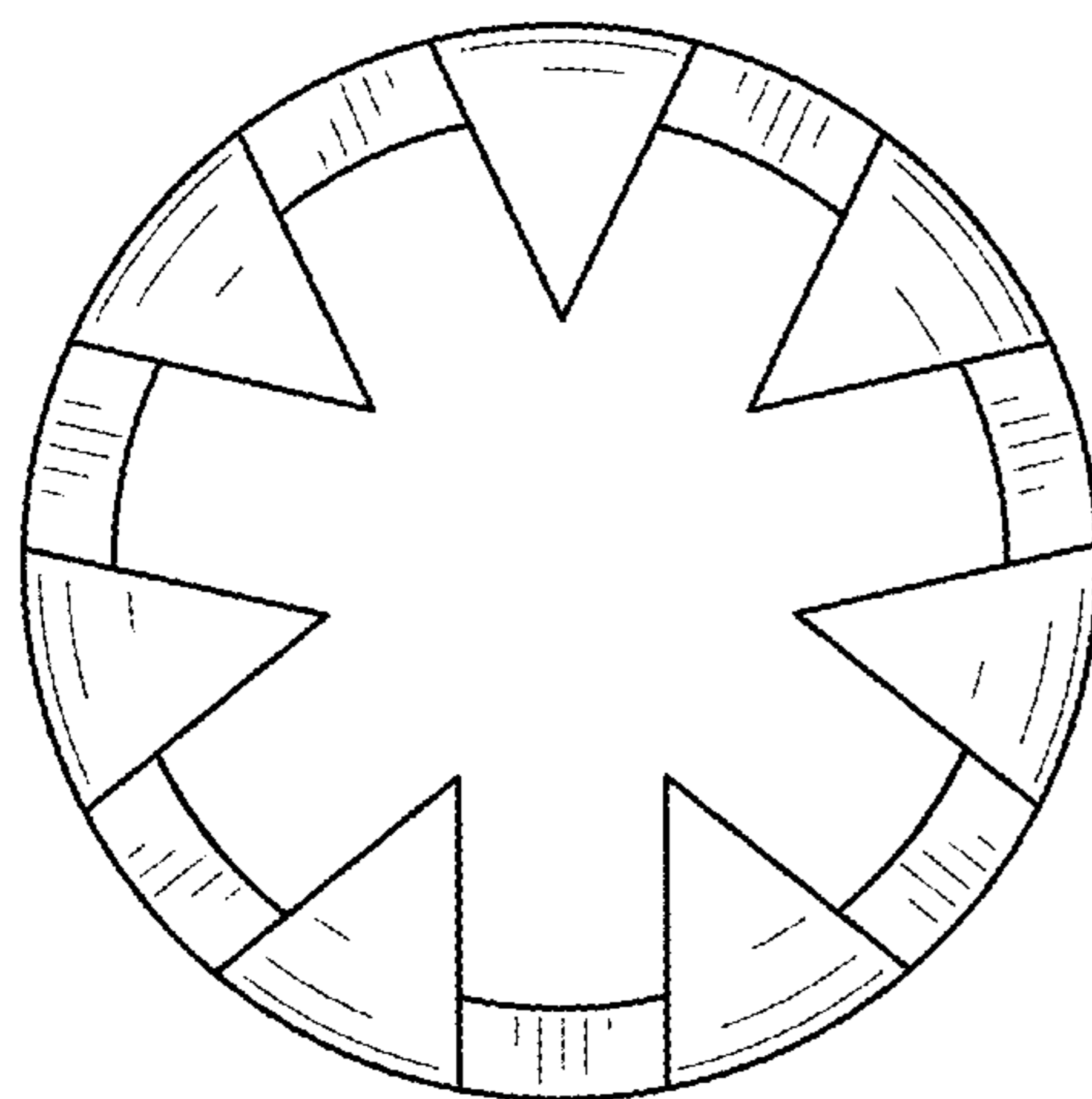

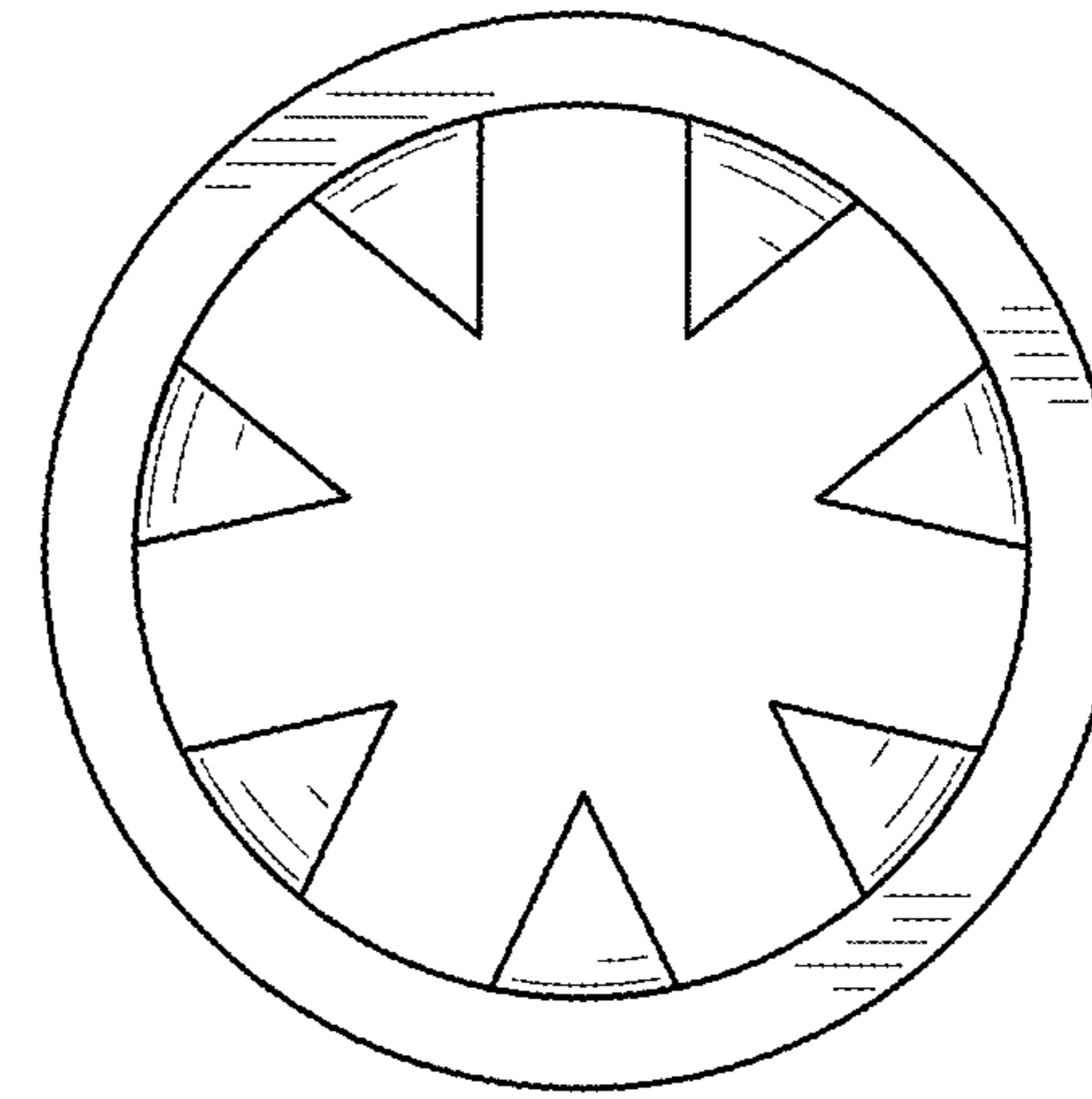
