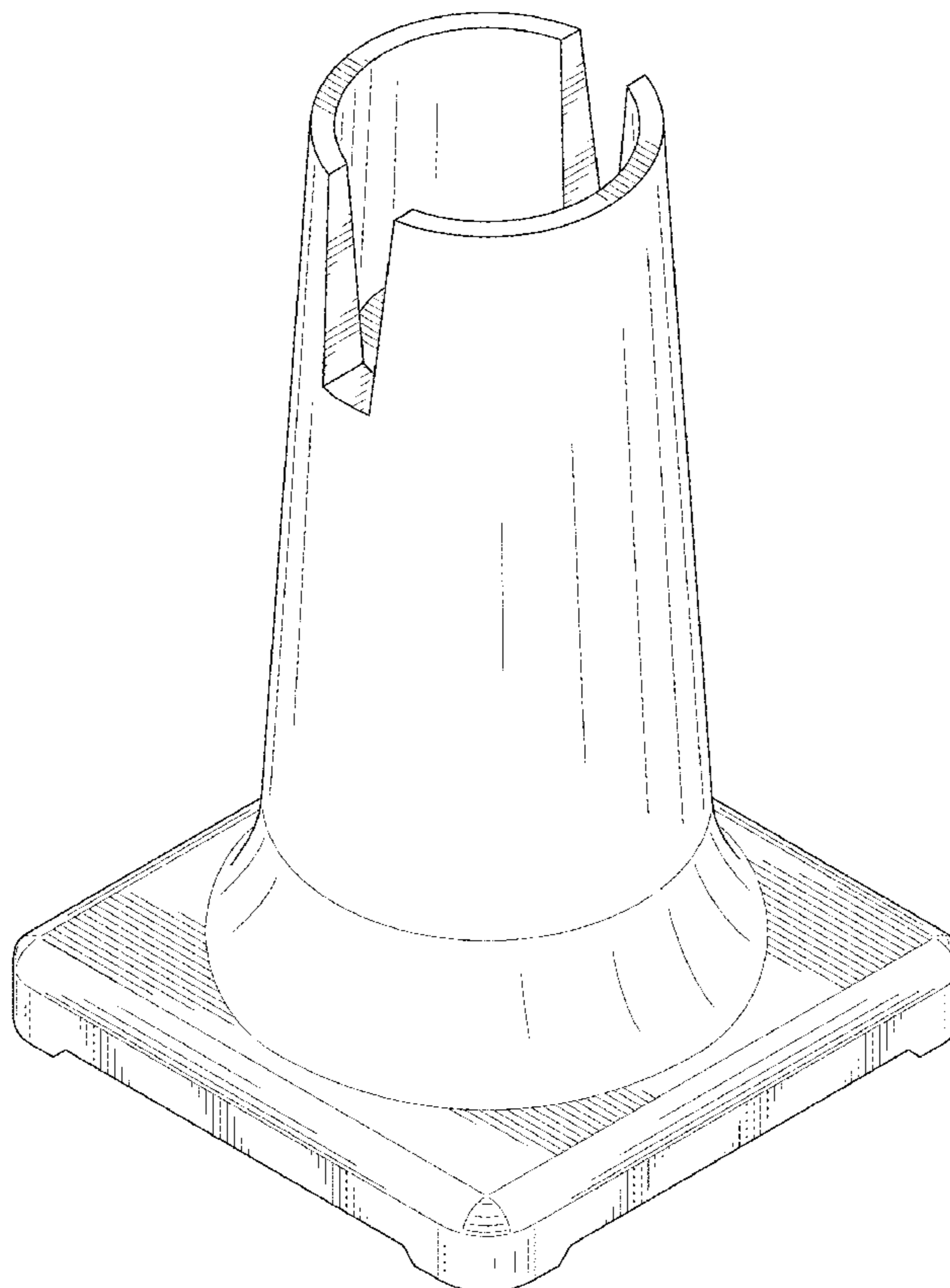
The ornamental design for a fire extinguisher stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the present invention;

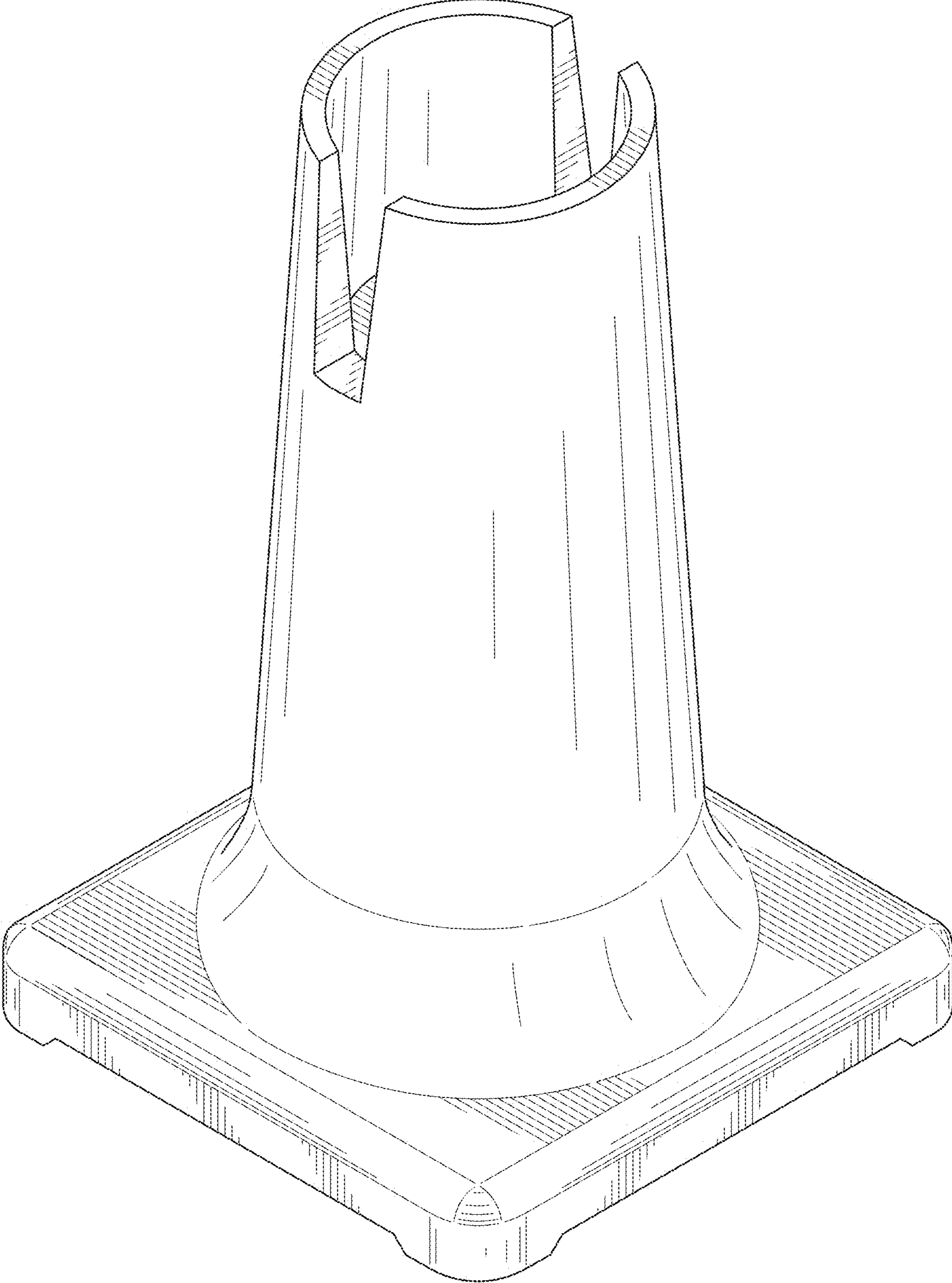

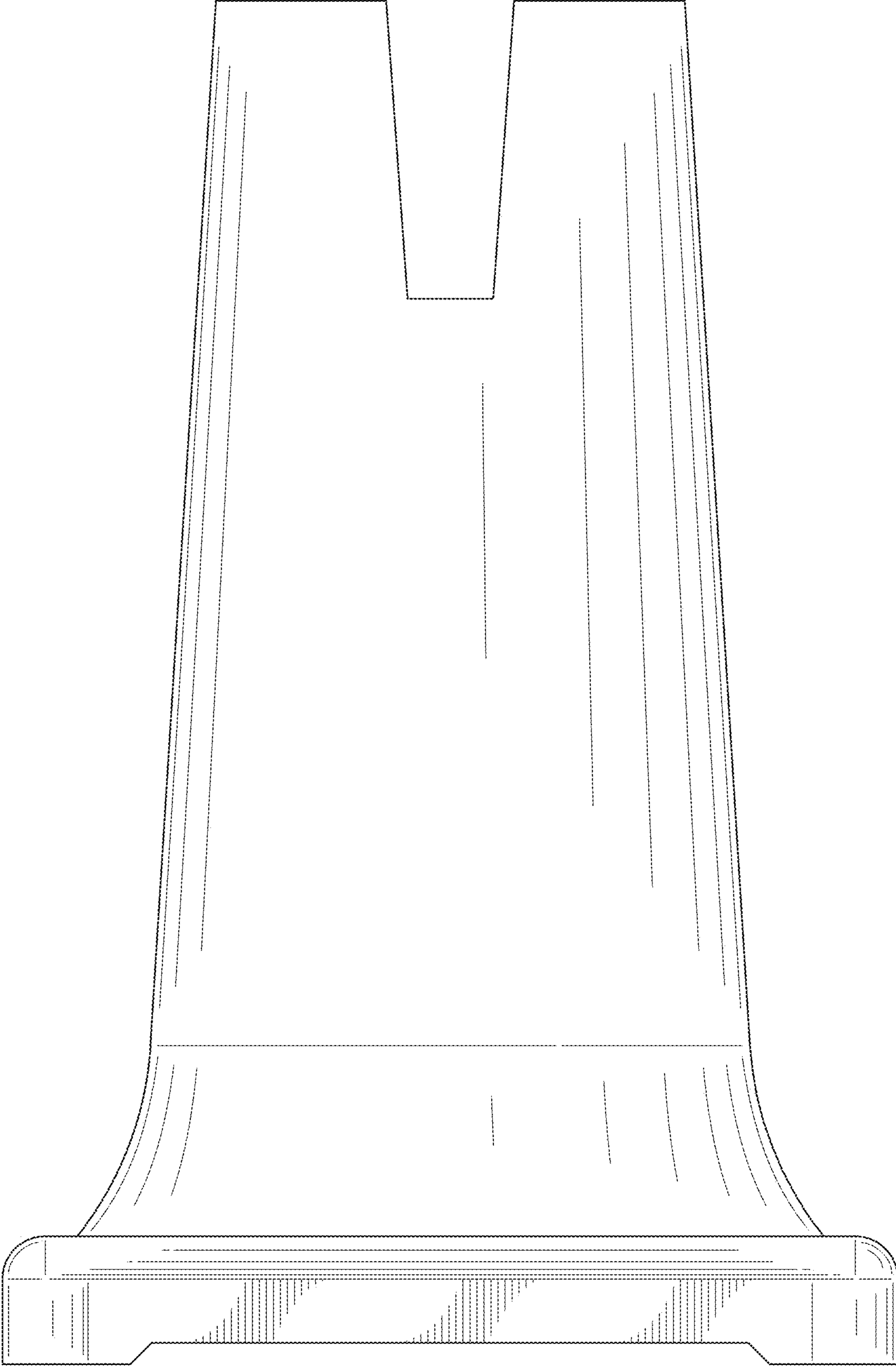

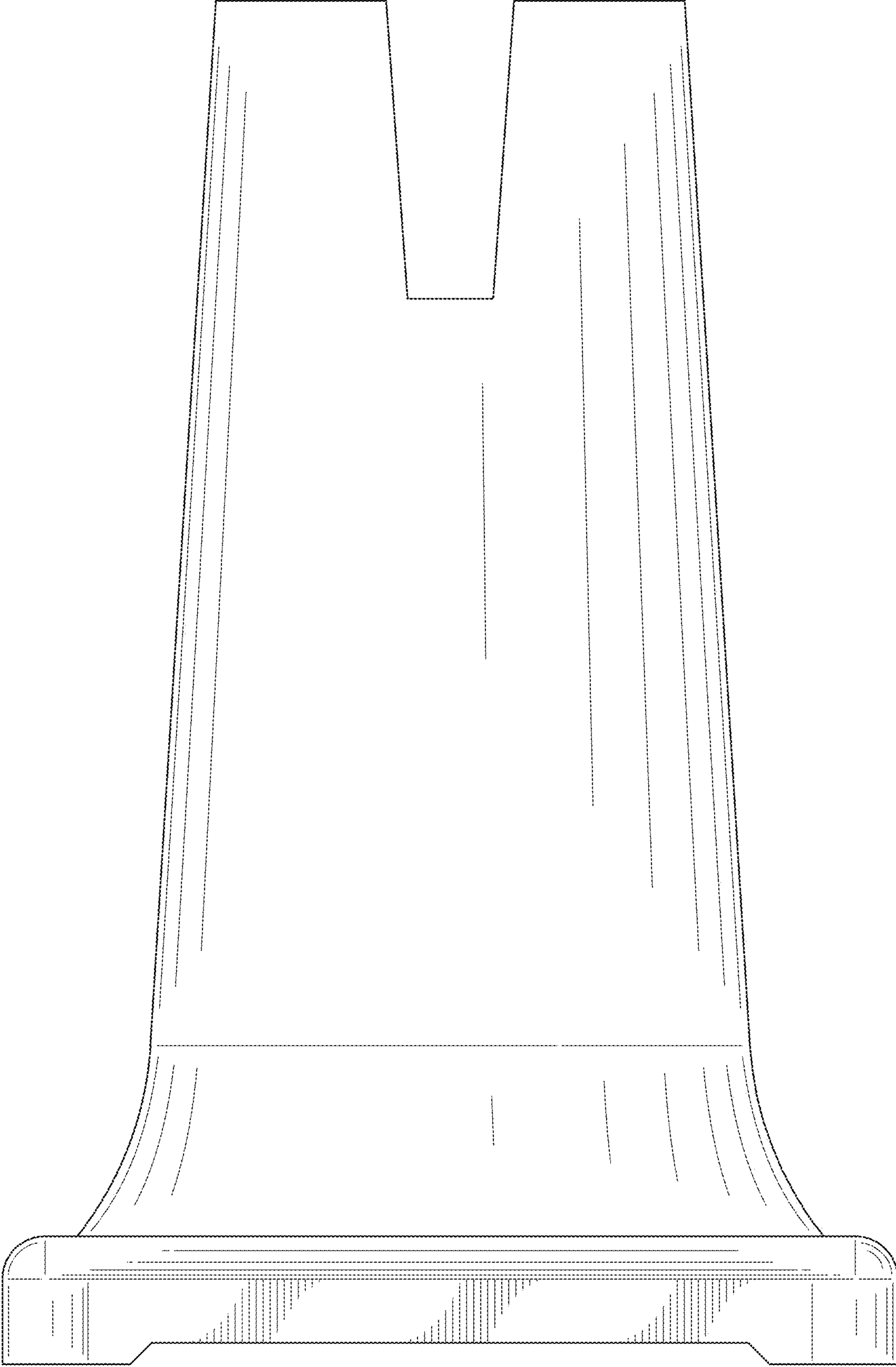

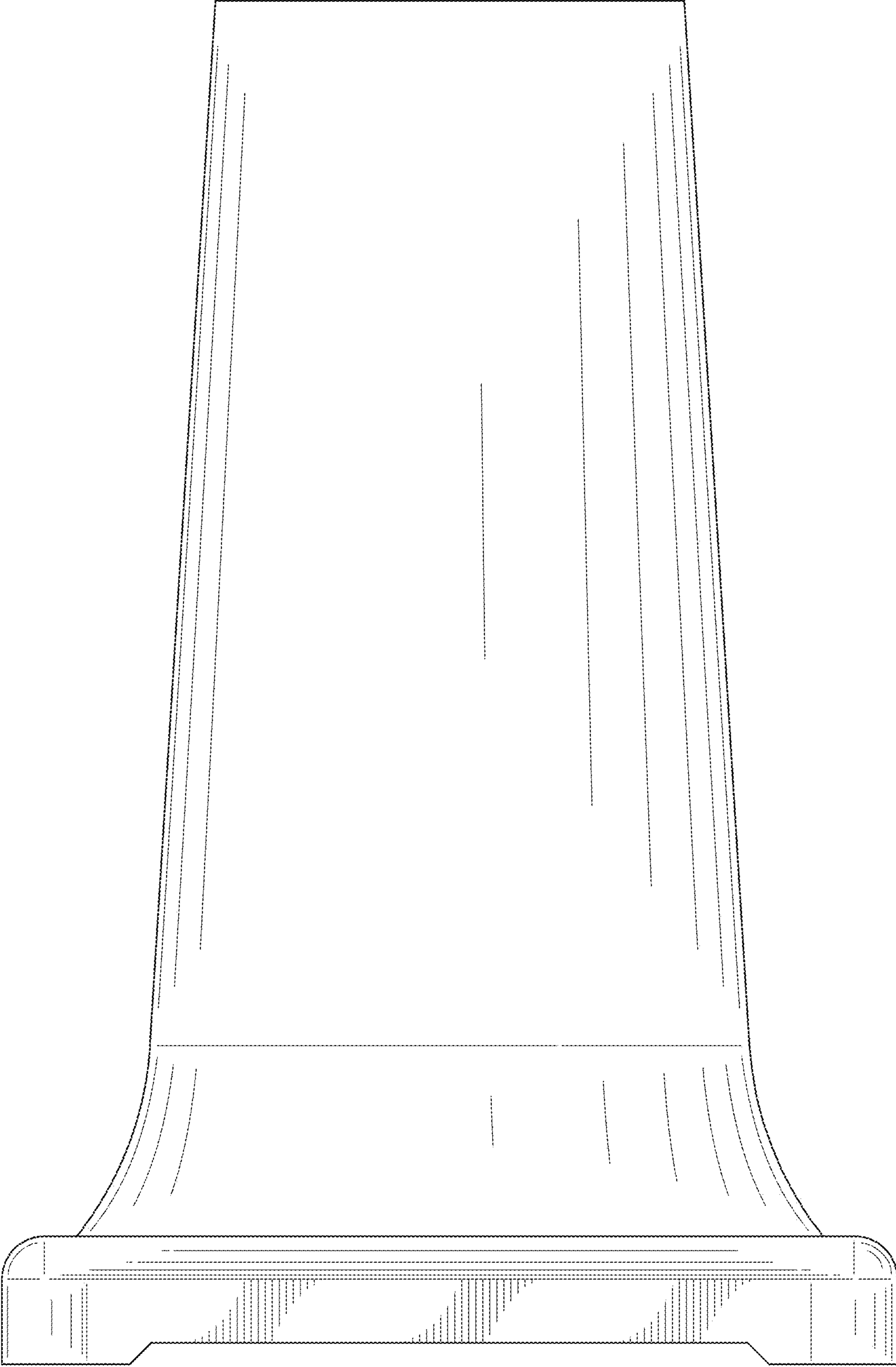

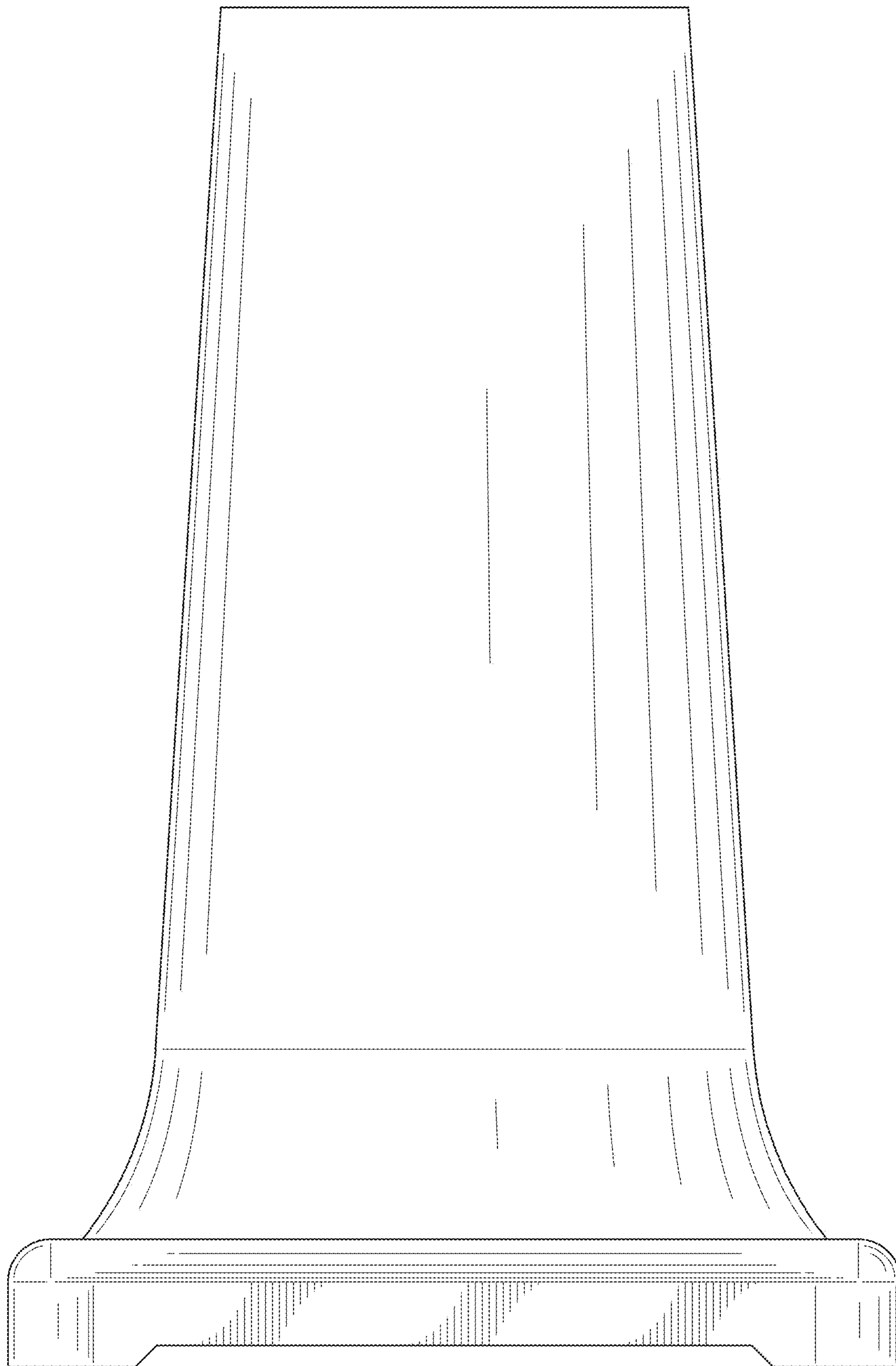

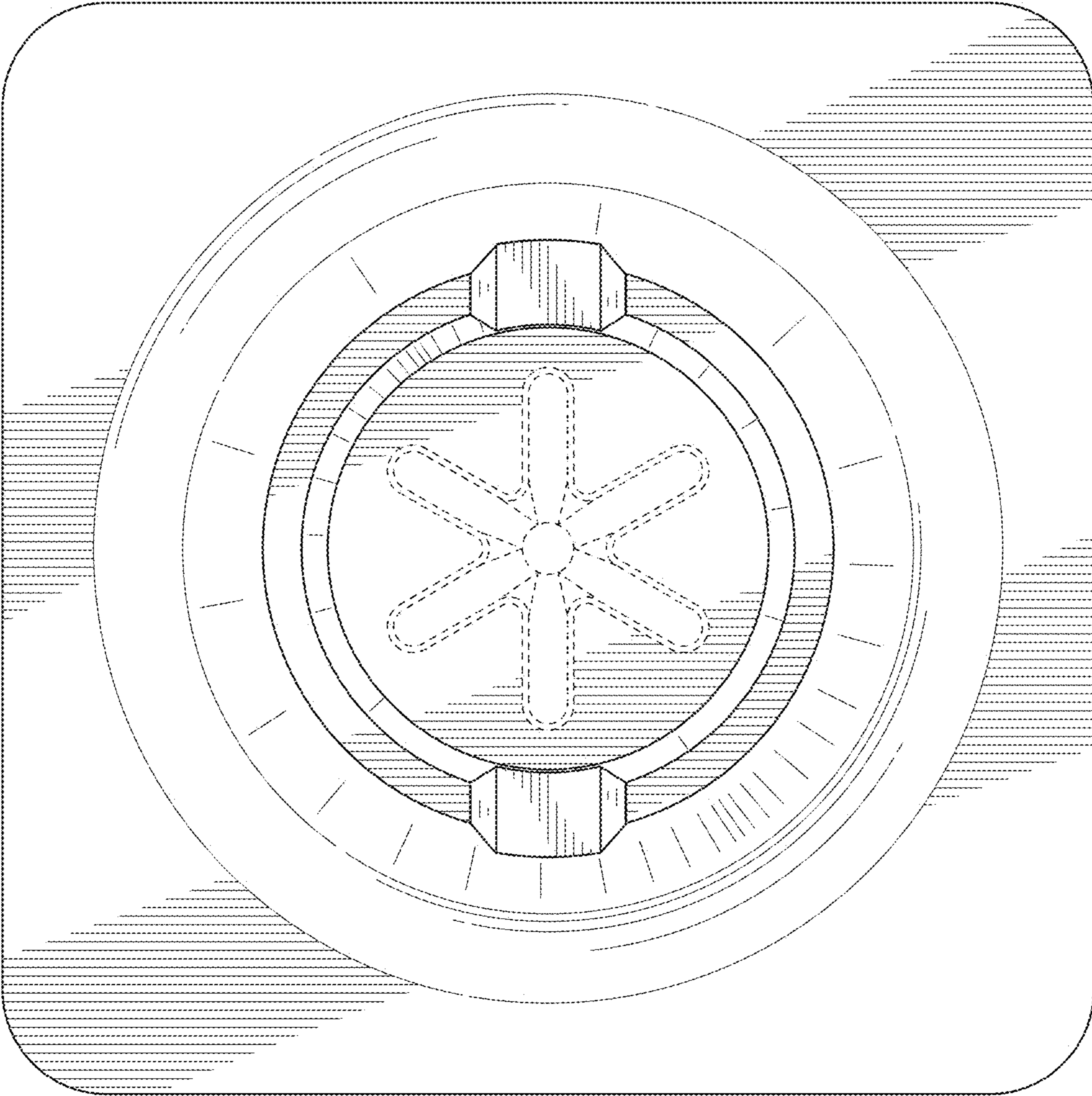

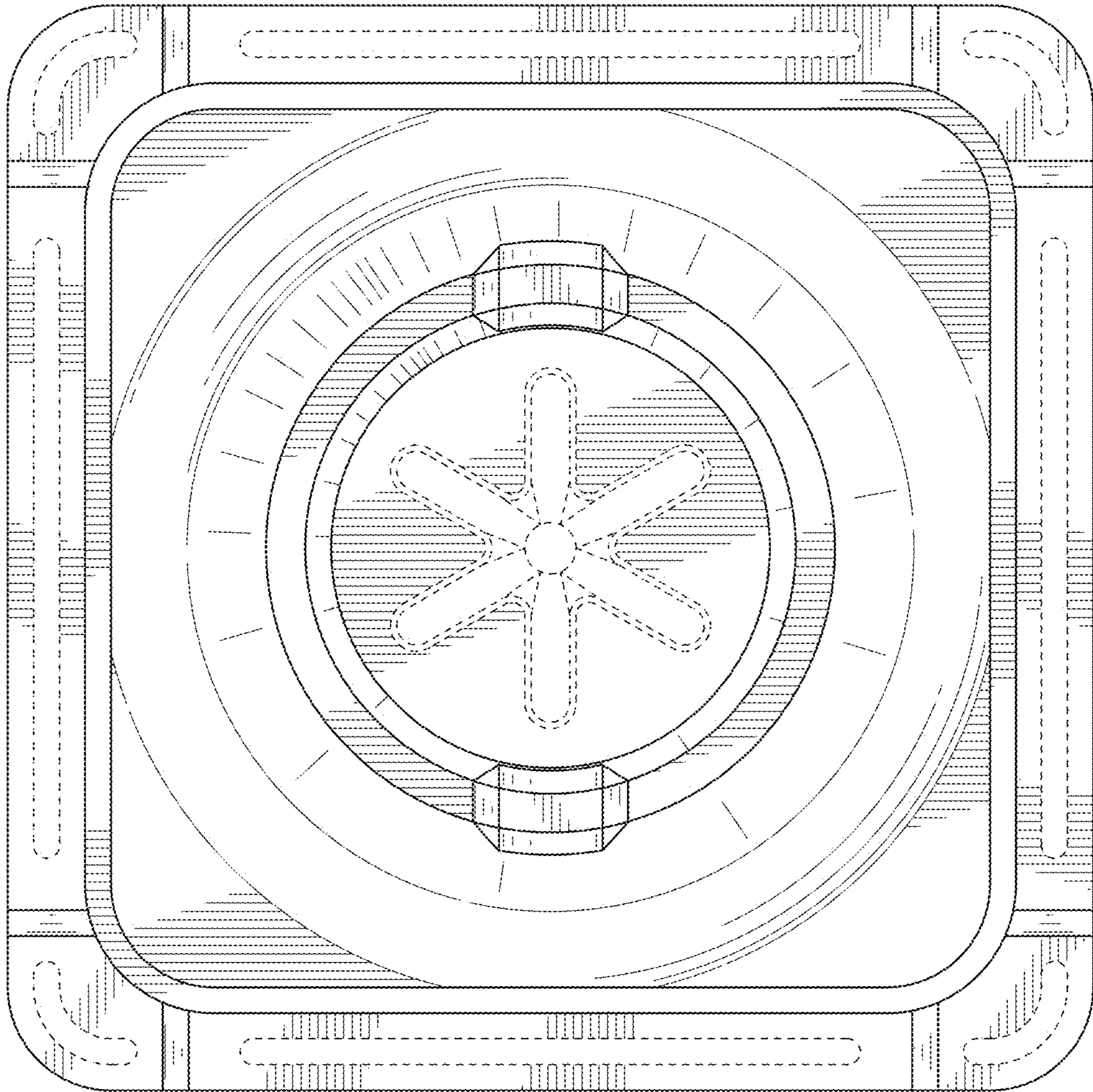

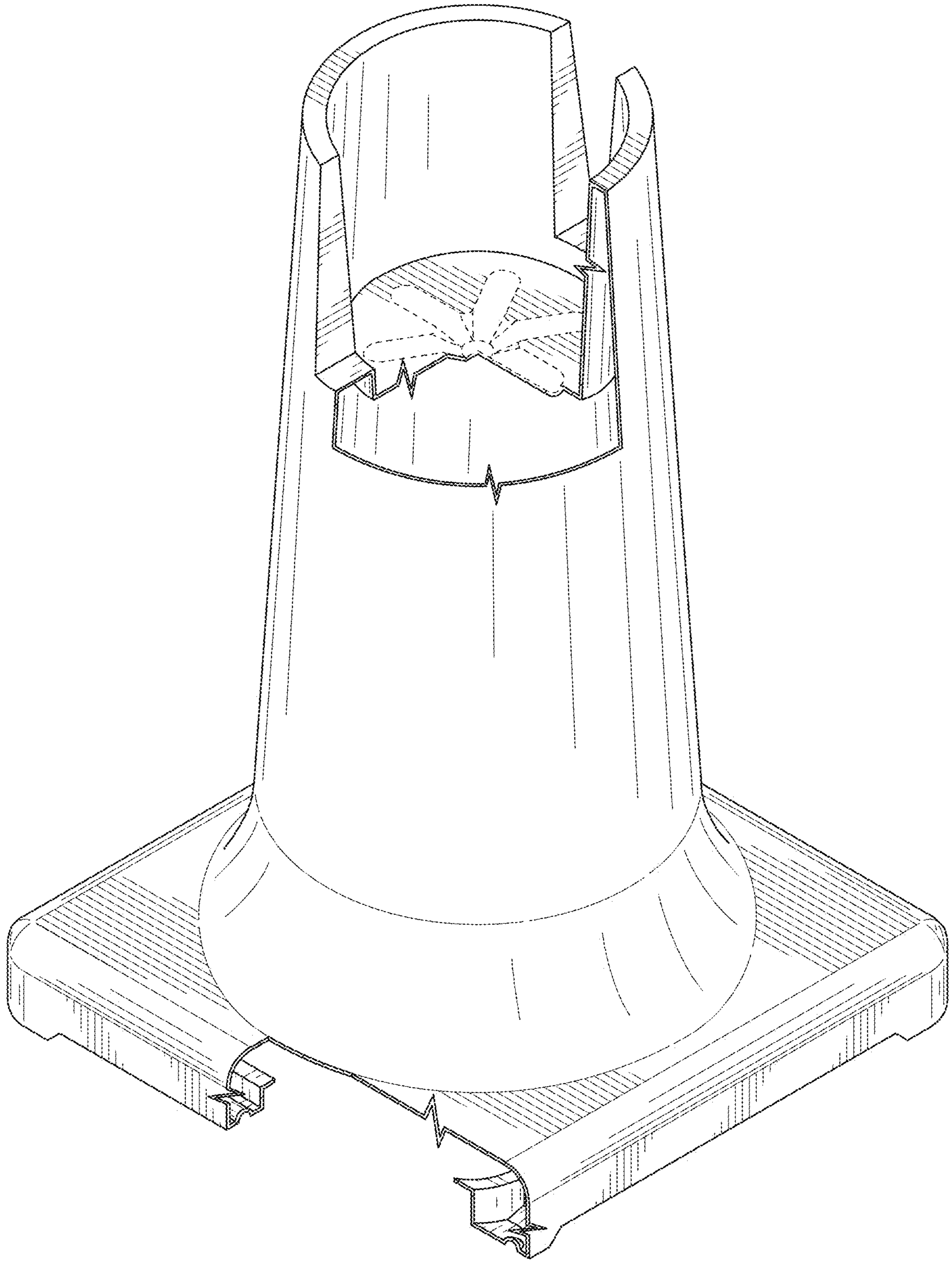
