The ornamental design for a head scarf, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a head scarf showing my new design;

FIG. 2 is a right side view thereof;

FIG. 3 is a rear view thereof;

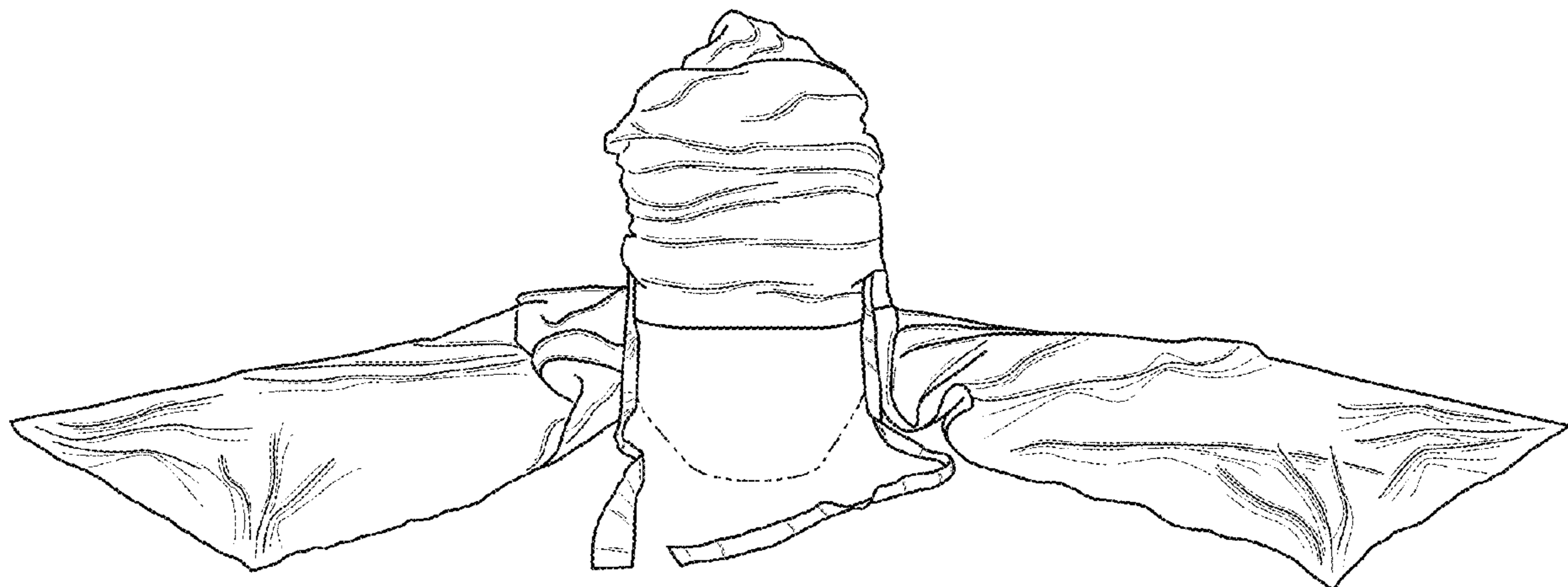
FIG. 4 is a left side view thereof; and,

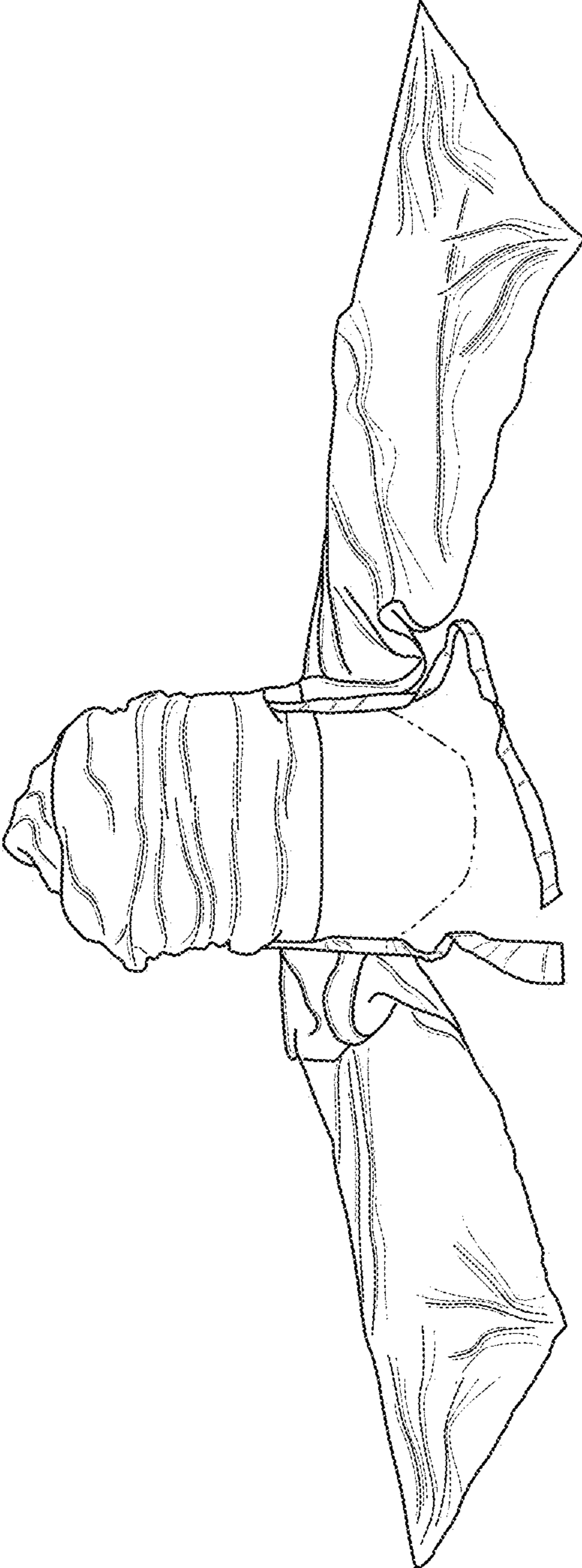

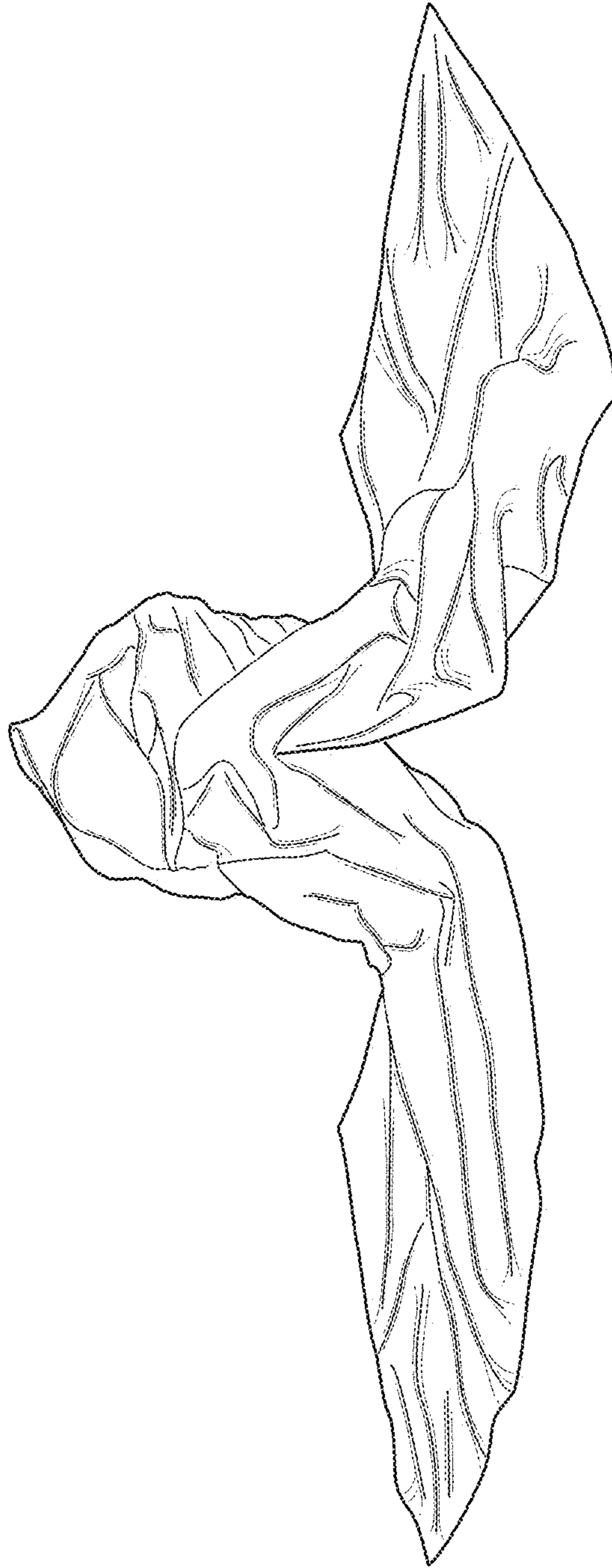

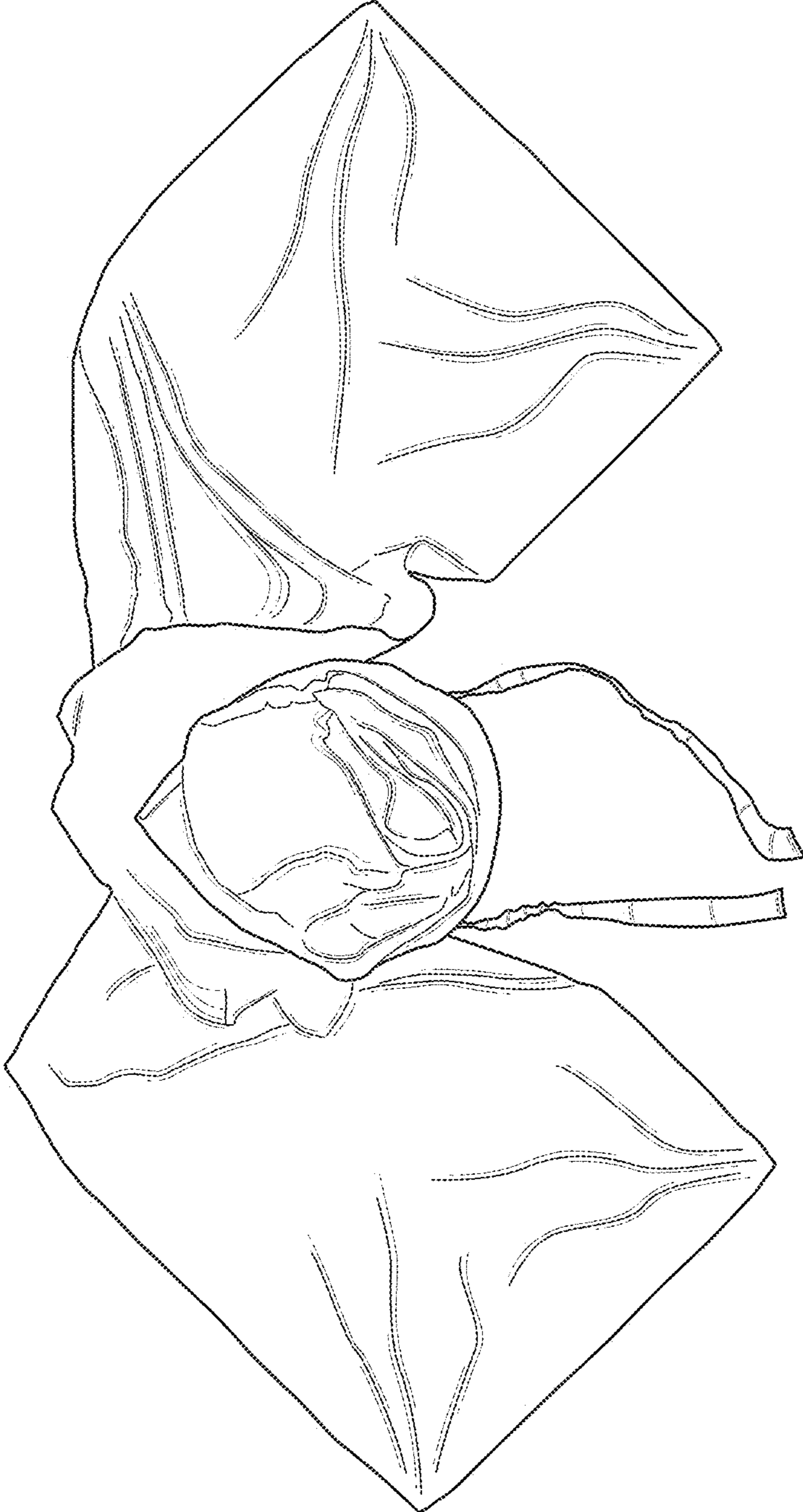
