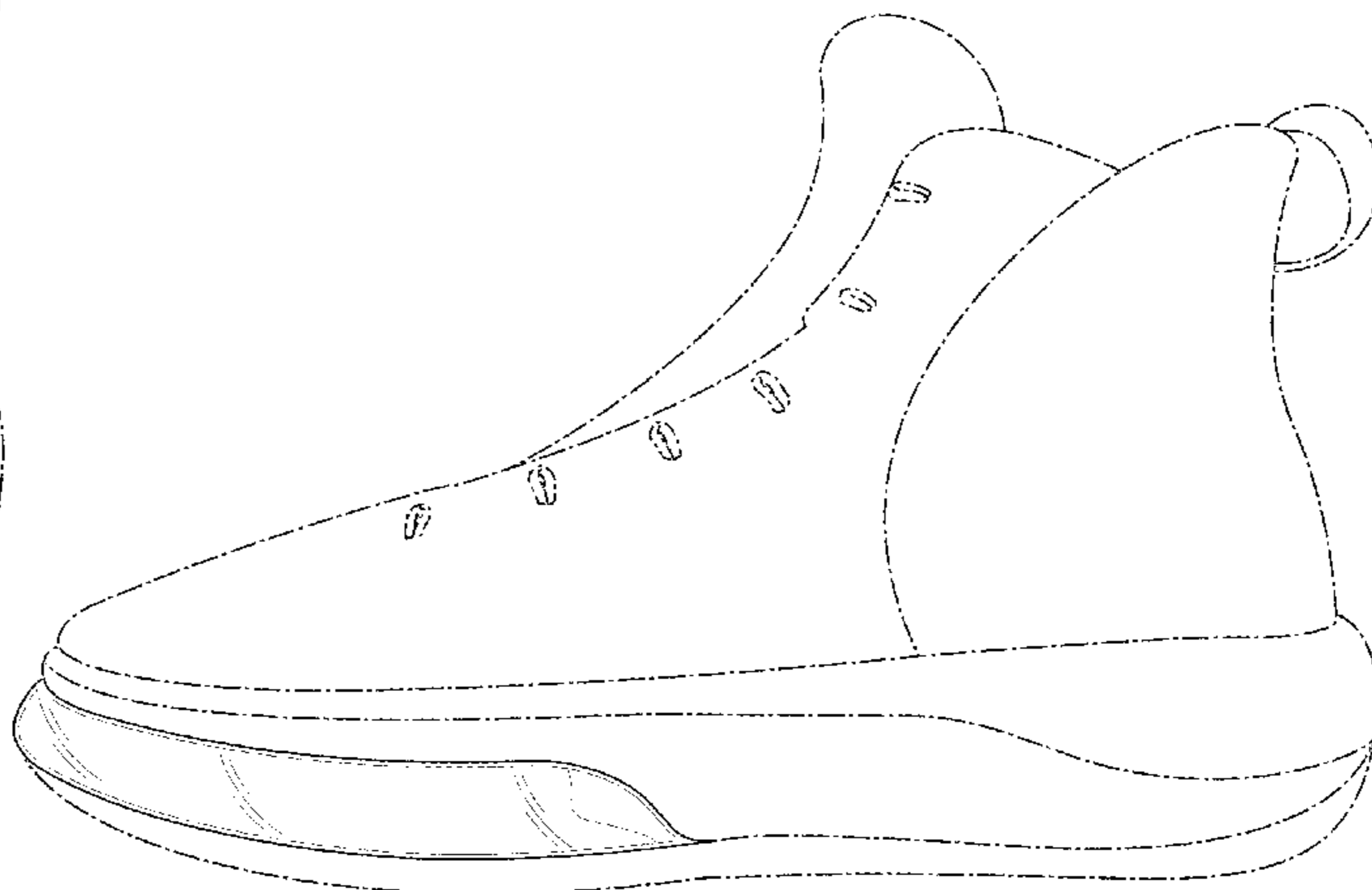
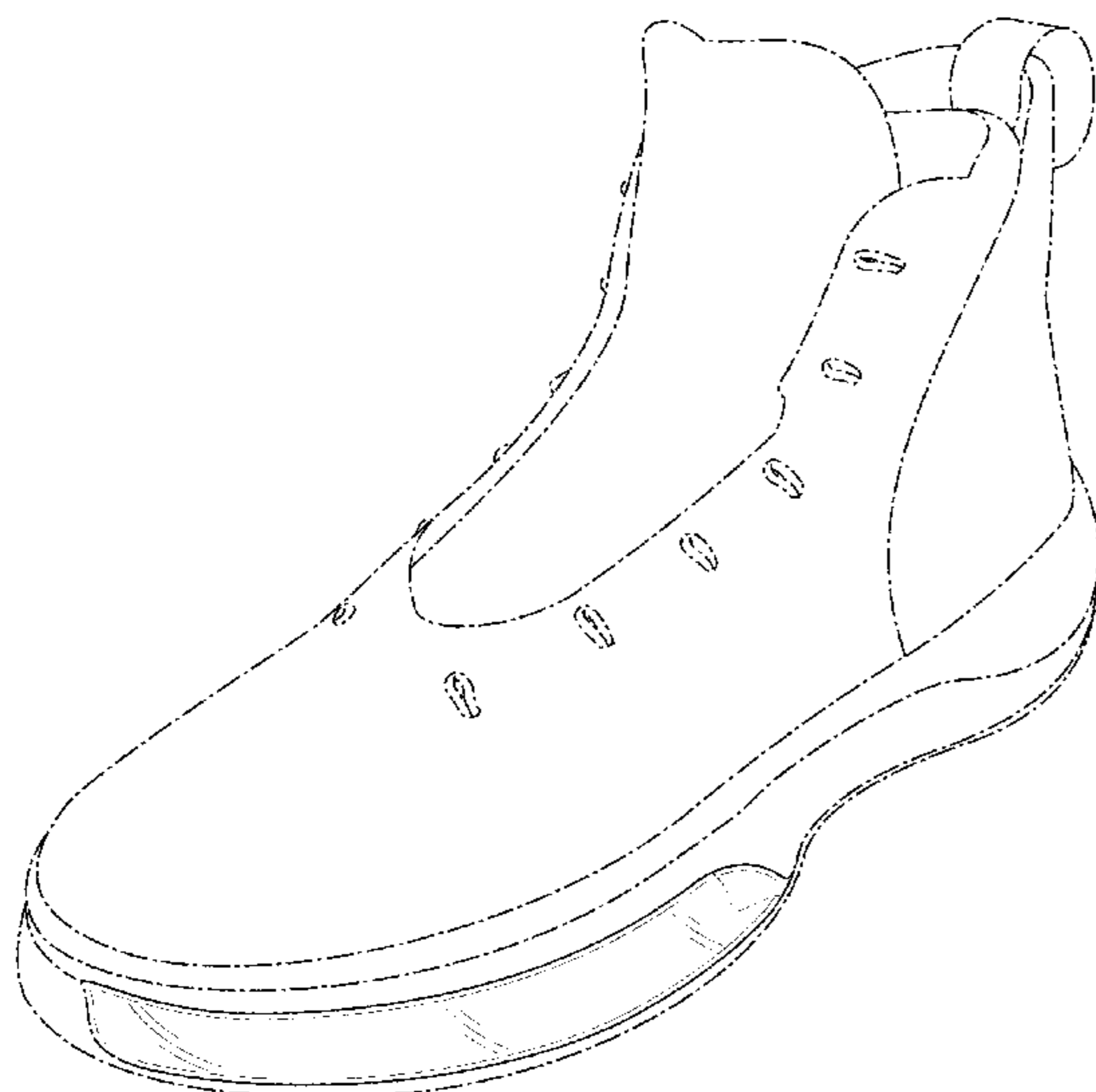
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is a side view thereof; and,  
FIG. 3 is a front view thereof.  
The broken line immediately adjacent to the front-most end of the shaded area defines the bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

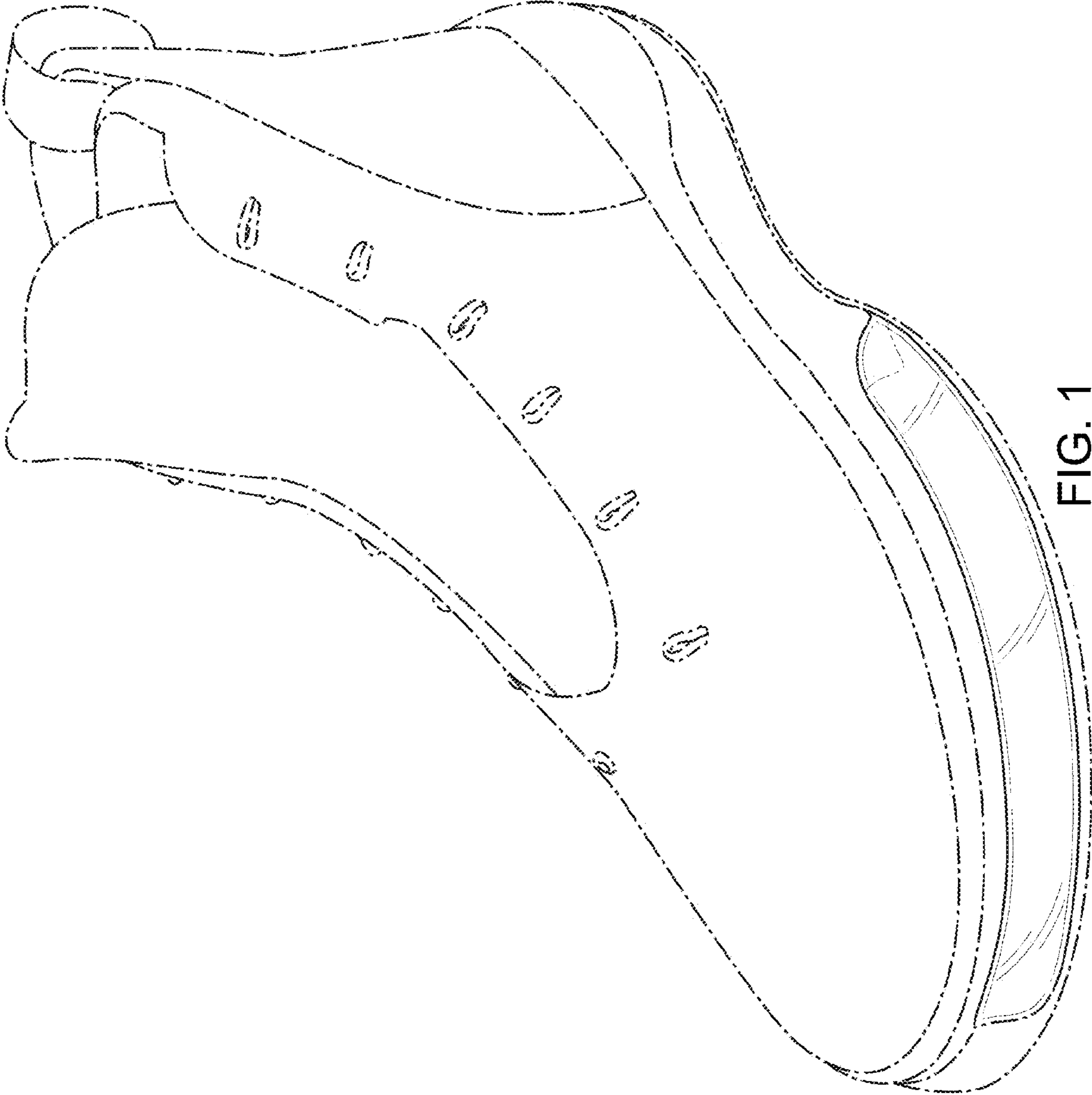

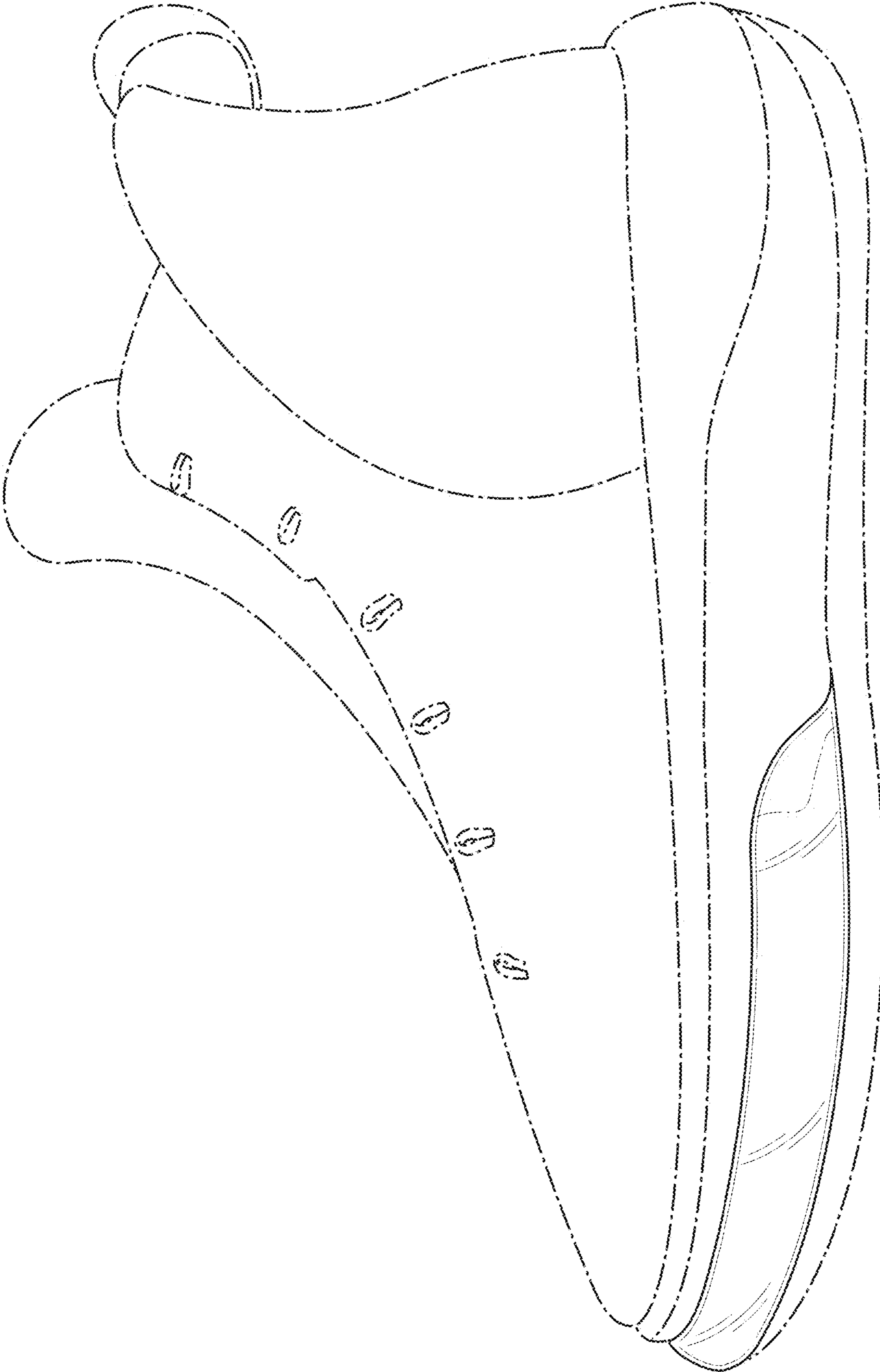

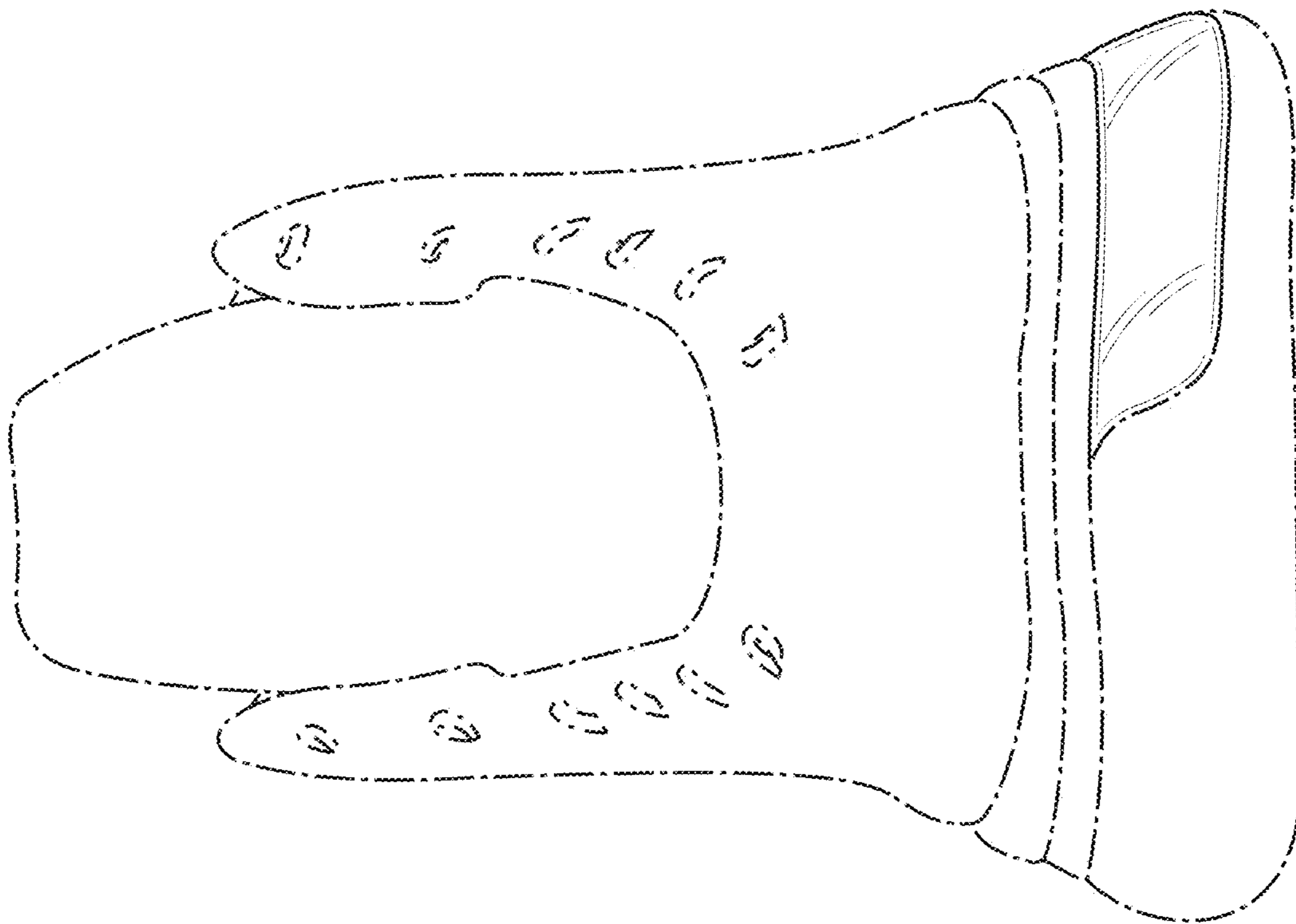
