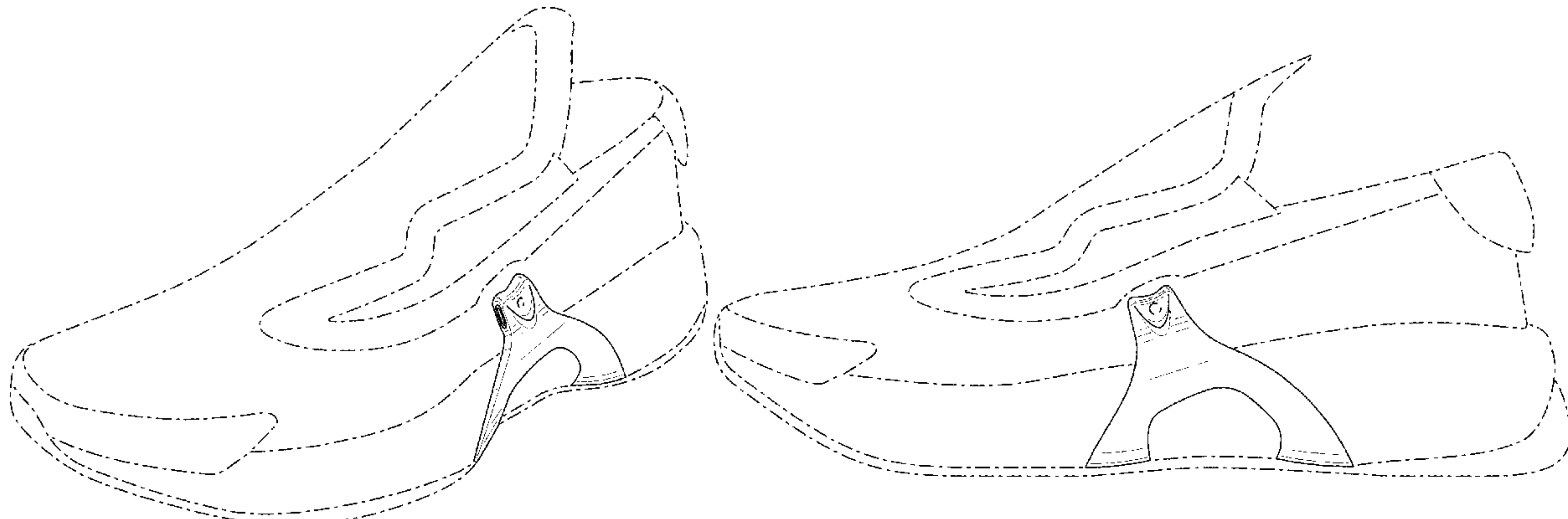
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
 FIG. 2 is a side view thereof;
 FIG. 3 is a rear perspective view thereof; and,
 FIG. 4 is a top view thereof.
 The broken line showing of the circular region within the shaded area represents a feature that forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

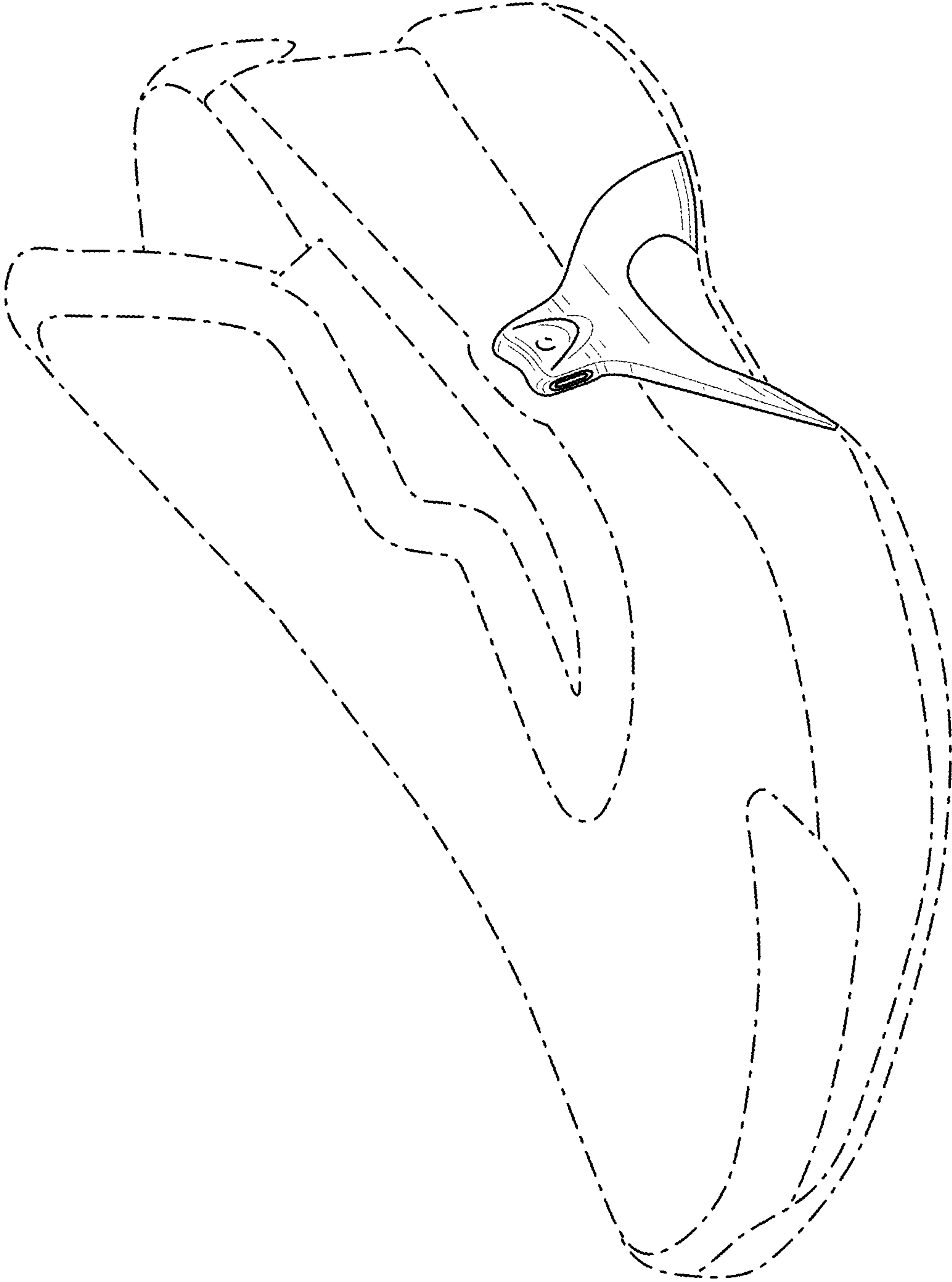

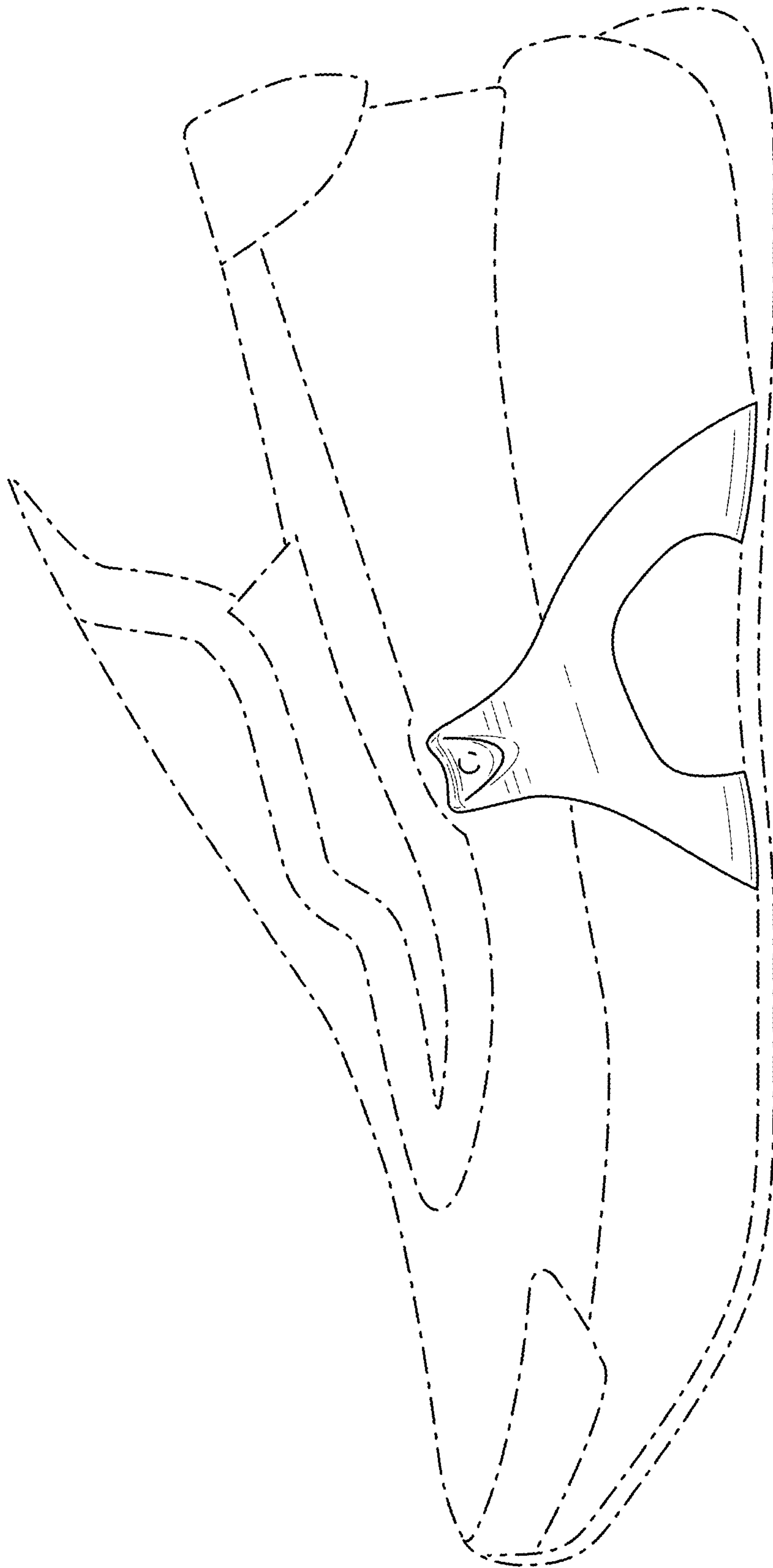

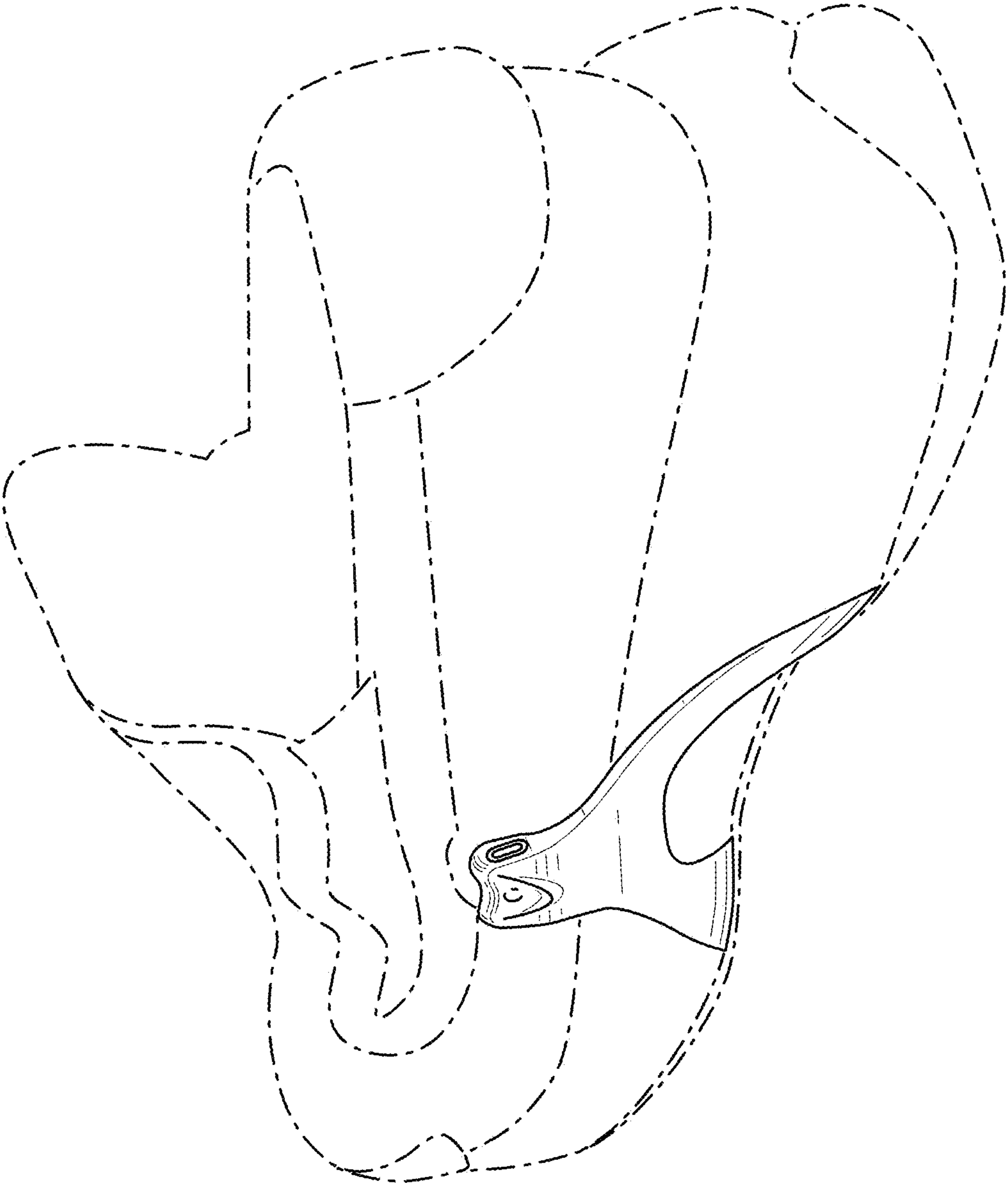

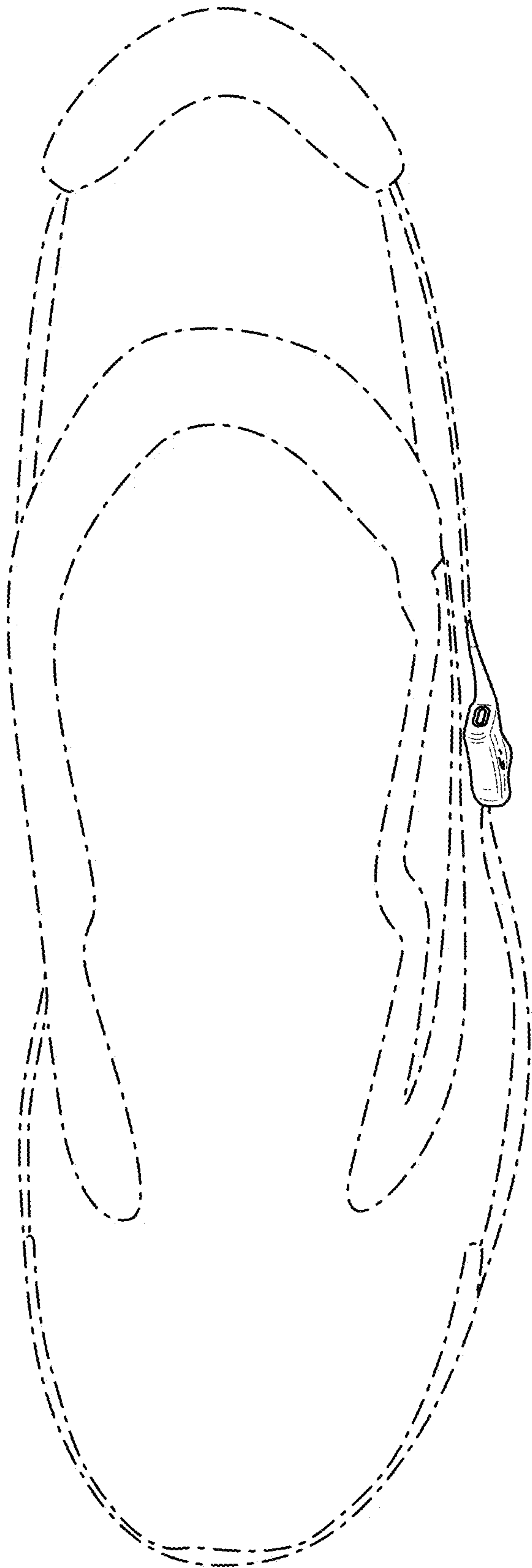
