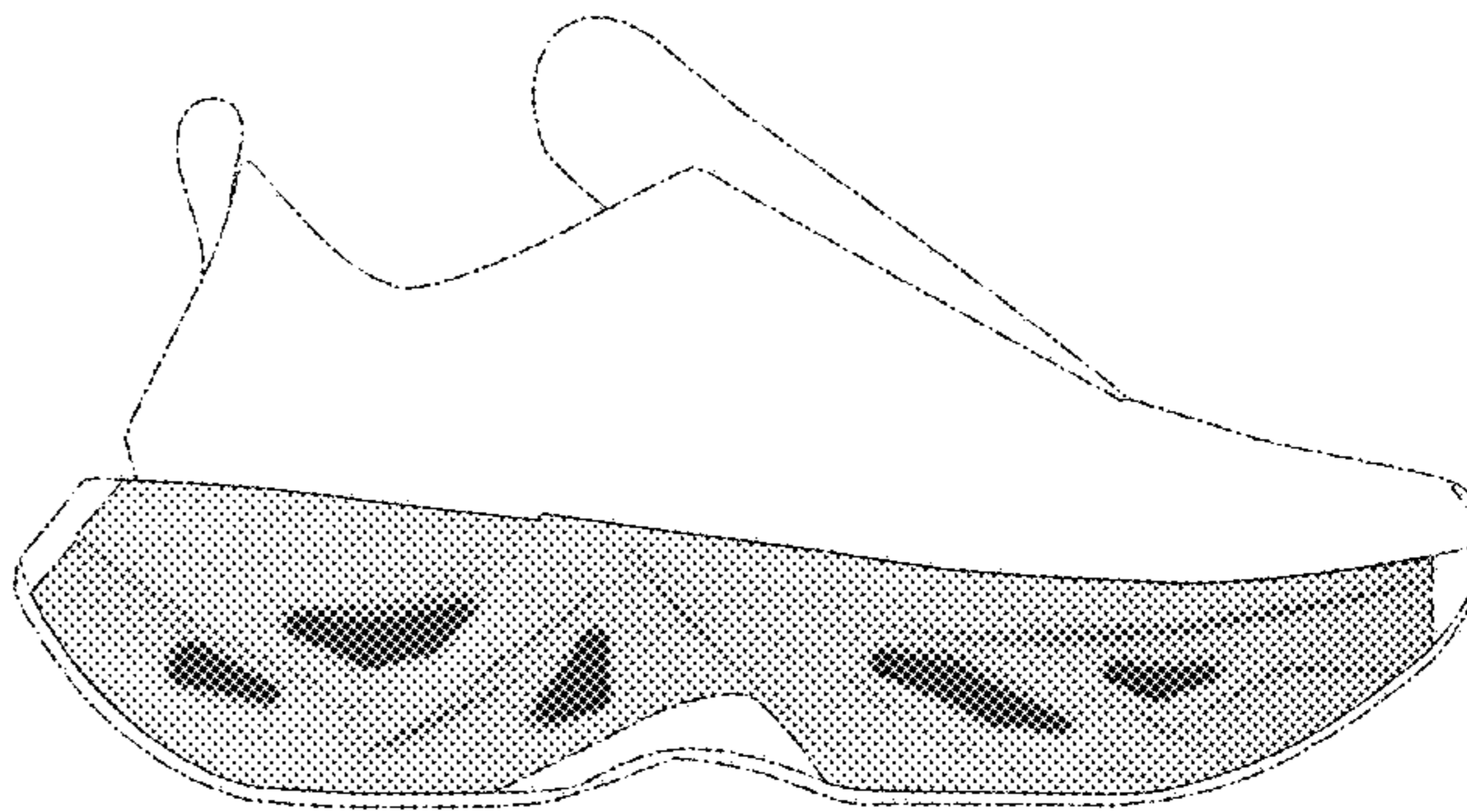
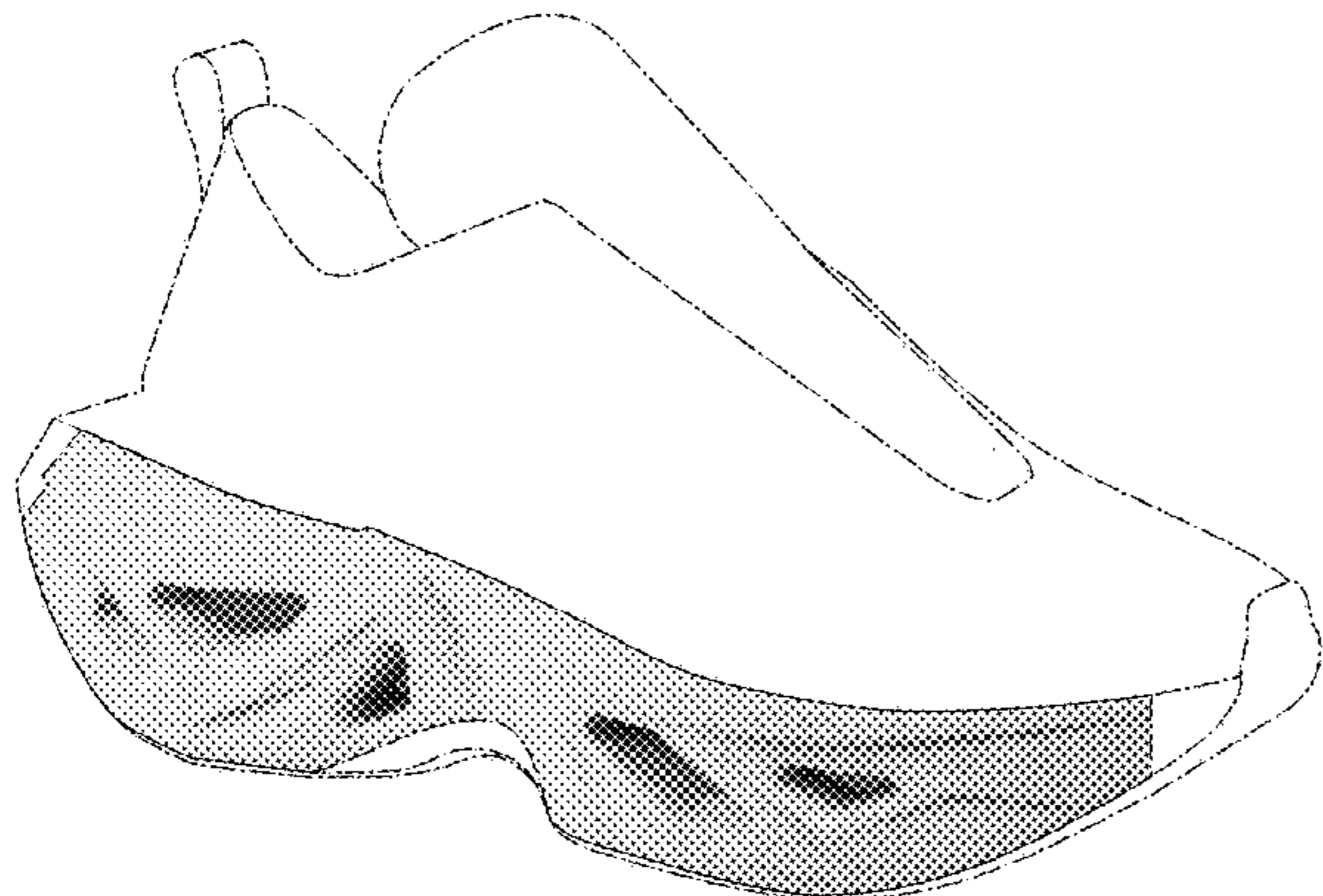

**DESCRIPTION**

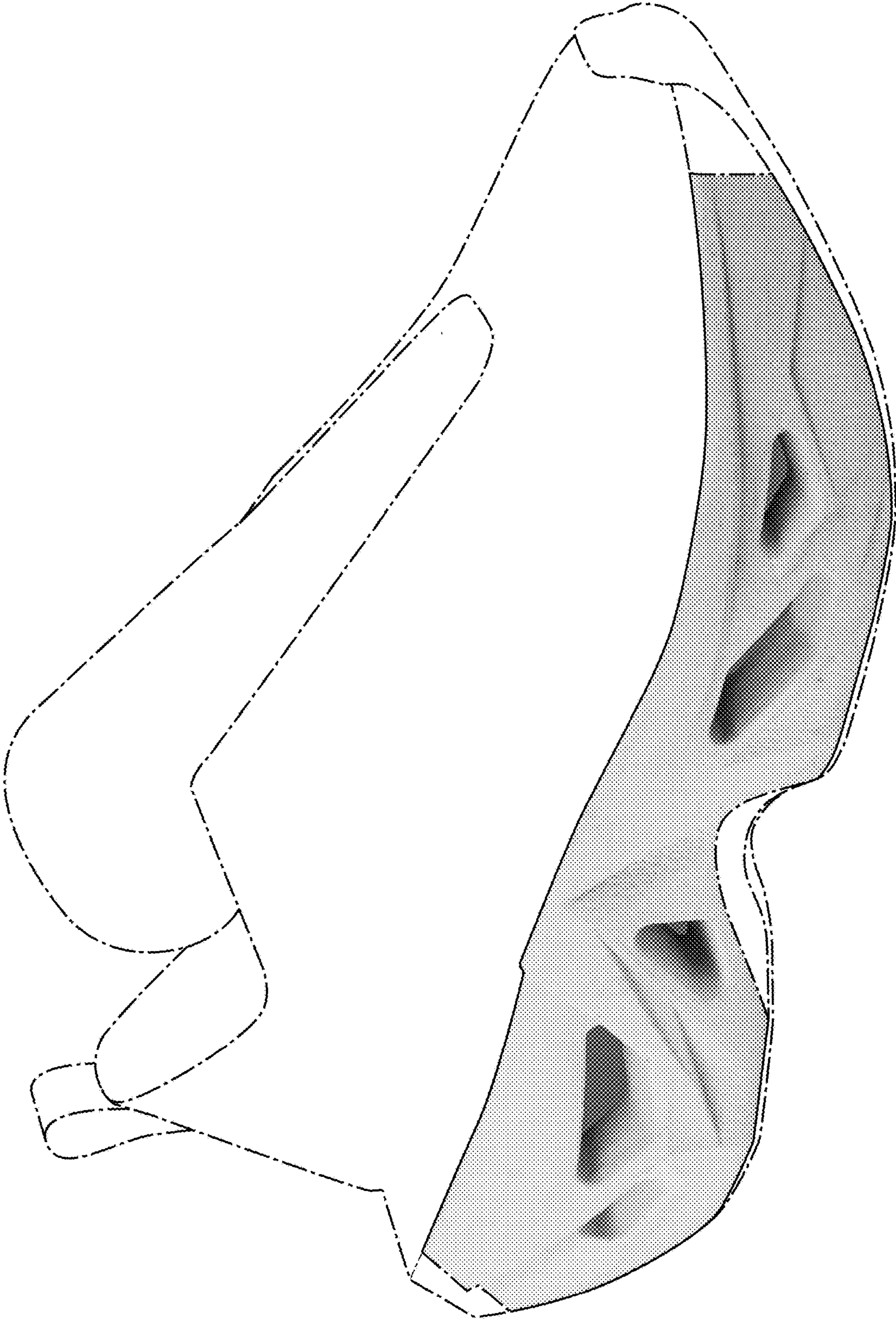

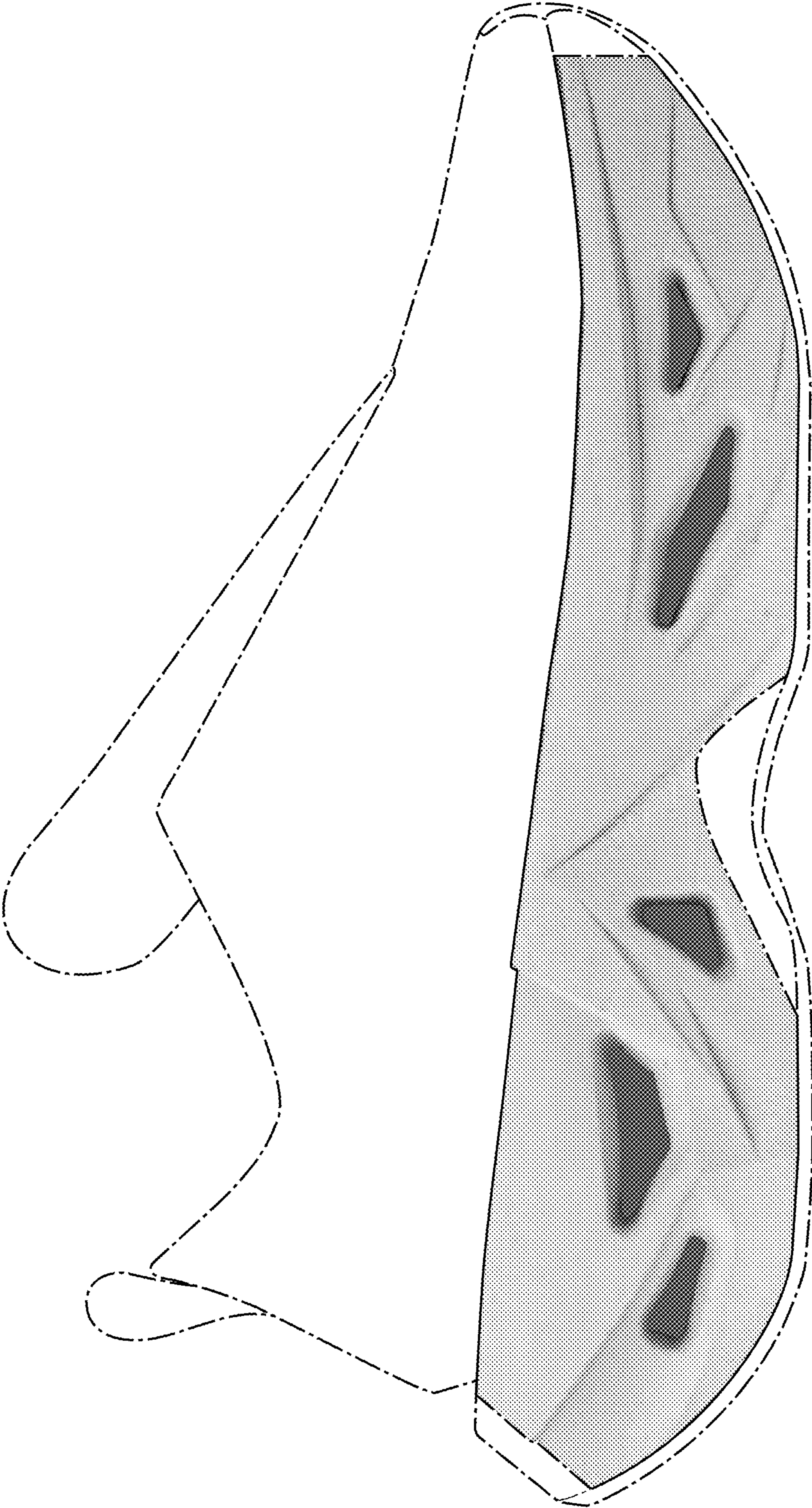

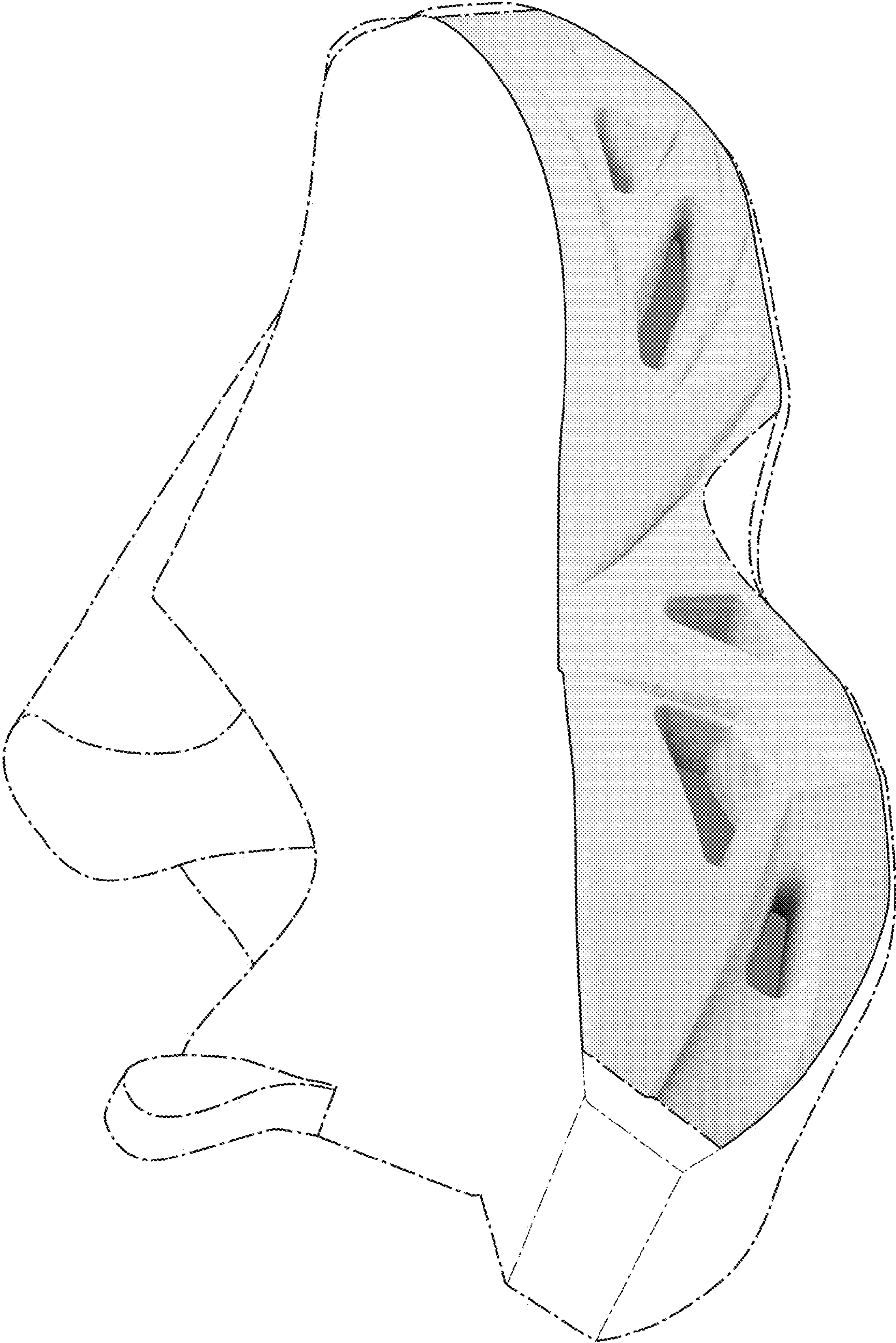
