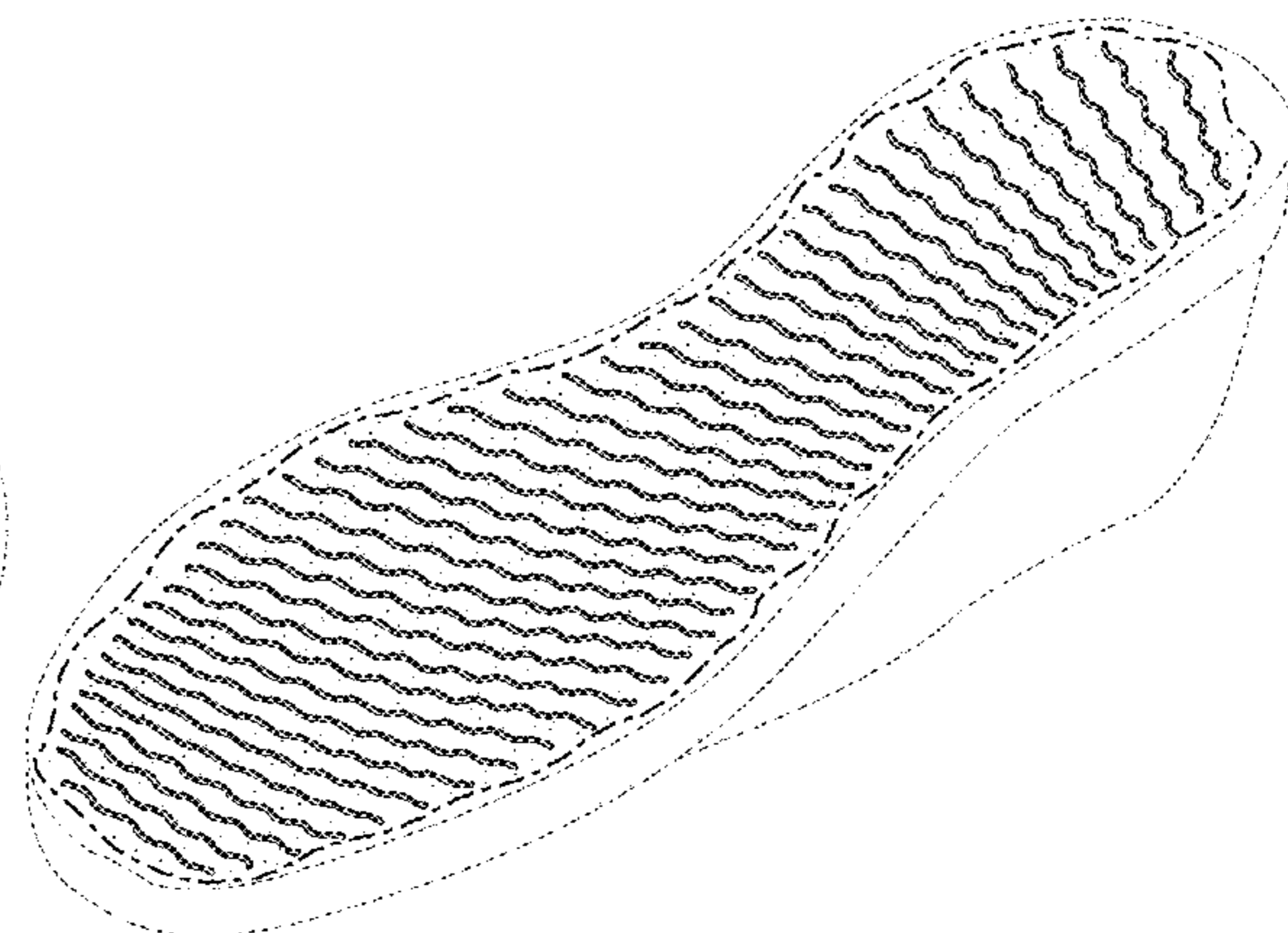
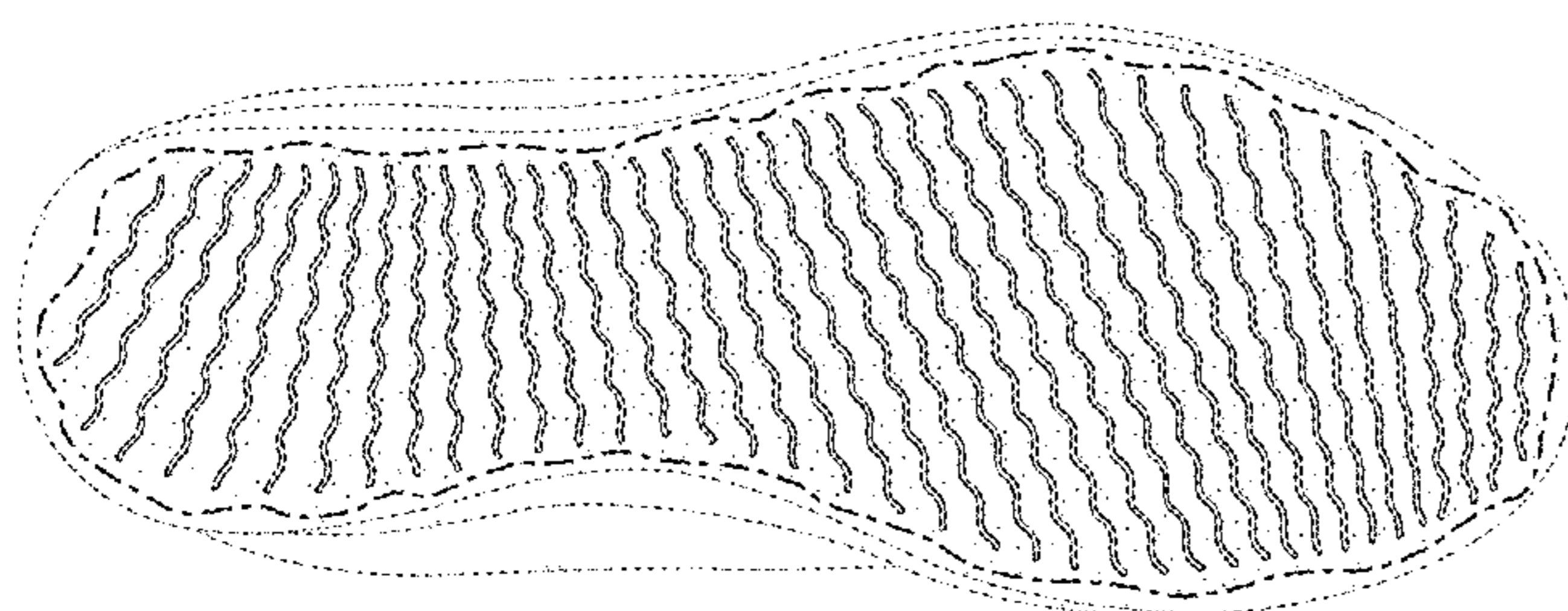
(57) **CLAIM**

We claim the ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of footwear, showing our new design; FIG. 2 is a front, bottom perspective view thereof; and, FIG. 3 is a back, bottom perspective view thereof. The regular dashed lines are included for illustrating environmental structure and form no part of the claimed design. 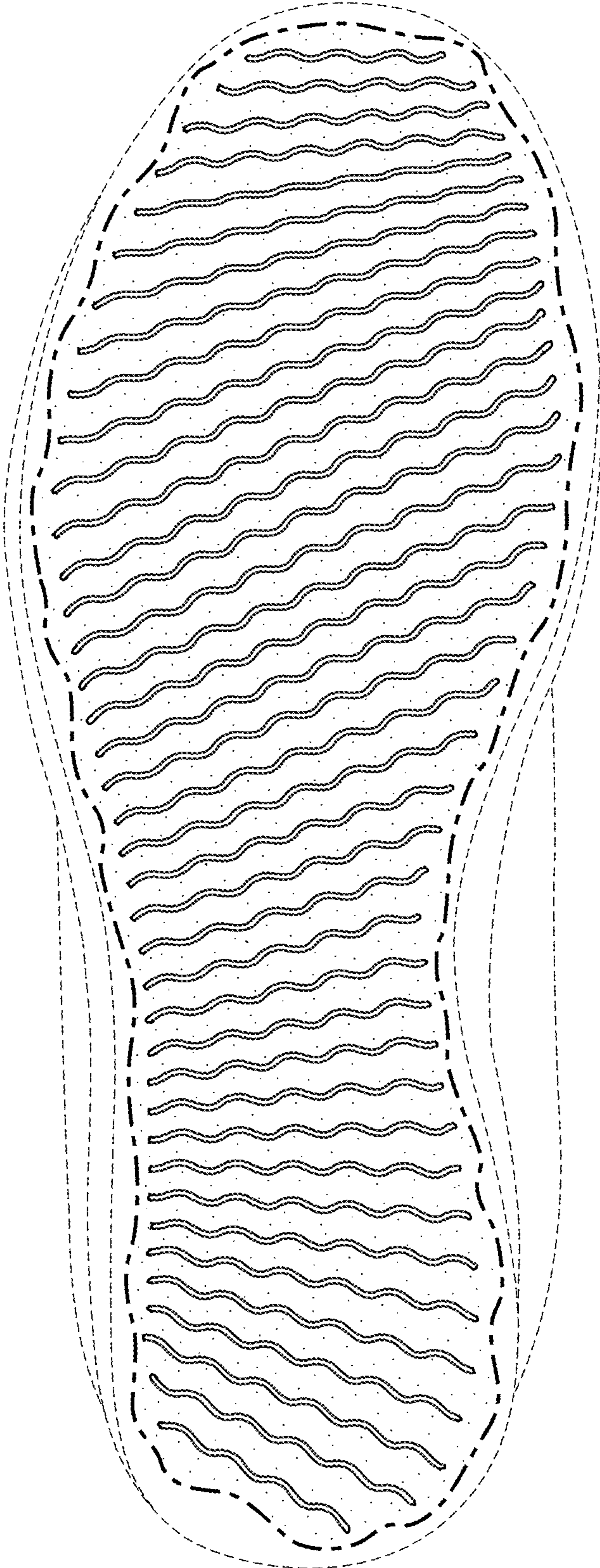

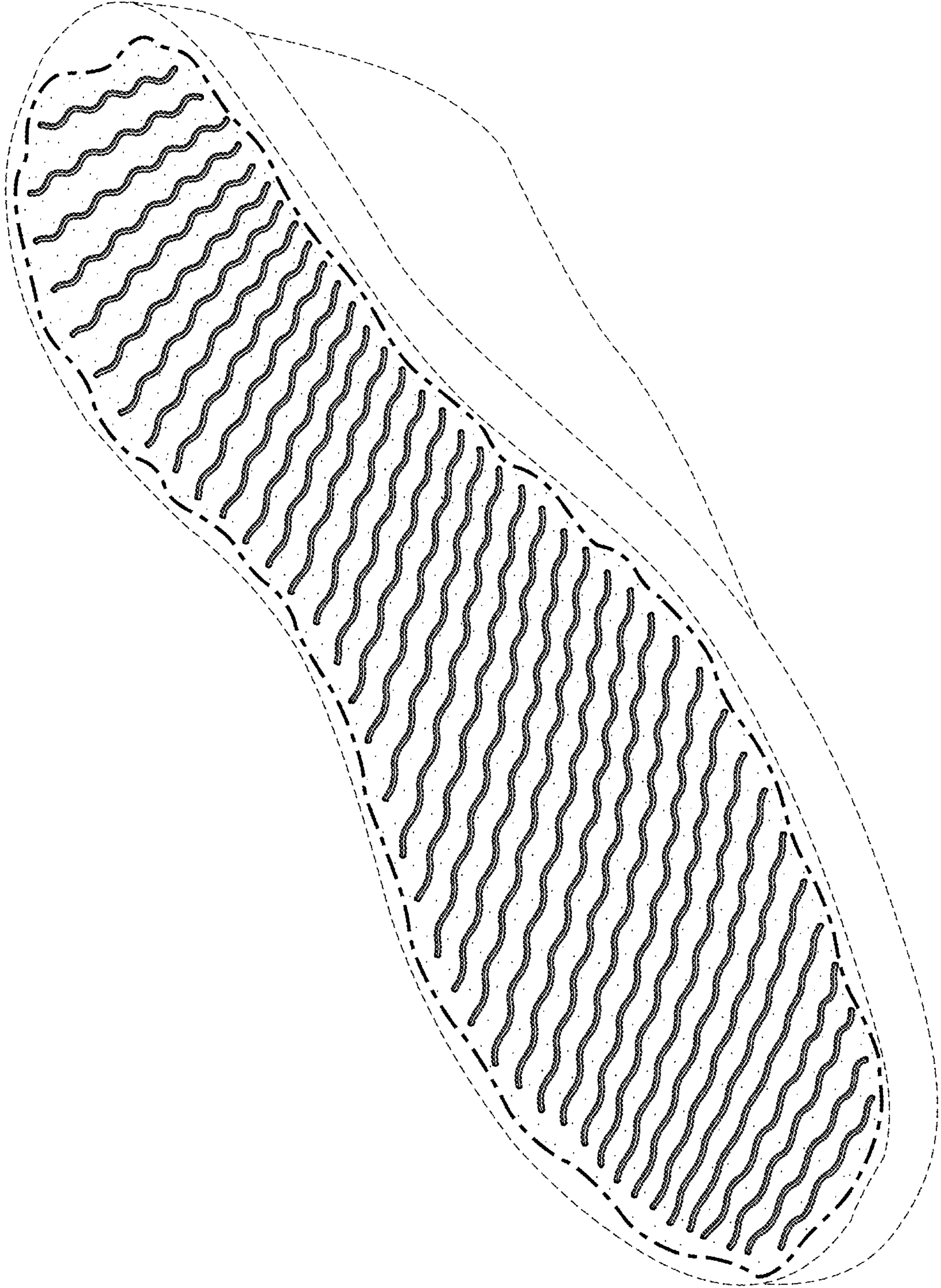

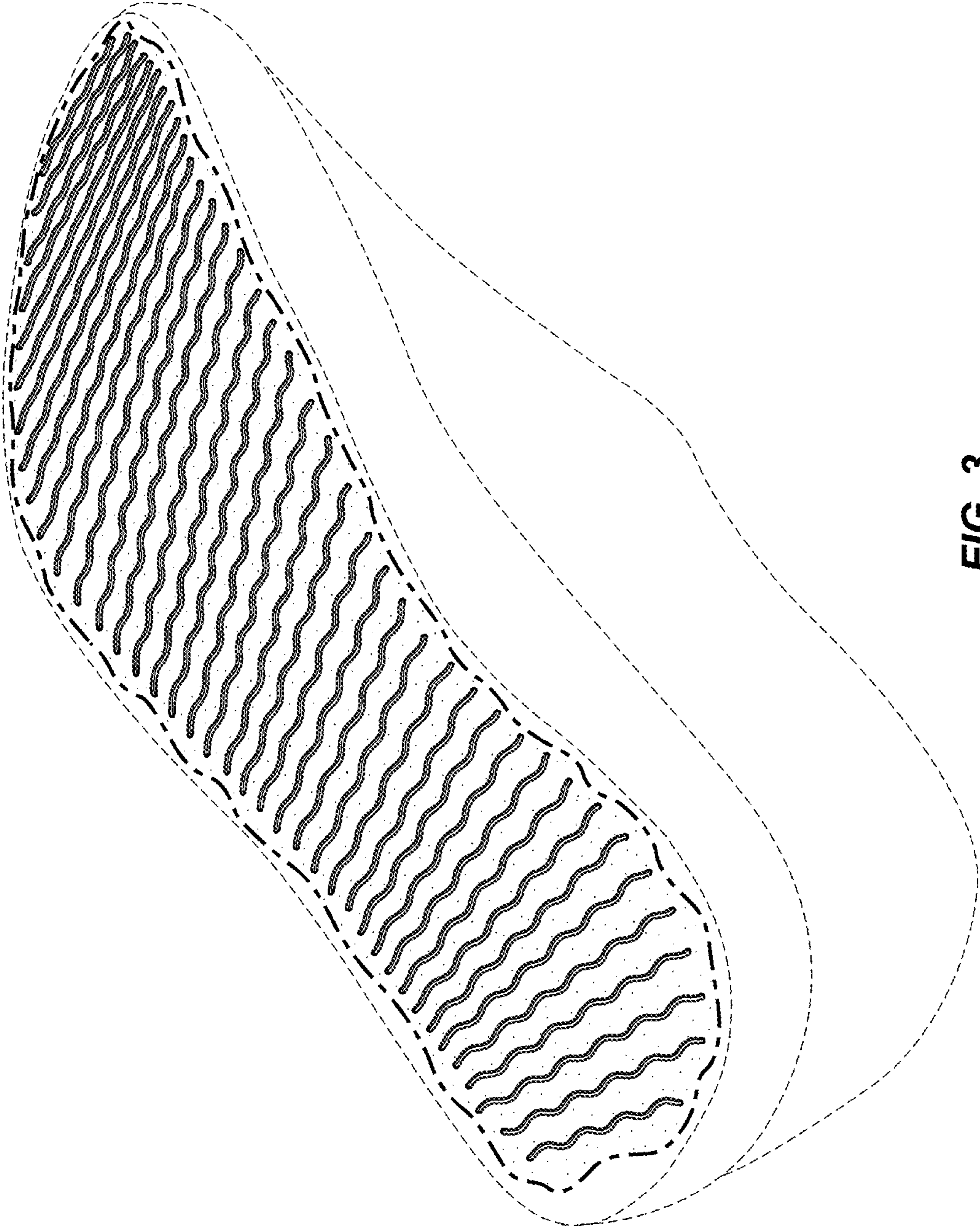
