The ornamental design for a shoe, as shown and described.

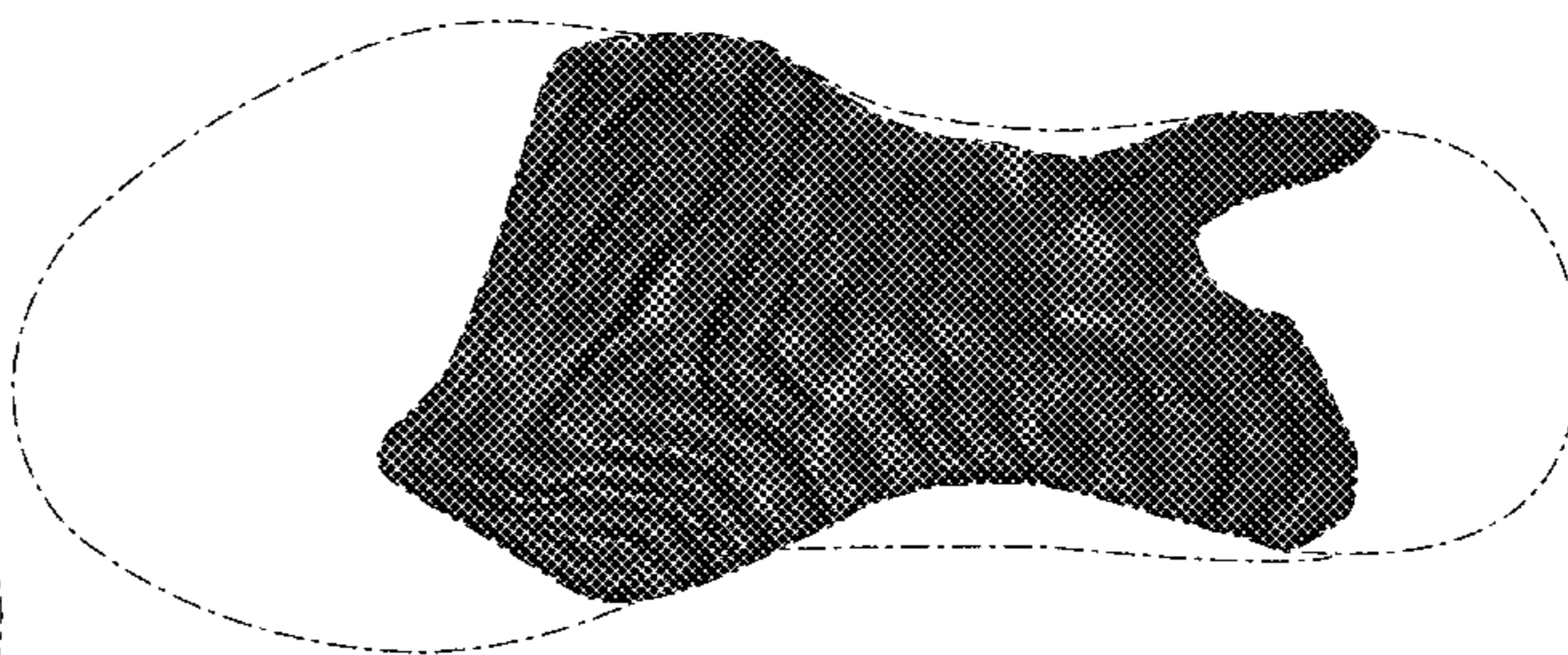
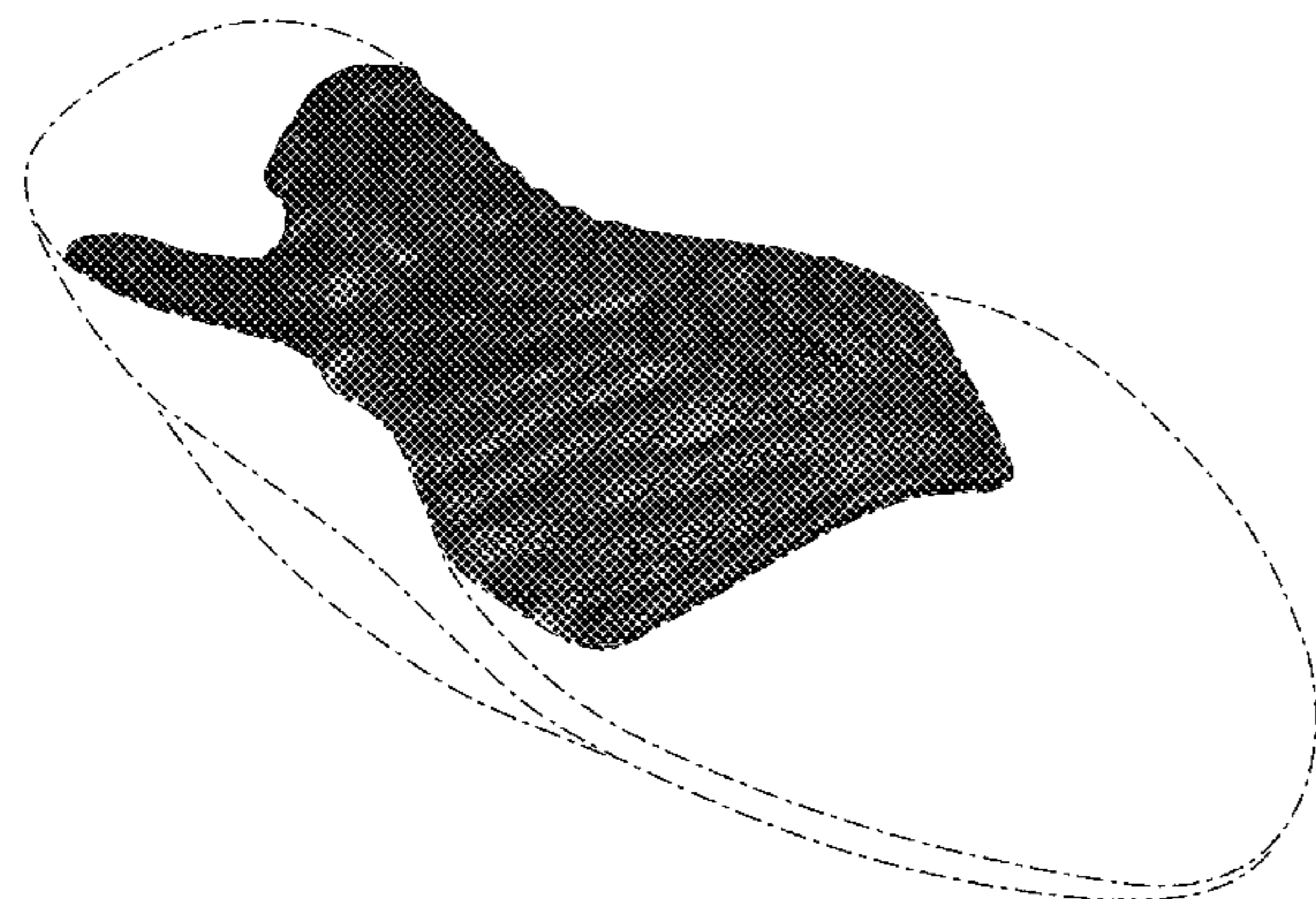
**DESCRIPTION**

FIG. 1 is a front bottom perspective view of a shoe showing my new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a rear bottom perspective view thereof;  
FIG. 4 is an opposite side front bottom perspective view thereof; and,  
FIG. 5 is an opposite side rear bottom perspective view thereof.

The broken line immediately adjacent to and surrounding to the photographic area defines the peripheral boundary of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

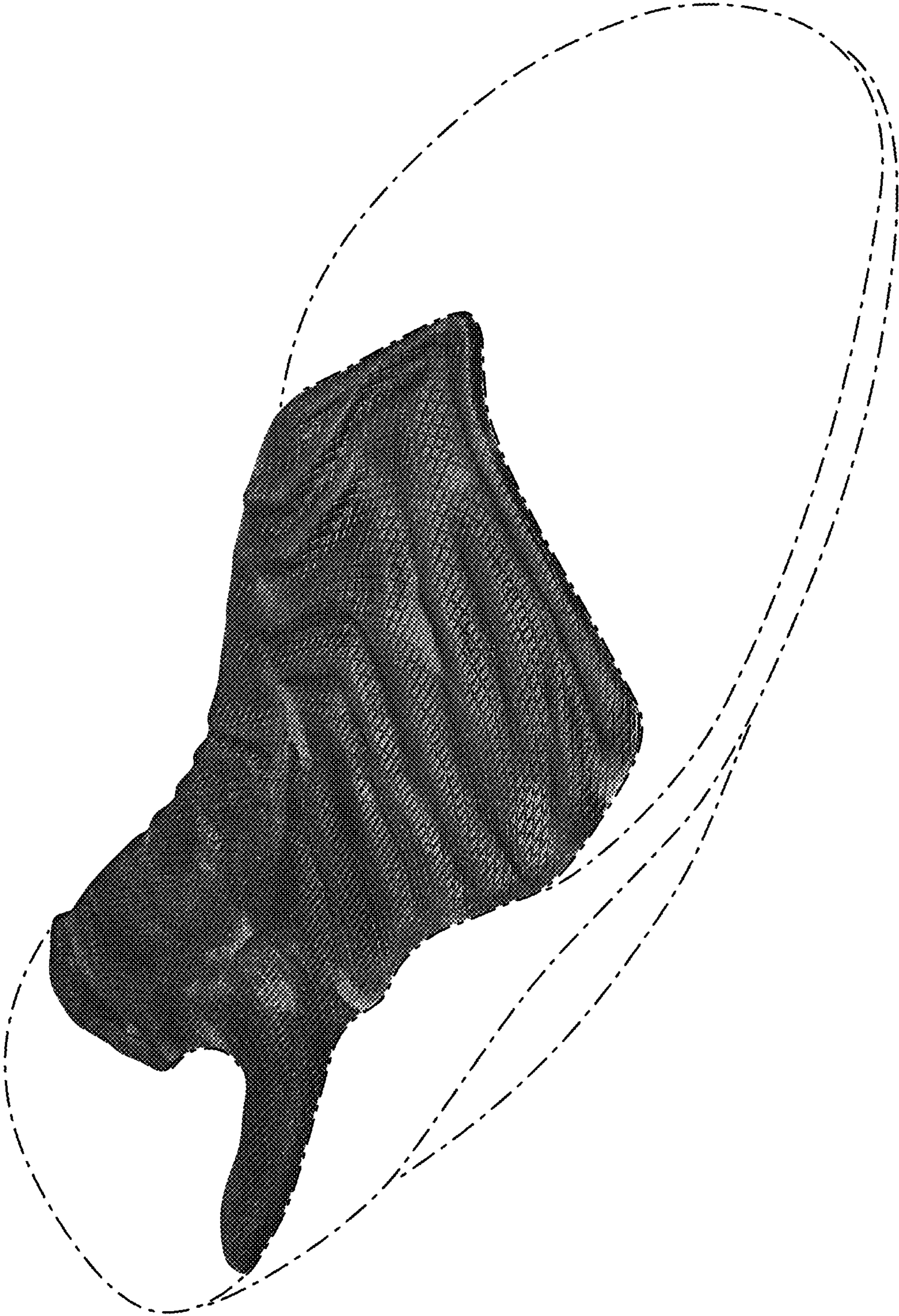

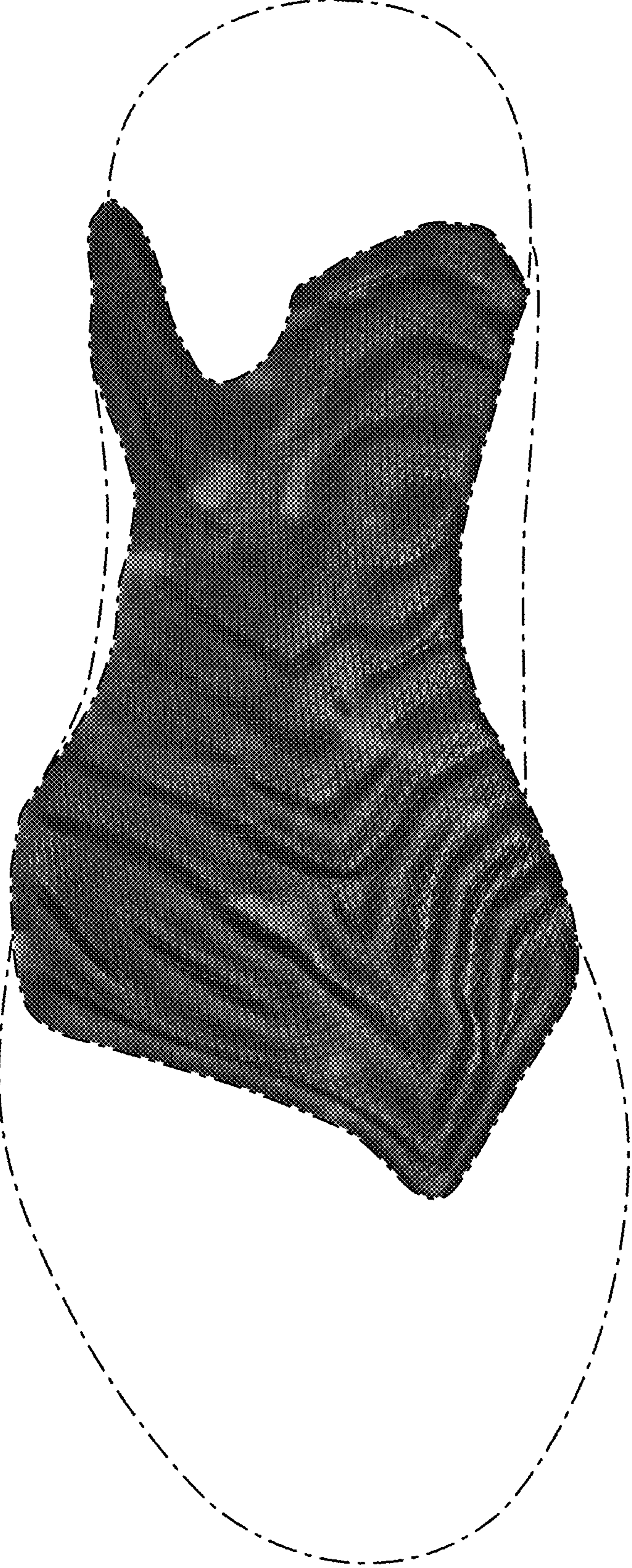

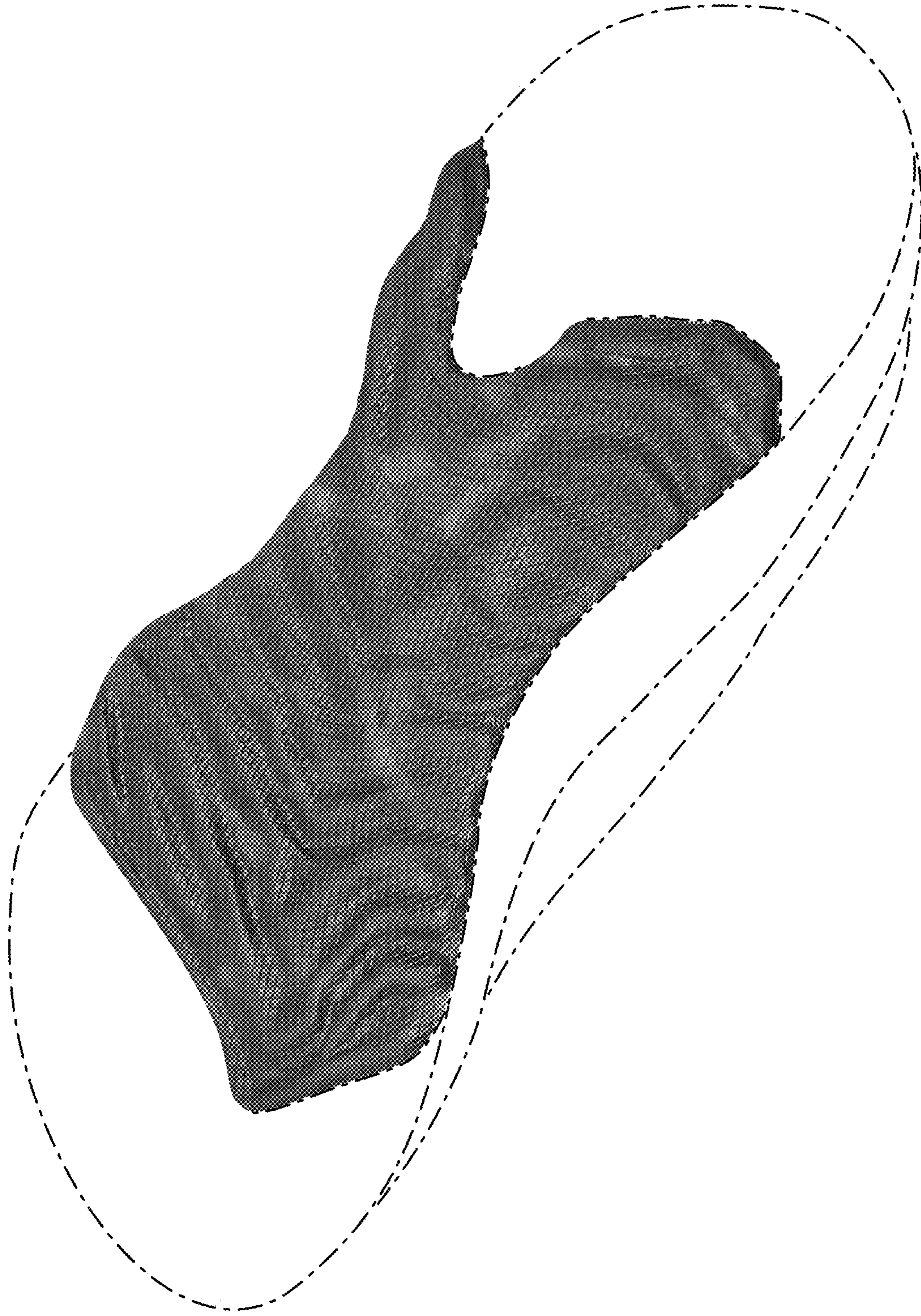

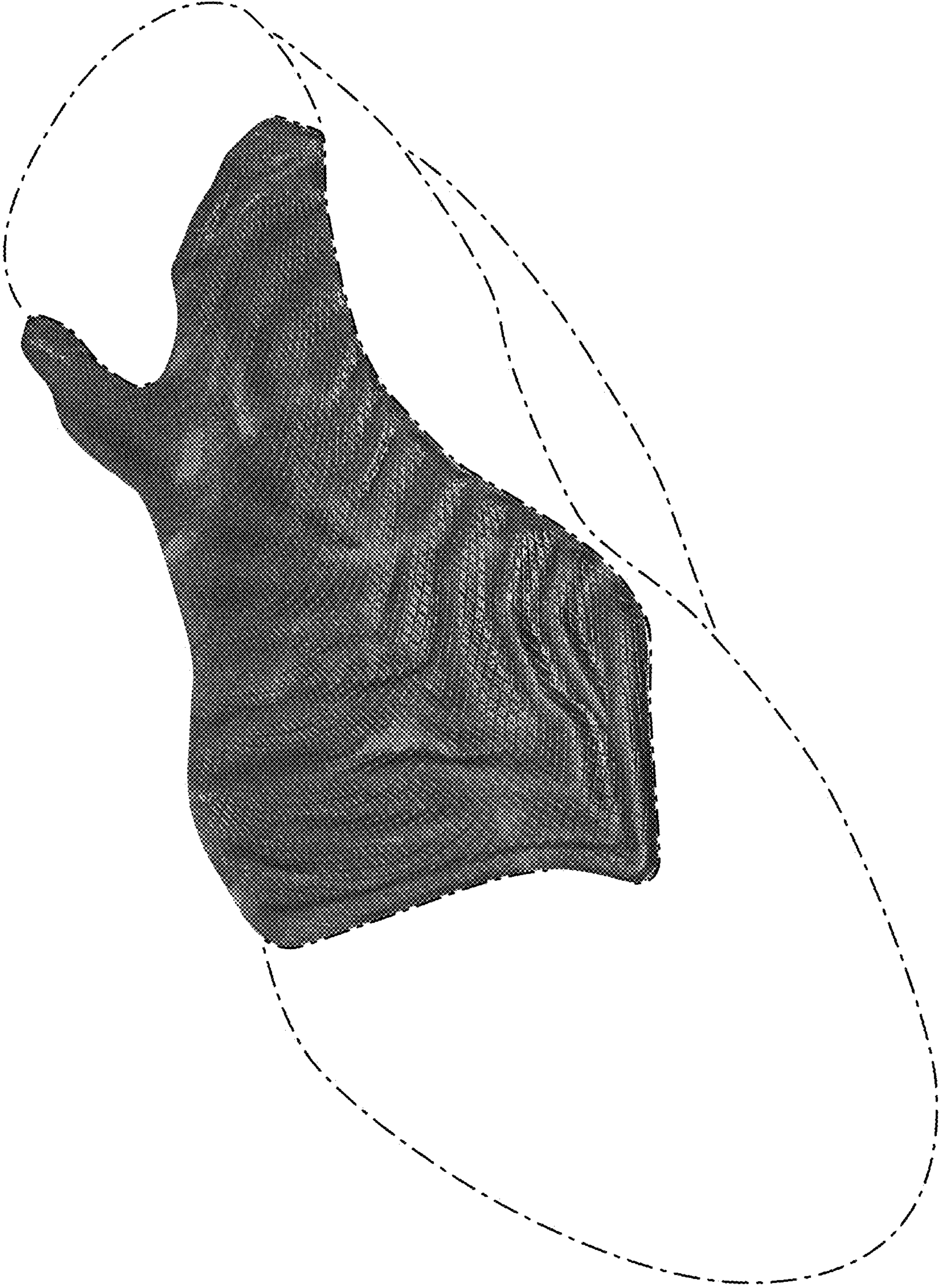
