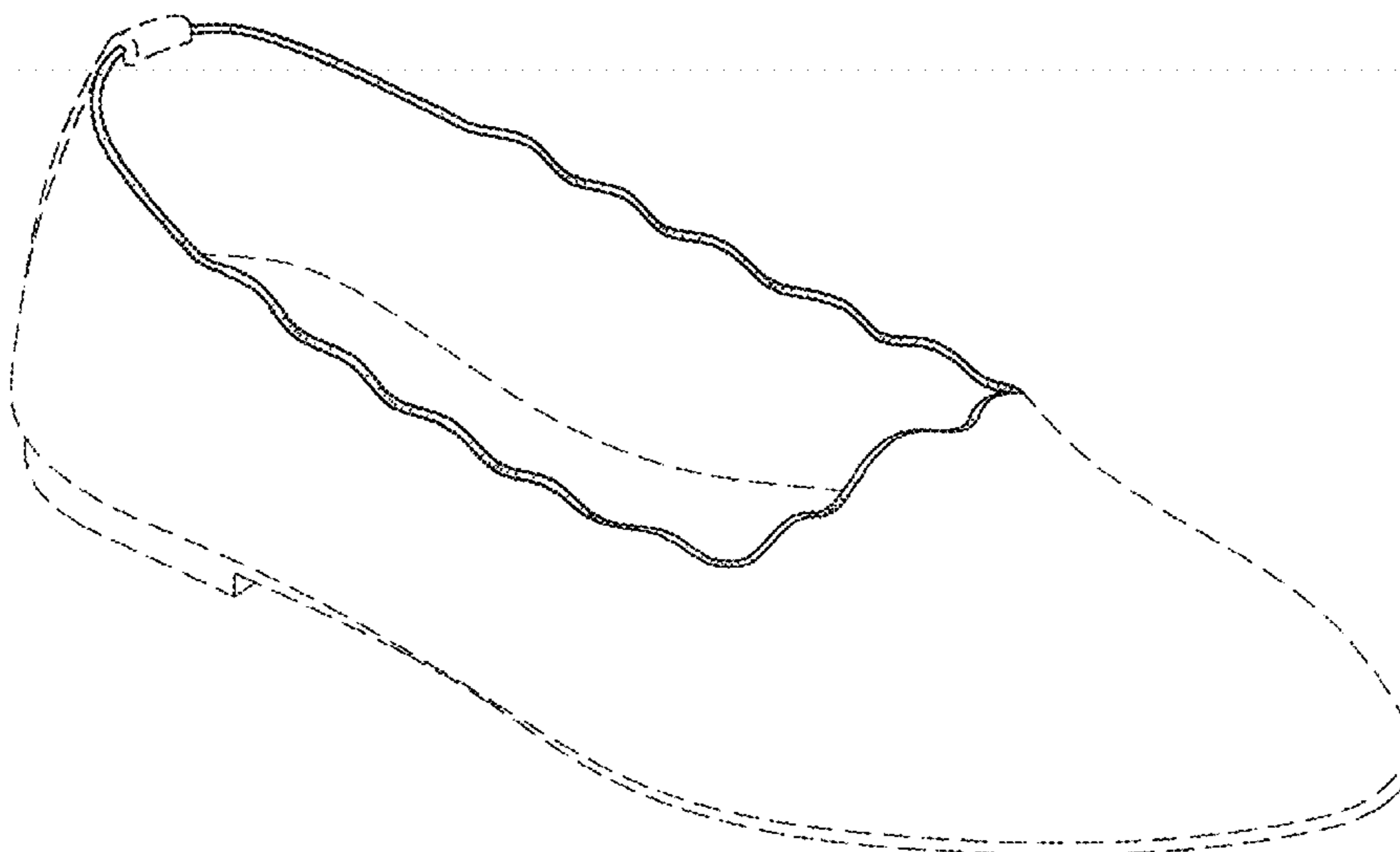
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe upper showing my new design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a rear view thereof; and,  
FIG. 7 is a front view thereof.  
The broken lines shown in the drawings represent portions of the shoe upper, midsole periphery and outsole bottom that form no part of the claimed design.

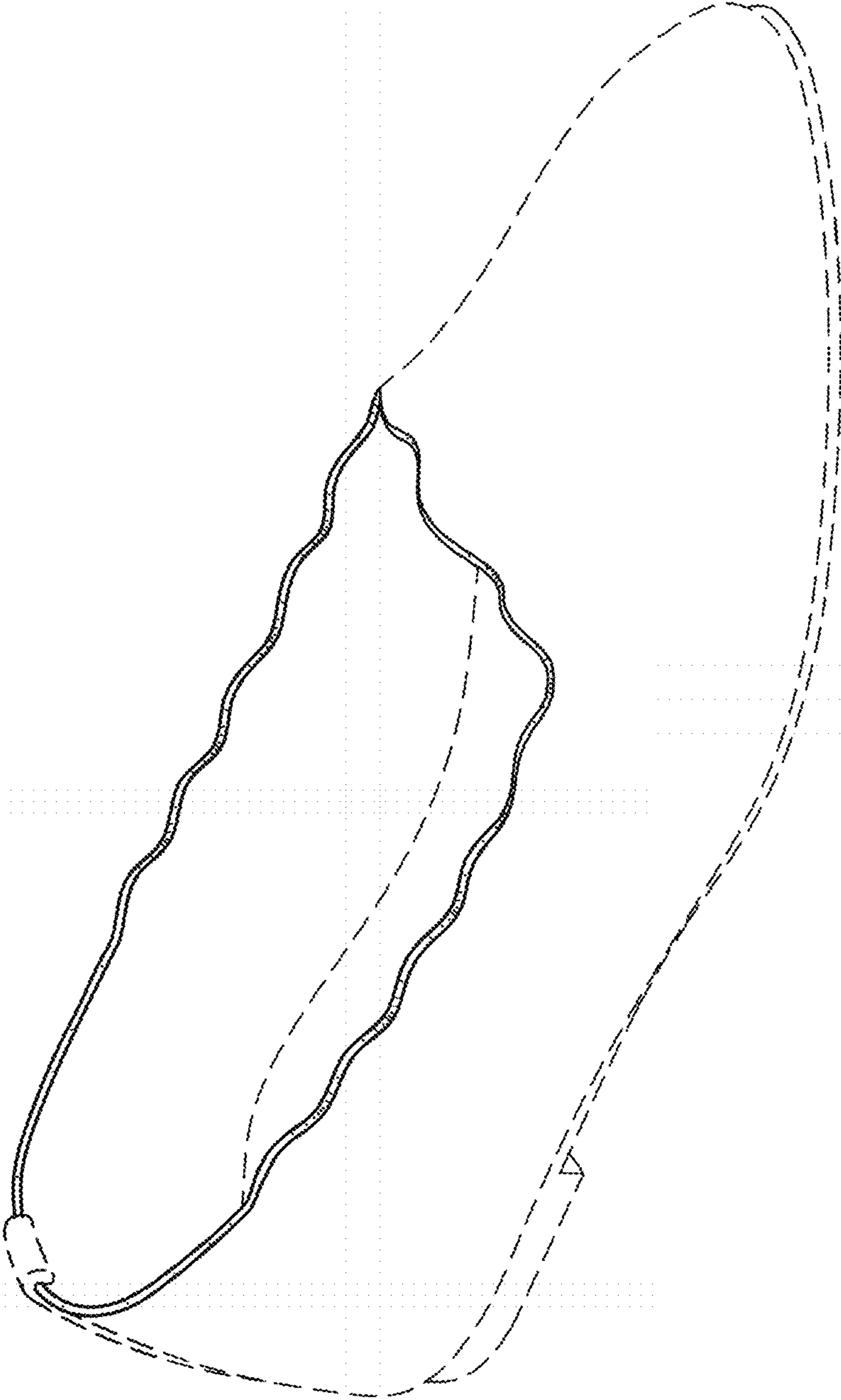

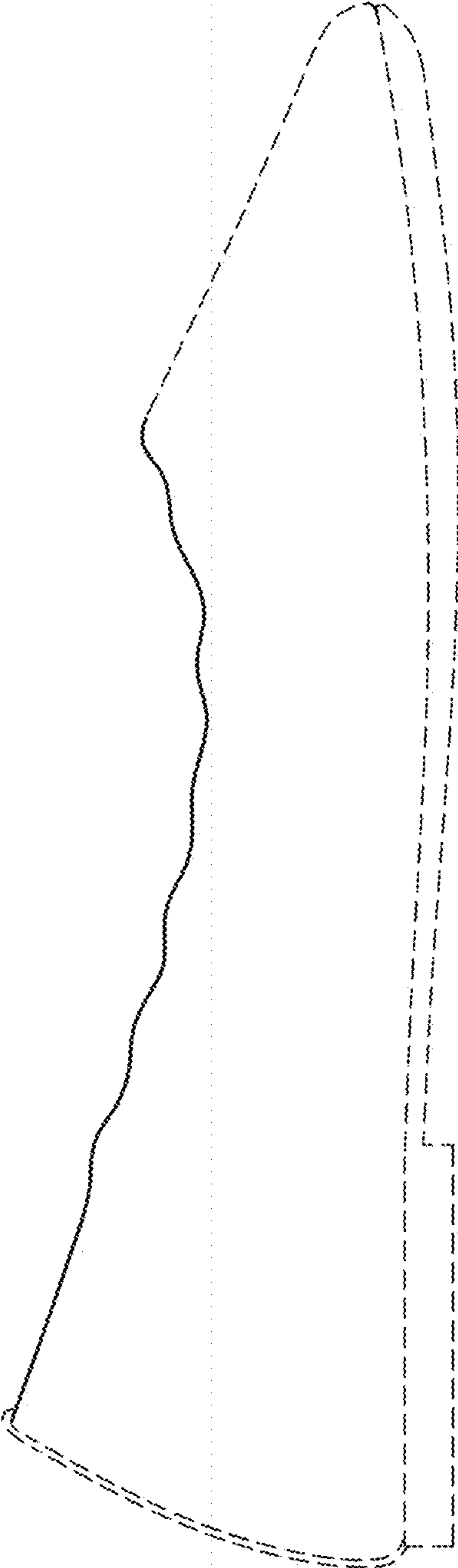

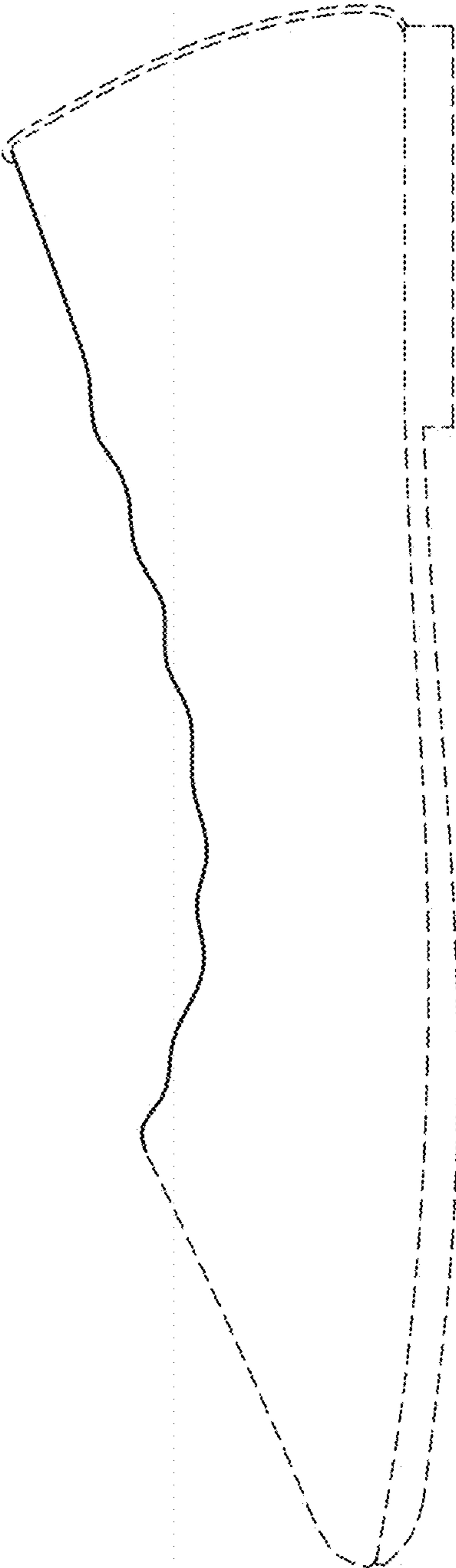

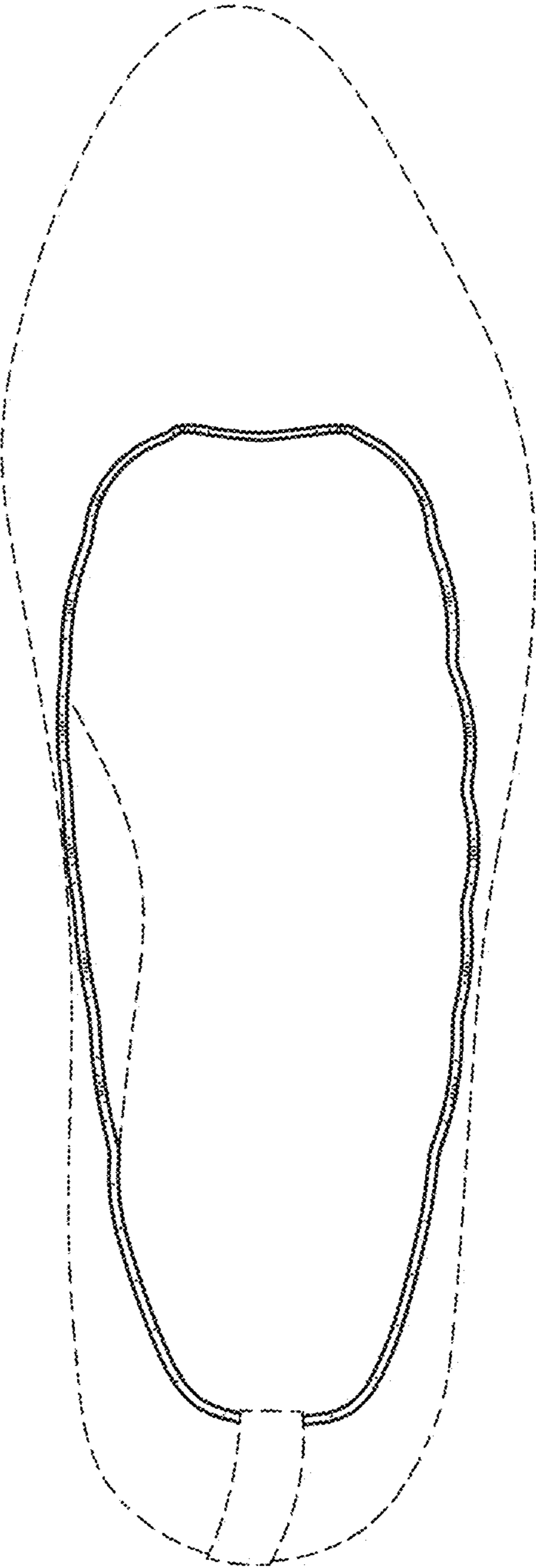

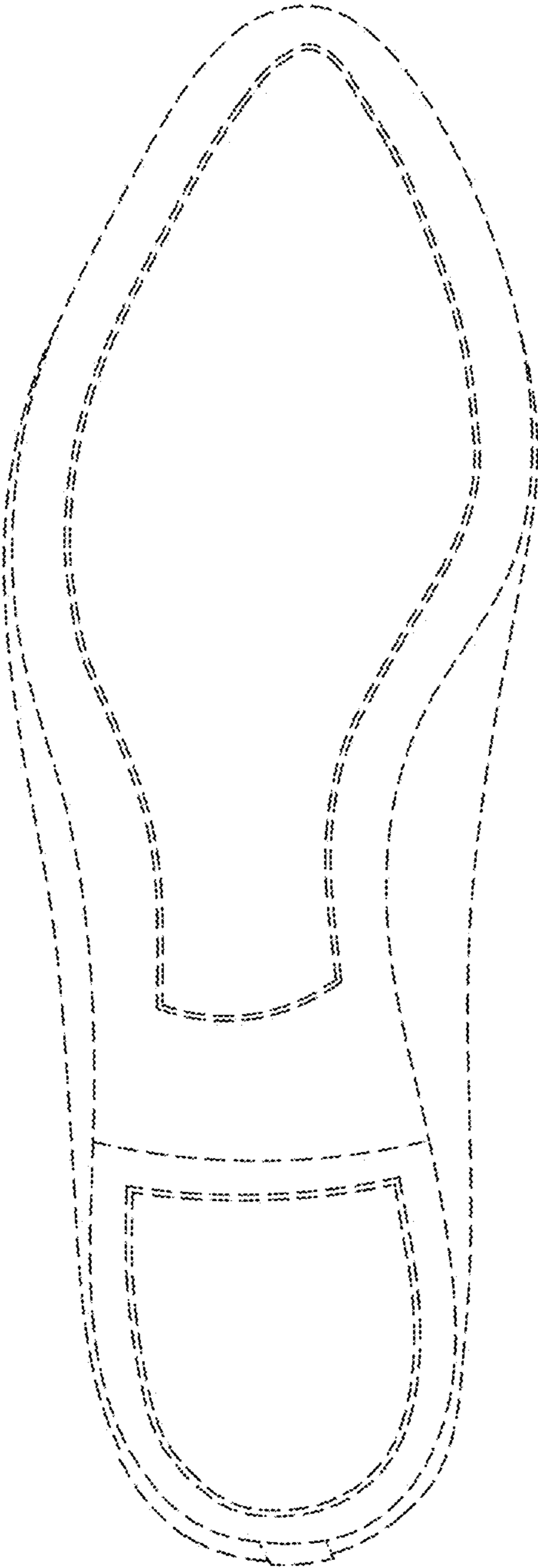

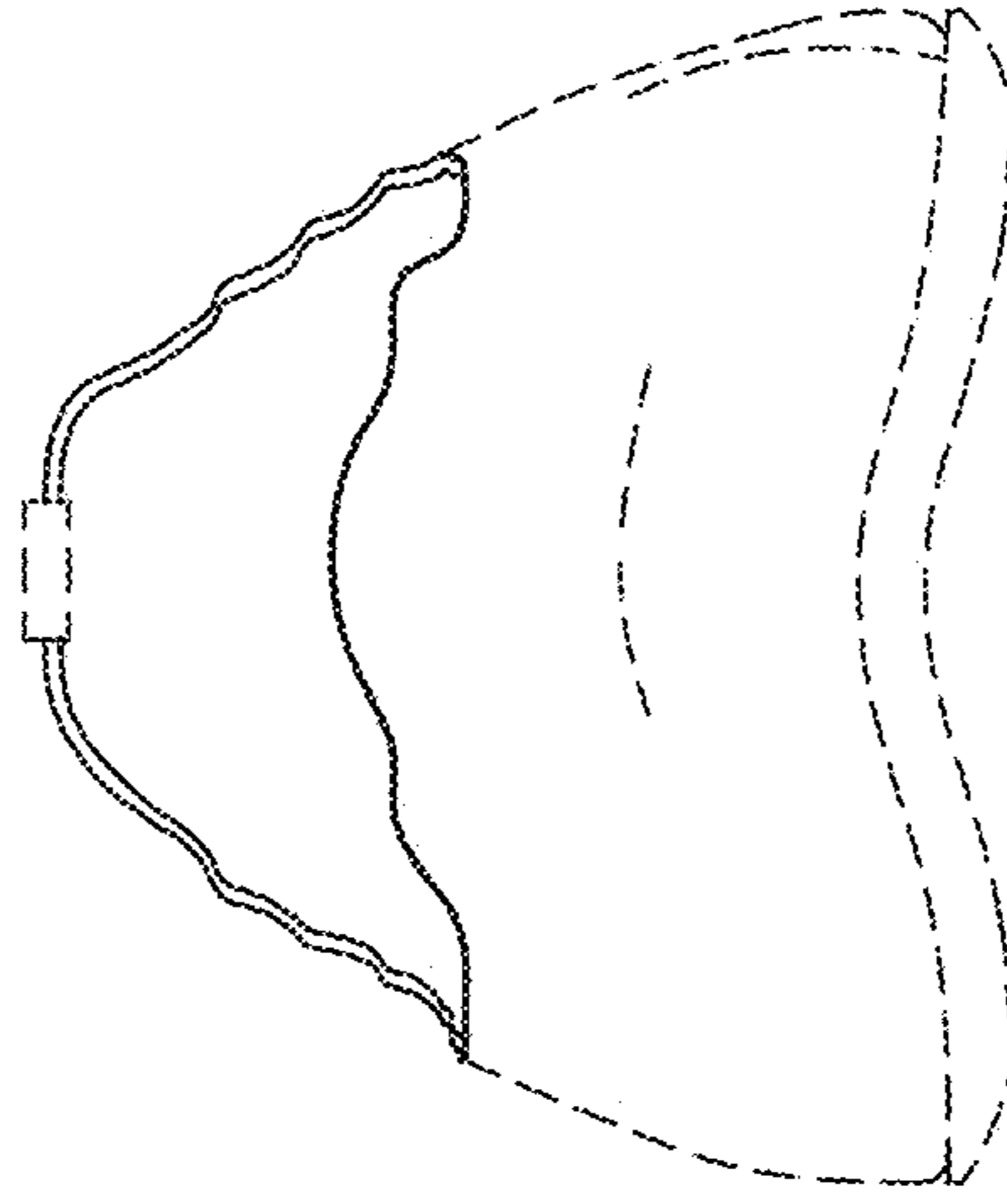
