(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

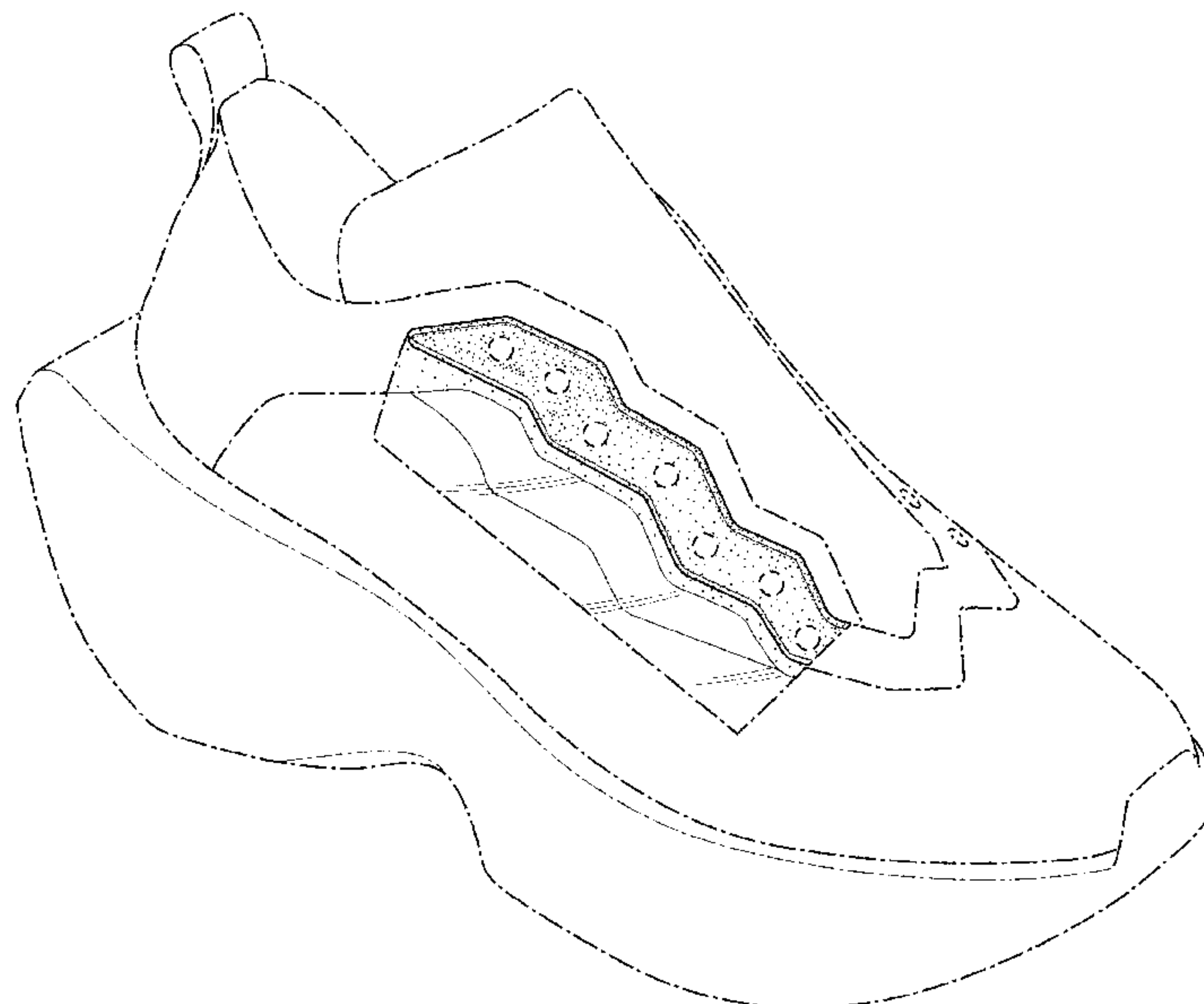
FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The broken line showing of the circular regions within the shaded area represent eyelets that form no part of the claimed design. The oblique shade lines represent a translucent or transparent appearance. The broken line immediately adjacent to the shaded area defines the bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

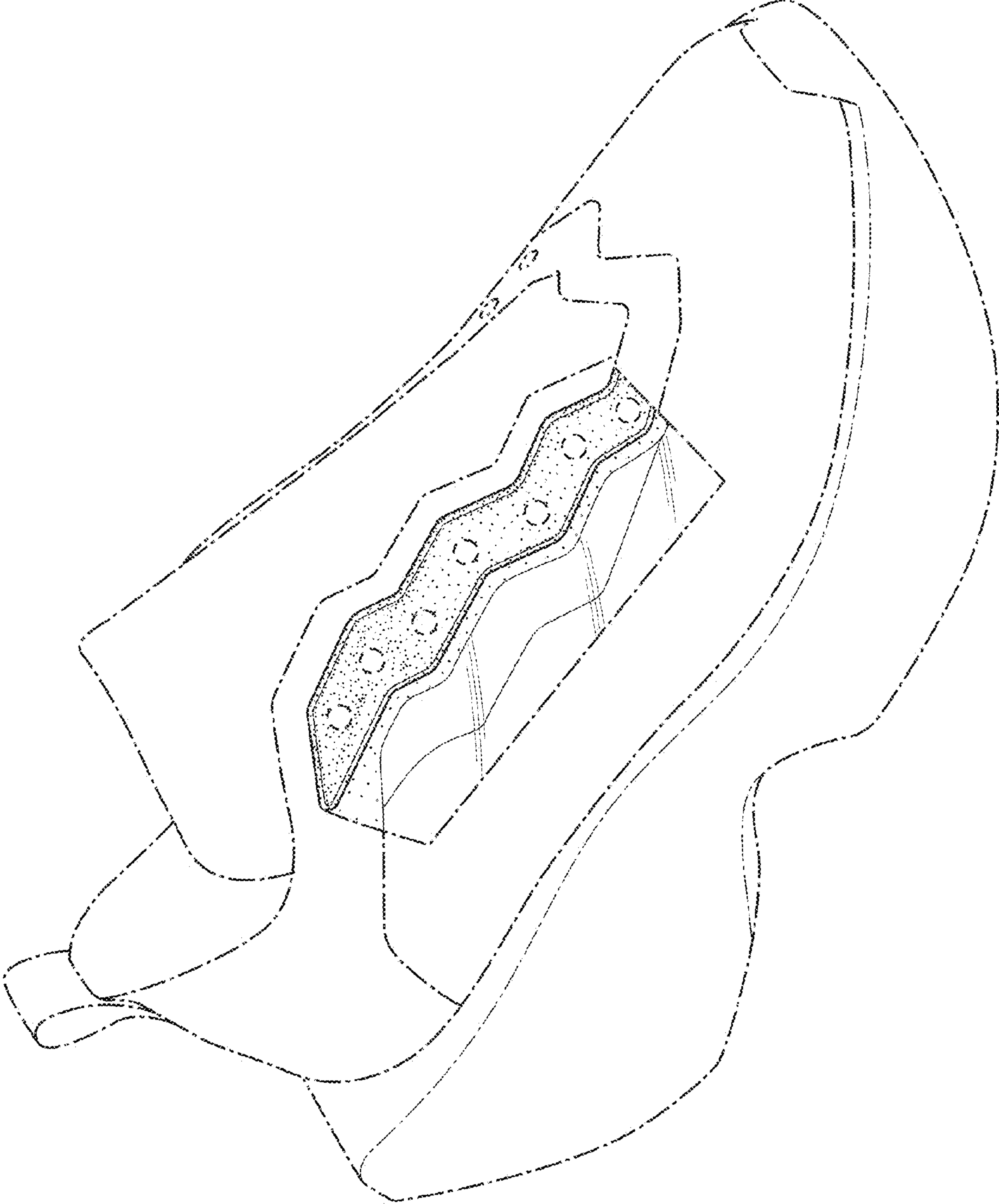

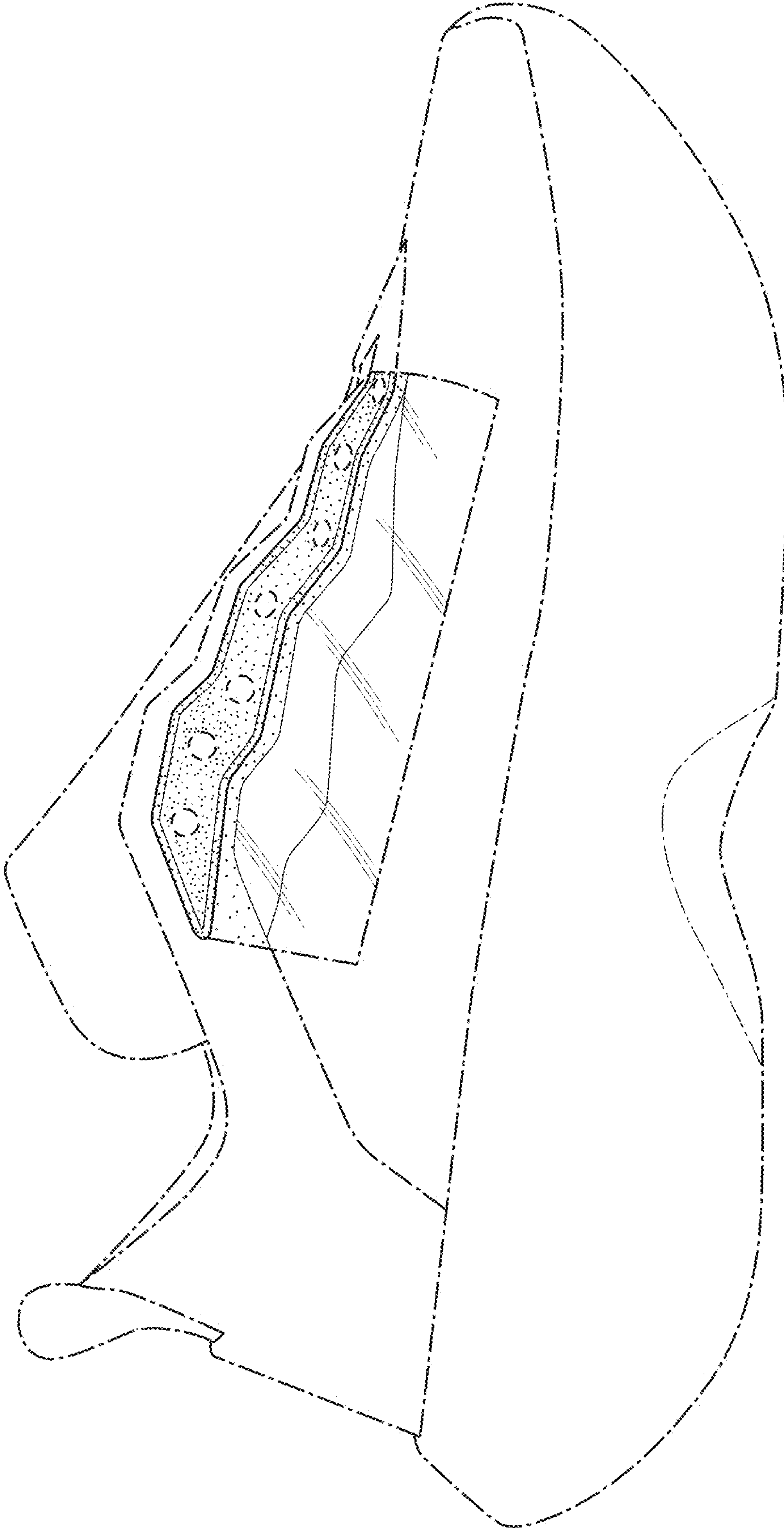

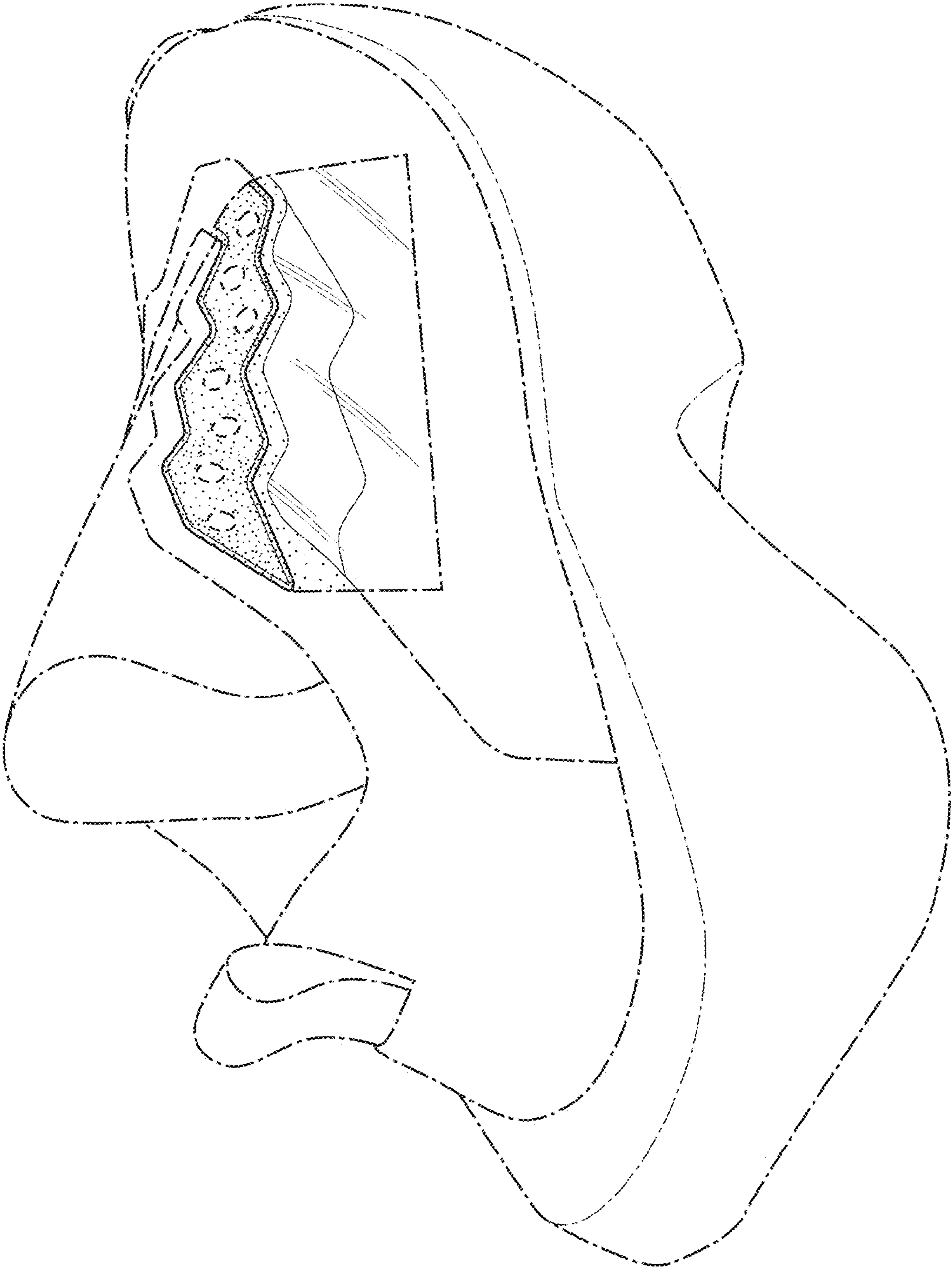
