The ornamental design for a shock absorbing support tip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the shock absorbing support tip showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
In the drawings, the evenly-spaced broken lines depict portions of the article that form no part of the claimed design, the dash-dot-dash lines represent boundaries of the claimed design and form no part thereof.

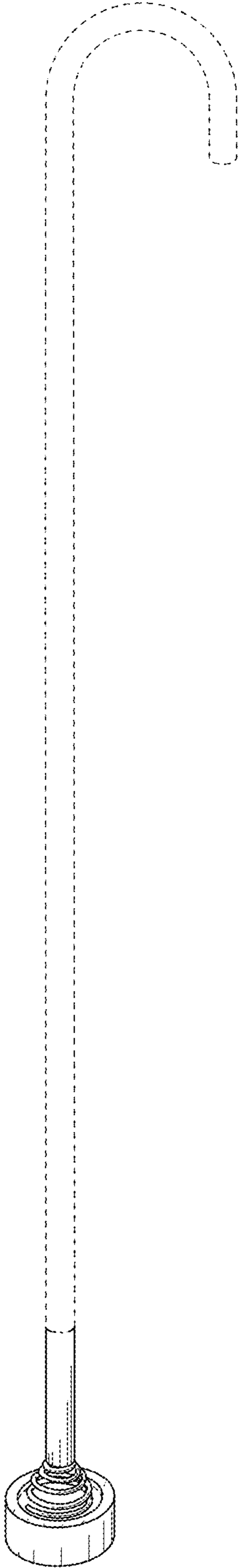

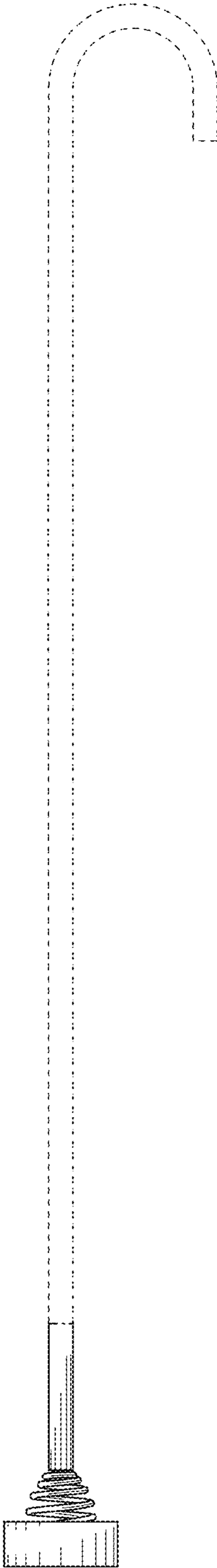

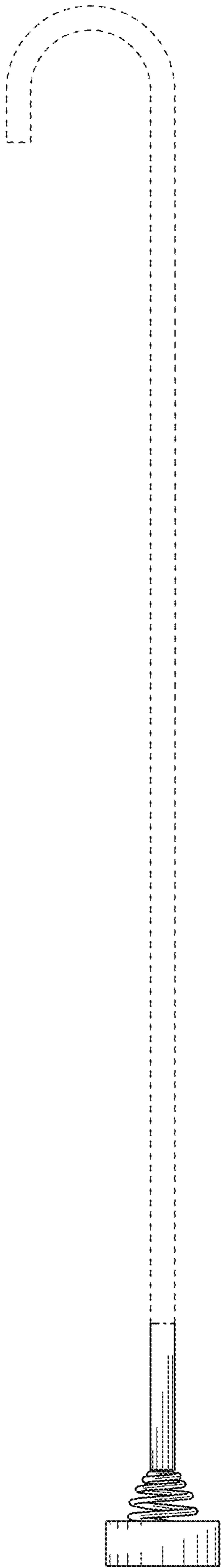

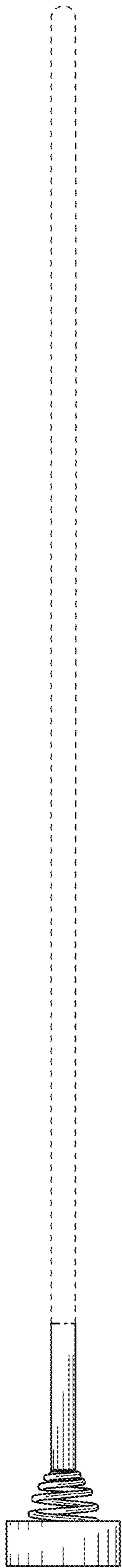

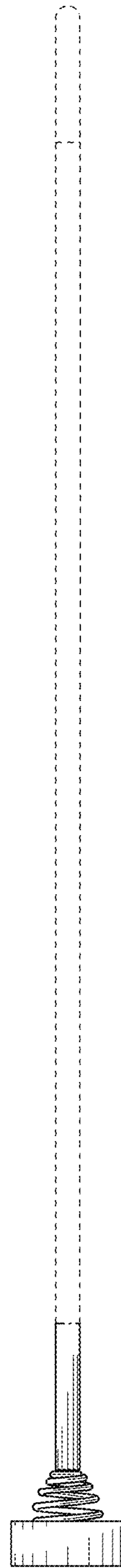

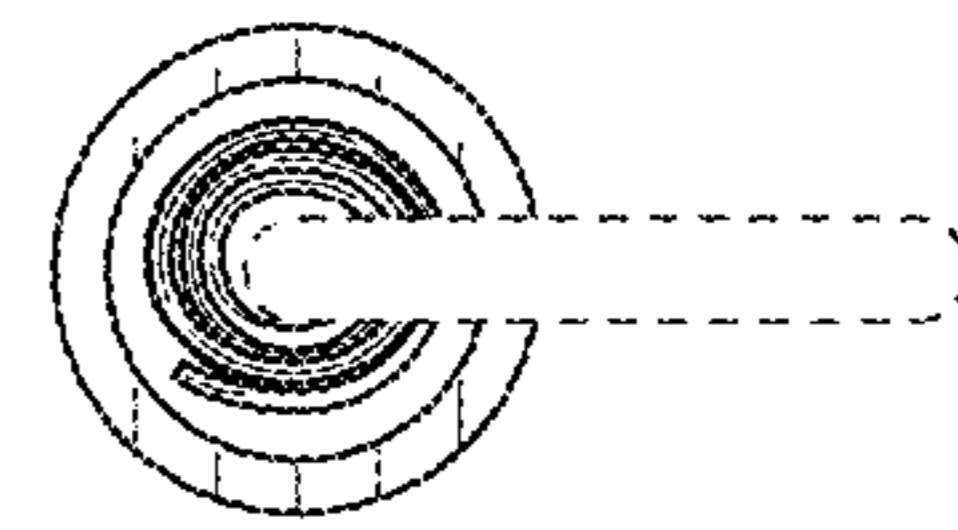

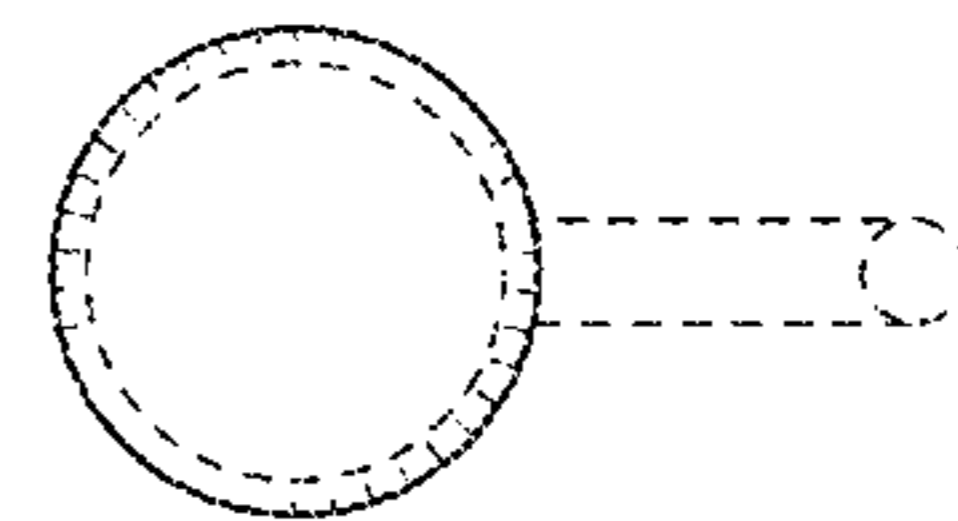
