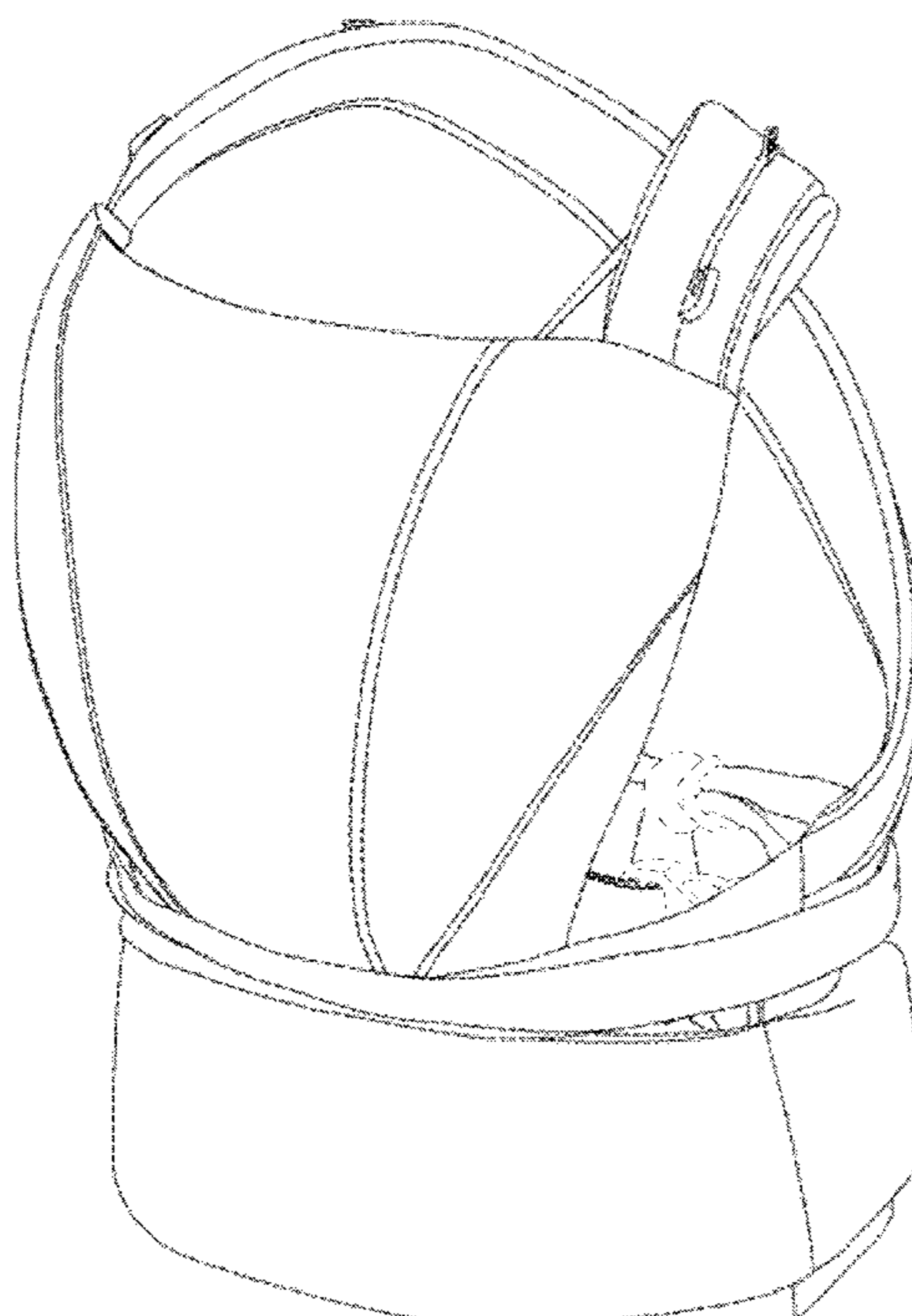
1. Baby carrier

The broken lines in the drawings depict portions of the baby carrier that form no part of the claimed design.

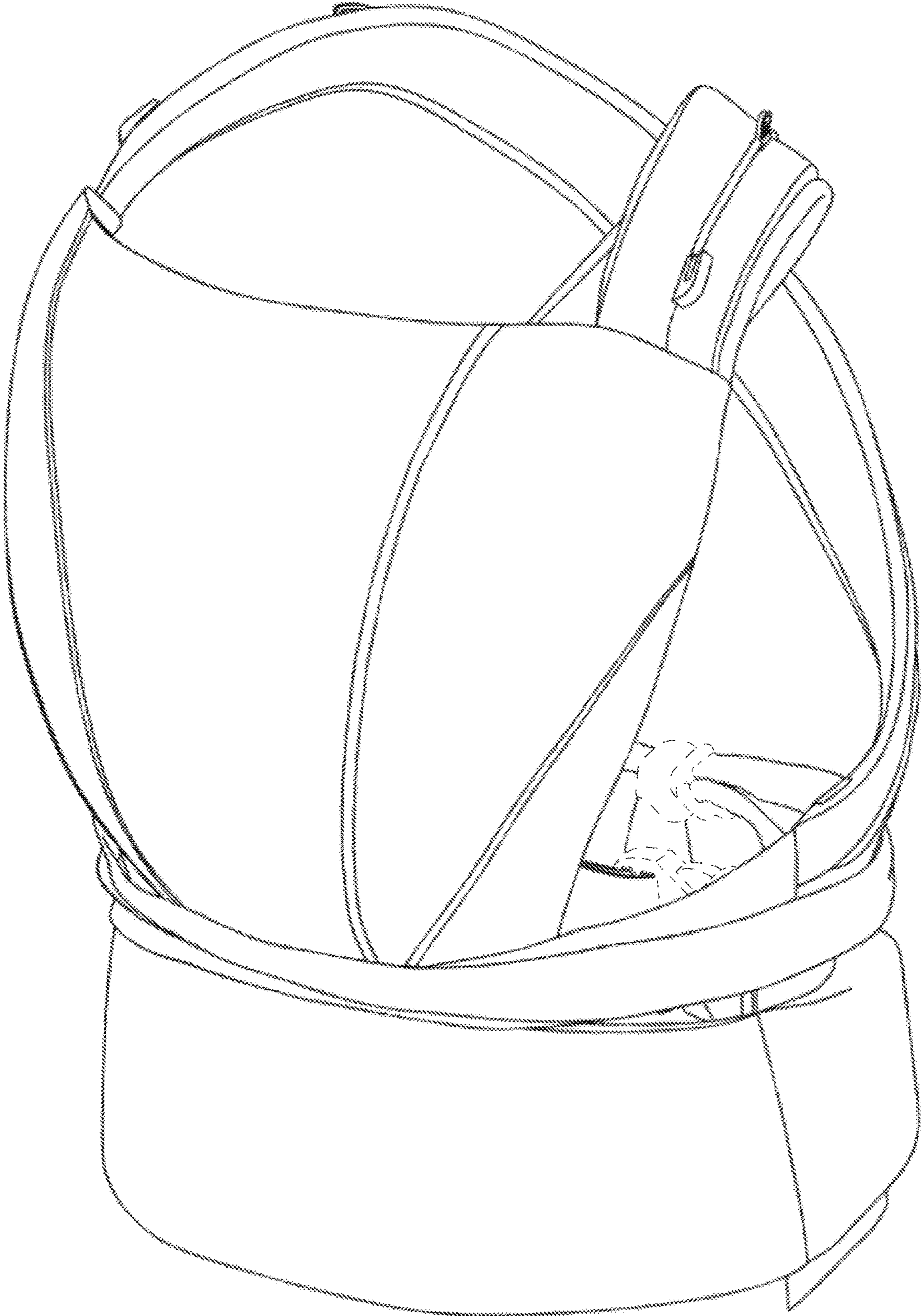

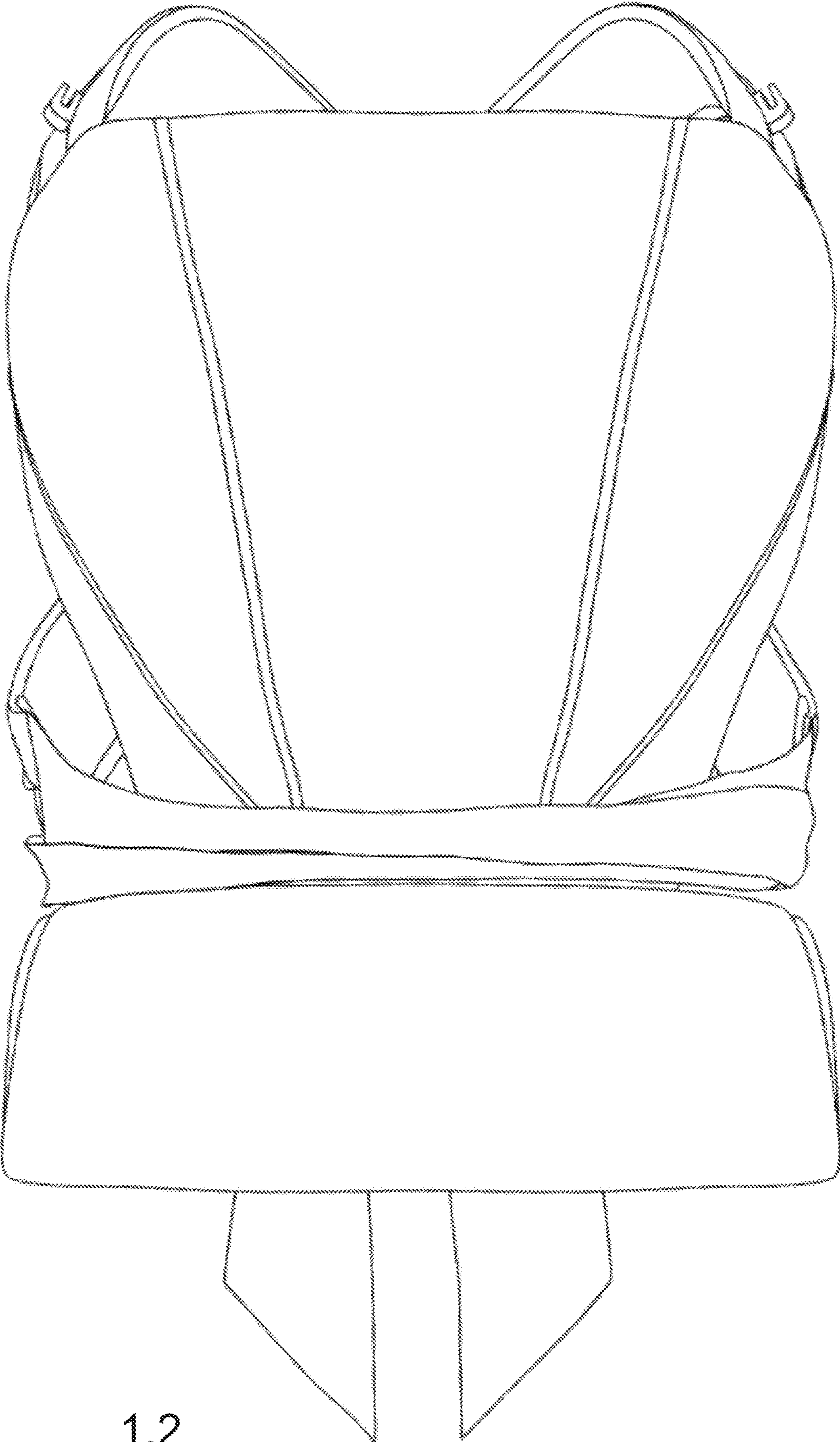

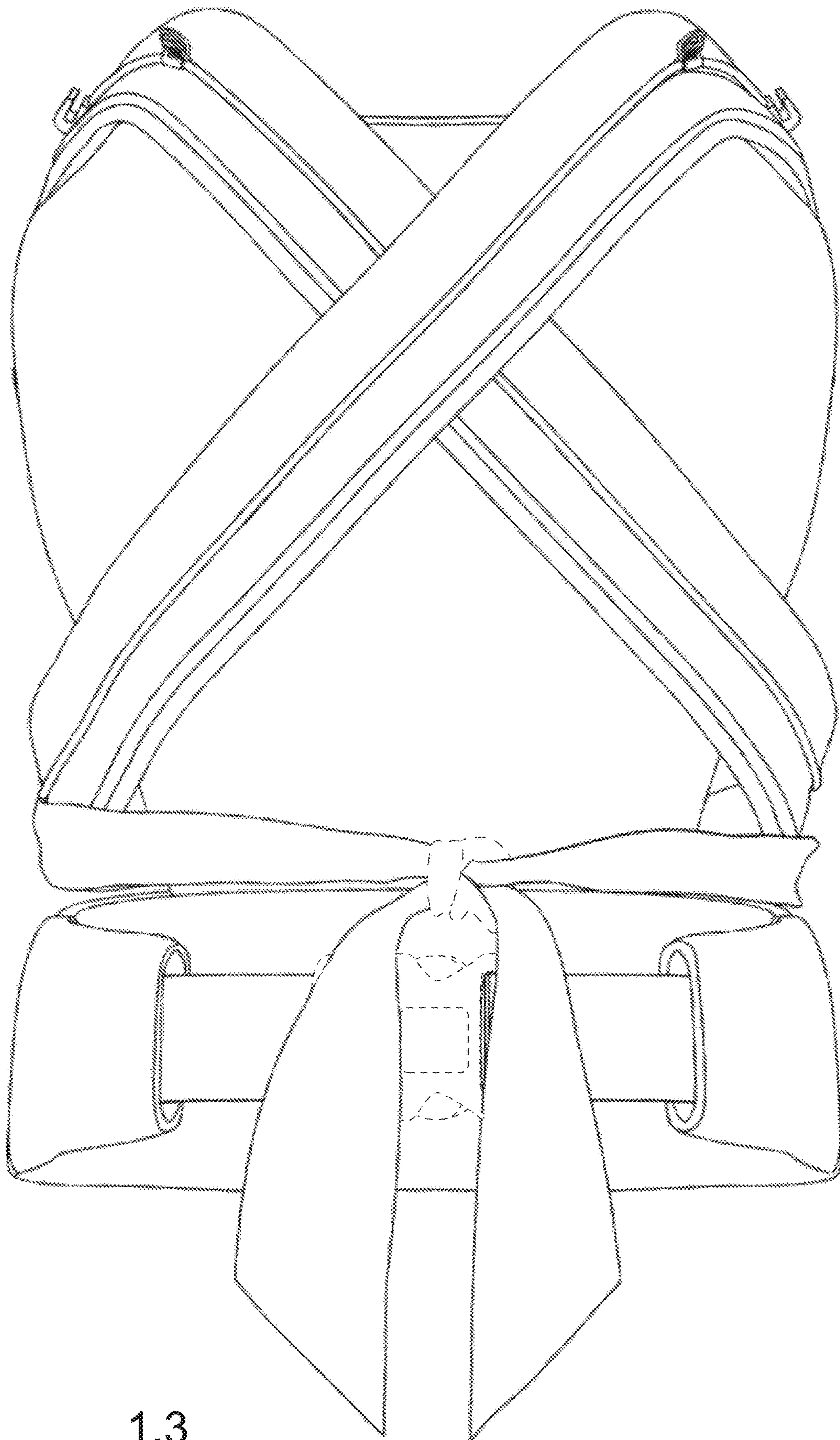




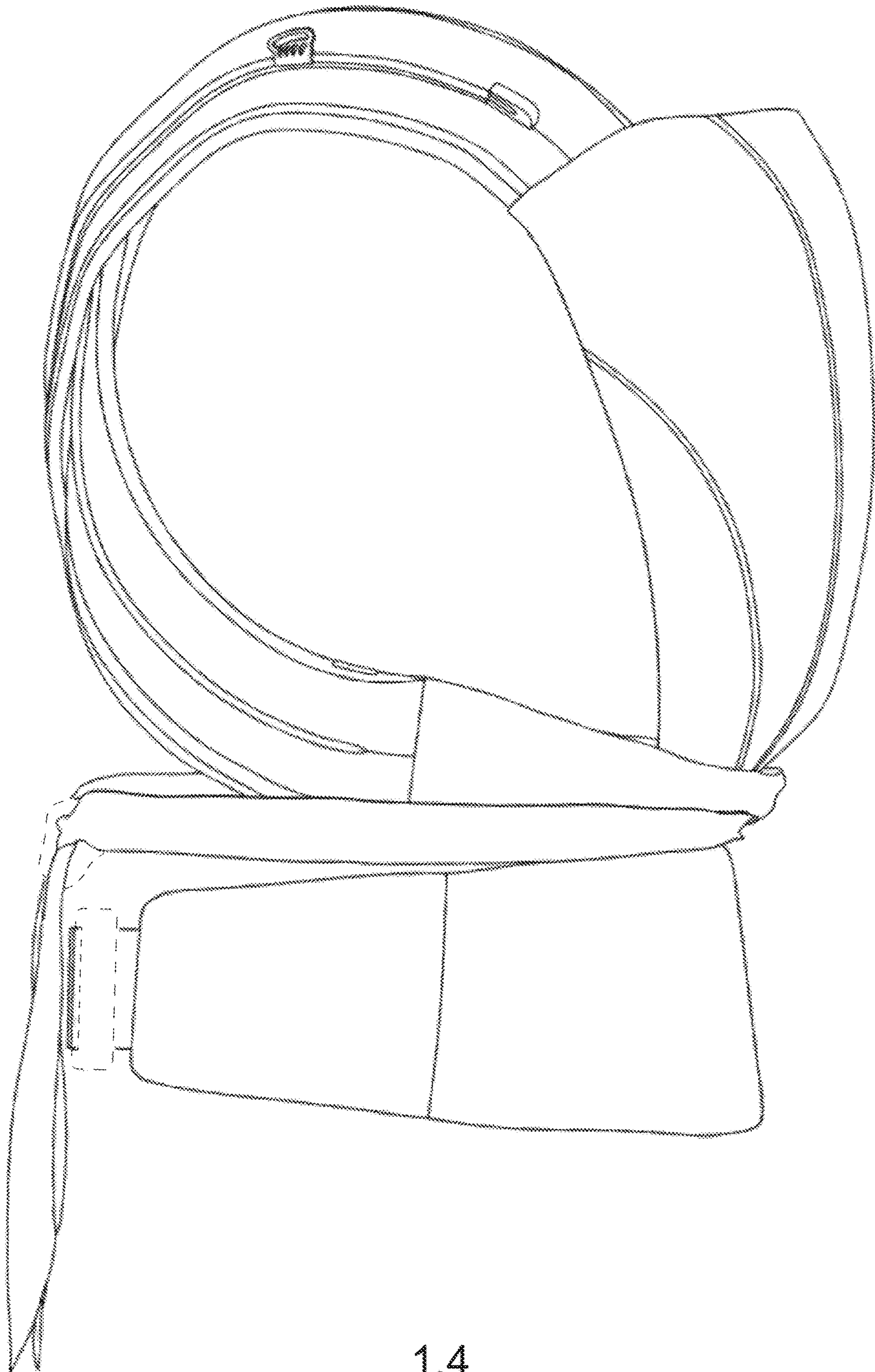

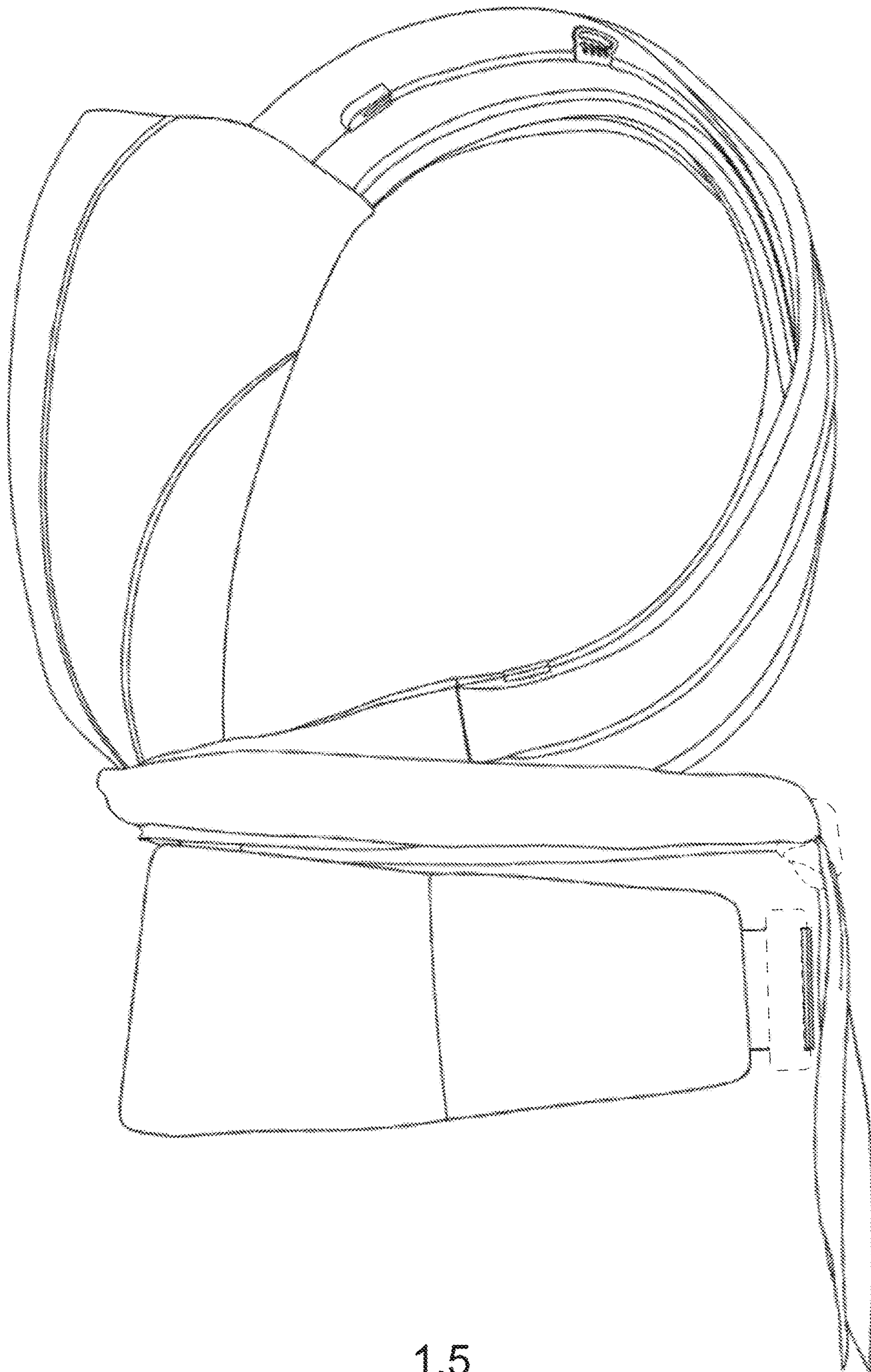

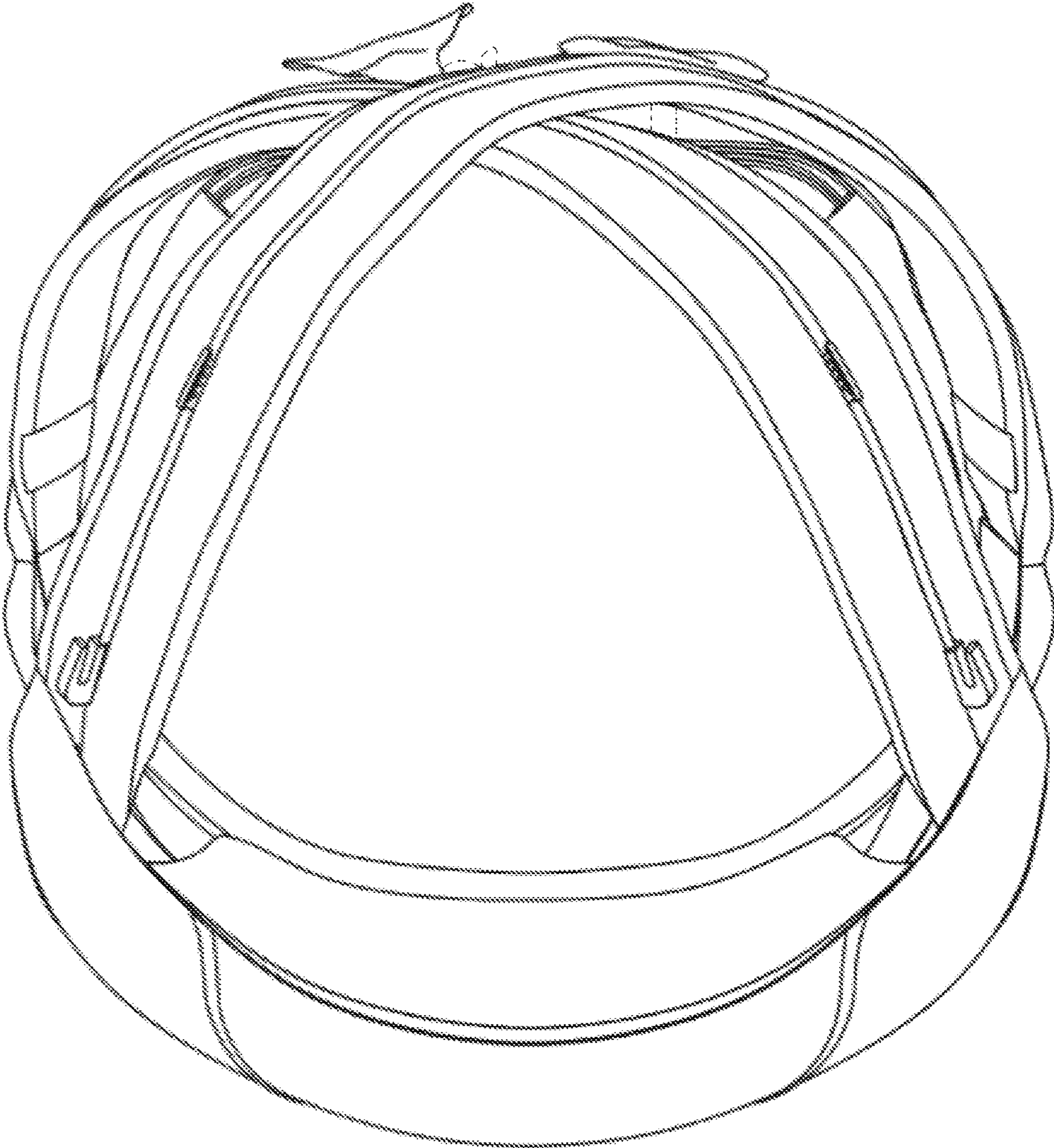
