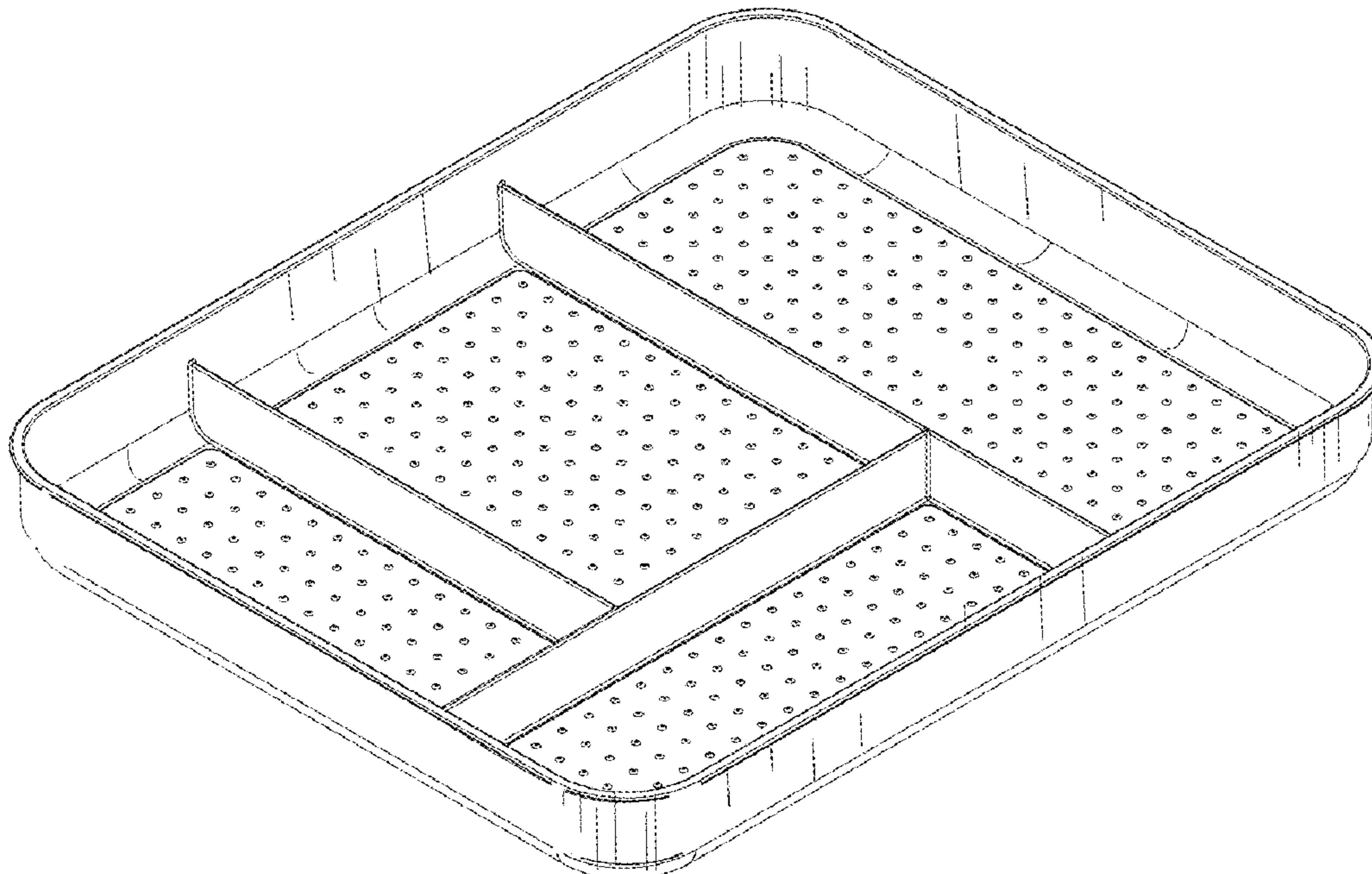
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the organizer tray.  
 FIG. 2 is a top plan view of the organizer tray.  
 FIG. 3 is a front elevational view of the organizer tray.  
 FIG. 4 is a rear elevational view of the organizer tray.  
 FIG. 5 is a right side elevational view of the organizer tray.

 FIG. 8 is a perspective view of an alternative embodiment of the organizer tray; and,

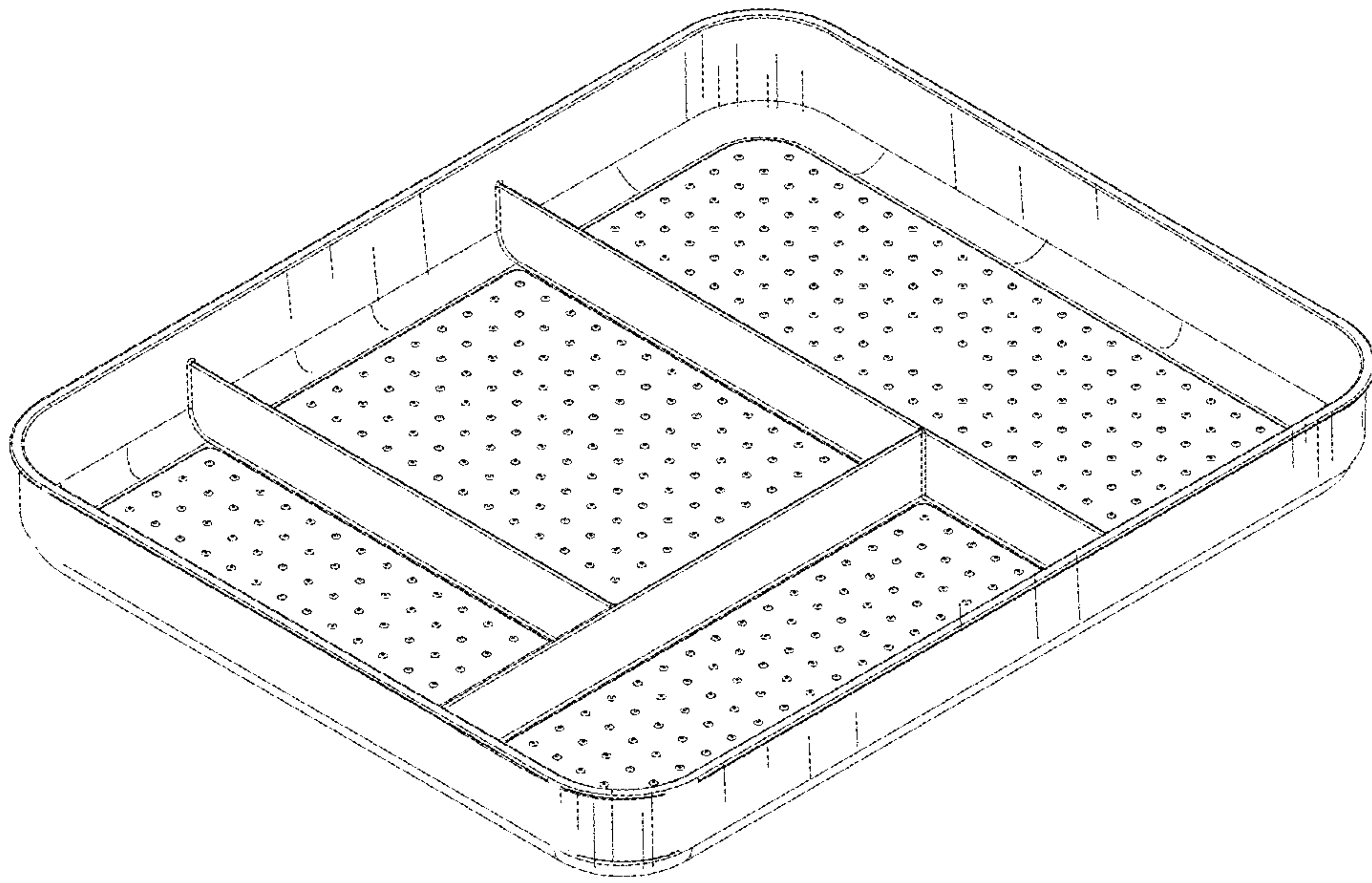

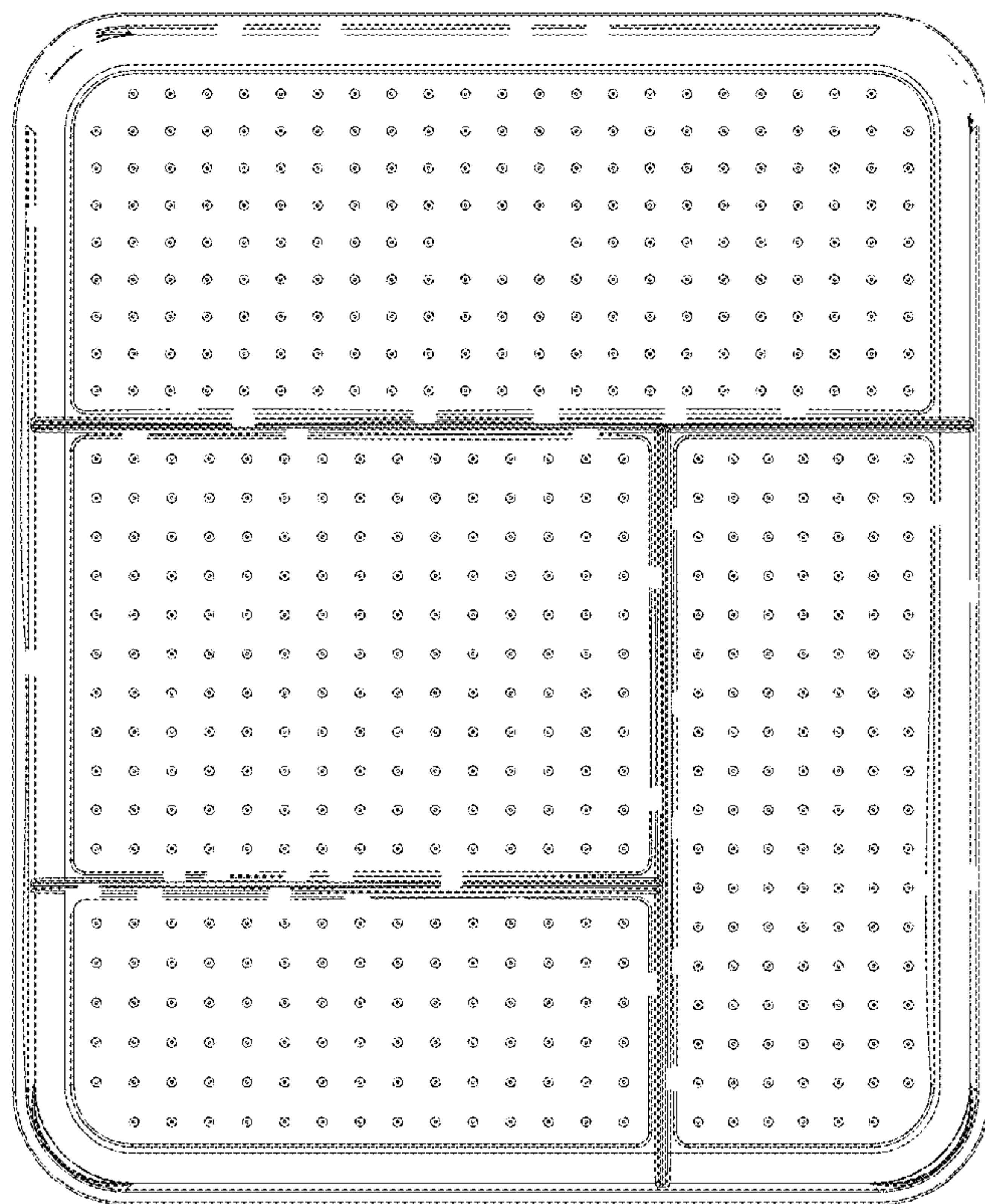

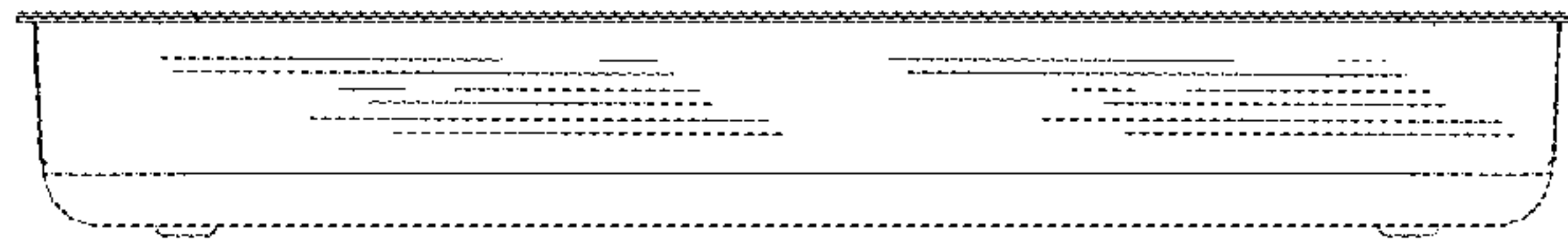

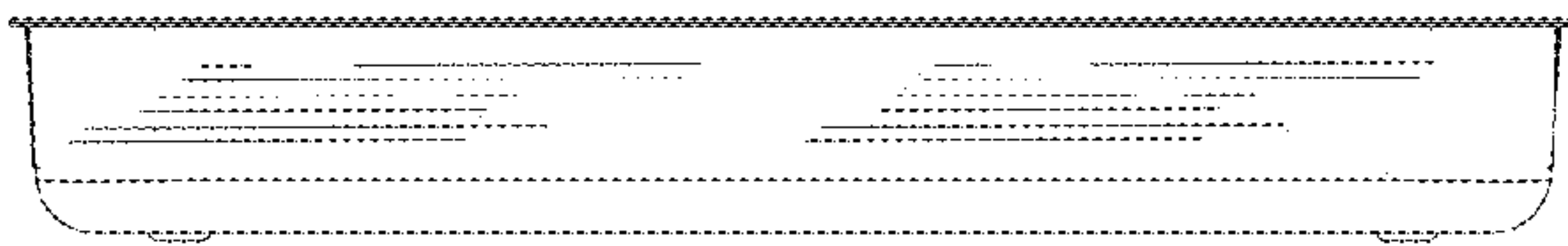

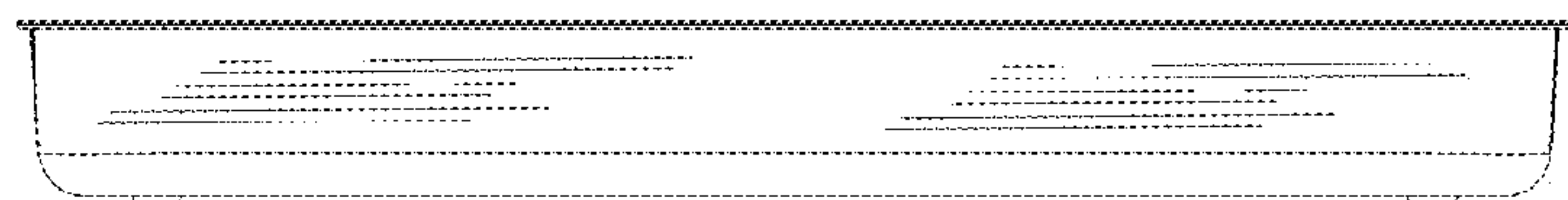

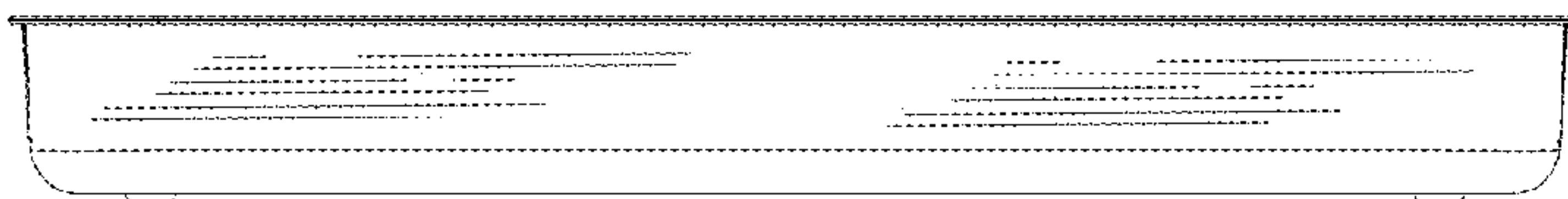

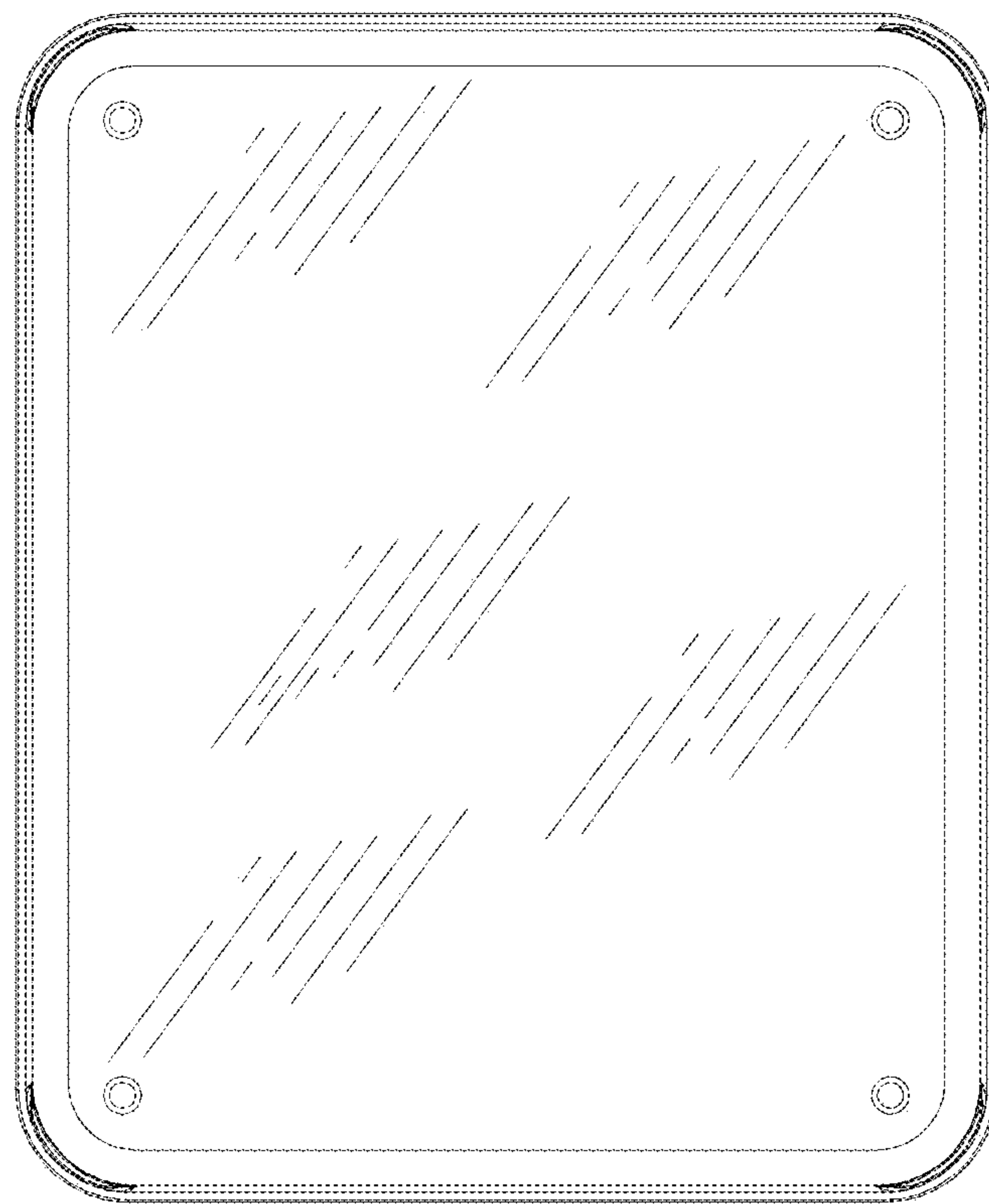

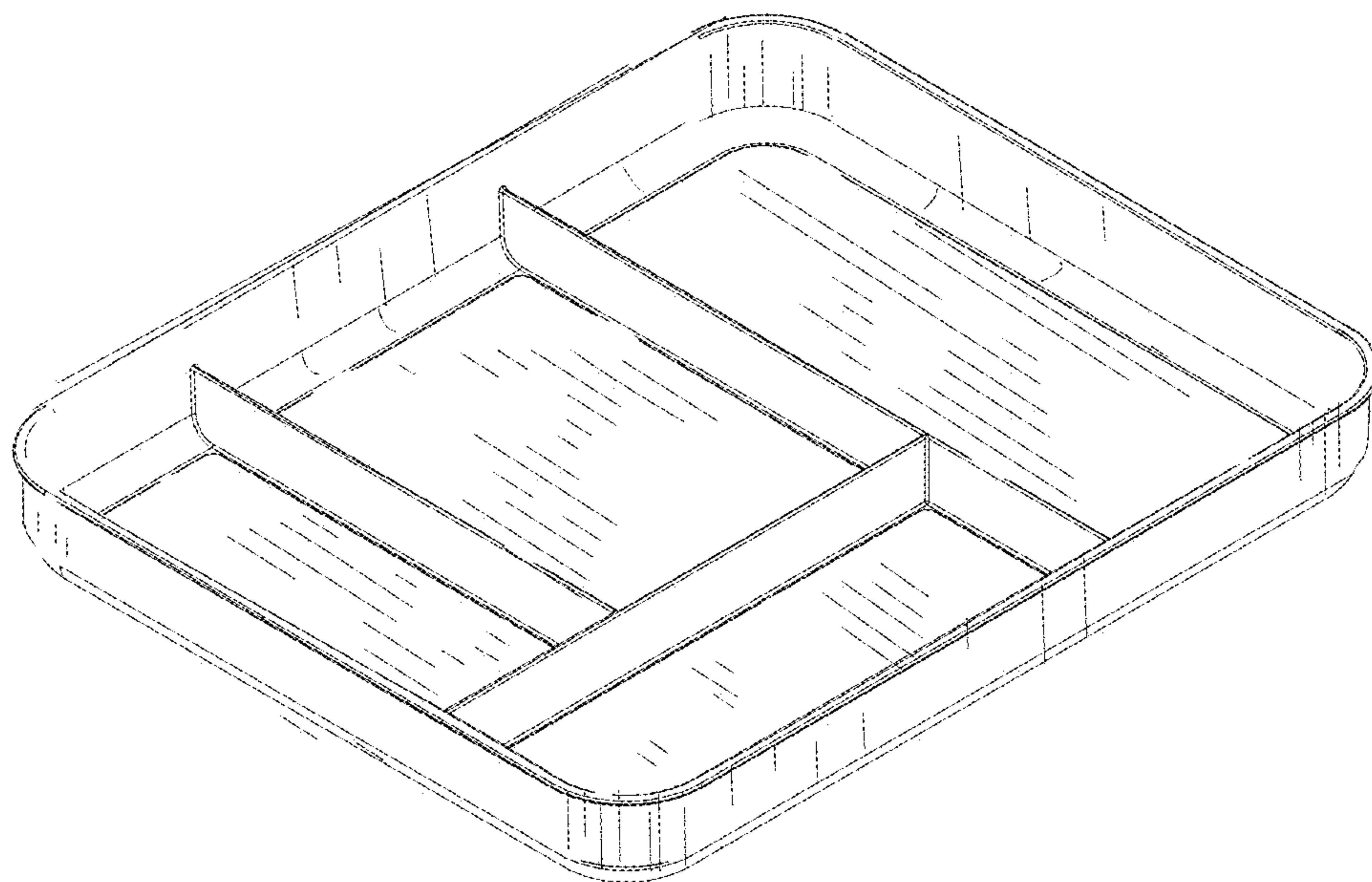

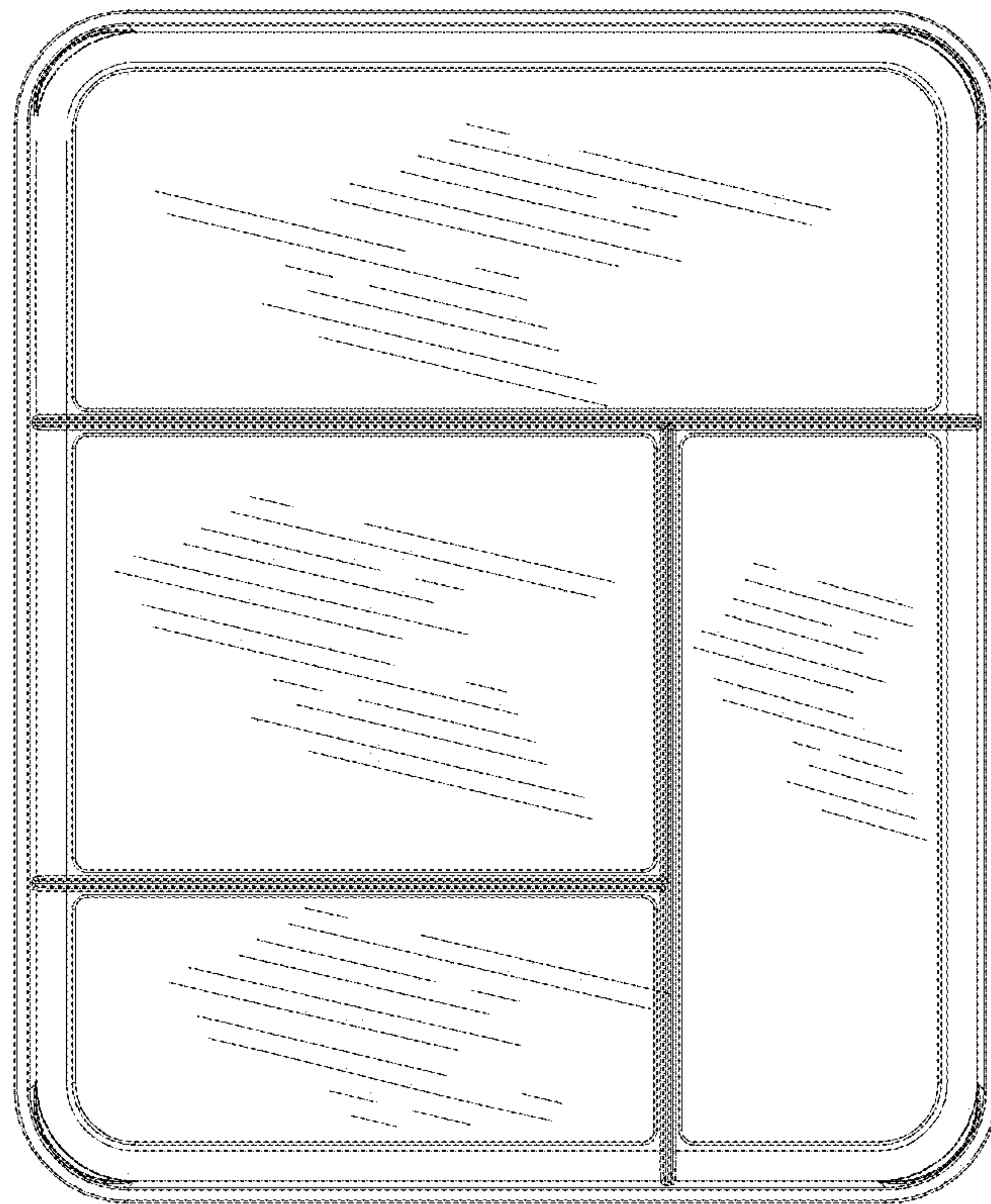
