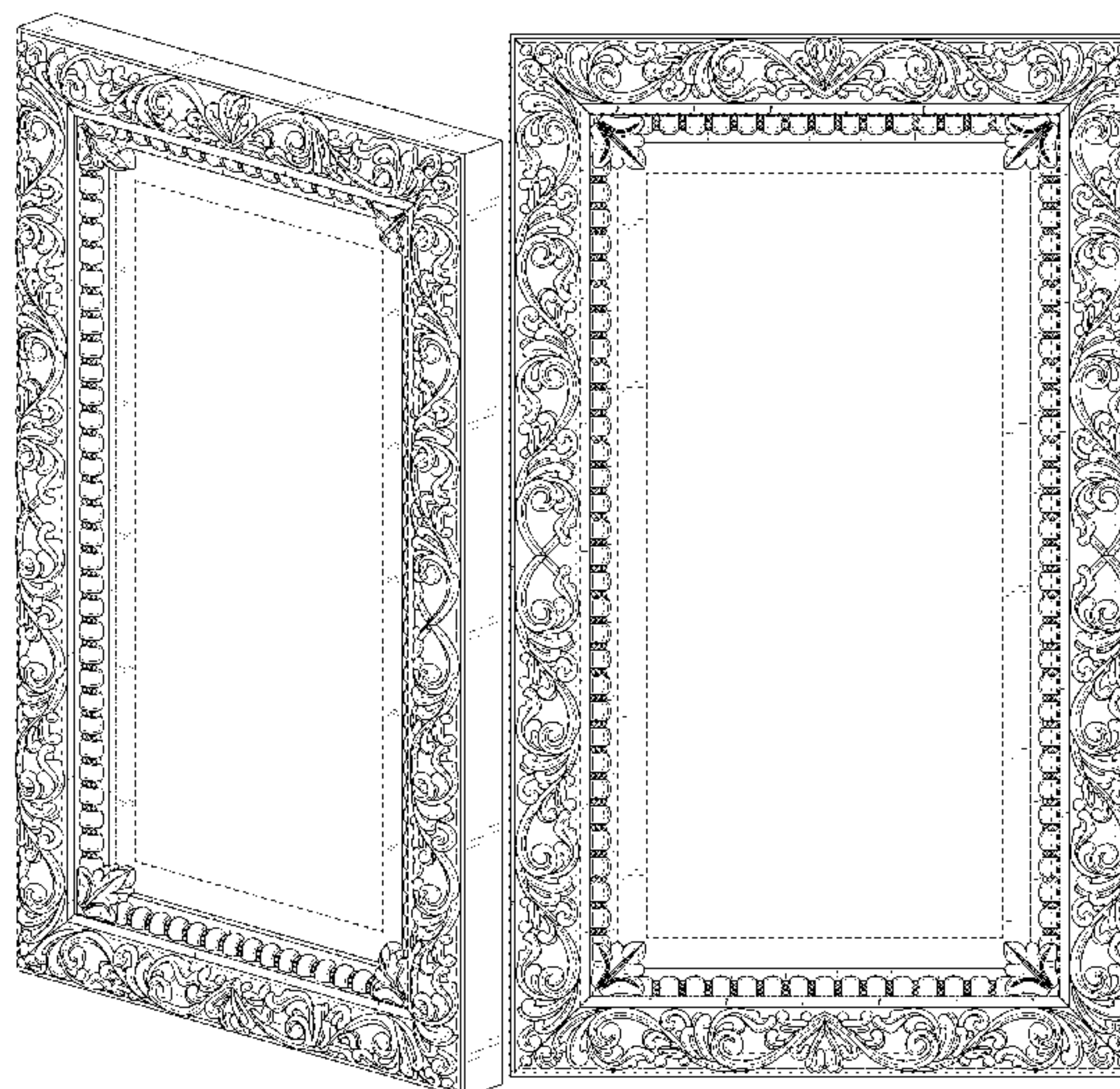
The ornamental design for a wall plate, as shown and described.

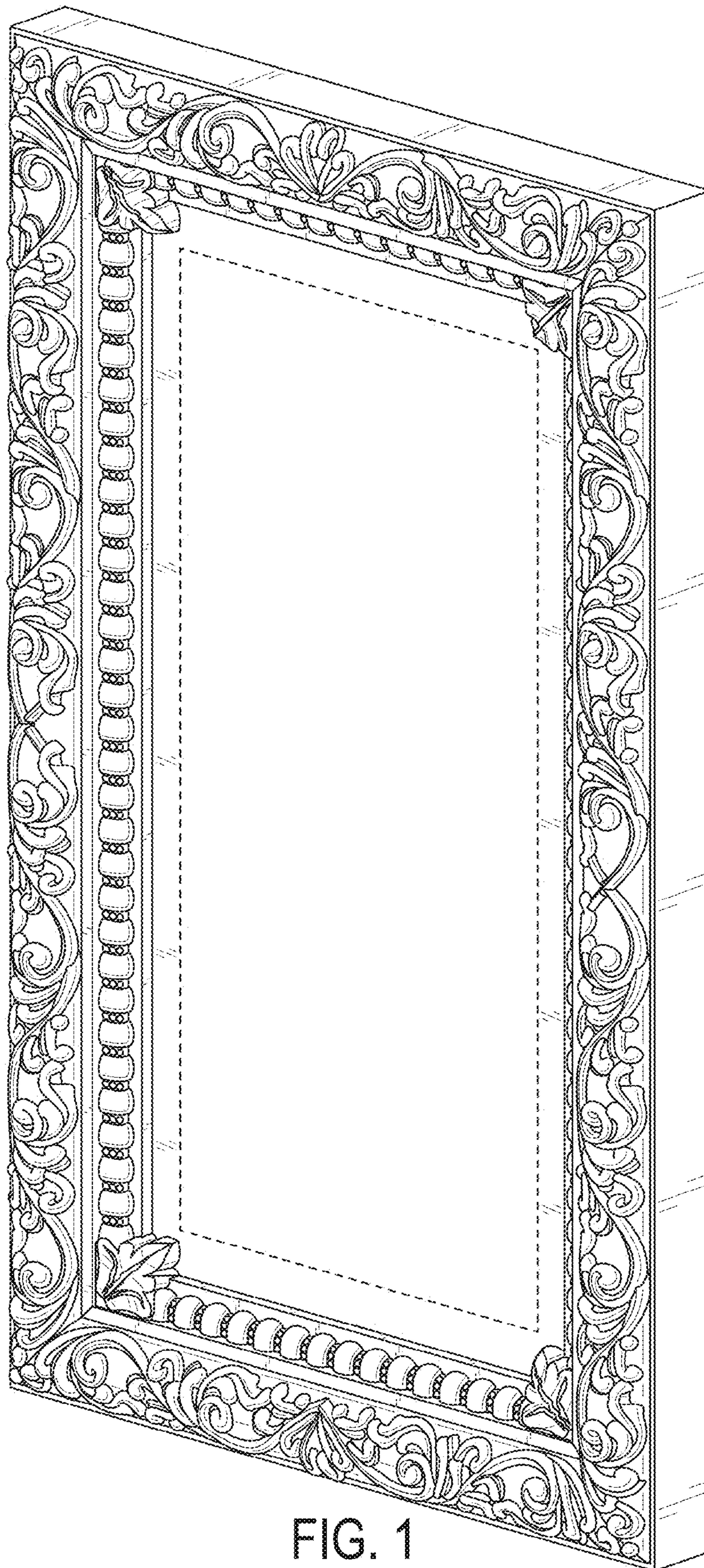

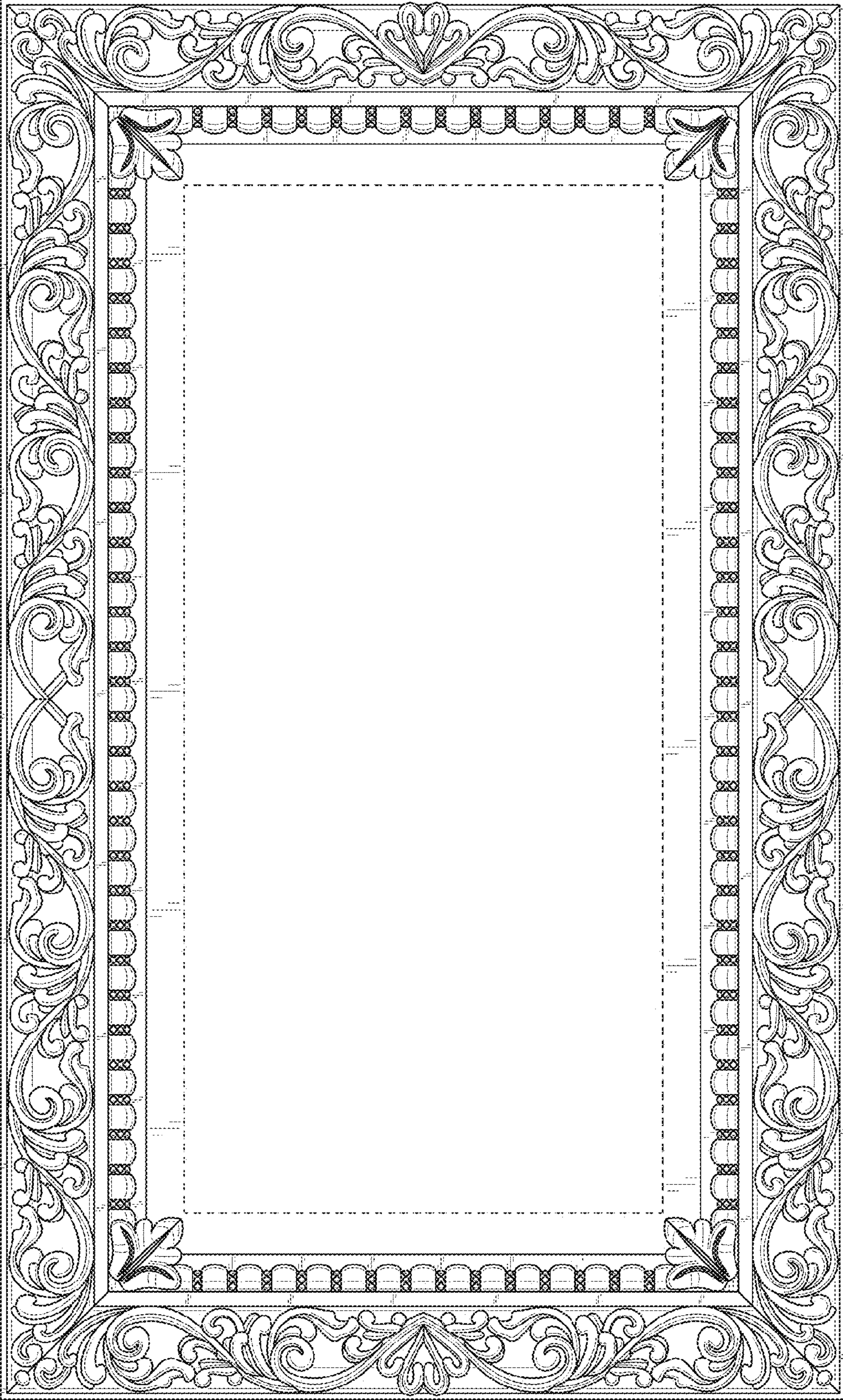

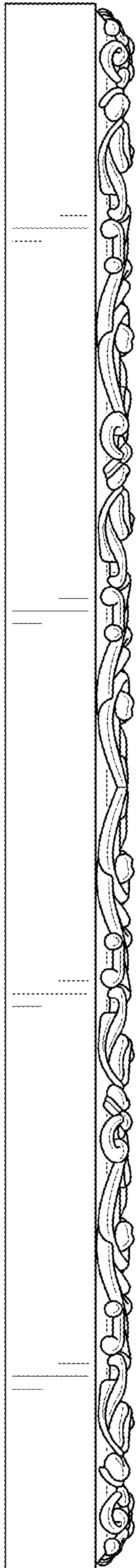

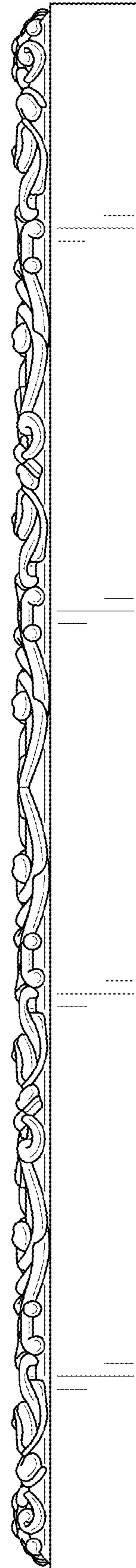

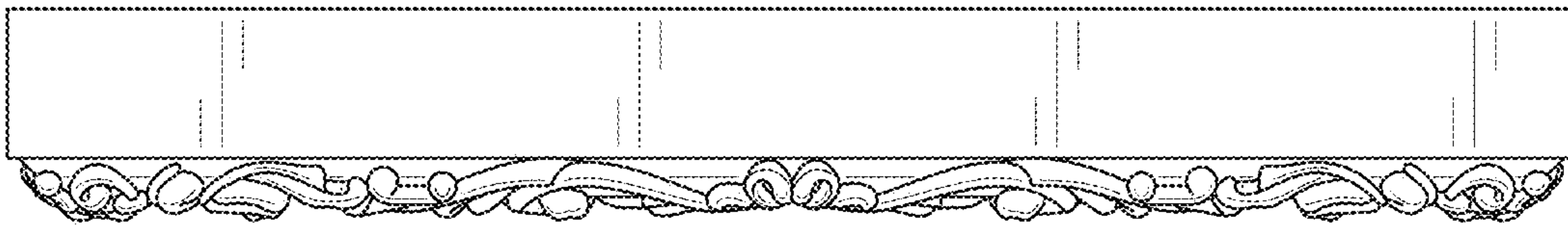

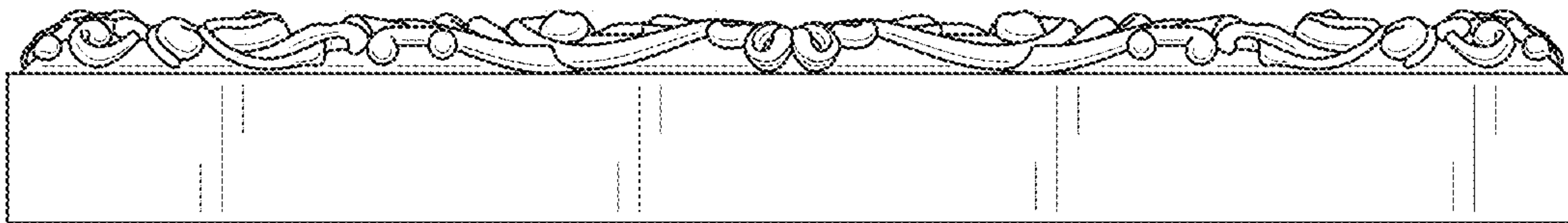

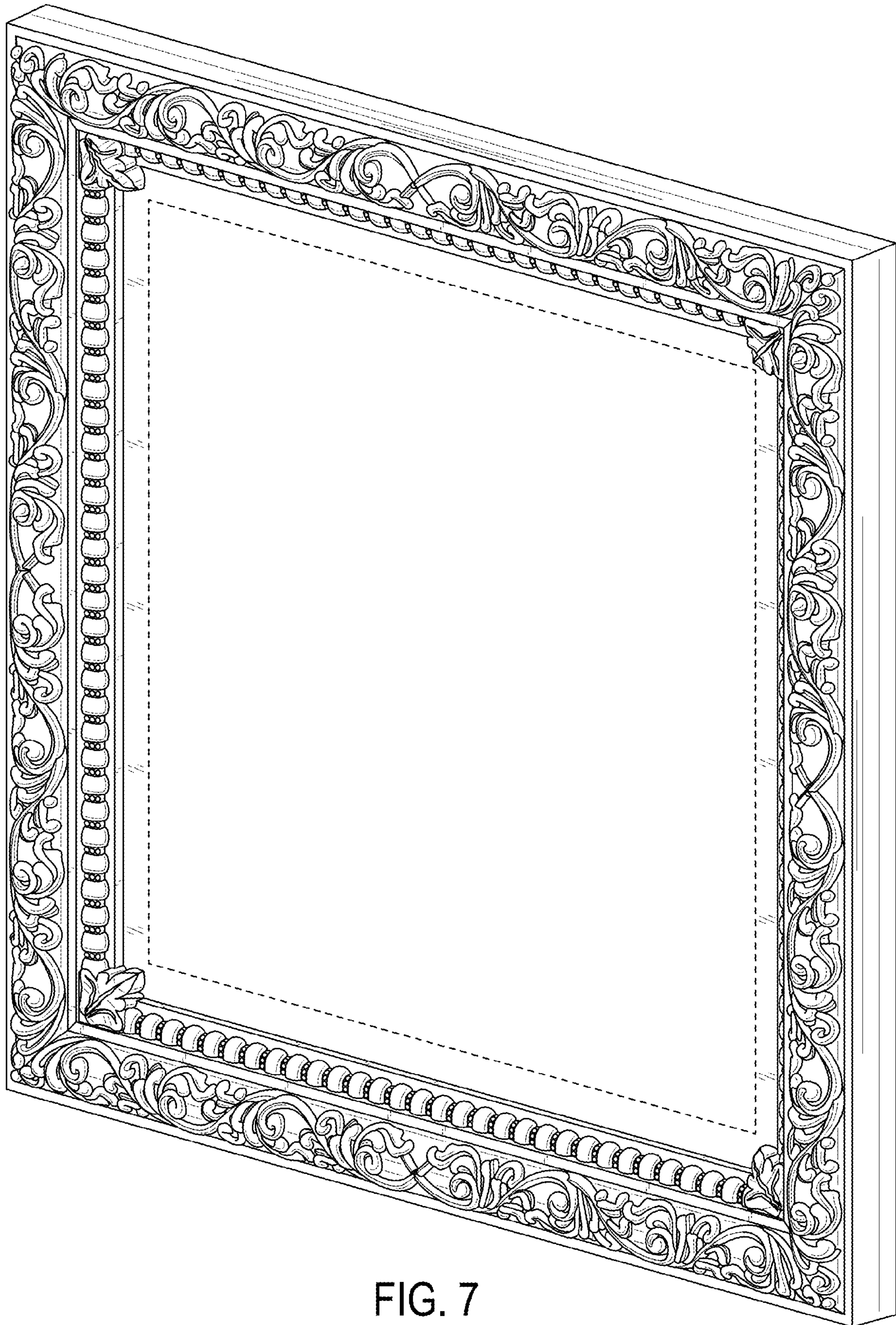

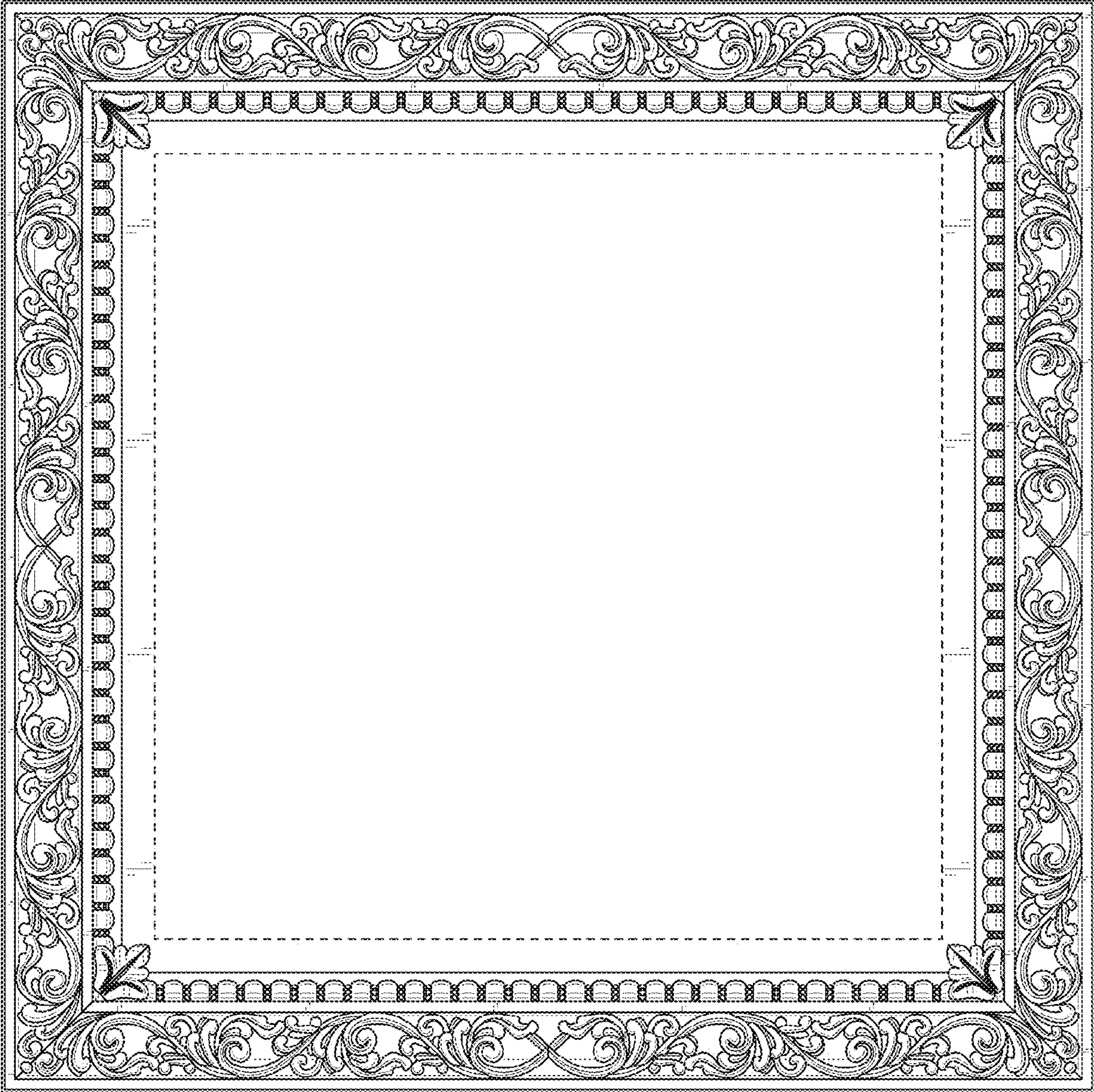

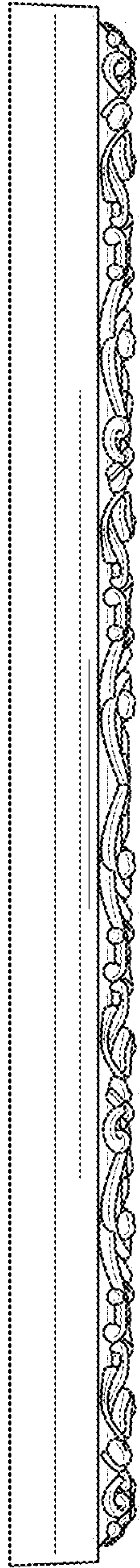

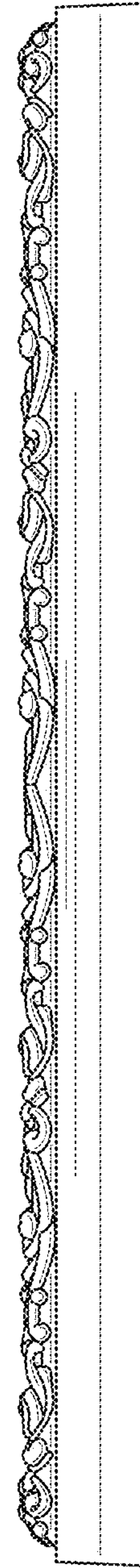

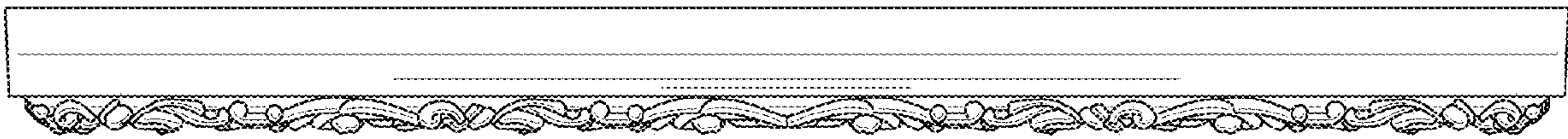

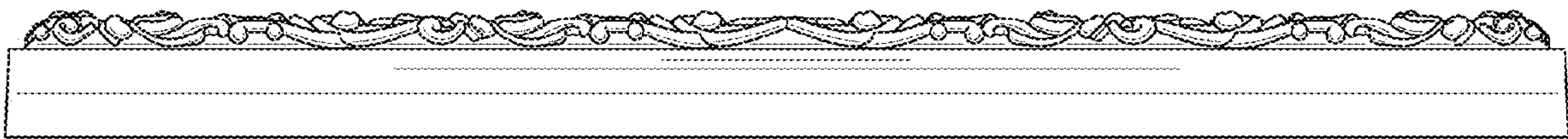

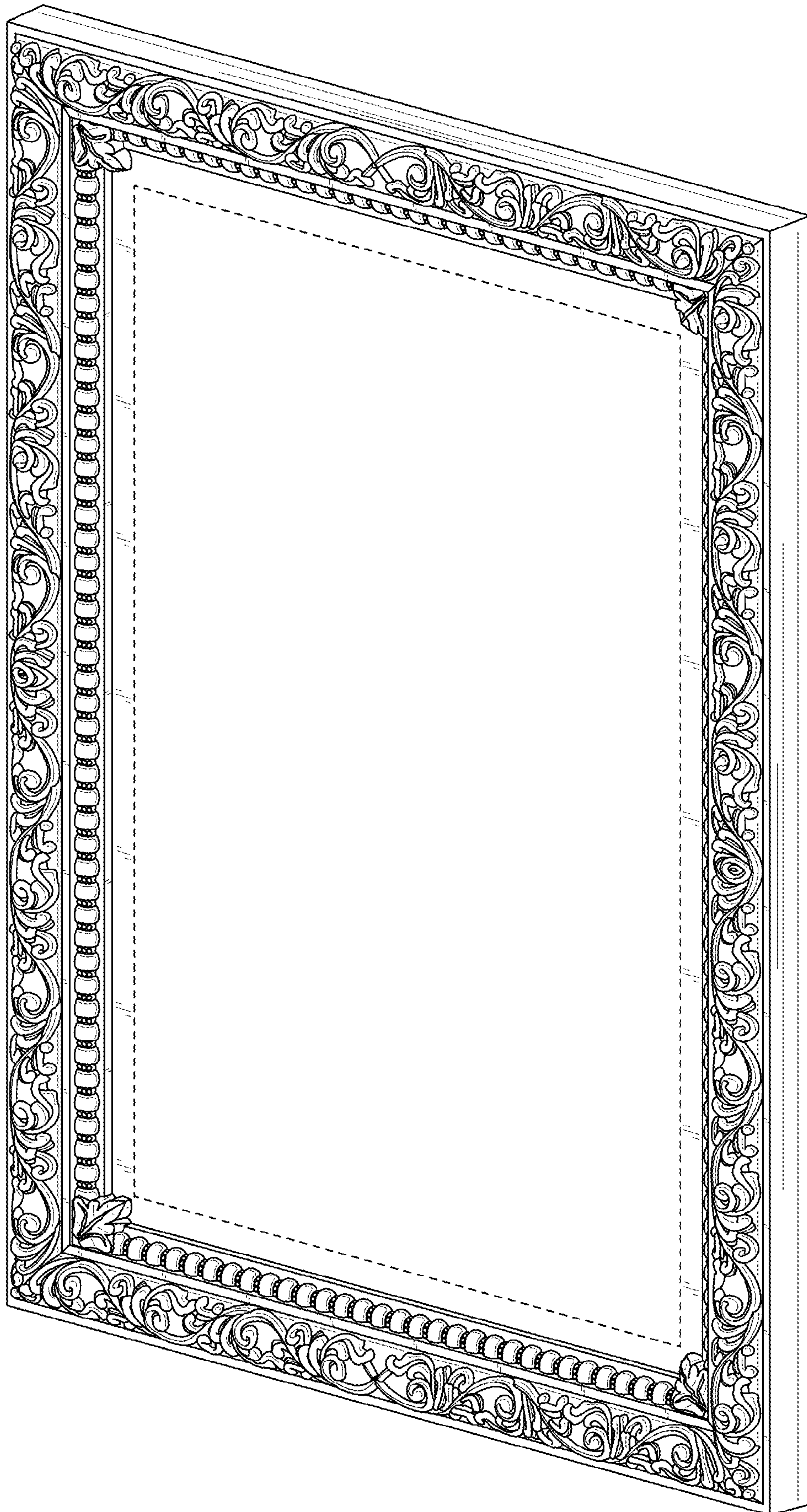

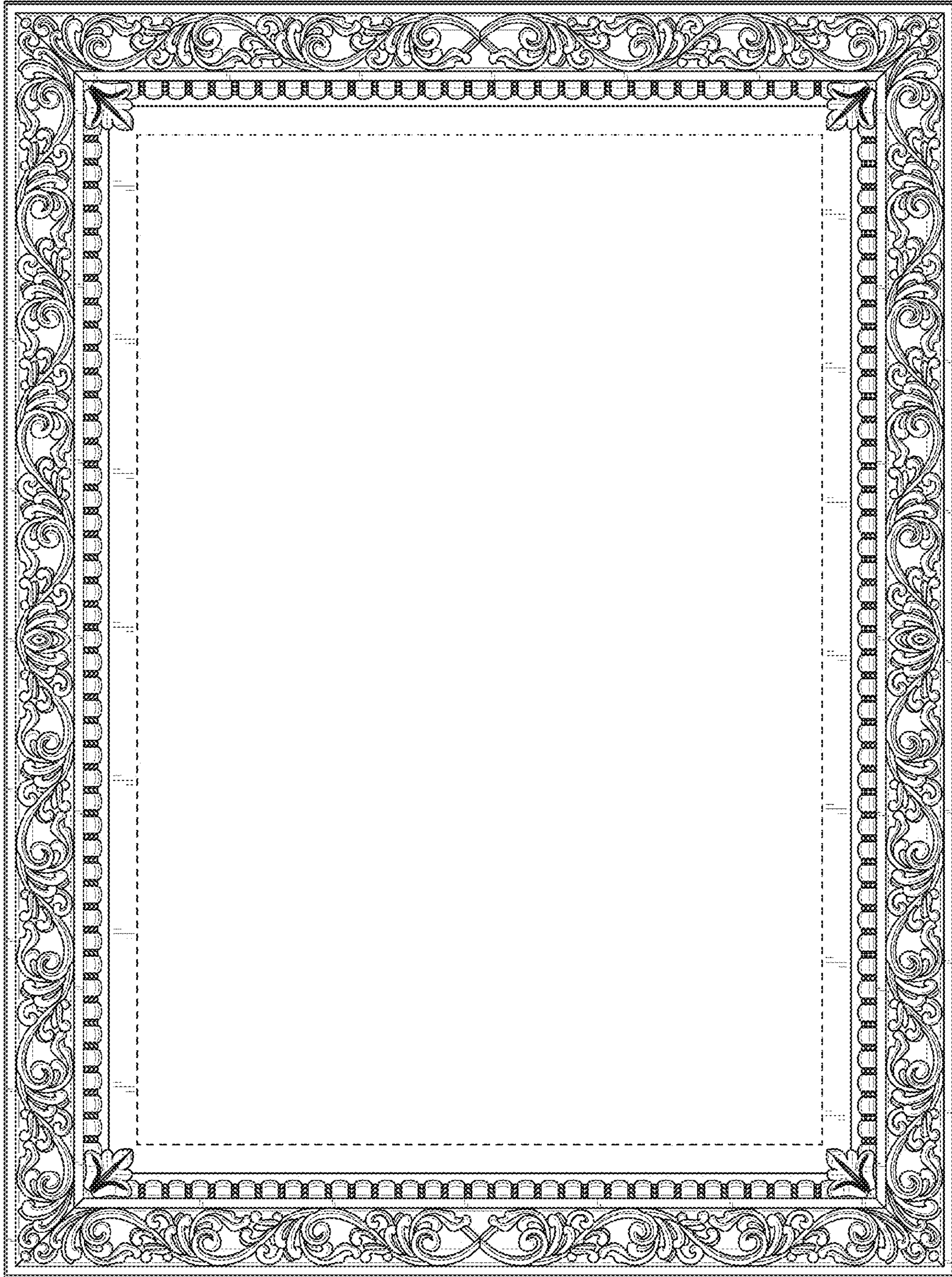

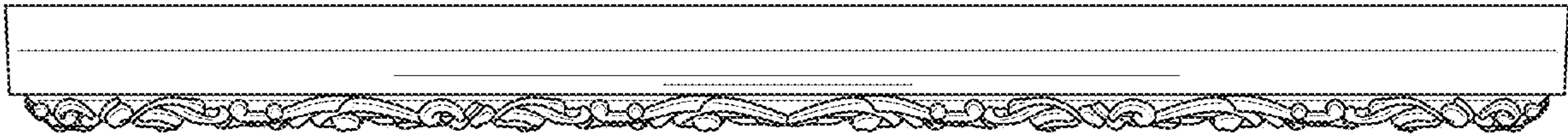

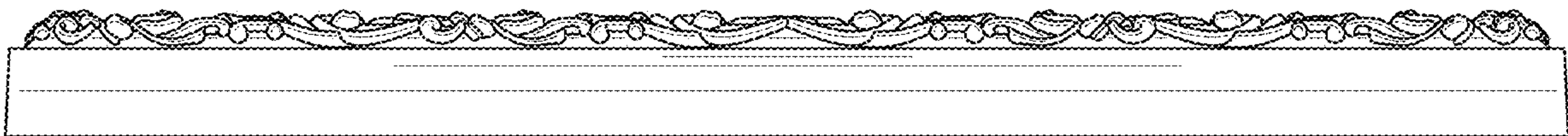

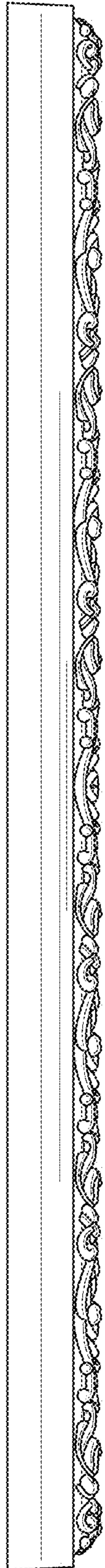

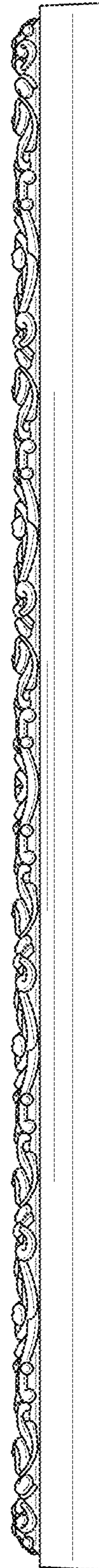

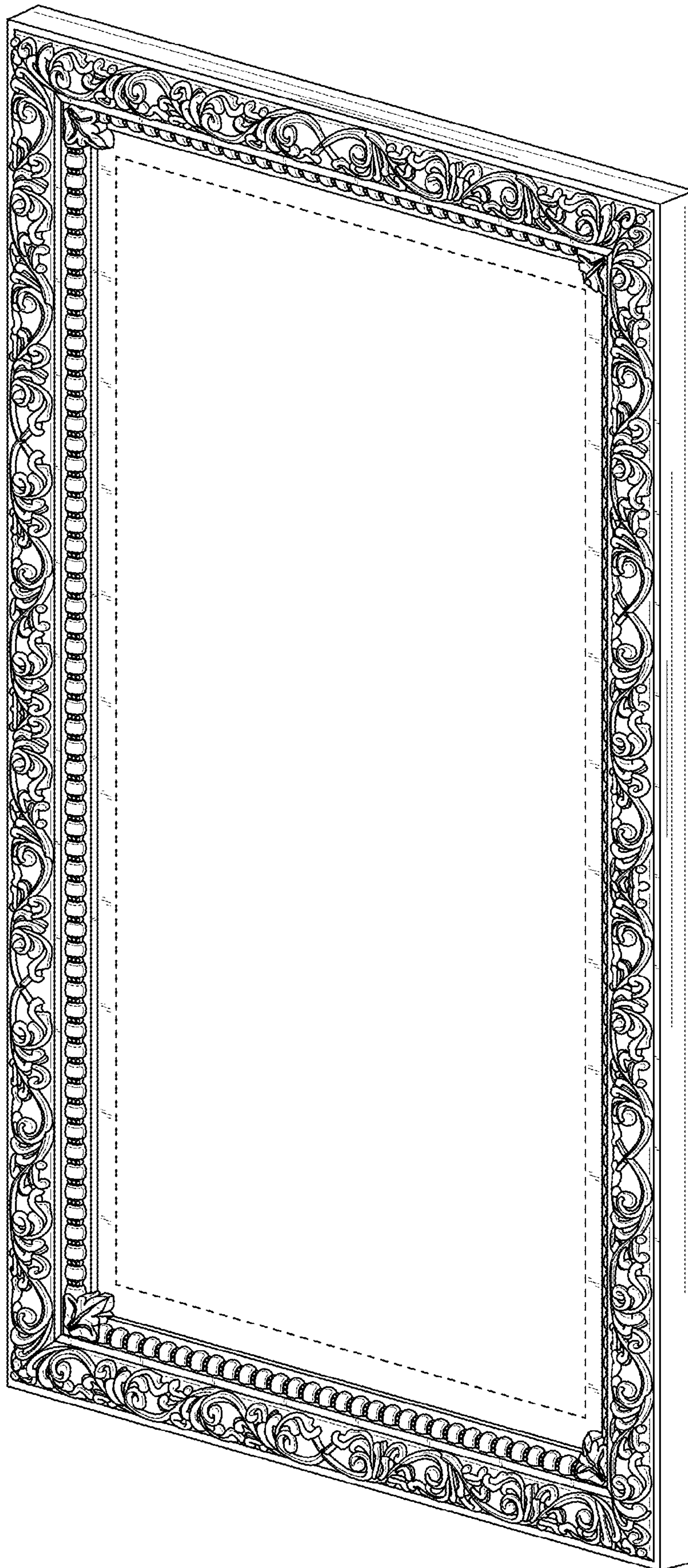

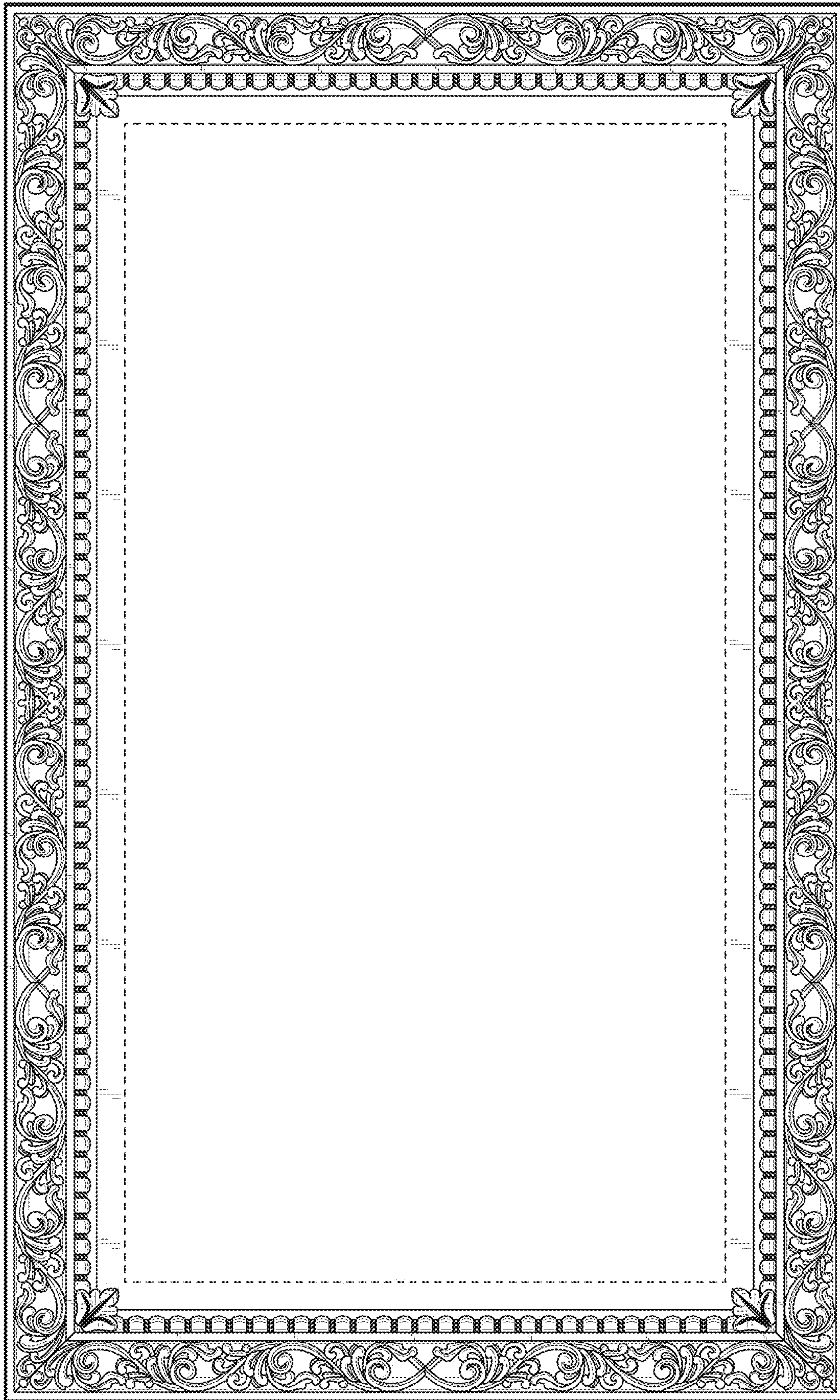

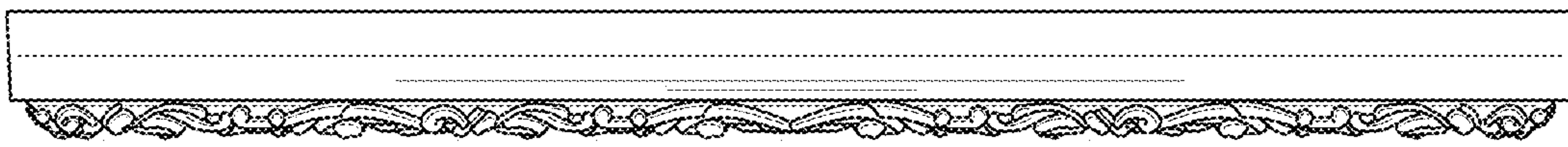

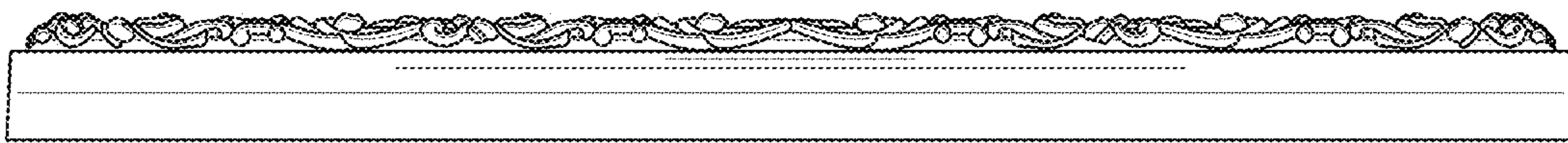

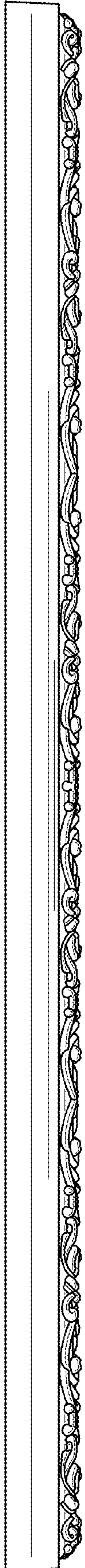

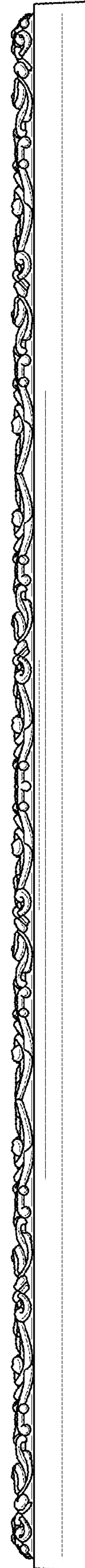
