DESCRIPTION

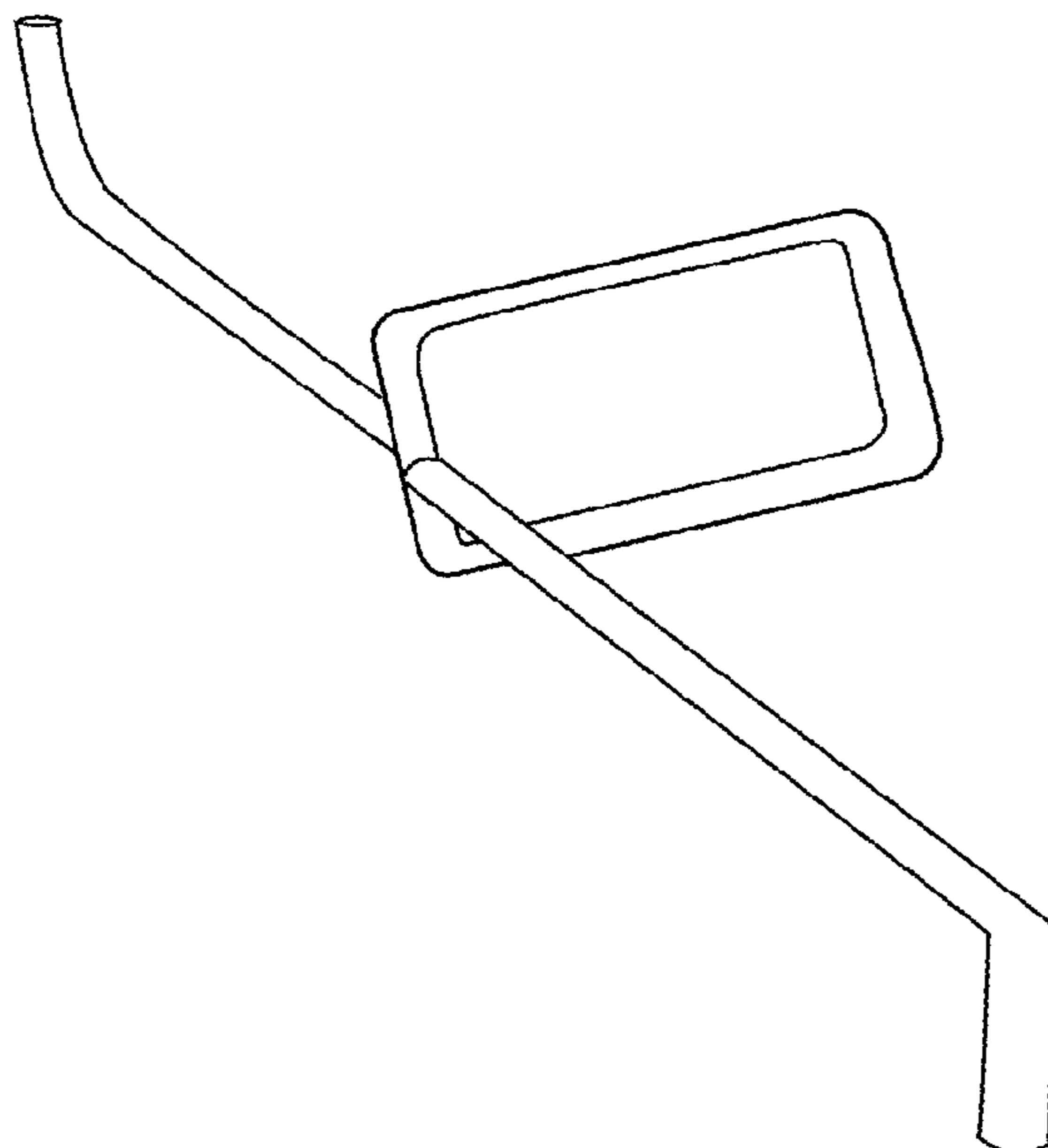
FIG. 1 is a perspective view of a first embodiment of a combination rebar positioner and fastener, showing my new design;

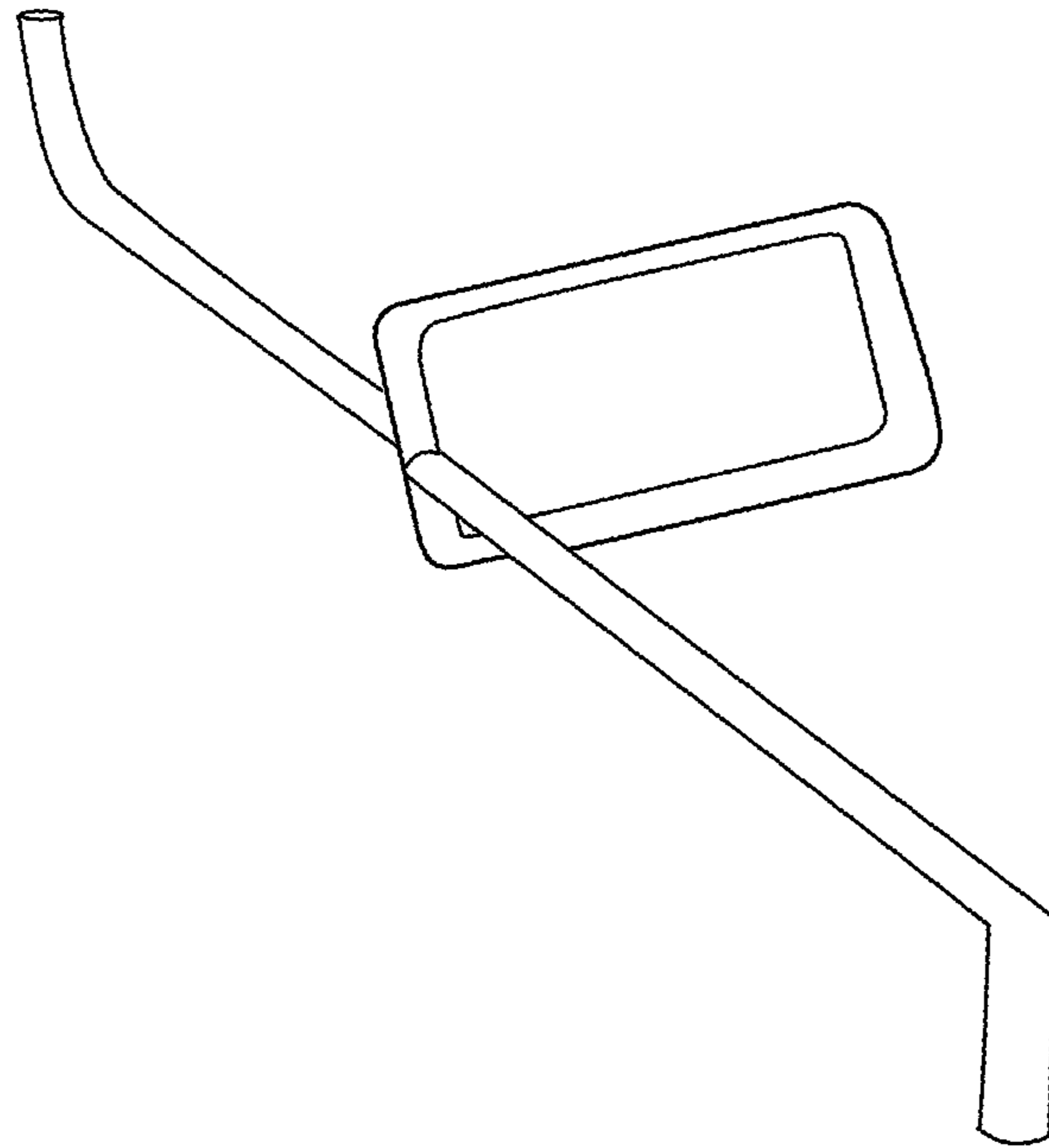

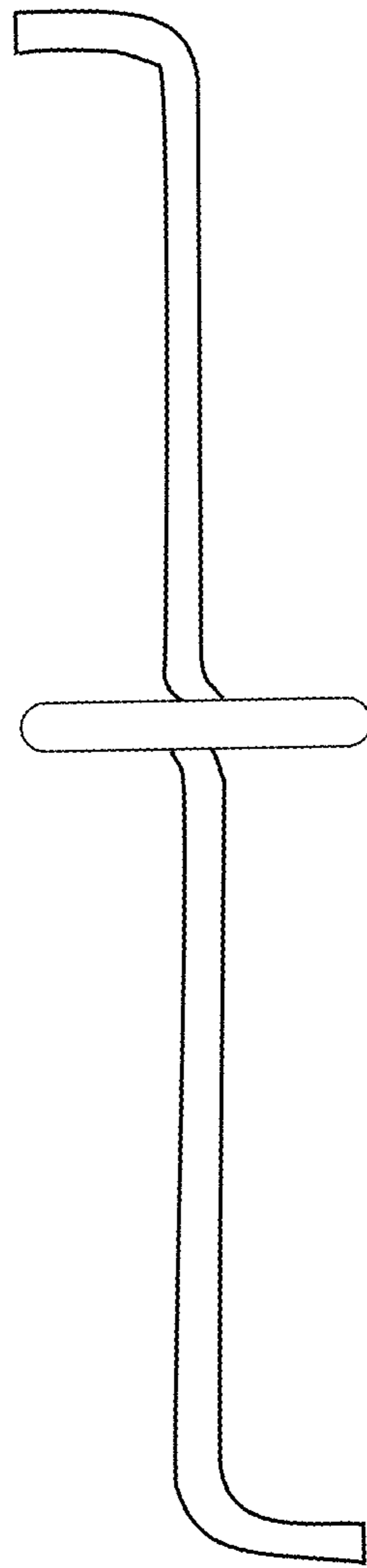

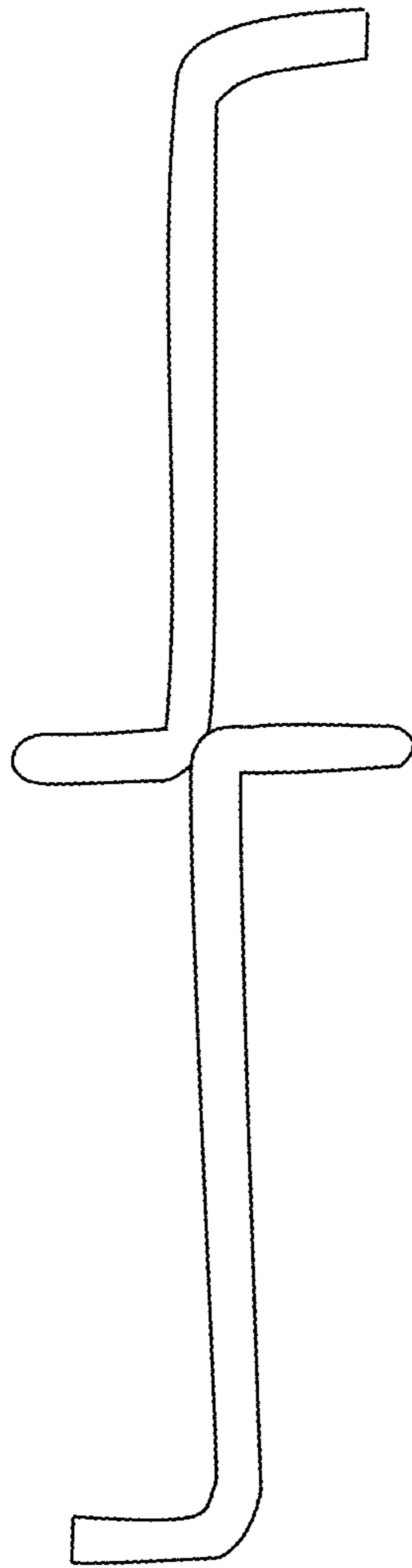

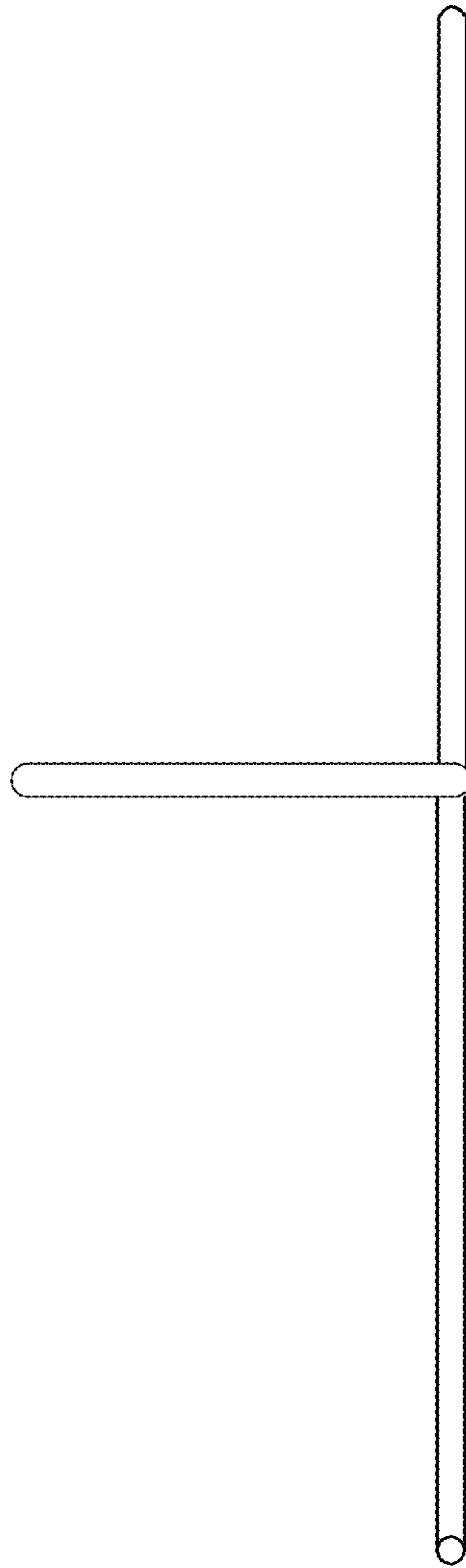

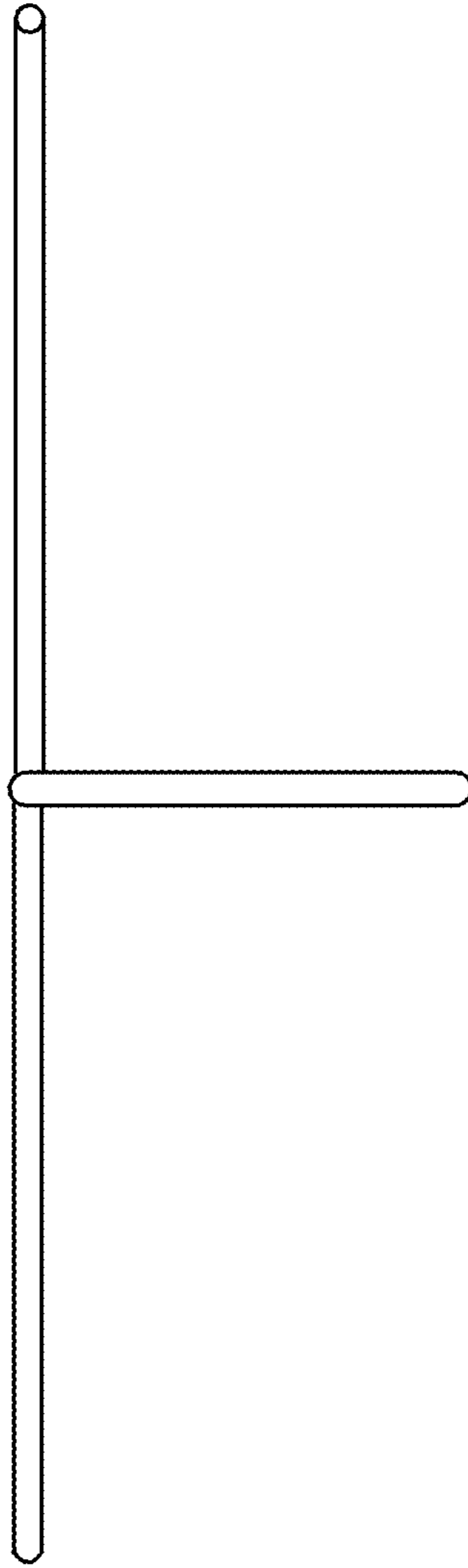

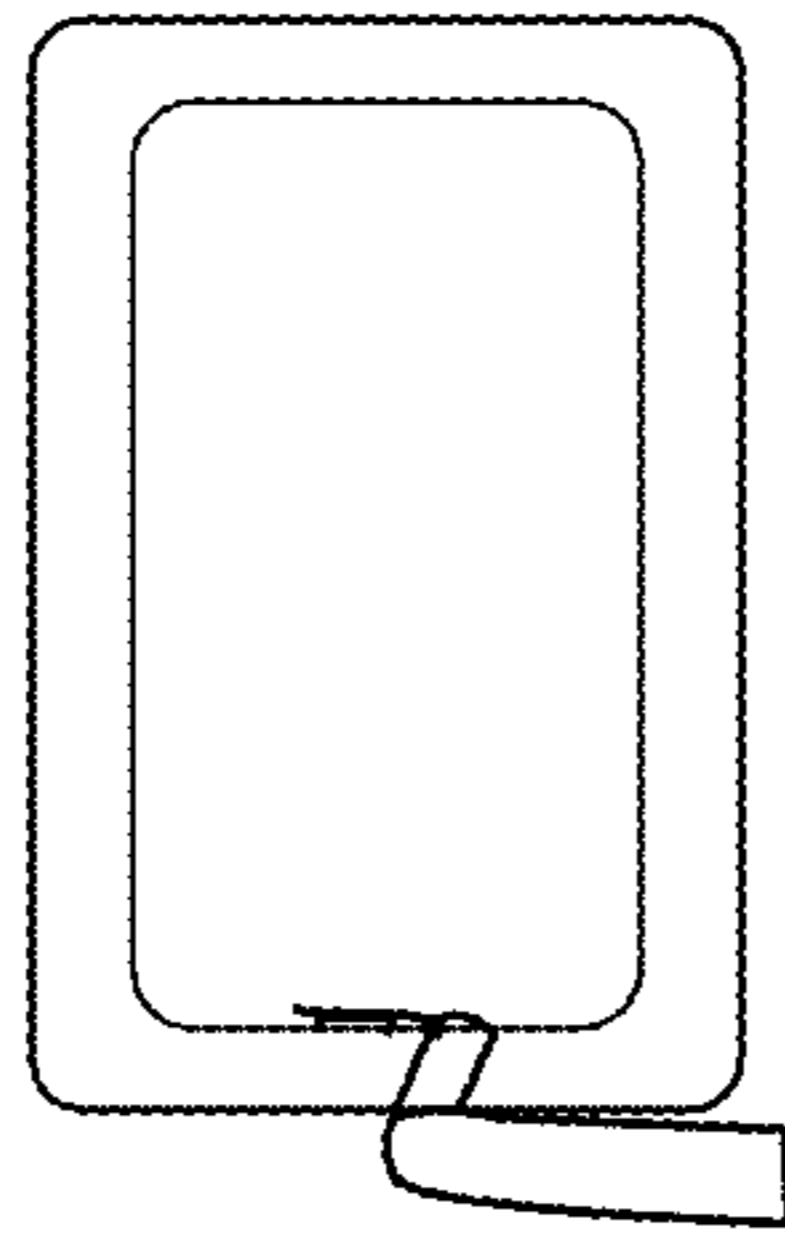

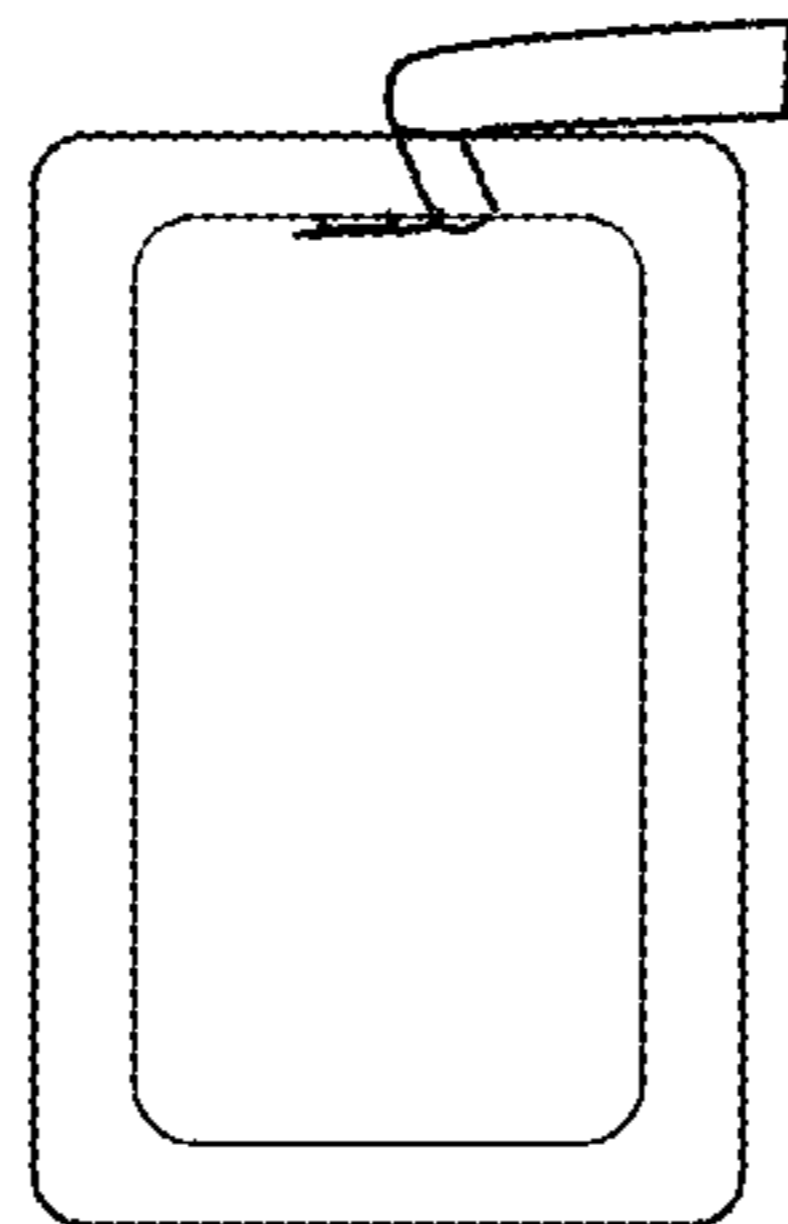
