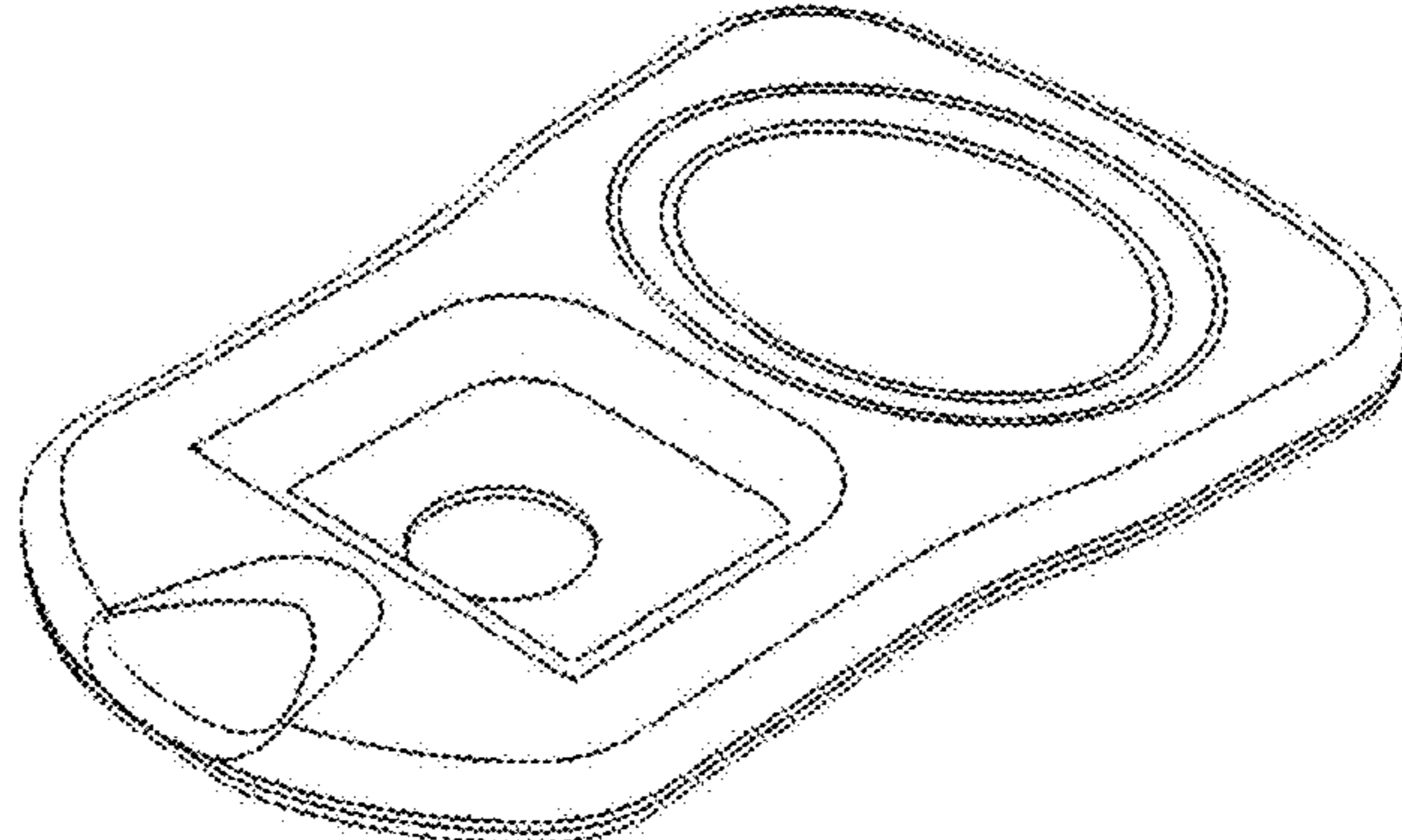
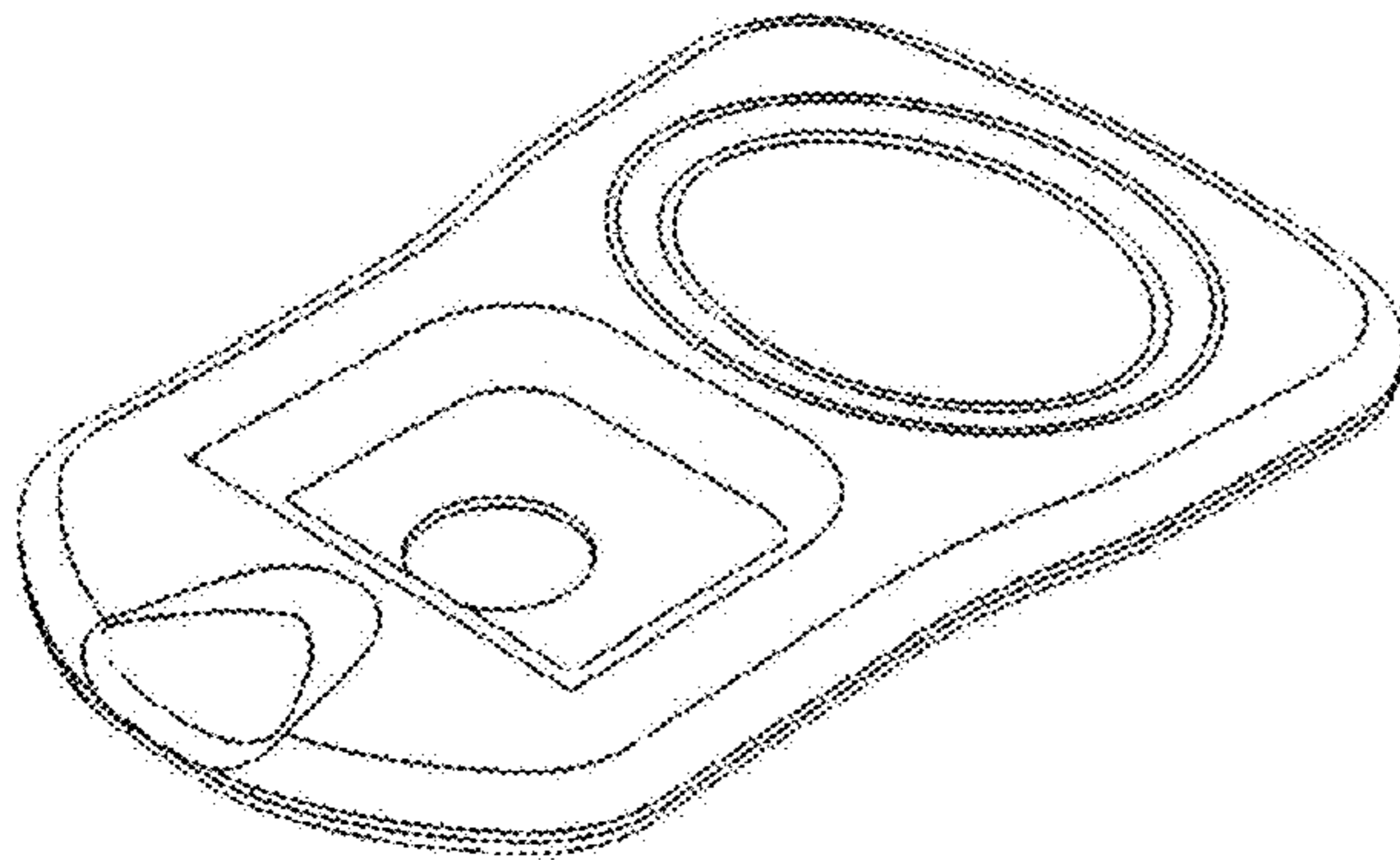
(57) **CLAIM**

I claim the ornamental design for a beverage can tab, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a beverage can tab according to a first embodiment of my new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a back elevation view thereof; FIG. 7 is a left side elevation view thereof, a right side elevation view being a mirror image of the left side elevation view; FIG. 8 is a top perspective view of a beverage can tab according to a second embodiment of my new design; FIG. 9 is a bottom perspective view thereof; FIG. 10 is a top plan view thereof; FIG. 11 is a bottom plan view thereof; FIG. 12 is a front elevation view thereof; FIG. 13 is a back elevation view thereof; and, FIG. 14 is a left side elevation view thereof, a right side elevation view being a mirror image of the left side elevation view.

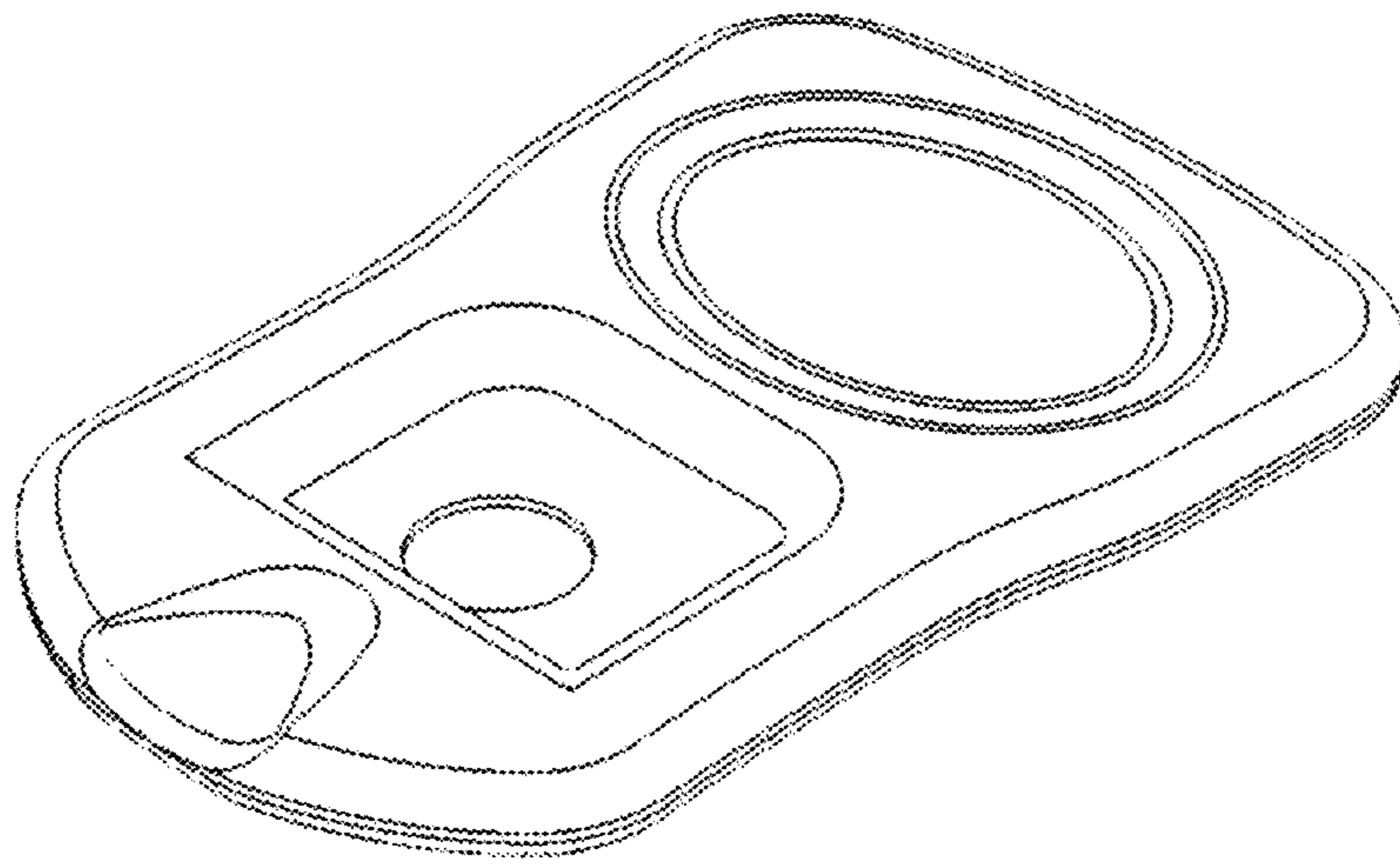

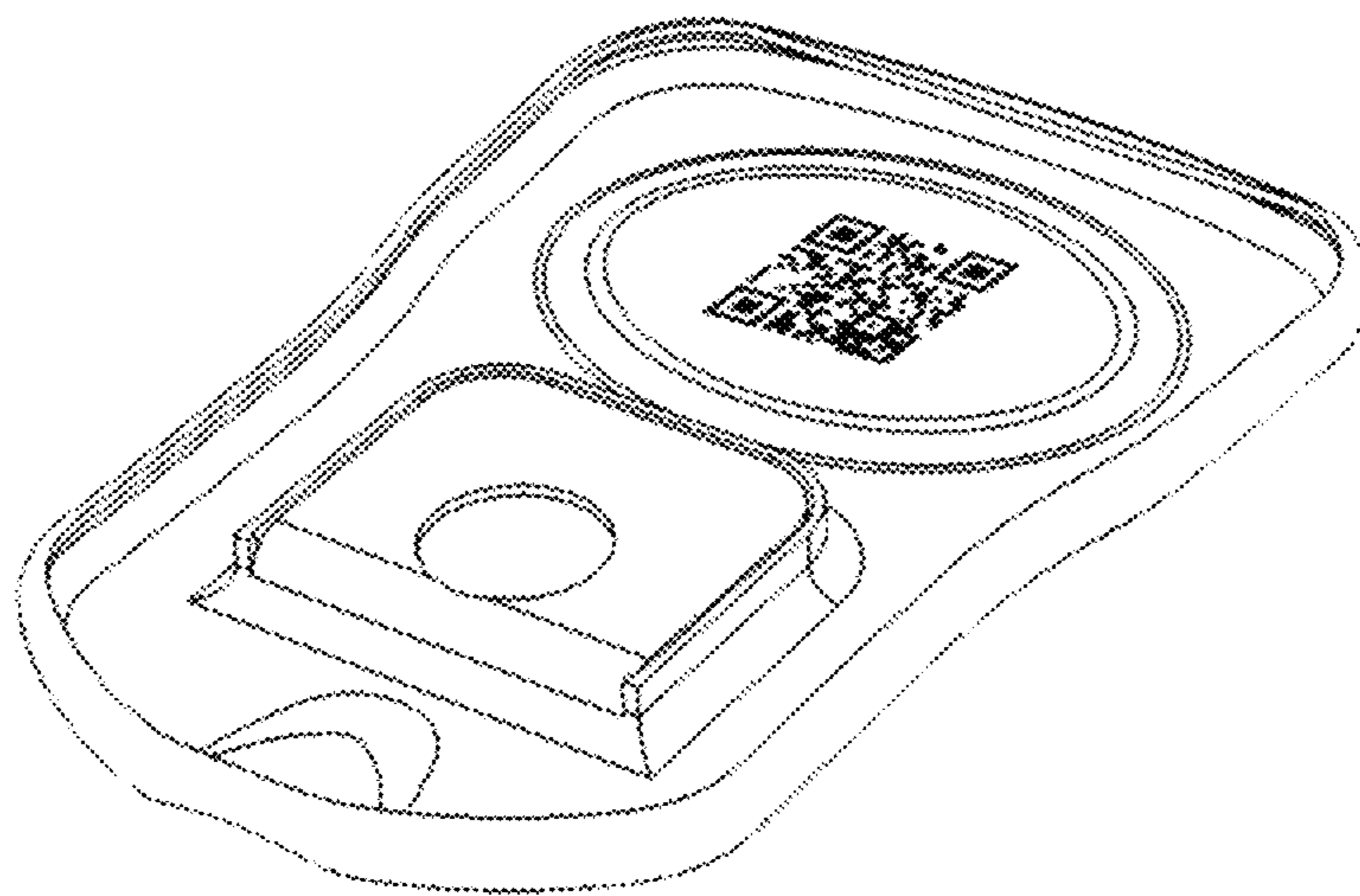

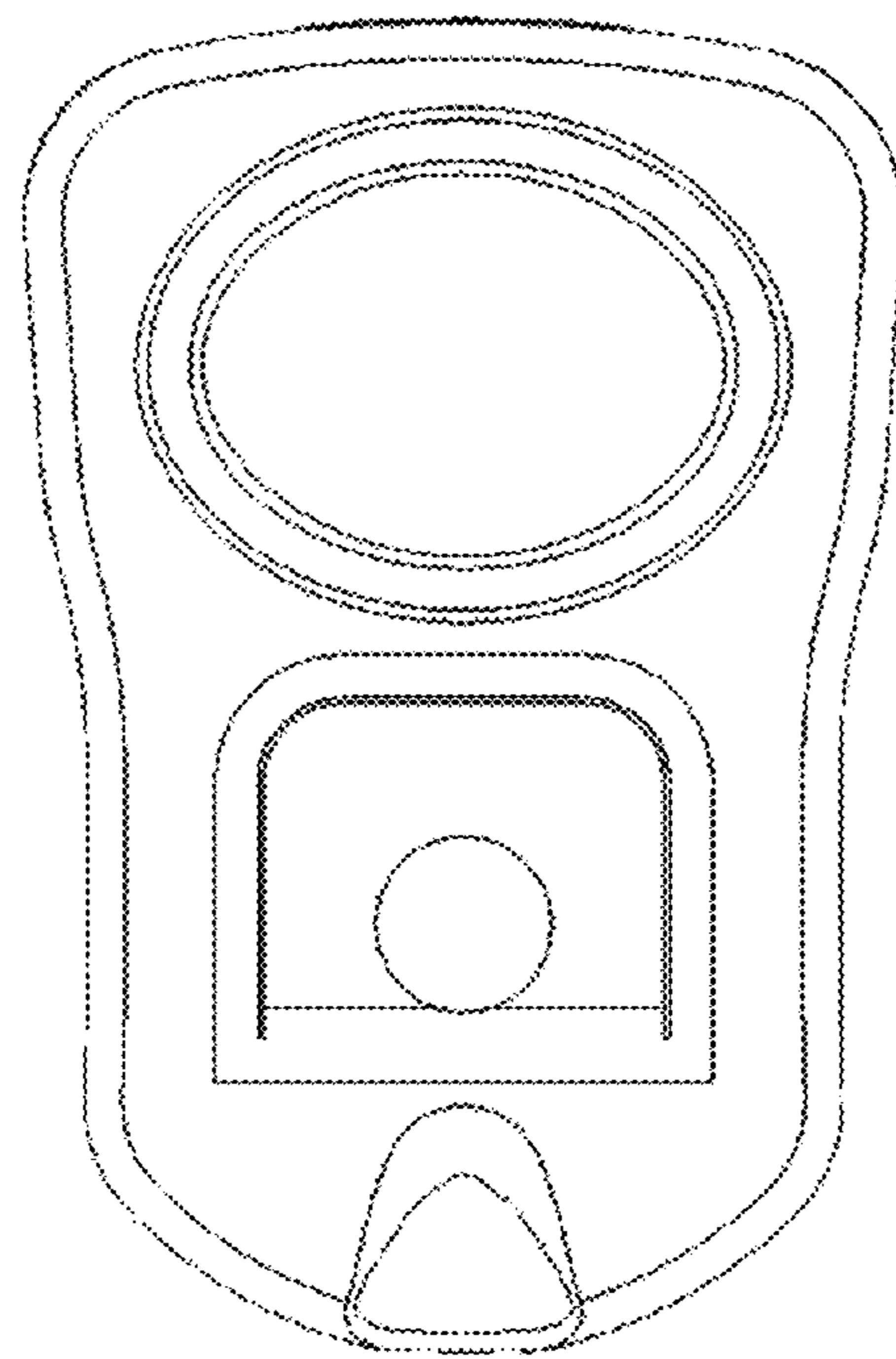

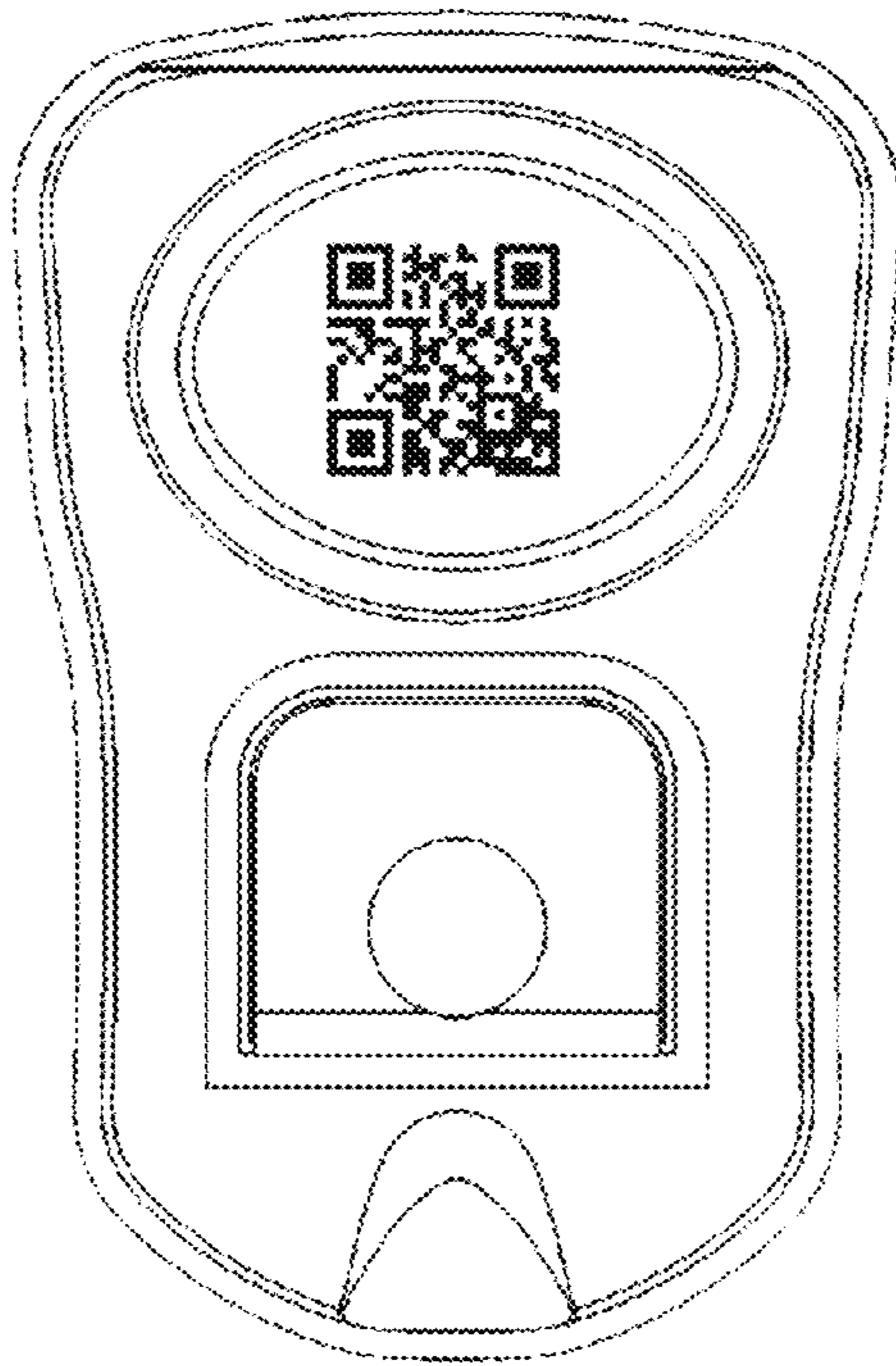

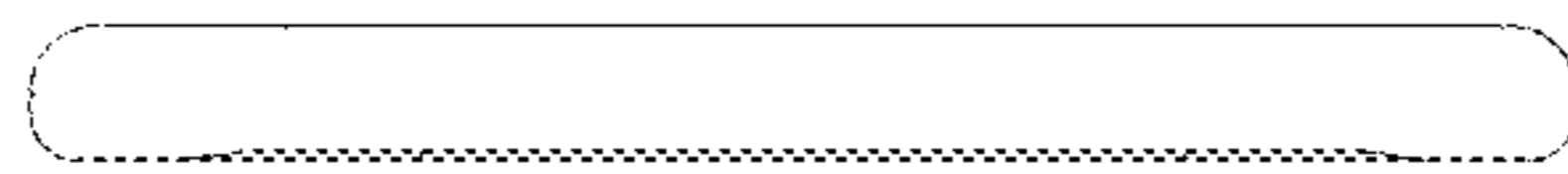

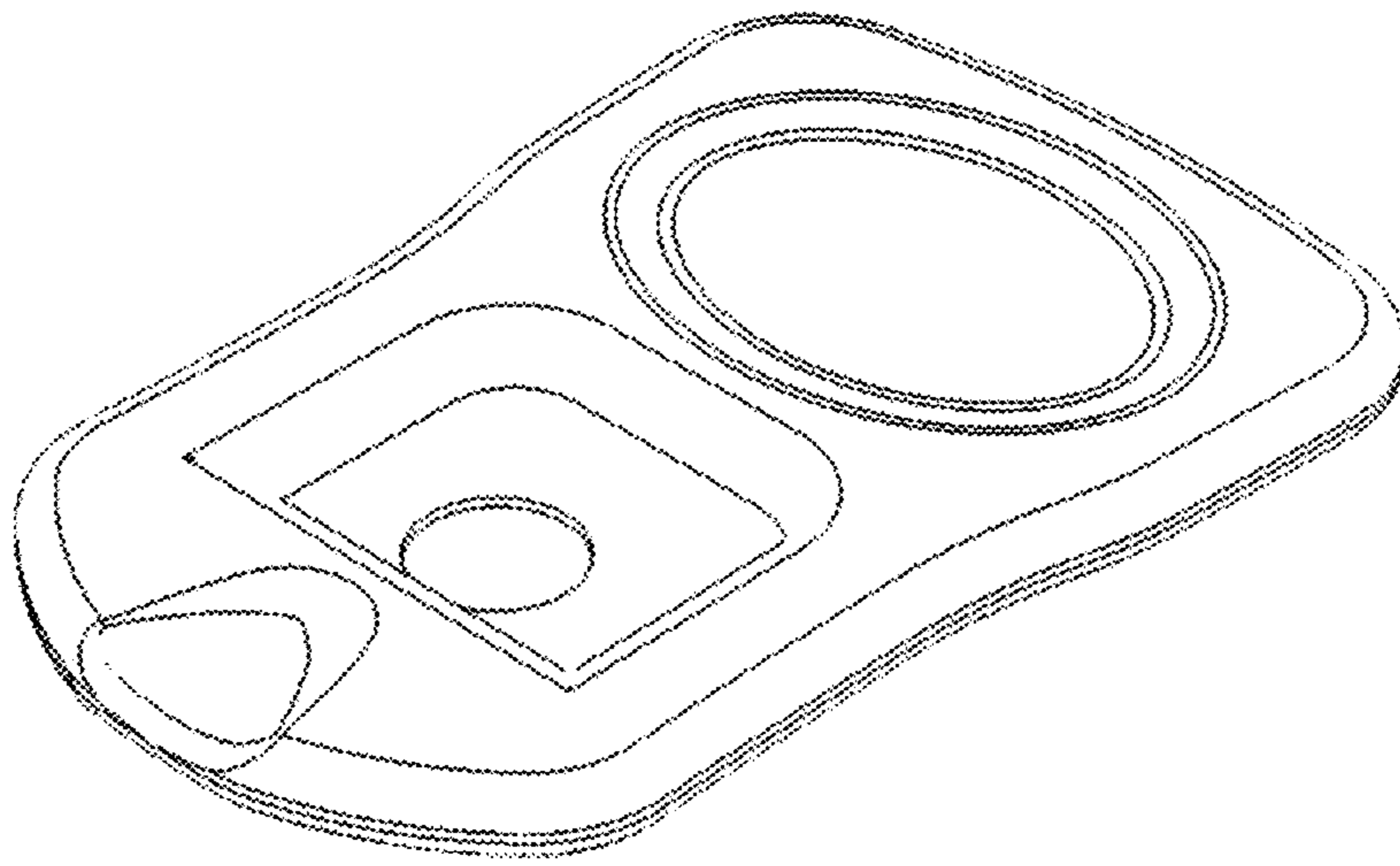

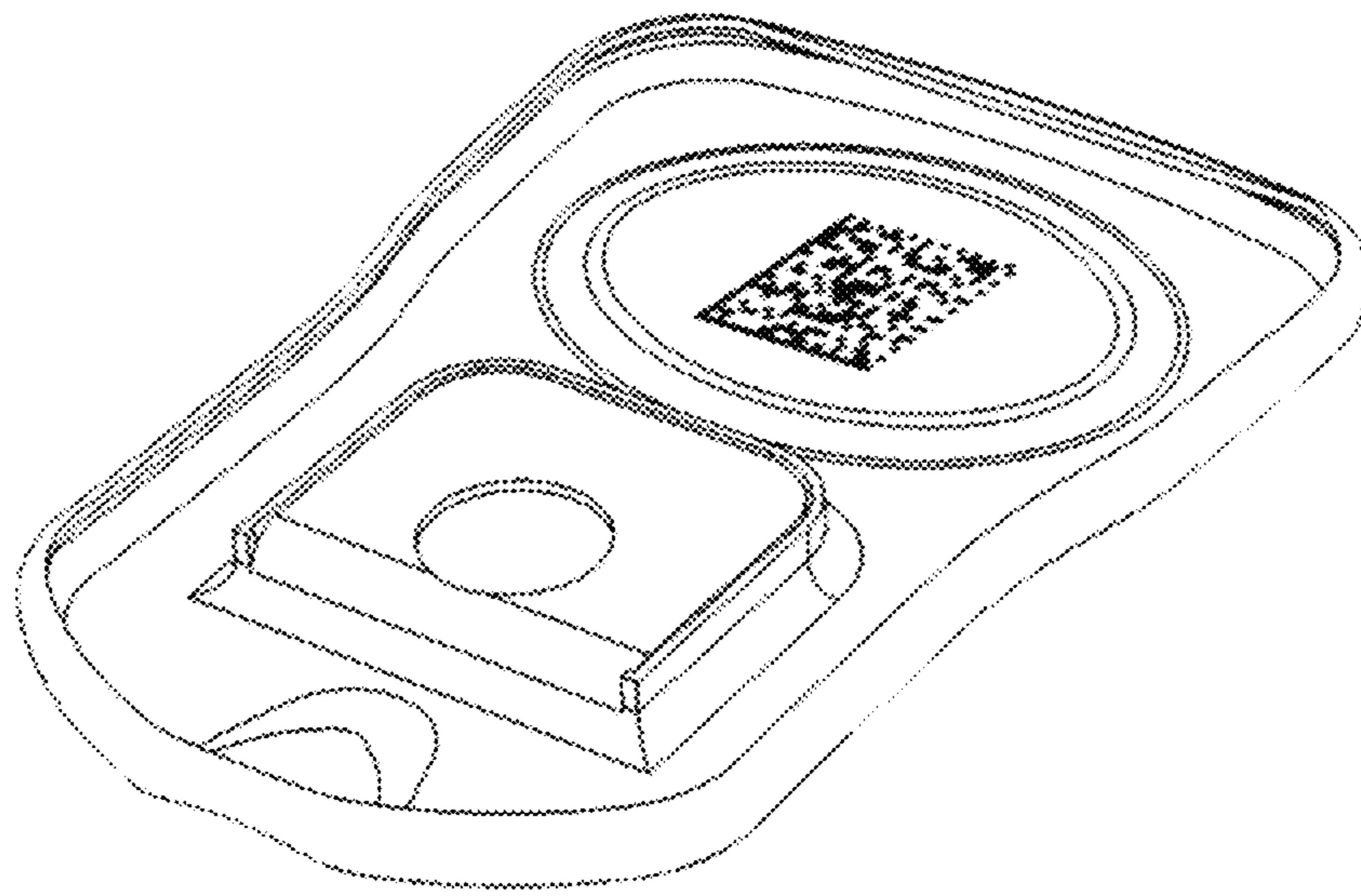

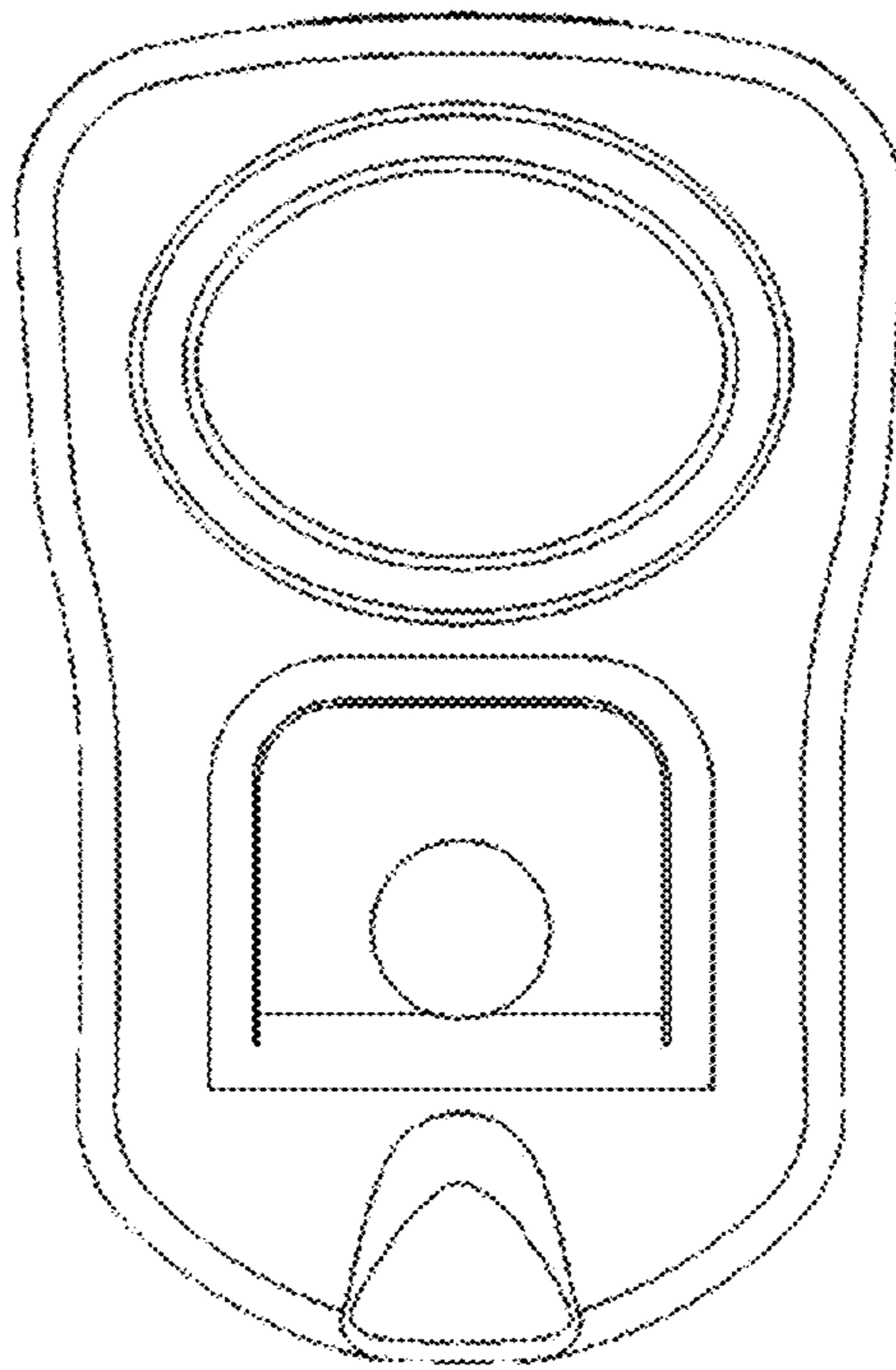

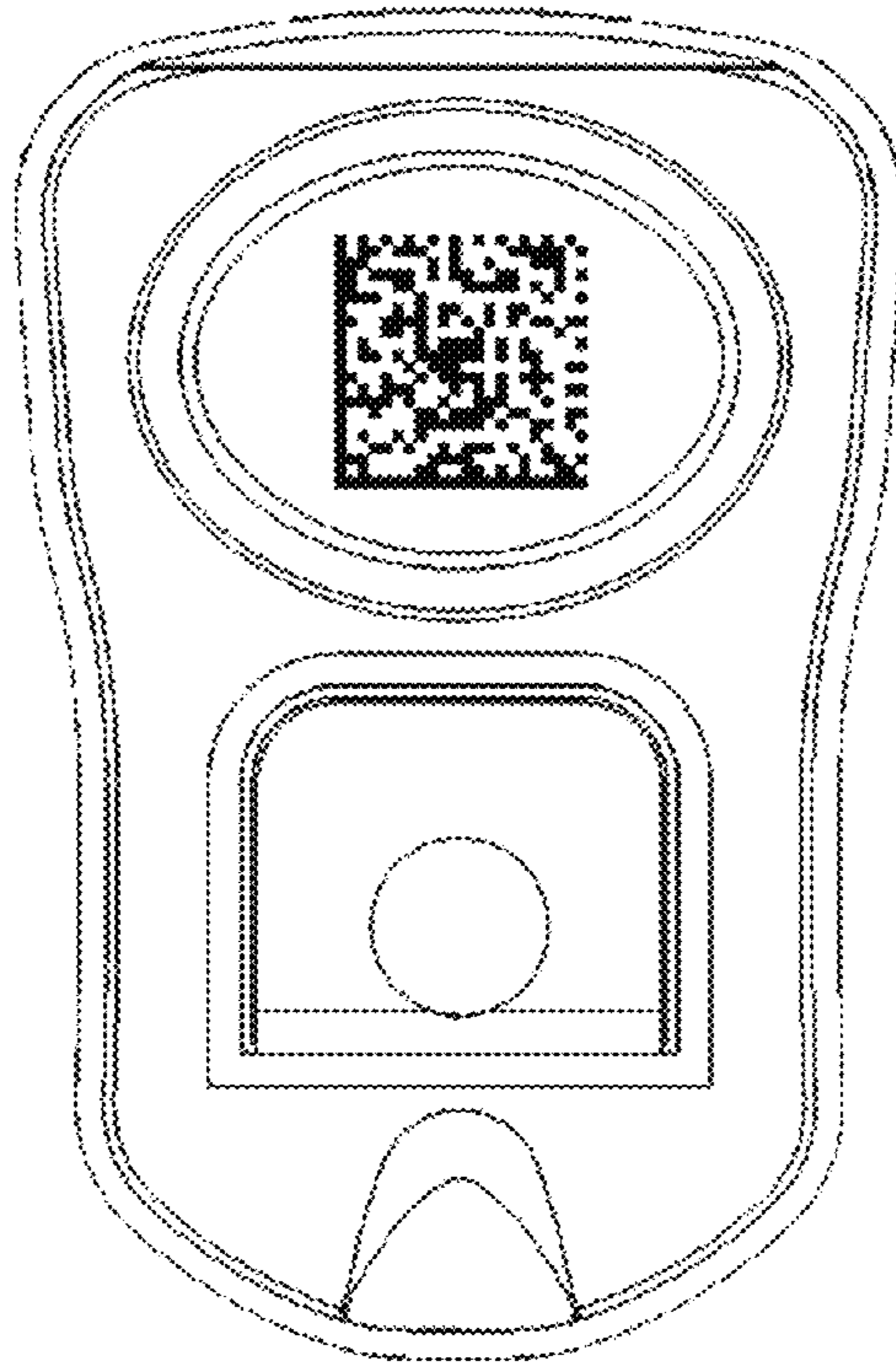

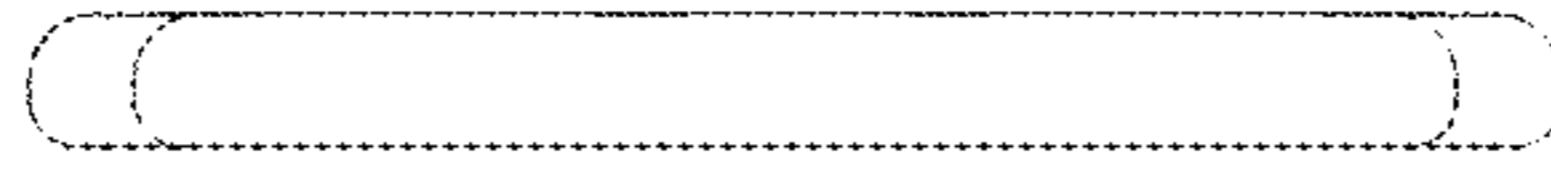
