FIG. 8 is a top plan view thereof.

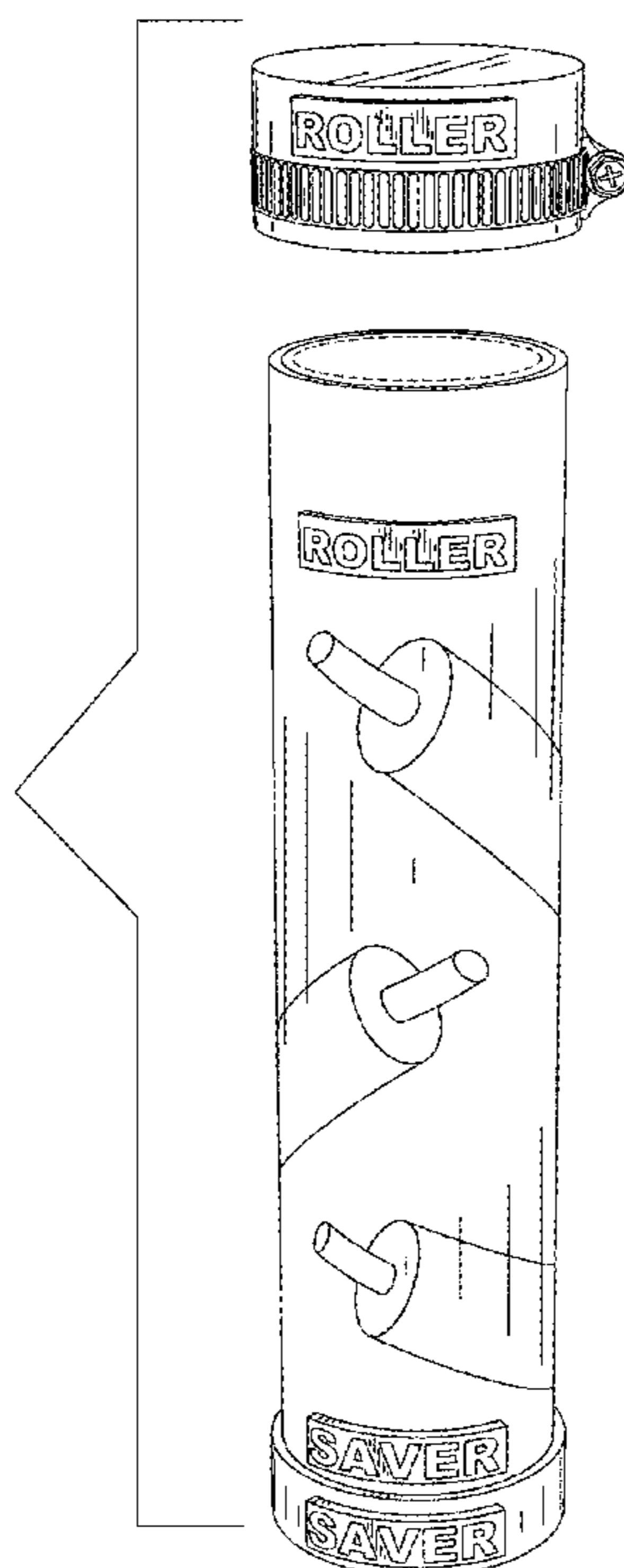
The even-length broken line defines the bounds of the claim and forms no part of the claimed design.

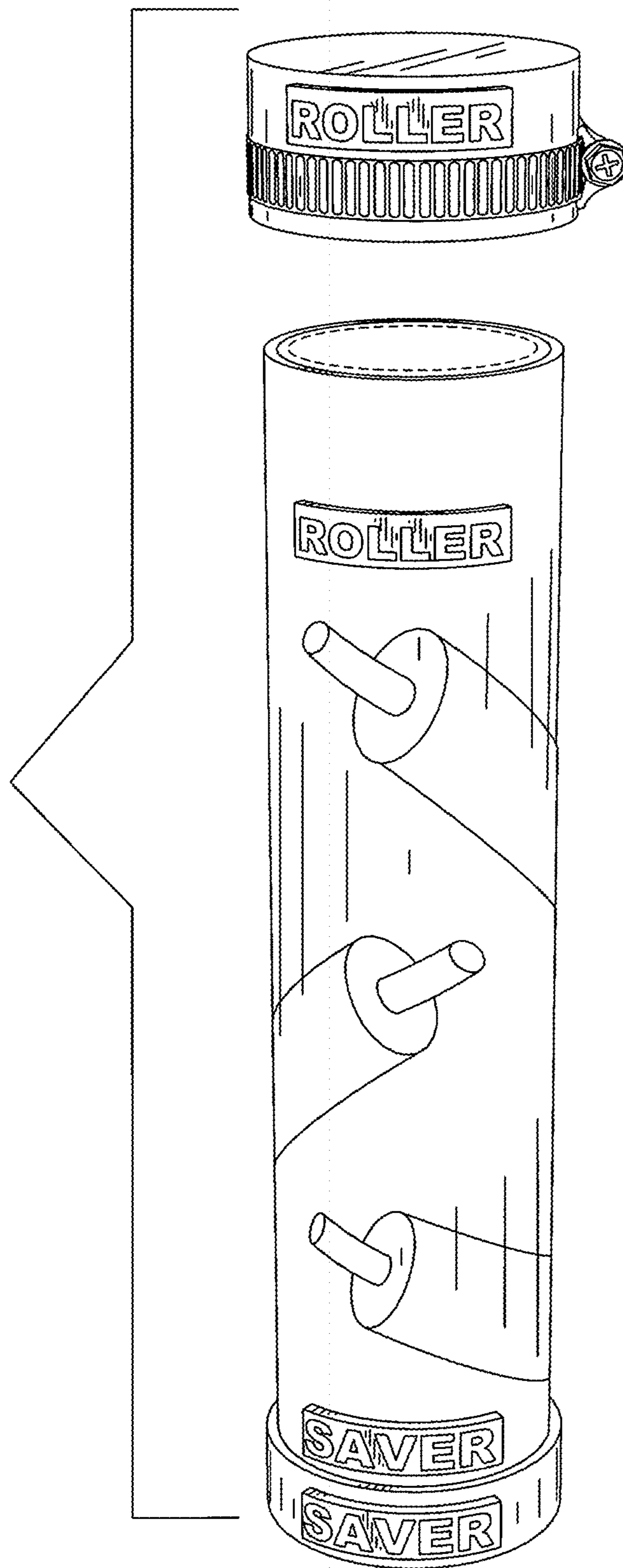

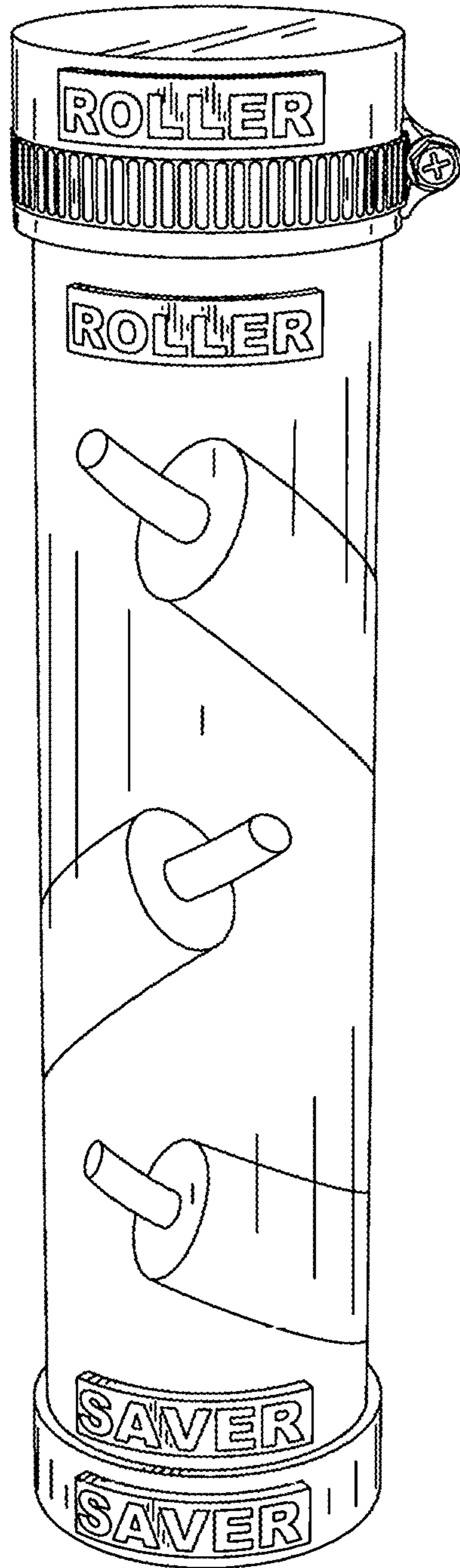

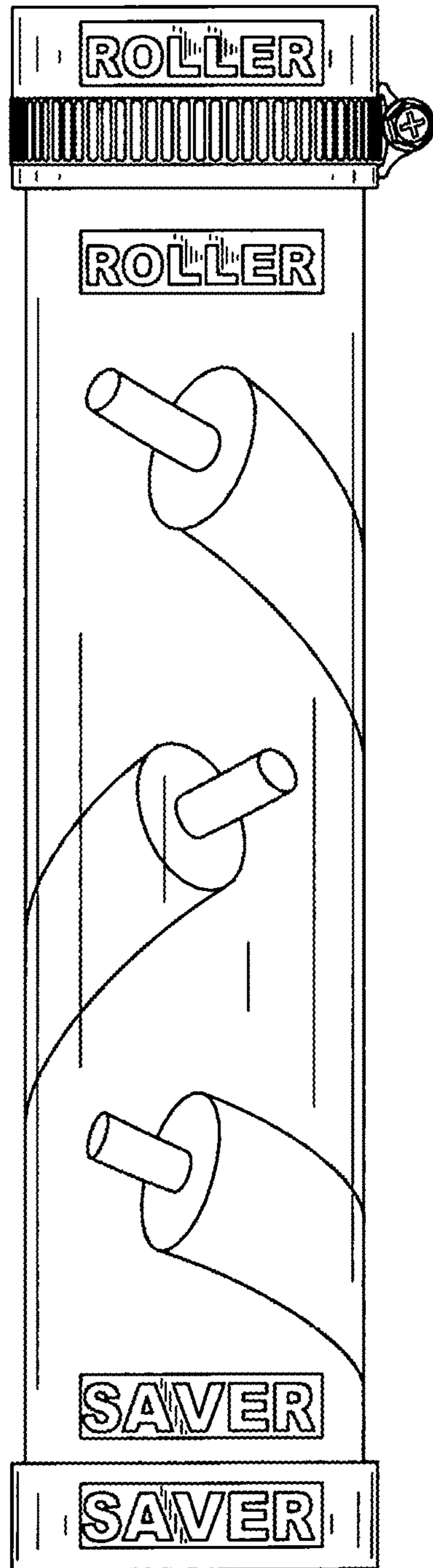

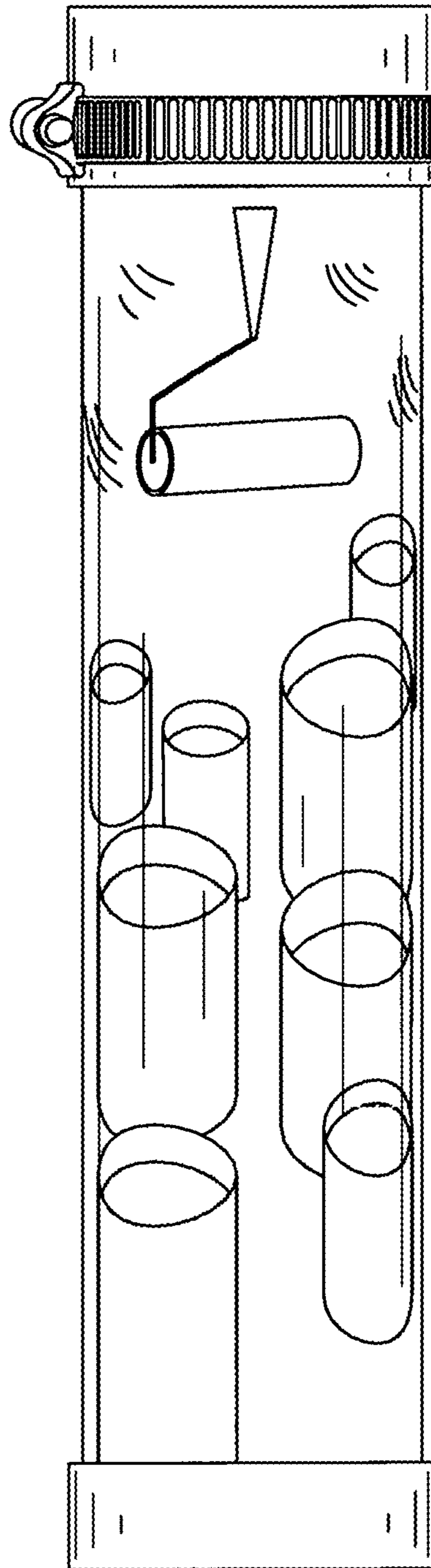
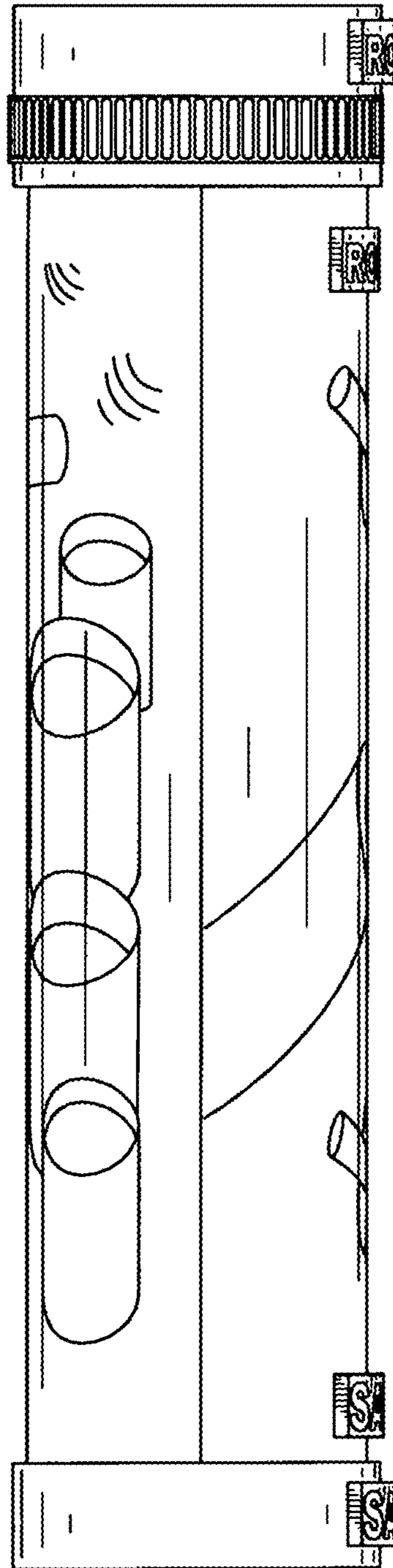

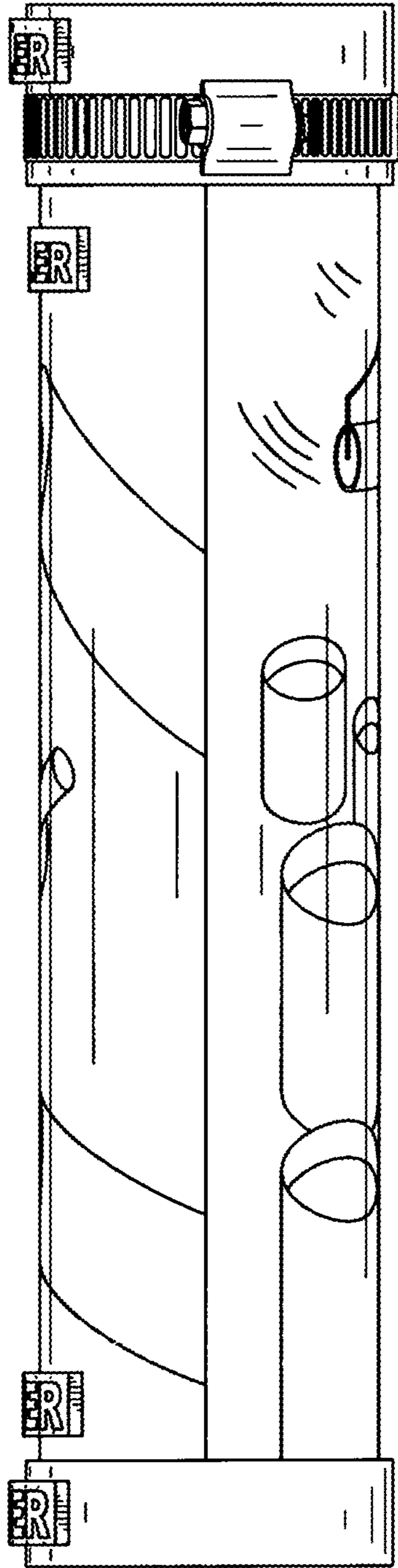

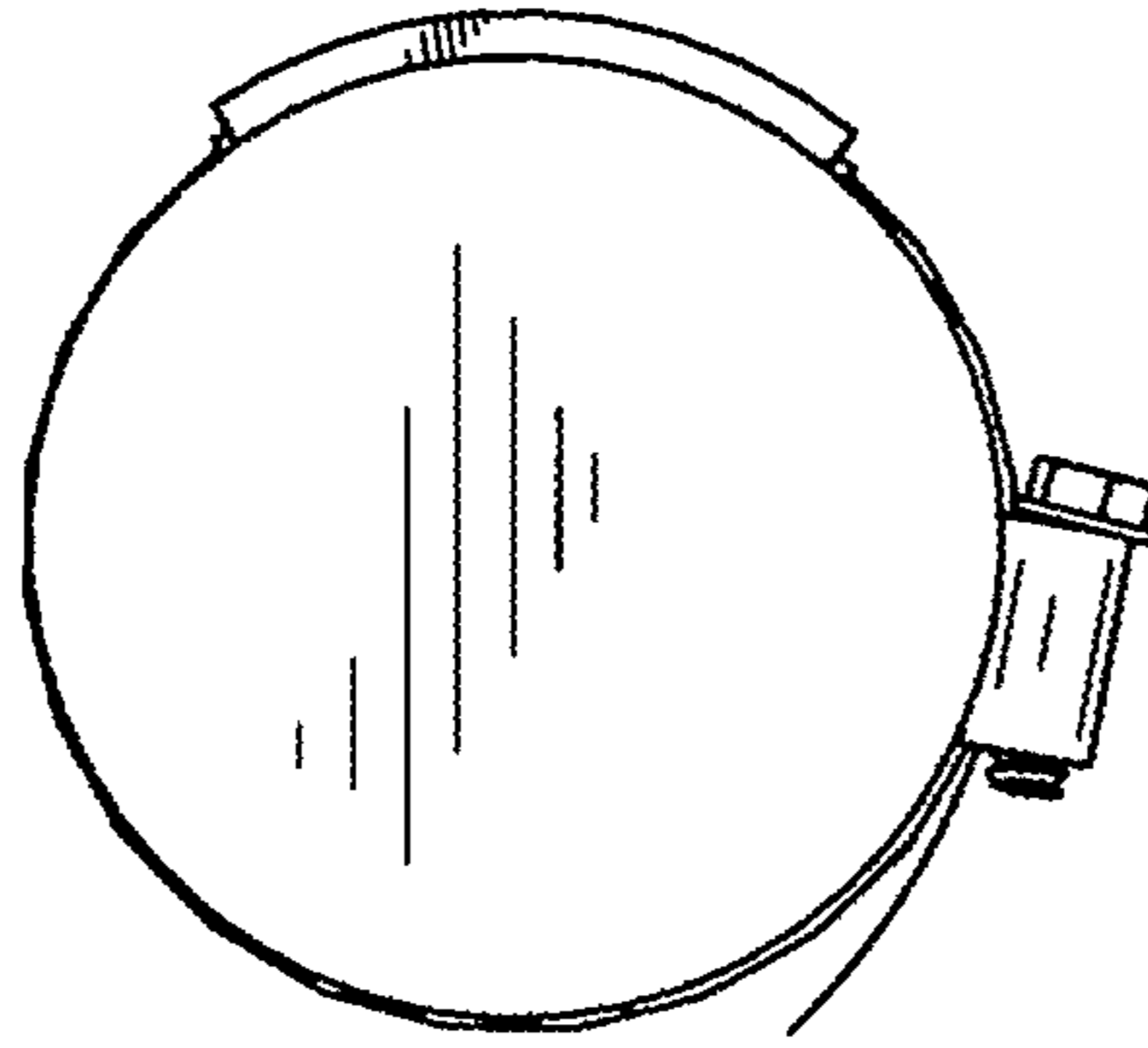

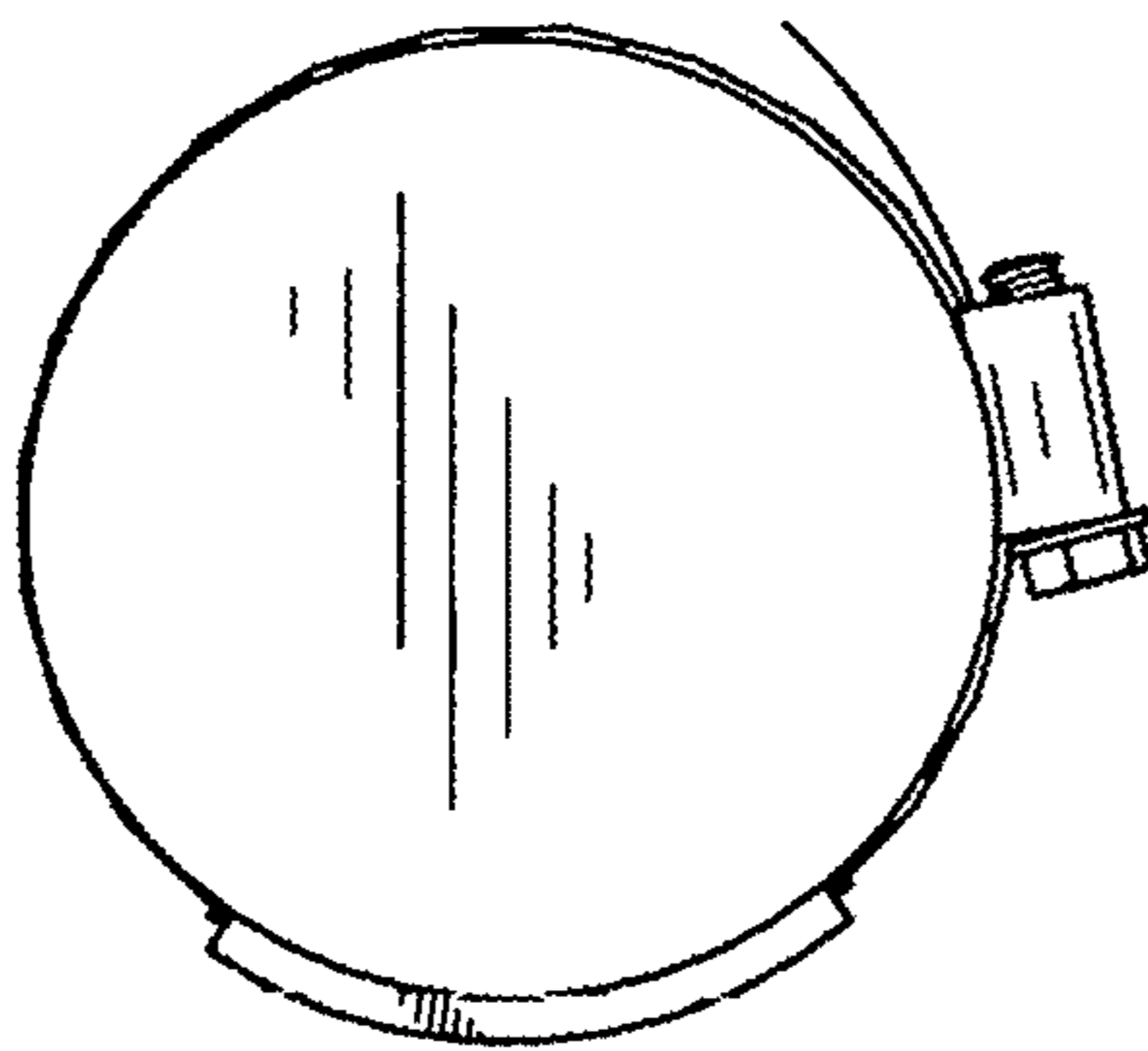
