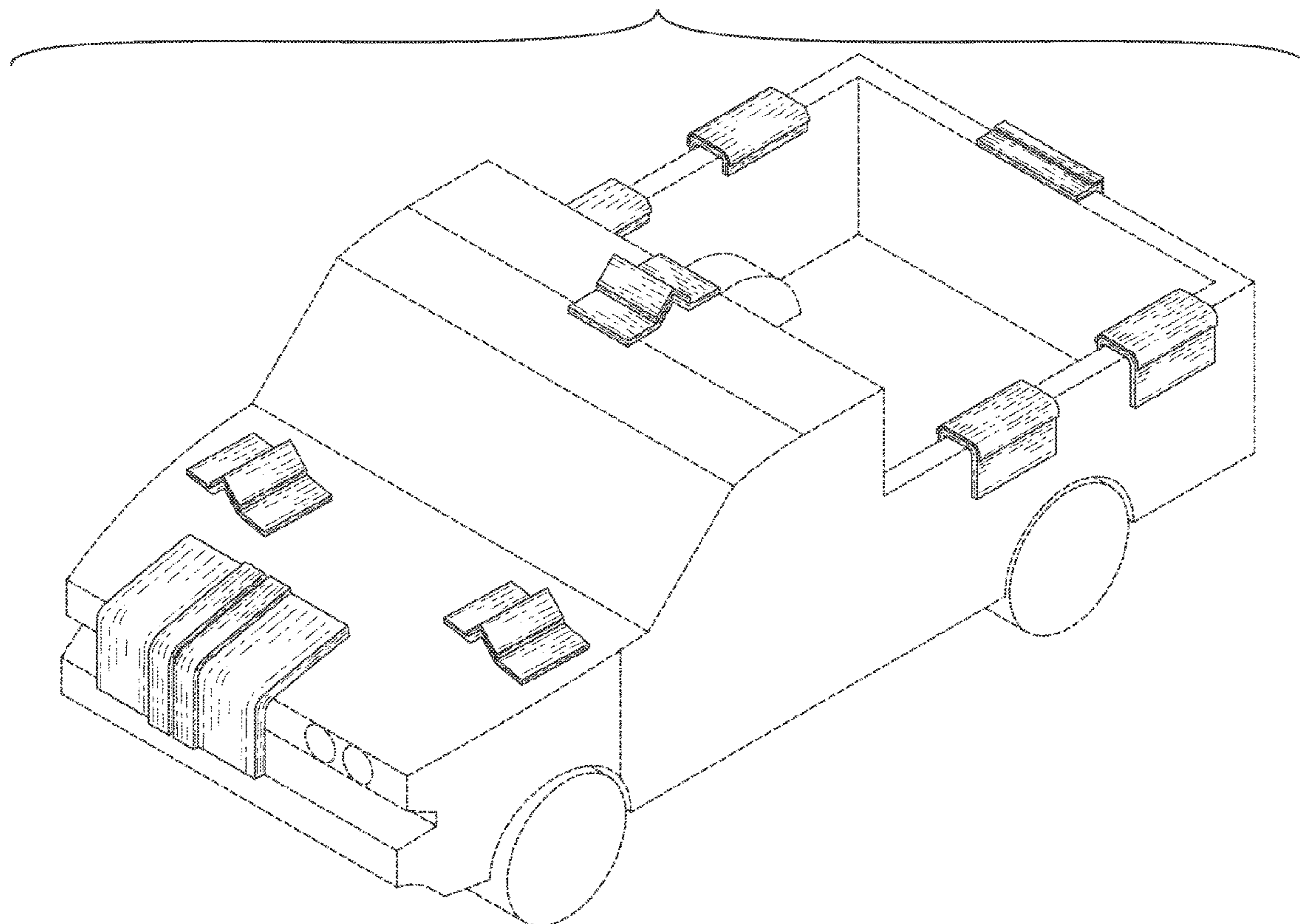
(57) **CLAIM**

The ornamental design for a set of protective load-bearing pads for vehicles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the set of protective load-bearing pads for vehicles showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top plan view thereof. The broken line showing of a pickup truck is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

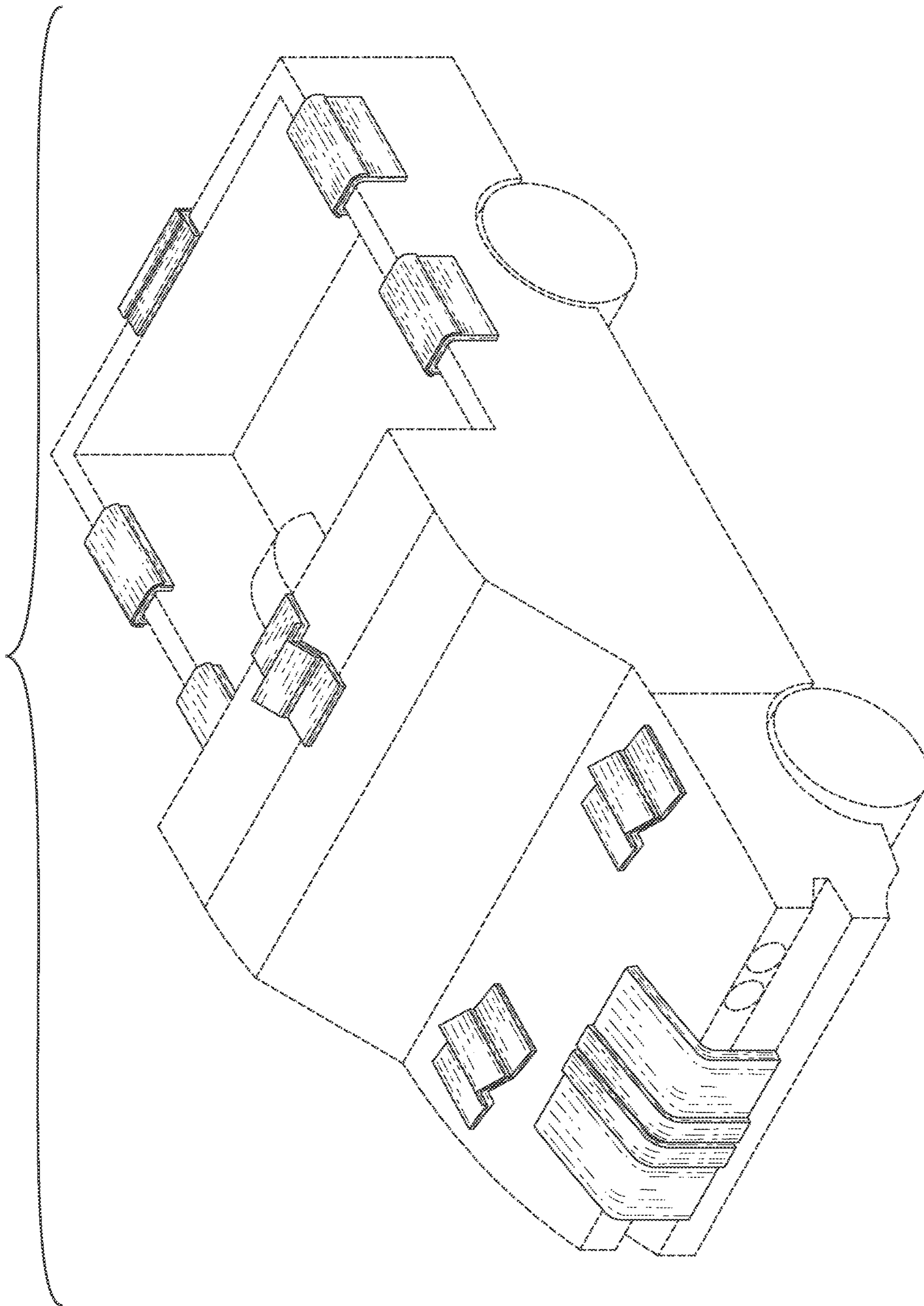

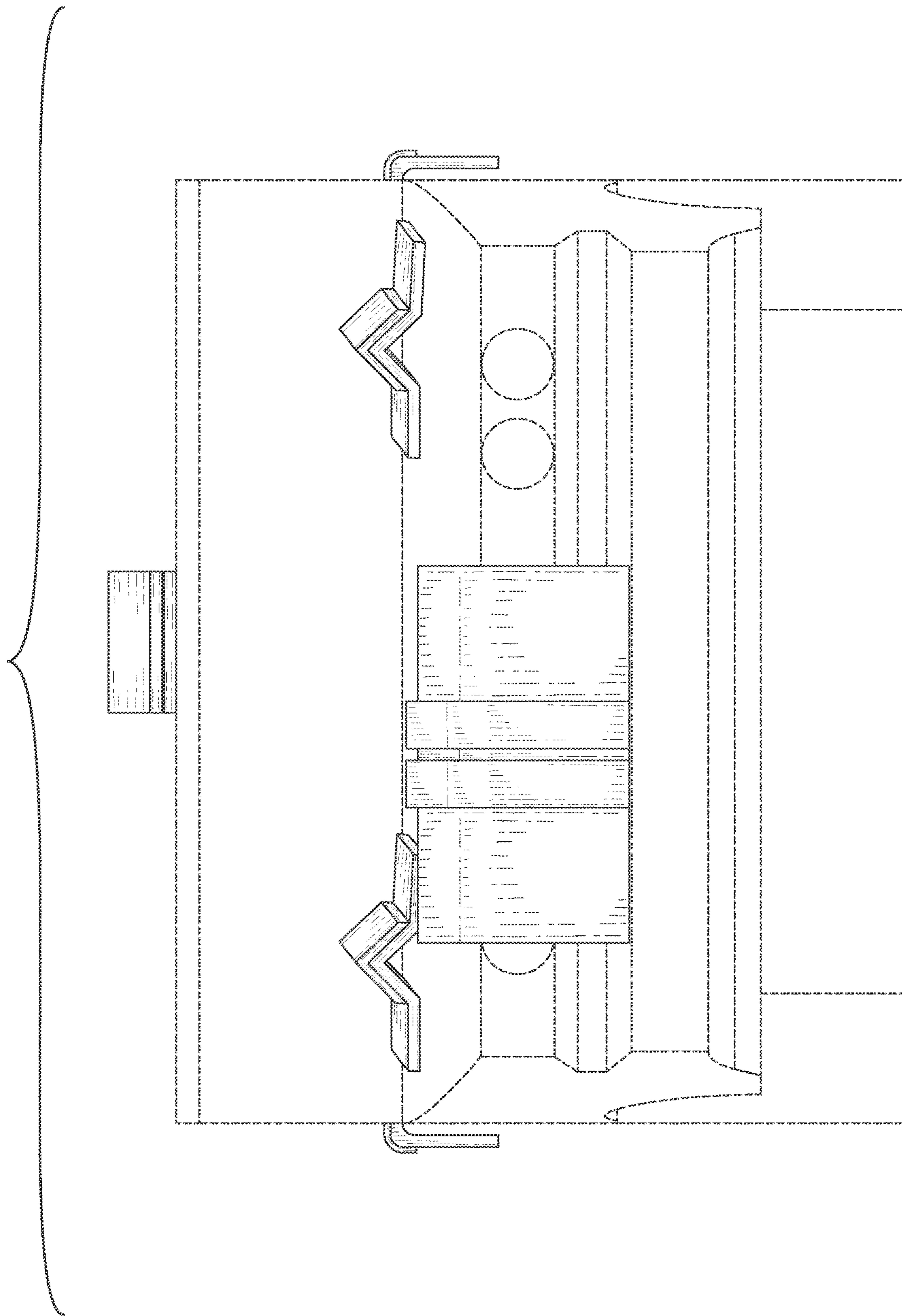

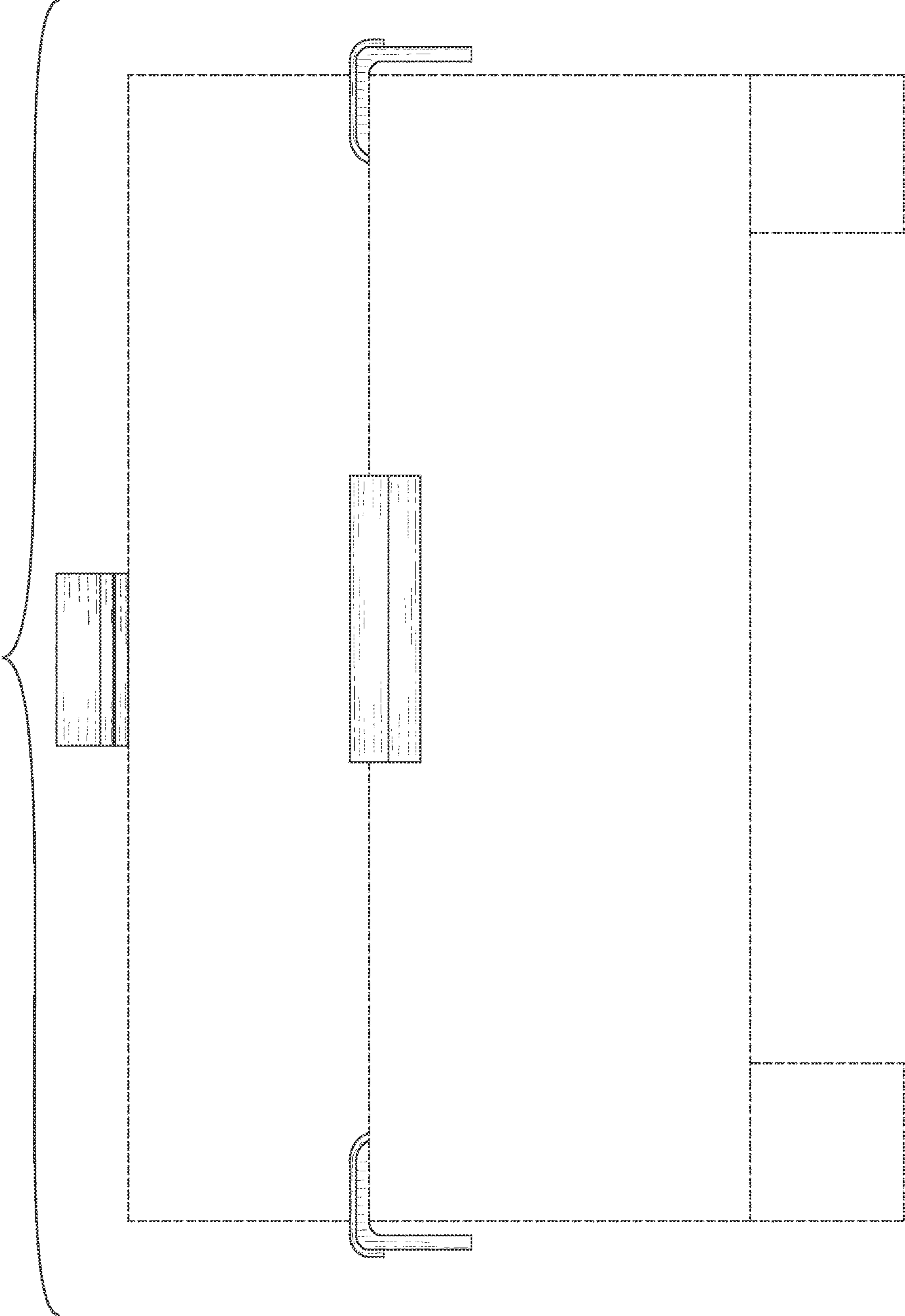

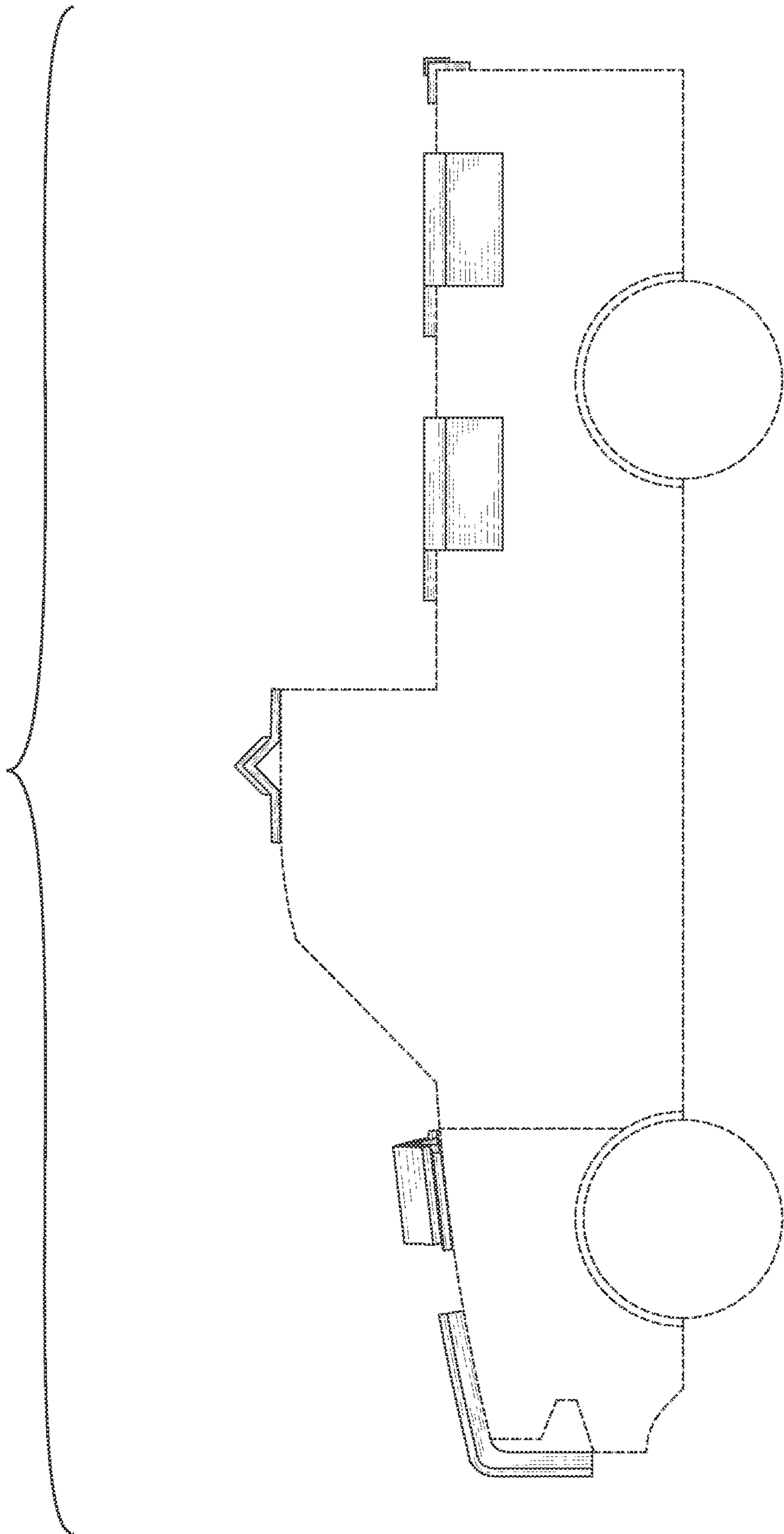

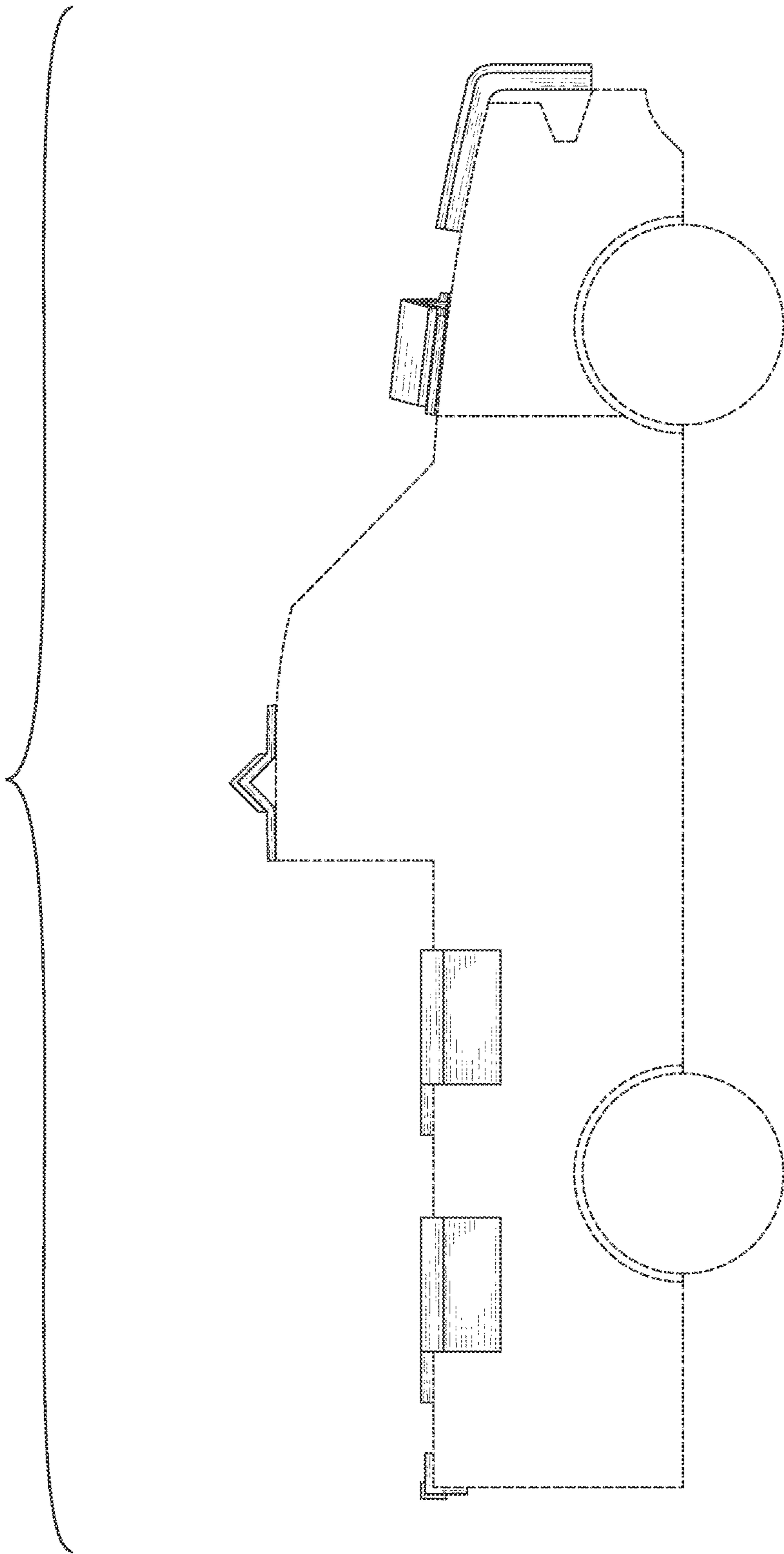

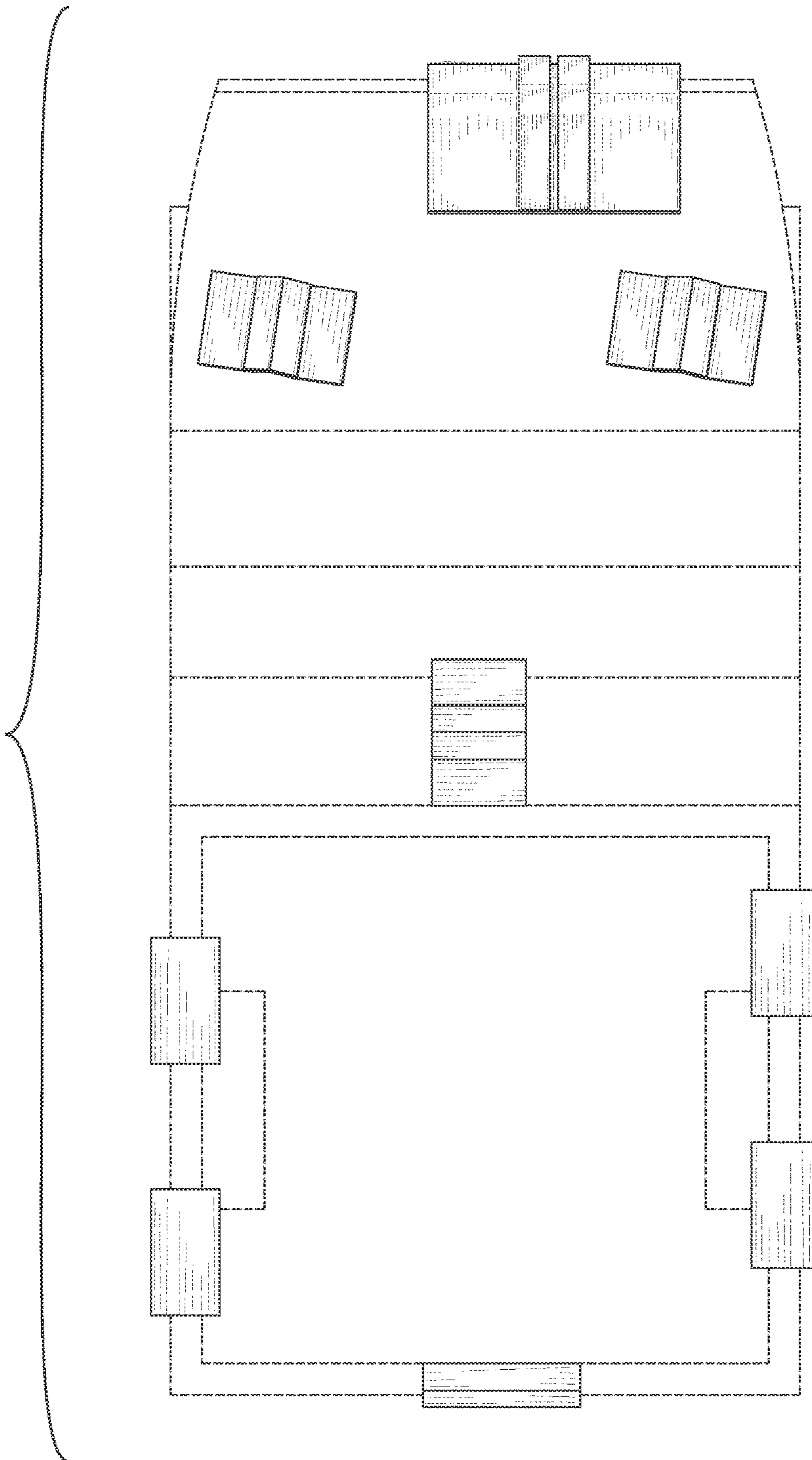

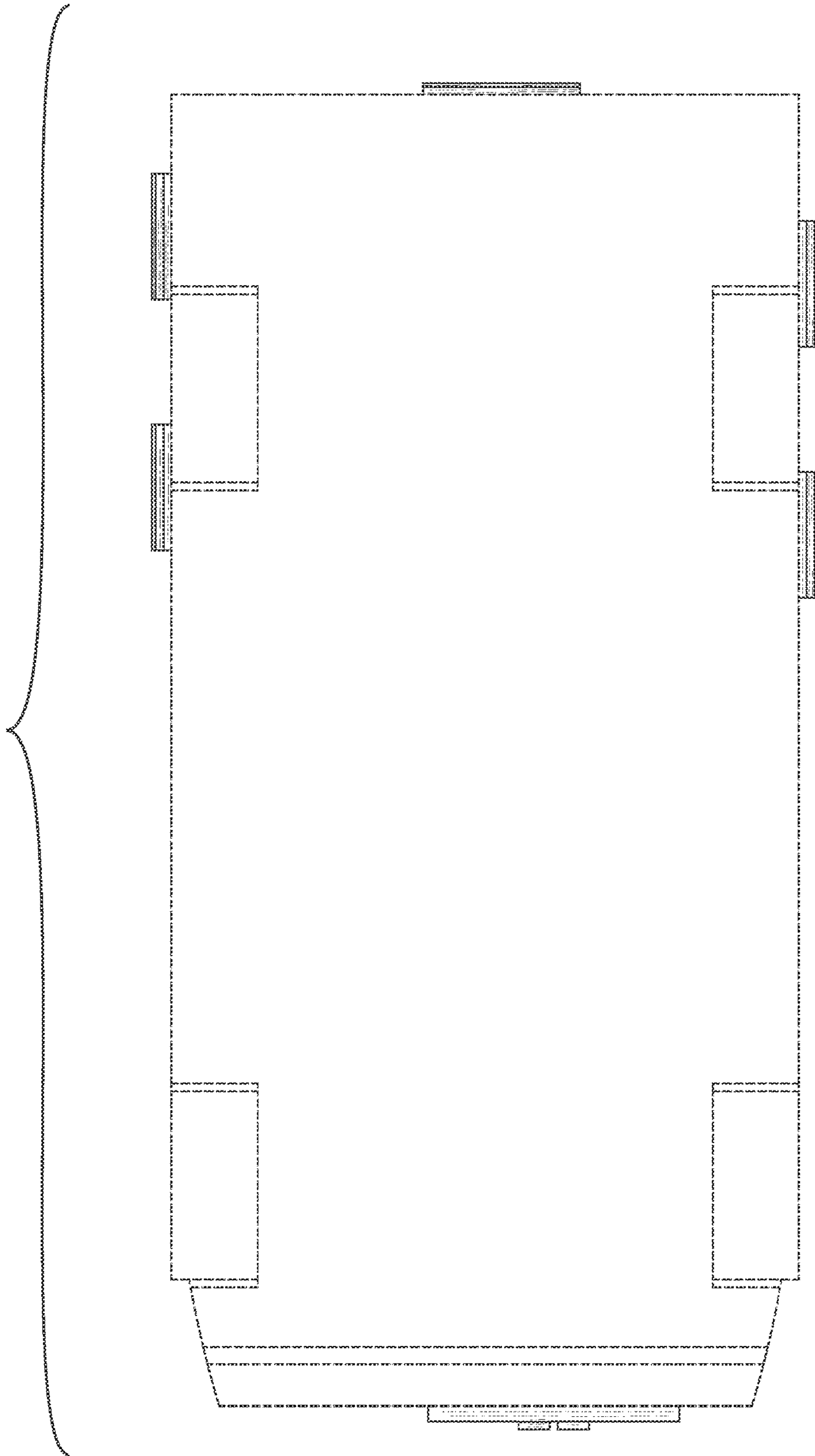
